FIG. 4 is a side view of the escutcheon on FIG. 1;

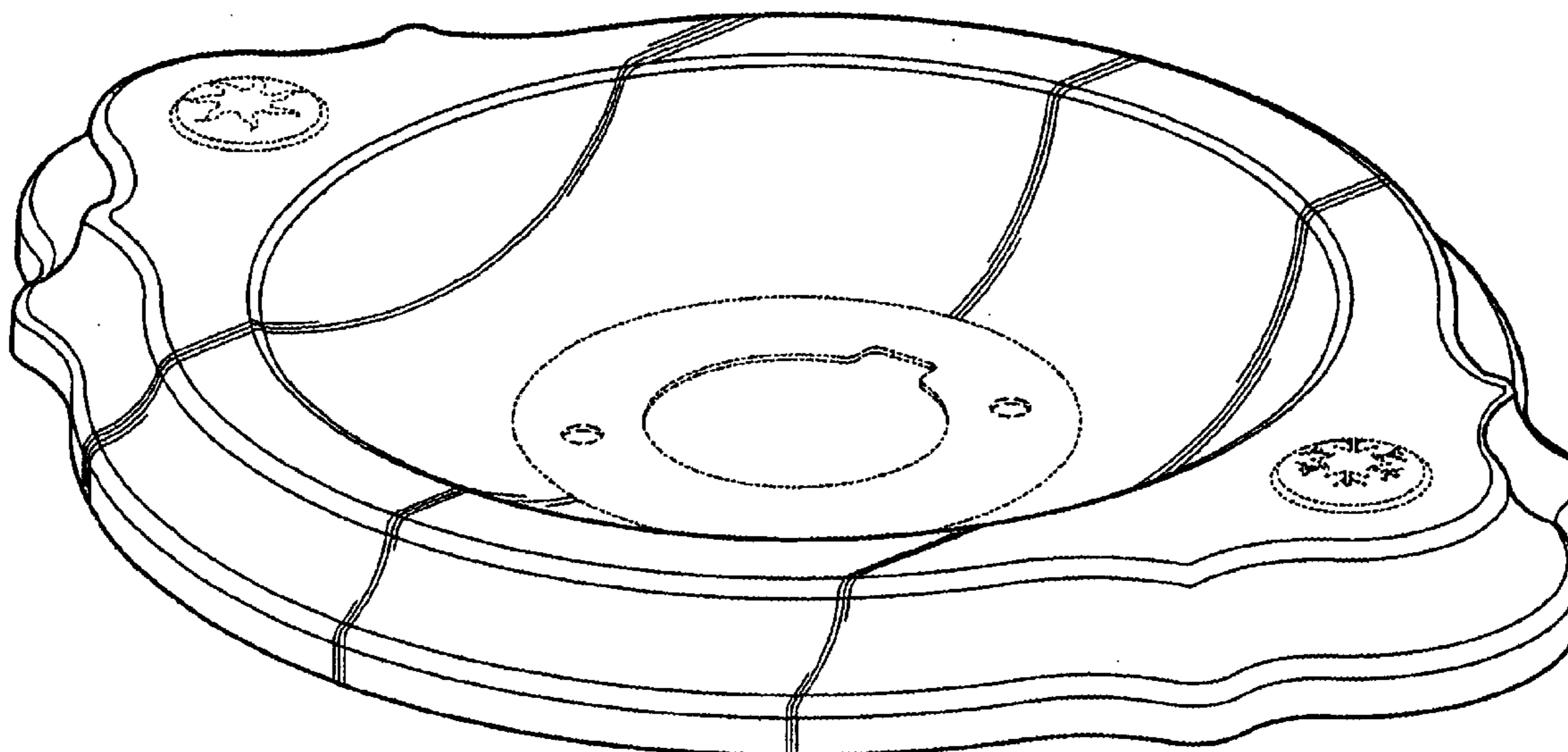
FIG. 5 is a top view of the escutcheon of FIG. 1;

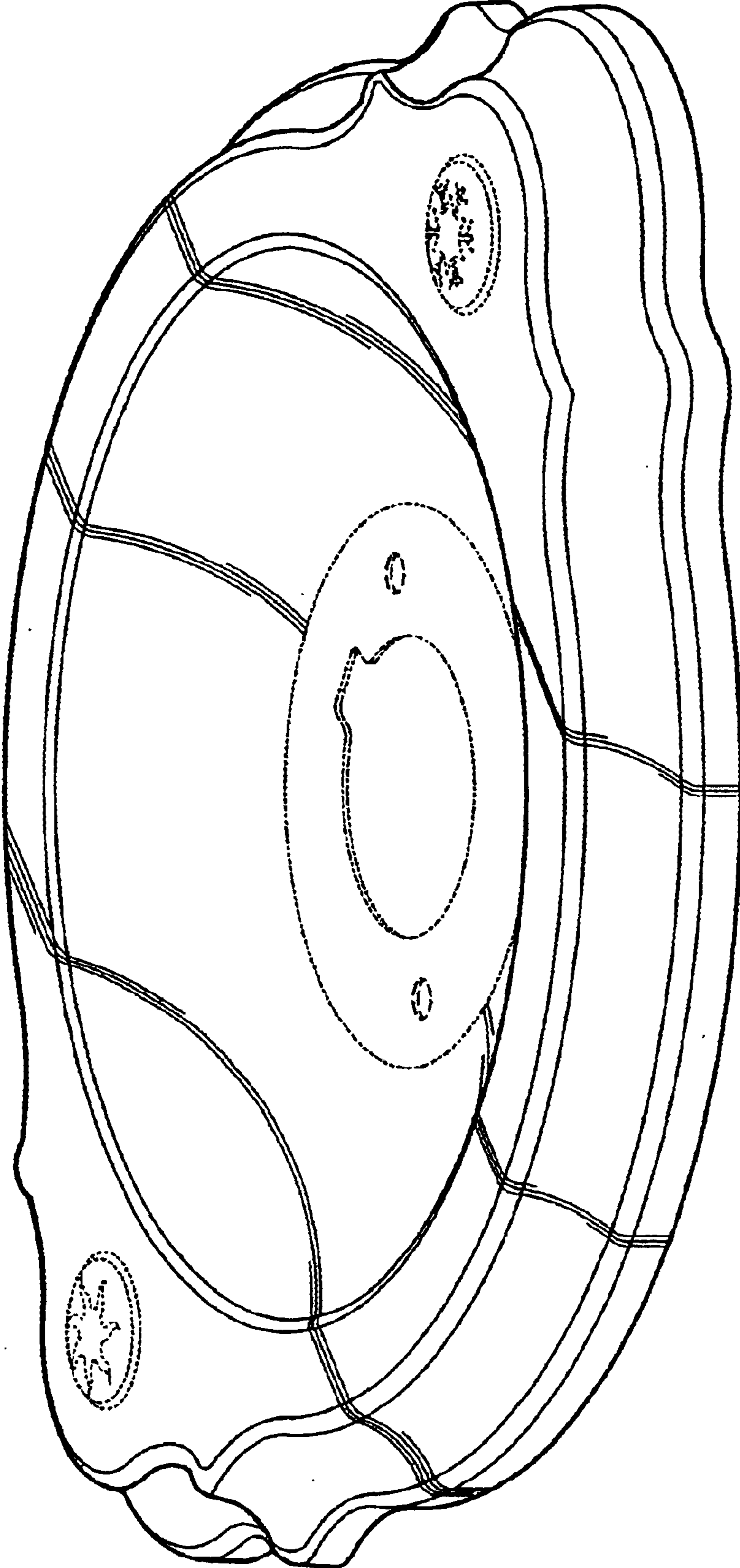

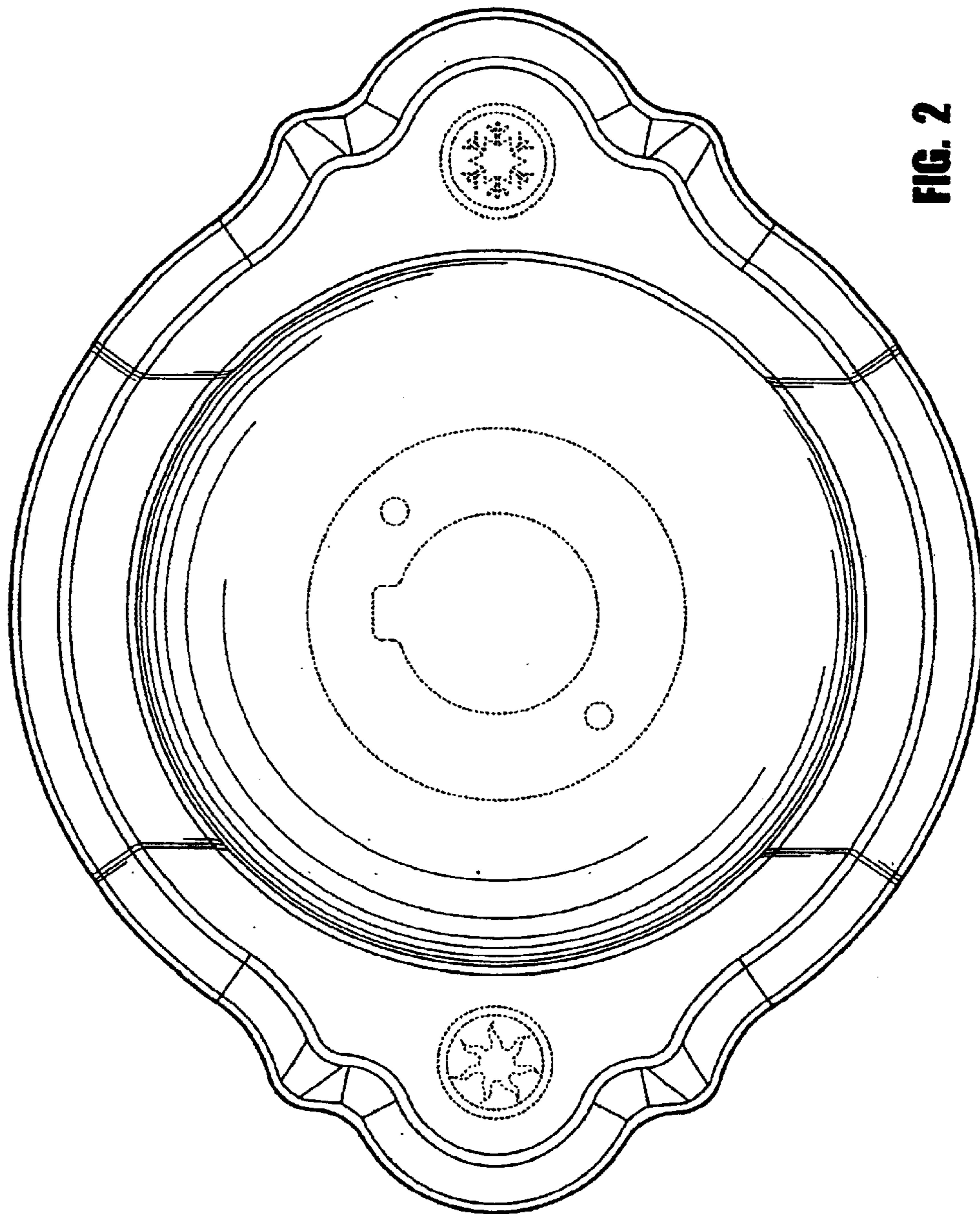

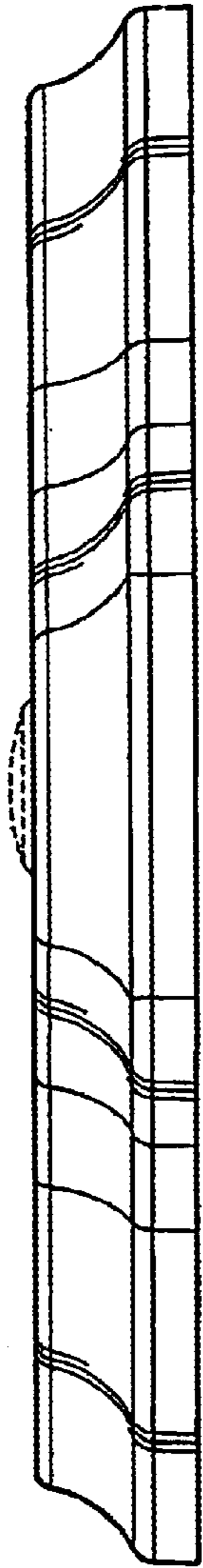

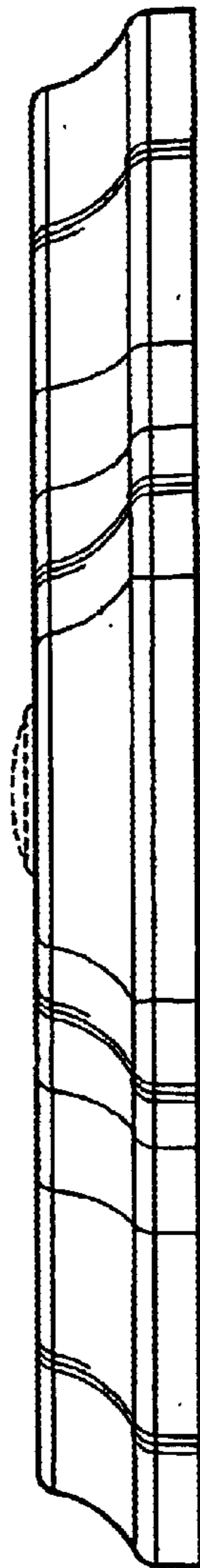

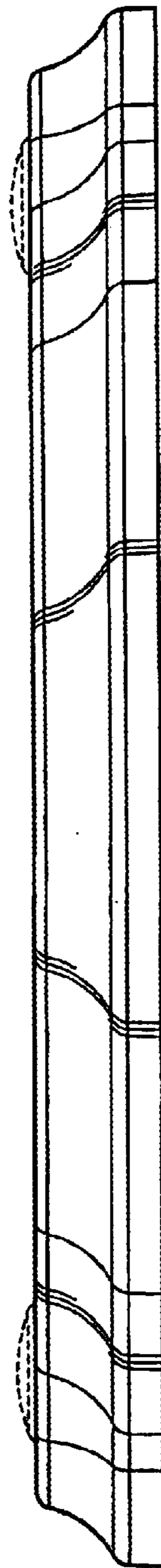

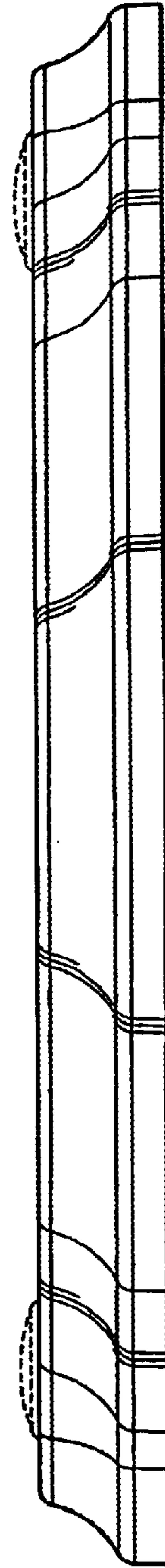

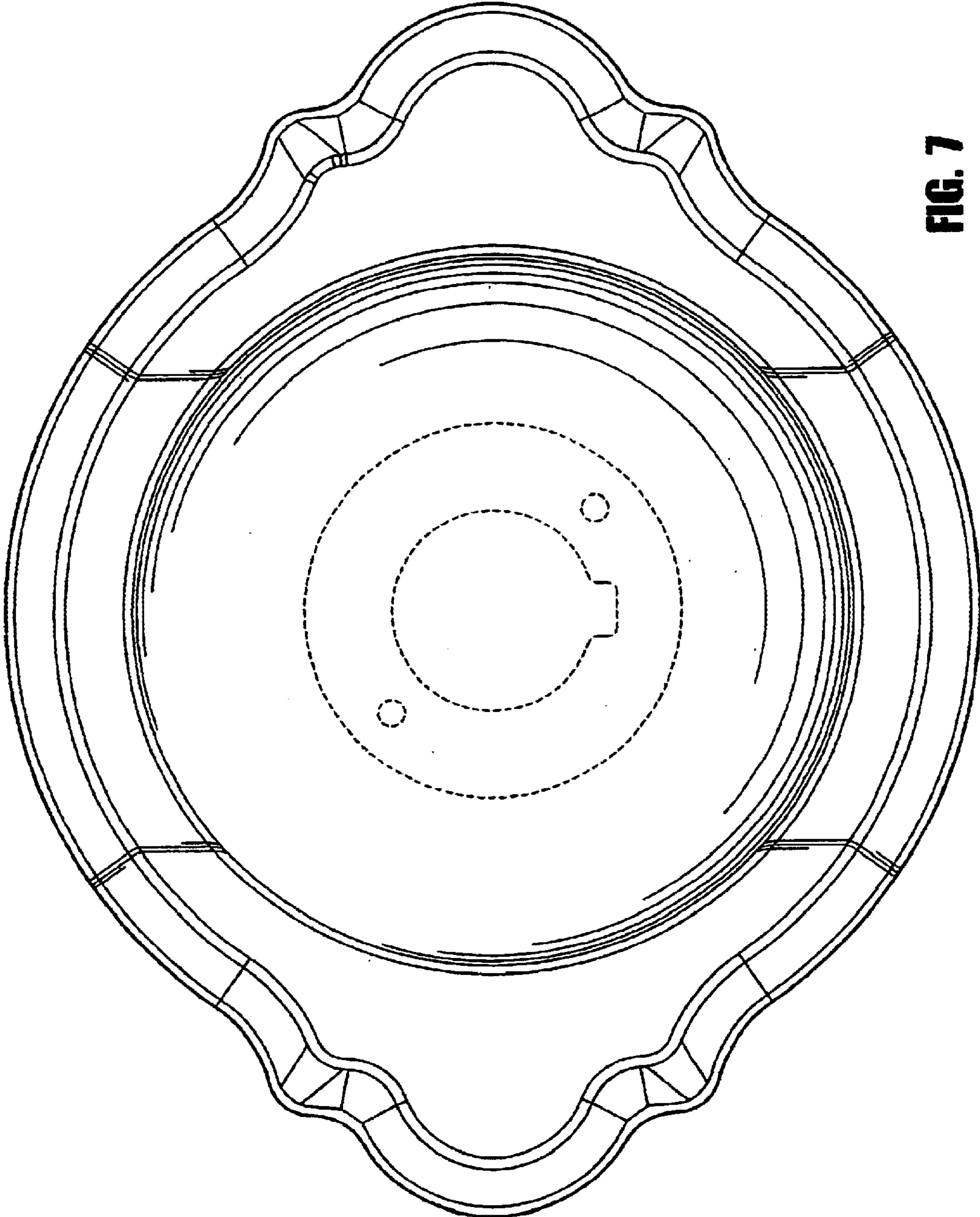
