The ornamental design for a light fixture ornament, as shown
and described.

DESCRIPTION

a mirror image thereof;

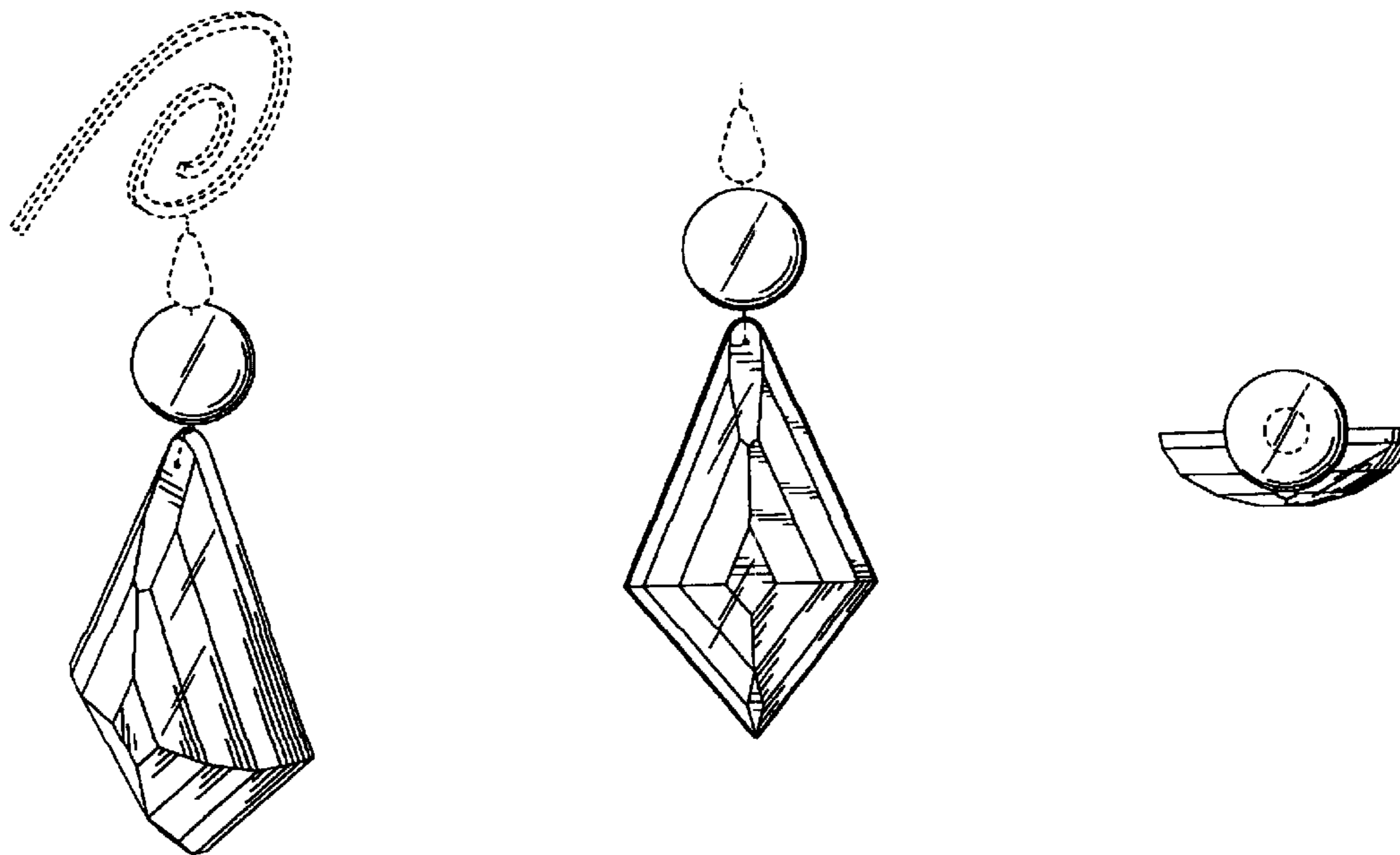
FIG. 4 is a back elevational view thereof;

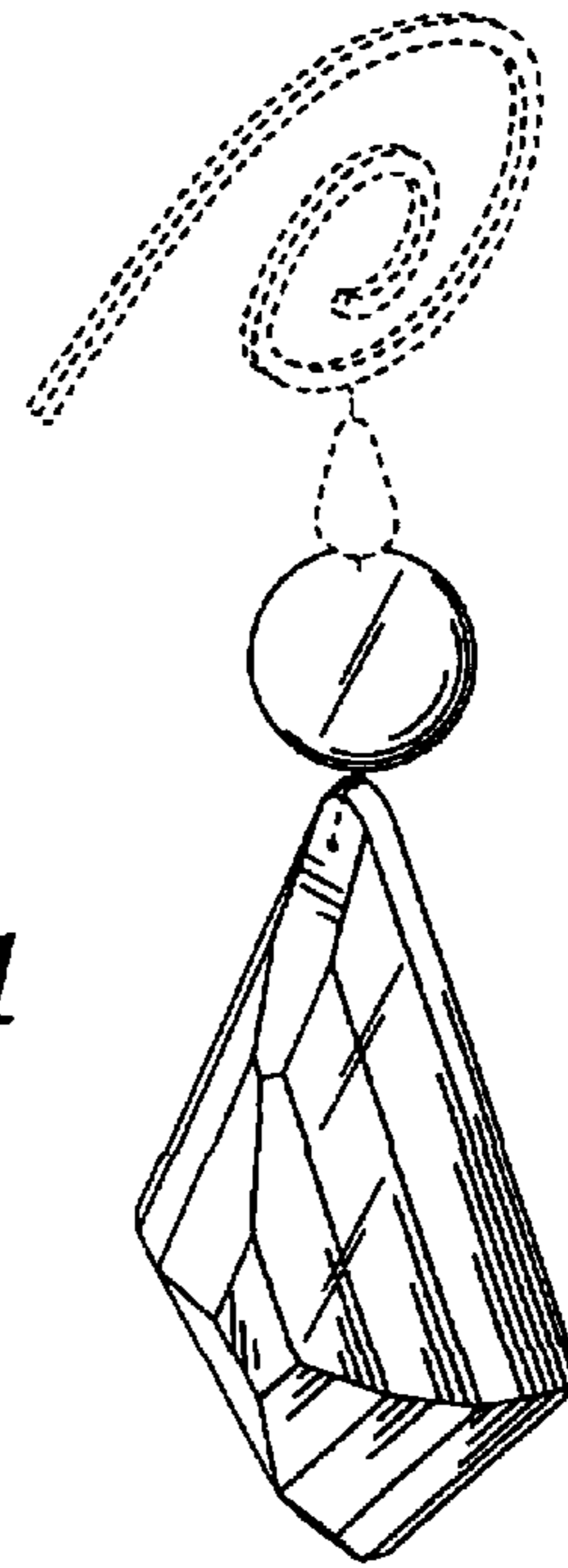

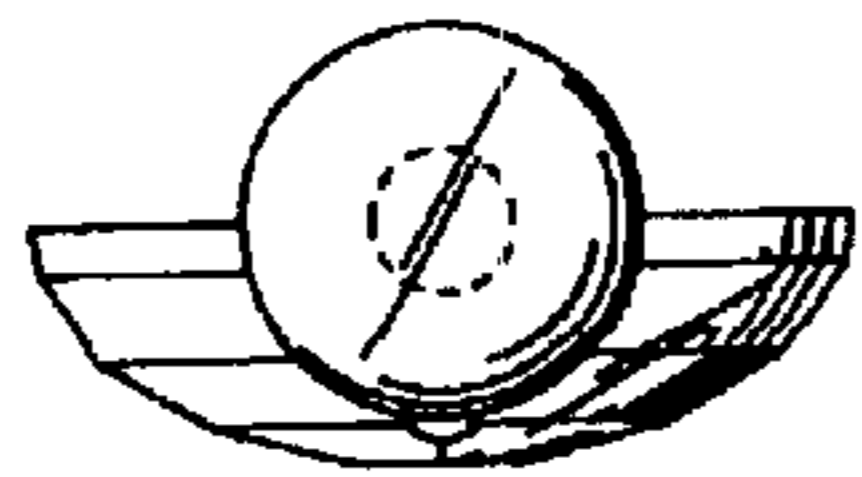

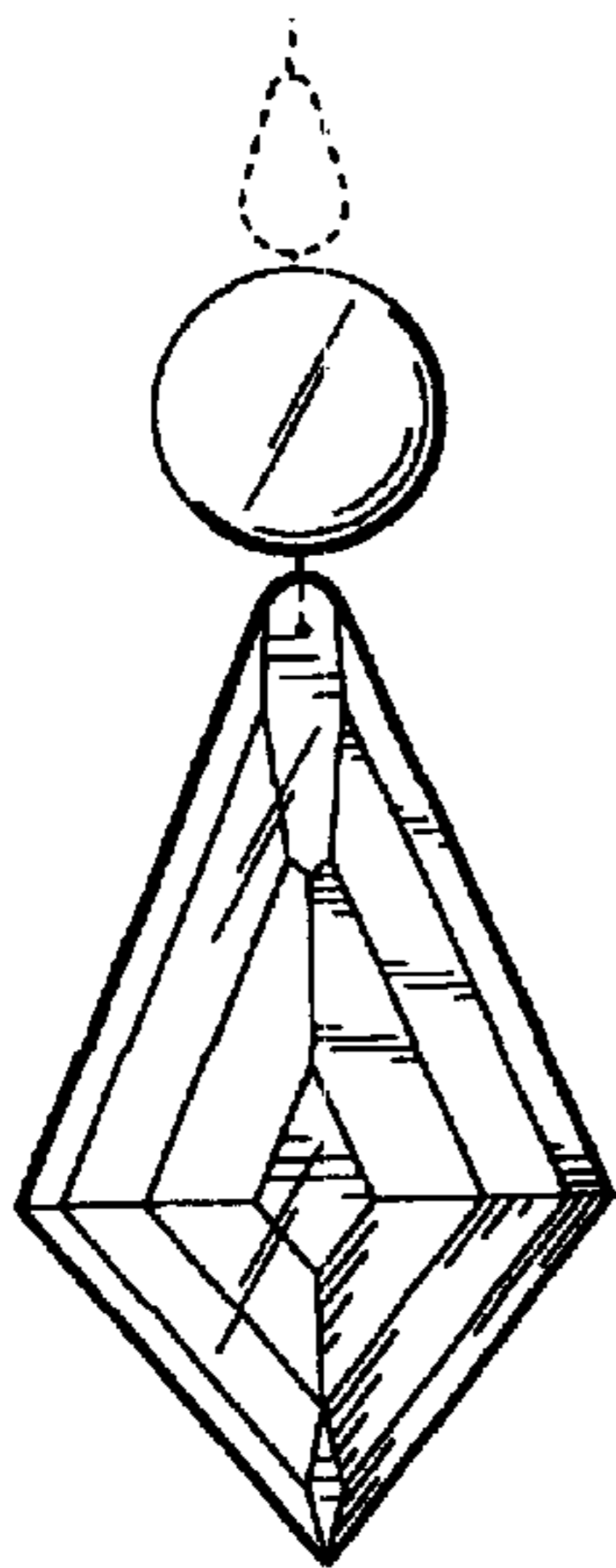

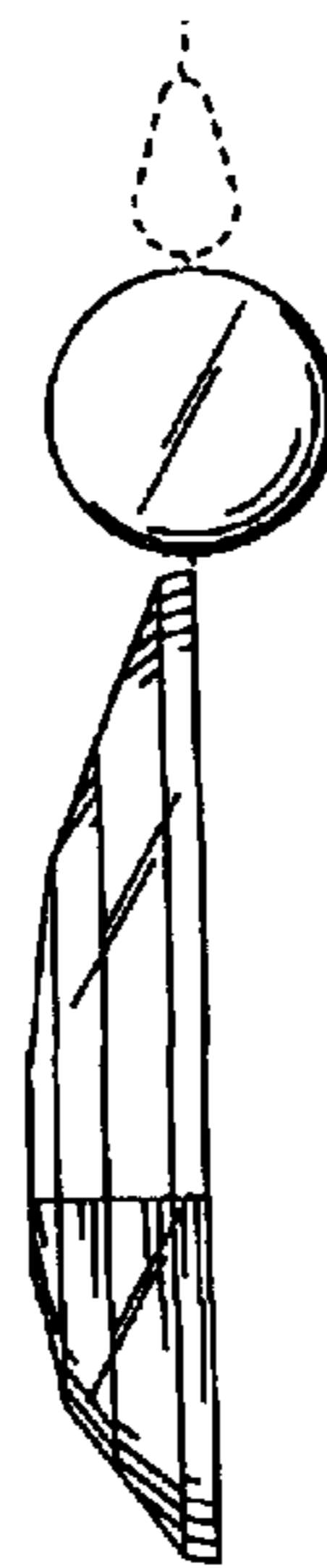

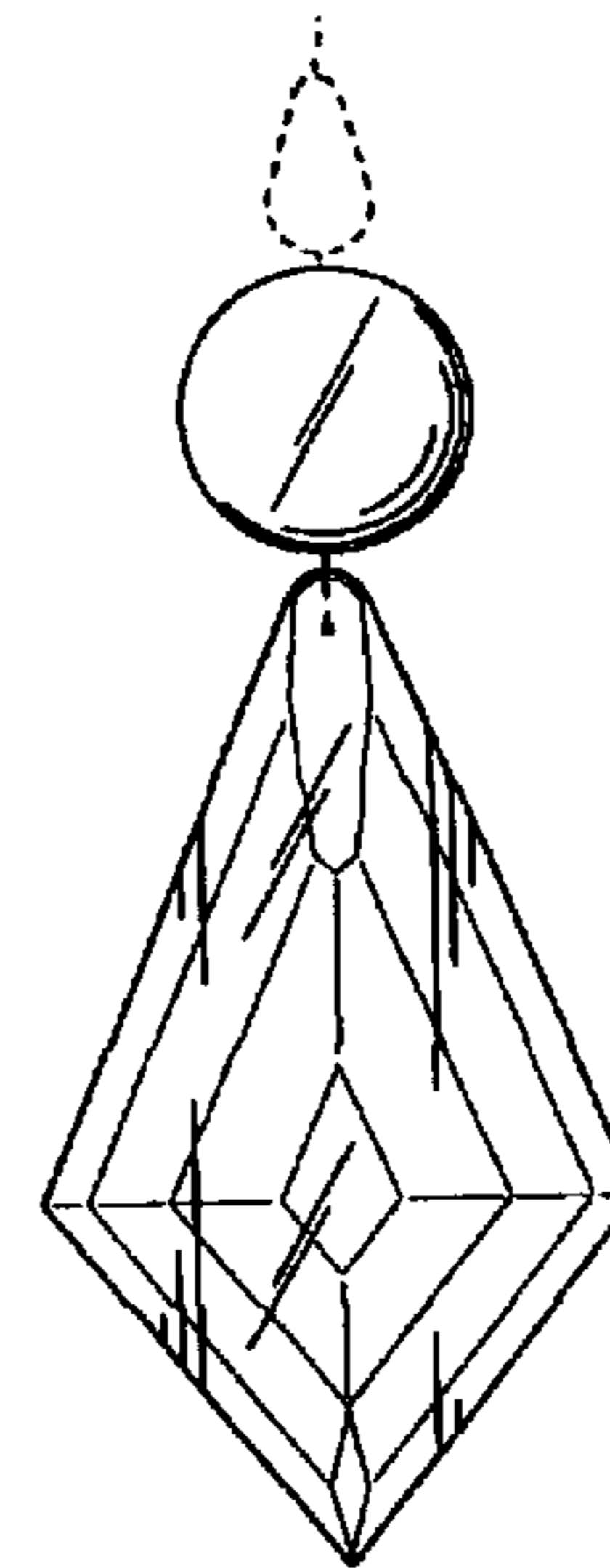

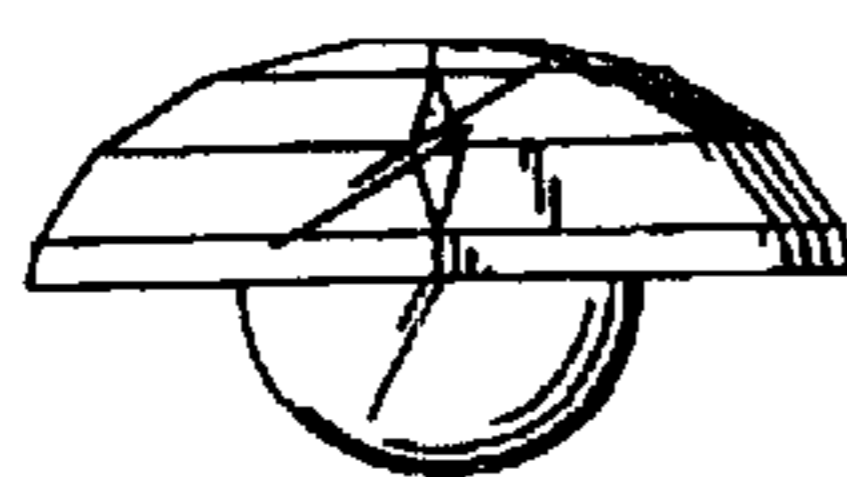
