**DESCRIPTION**

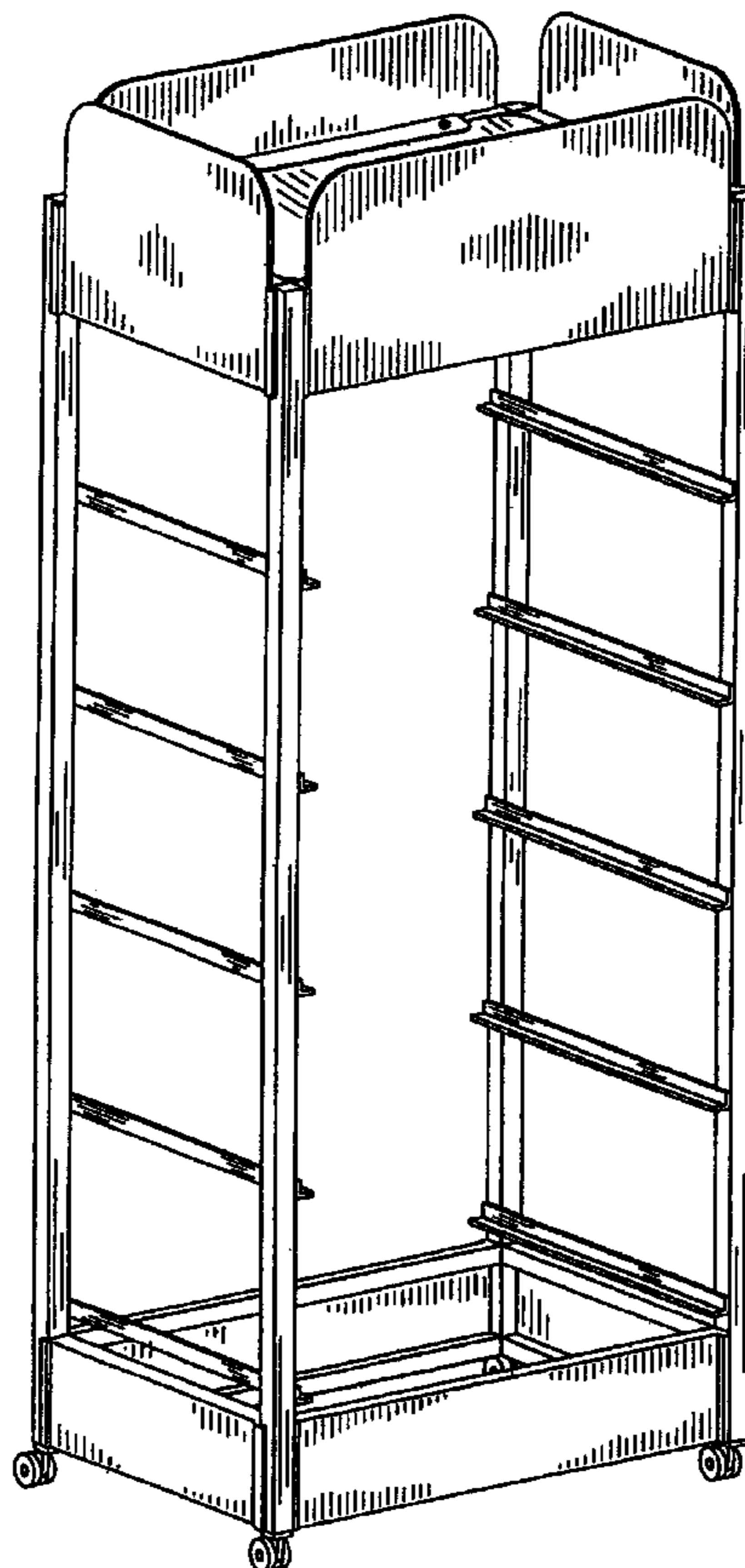
FIG. 1 is a perspective view of the display rack showing my new design;

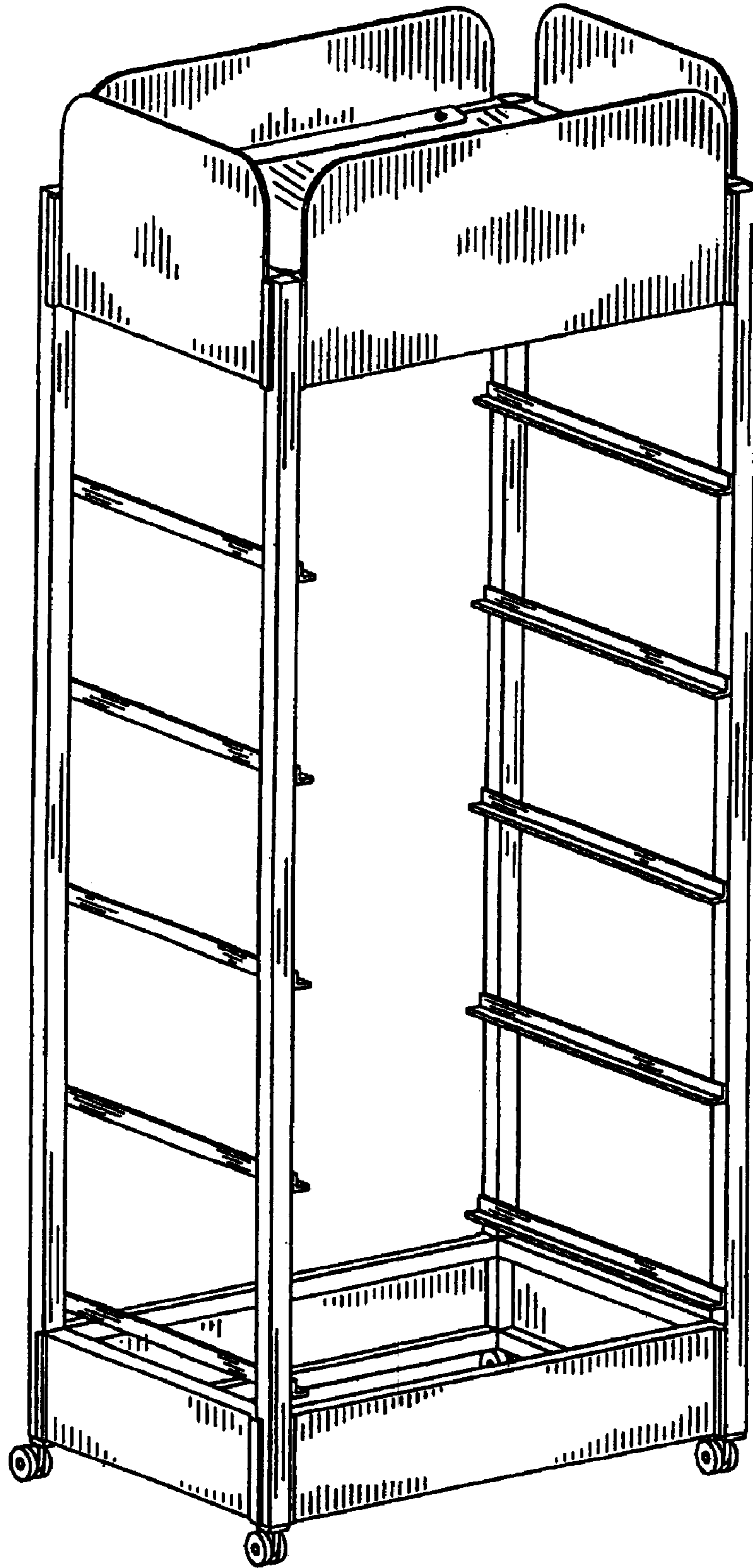

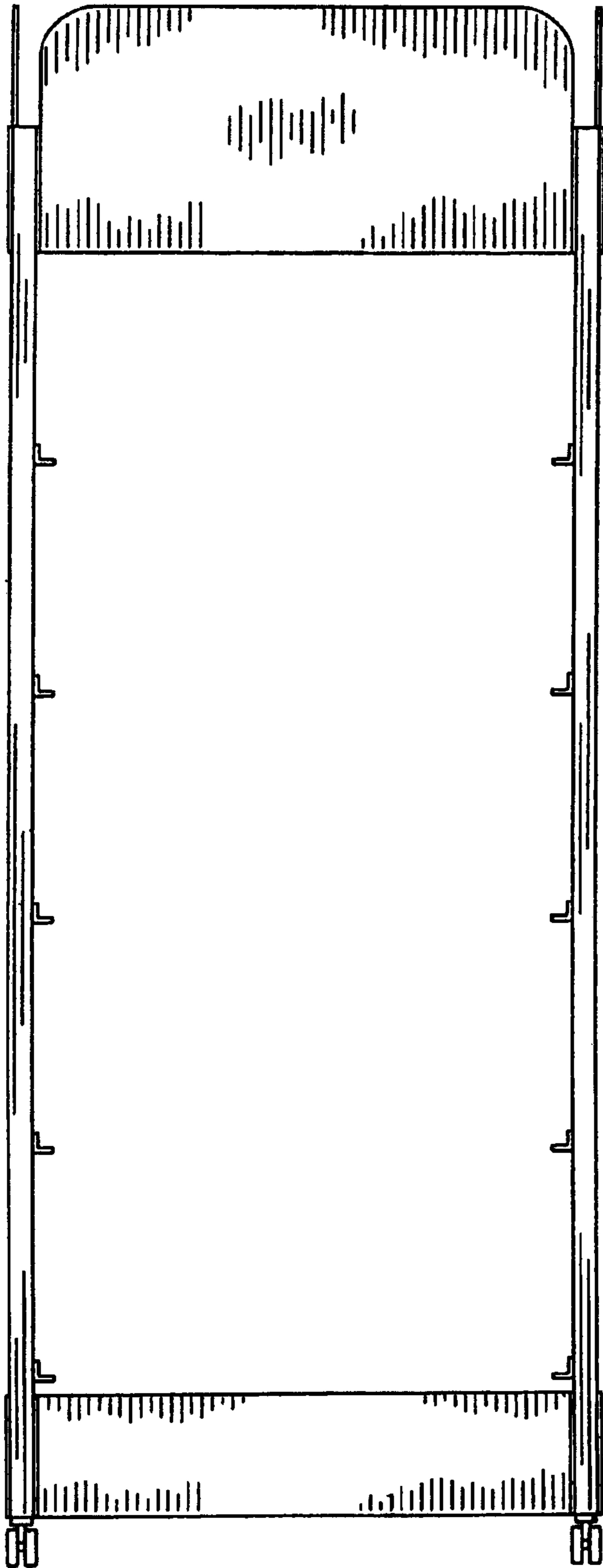

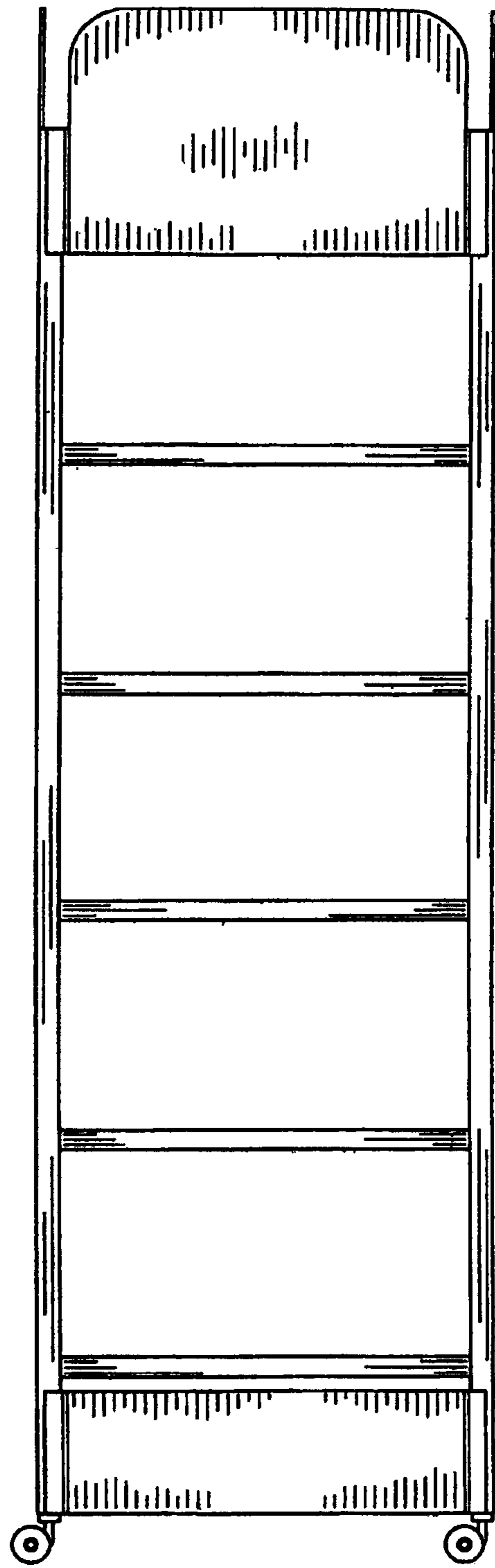

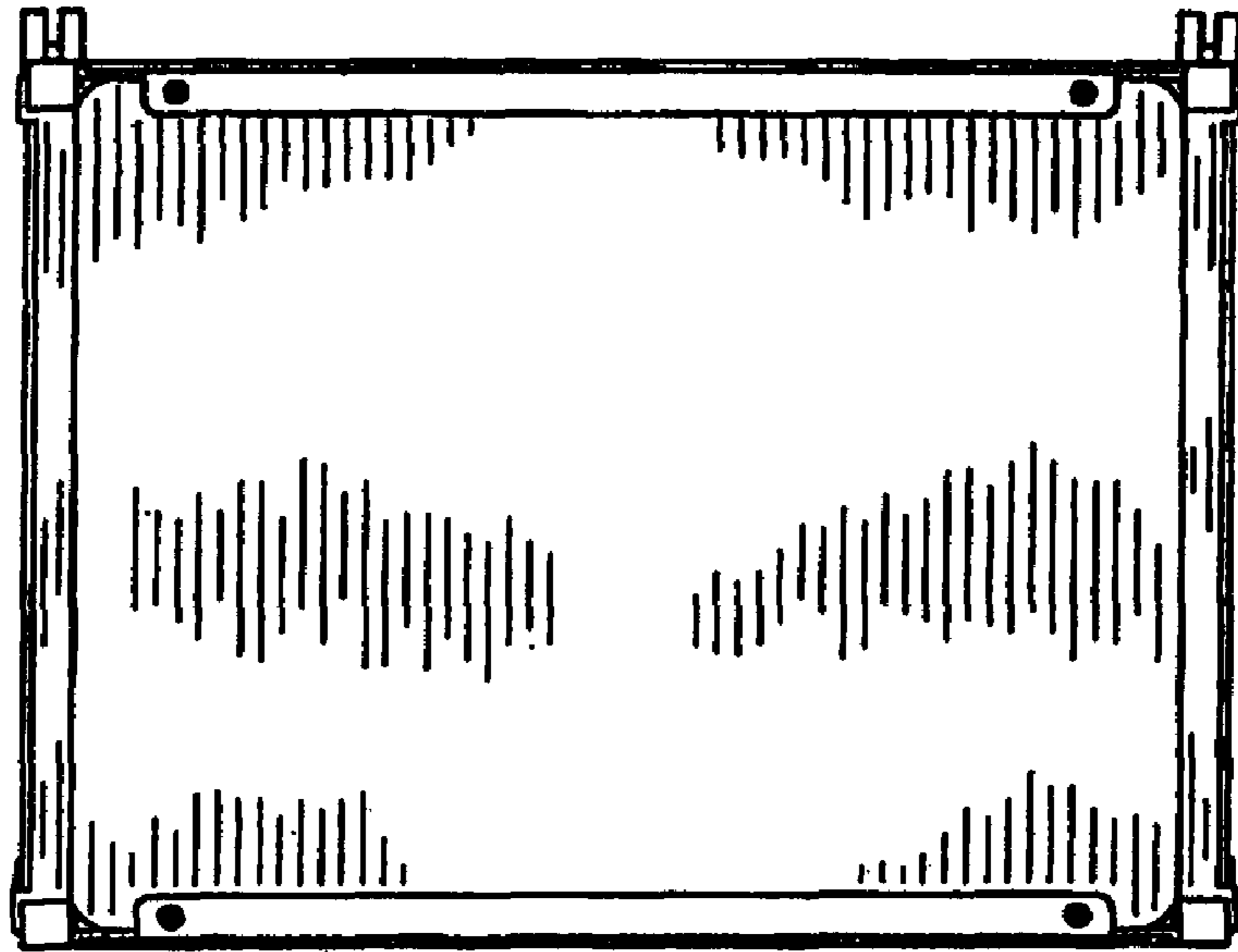

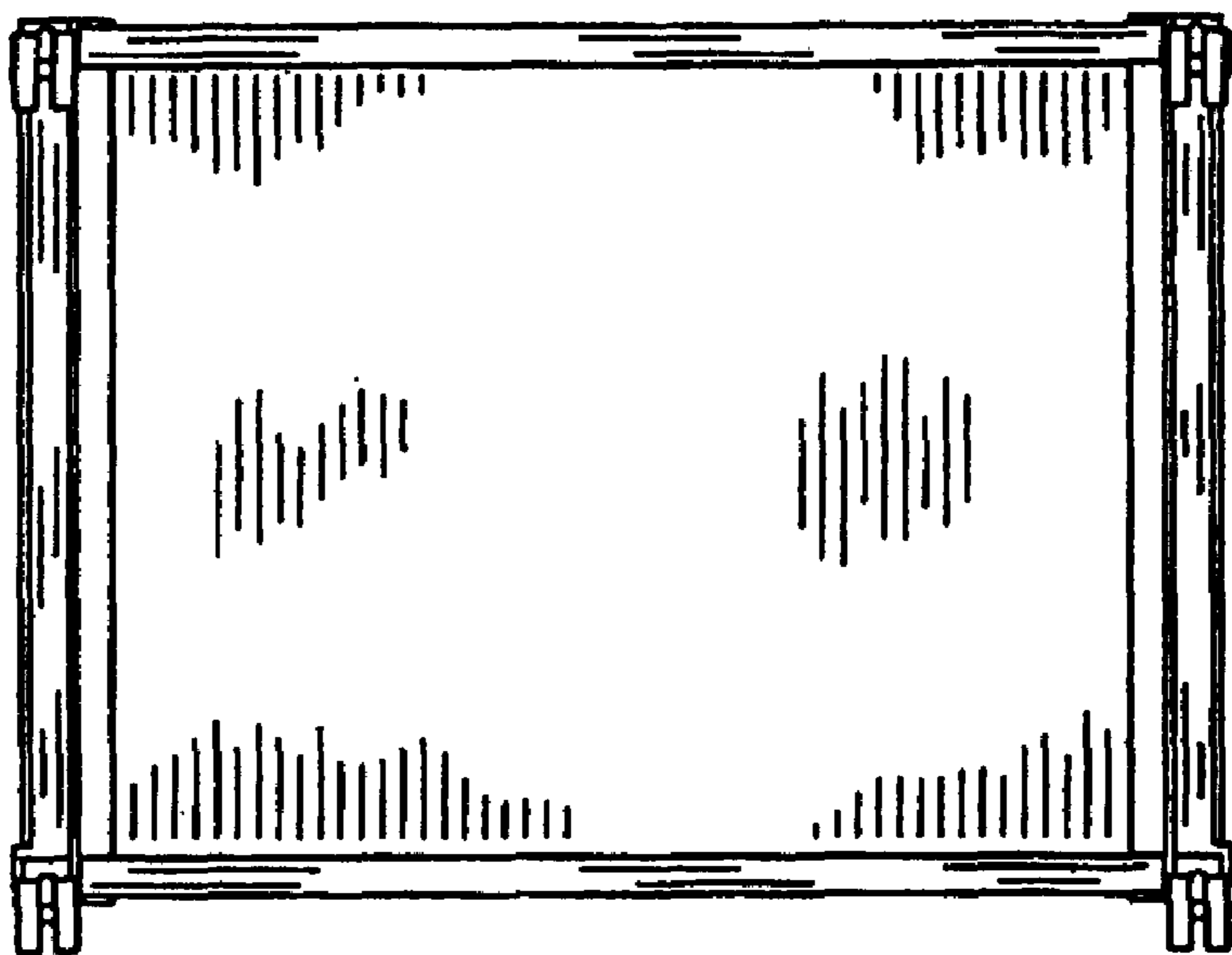
