DESCRIPTION

FIG. 1 is a front and right side perspective view of a wrist watch showing my new design;

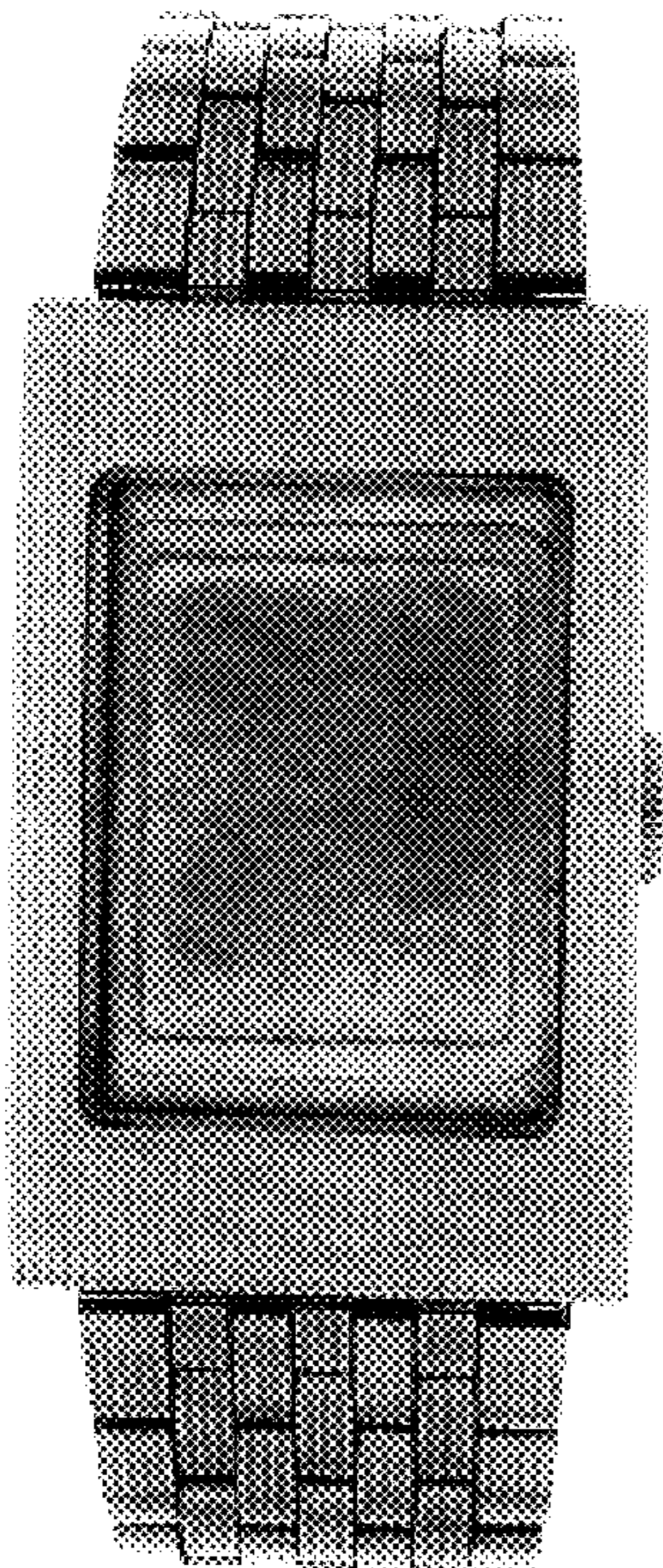

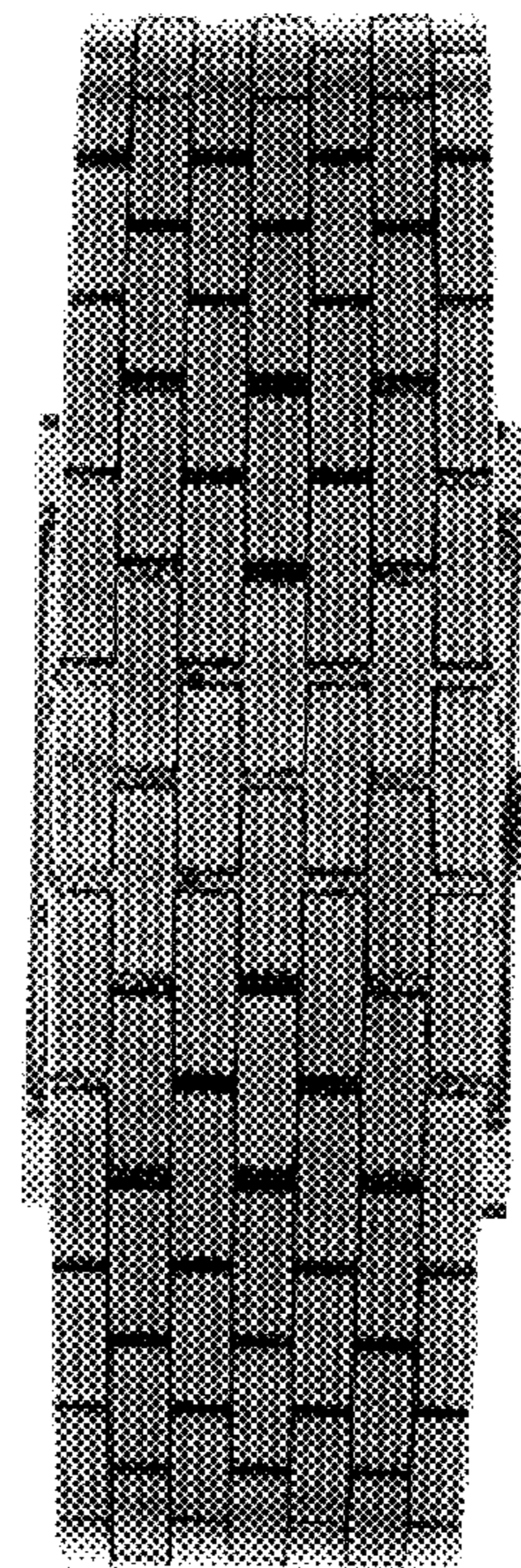

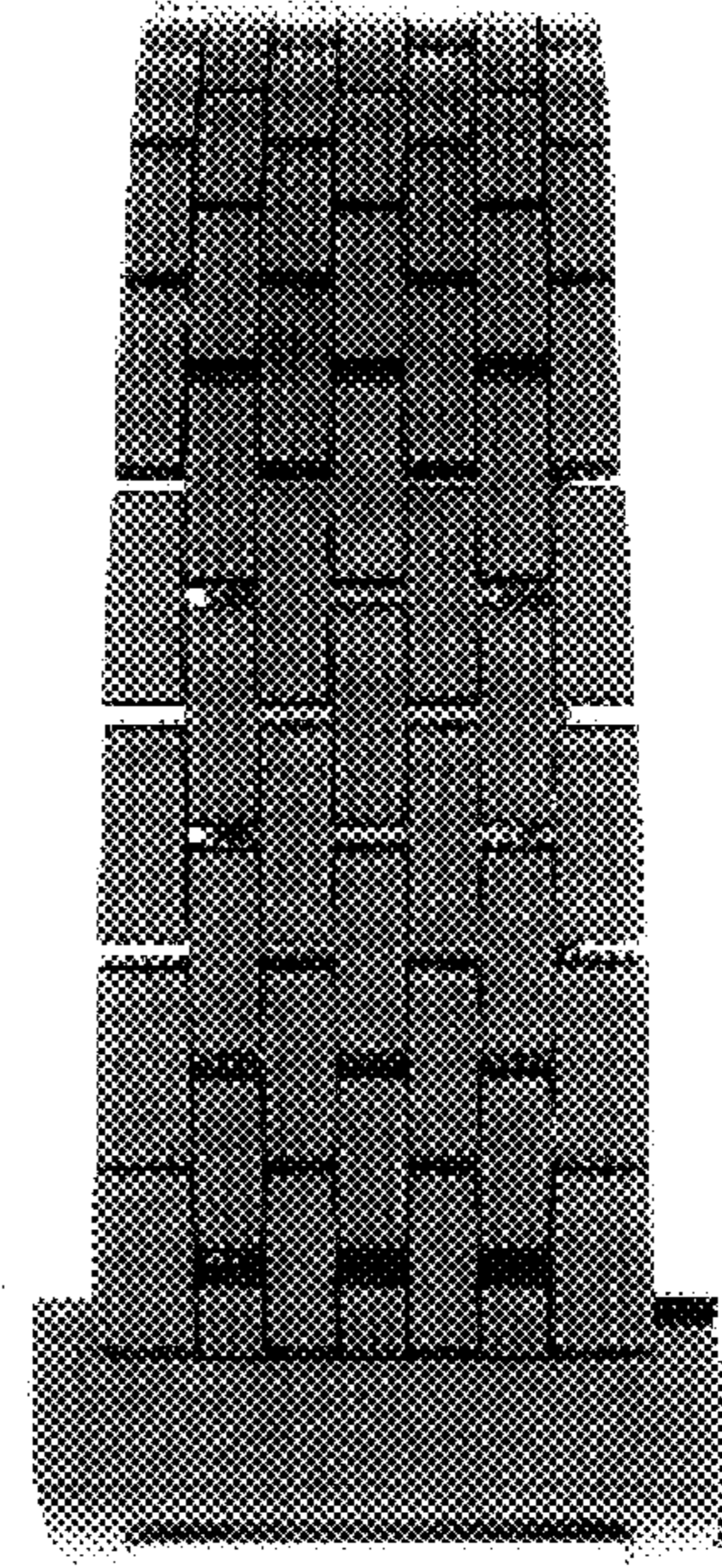

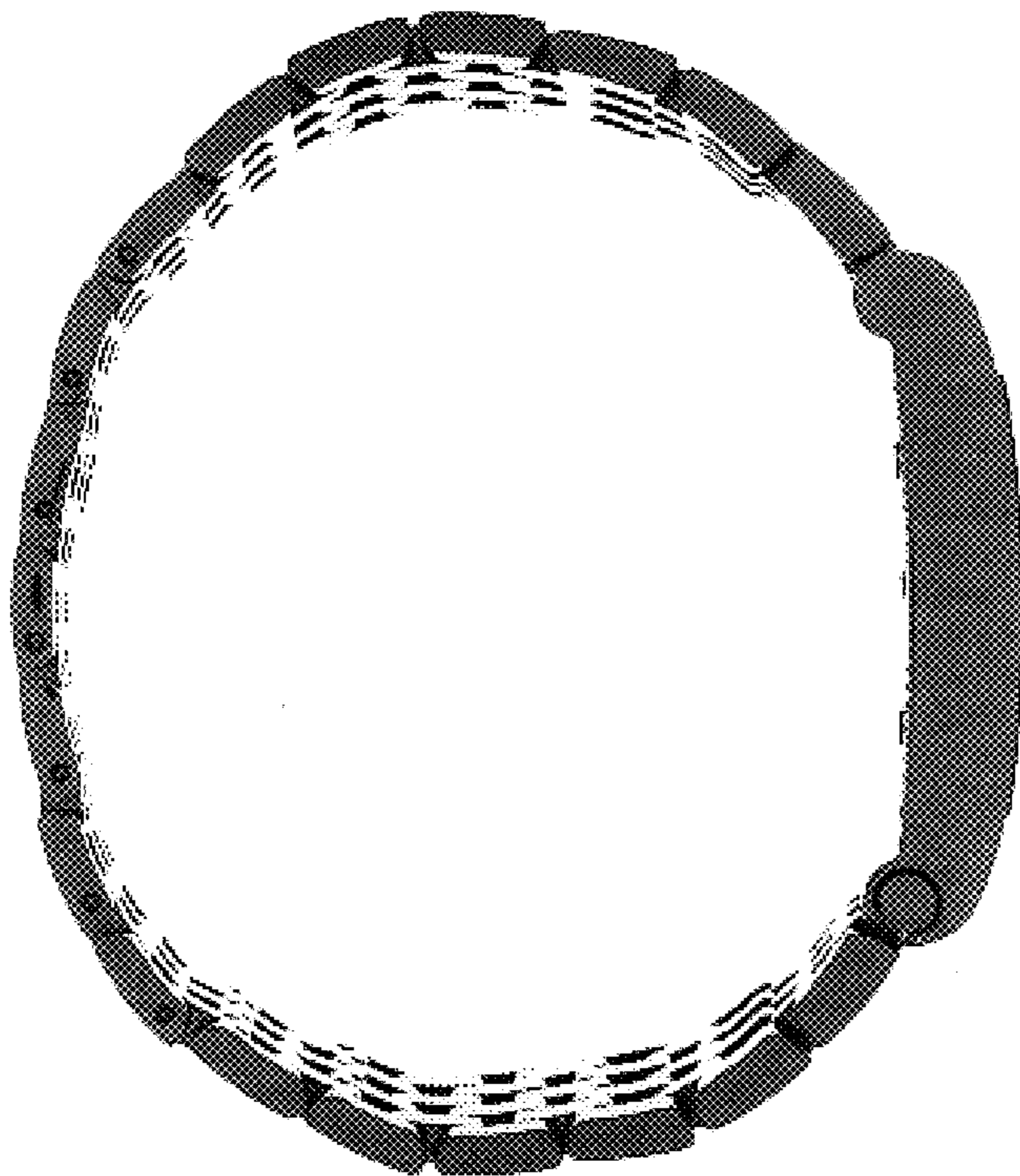
