FIG. 1 is the front elevation view of the design of the present invention

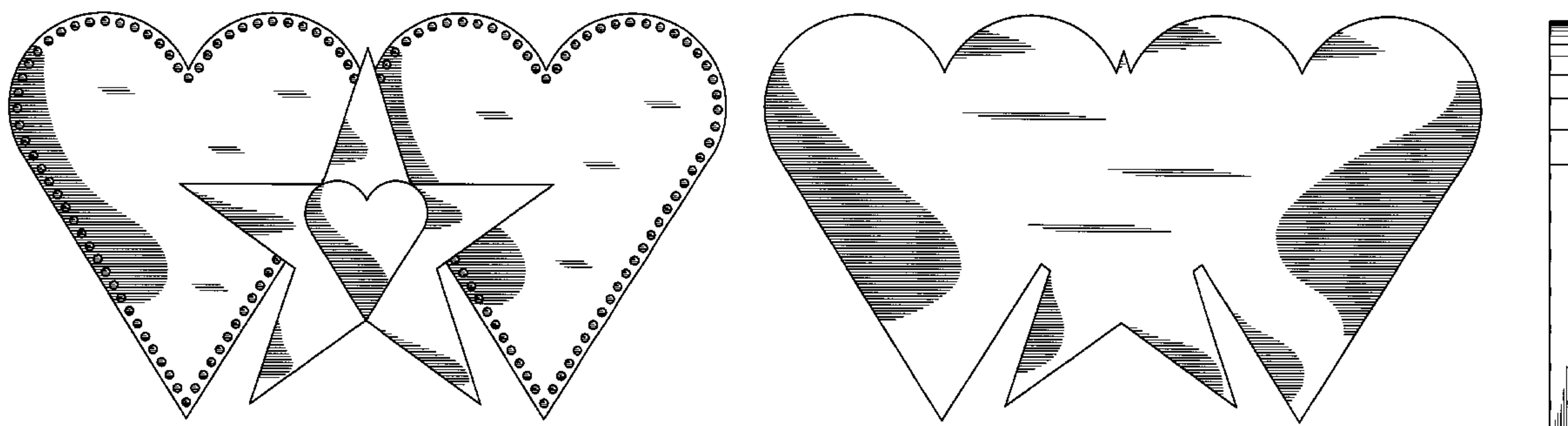
FIG. 2 is the back view of the design of the present invention.

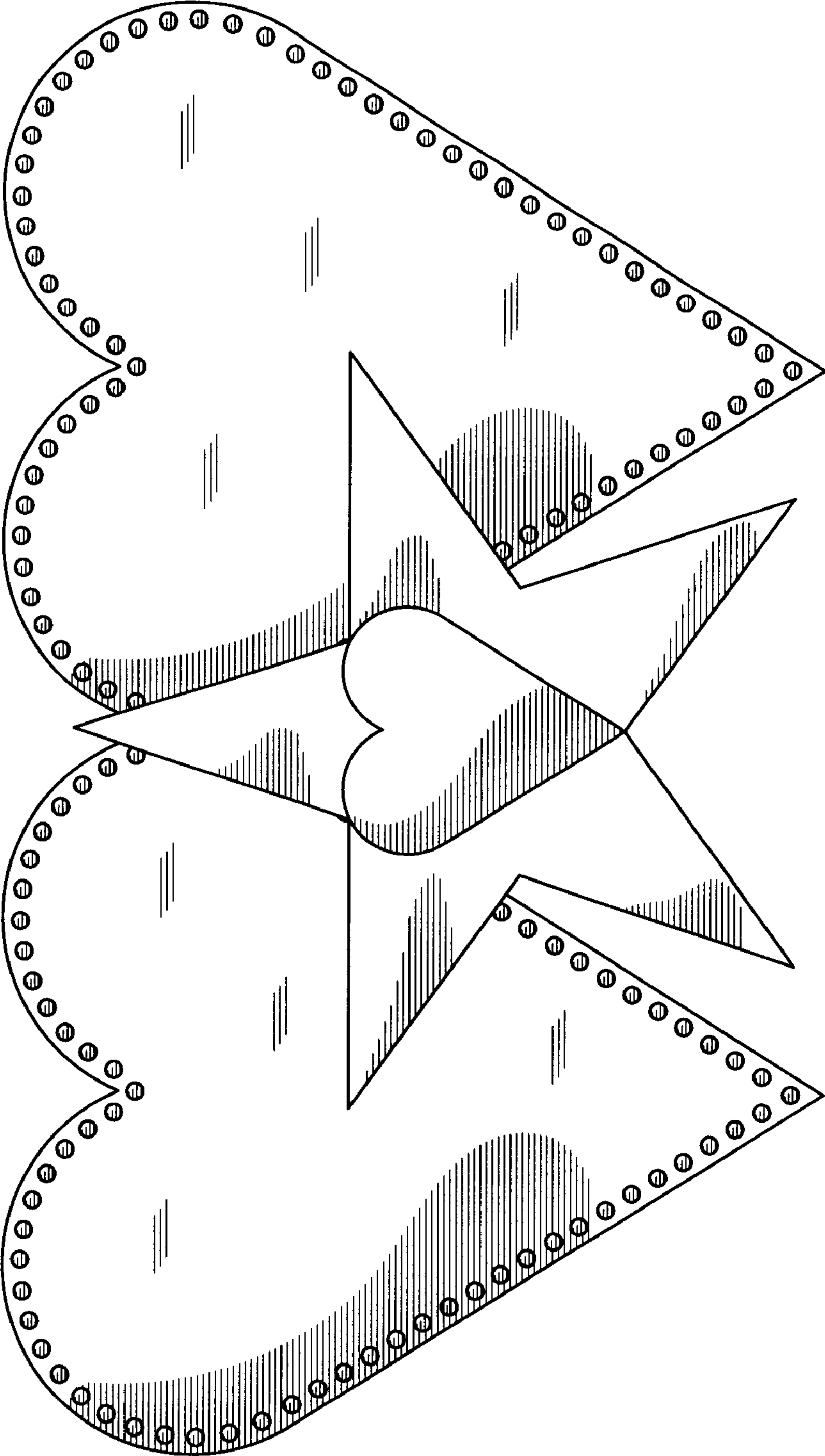

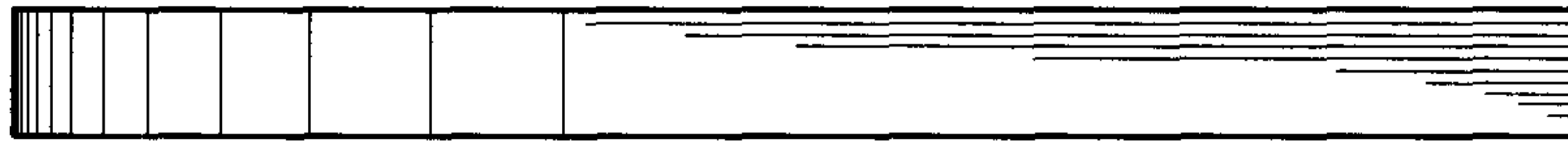
