DESCRIPTION

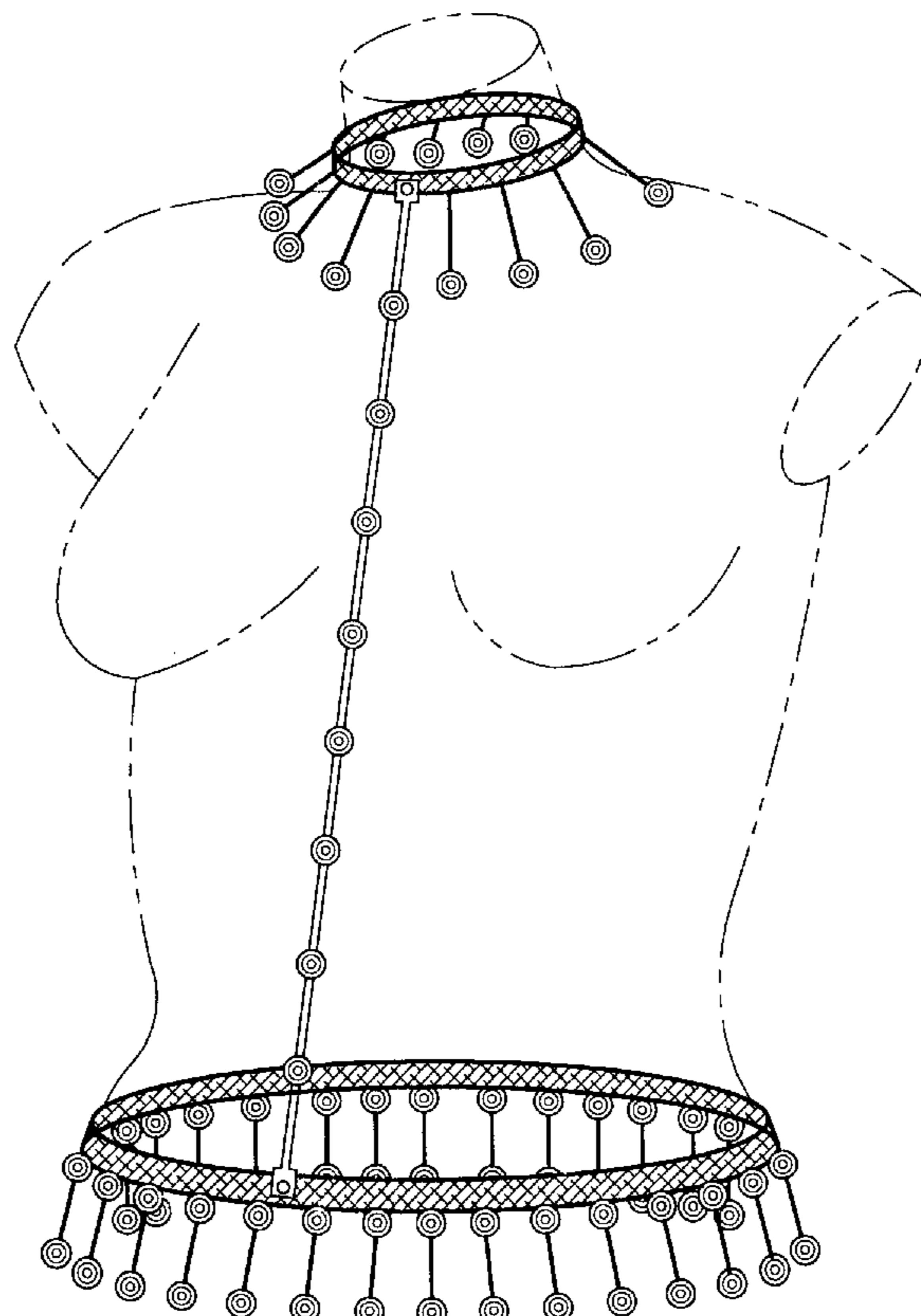
FIG. 1 is a front view of a decorative waistlet showing our new design;

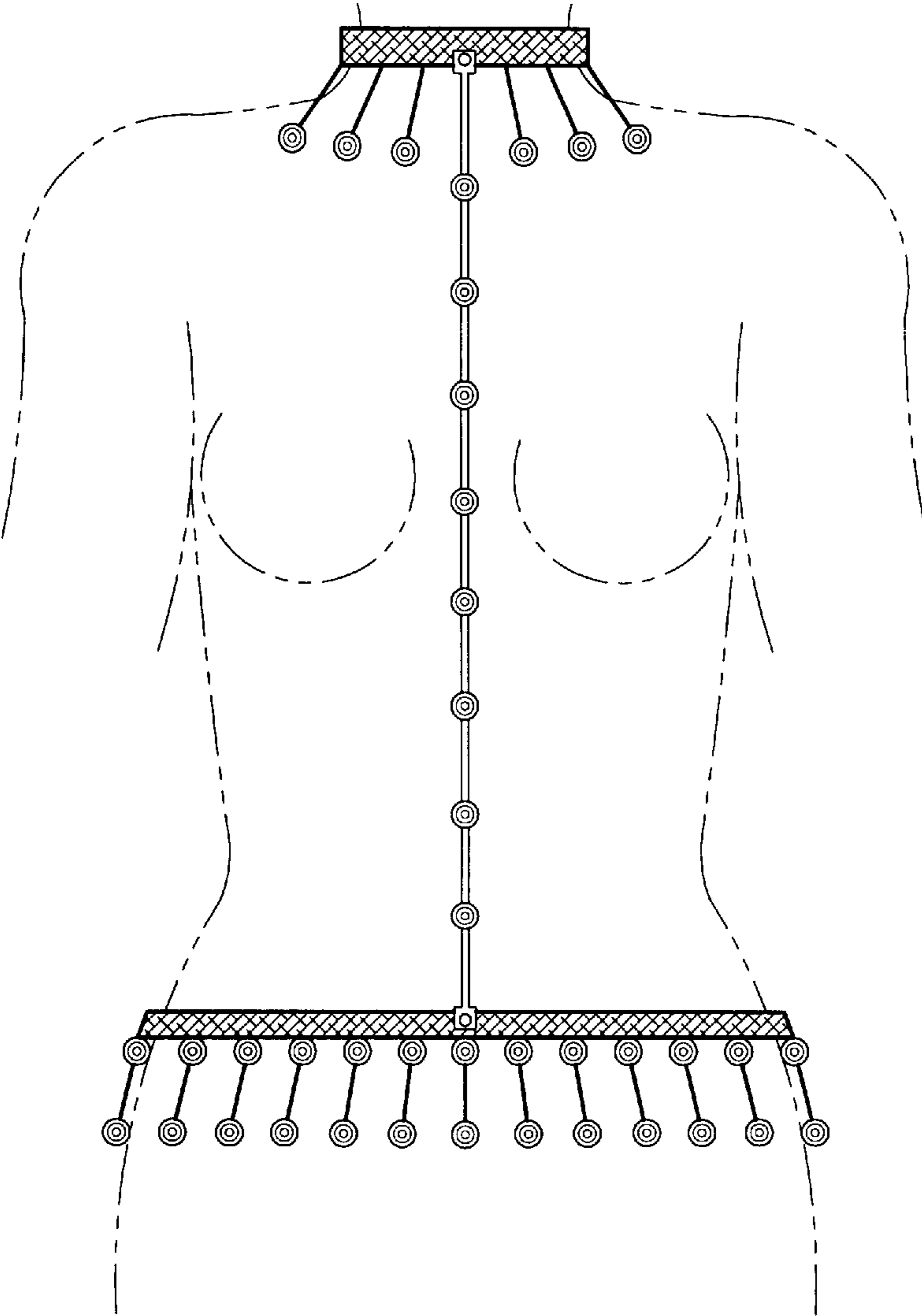

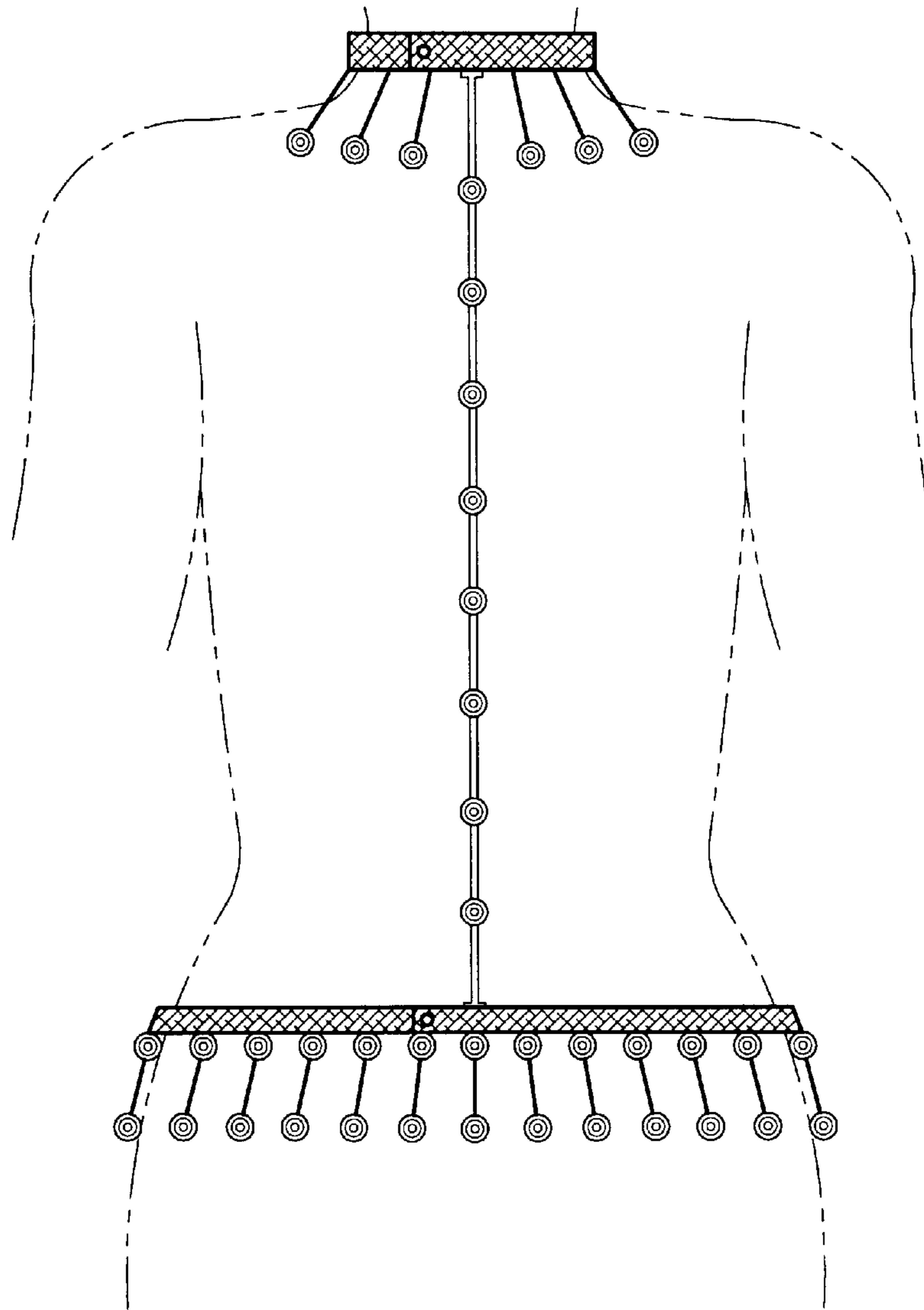

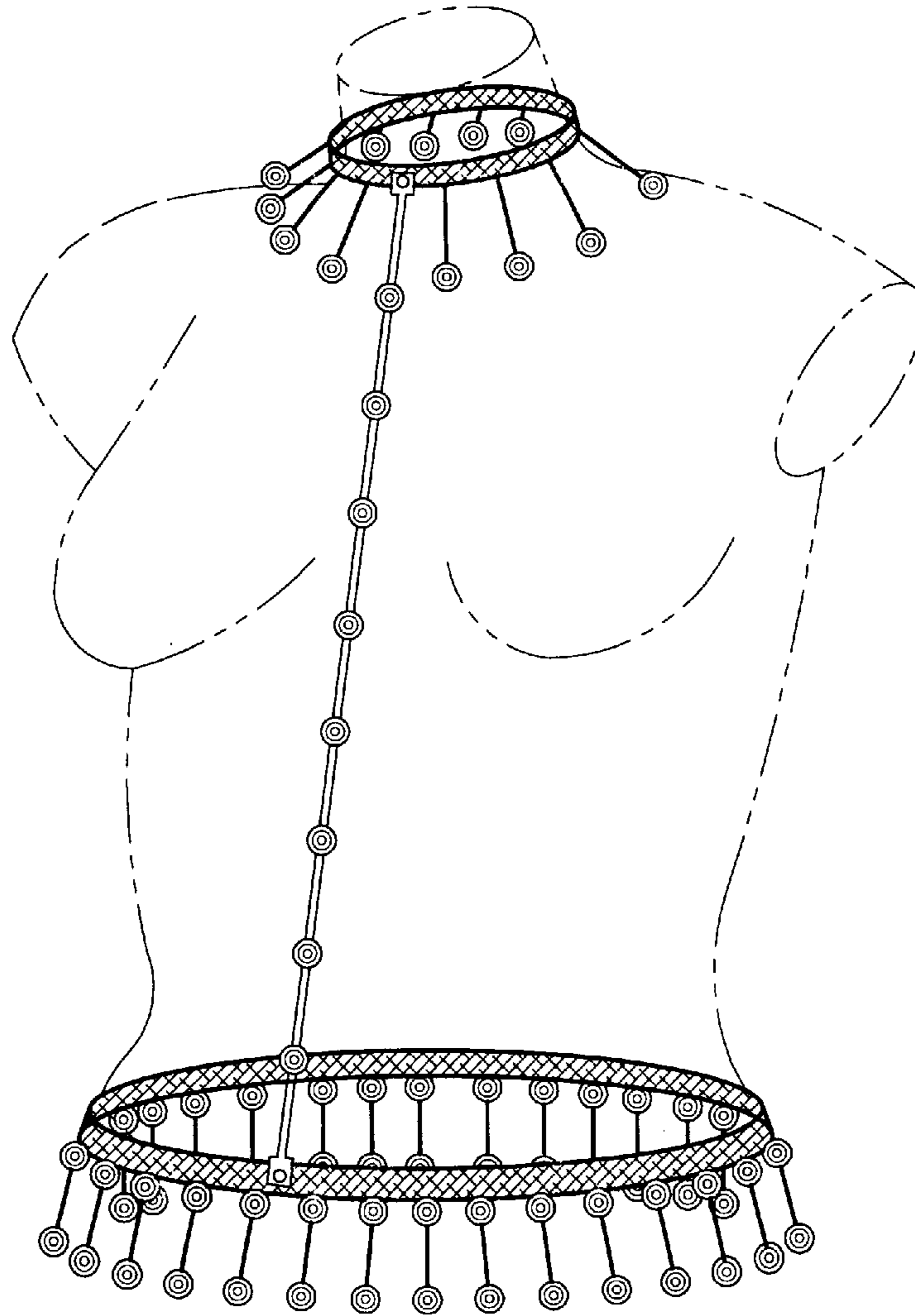
