(57) **CLAIM**

We claim the ornamental design for a combined television receiver with digital video disc player and video tape recorder, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a combined television receiver with digital video disc player and video tape recorder of the present invention;

FIG. 3 is a first side view thereof;
FIG. 4 is a rear view thereof;

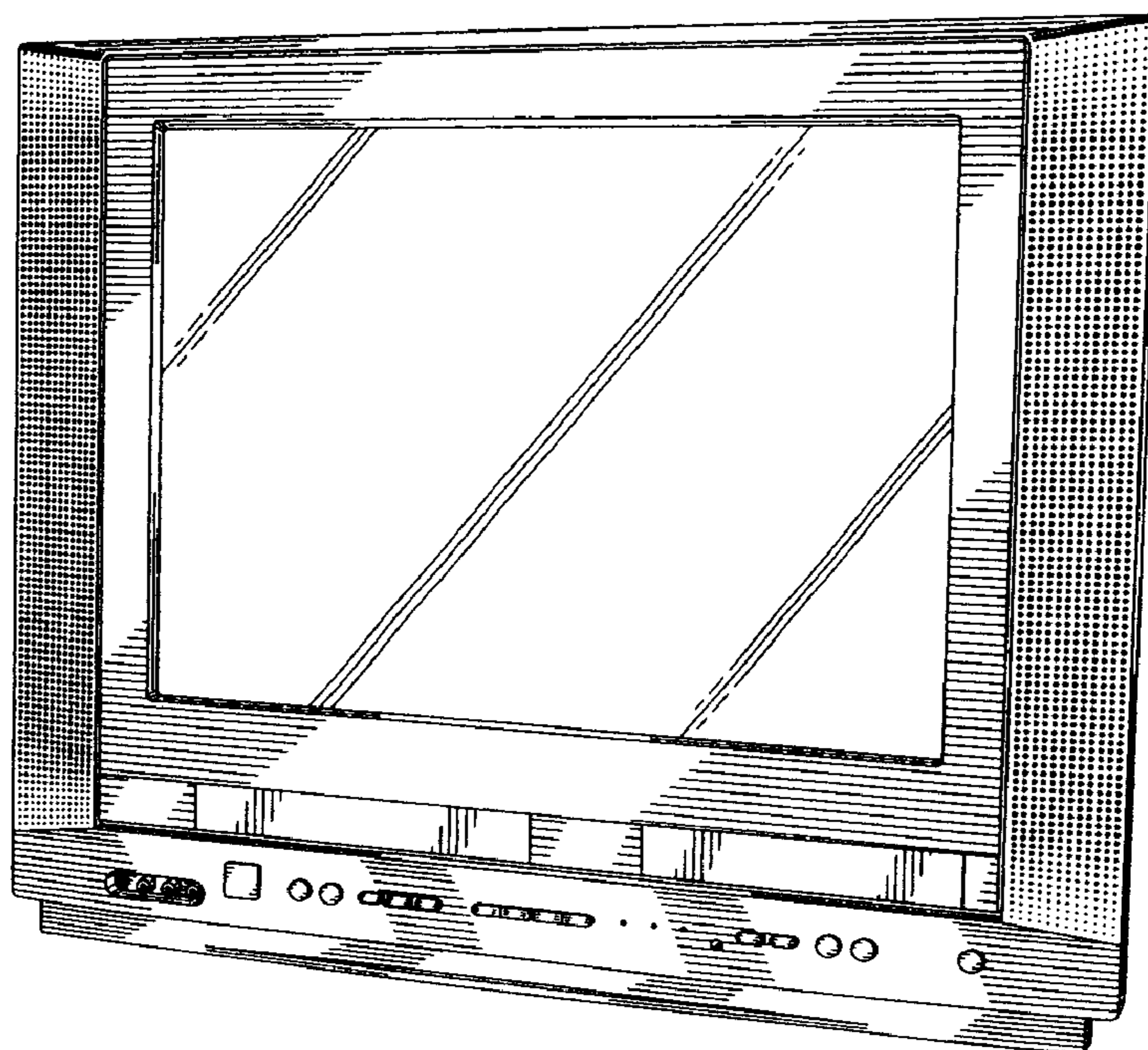

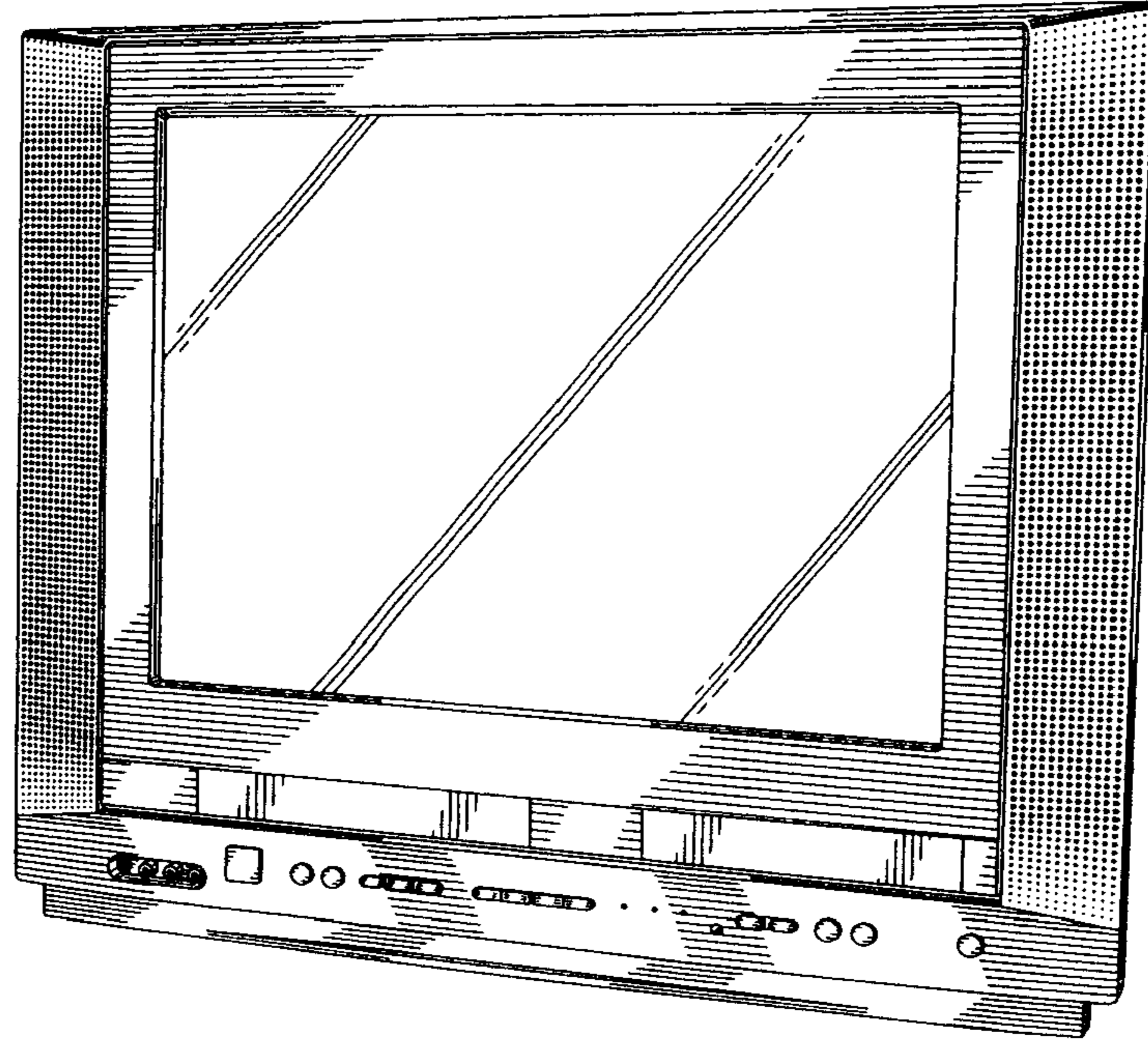

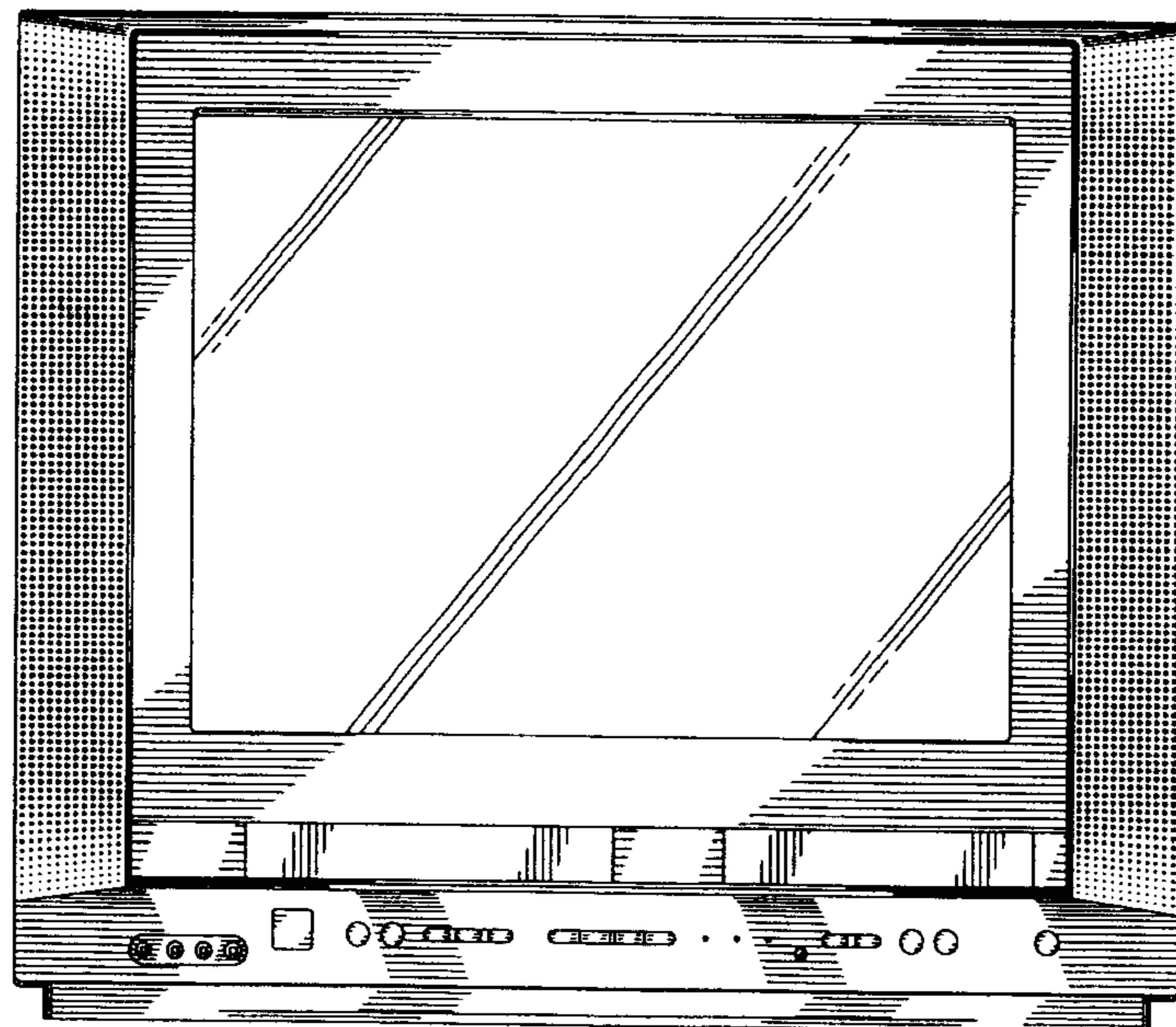

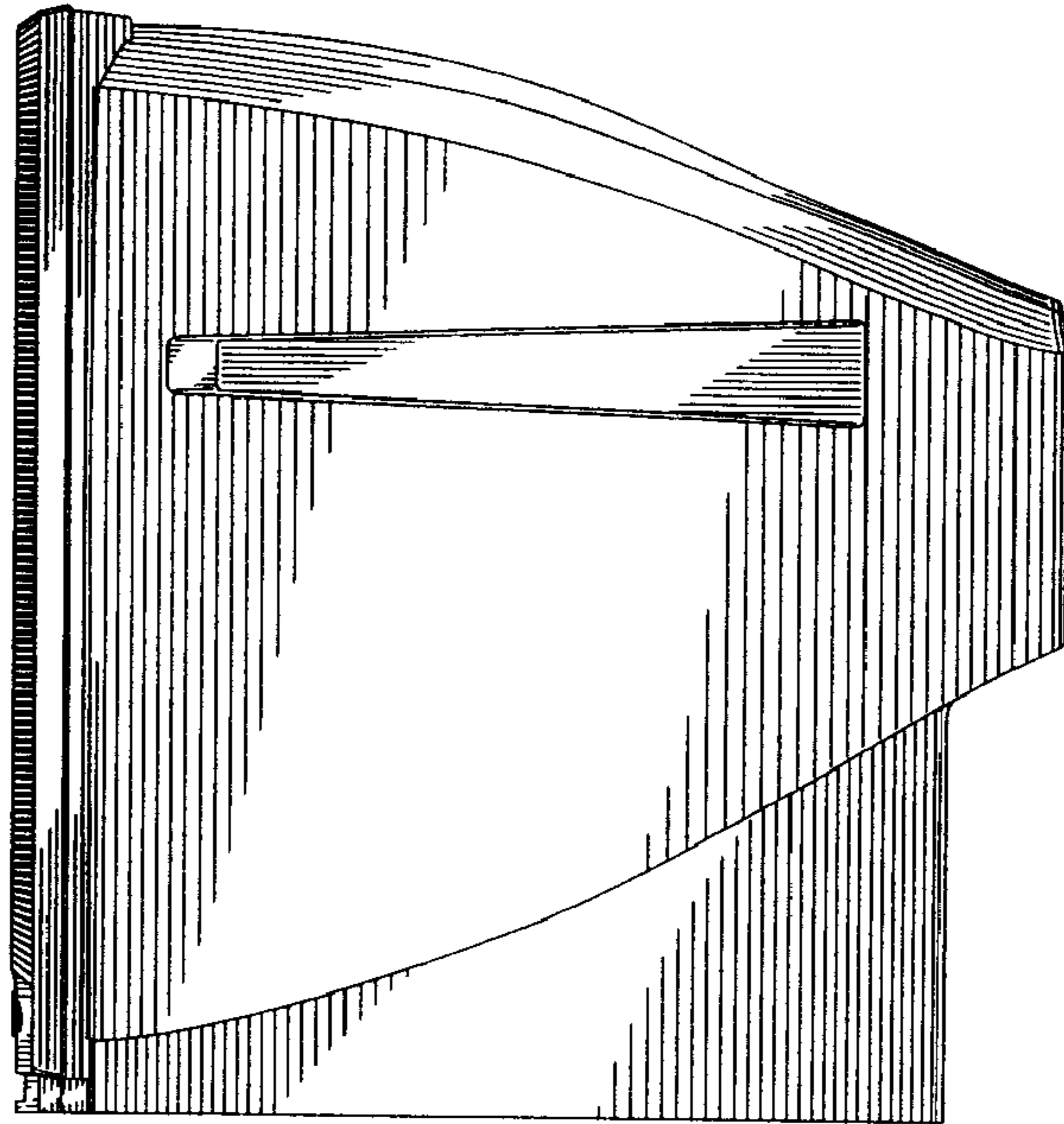

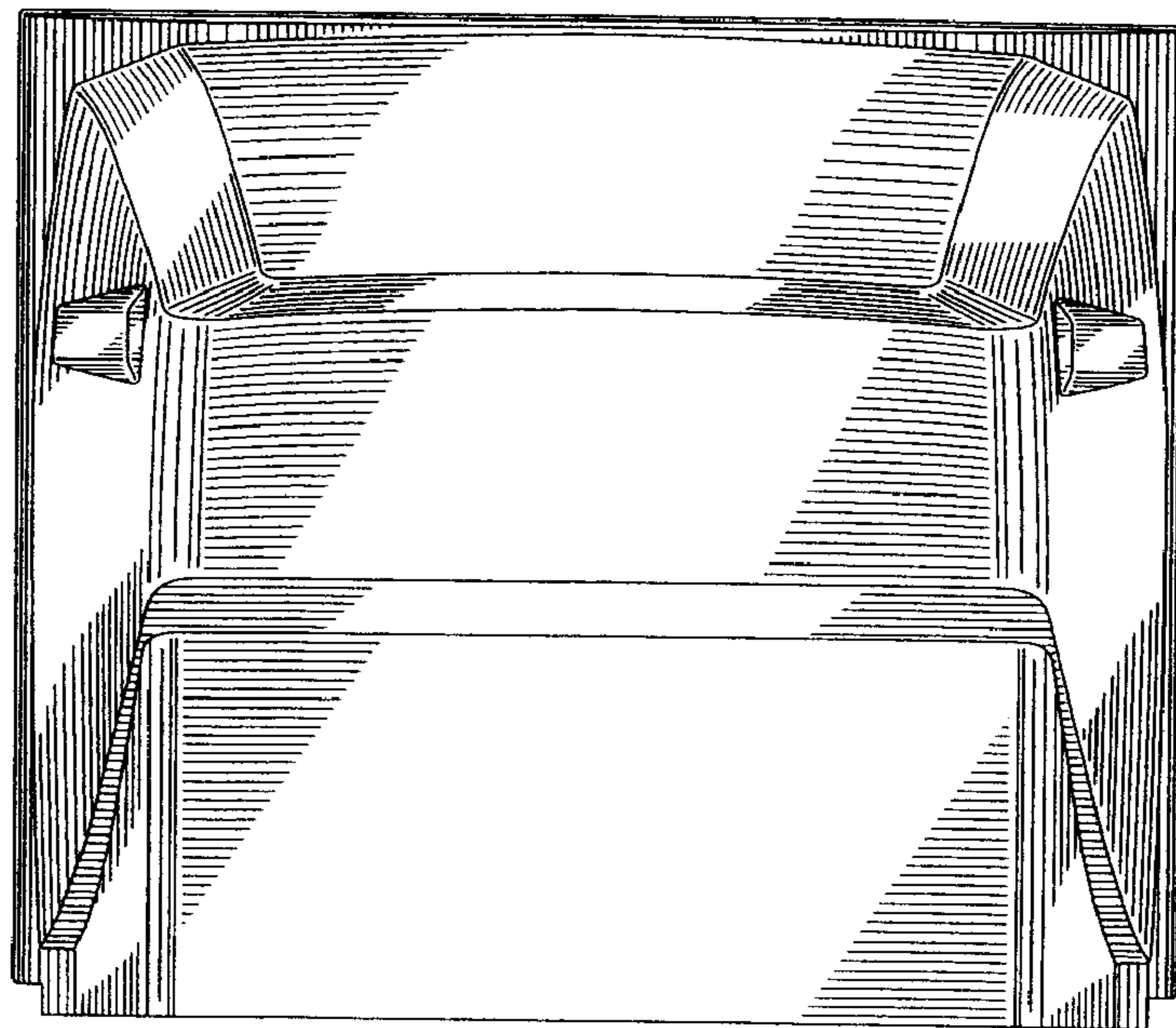

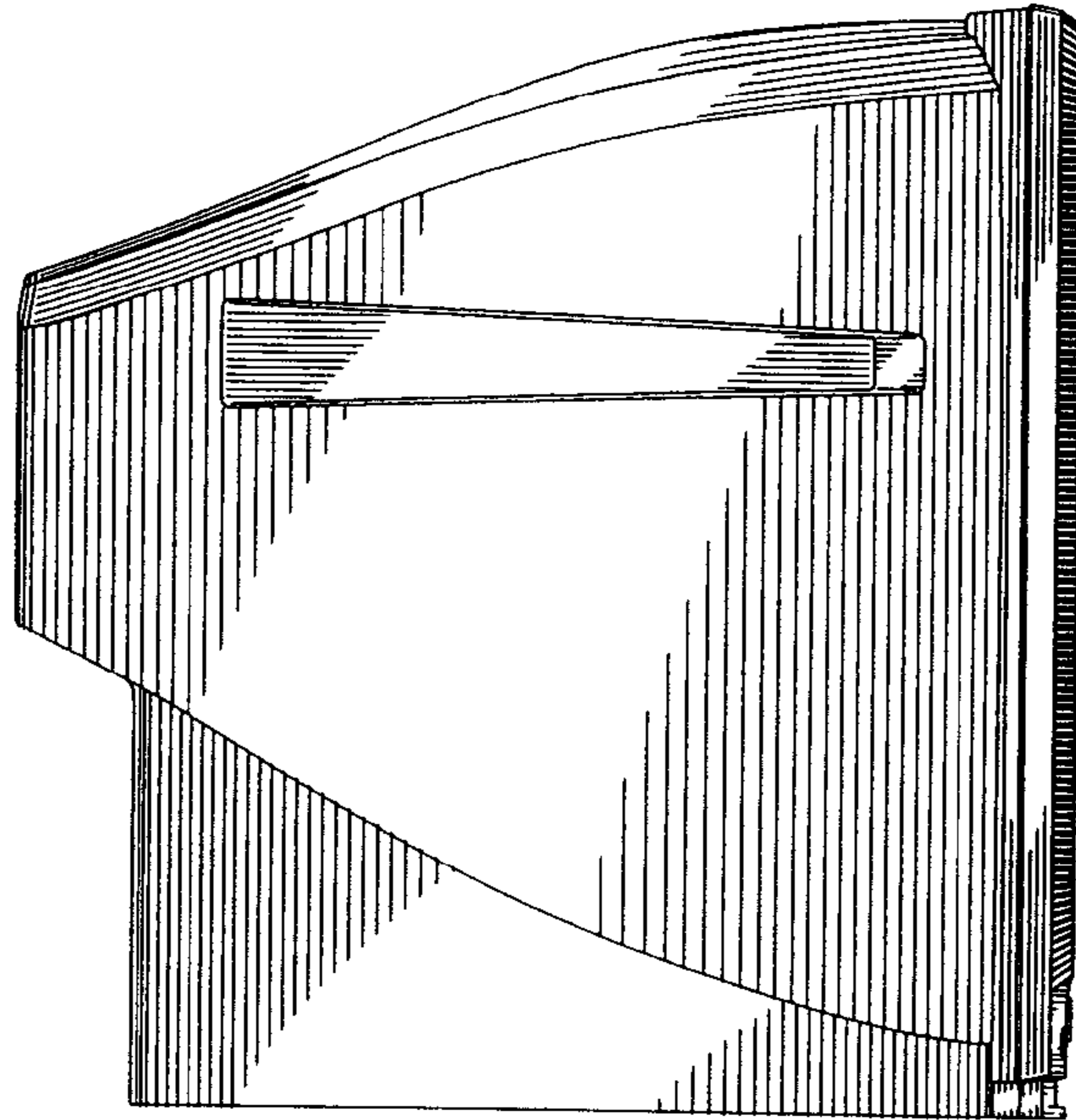

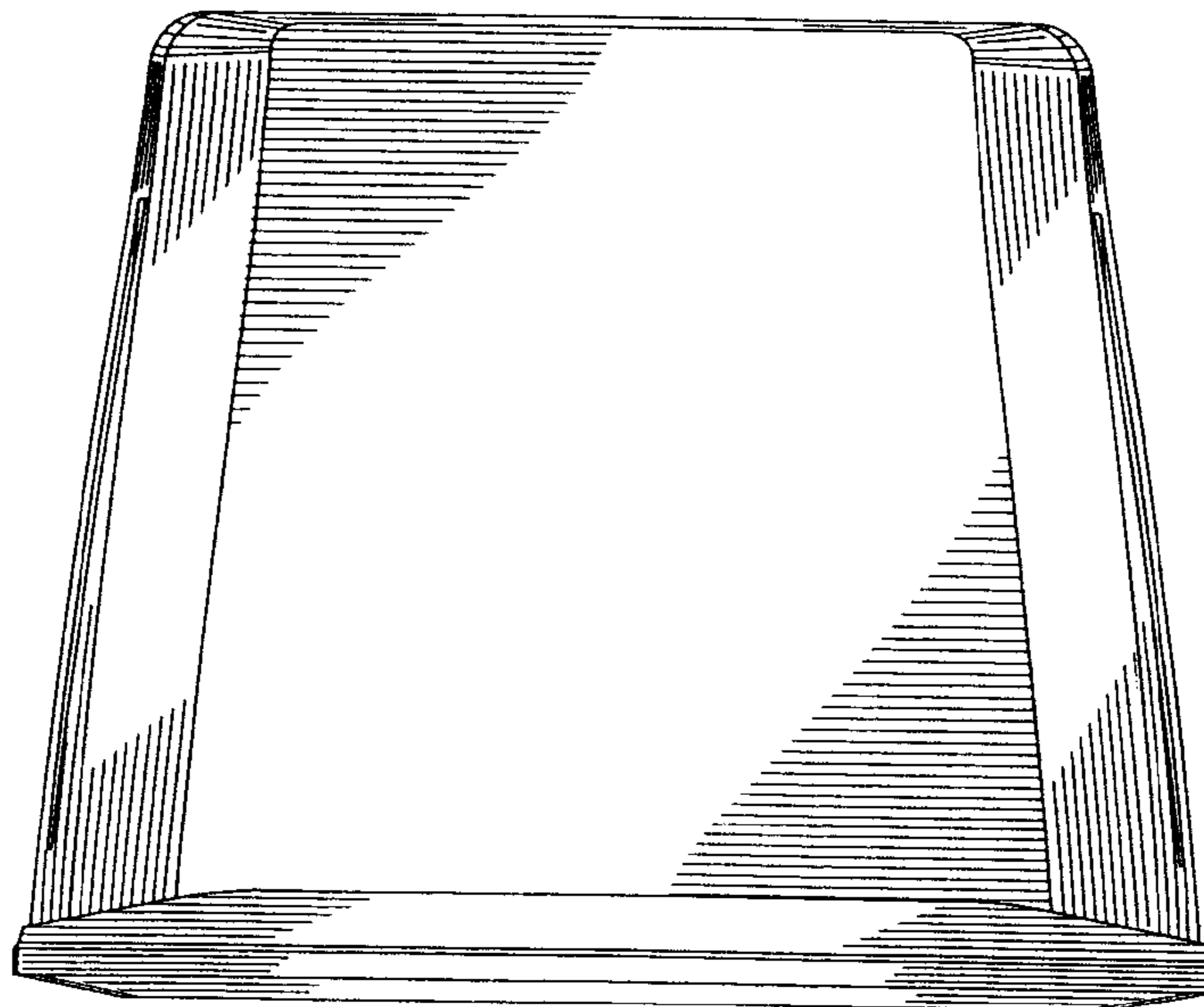
