(57) **CLAIM**

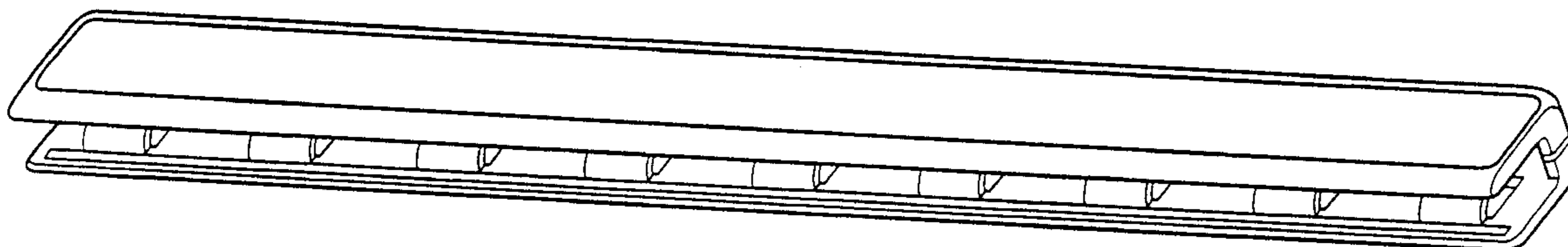
The ornamental design for a rectangular clip, as shown and described.

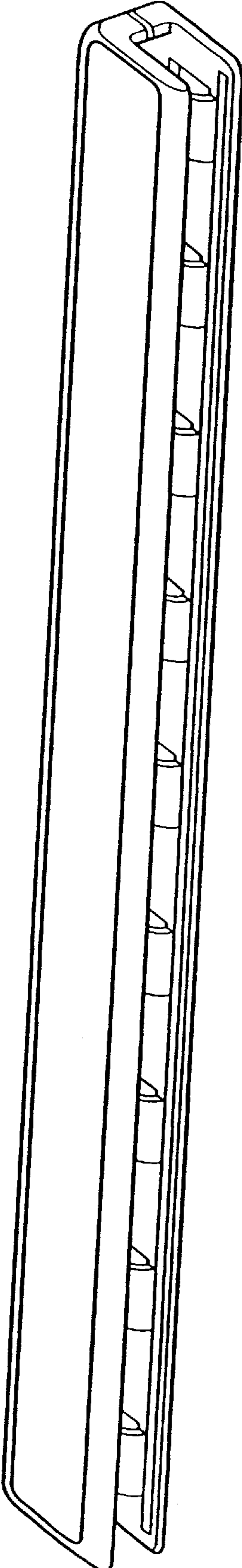

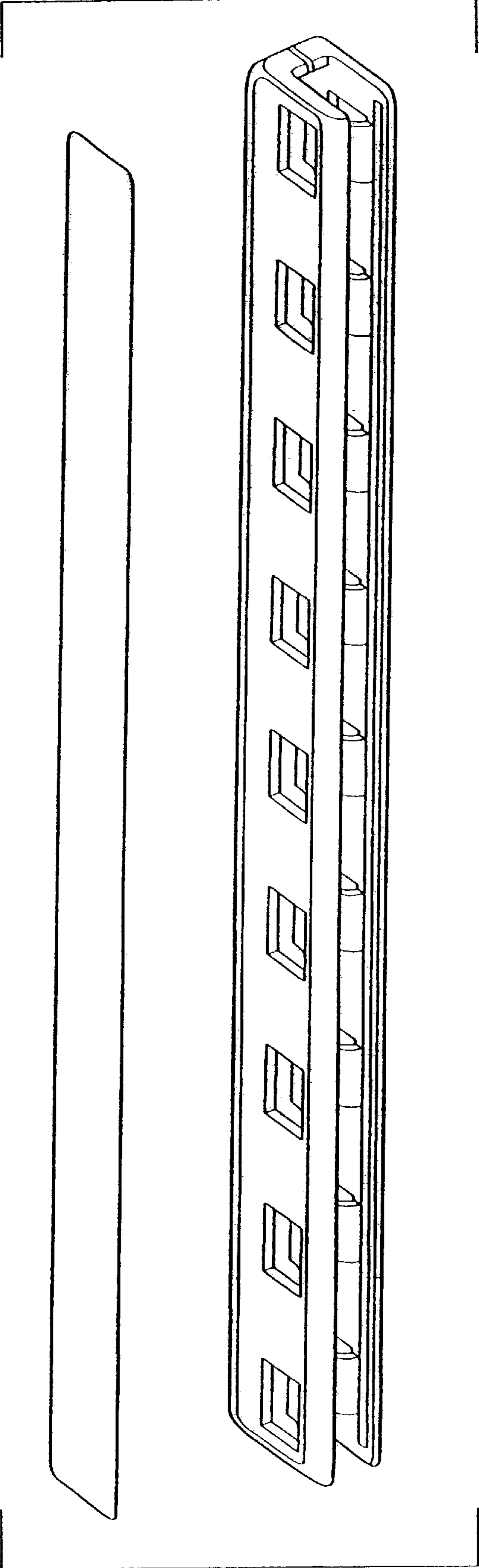

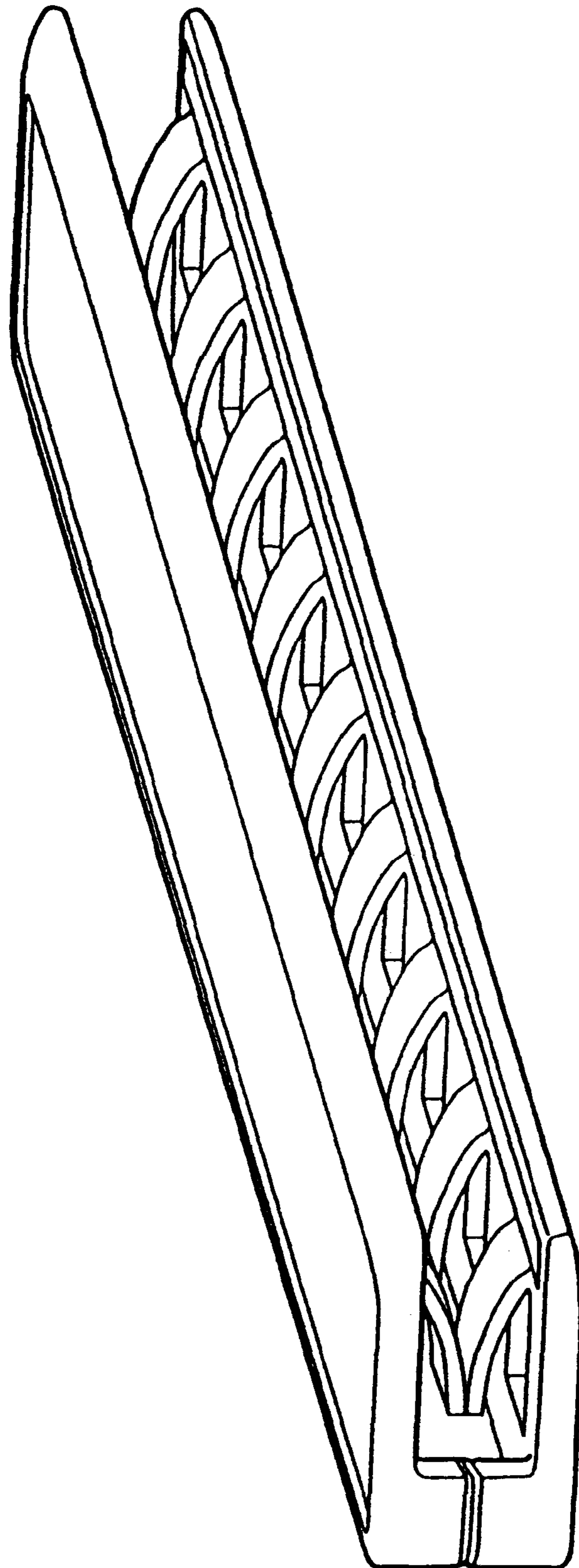
