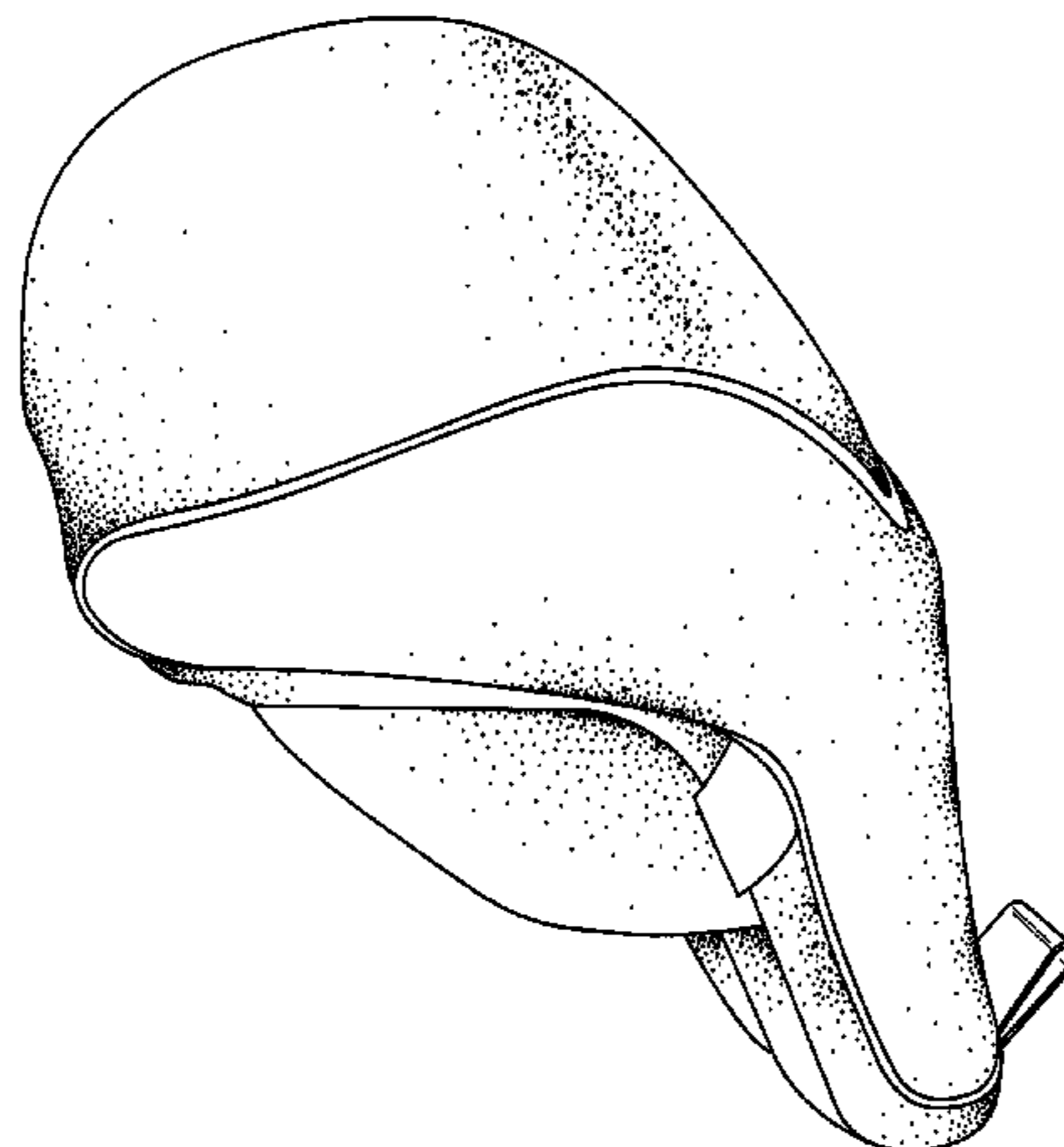
(57) **CLAIM**

I claim the ornamental design of a golf club head cover, substantially as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of a golf club head cover. FIG. 2 is a left side elevational view of the golf club head cover. FIG. 3 is a right side elevational view of the golf club head cover. FIG. 4 is a front elevational view of the golf club head cover. FIG. 5 is a back elevational view of the golf club head cover. FIG. 6 is a top elevational view of the golf club head cover; and, FIG. 7 is a bottom elevational view of the golf club head cover.

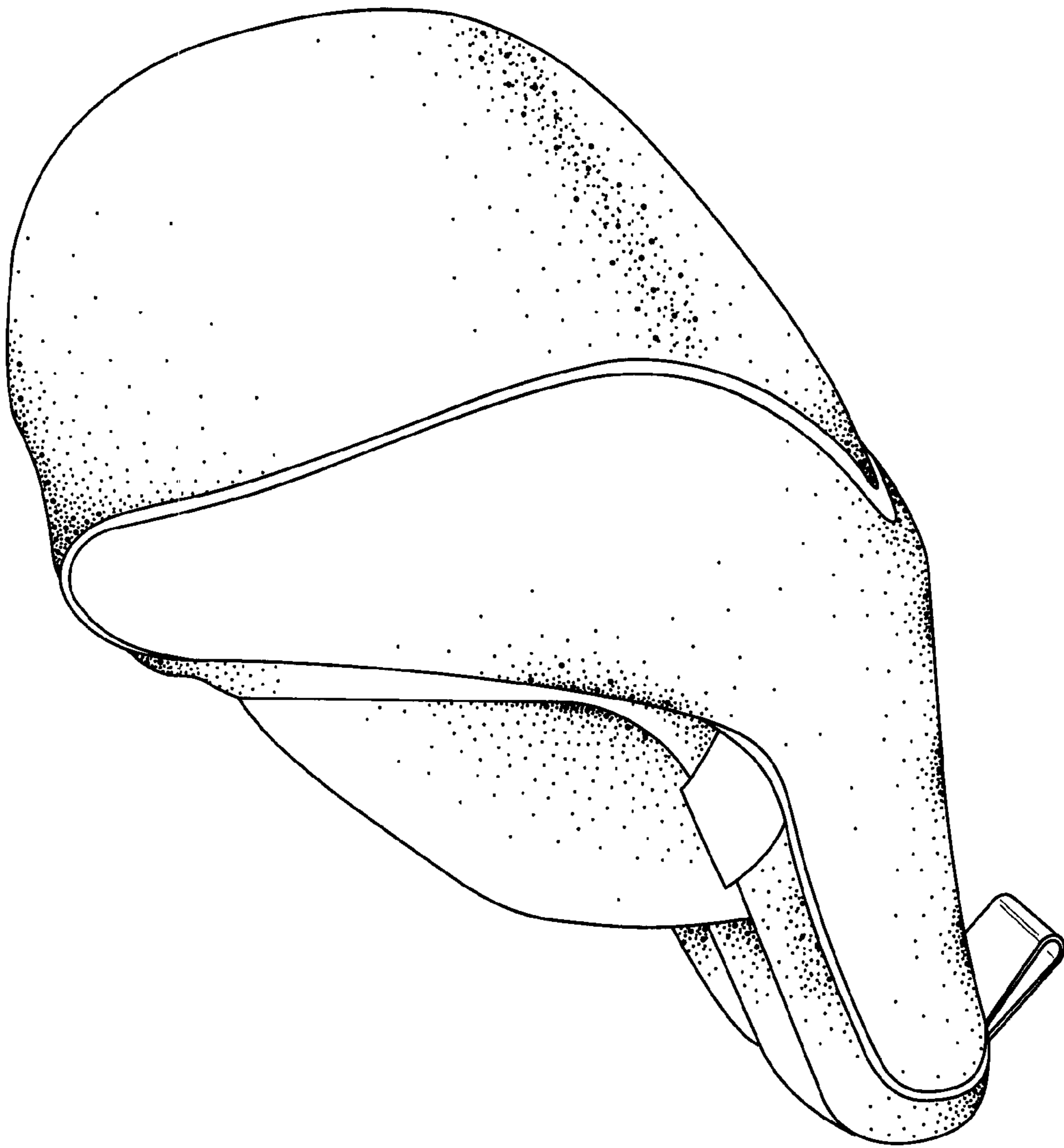

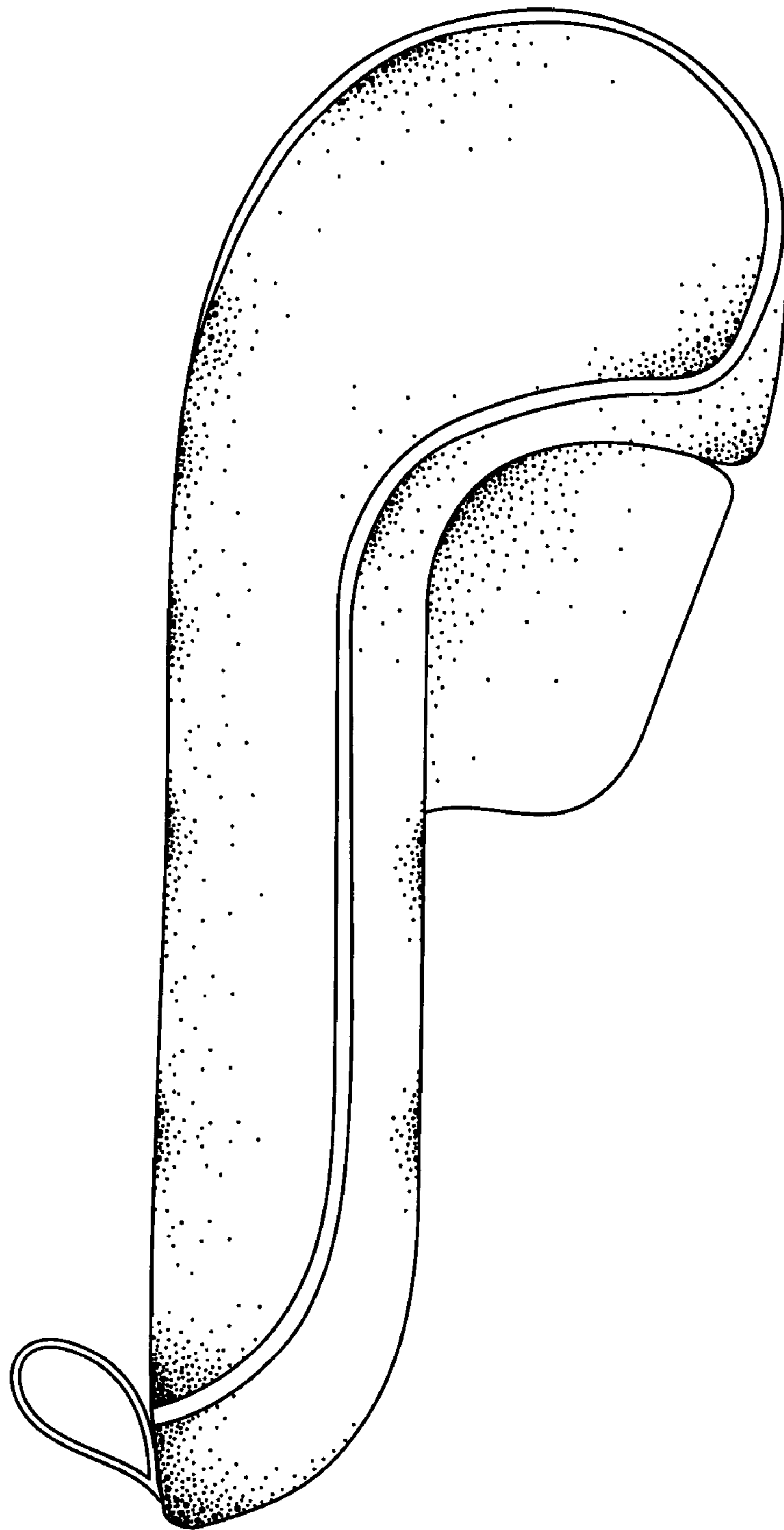

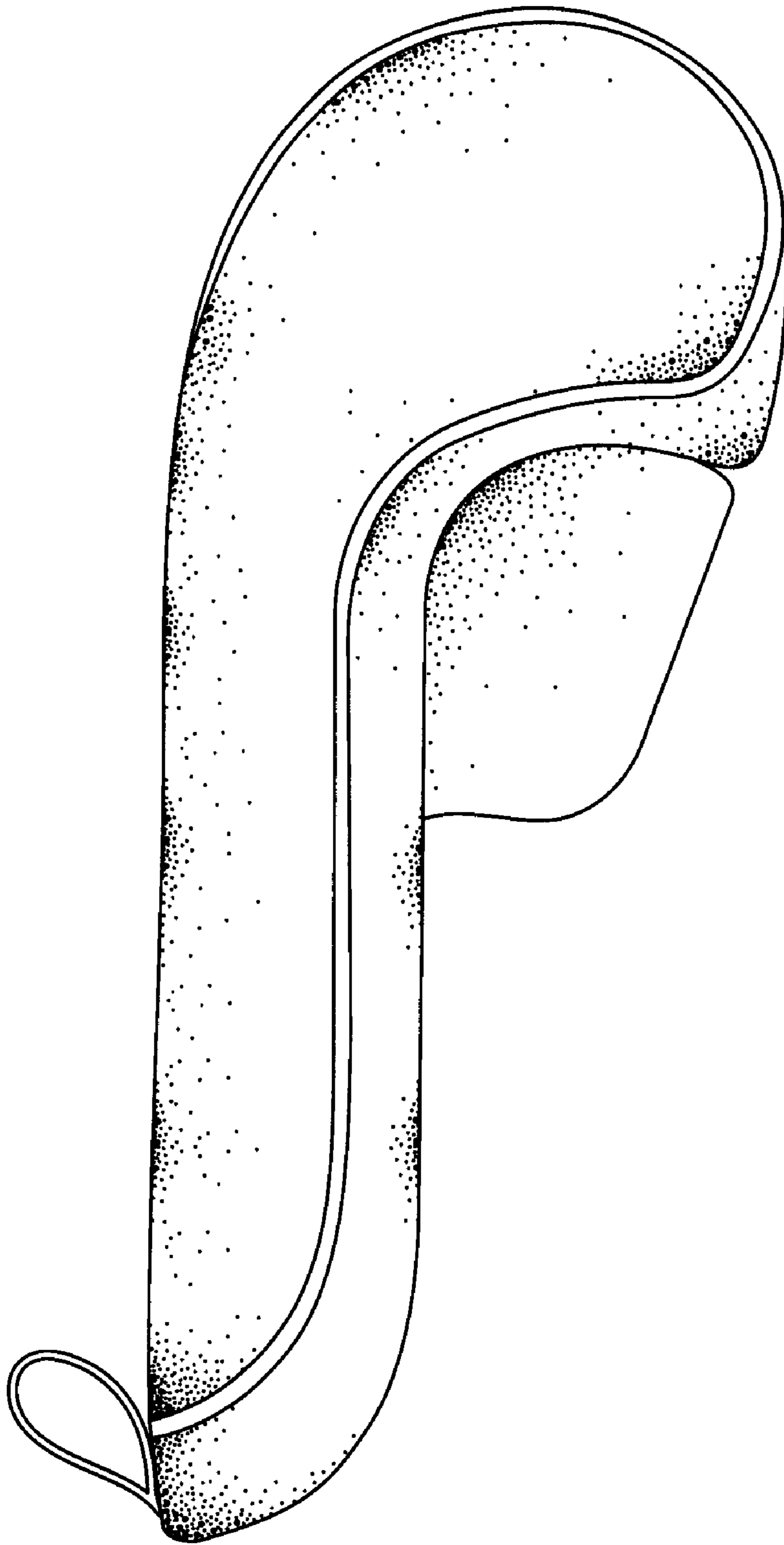

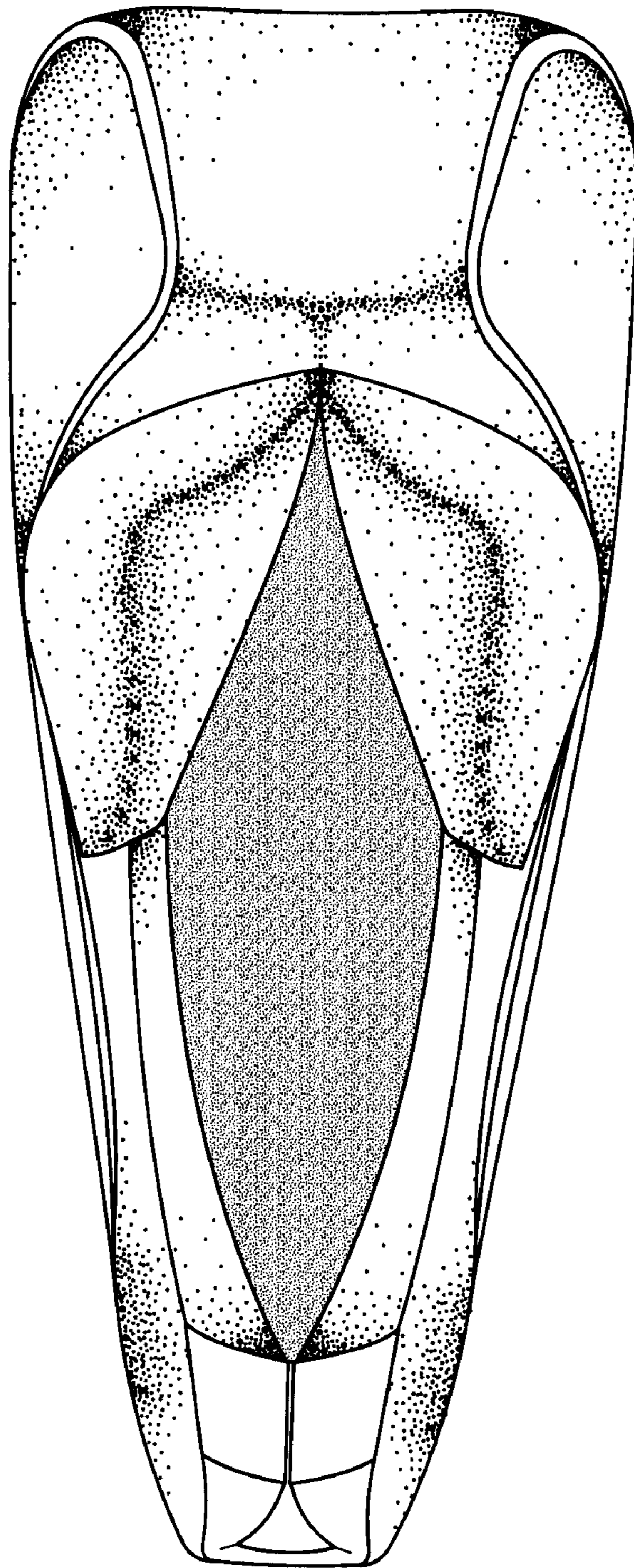

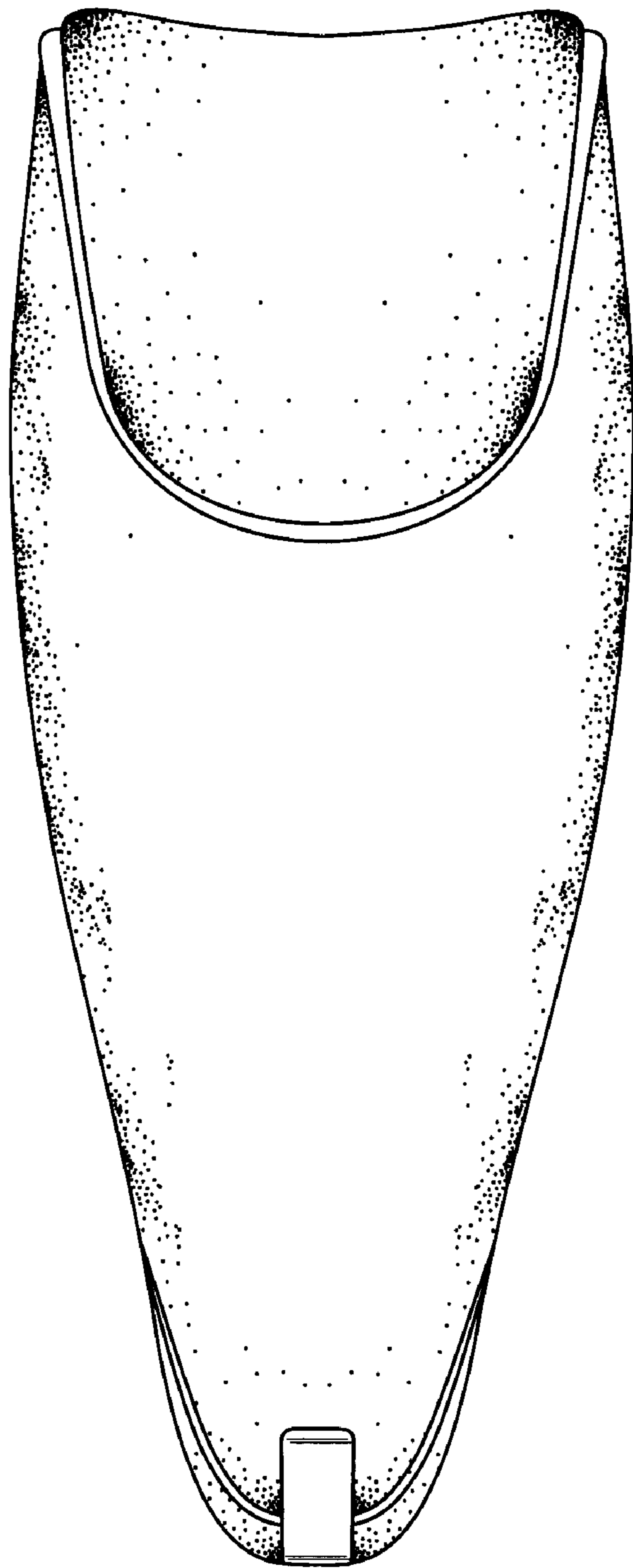

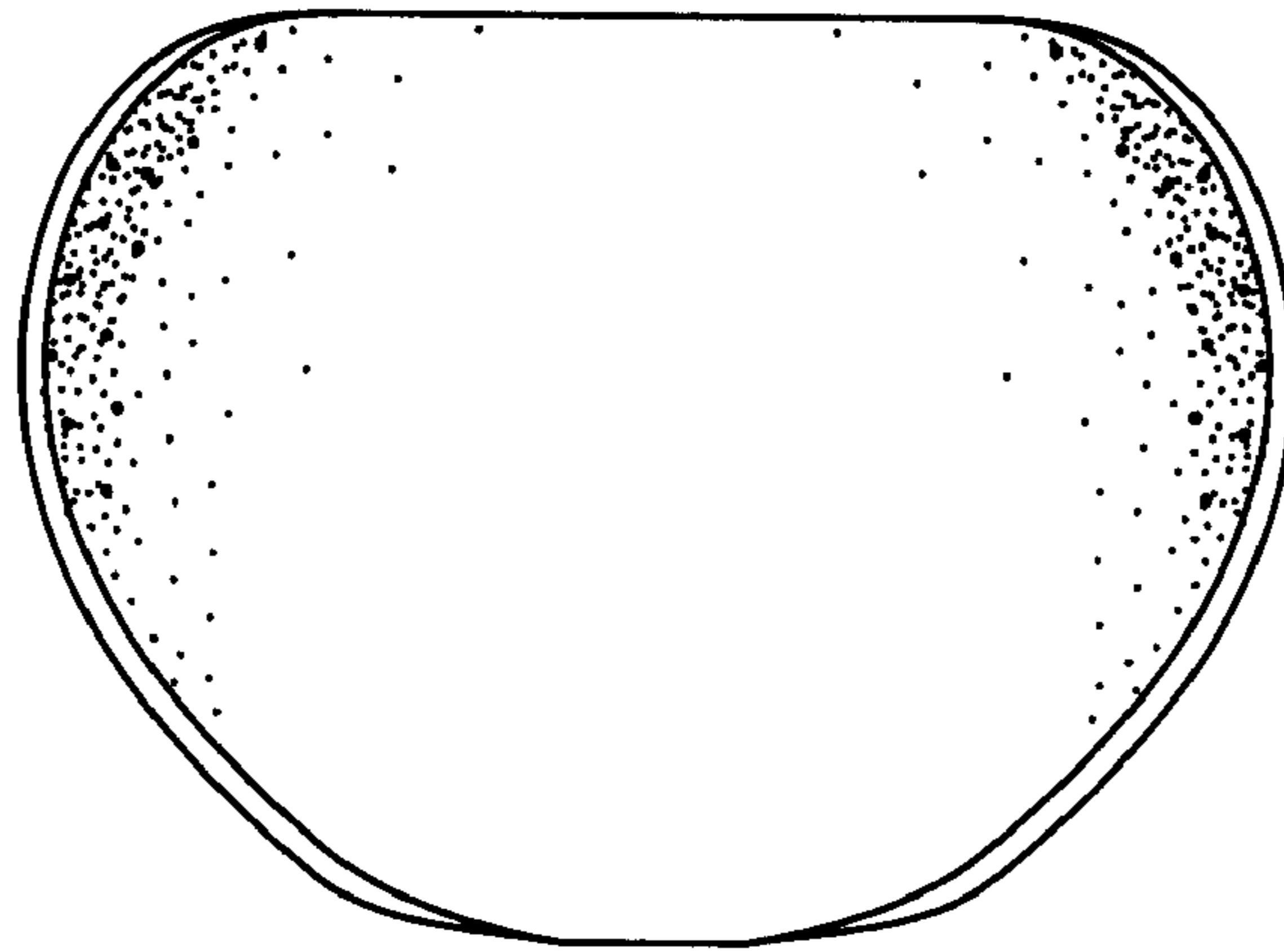

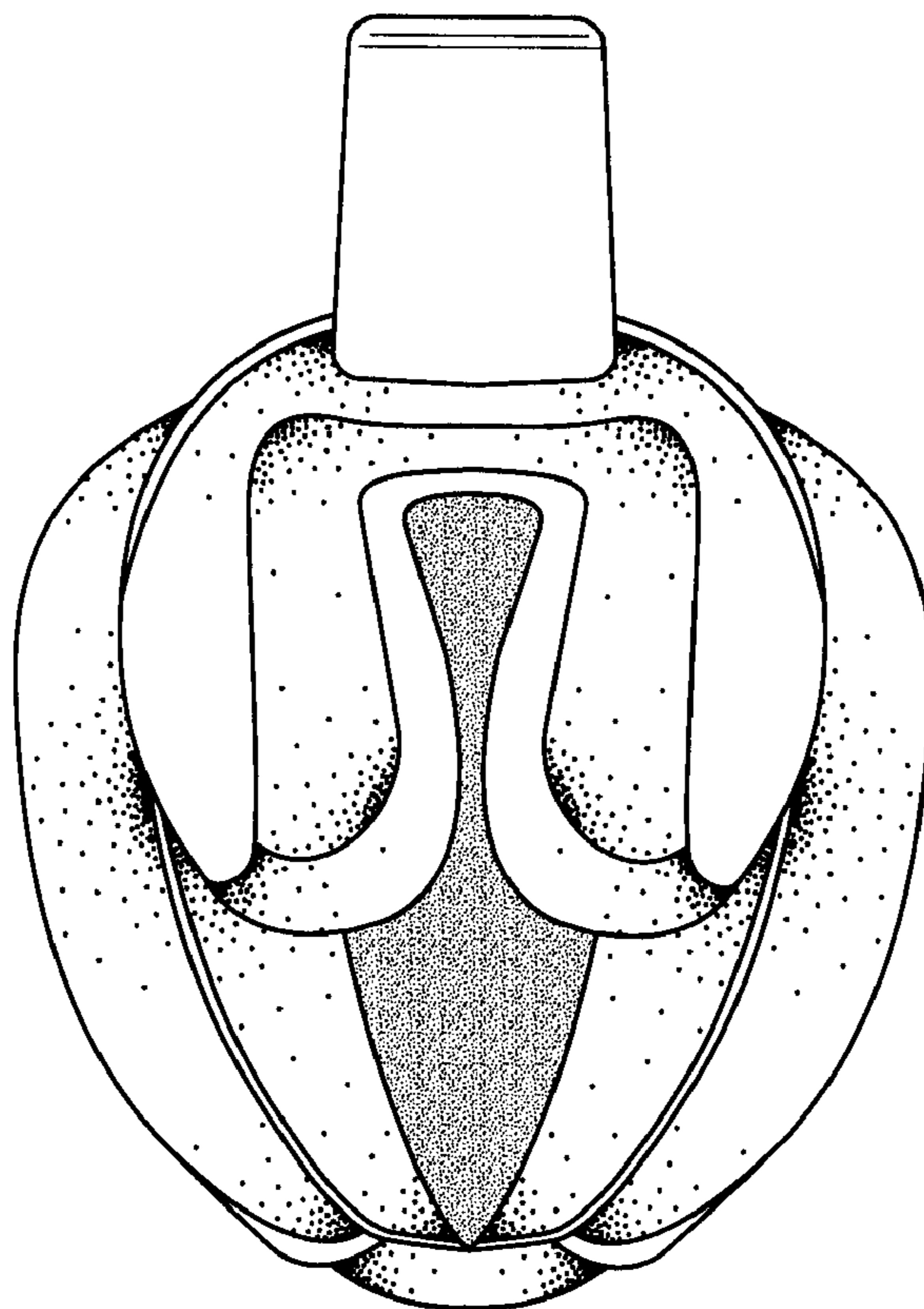
