(57) **CLAIM**

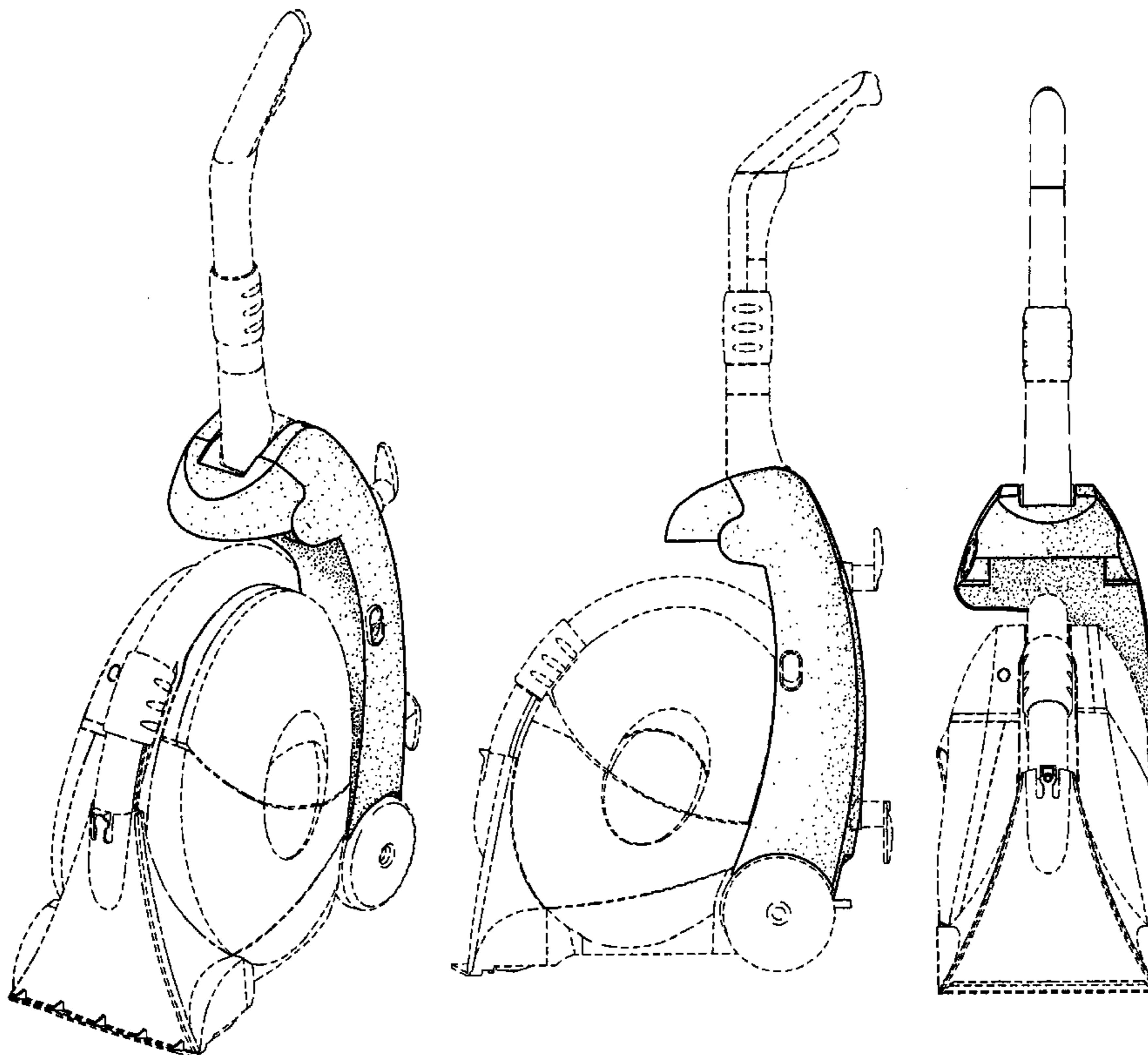
We claim the ornamental design for a portion of a portable cleaning machine, as shown and described.

DESCRIPTION

FIG. 1 is a left perspective view of a portion of a portable cleaning machine showing our new design; FIG. 2 is a right perspective view thereof; FIG. 3 is a right side view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a front view thereof; and, FIG. 6 is a top view thereof.

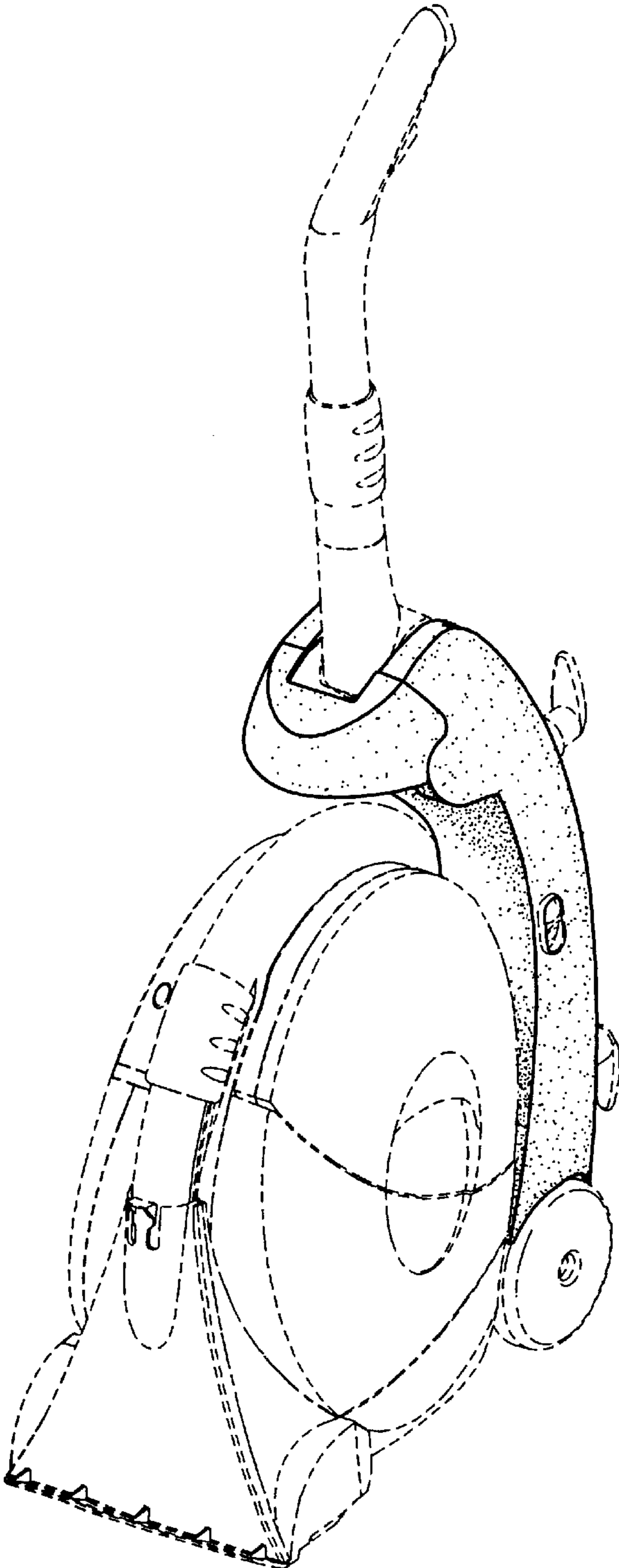

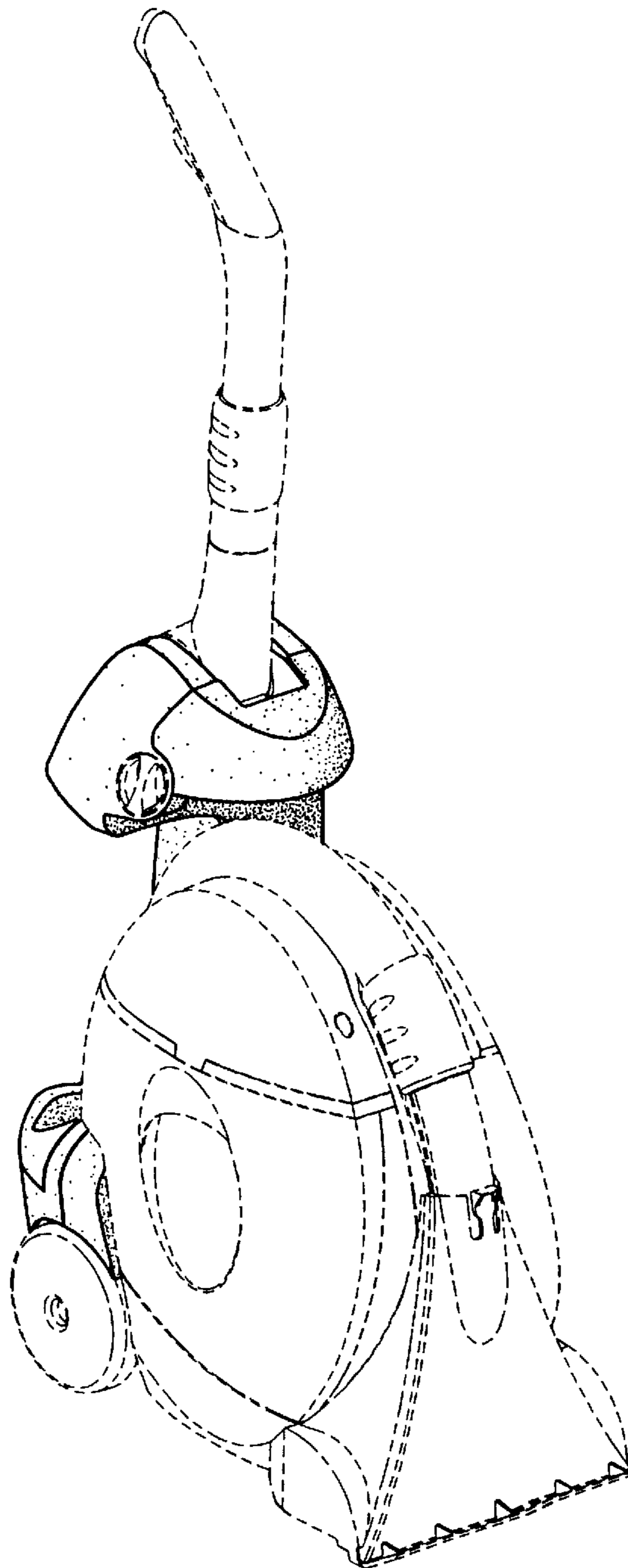

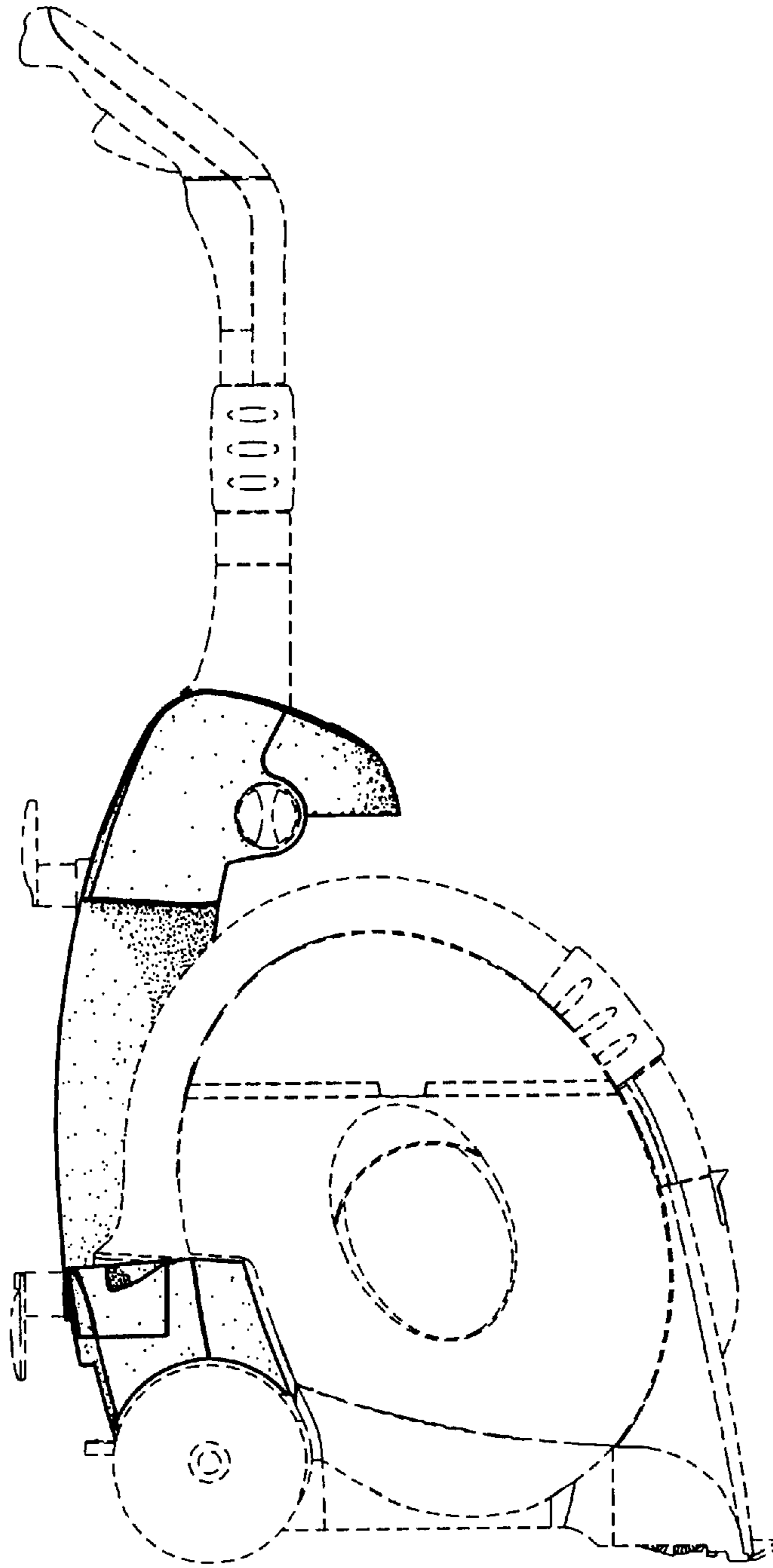

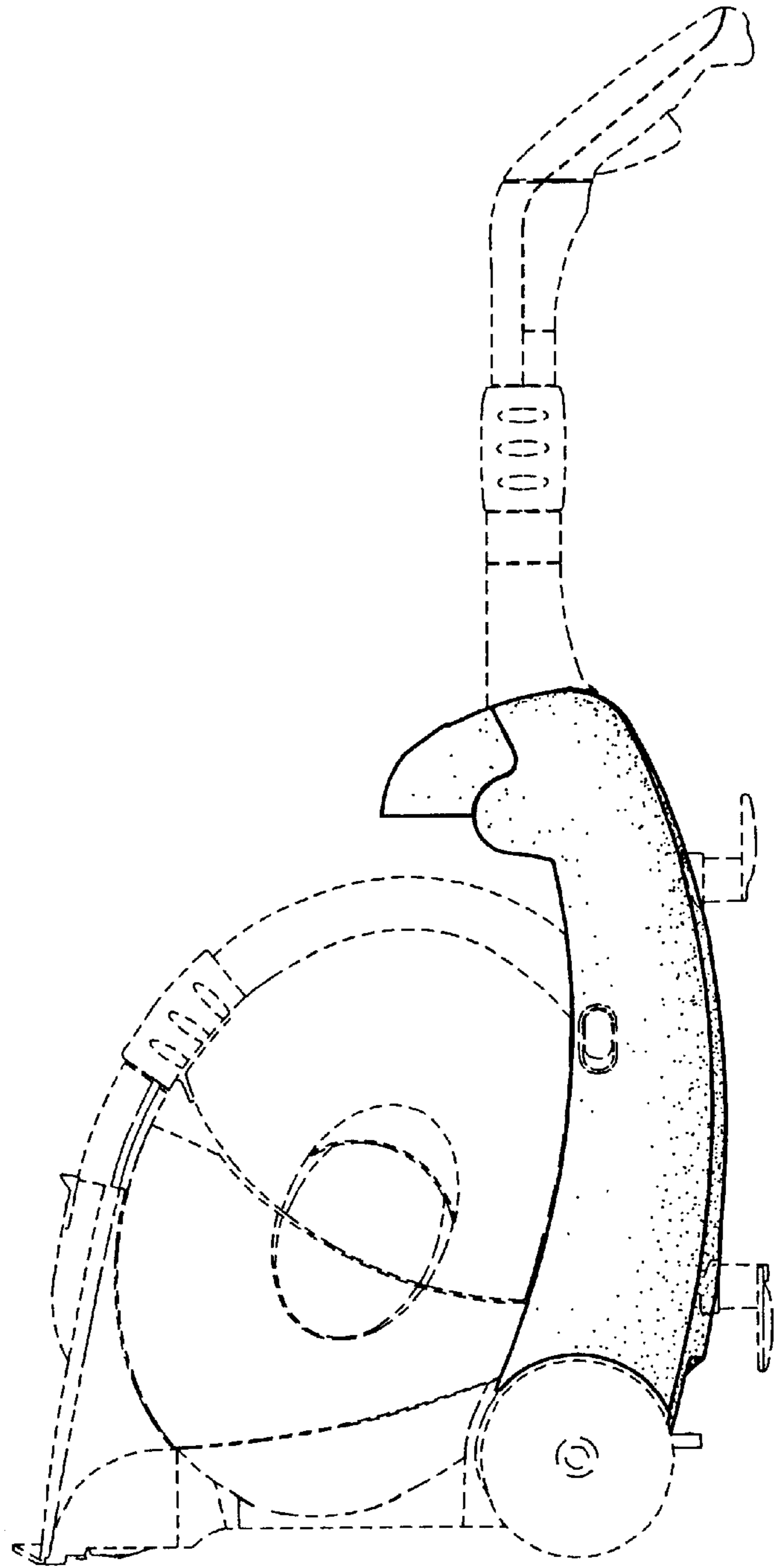

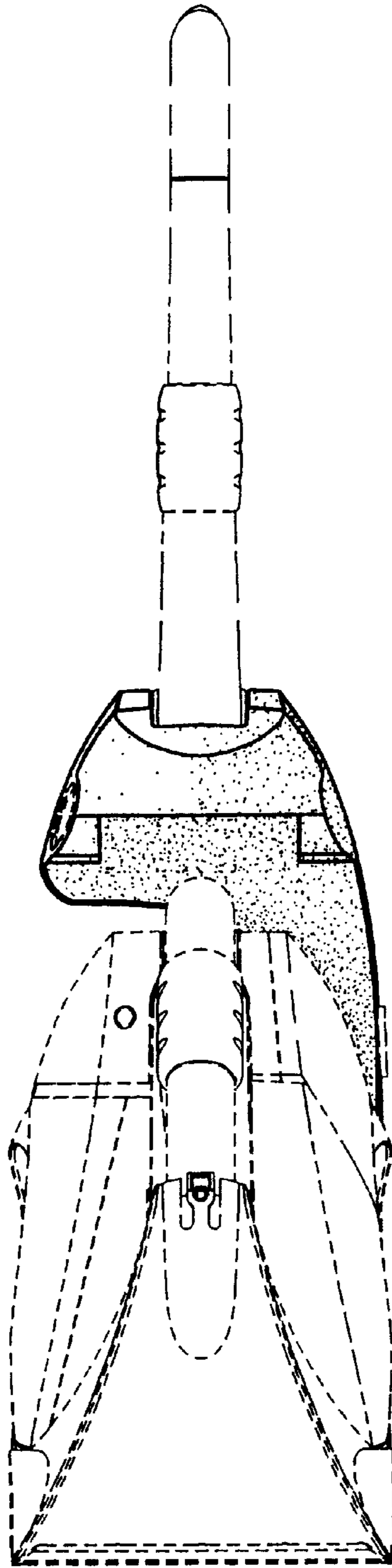

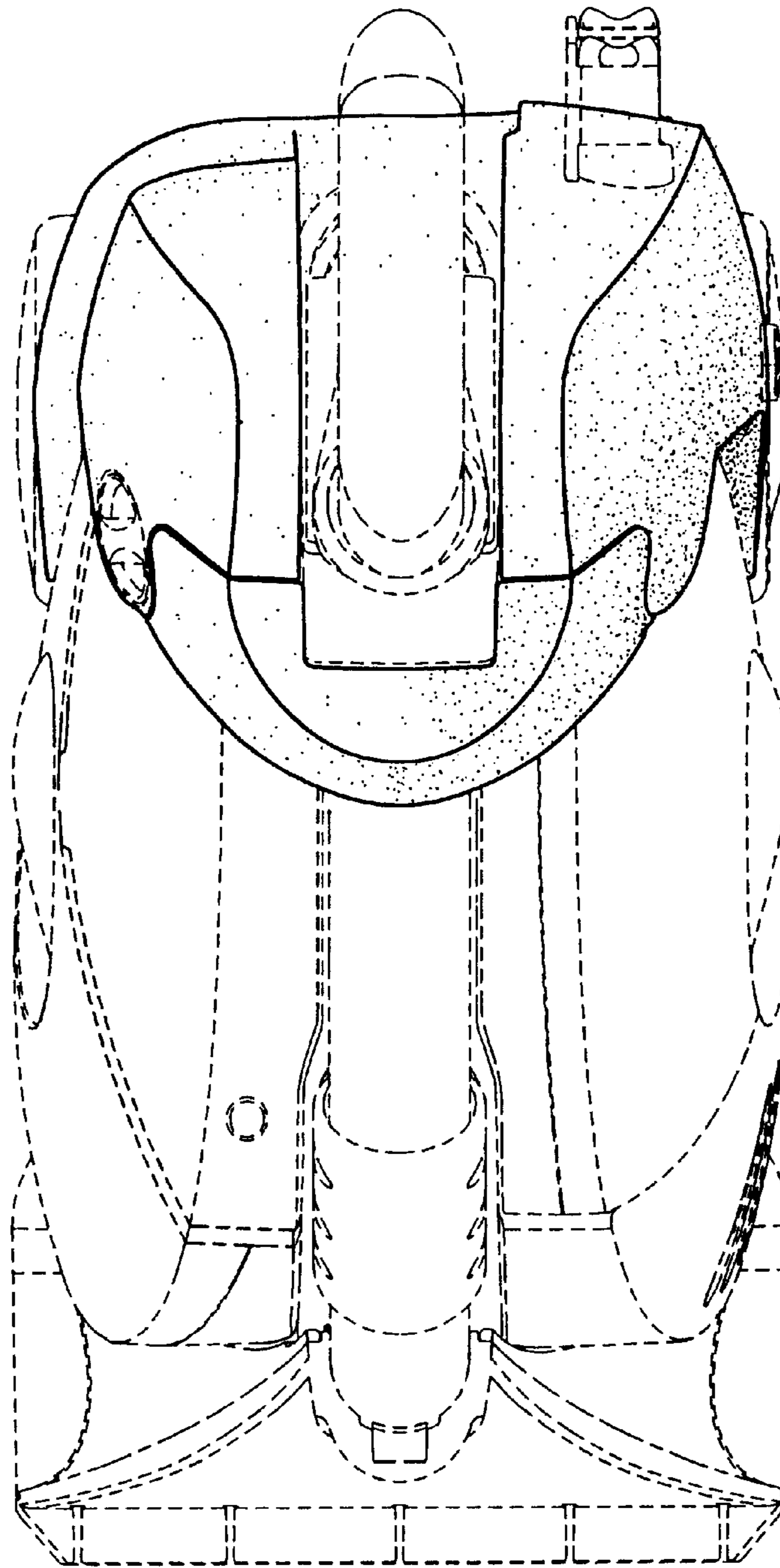
