FIG. 4 is a left side elevational view thereof; and,

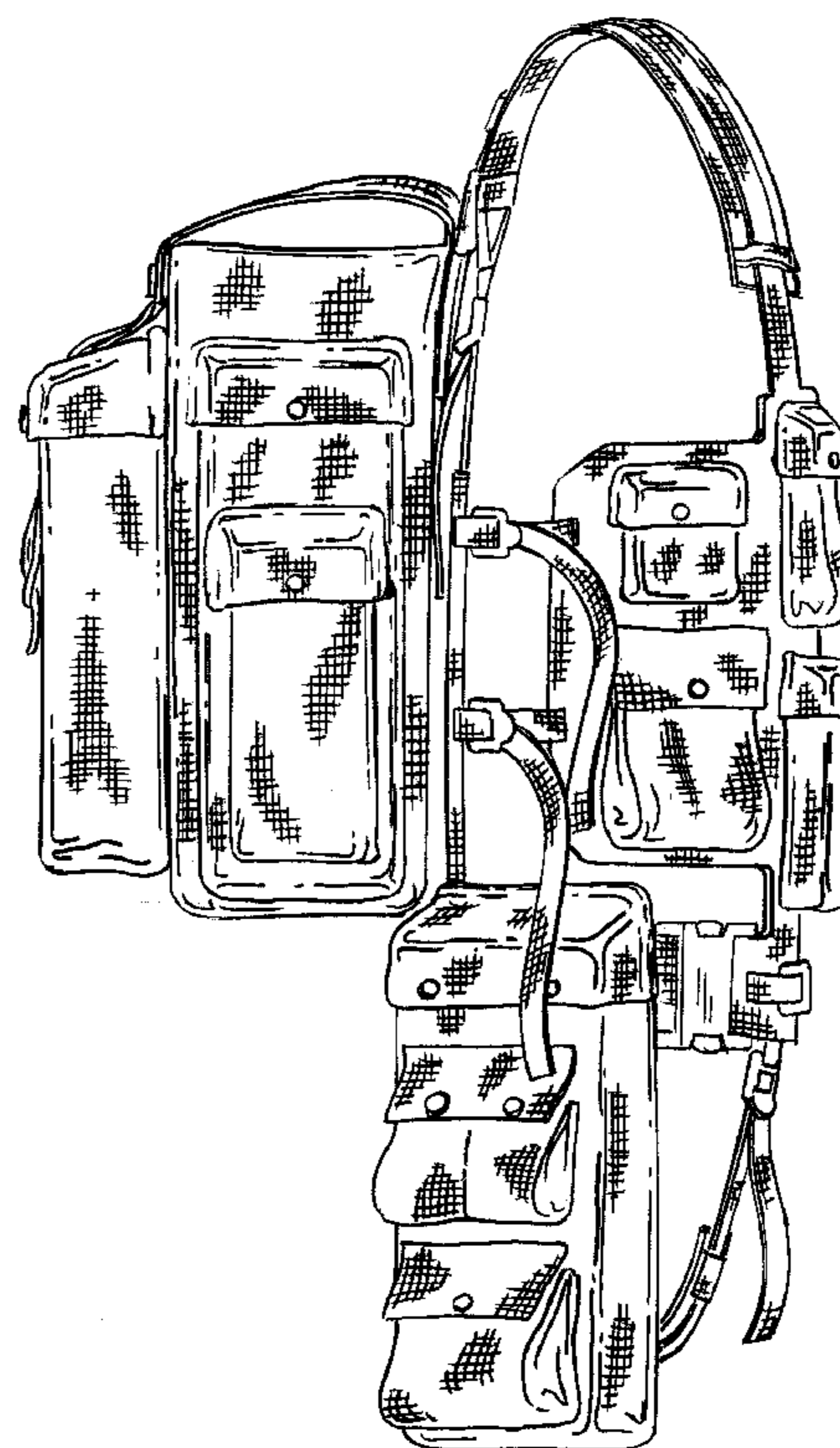
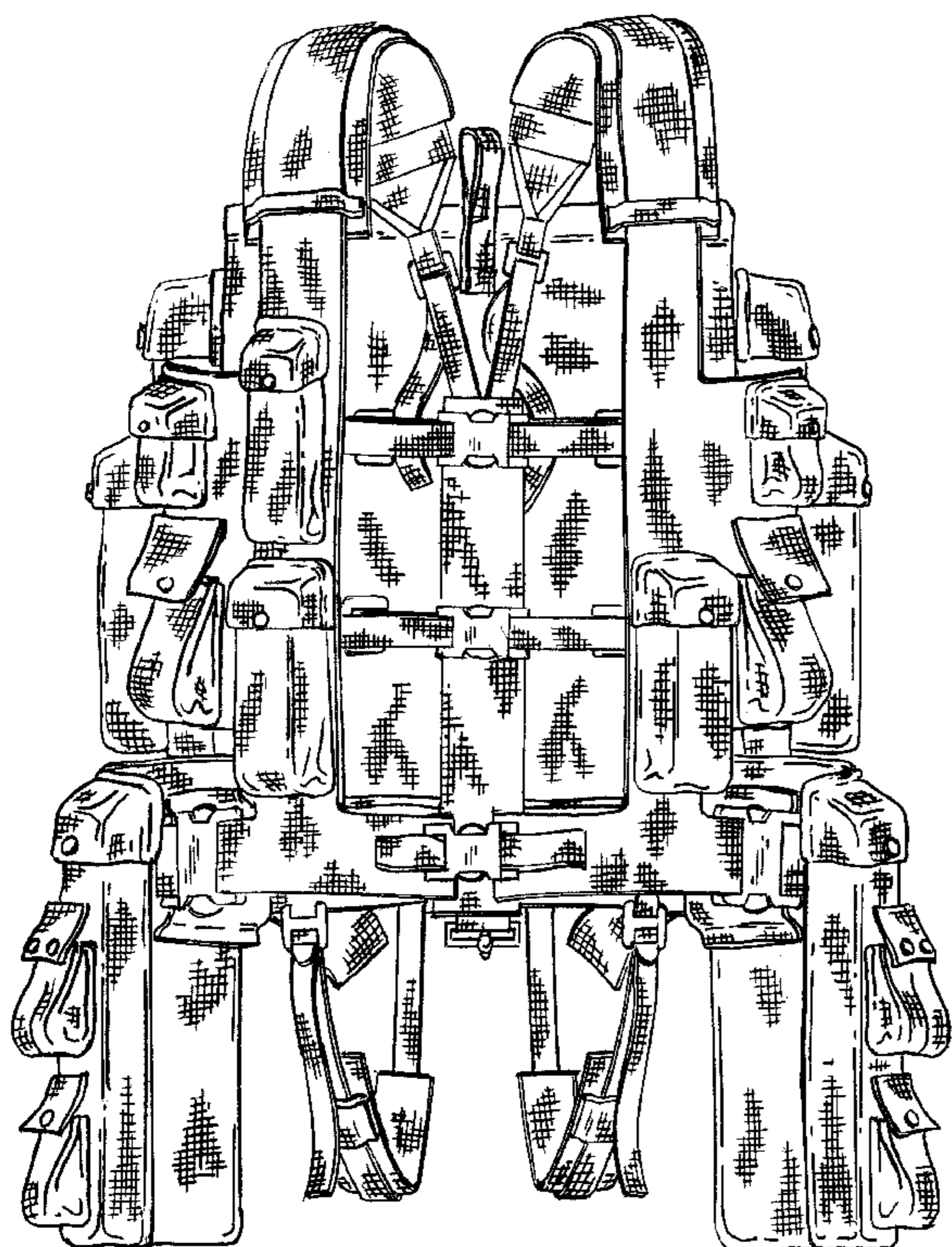
FIG. 5 is right side elevational view thereof.

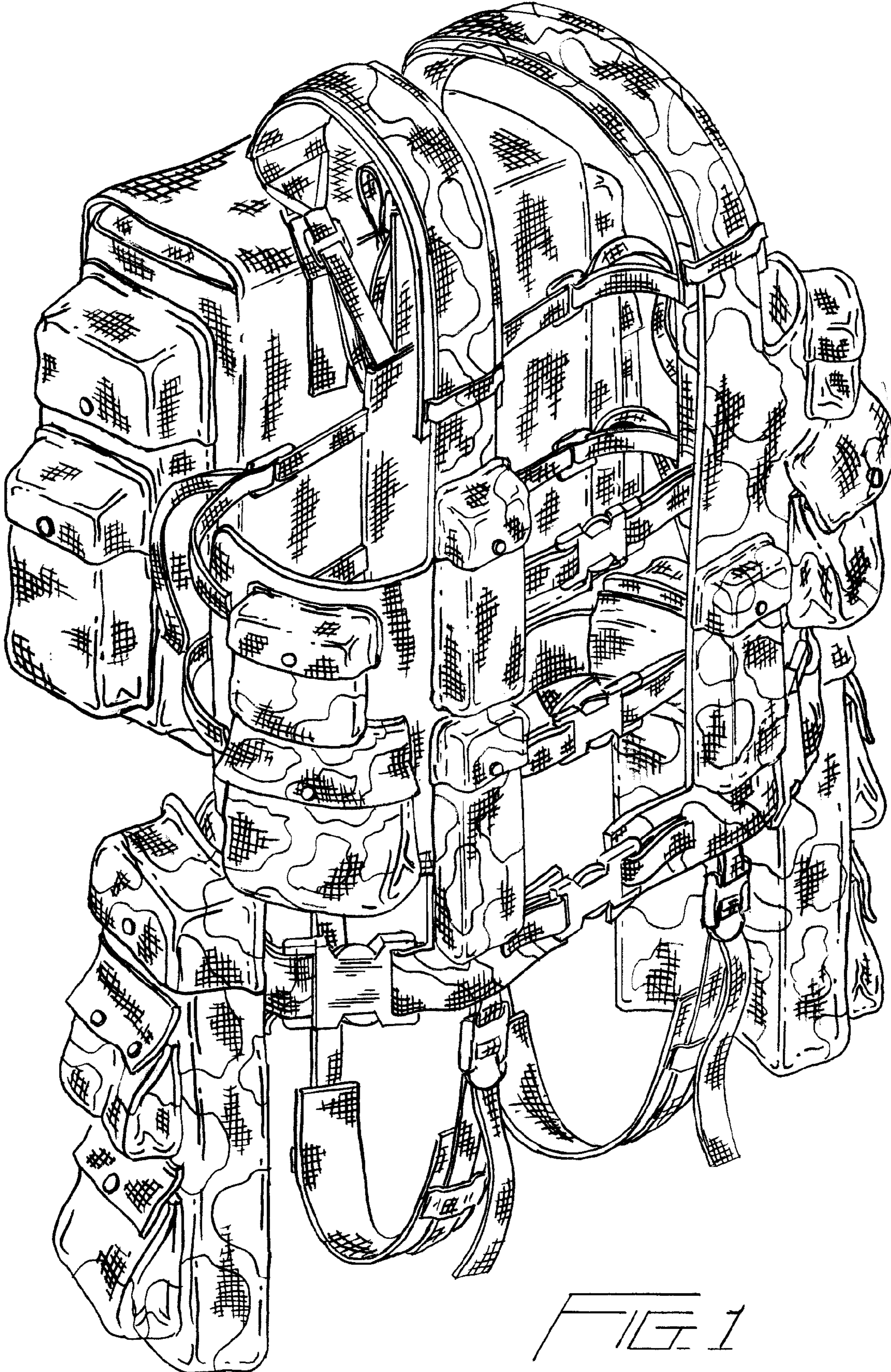

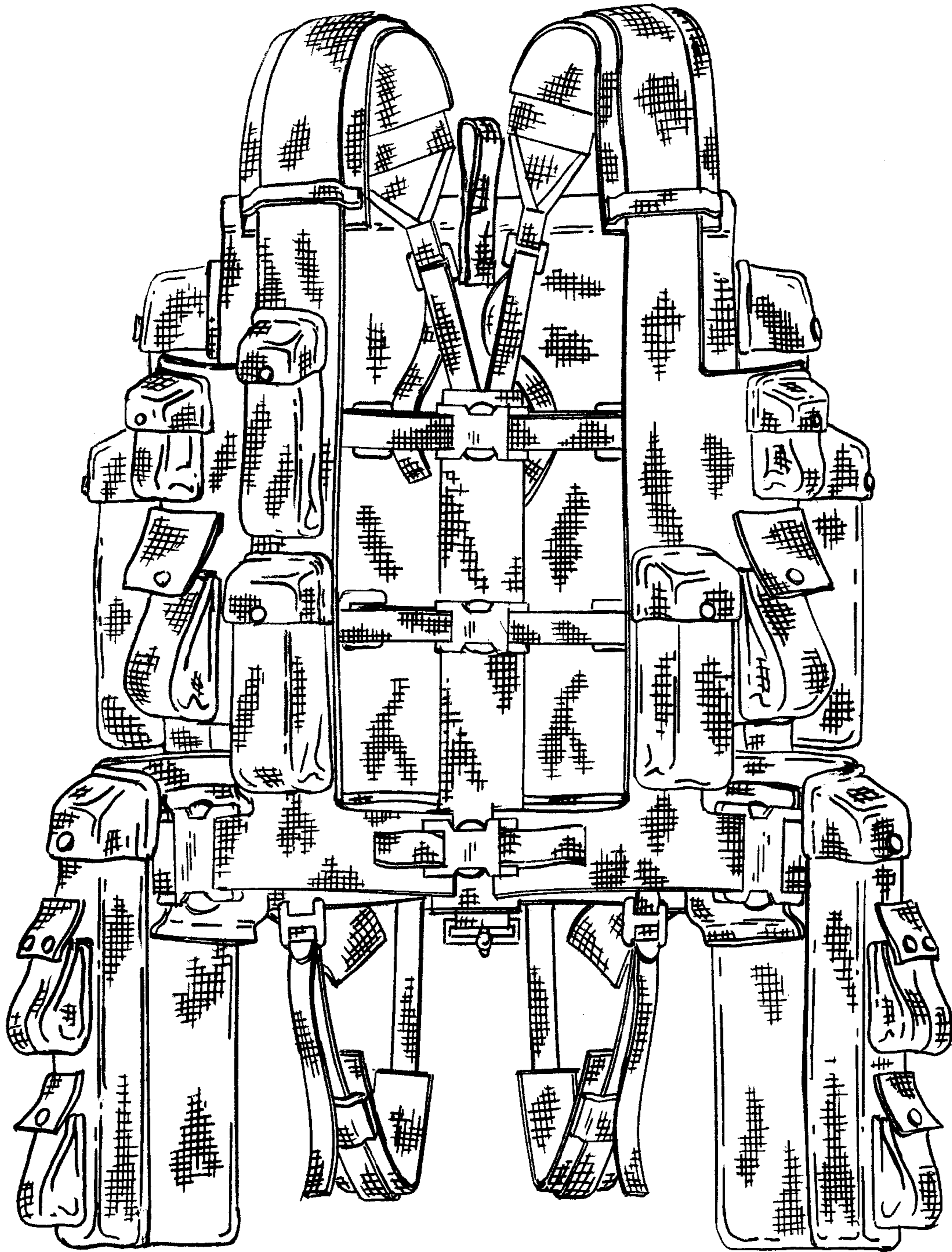

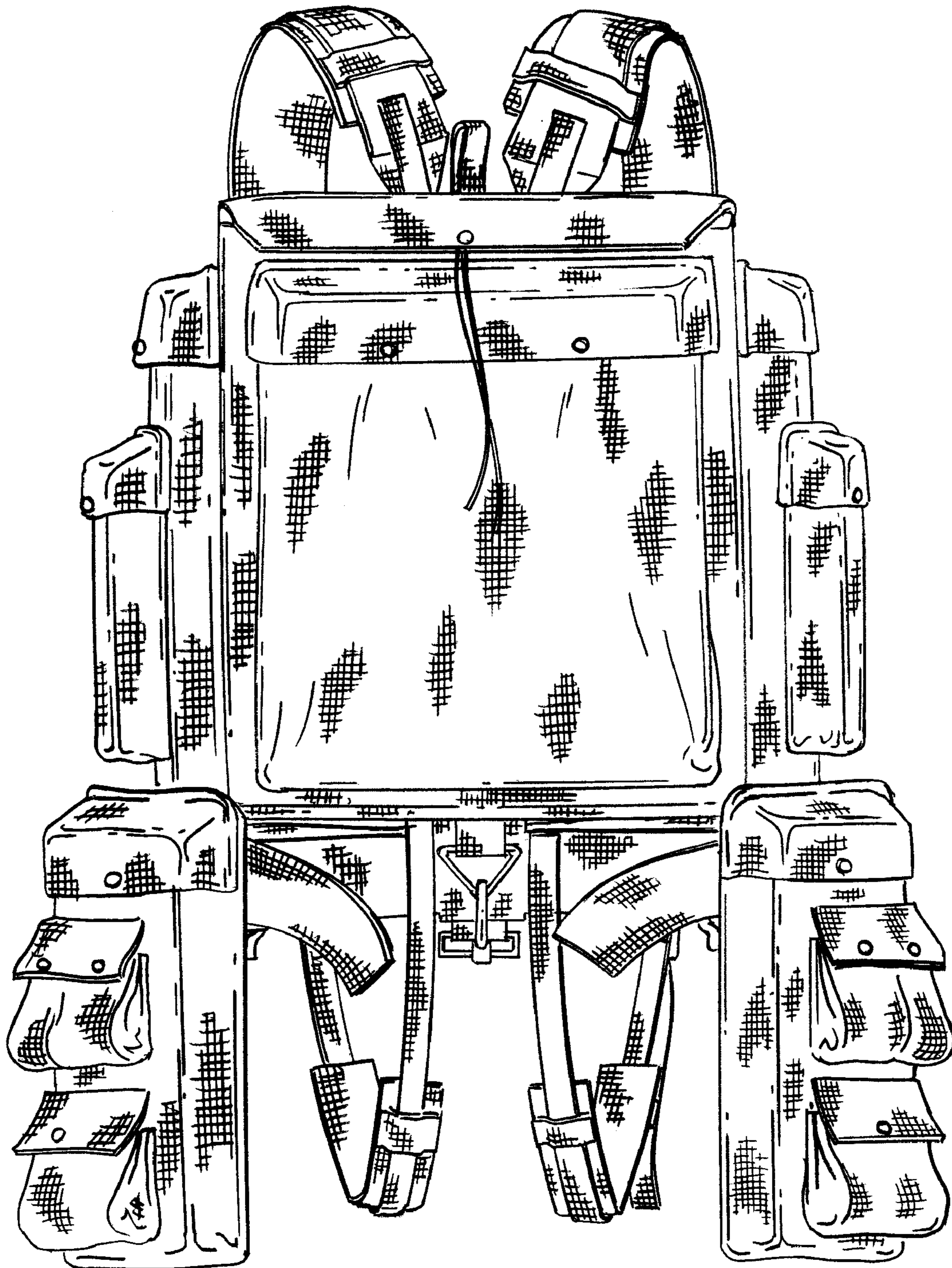

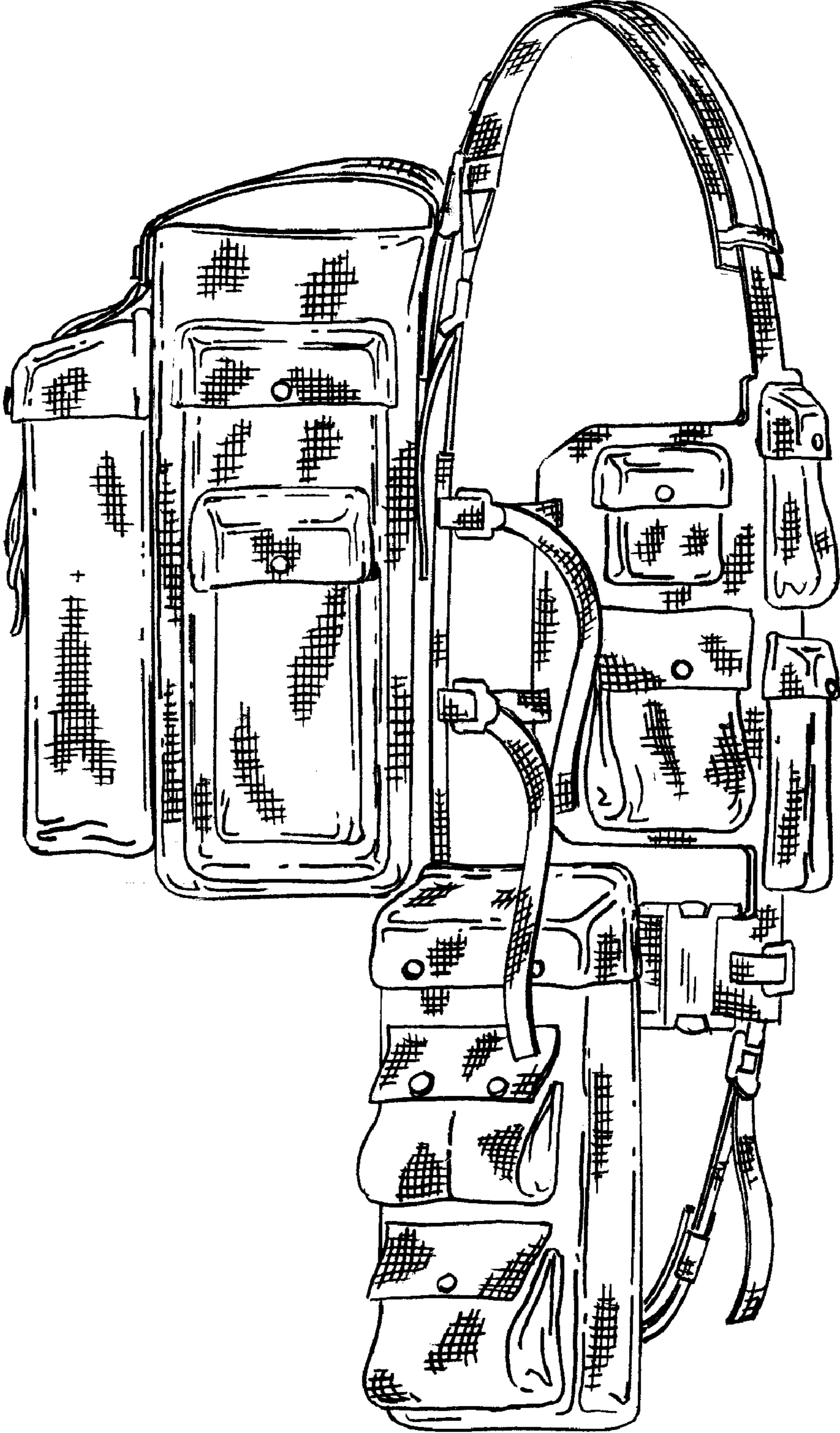
