FIG. 12 is a front view;

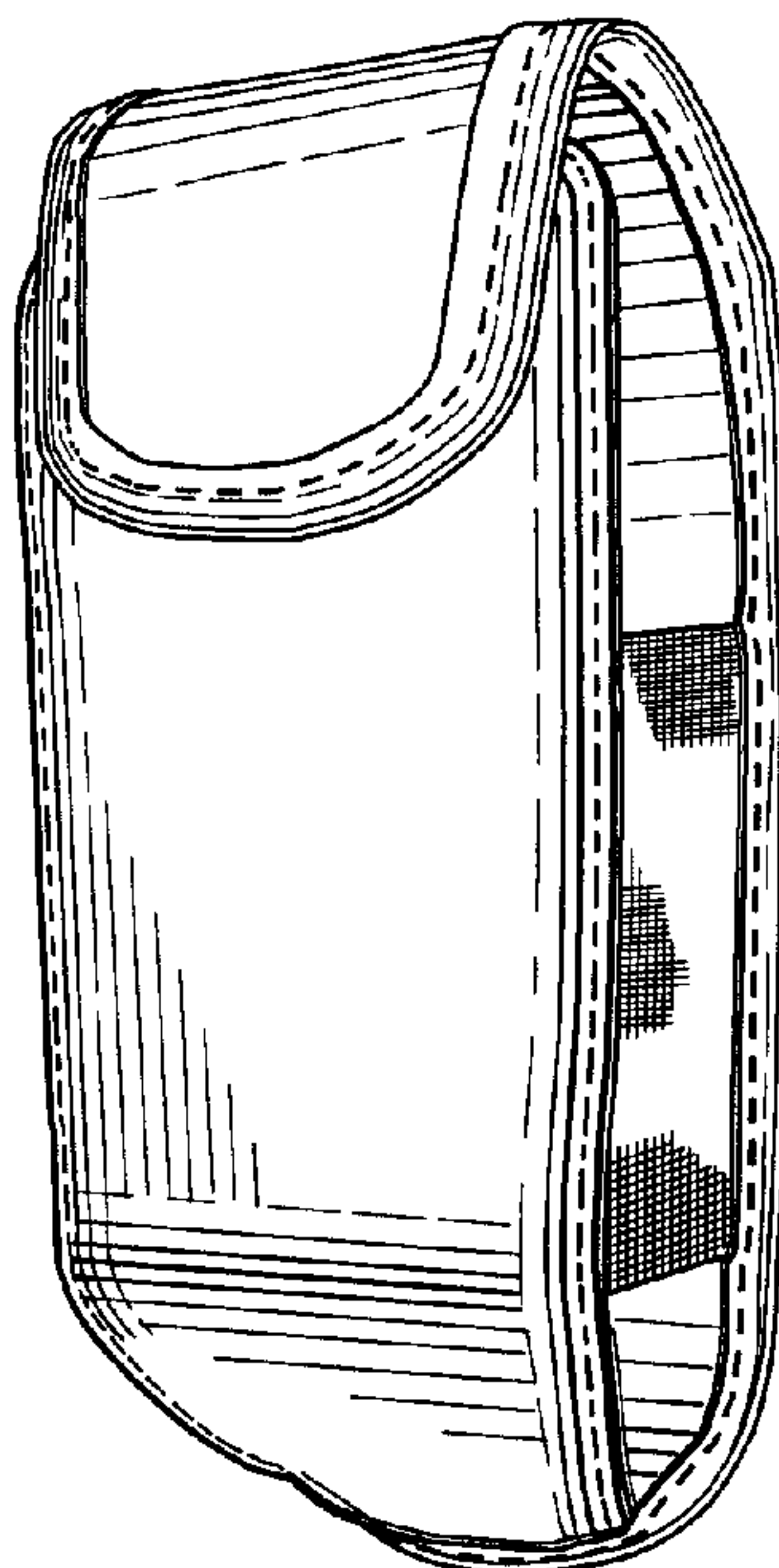
FIG. 13 is a left side view;

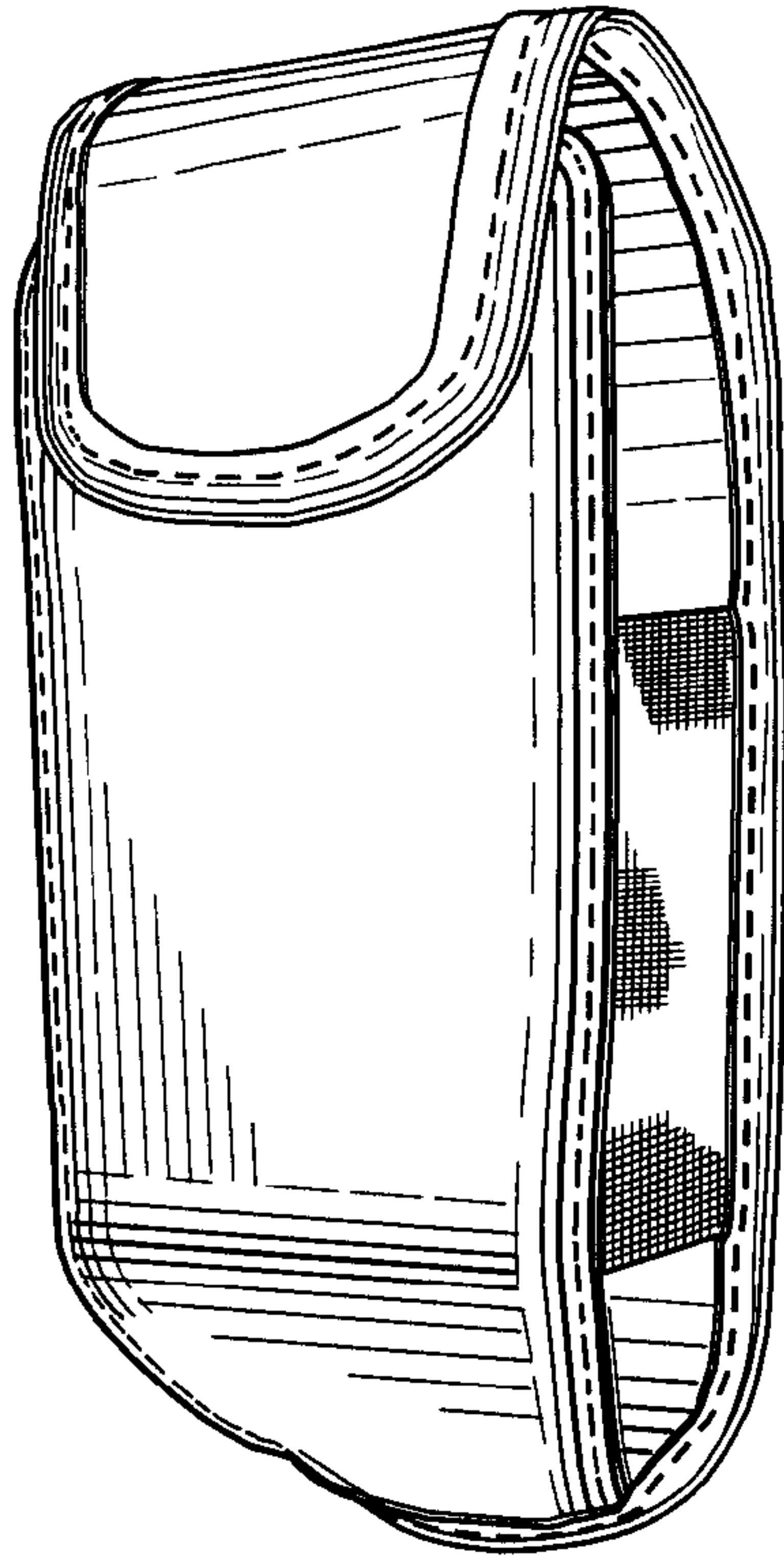

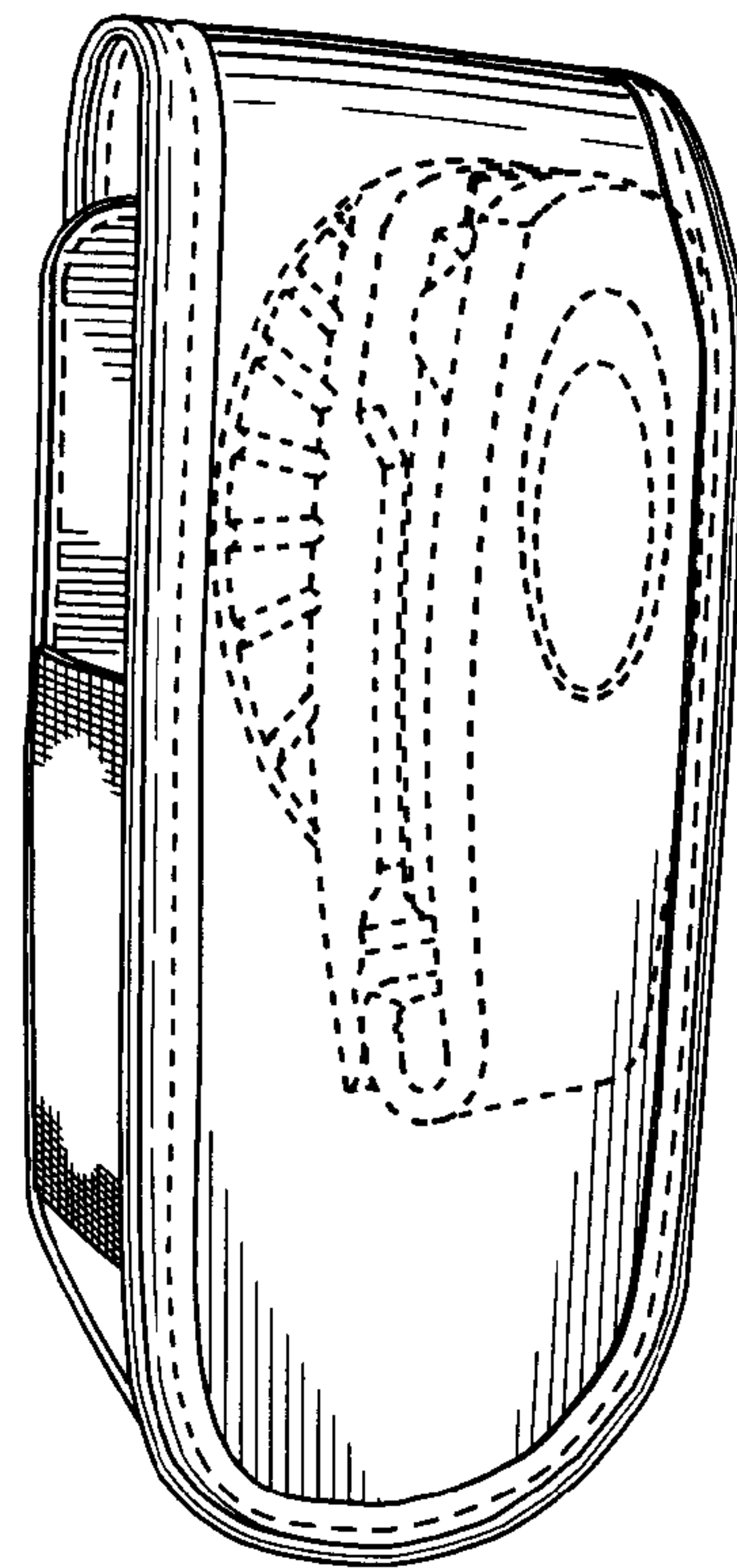

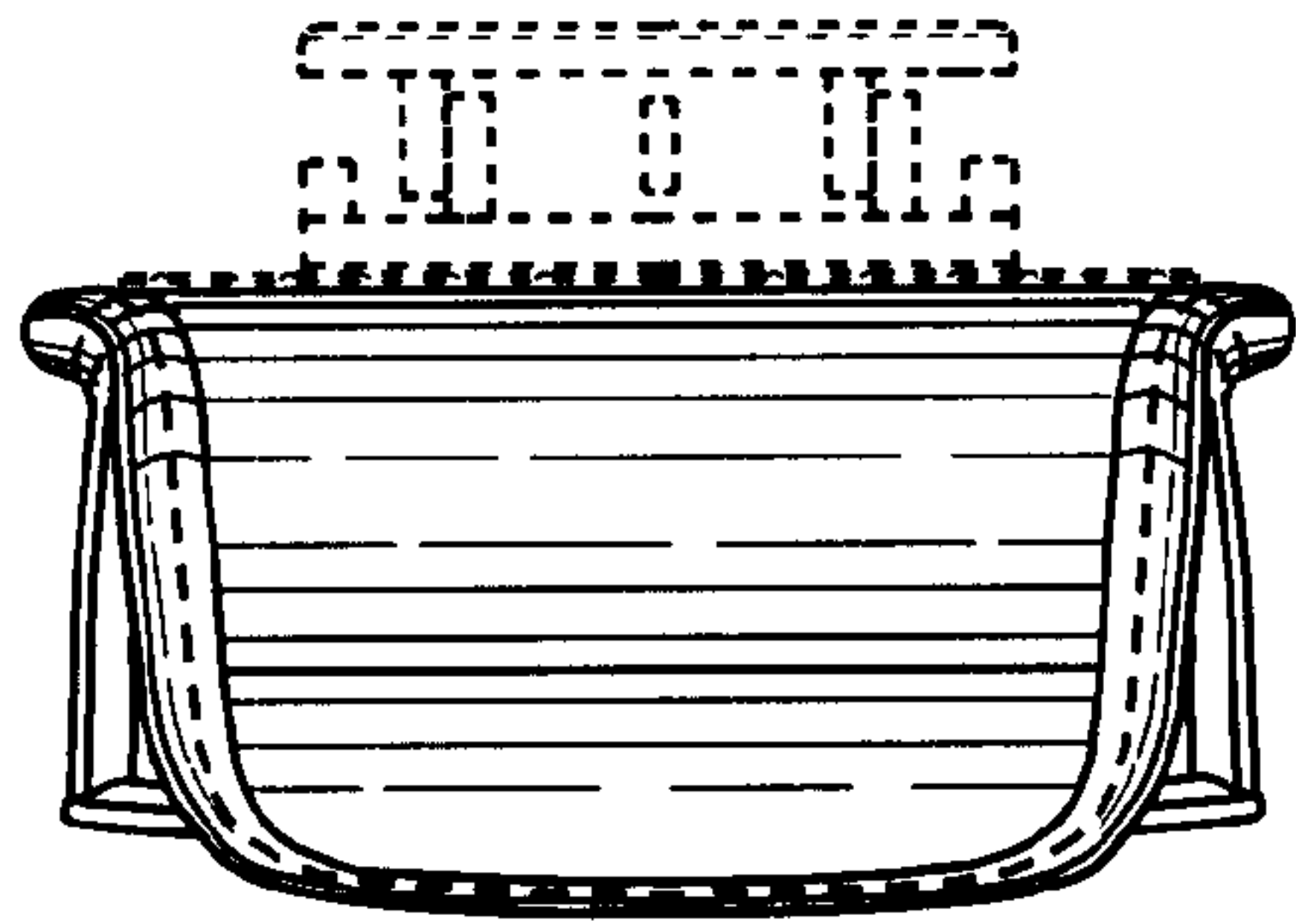

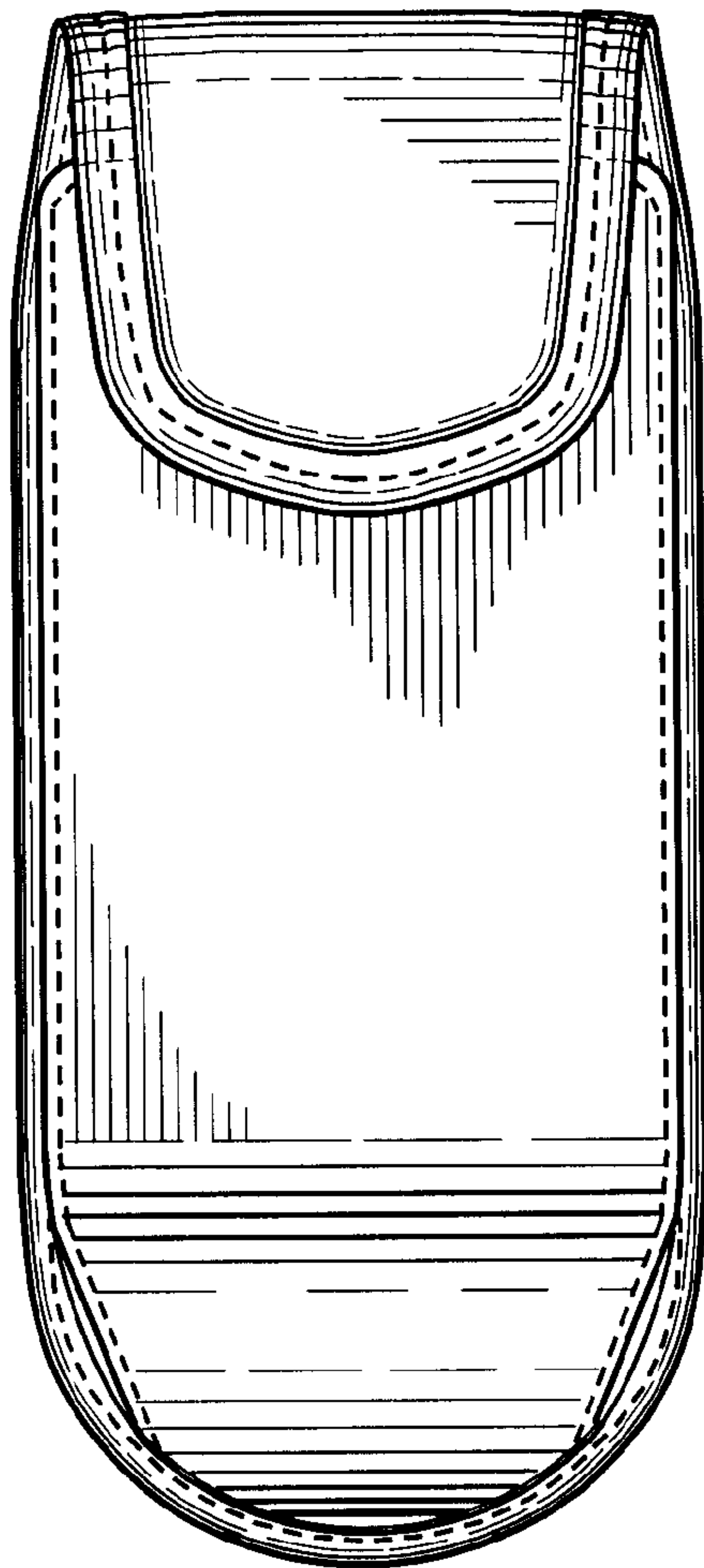

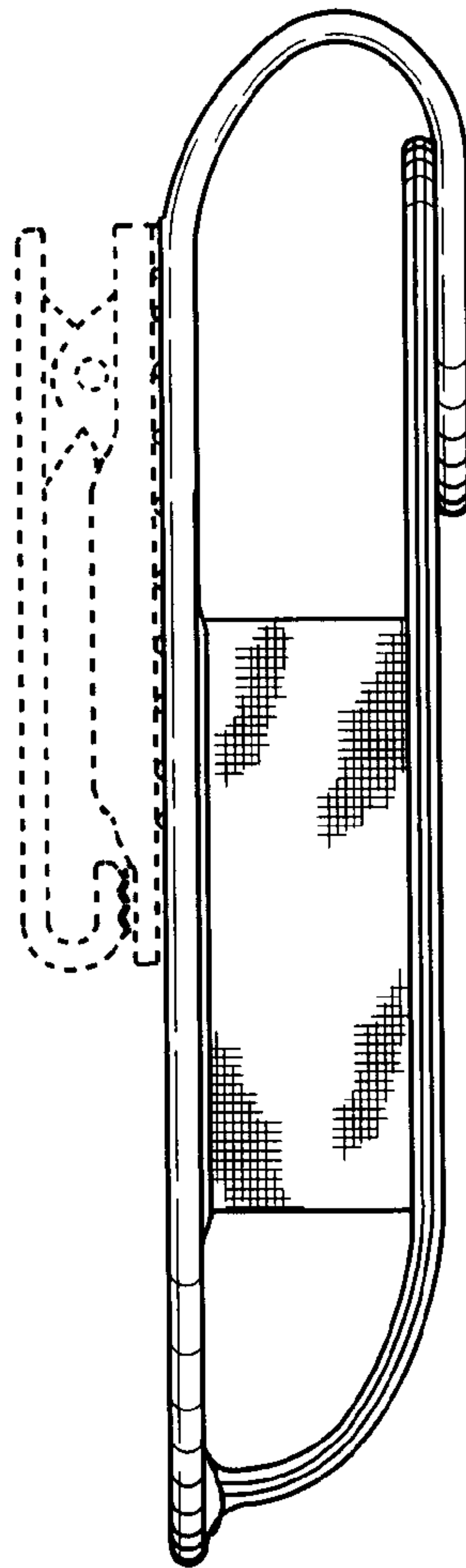

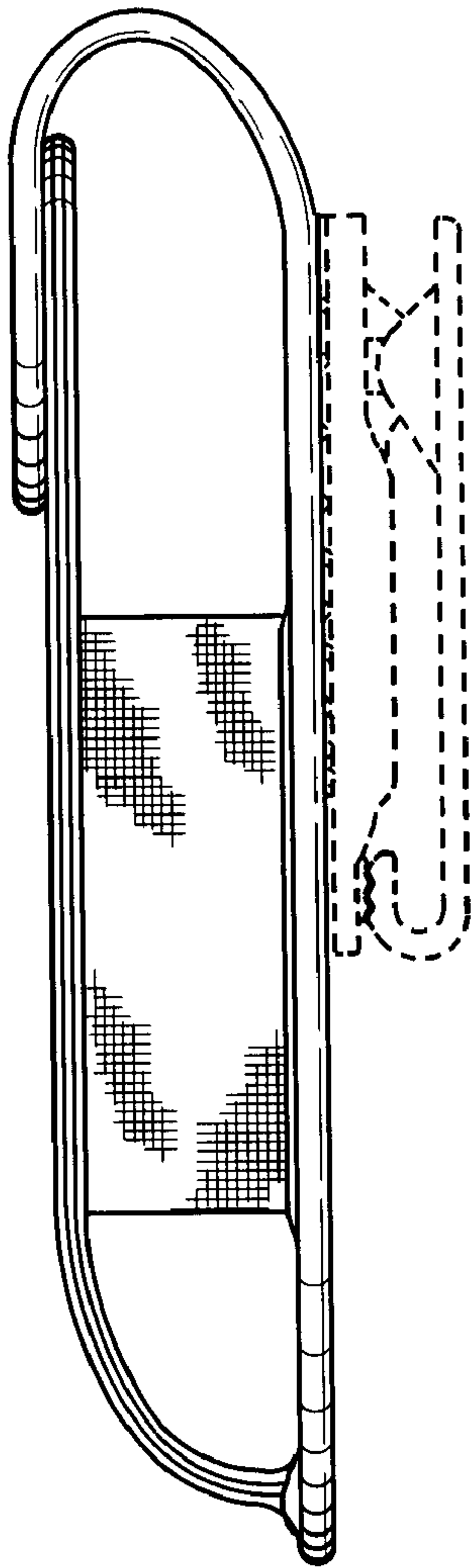

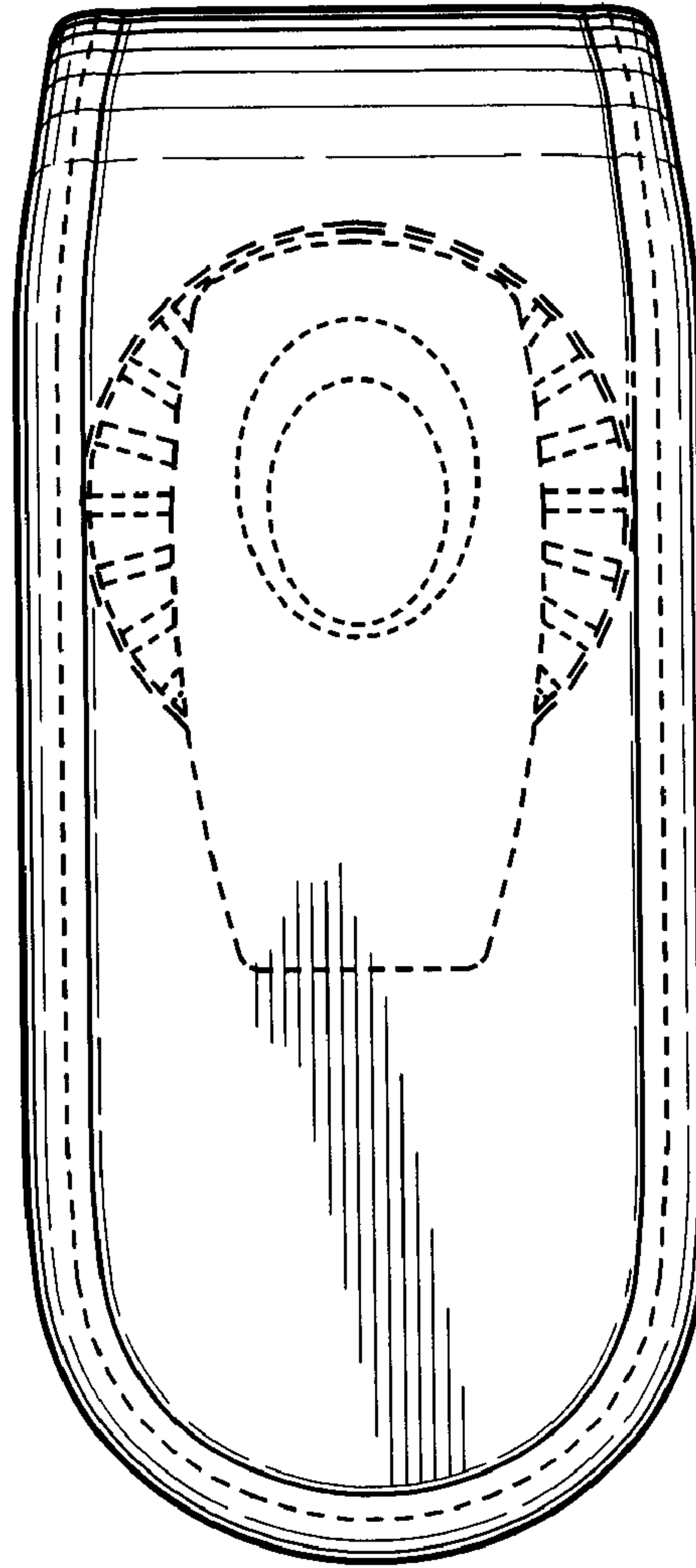

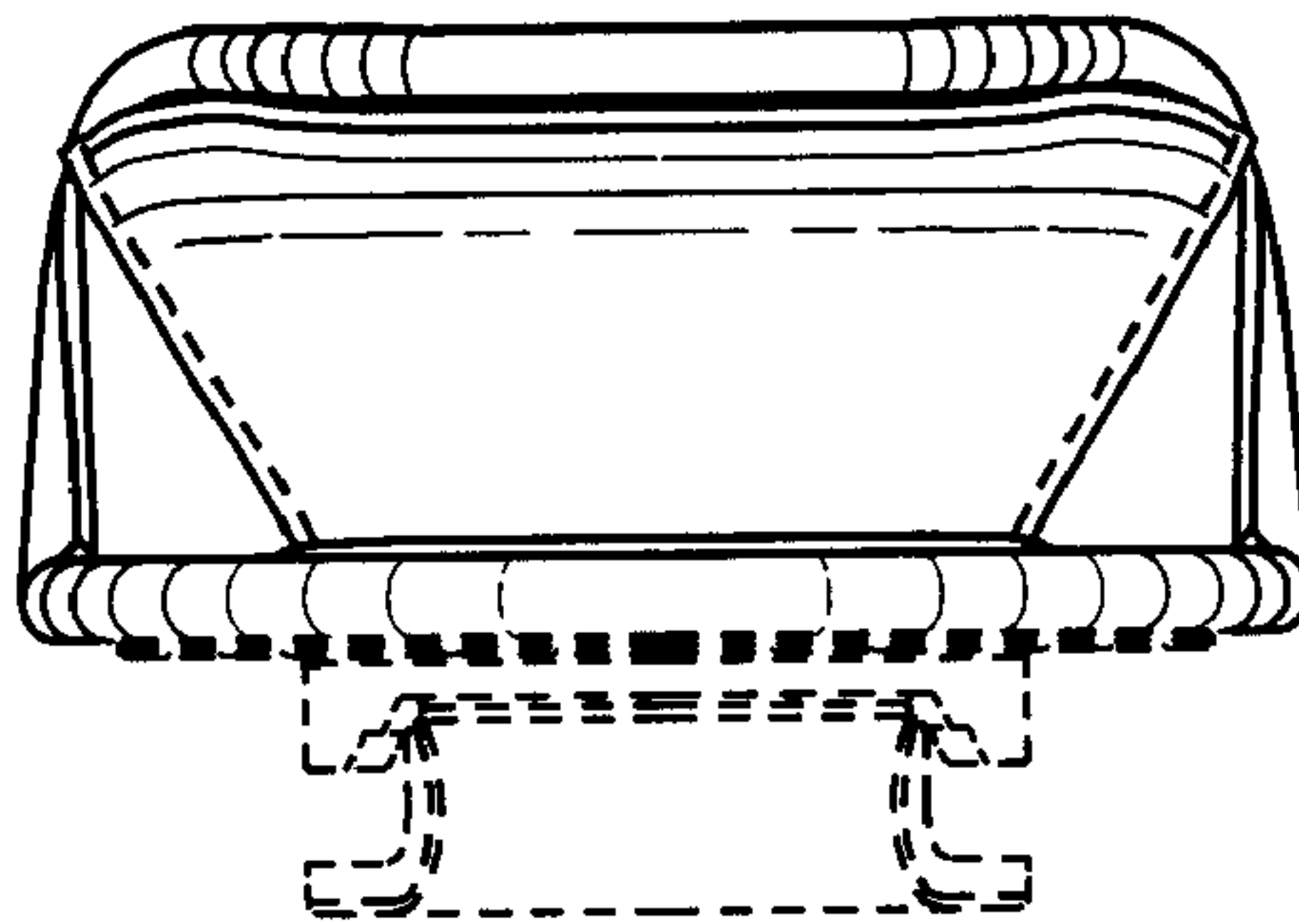

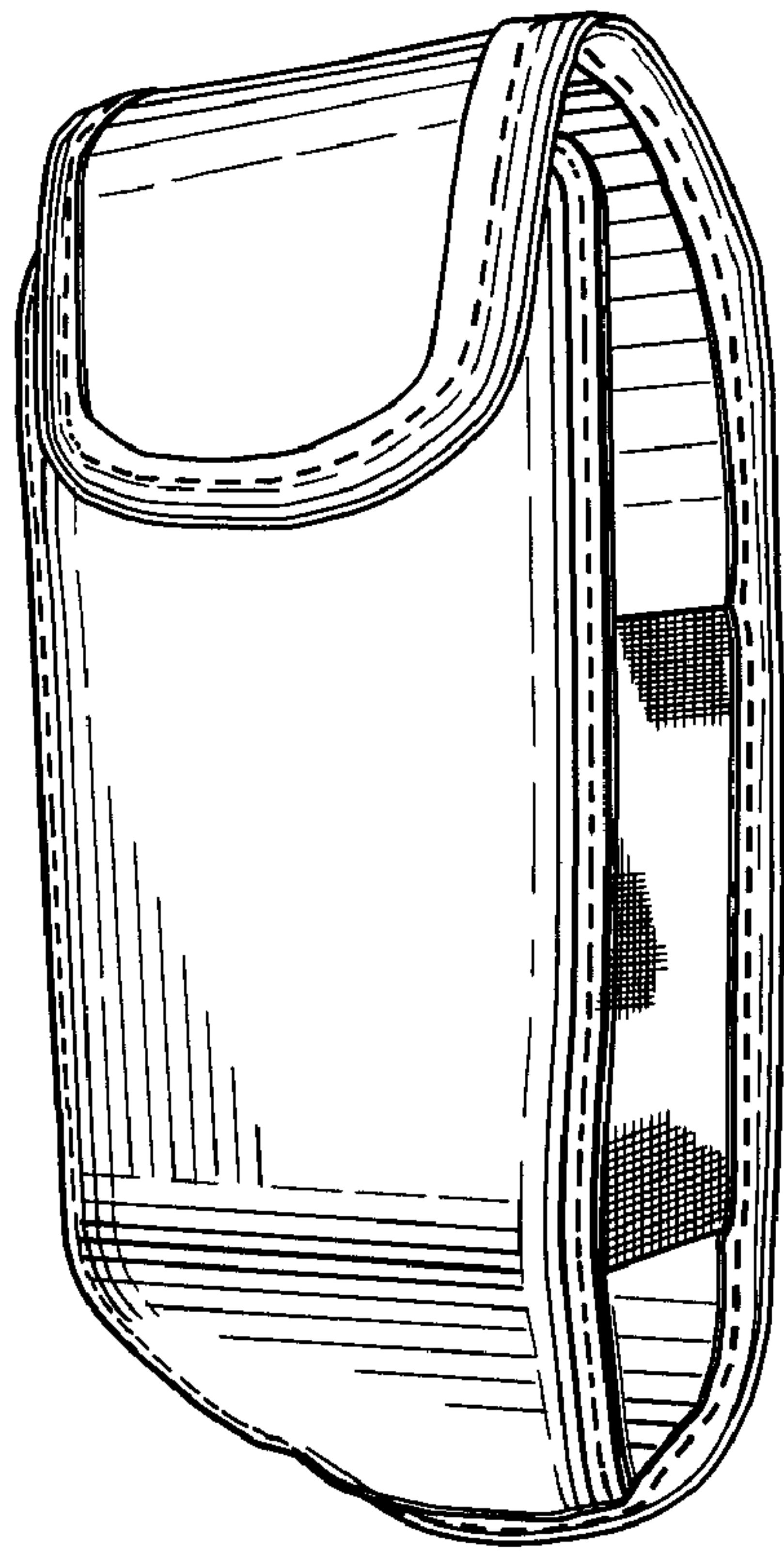

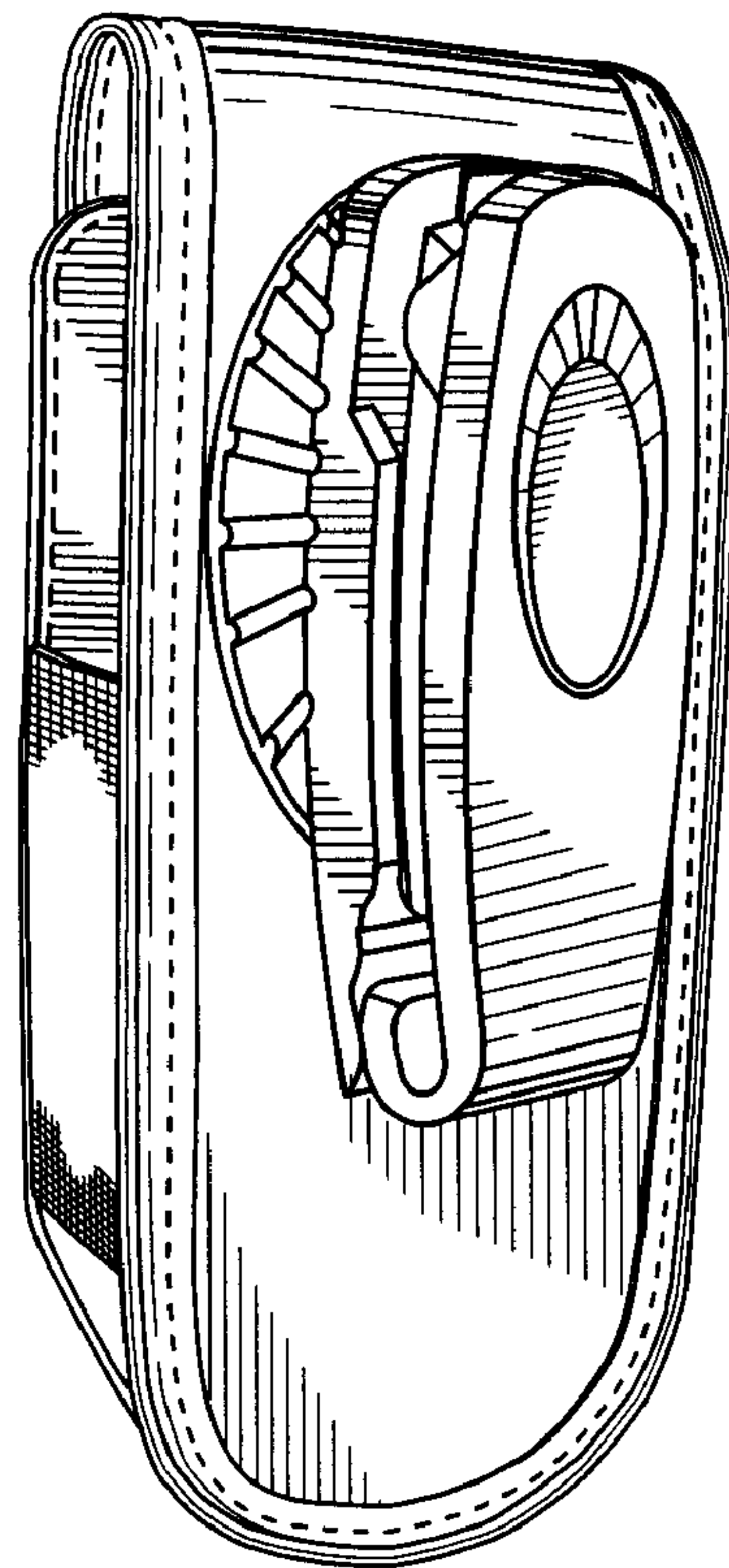

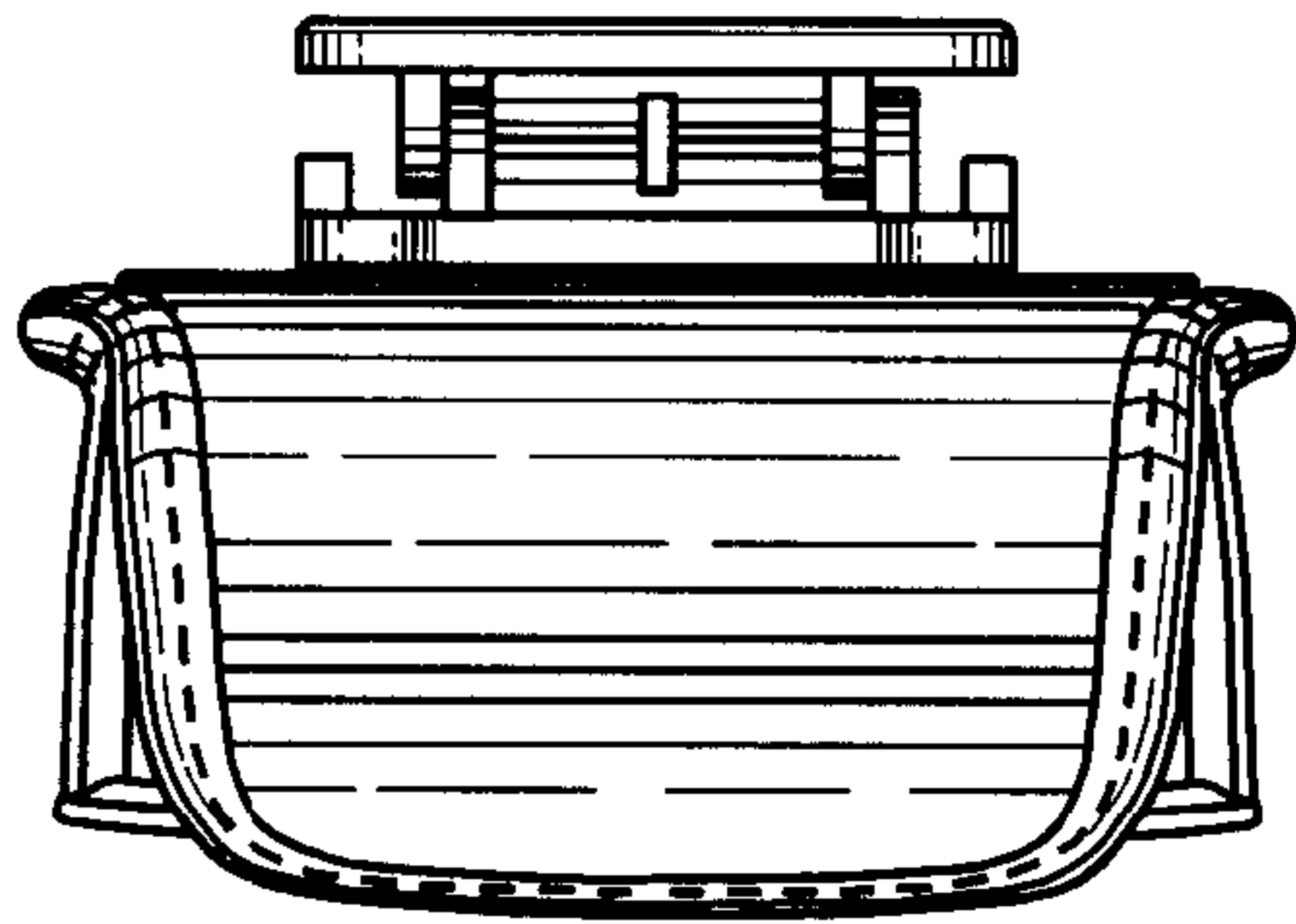

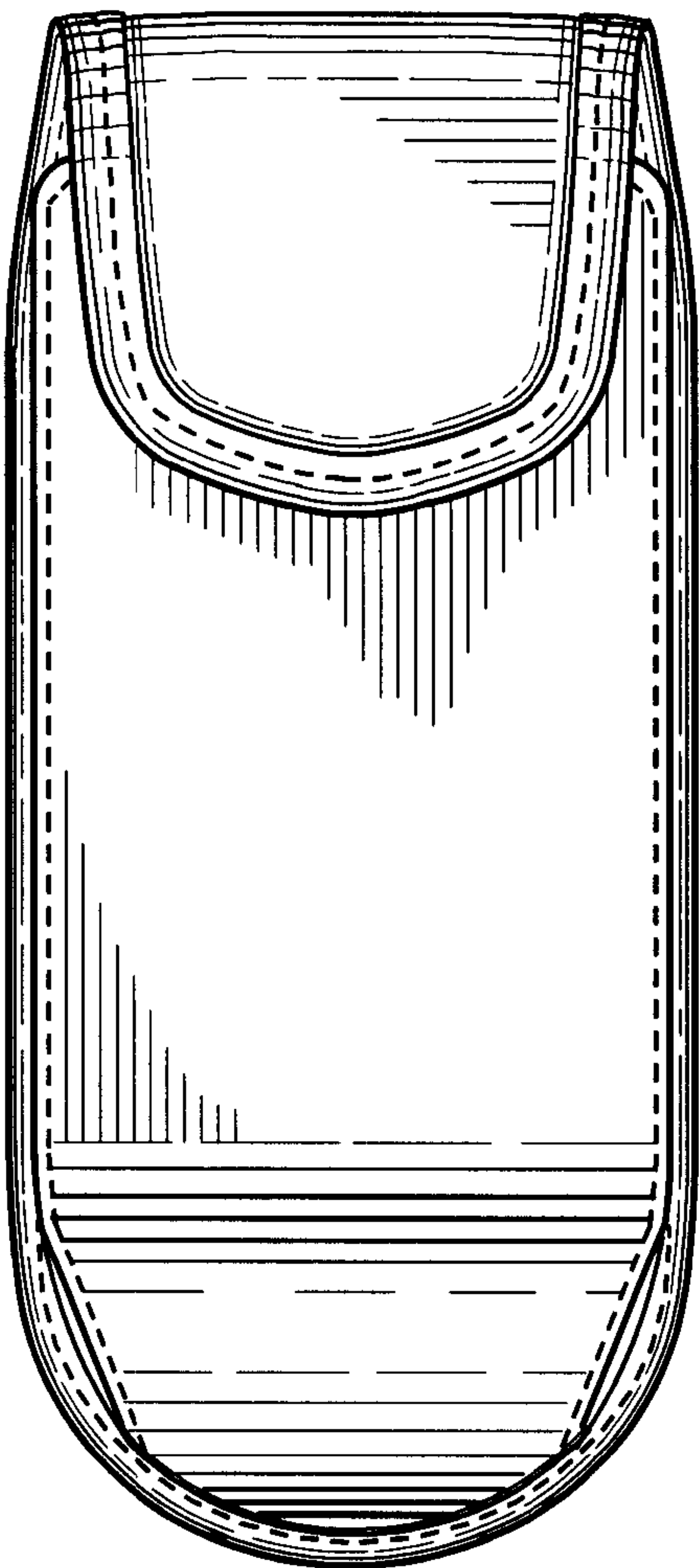

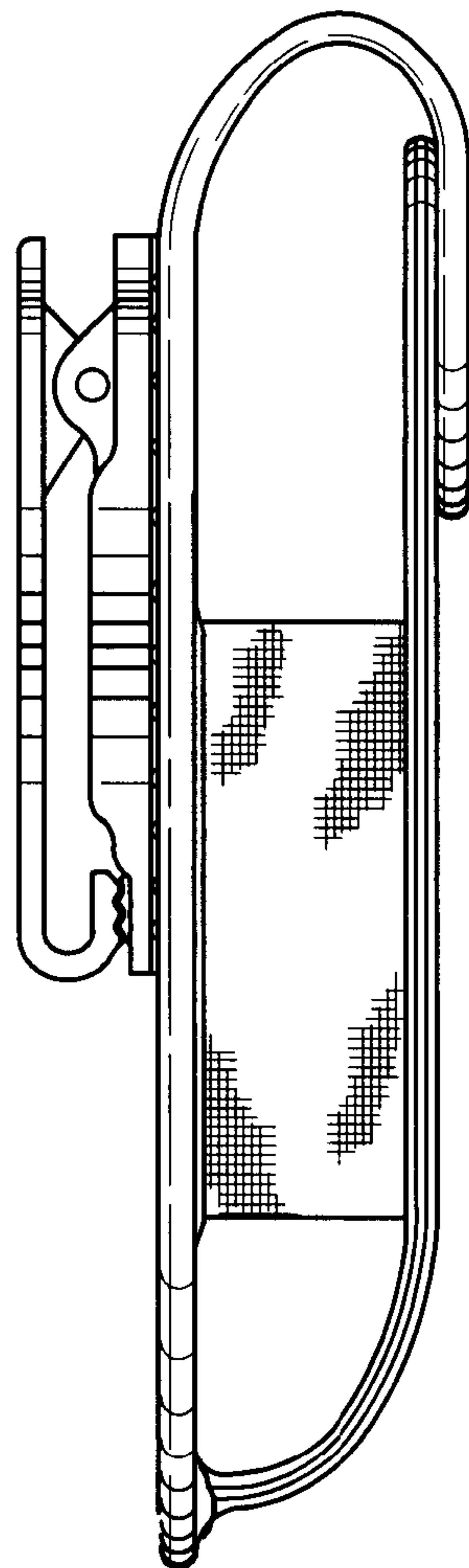

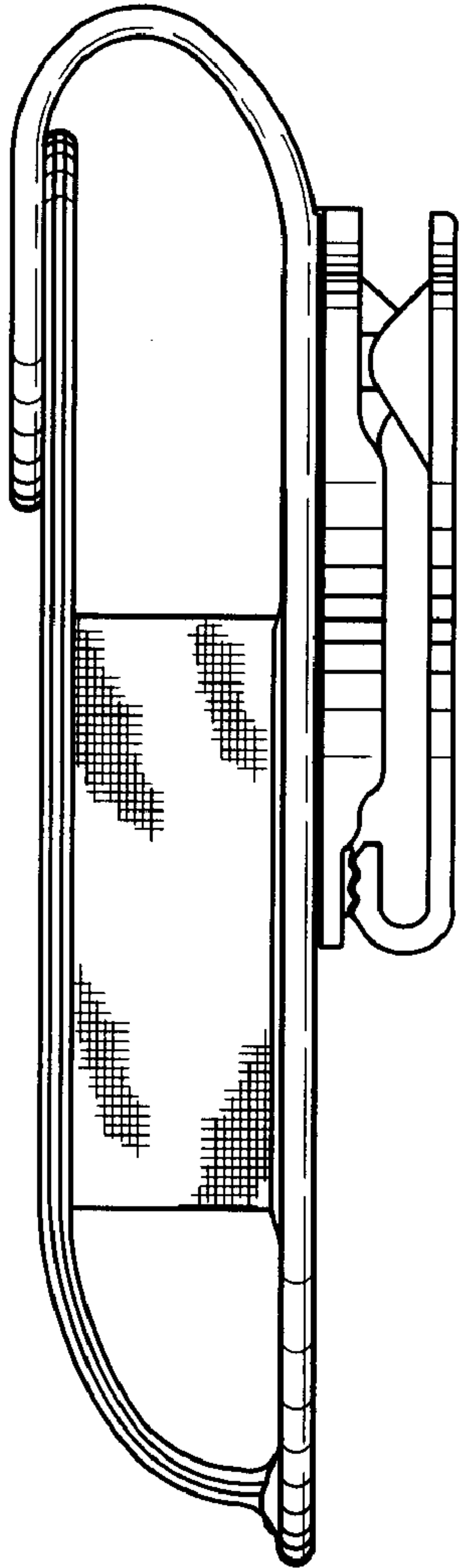

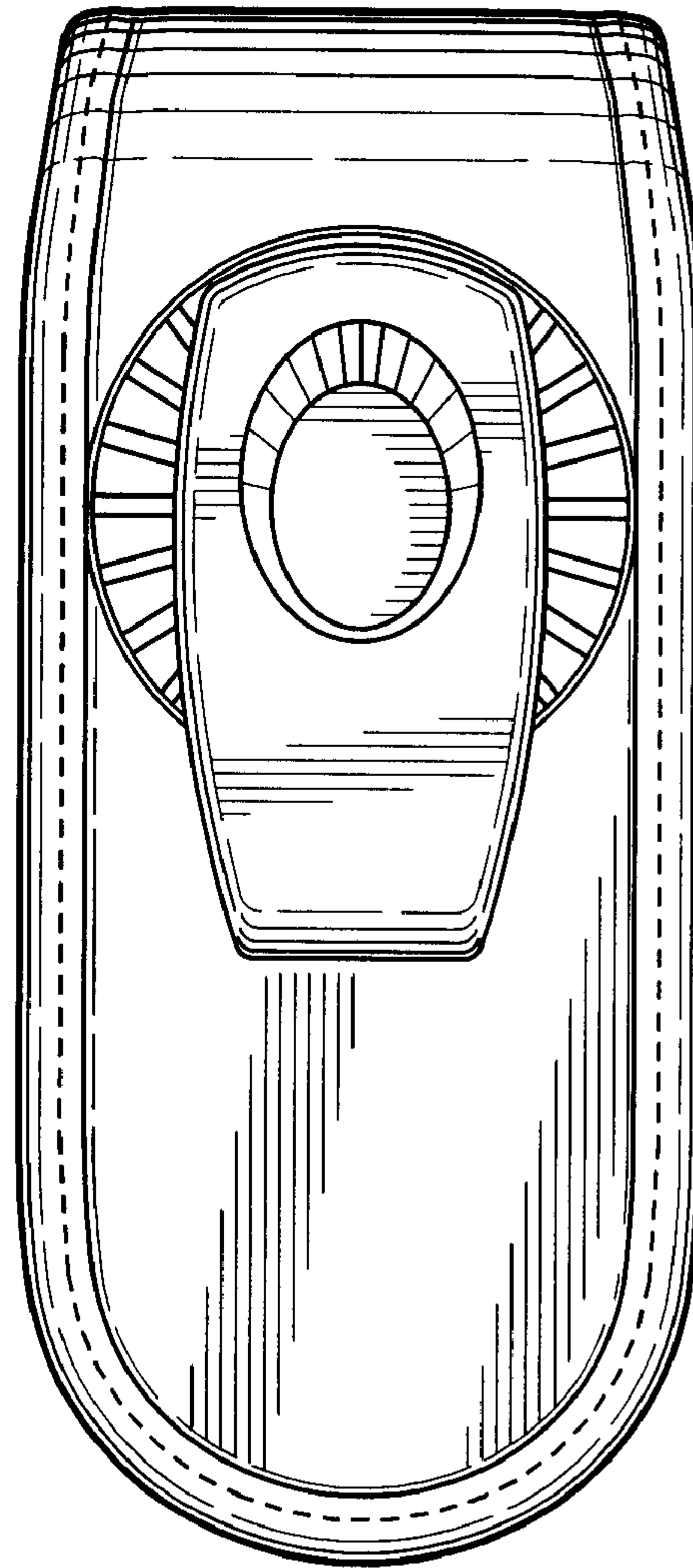

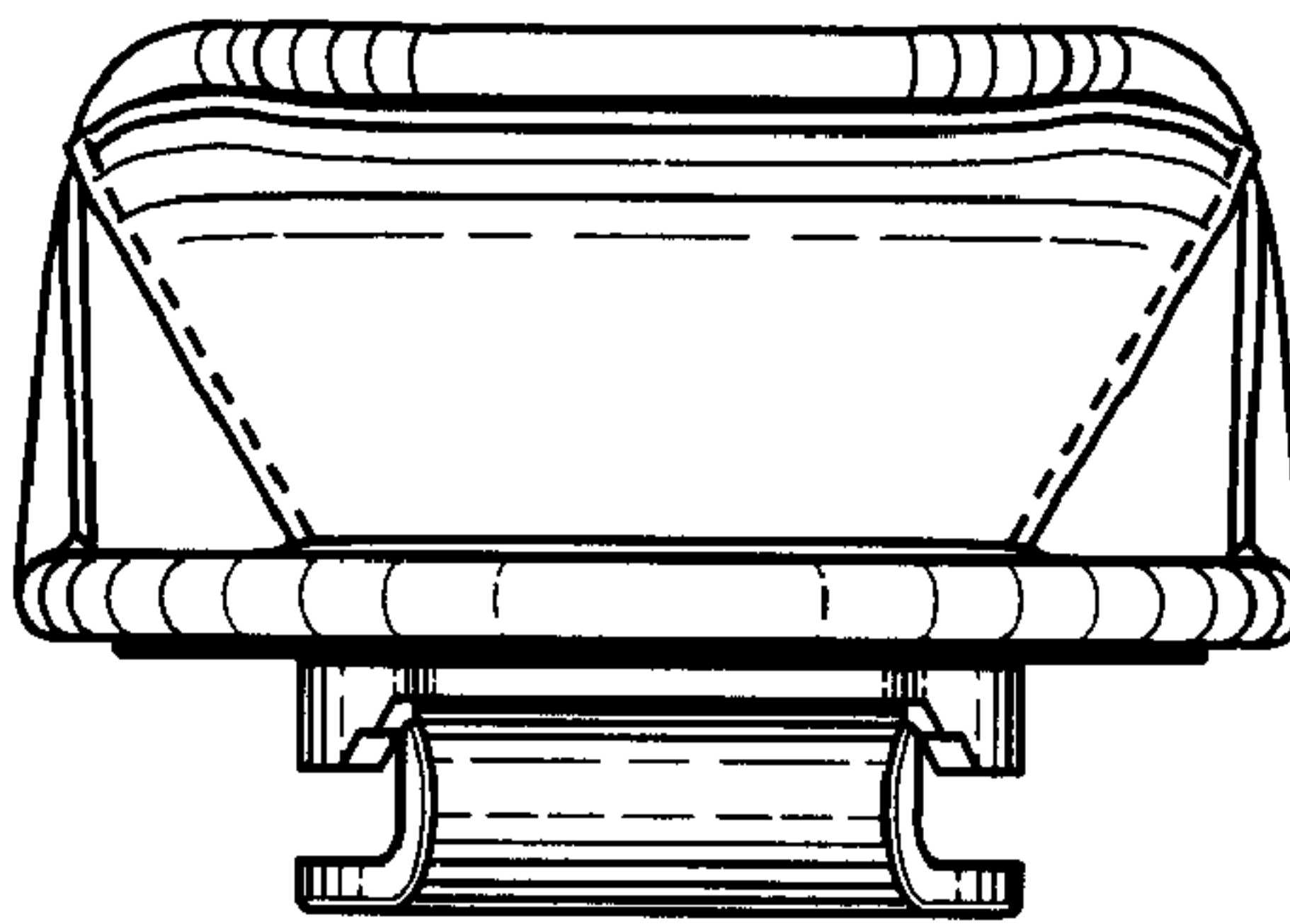
