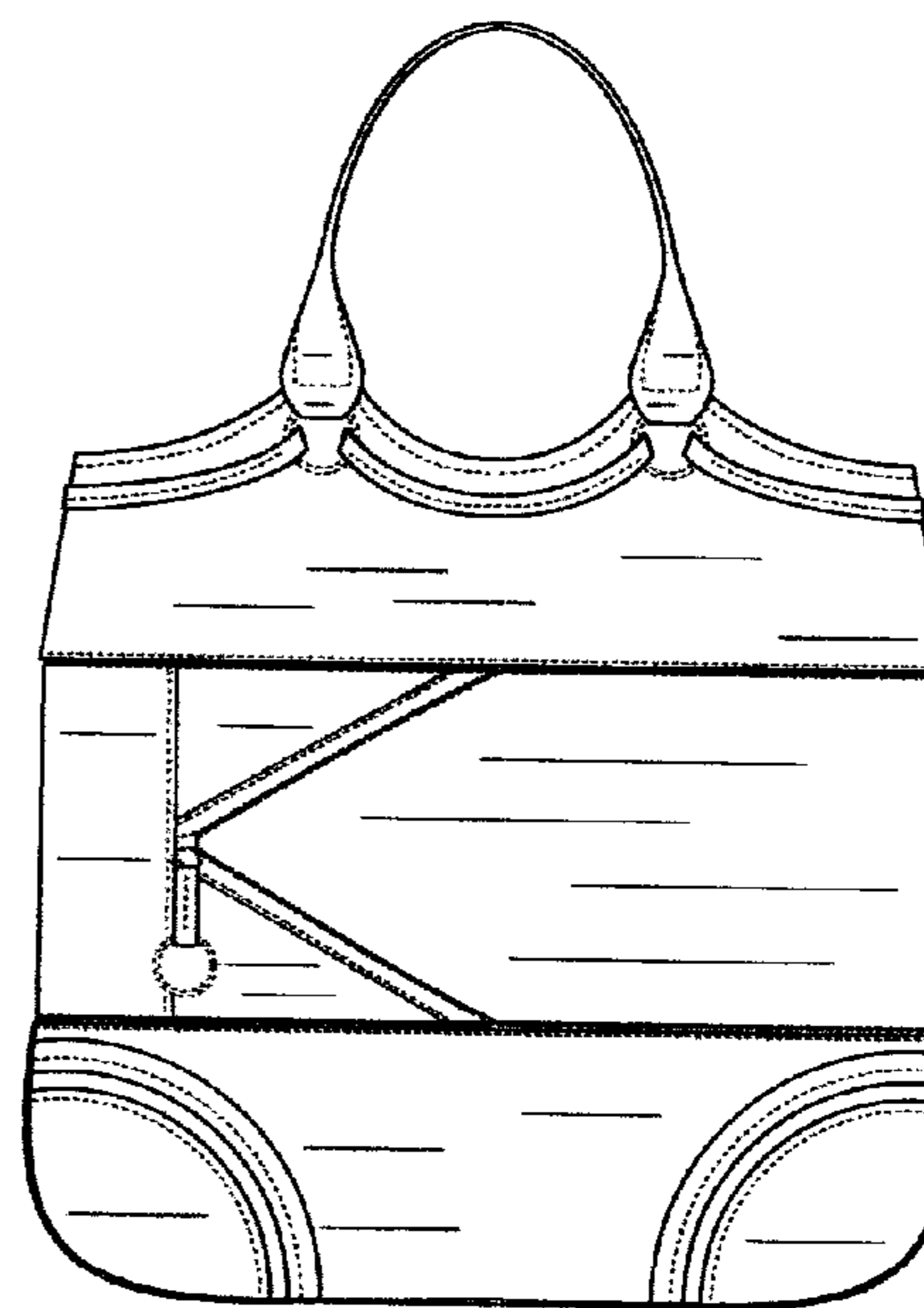
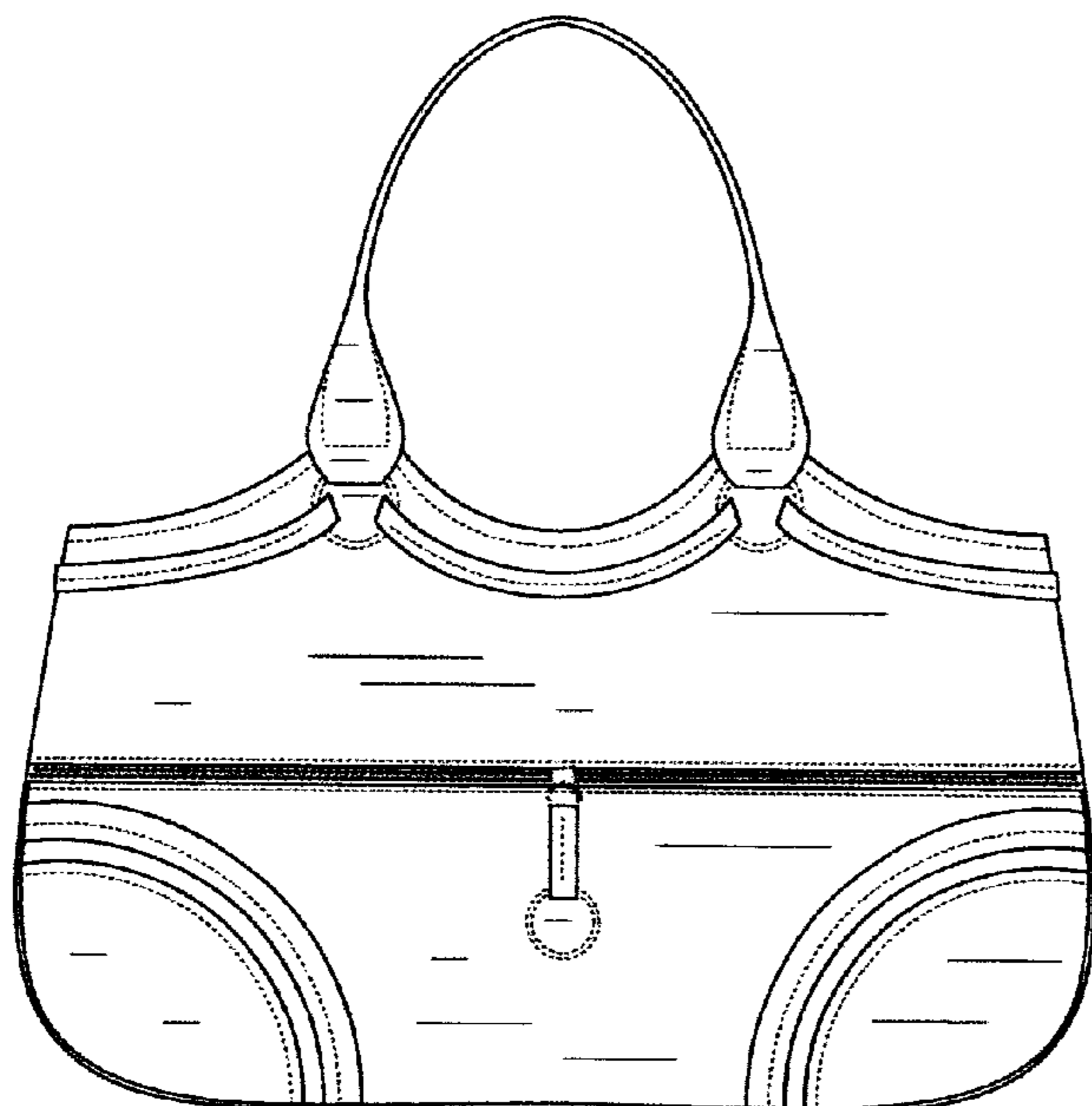
(57) **CLAIM**

The ornamental design for a handbag, as shown and described.

DESCRIPTION

FIG. 1 is a bottom plan view of my new design;
 FIG. 2 is a front elevation view thereof;
 FIG. 3 is a side elevation view thereof;
 FIG. 4 is a top plan view thereof;
 FIG. 5 is a rear elevation view thereof;
 FIG. 6 is a front elevation view of the design, but showing the handbag in an expanded condition;
 FIG. 7 is a side elevation view thereof; and,
 FIG. 8 is a rear elevation view thereof.
 The broken line showing of stitching in FIGS. 1–8 and a zipper pull in FIGS. 5, 6, and 7 is for illustrative purposes only and forms no part of the claimed design.

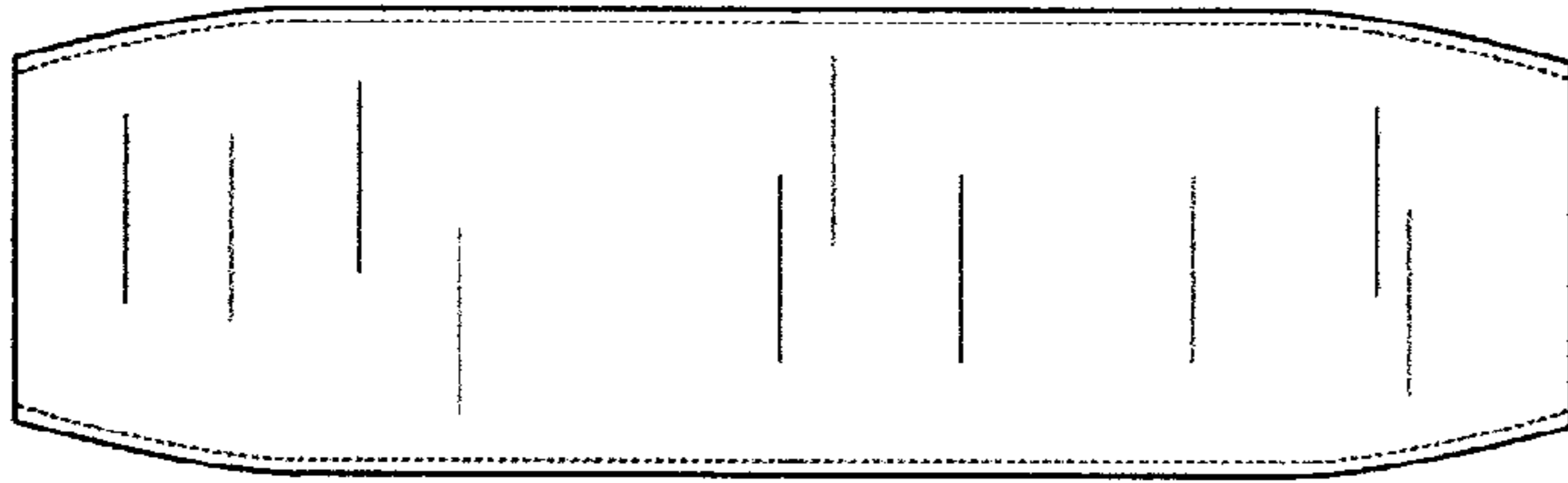

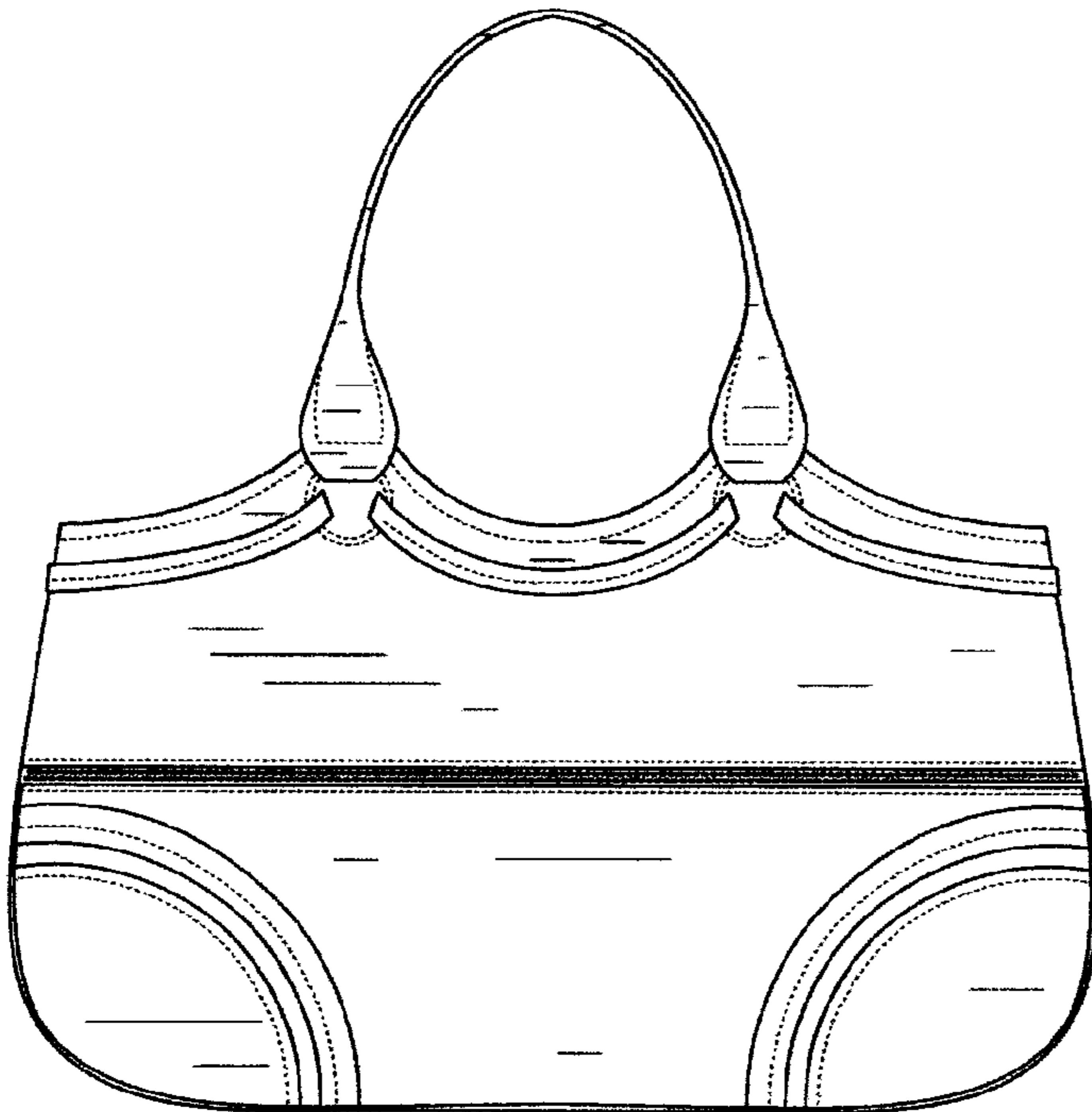

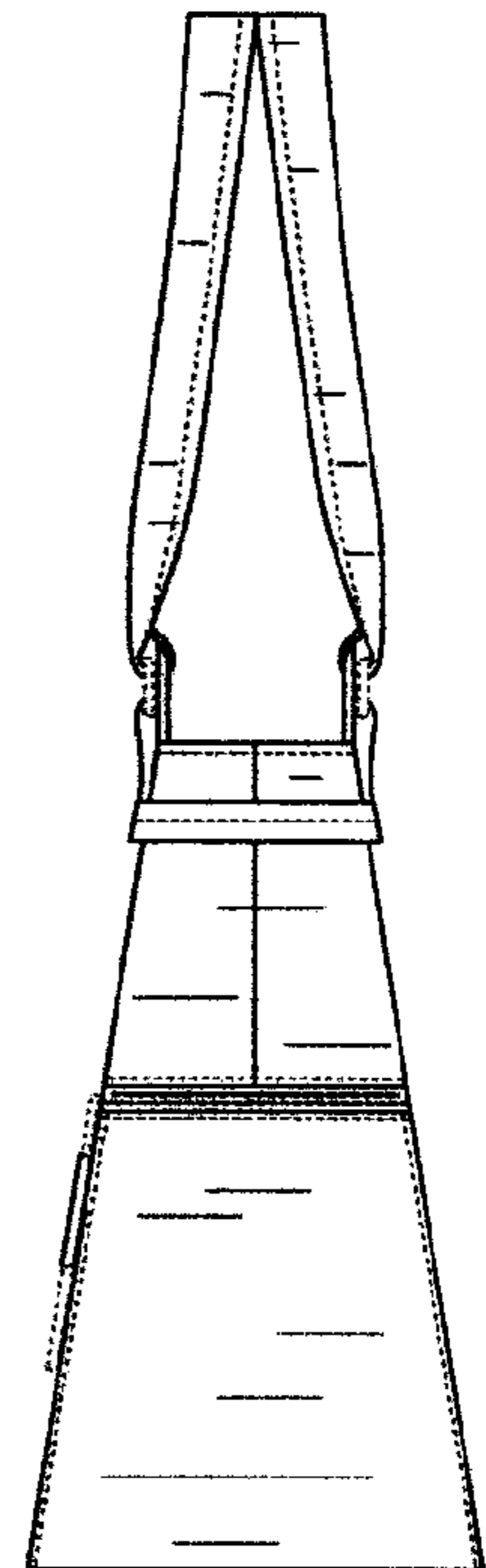

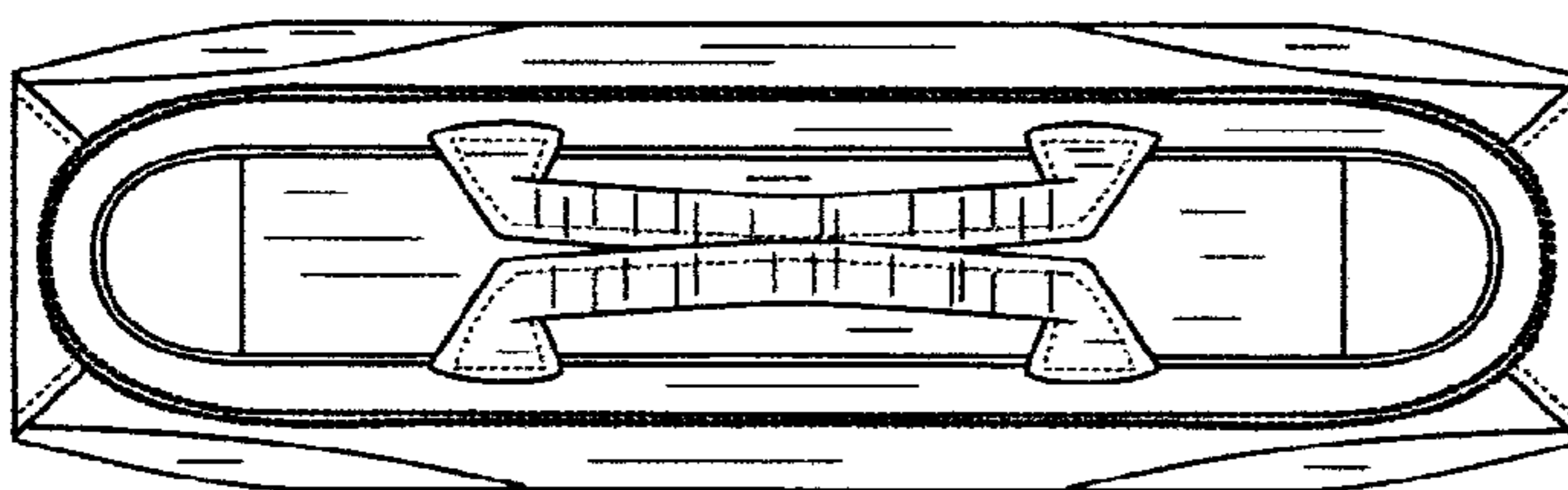

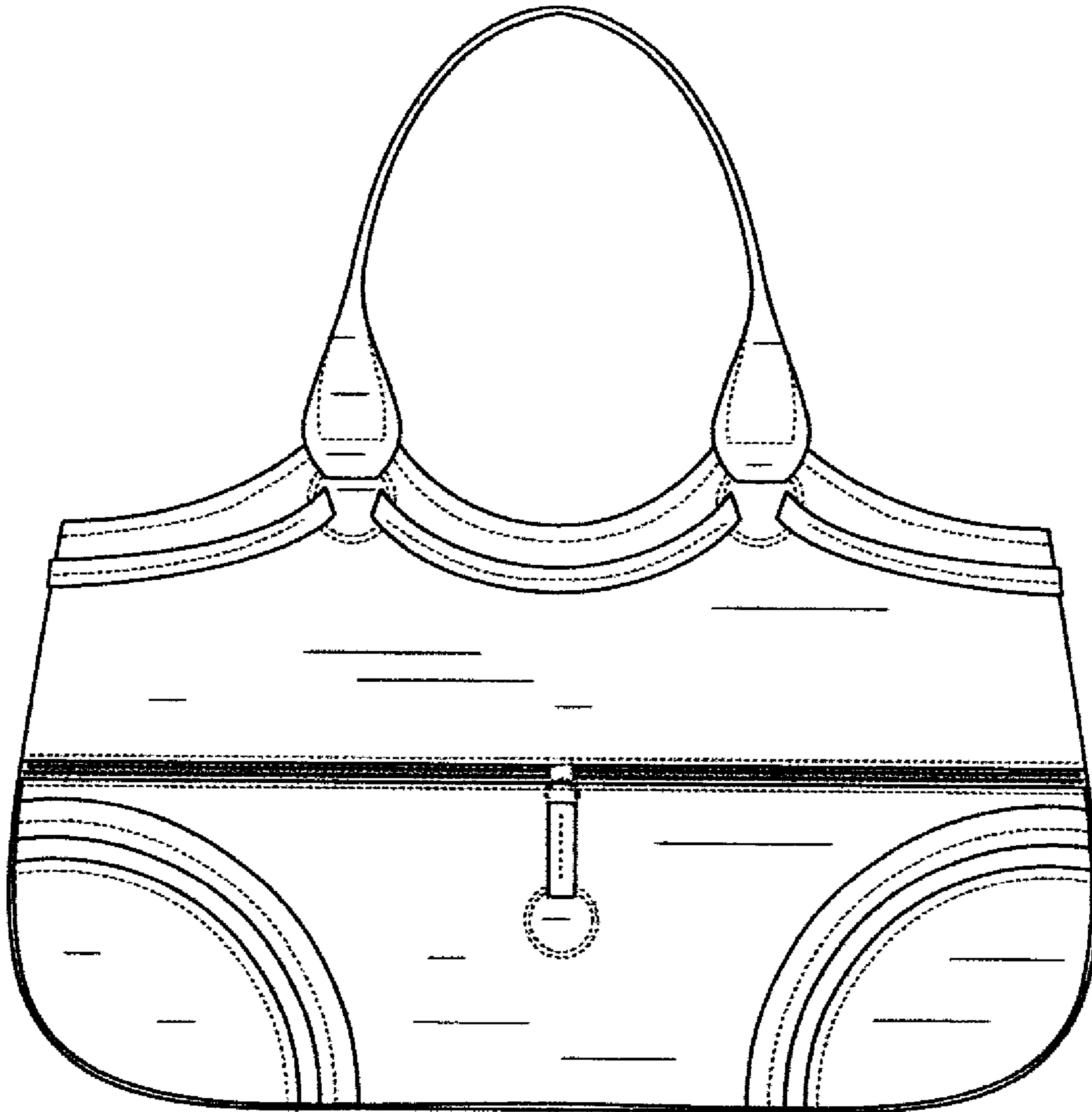

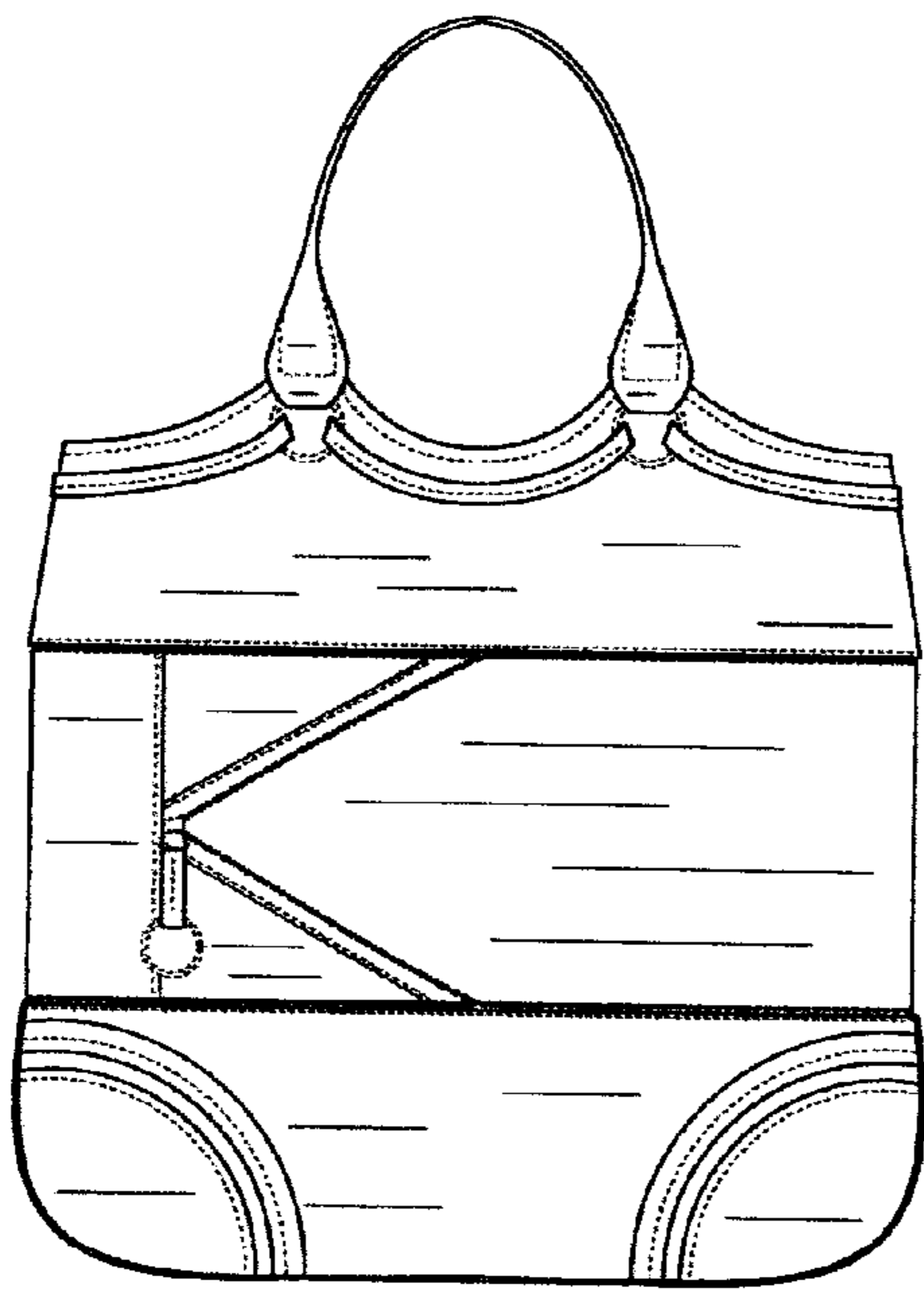

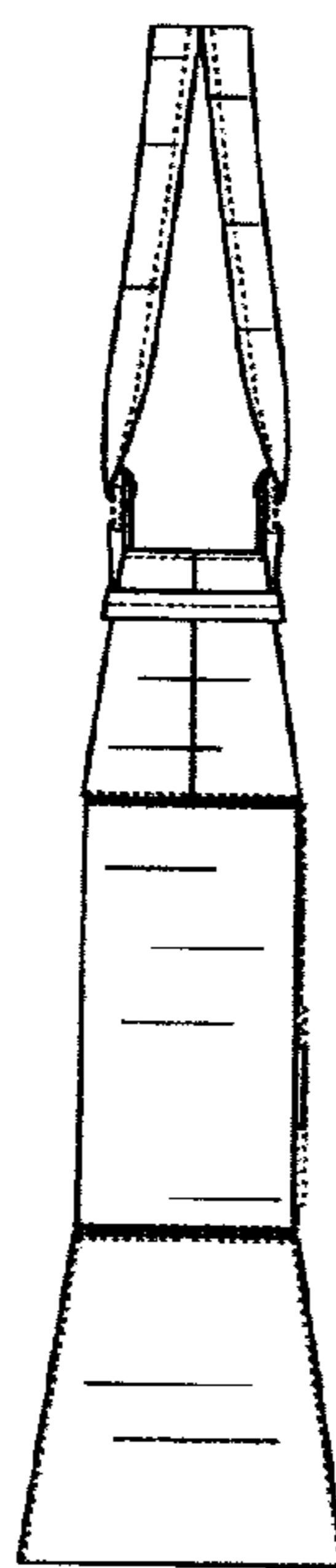

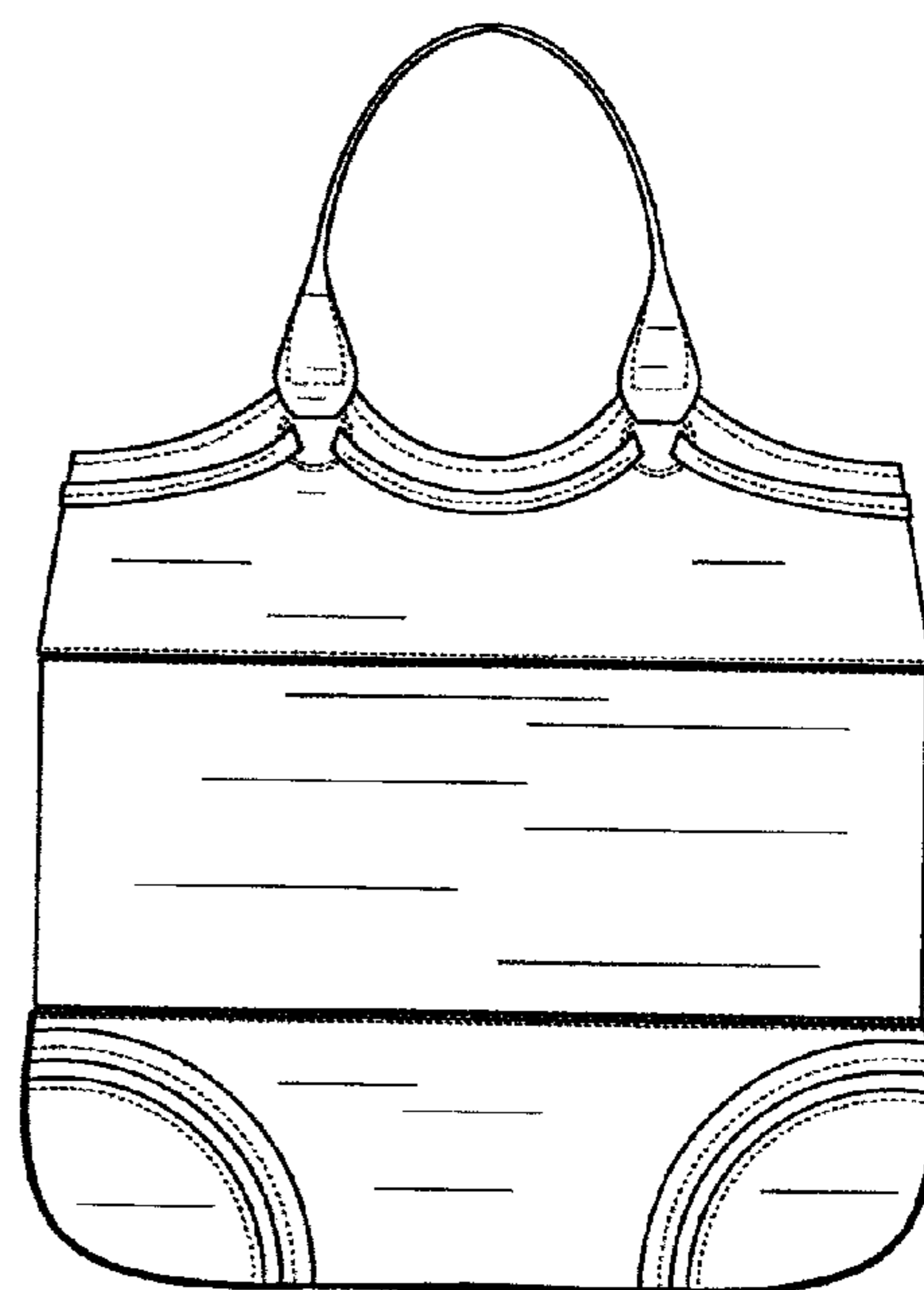
