(57) **CLAIM**

We claim the ornamental design for a grill ornamentation, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a grill ornamentation, showing our new design in an exemplary environment of a gas grill;

FIG. 2 is a perspective view thereof shown without an exemplary environment;

FIG. 3 is a front elevational view thereof;

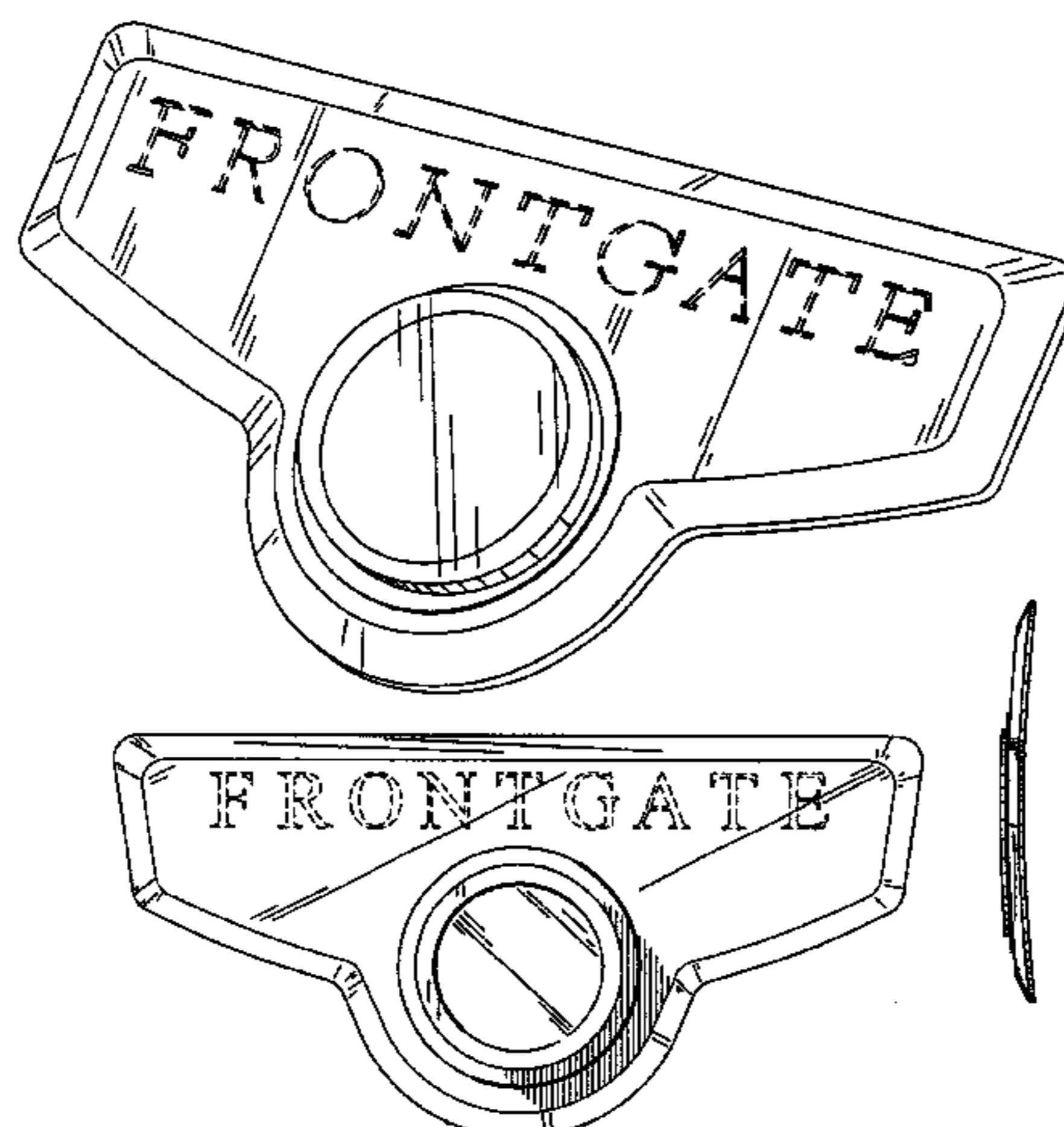
FIG. 4 is a right side elevational view thereof;

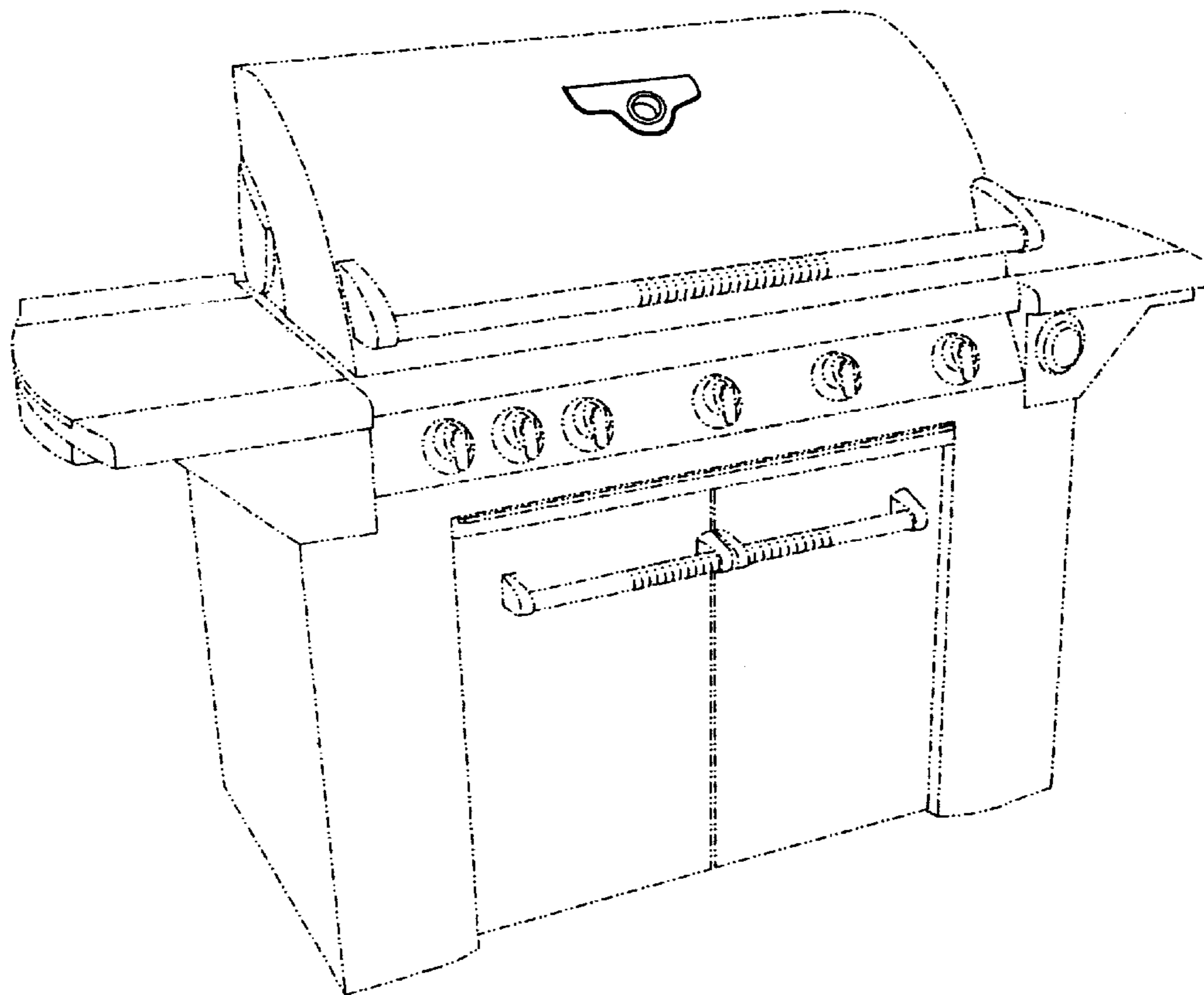

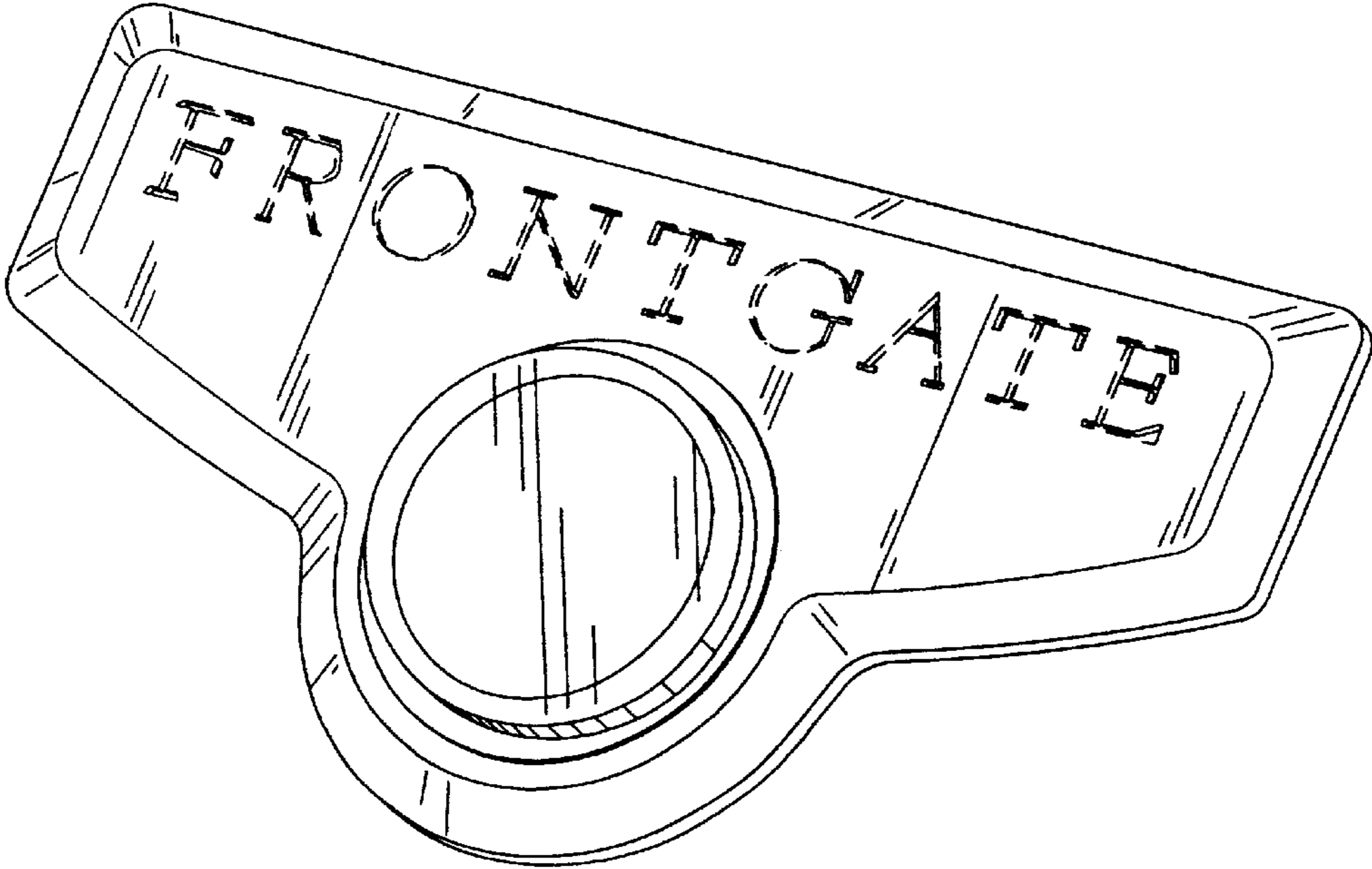

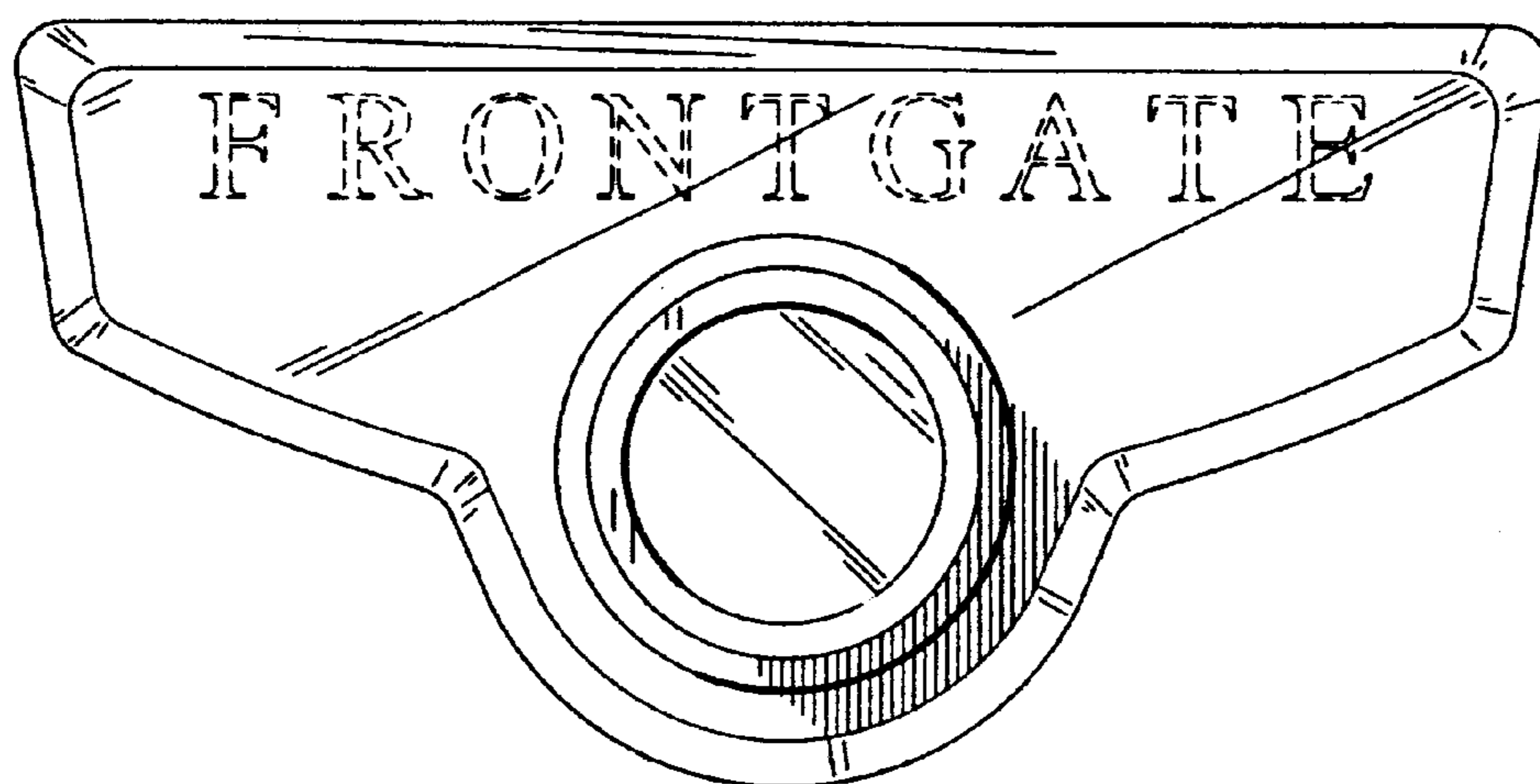

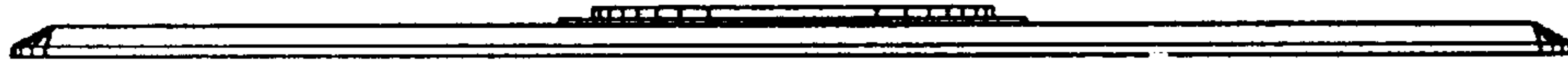

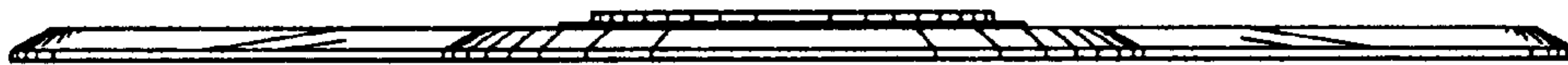
