(57) **CLAIM**

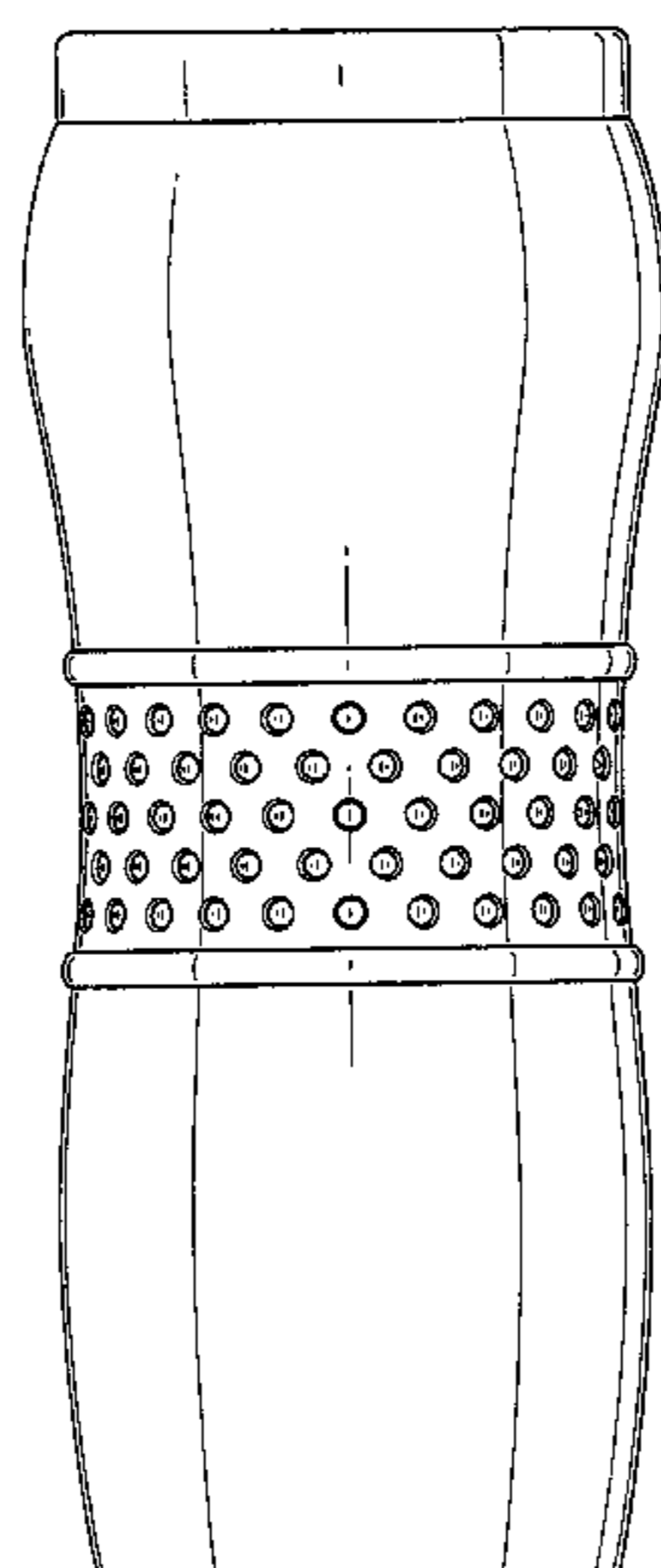
I claim the ornamental design for a cup, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the cup;
 FIG. 2 is a side view of the design embodiment shown in FIG. 1;
 FIG. 3 is a top view of the design embodiment shown in FIG. 1;
 FIG. 4 is a bottom view of the design embodiment shown in FIG. 1;
 FIG. 5 is a top, front perspective view of a cup showing a second embodiment of my new design;
 FIG. 6 is a front side view of the design embodiment shown in FIG. 5;
 FIG. 7 is a back side view of the design embodiment shown in FIG. 5;
 FIG. 8 is a left side view of the design embodiment shown in FIG. 5;
 FIG. 9 is a right side view of the design embodiment shown in FIG. 5;
 FIG. 10 is a top view of the design embodiment shown in FIG. 5; and,
 FIG. 11 is a bottom view of the design embodiment shown in FIG. 5.

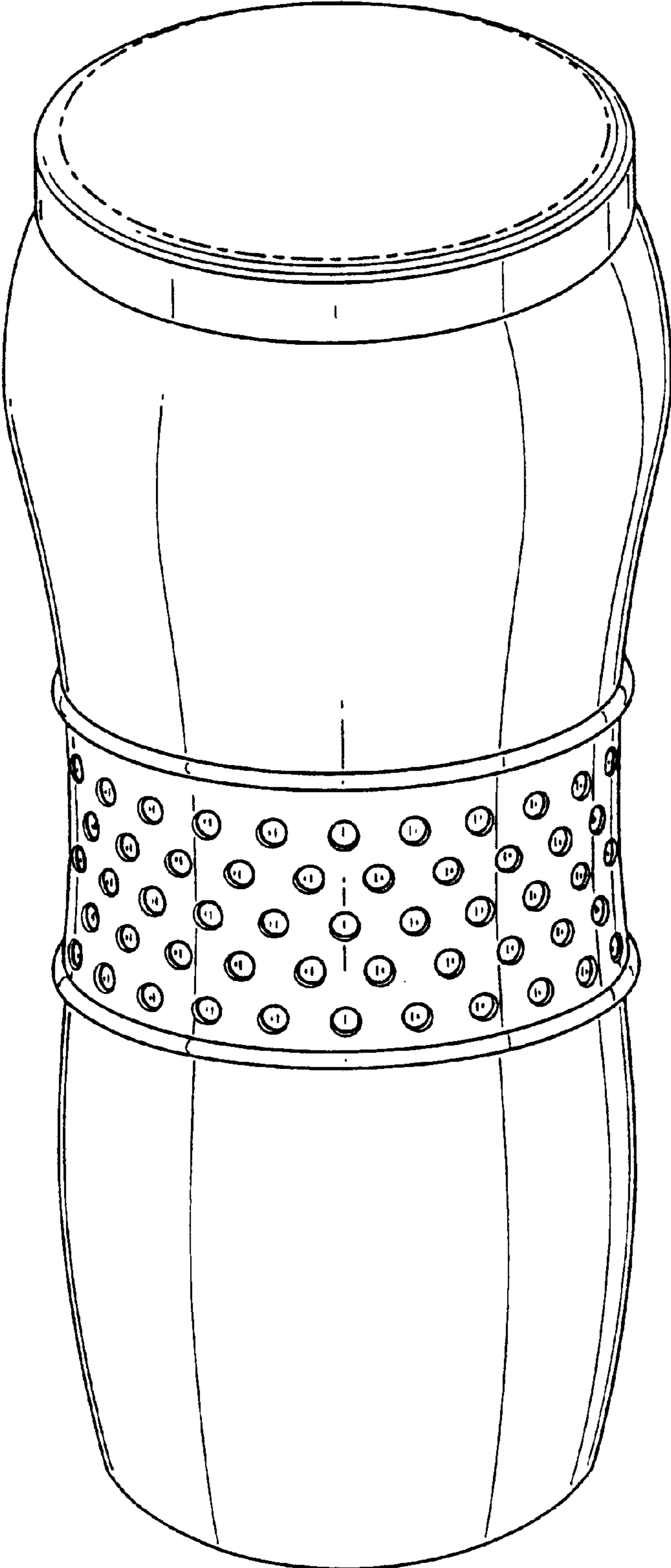

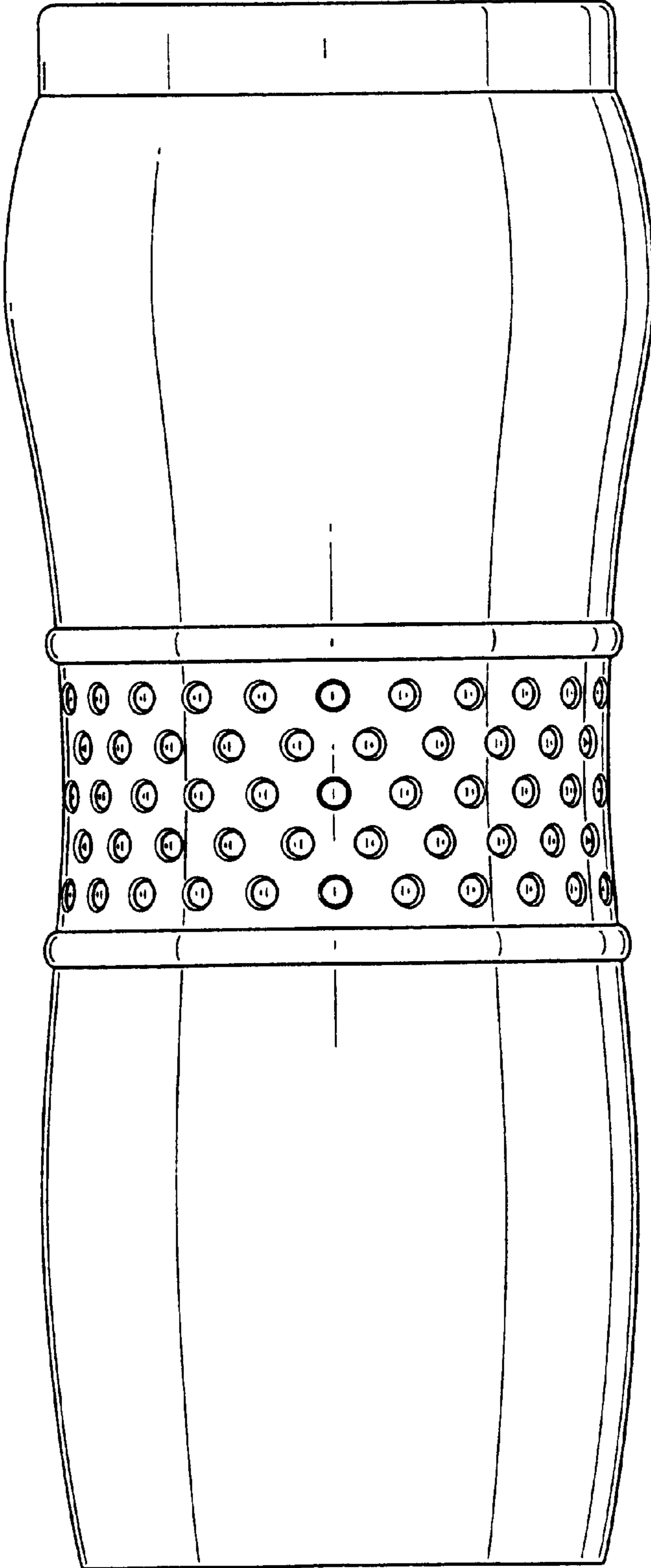

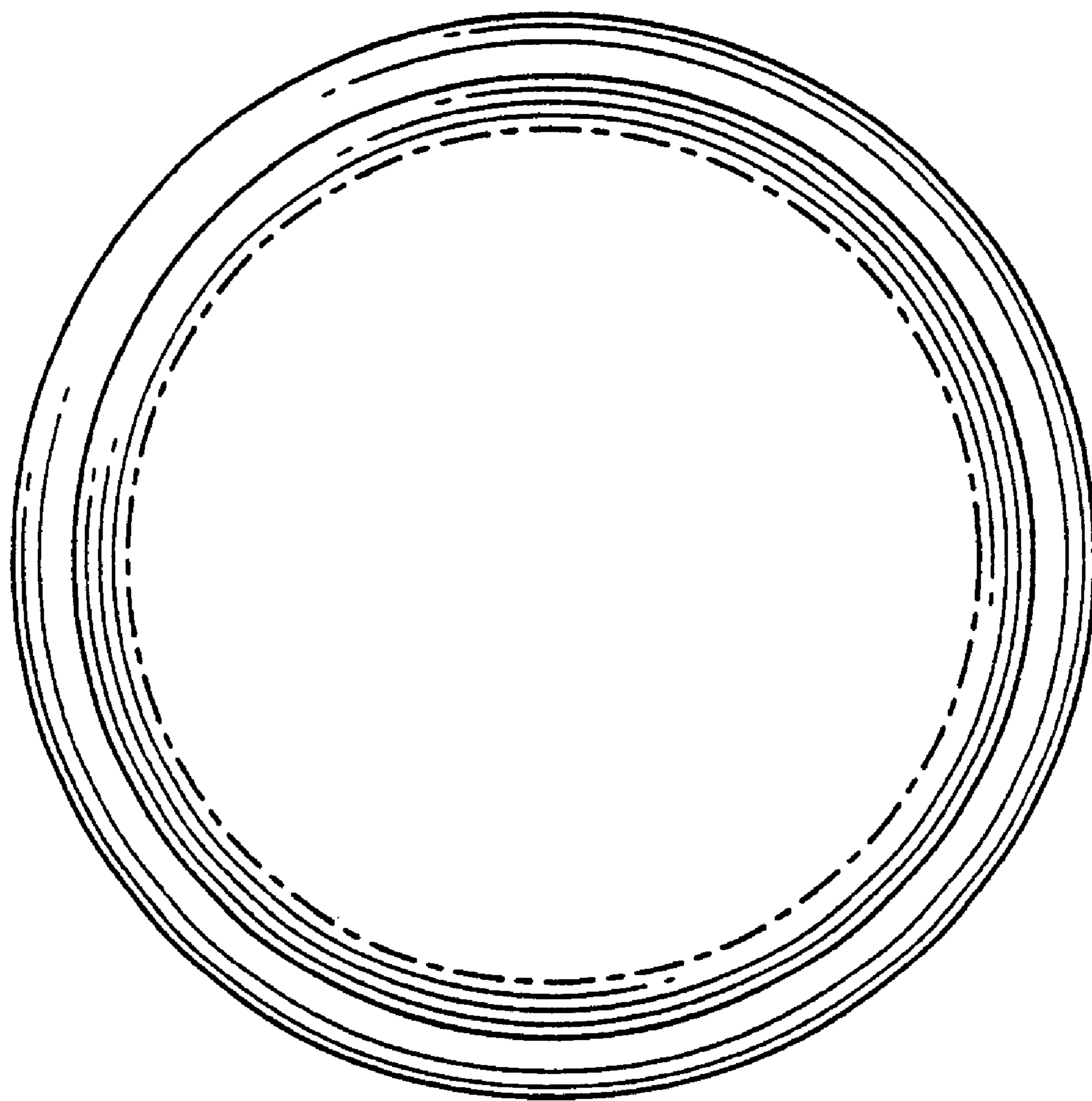

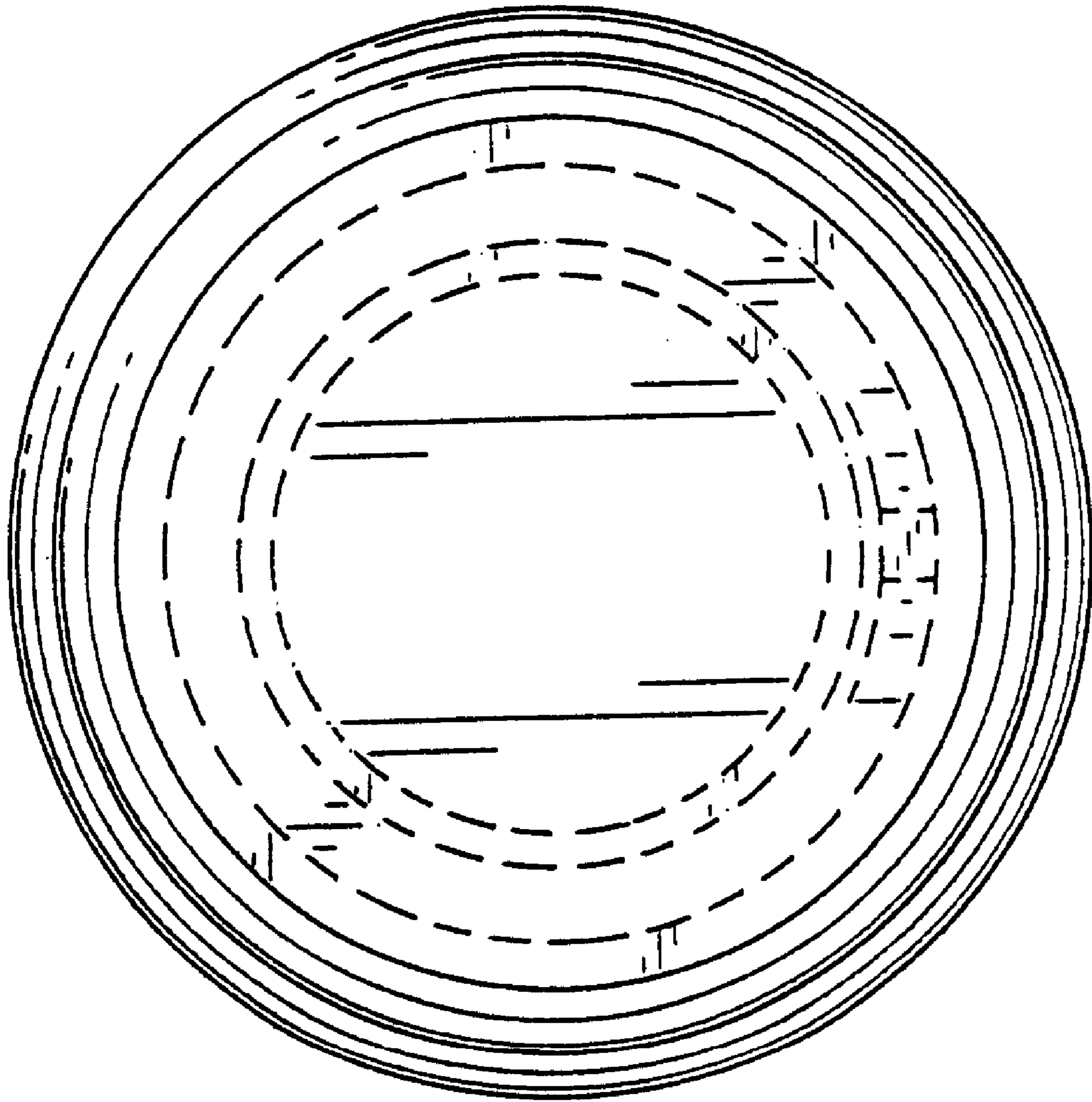

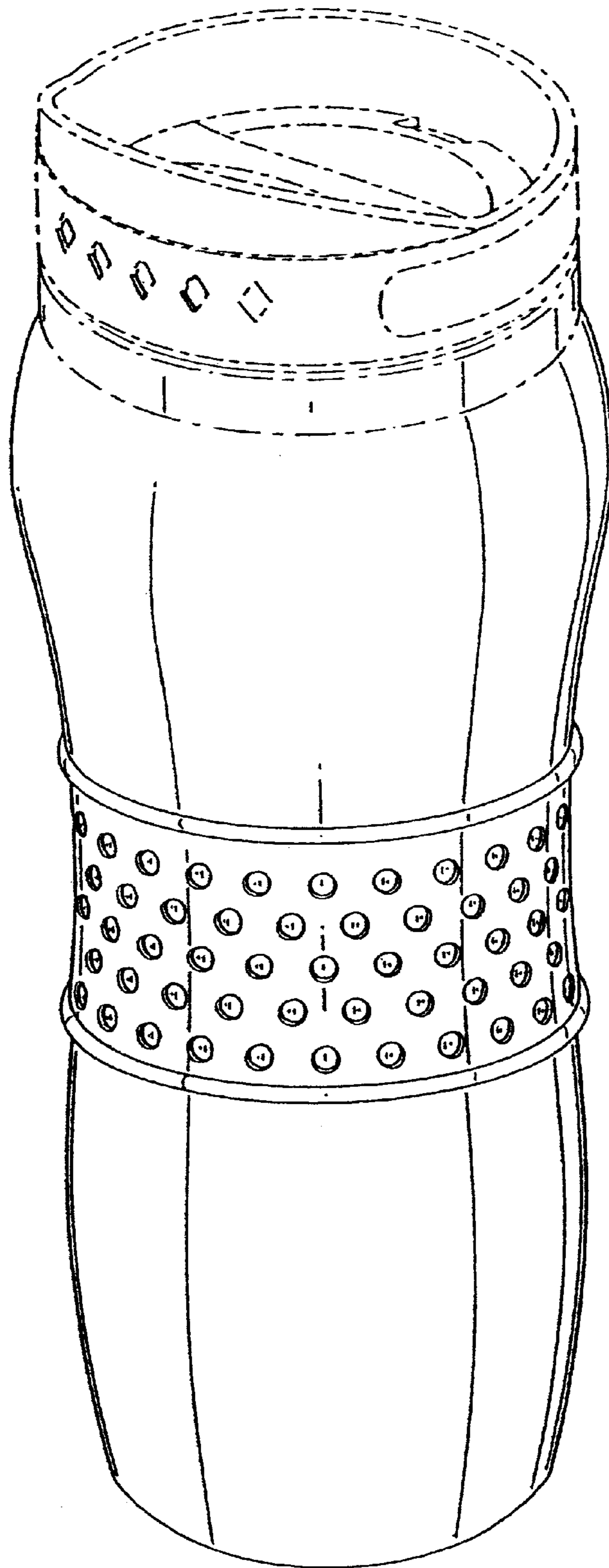

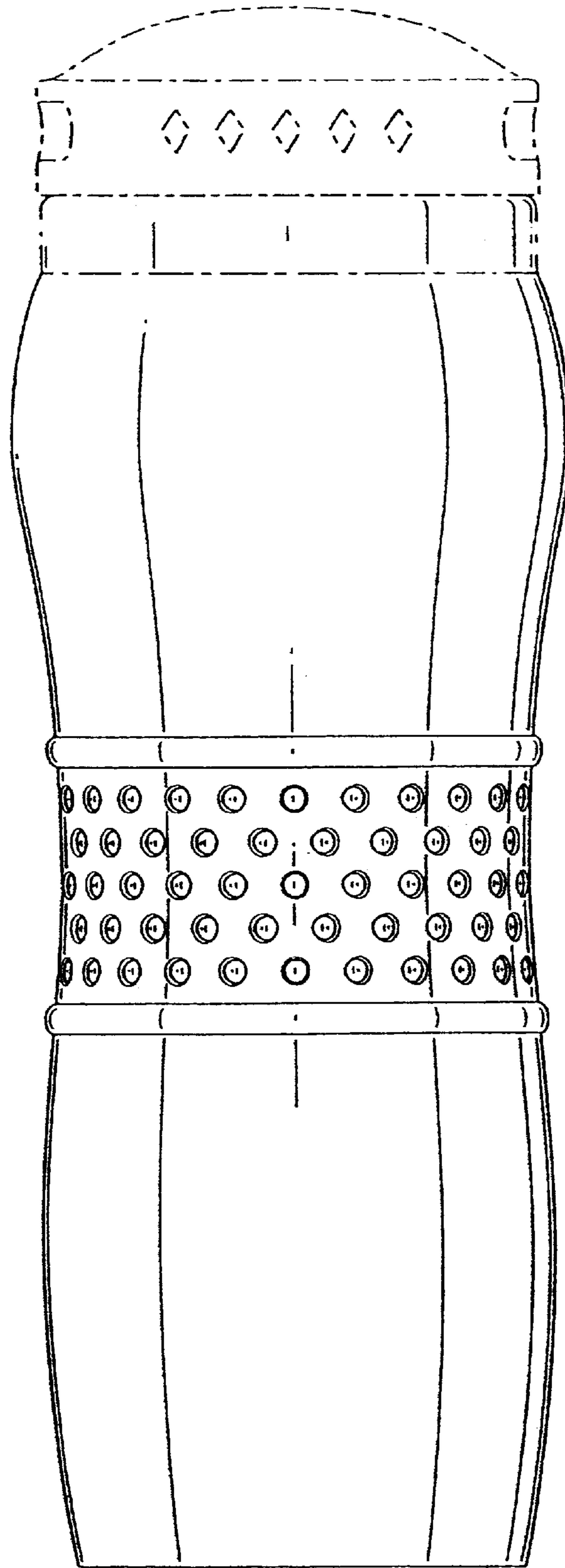

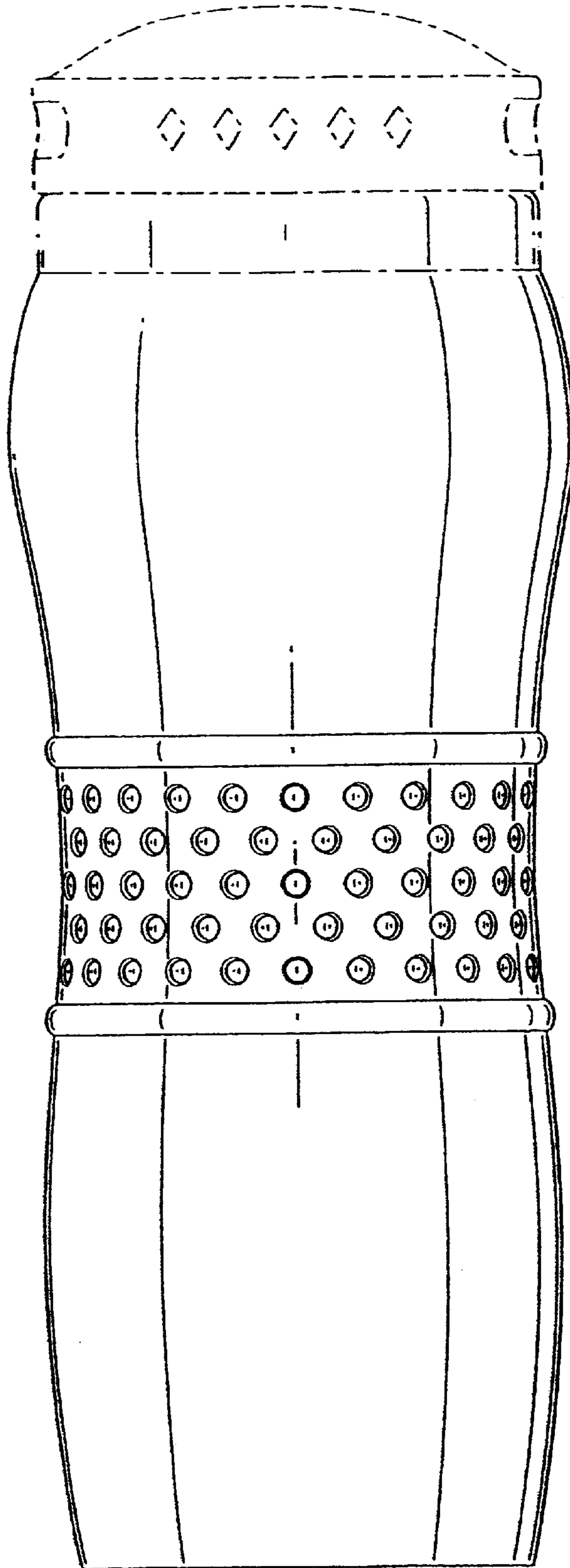

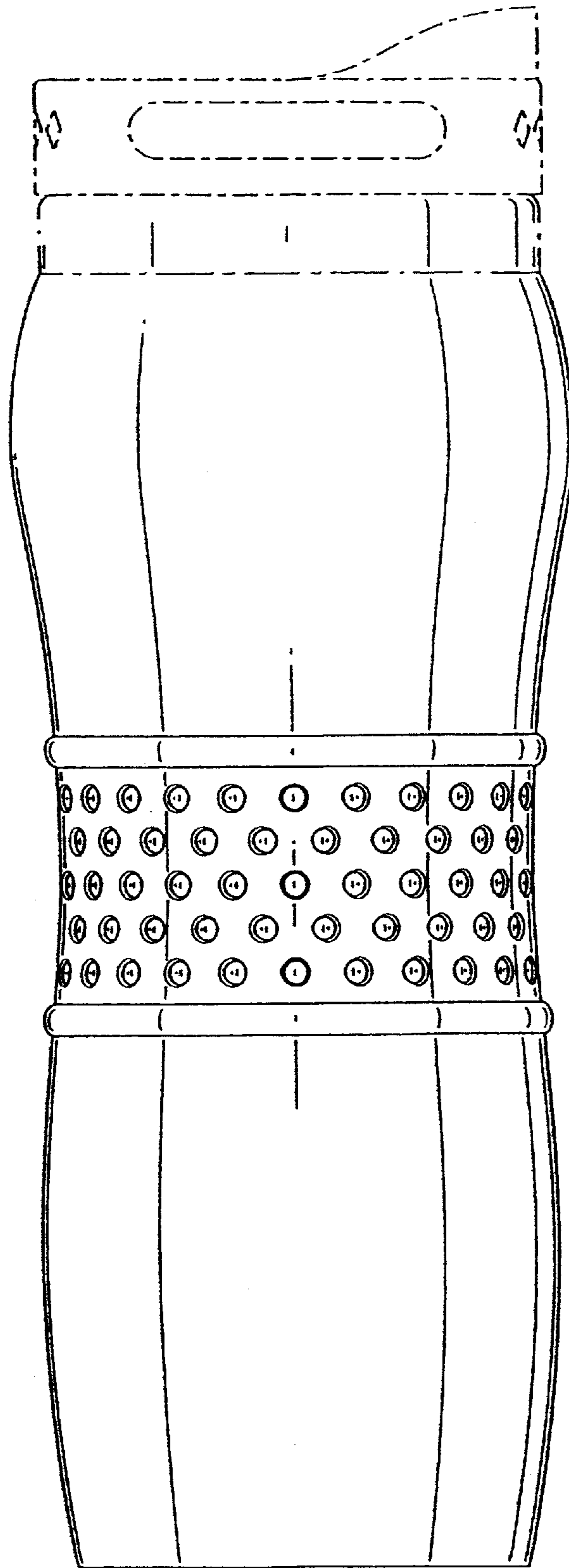

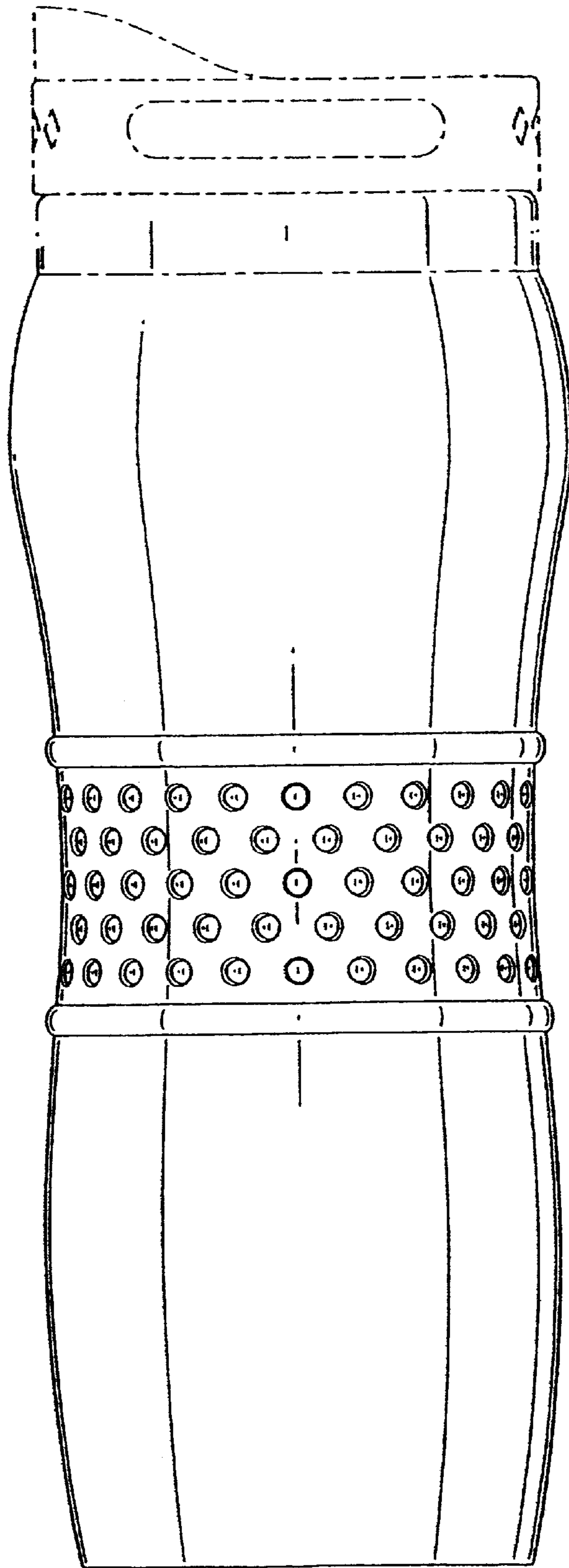

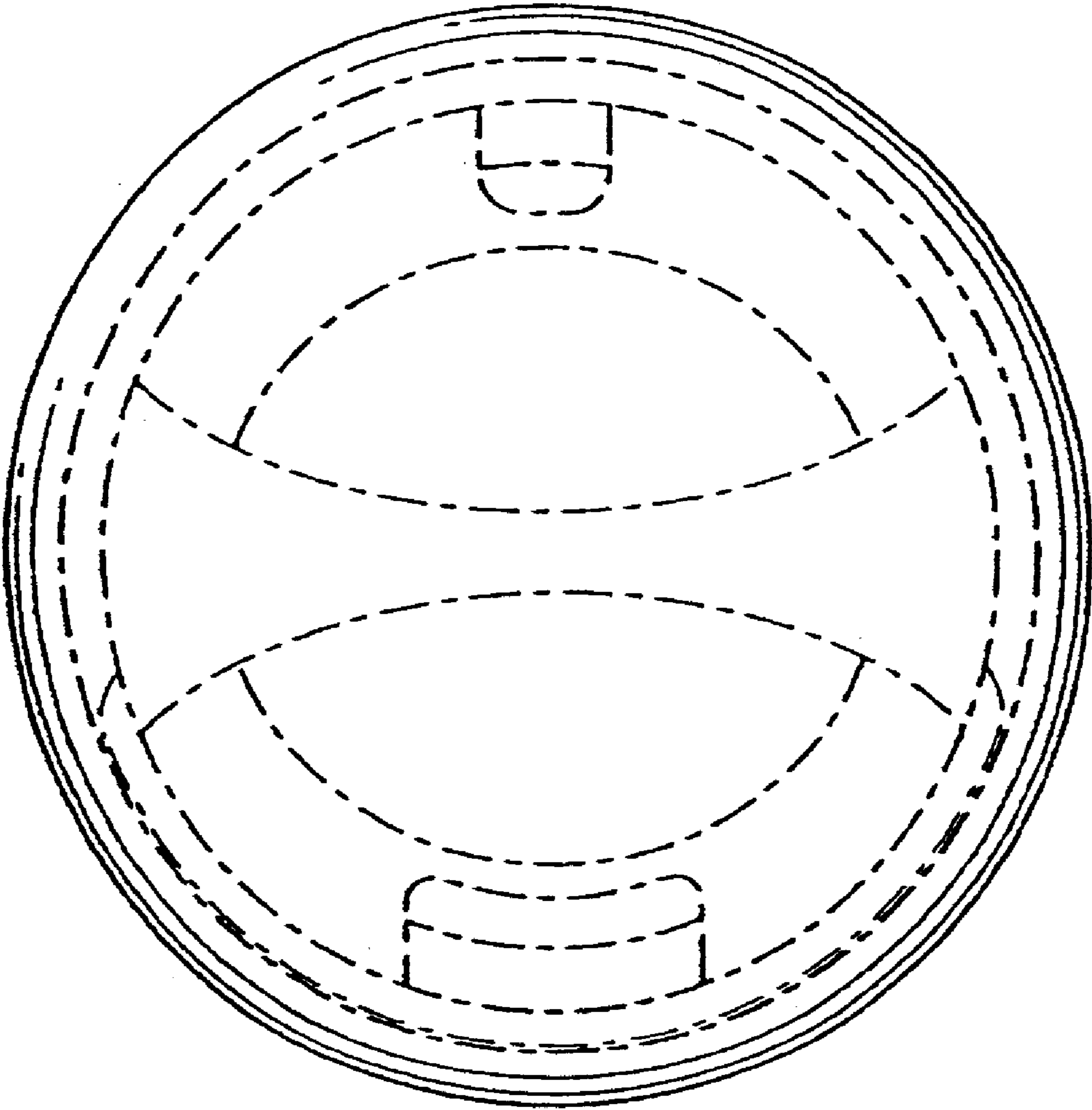

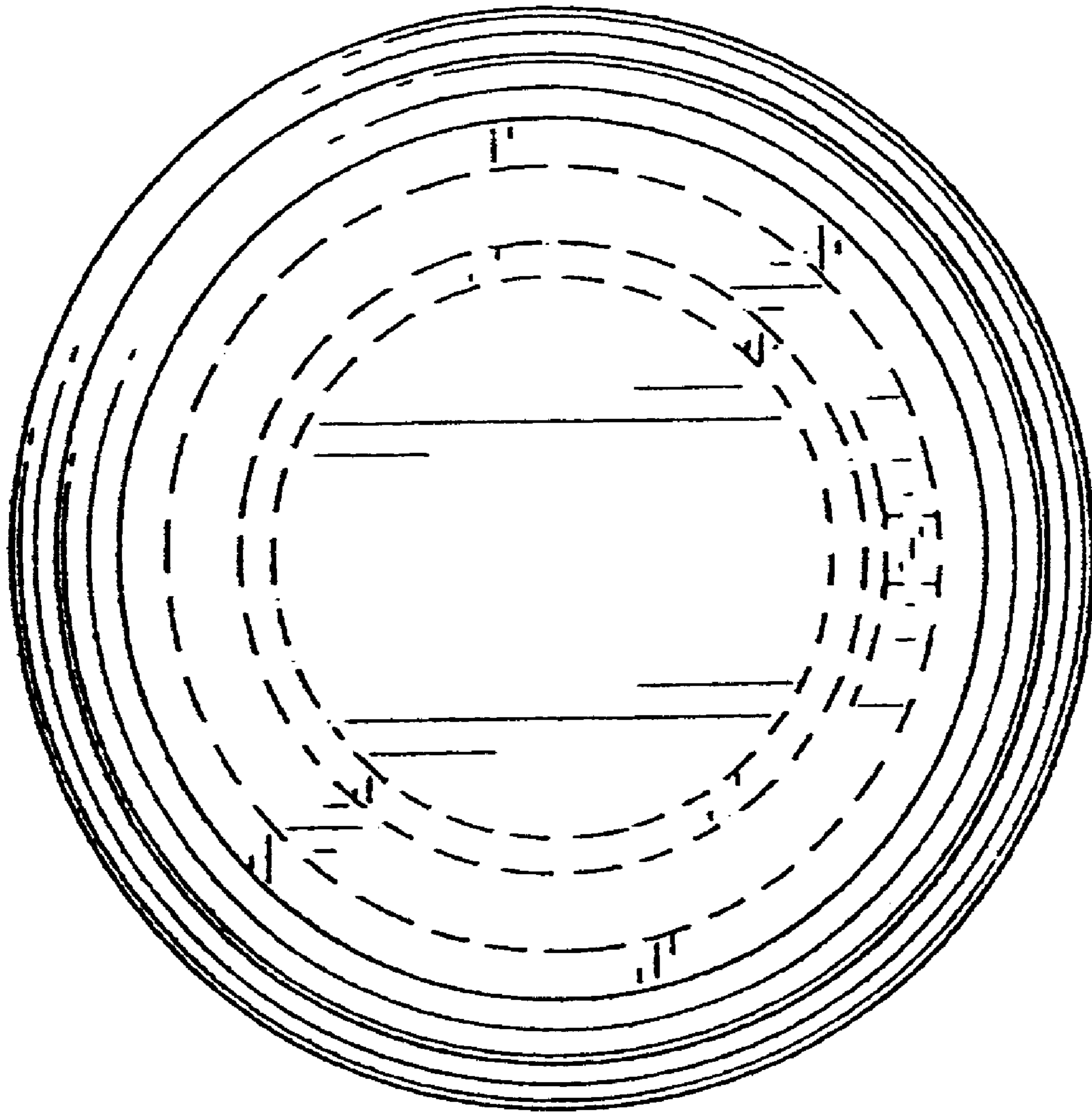
