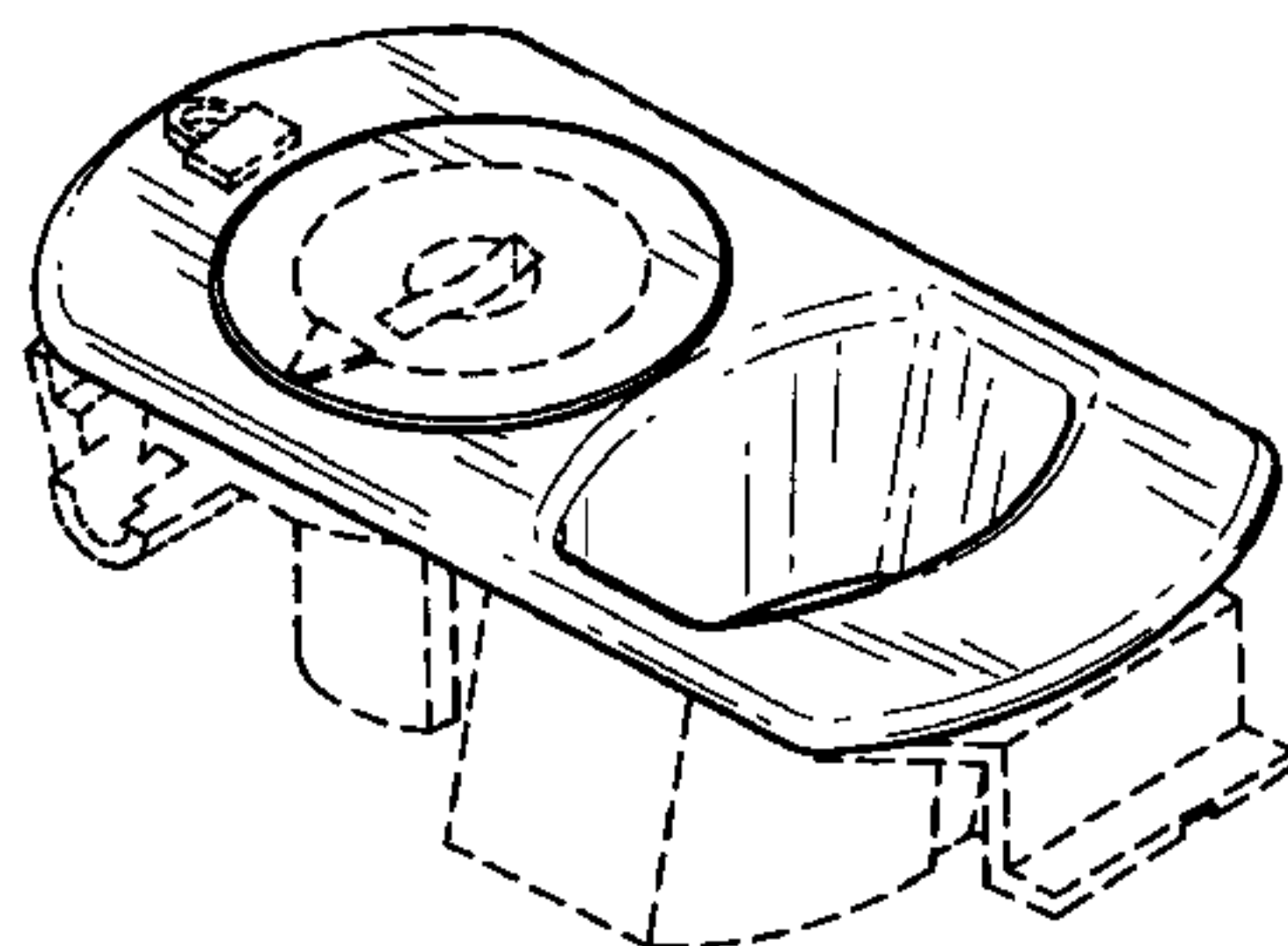
(57) **CLAIM**

The ornamental design for a slide latch, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a slide latch showing my new design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a right side elevational view thereof;  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a left side elevational view thereof; and,  
FIG. 6 is a perspective view thereof.  
The broken lines in the figures are for illustrative purposes only and form no part of the claimed design.
