**DESCRIPTION**

FIG. 1 is a front perspective view of a spray cap showing the first embodiment of our new design;

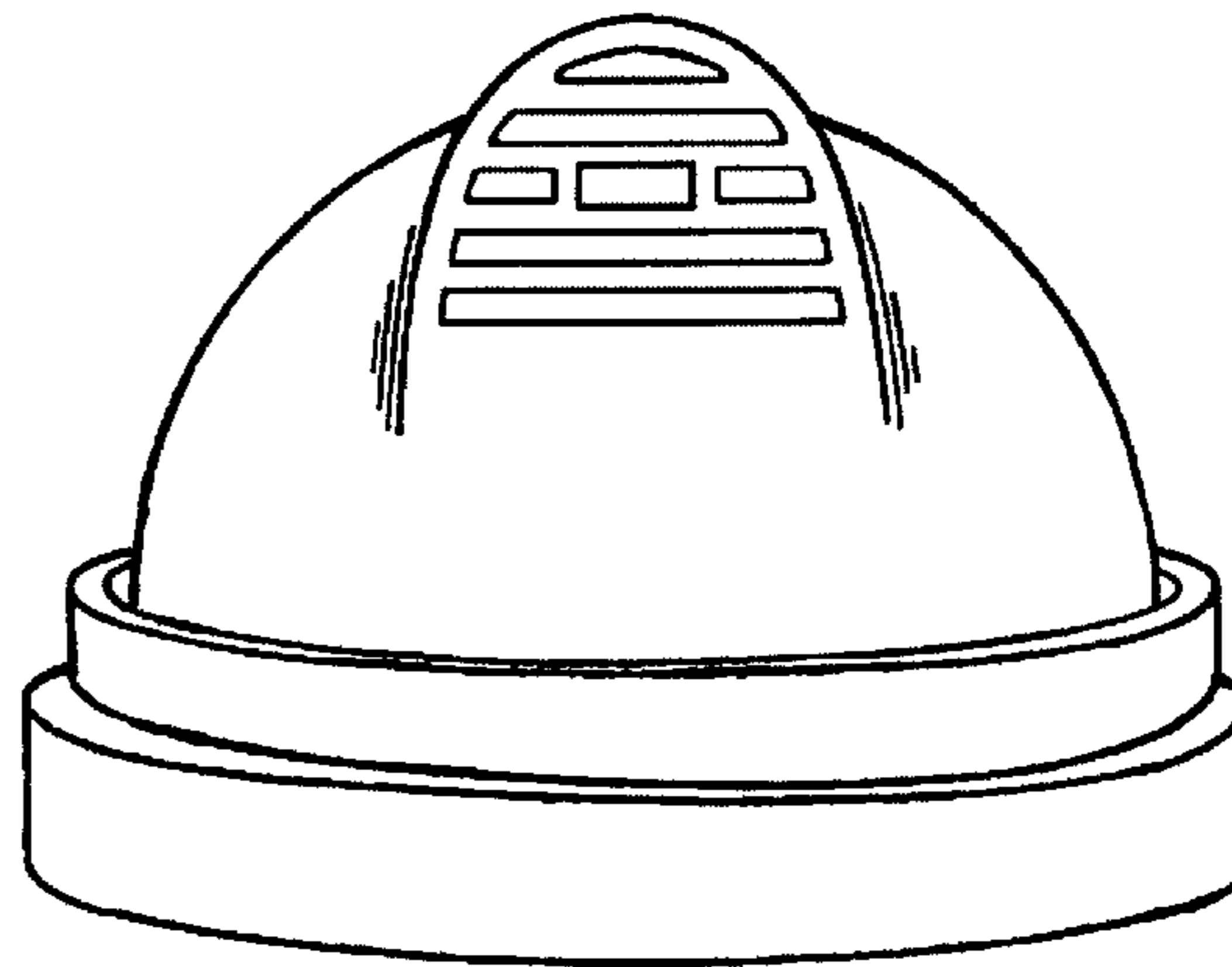
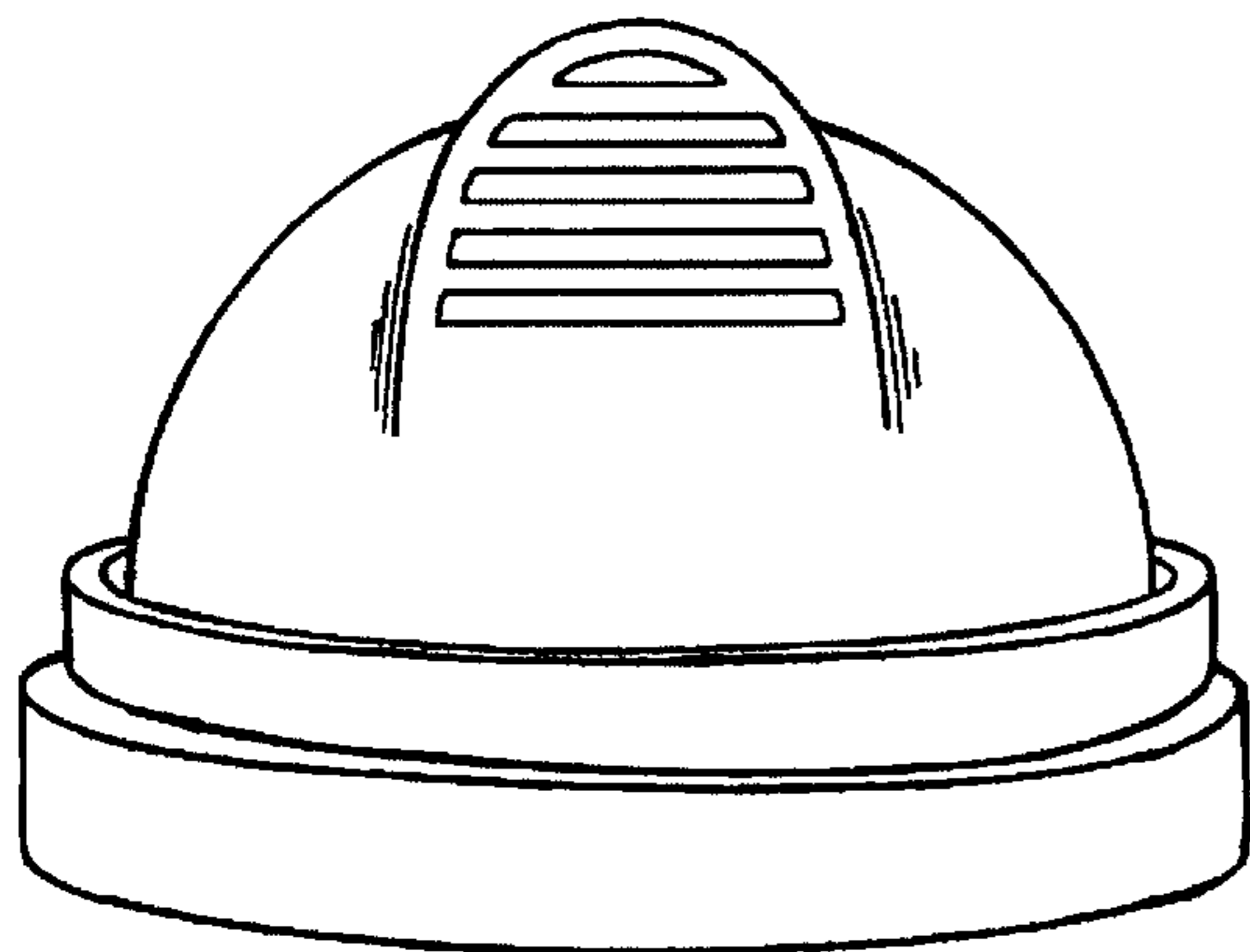

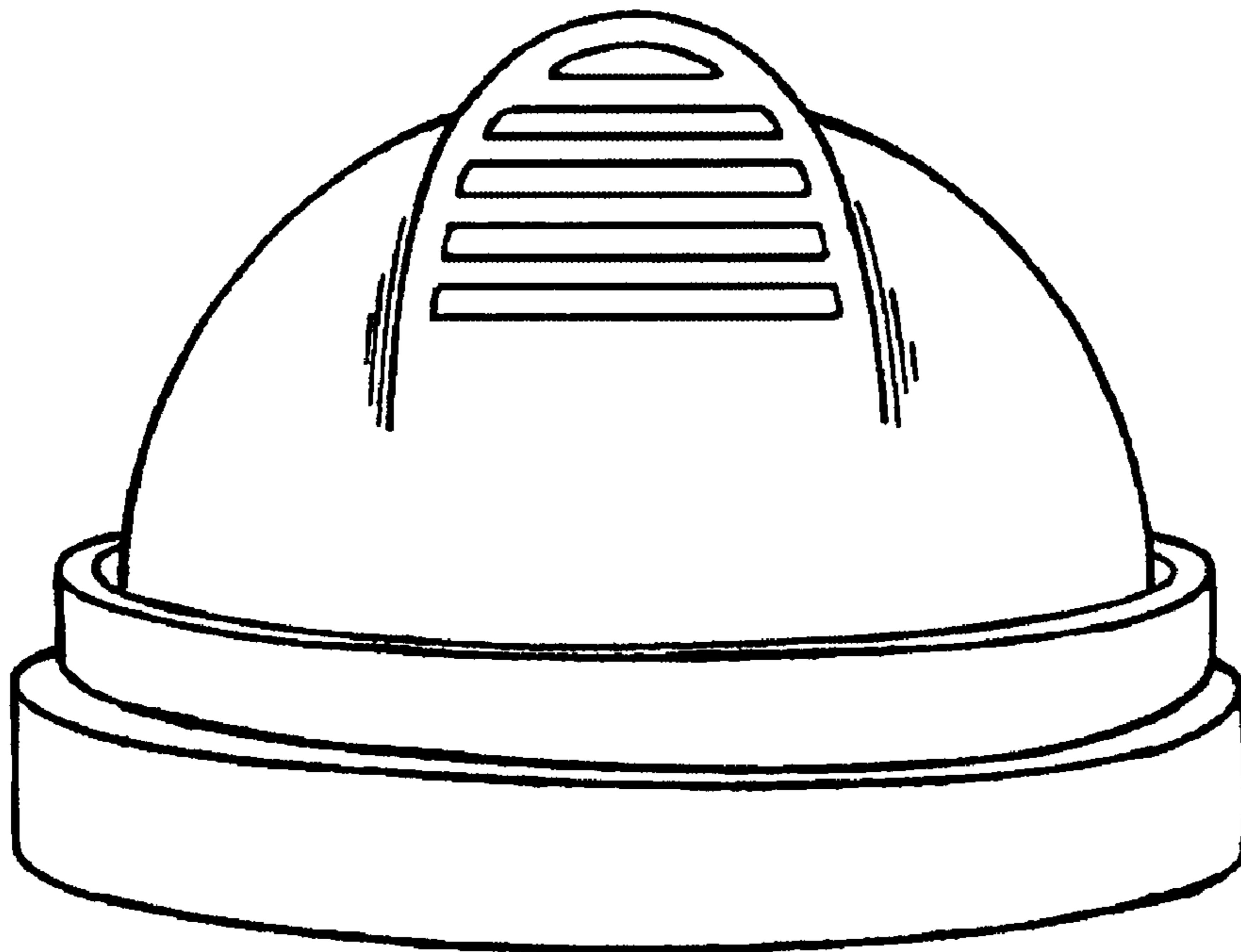

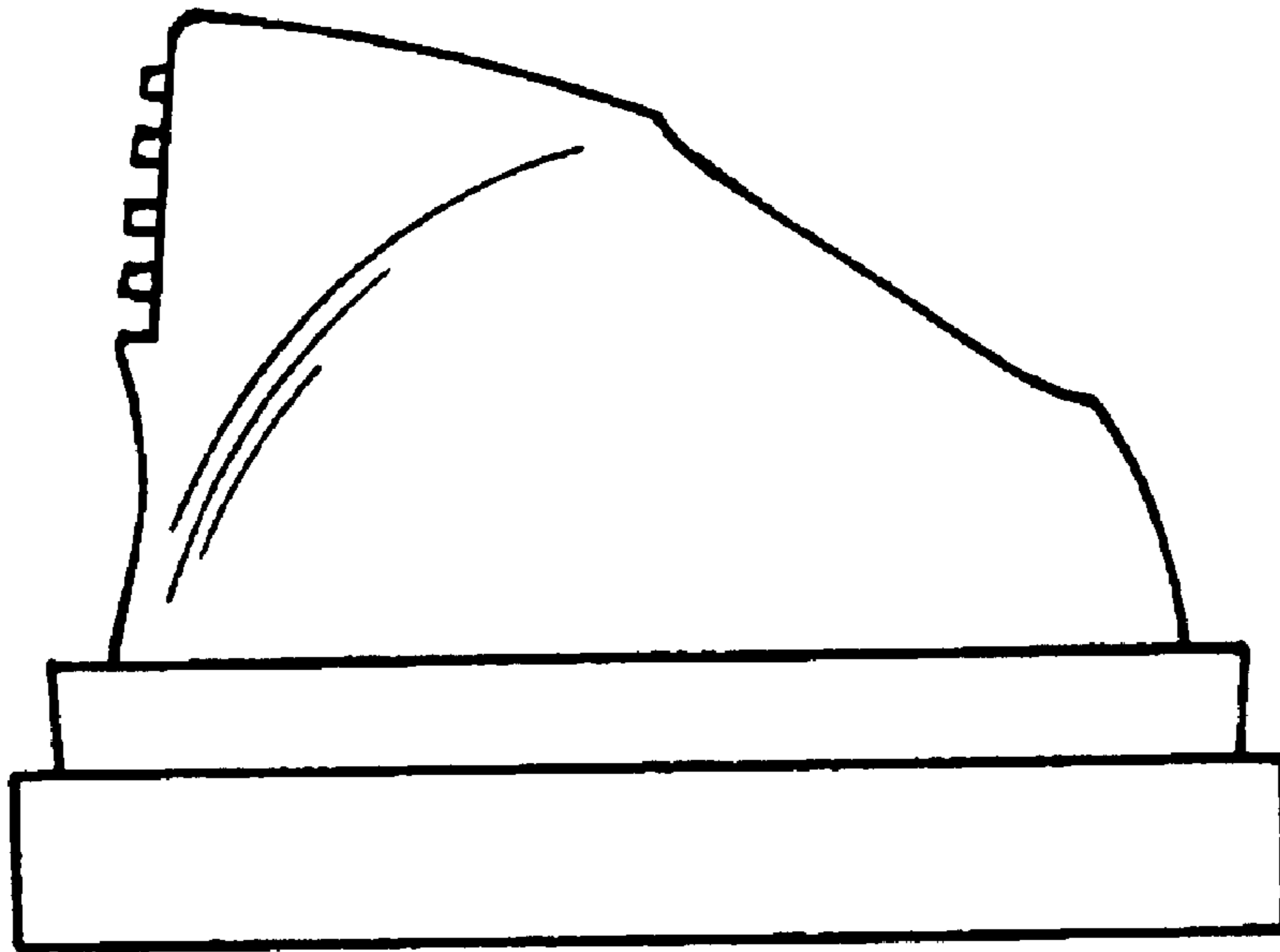

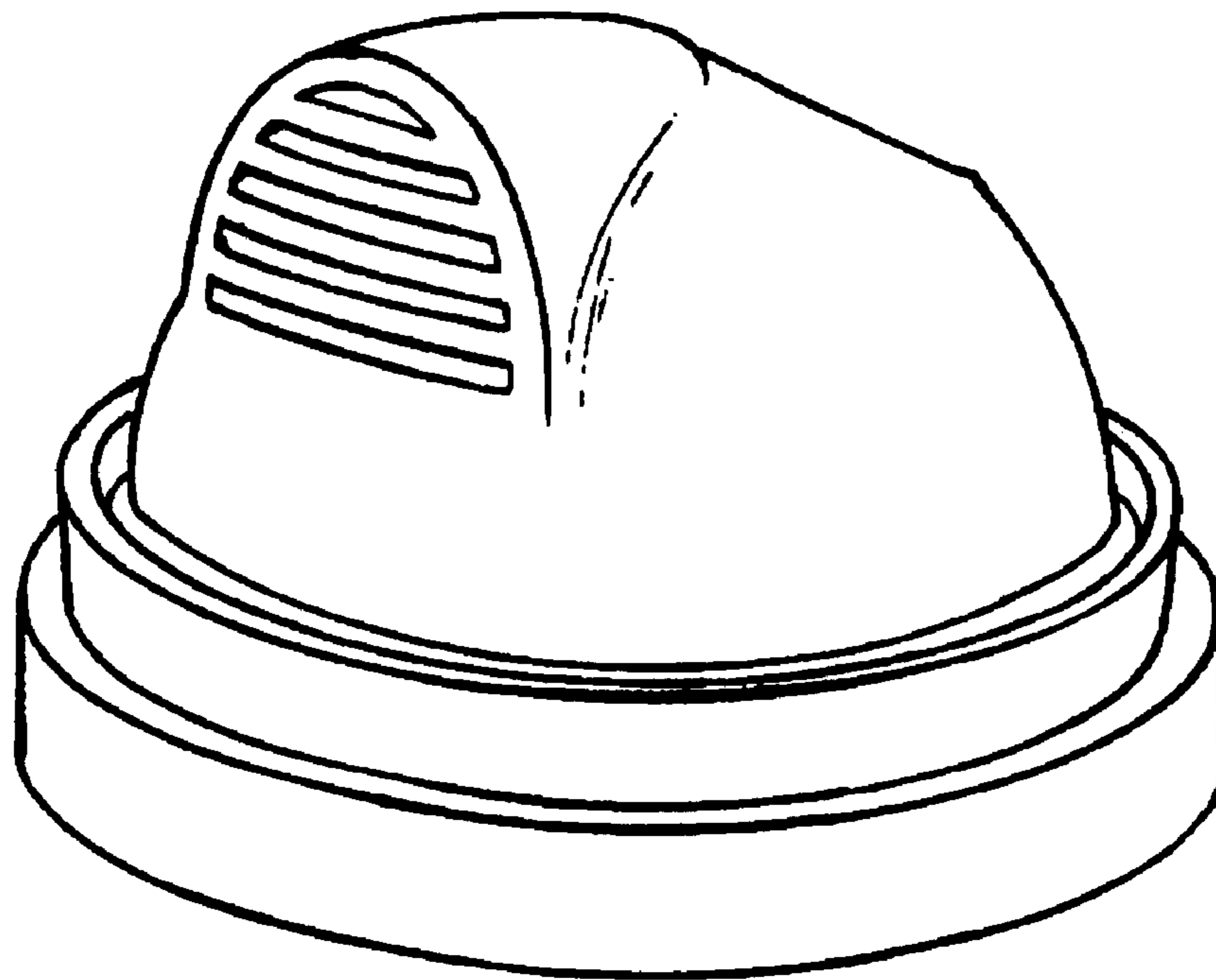

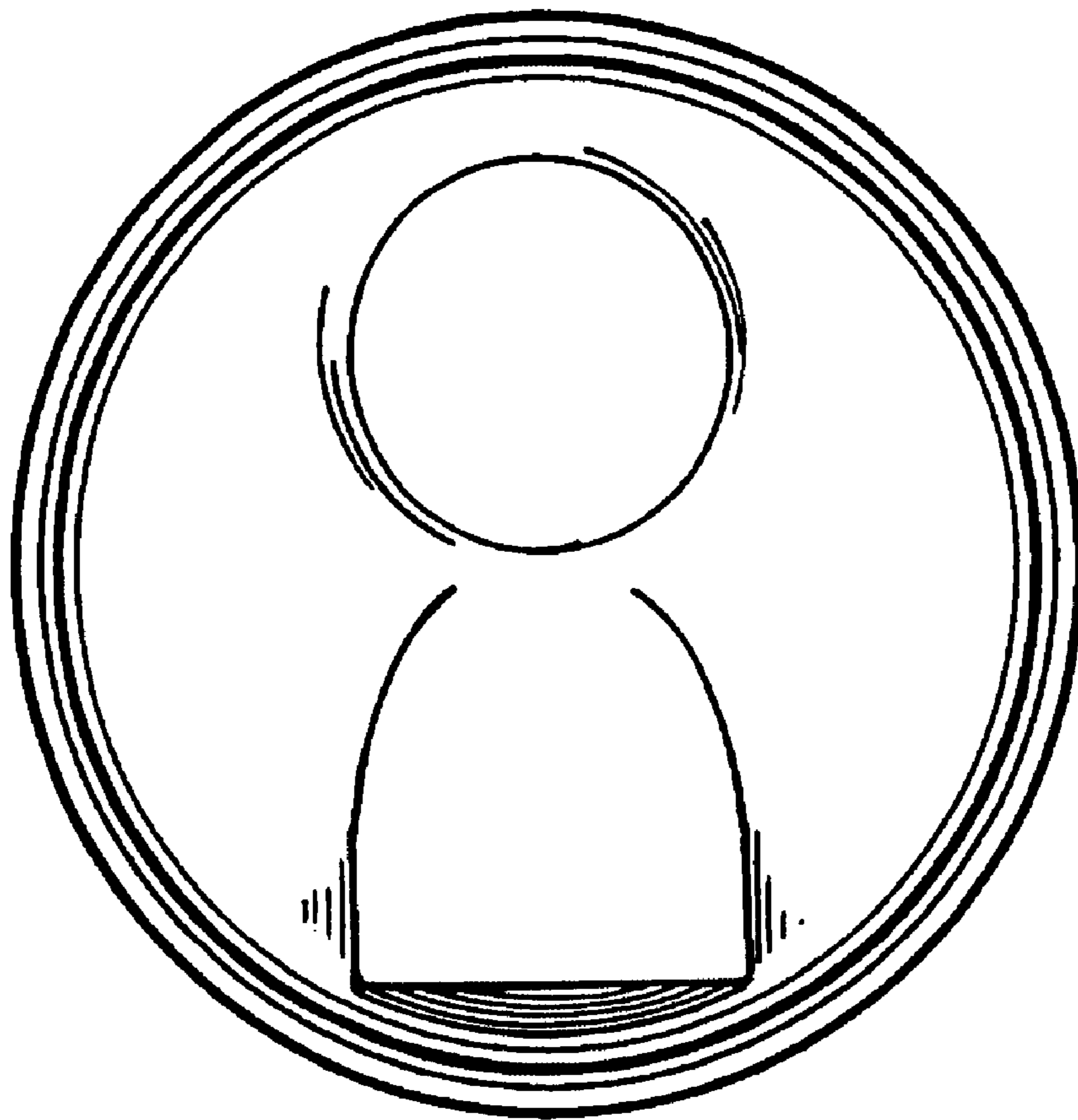

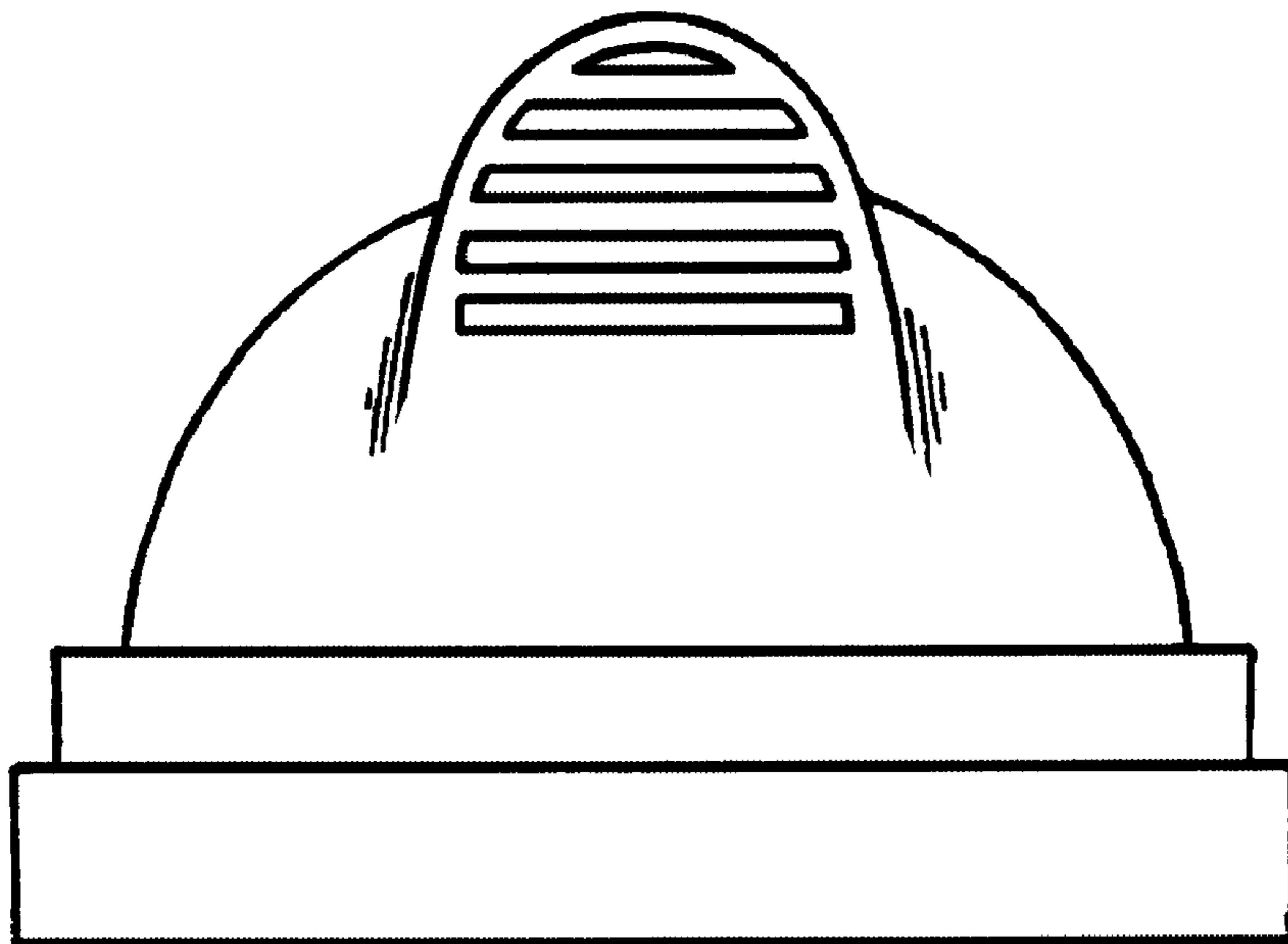

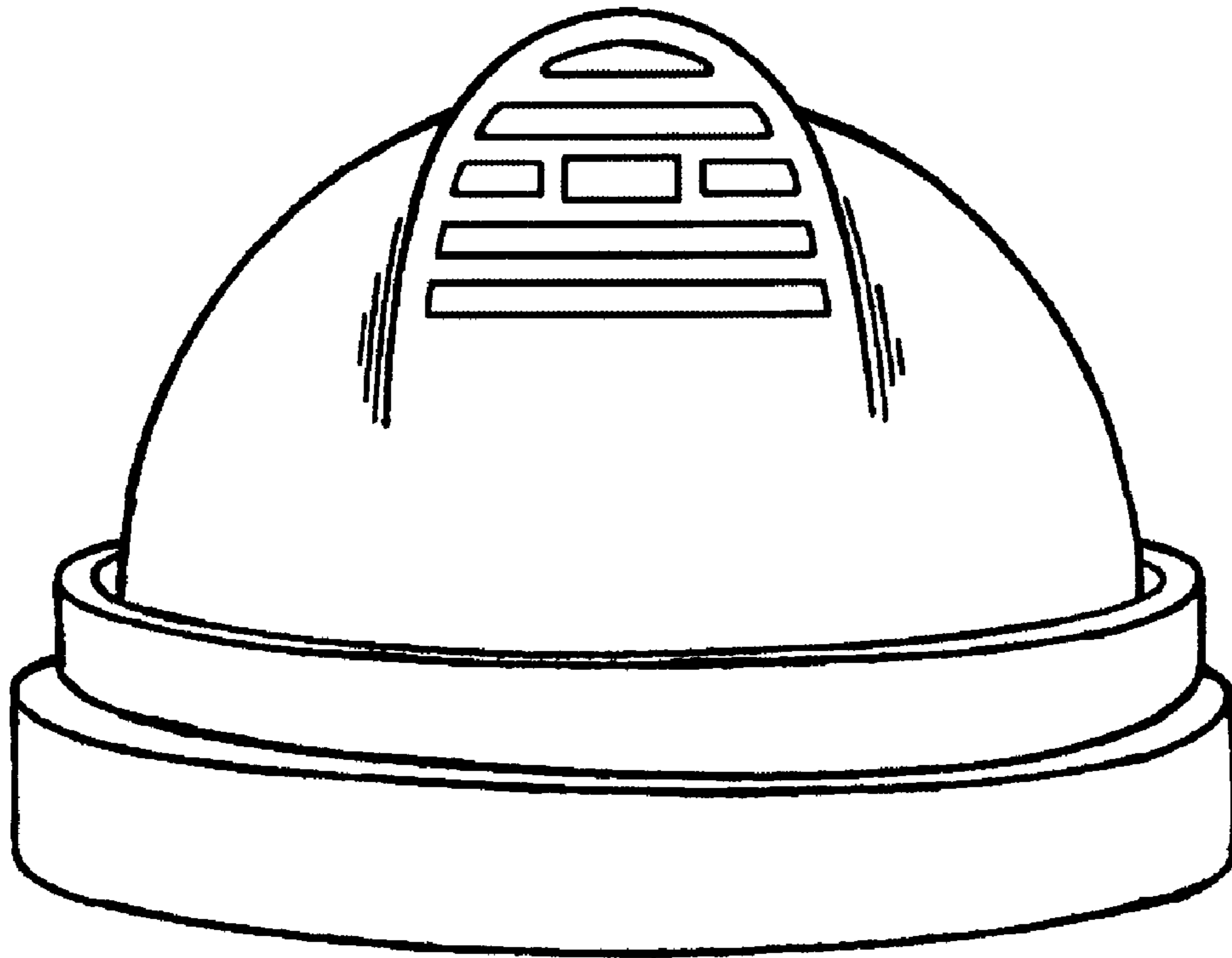

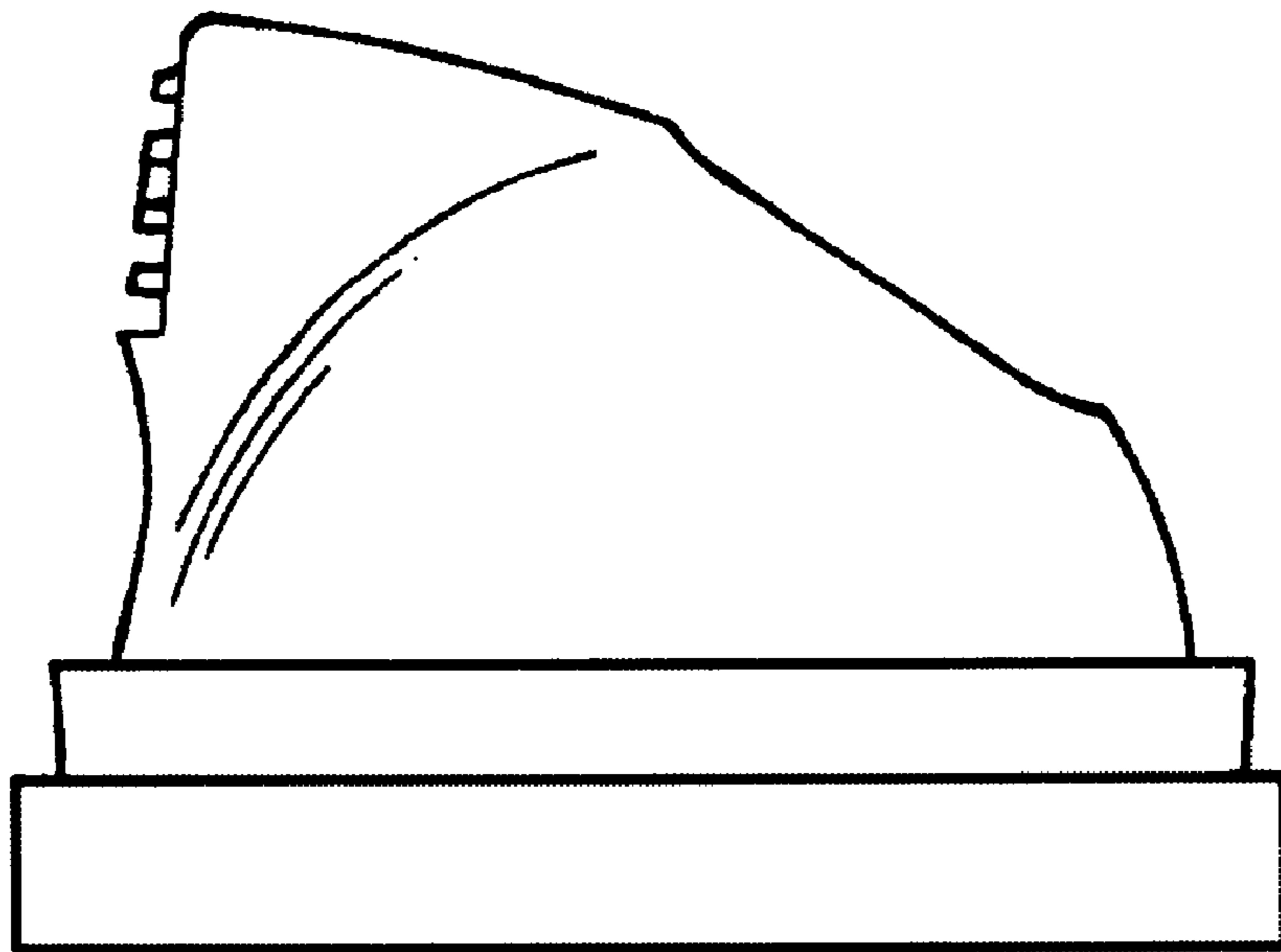

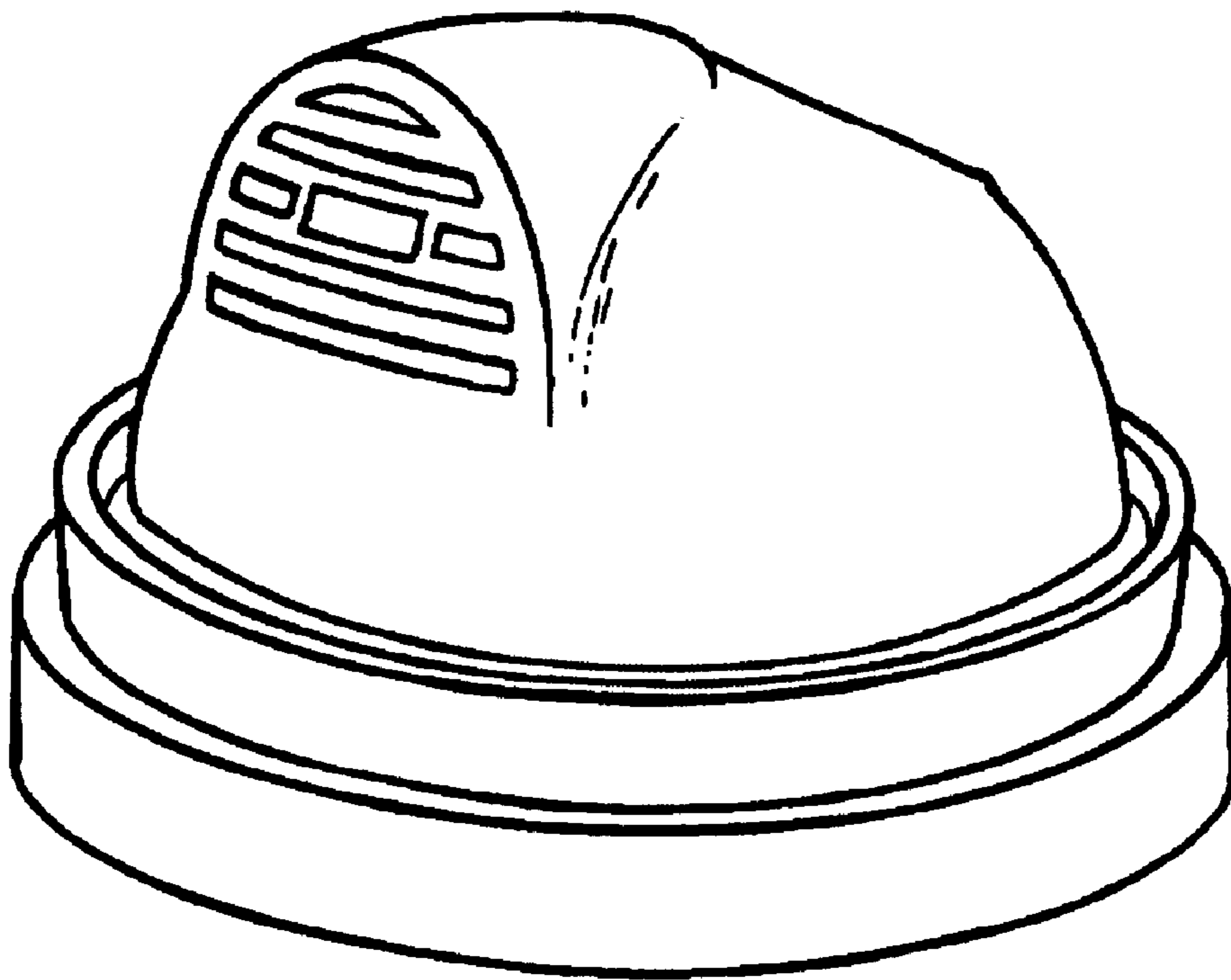

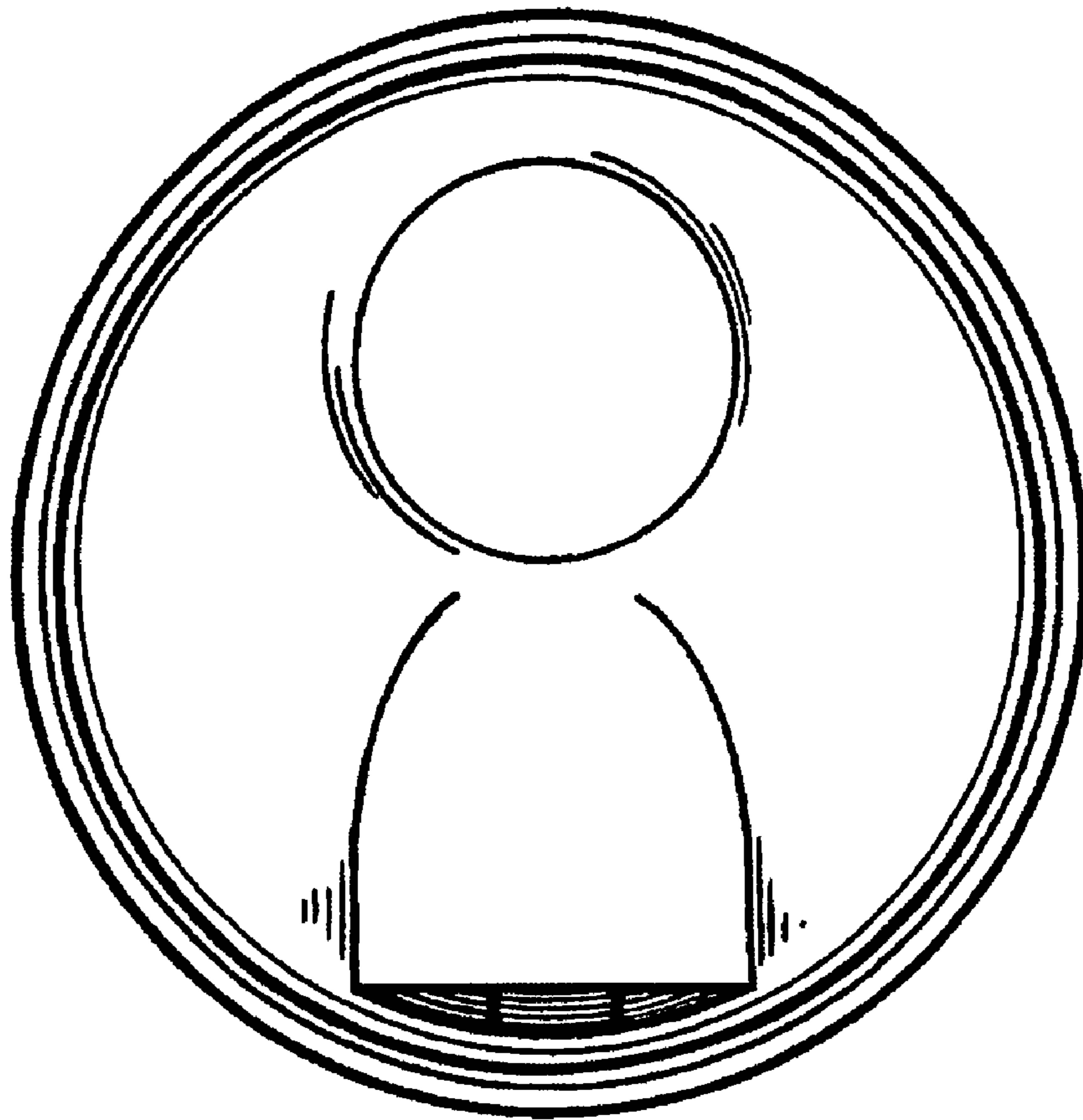
