(57)**CLAIM**

The ornamental design for a tank cover panel, as shown and described.

DESCRIPTION

FIG. 1 is a left front perspective view of a tank cover panel;

FIG. 2 is a top plan view of the tank cover panel of FIG. 1;

FIG. 3 is a left side elevational view of the tank cover panel of FIG. 1;

FIG. 4 is a left front perspective view of the tank cover panel of FIG. 1 on a reduced scale provided upon an exemplary four wheeled vehicle;

FIG. 5 is a left rear perspective view of the tank cover panel of FIG. 1 on a reduced scale provided upon the exemplary four wheeled vehicle;

FIG. 6 is a rear perspective view of the tank cover panel of FIG. 1 on a reduced scale provided upon the exemplary four wheeled vehicle;

FIG. 7 is a left side perspective view of the tank cover panel of FIG. 1 on a reduced scale provided upon the exemplary four wheeled vehicle;

FIG. 8 is a right side perspective view of the tank cover panel of FIG. 1 on a reduced scale provided upon the exemplary four wheeled vehicle; and,

FIG. 9 is a top perspective view of the tank cover panel of FIG. 1 on a reduced scale provided upon the exemplary four wheeled vehicle.

The broken lines immediately adjacent the shaded areas represent the boundaries of the claimed design and form no part thereof, while the other broken lines show environment and form no part of the claimed design.
