The ornamental design for a satellite antenna mounting plate, as shown and described.

DESCRIPTION

FIG. 1 is a front, right perspective view of a satellite antenna mounting plate showing a new design;

FIG. 11 is a right side view thereof;

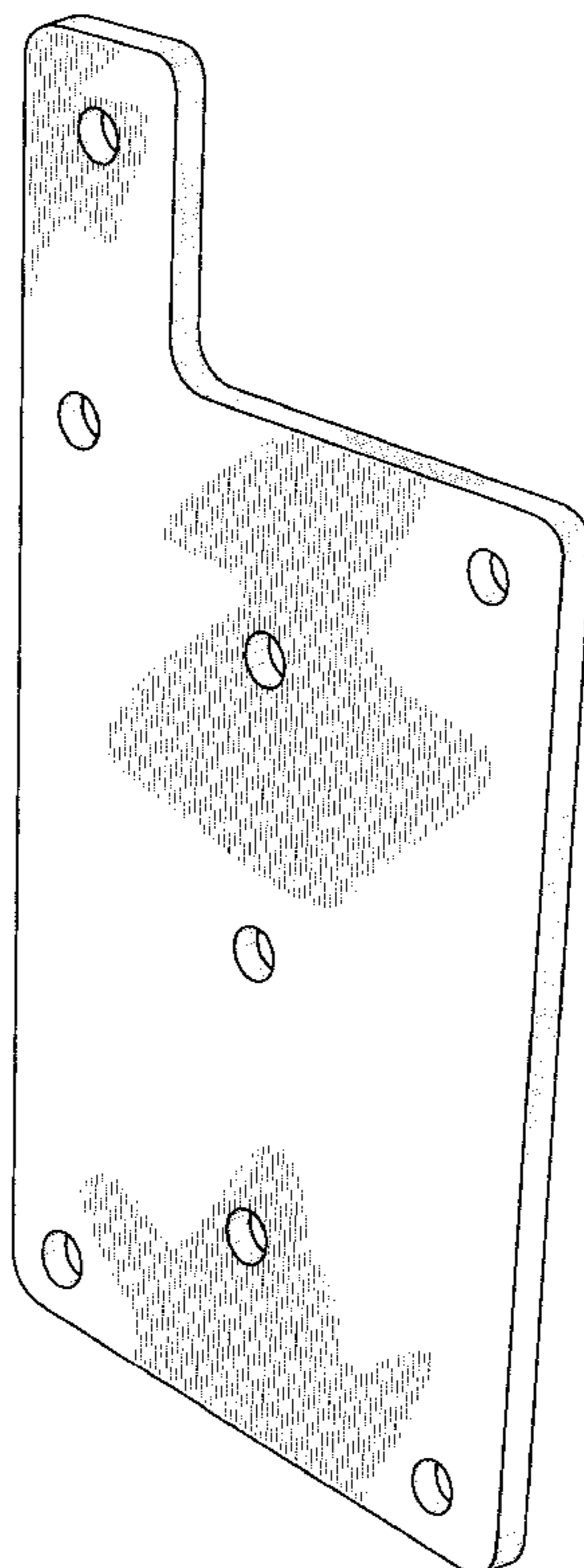
FIG. 12 is a top plan view thereof;

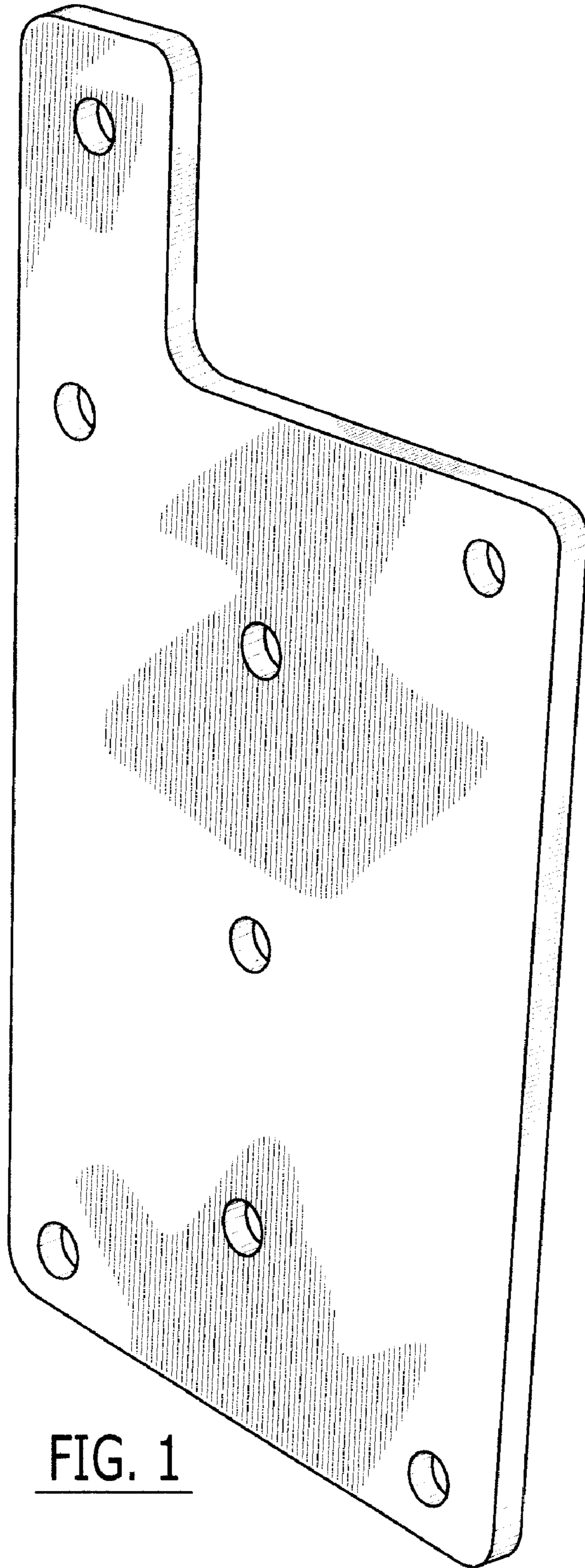

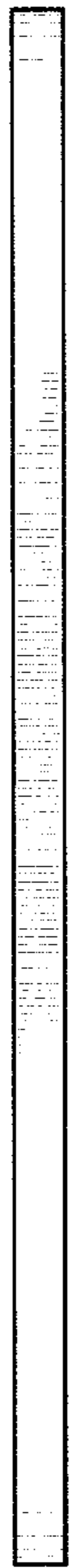

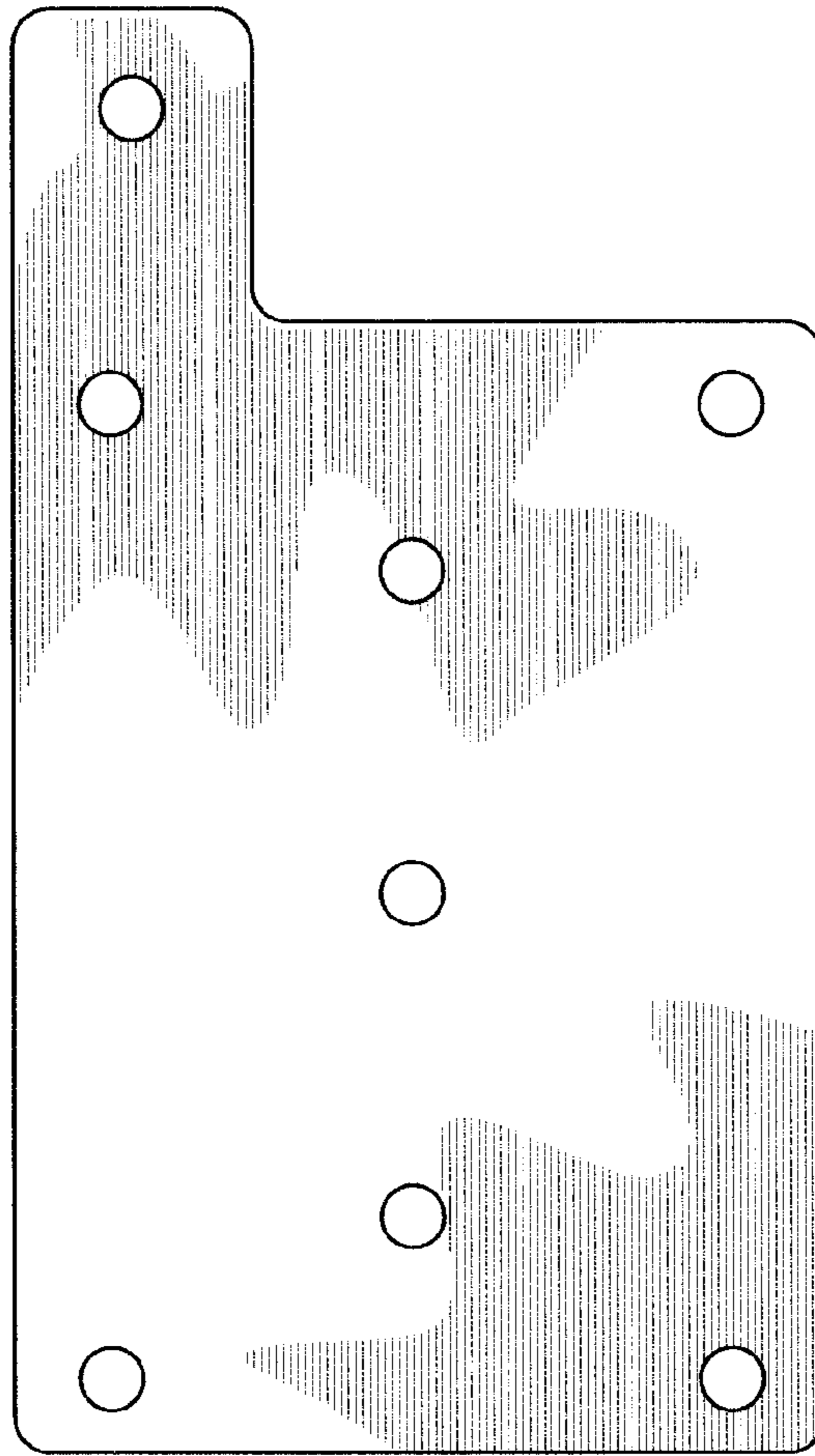

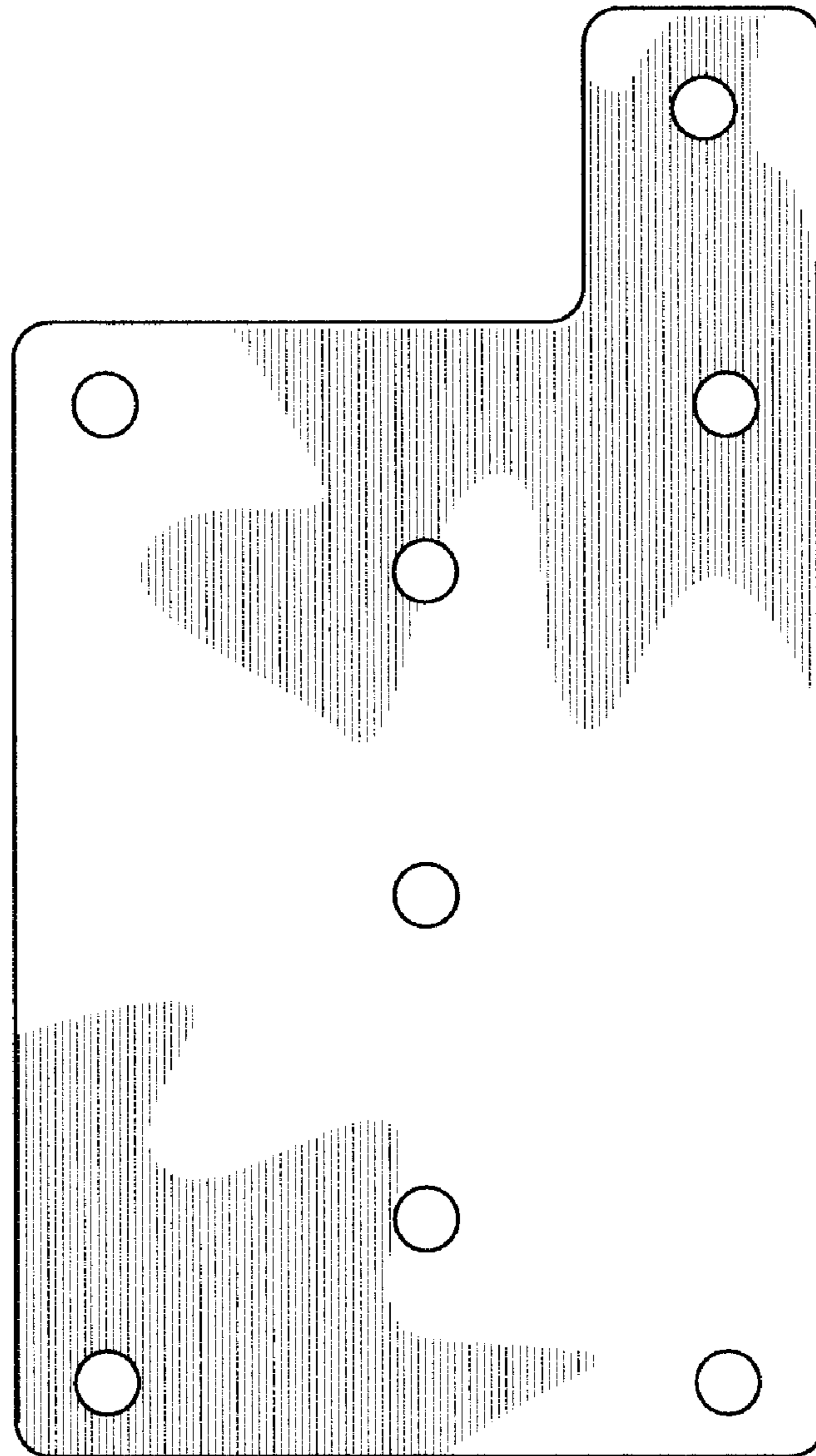

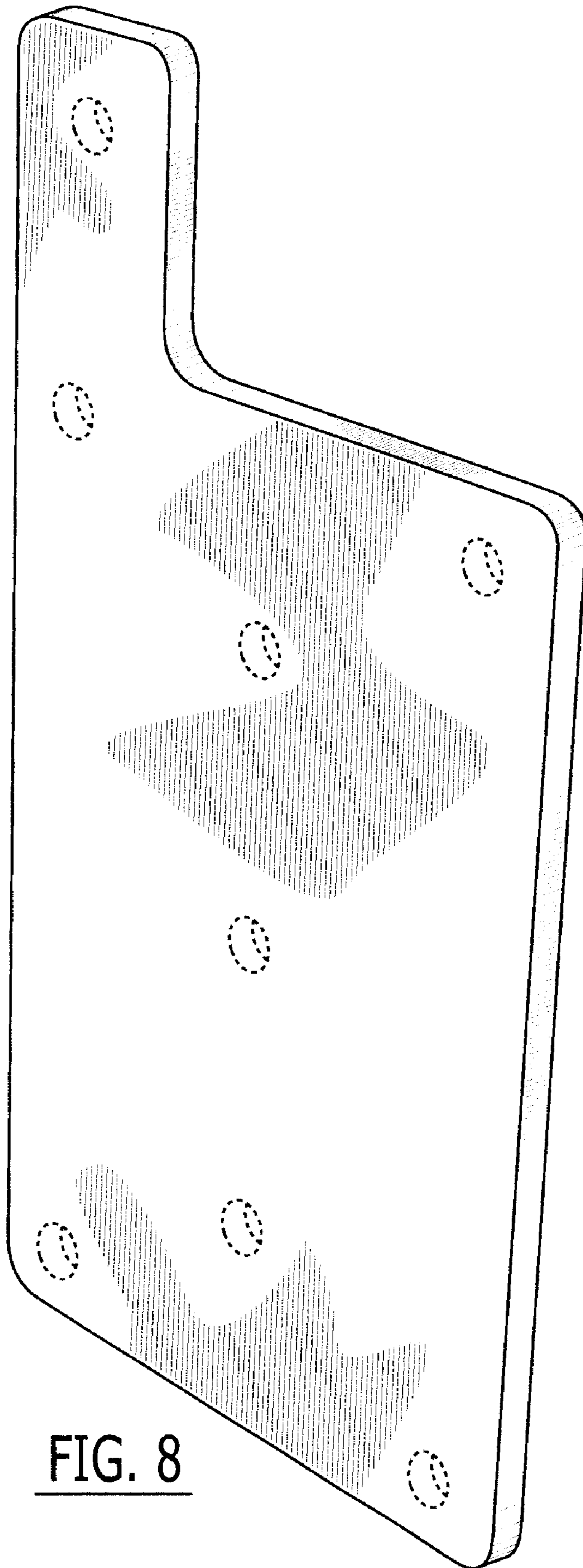

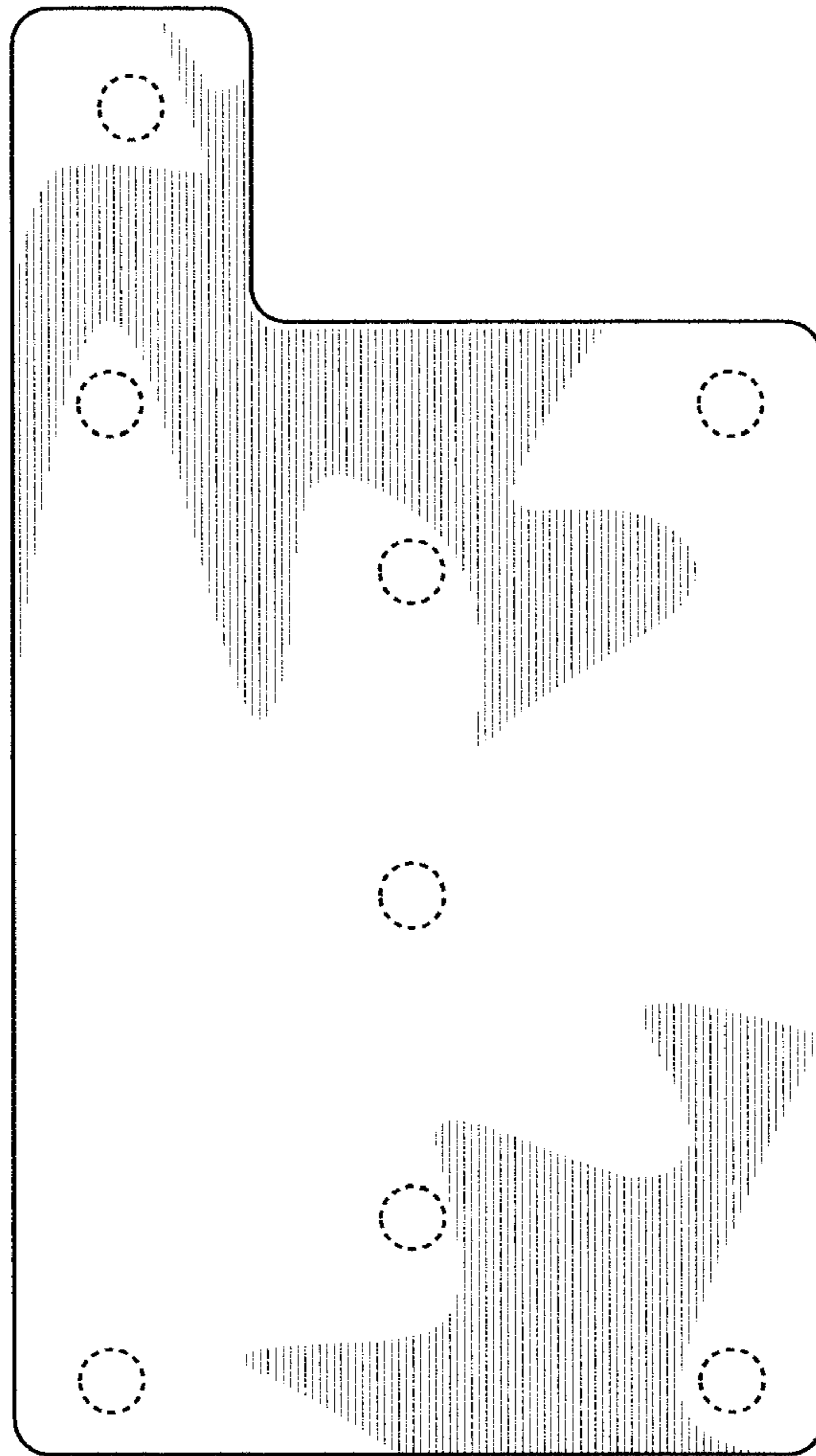

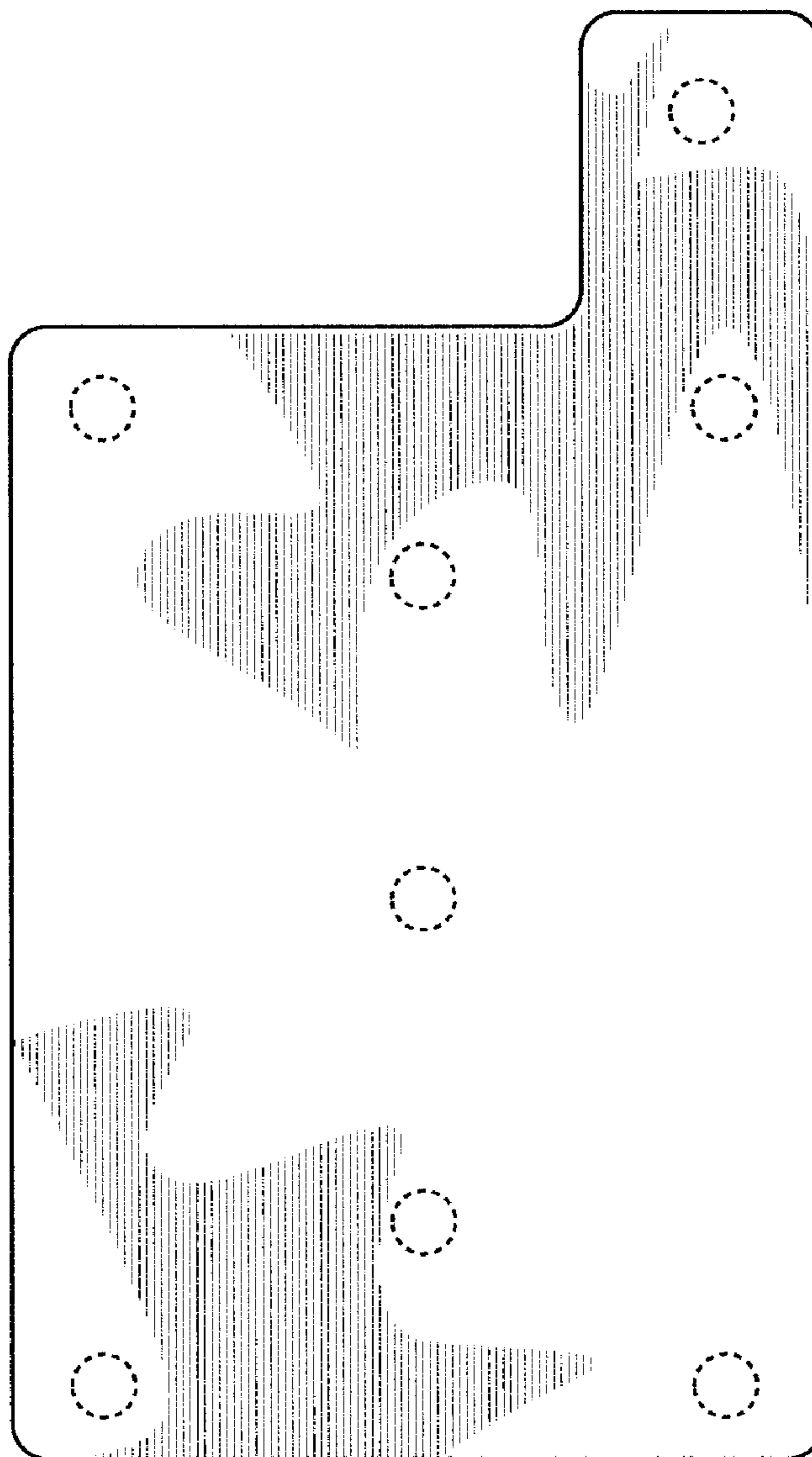
