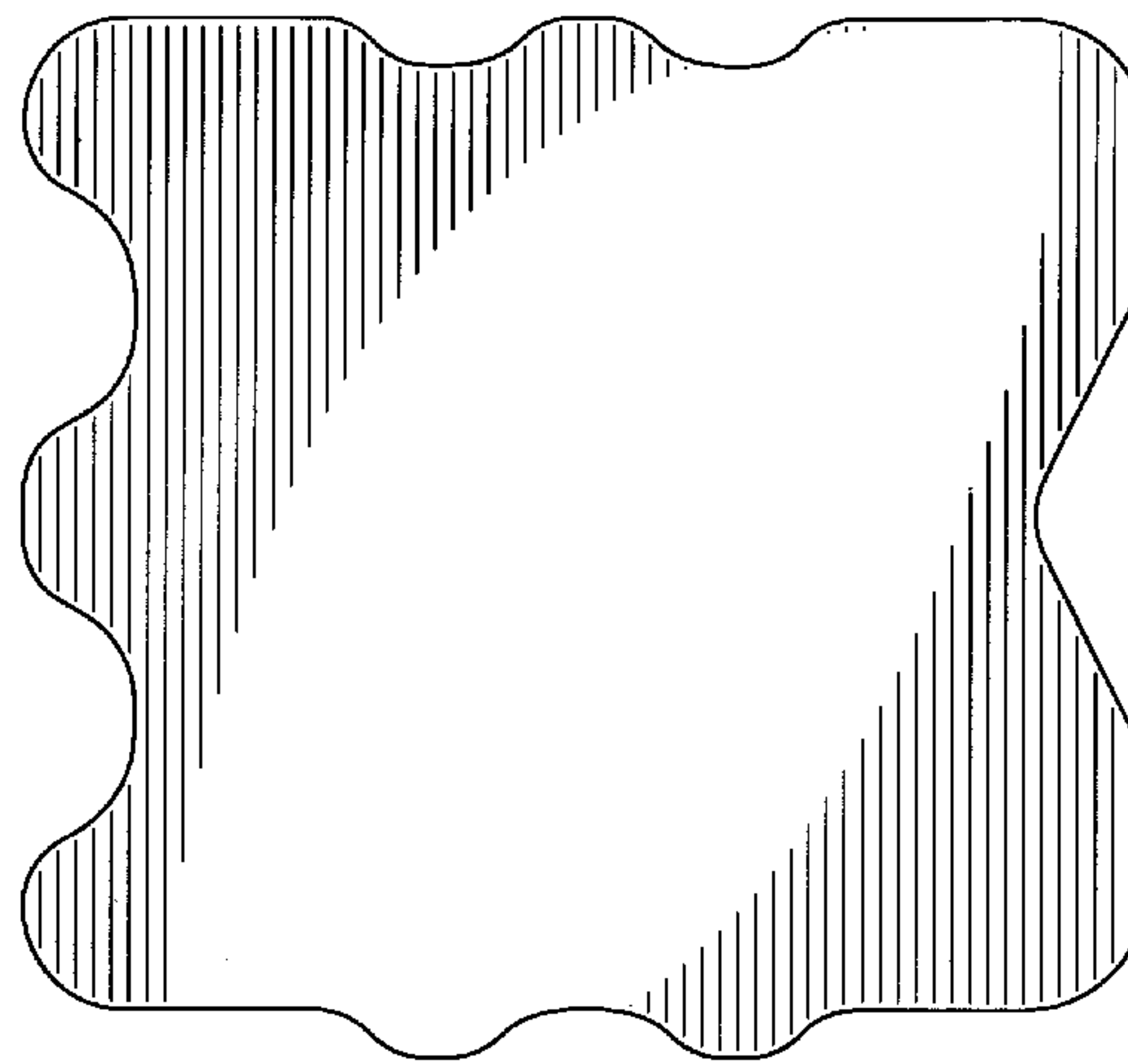
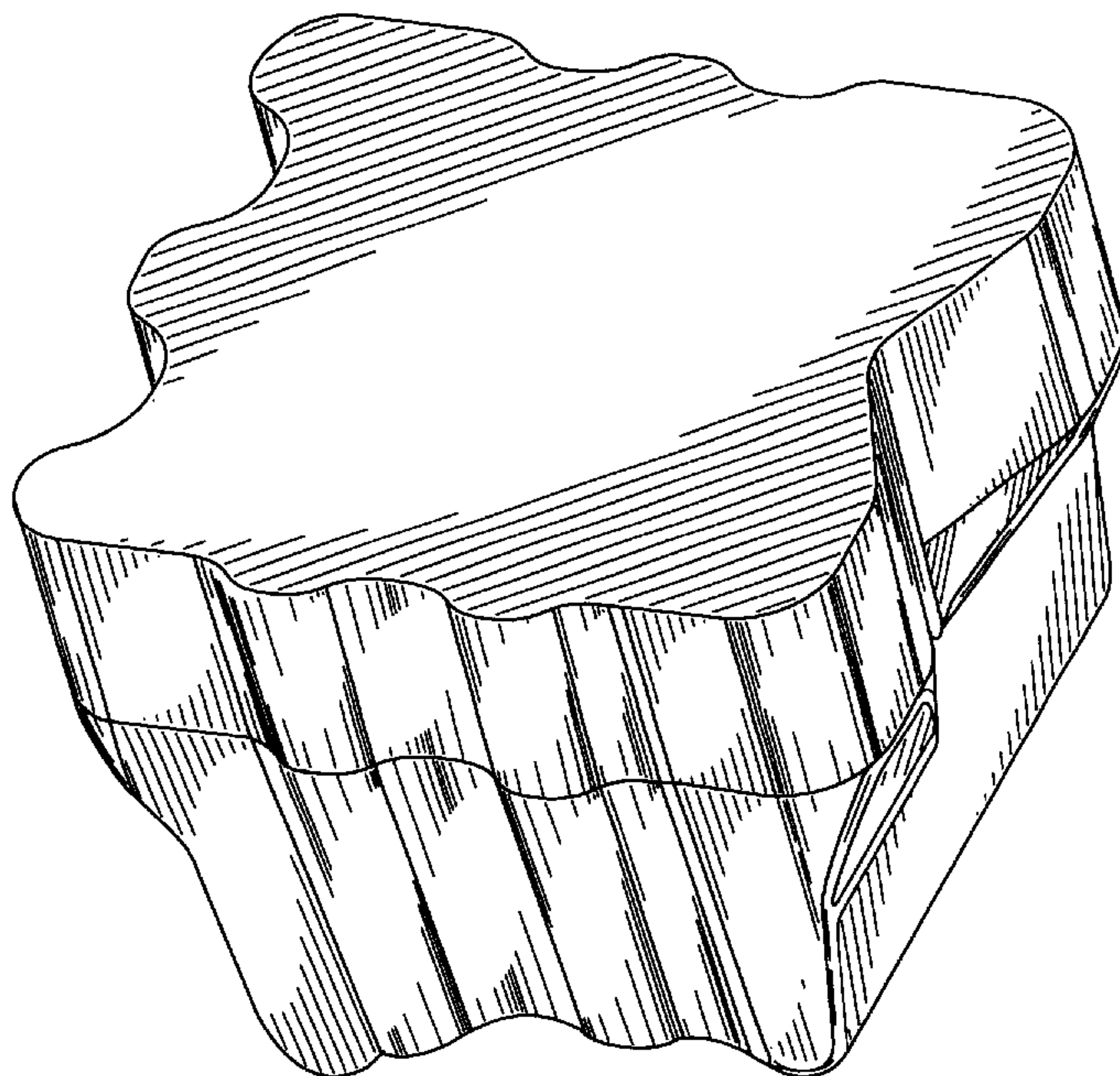

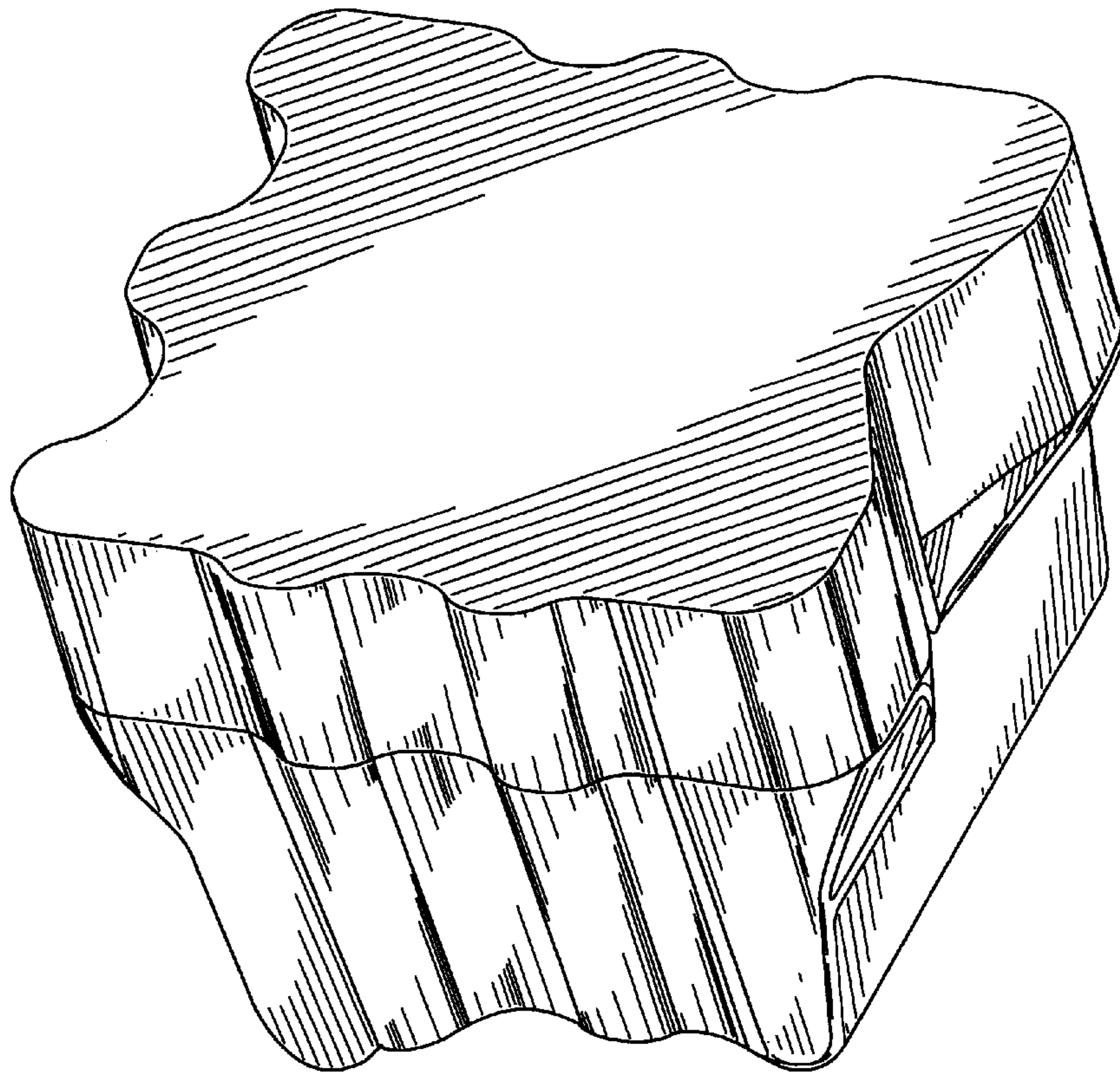

**DESCRIPTION**

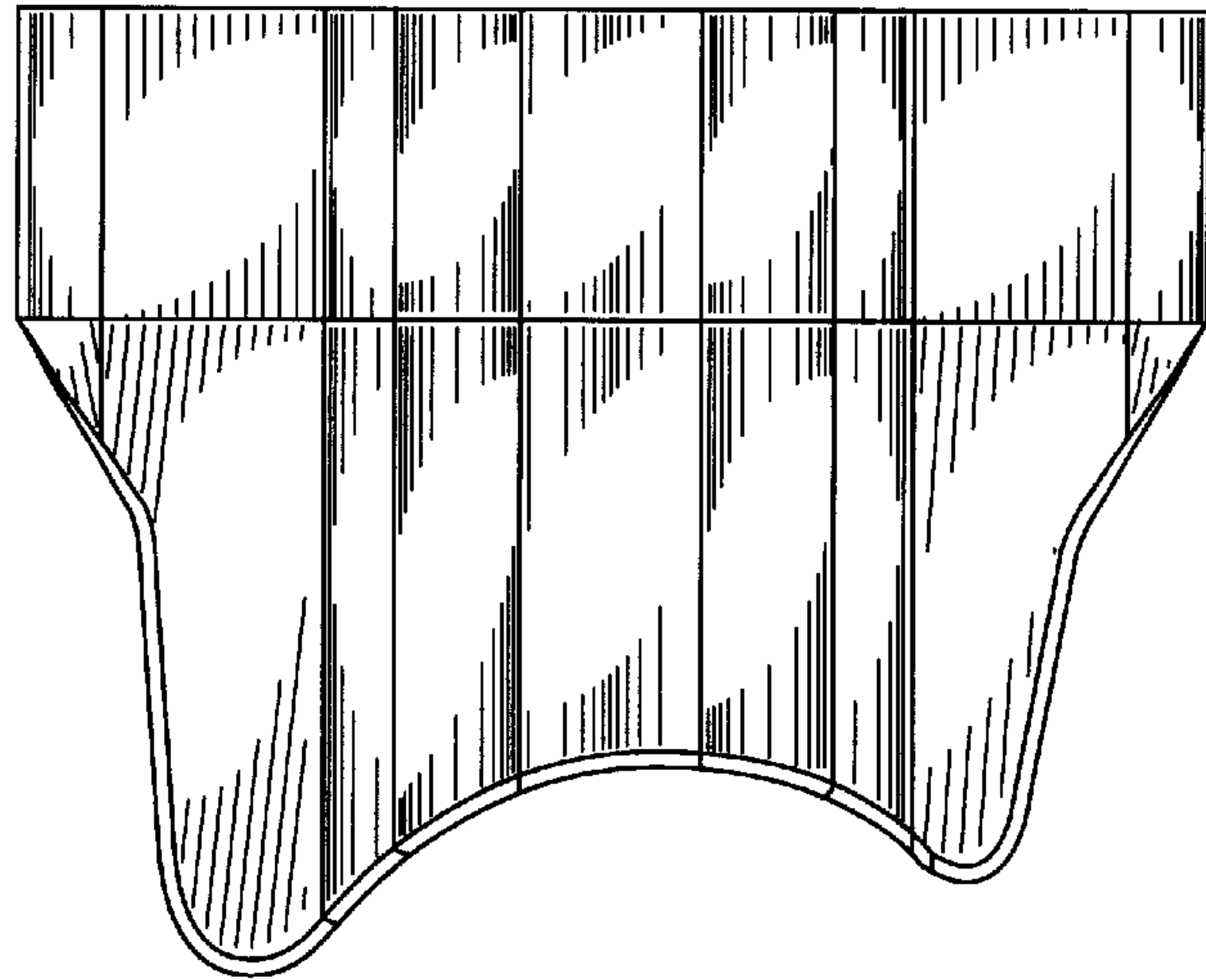

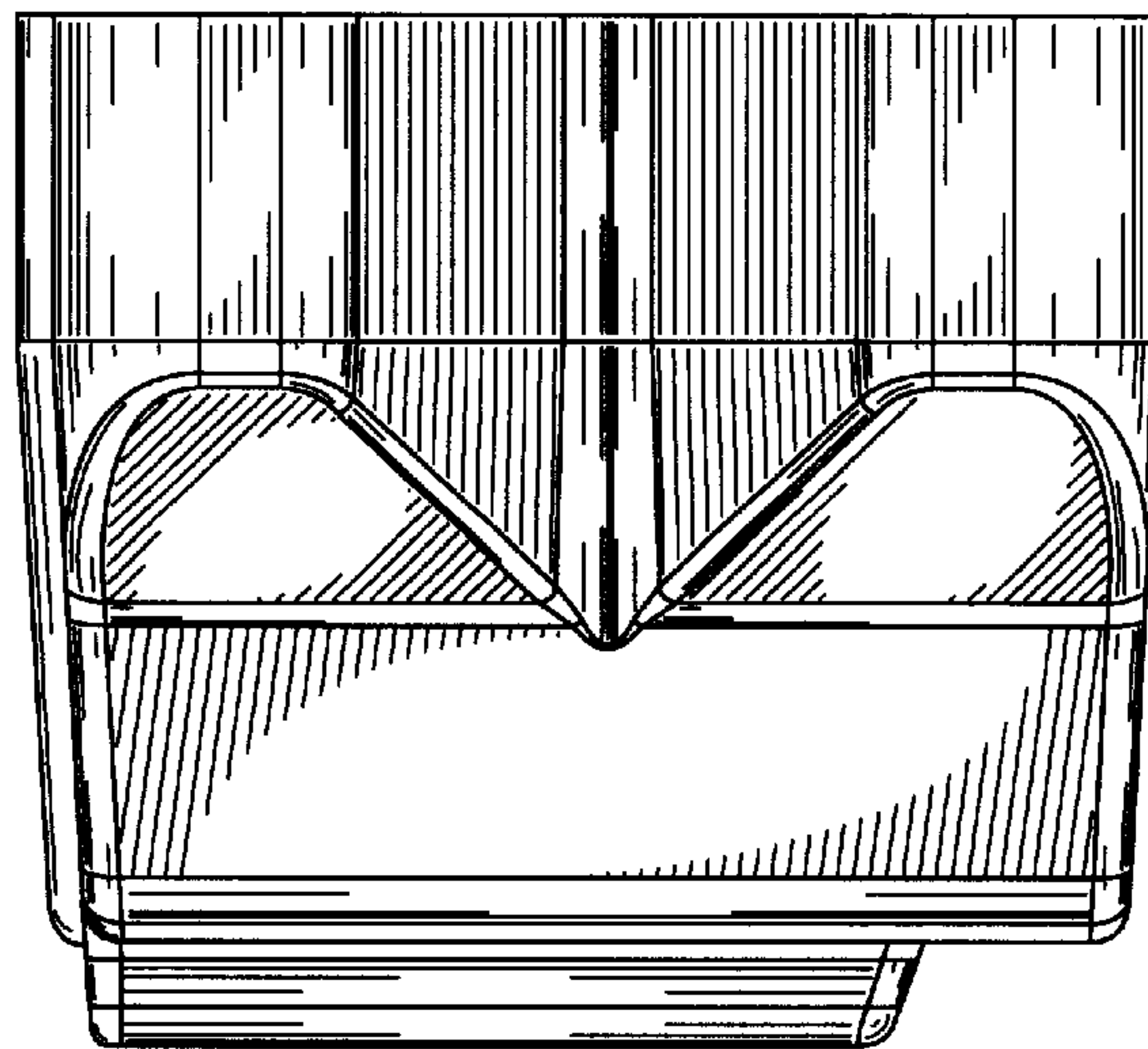




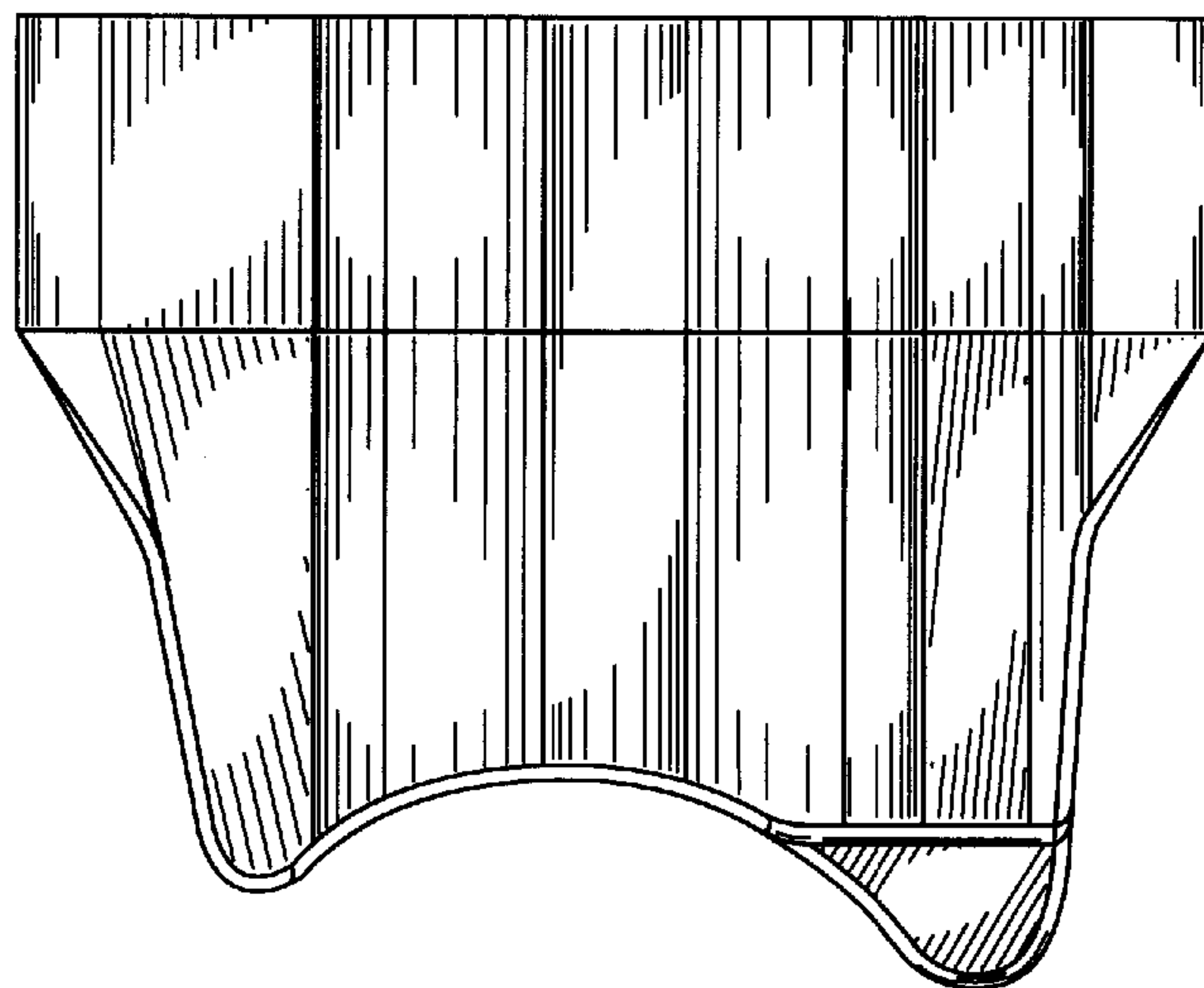

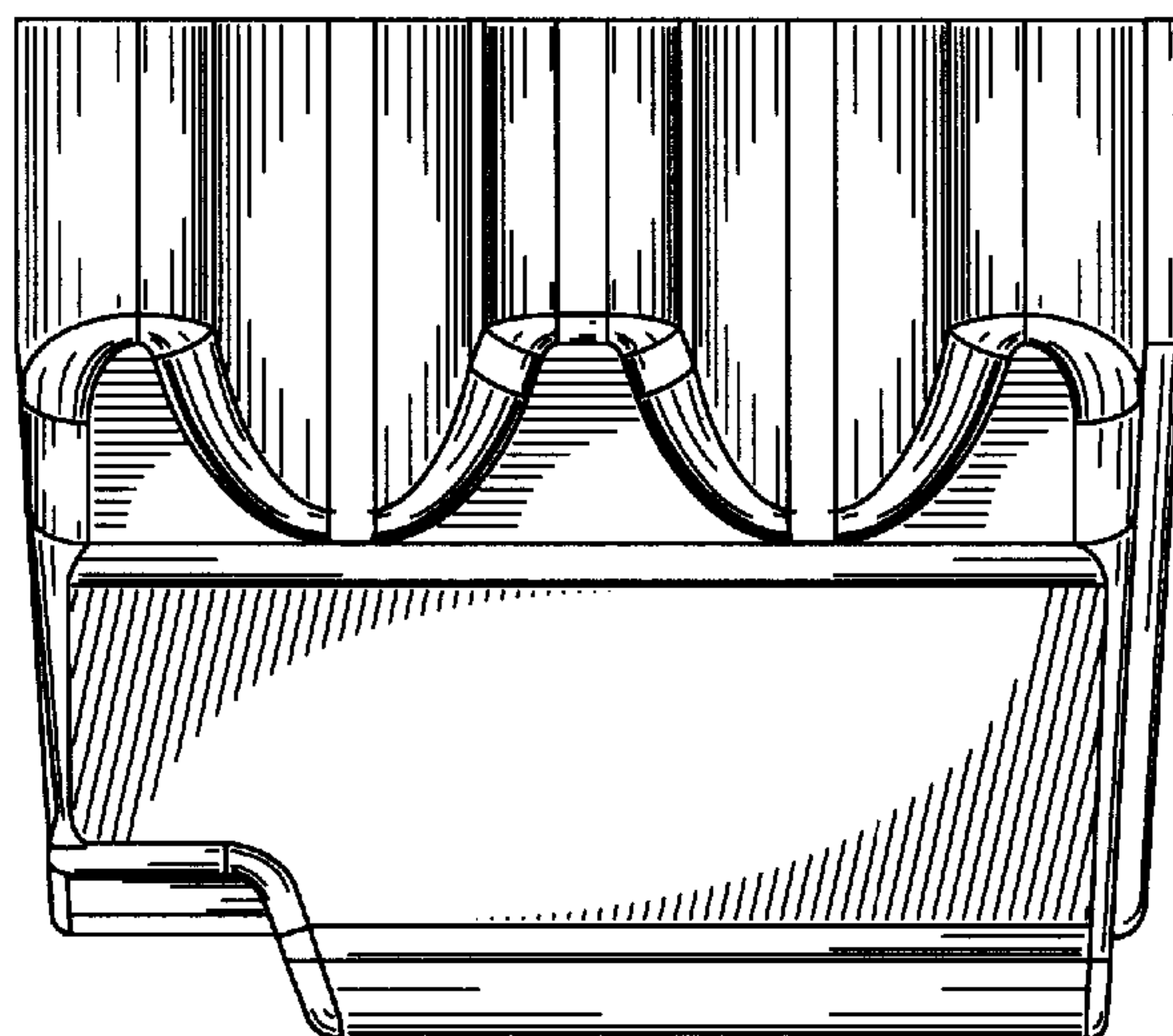

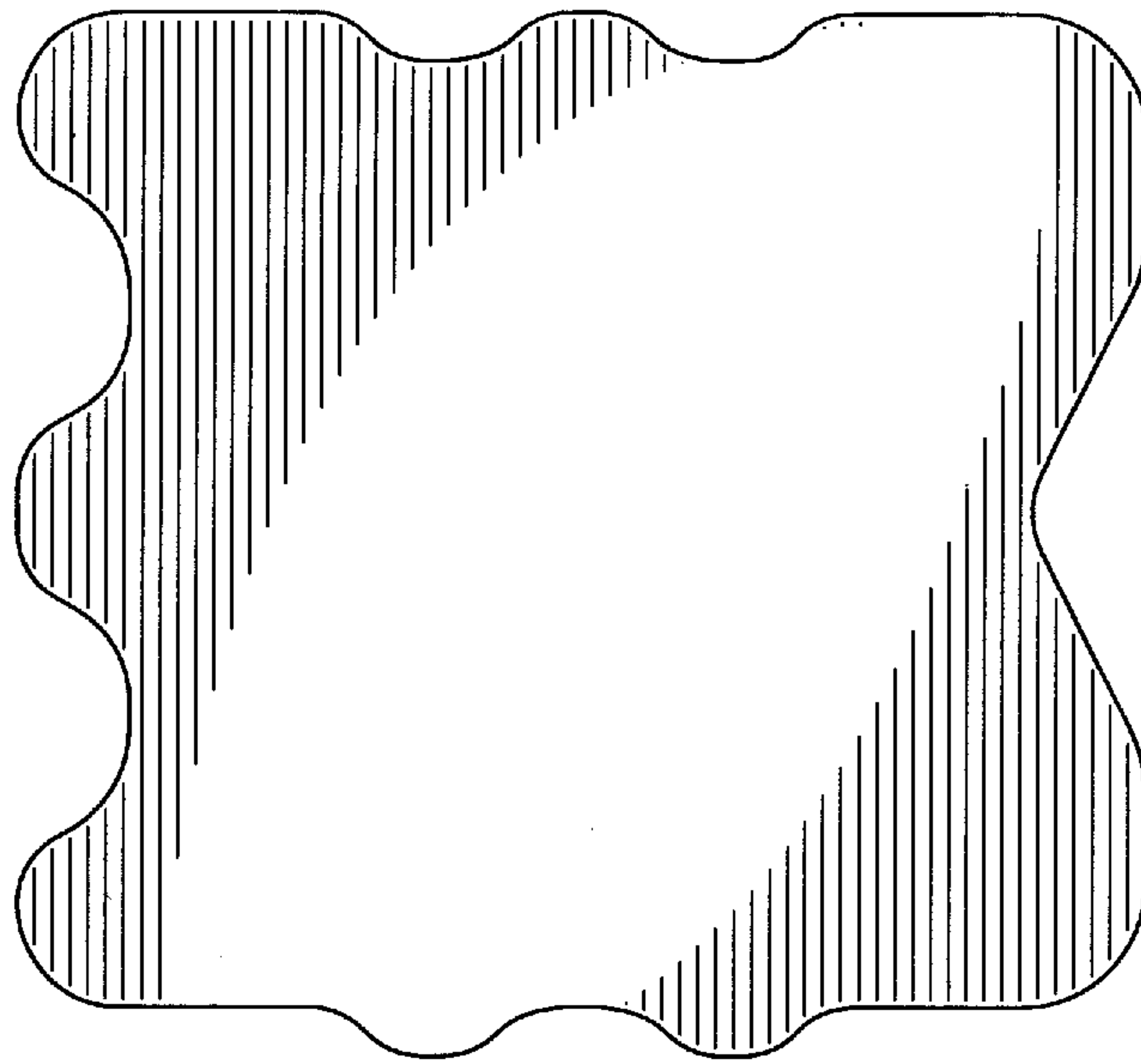

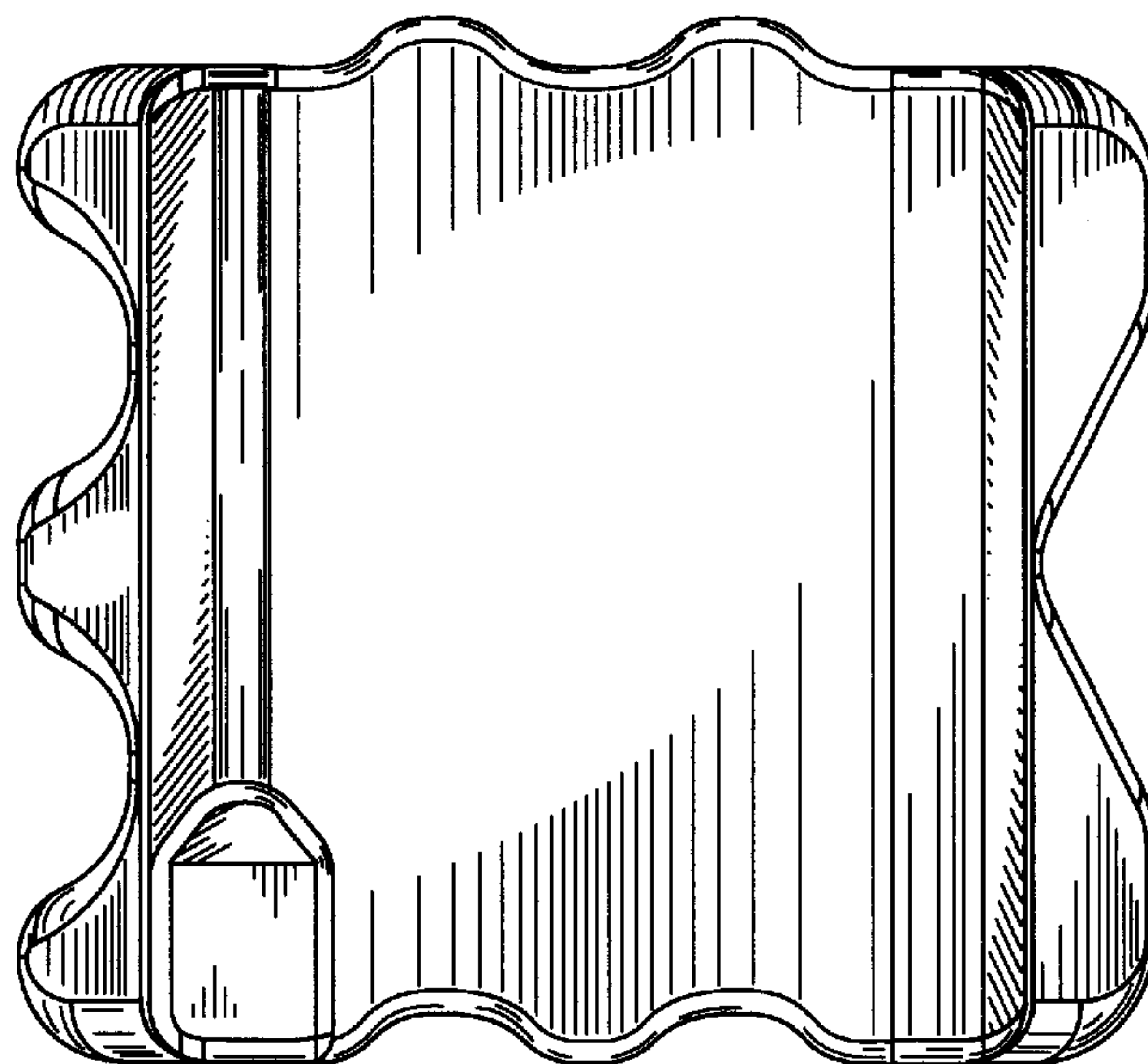
