FIG. 2 is a bottom plan view of the golf club head of my new design.

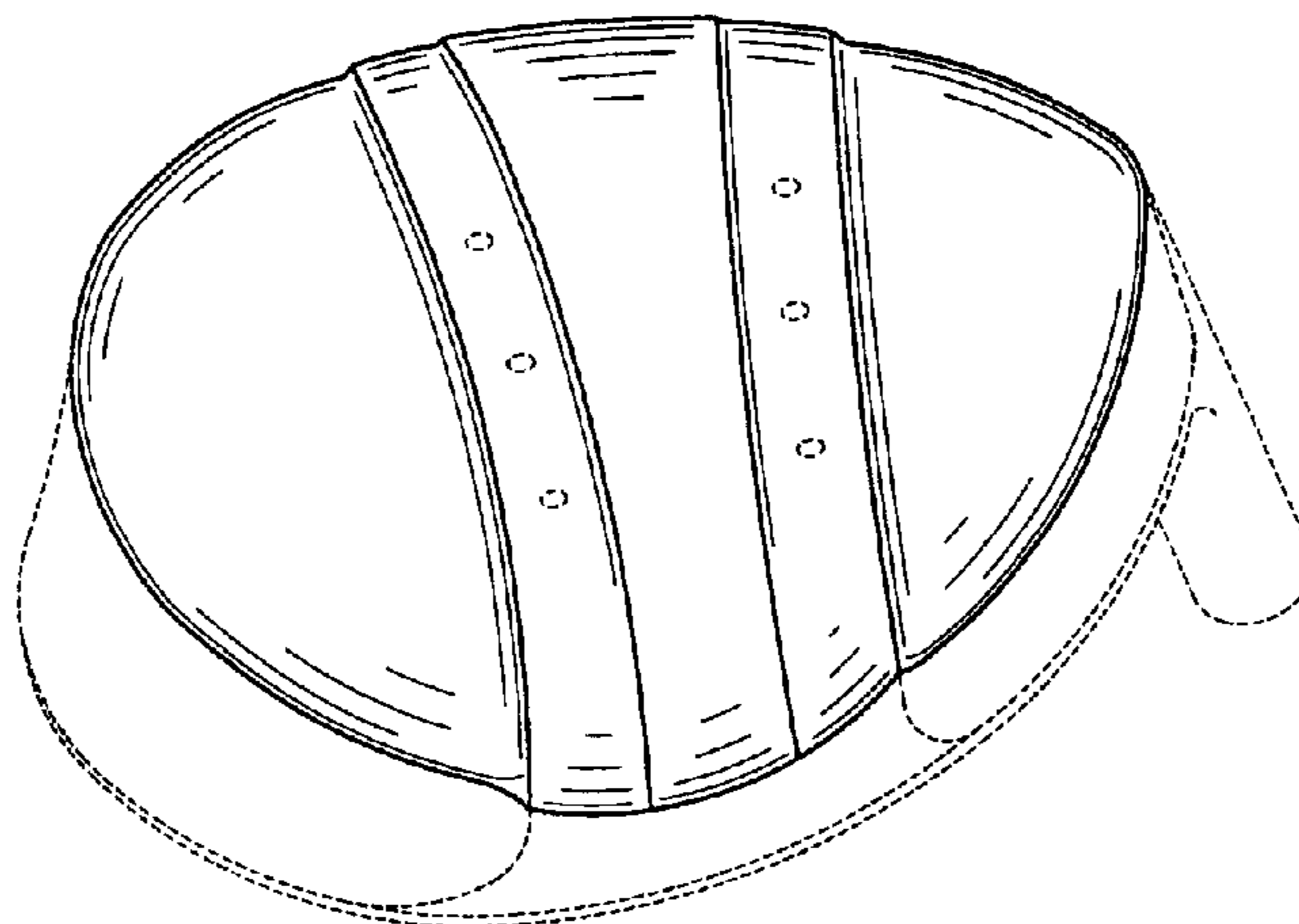
FIG. 3 is a rear side view of the golf club head of my new design.

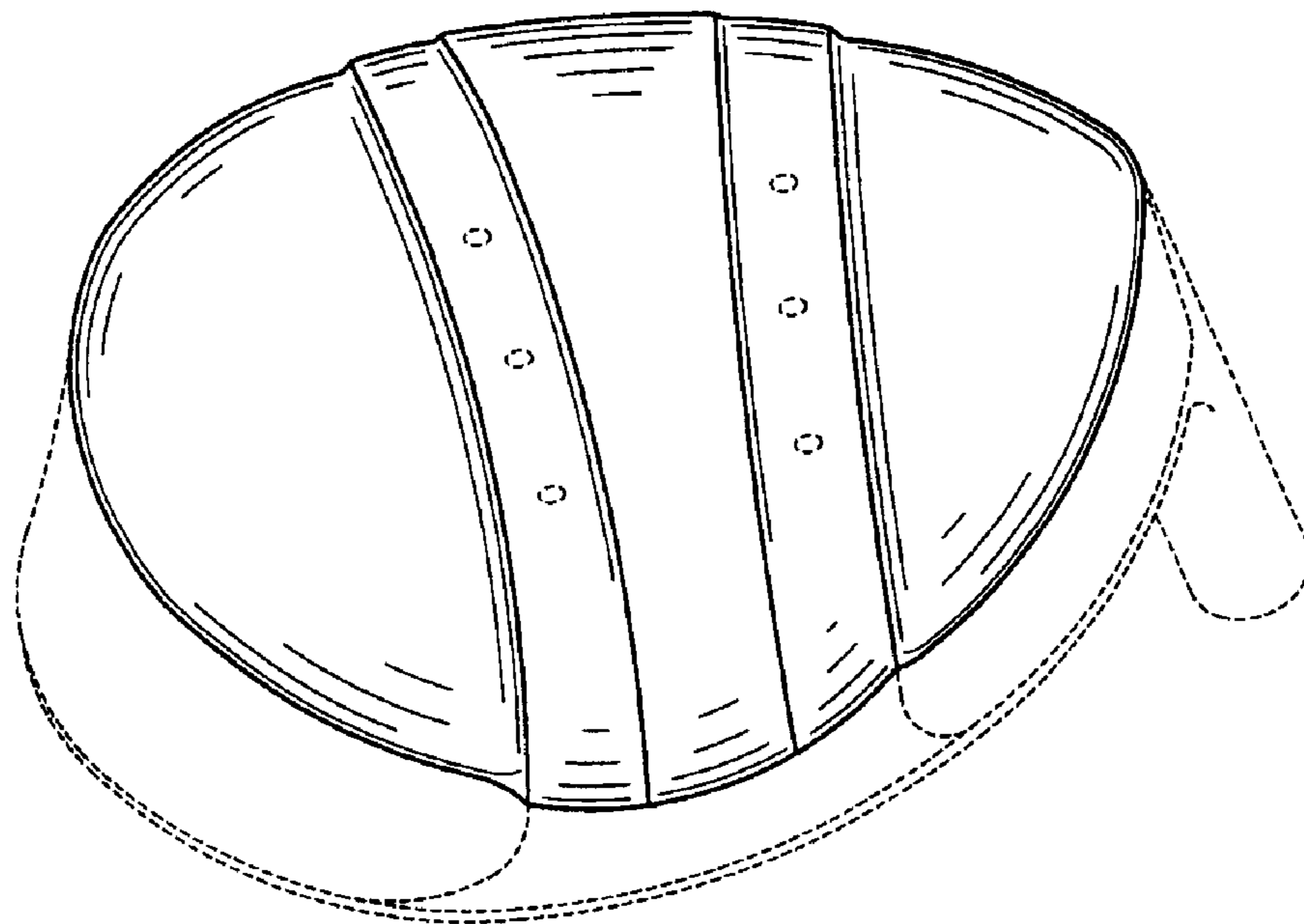

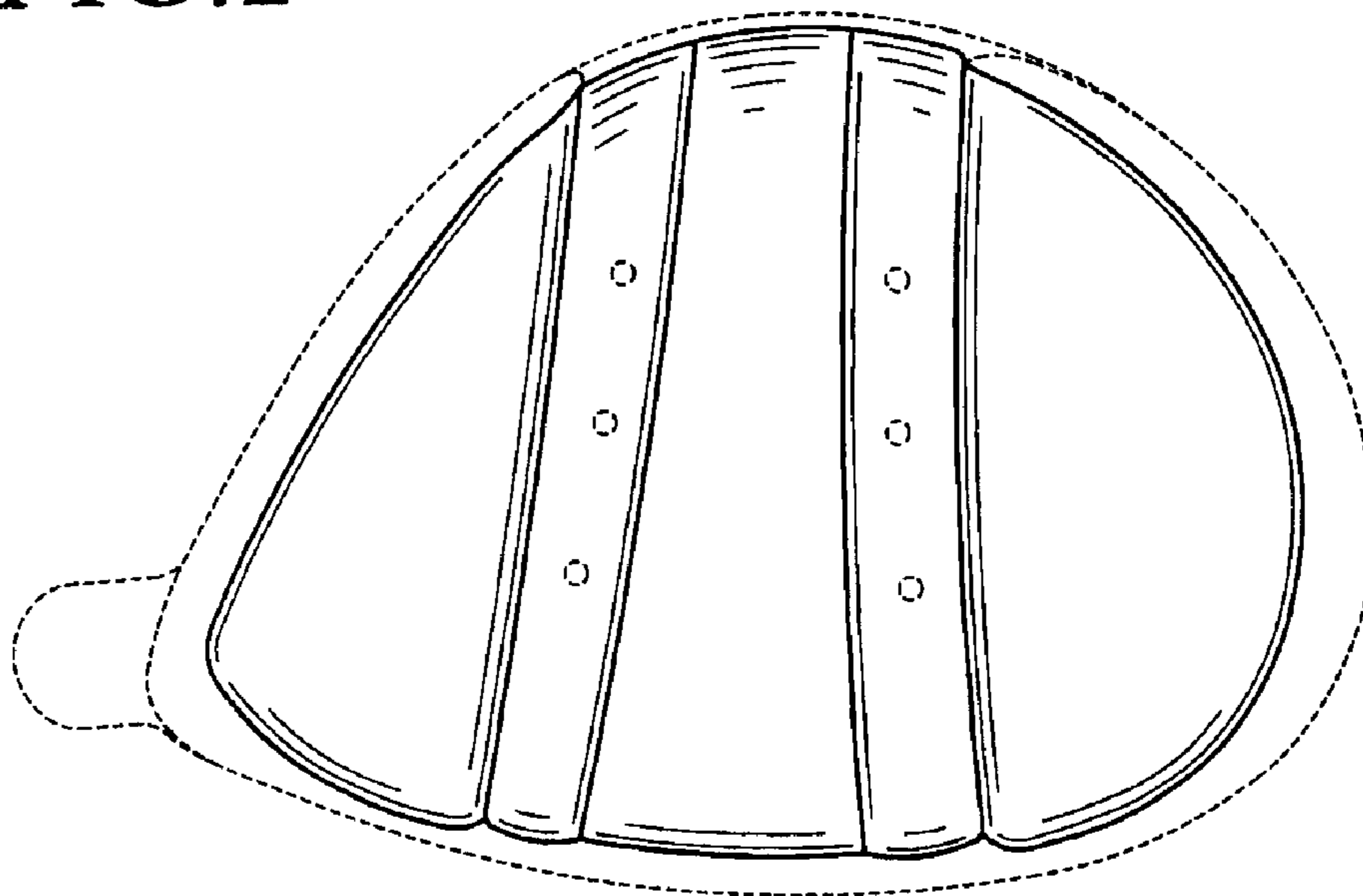

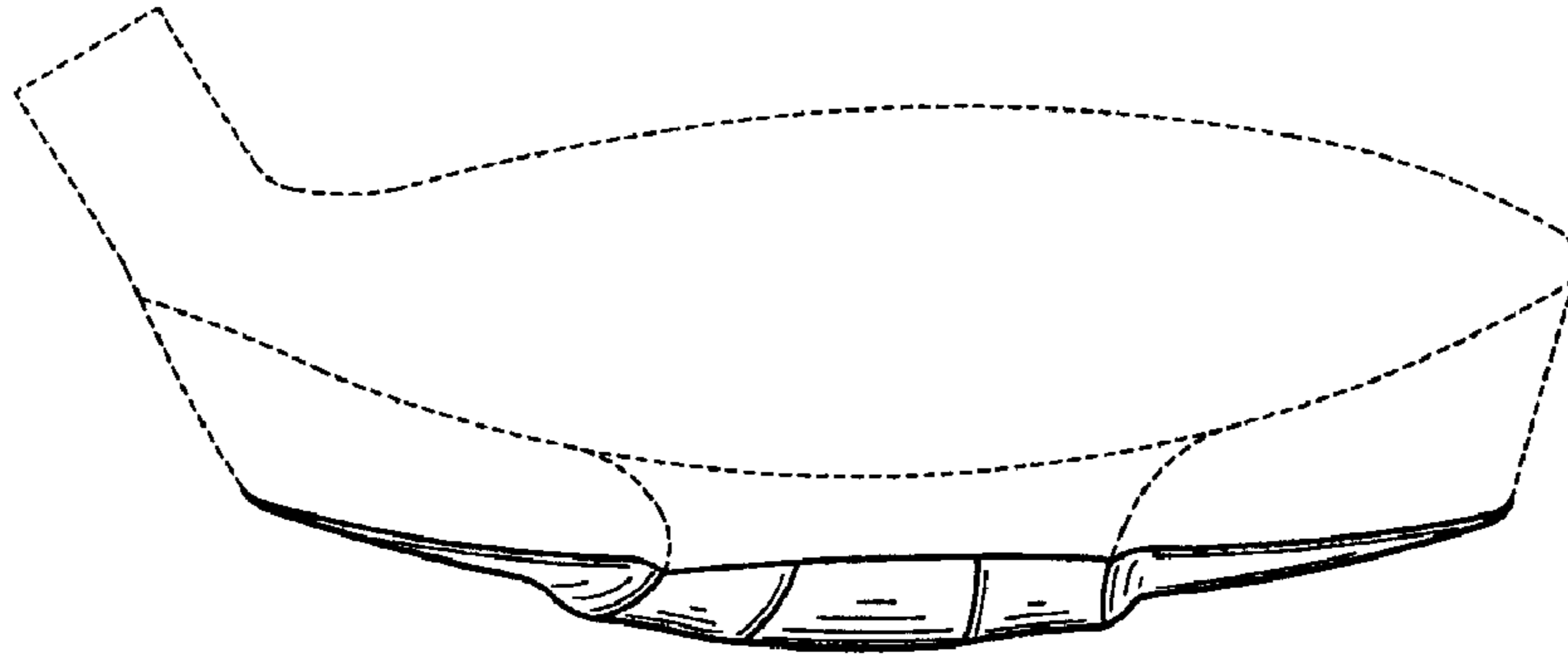

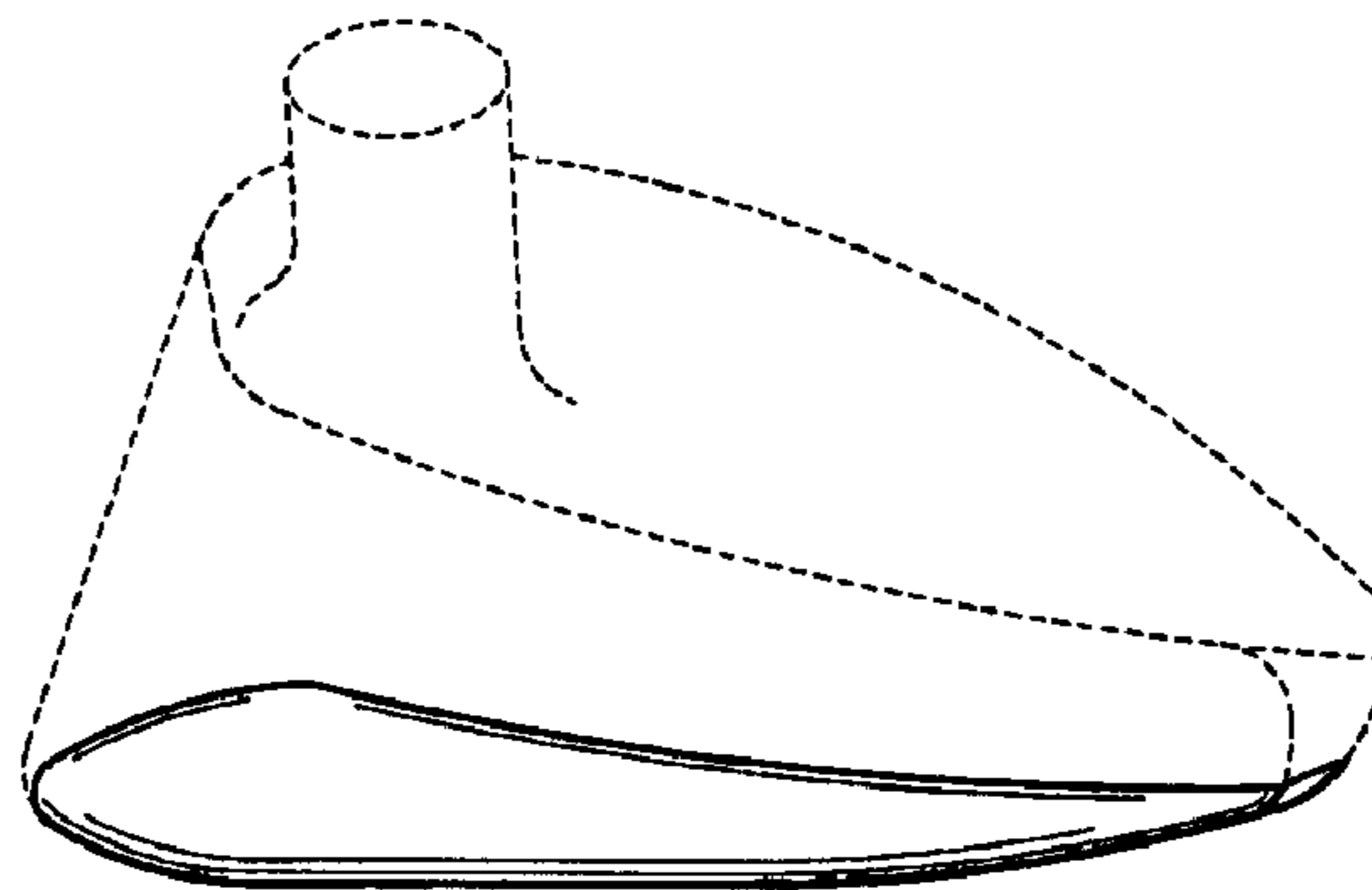
