FIG. 4 is a top view.

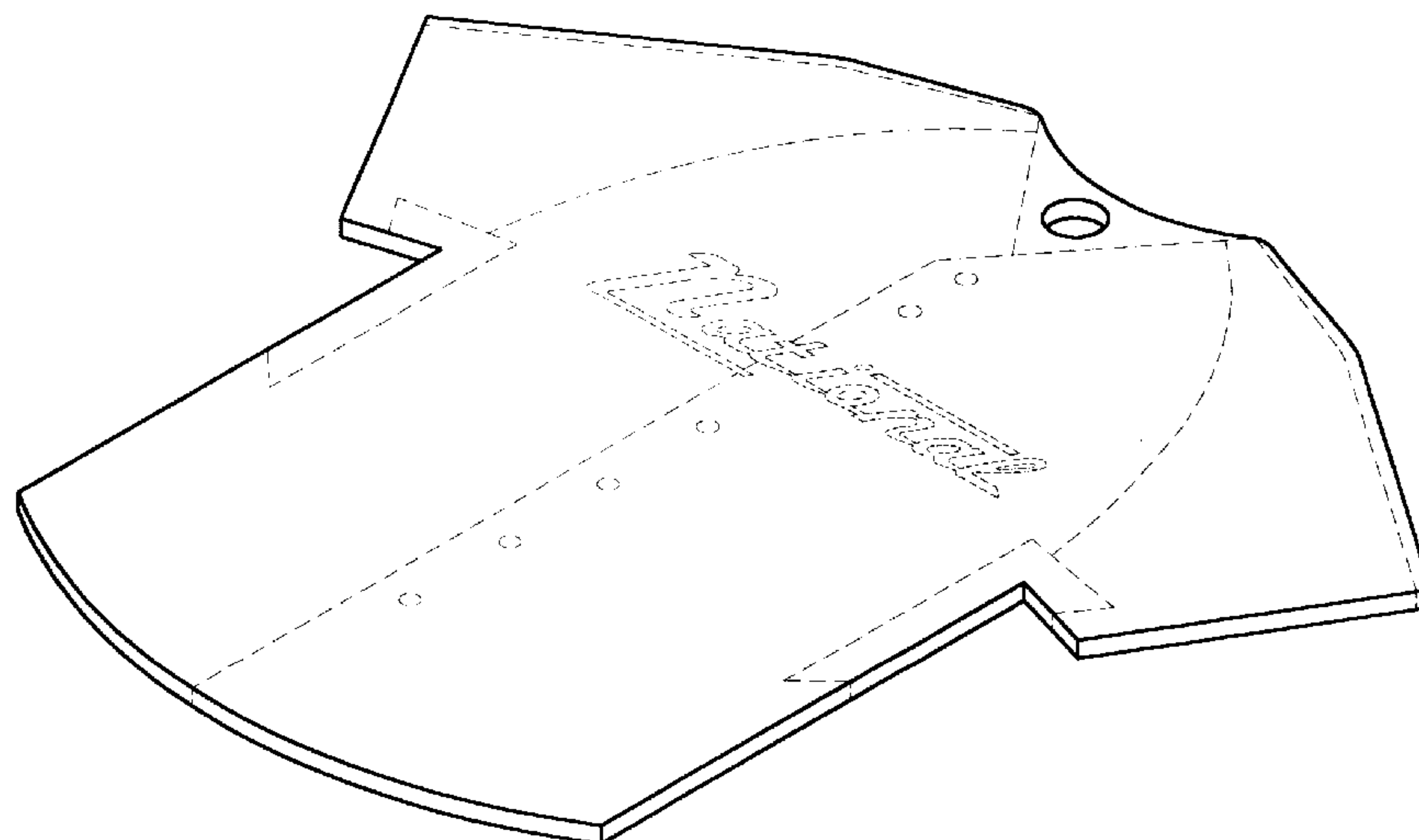
FIG. 5 is a bottom view.

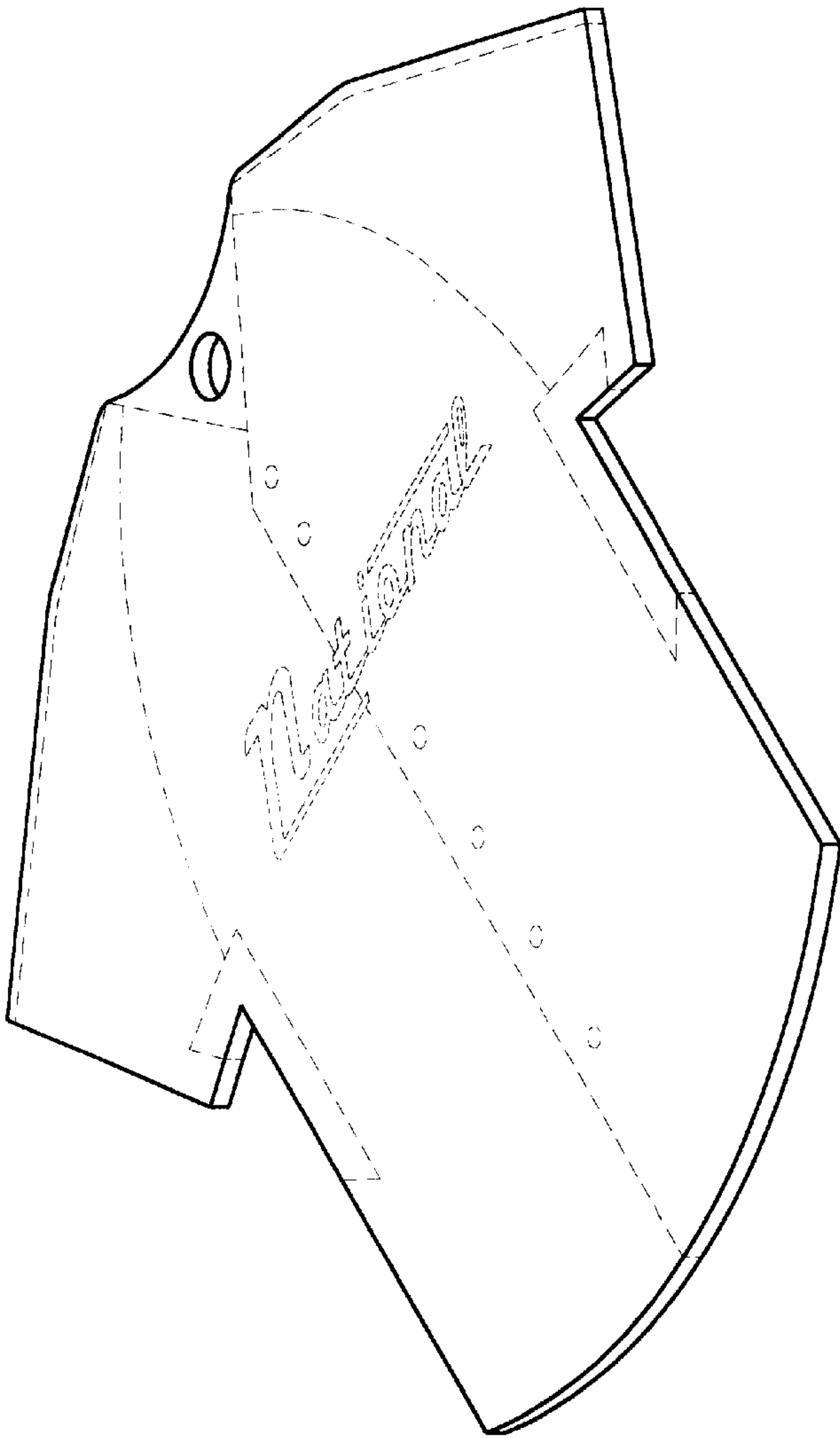

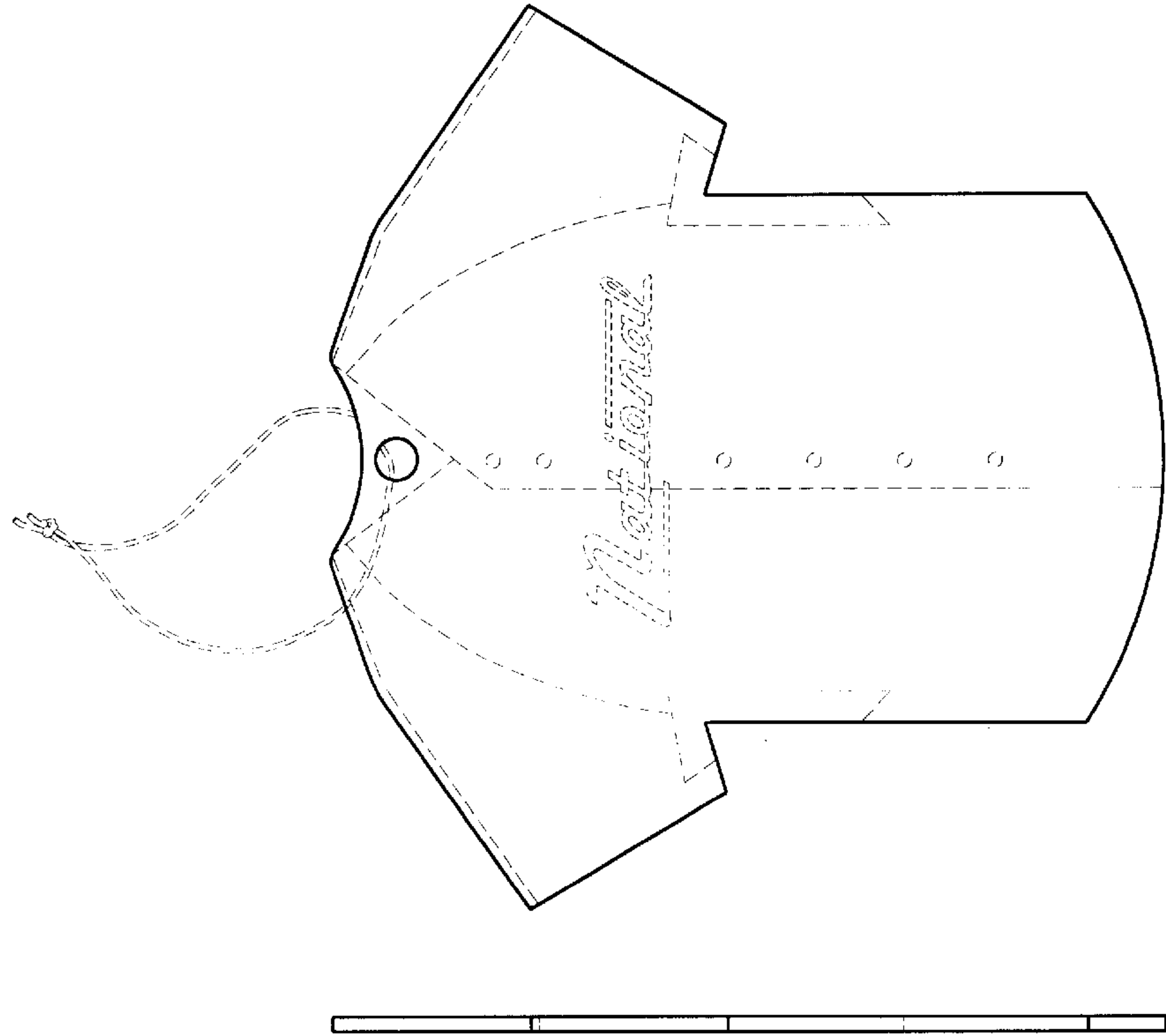
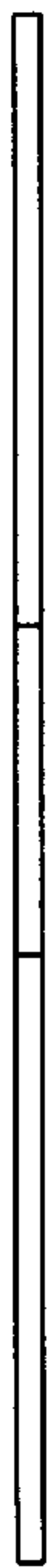

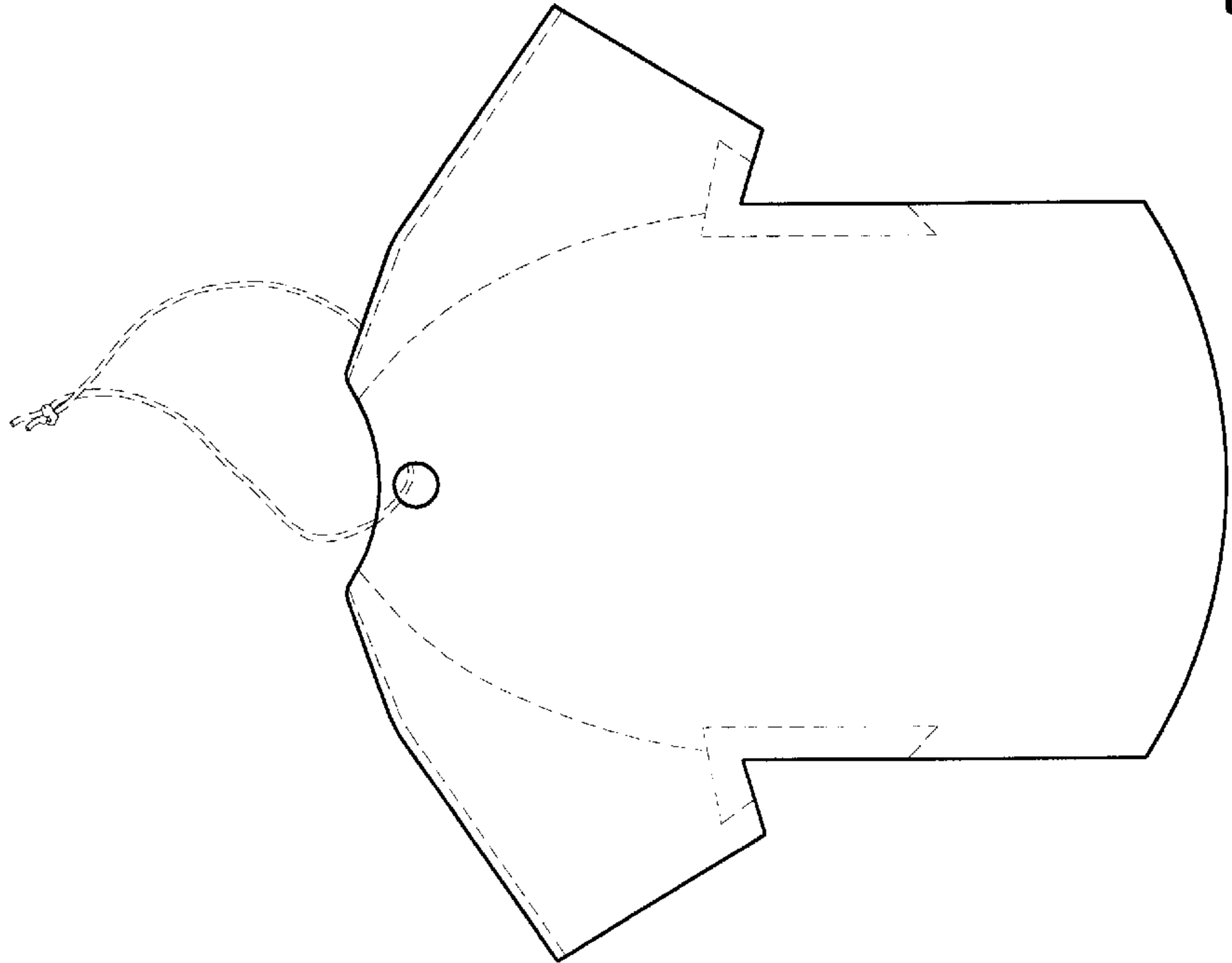

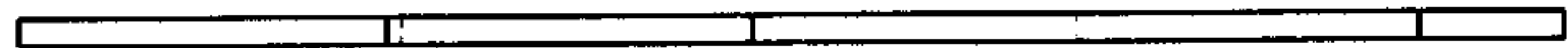
