The ornamental design for a figure-eight tablet, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a Figure-eight Tablet showing our new design with portions shown in stippling to indicate color contrast;

FIG. 2 is a right end elevation thereof;

FIG. 3 is a front elevation thereof;

FIG. 4 is a left end elevation thereof;

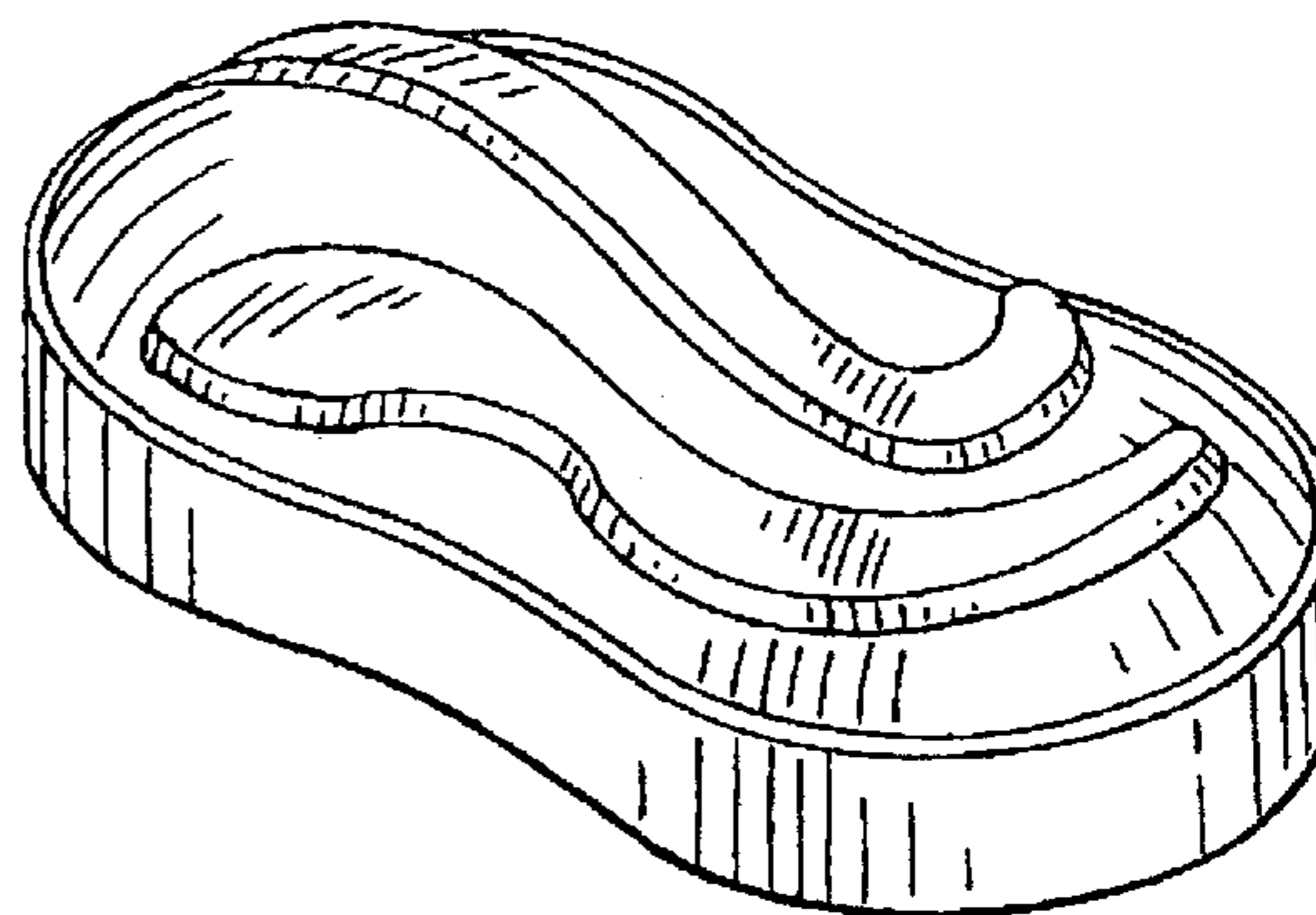
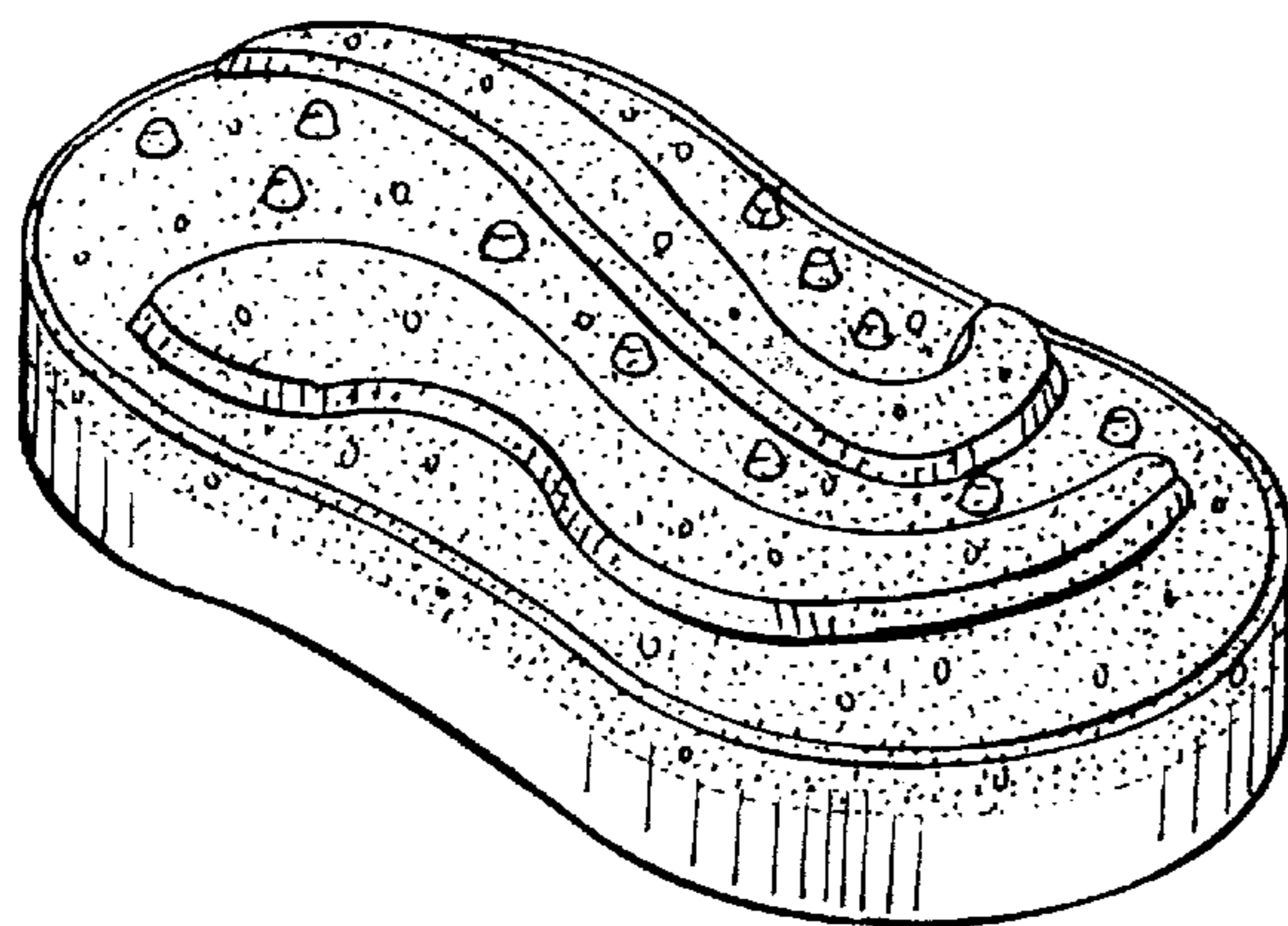
FIG. 5 is a rear elevation thereof;

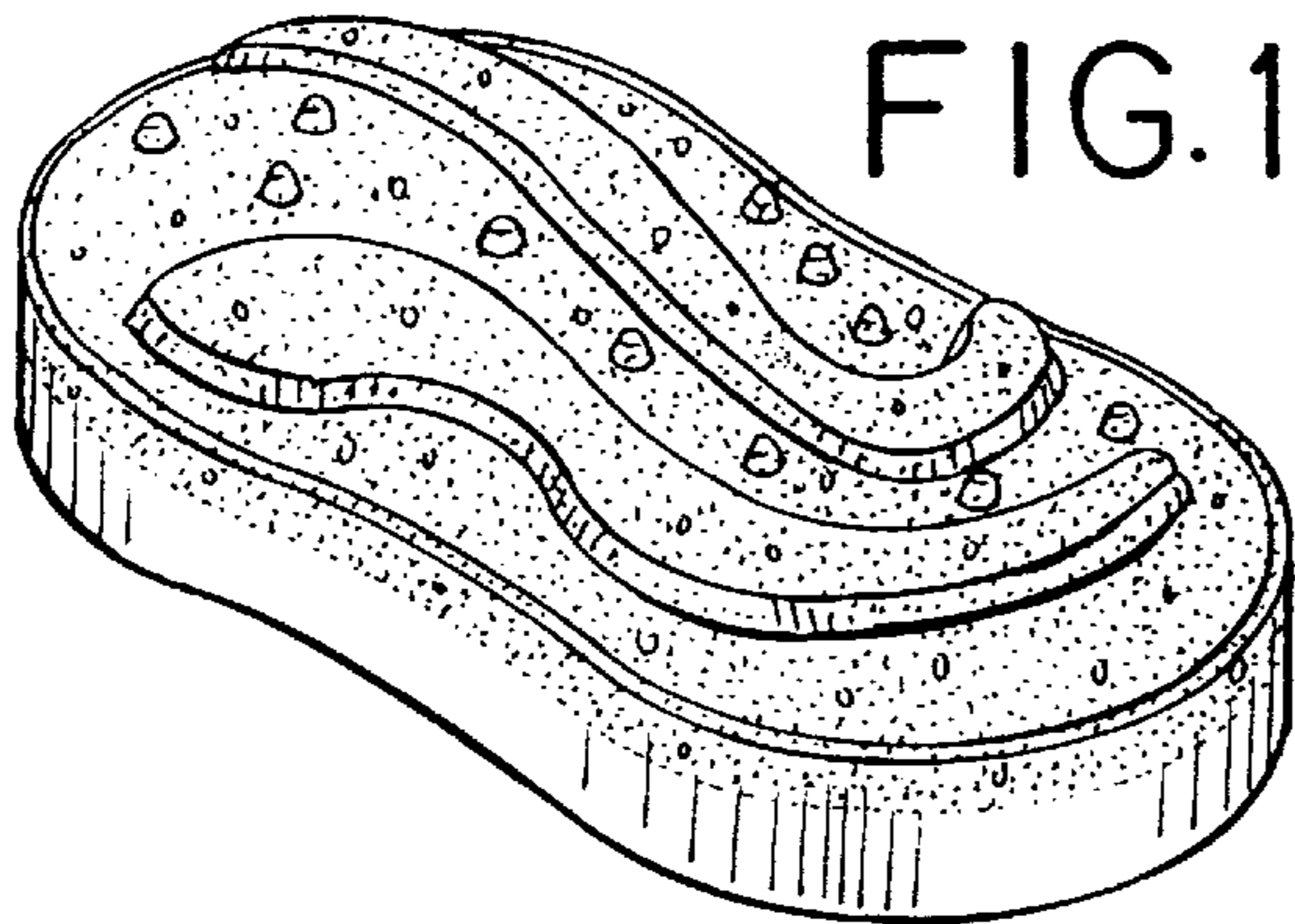

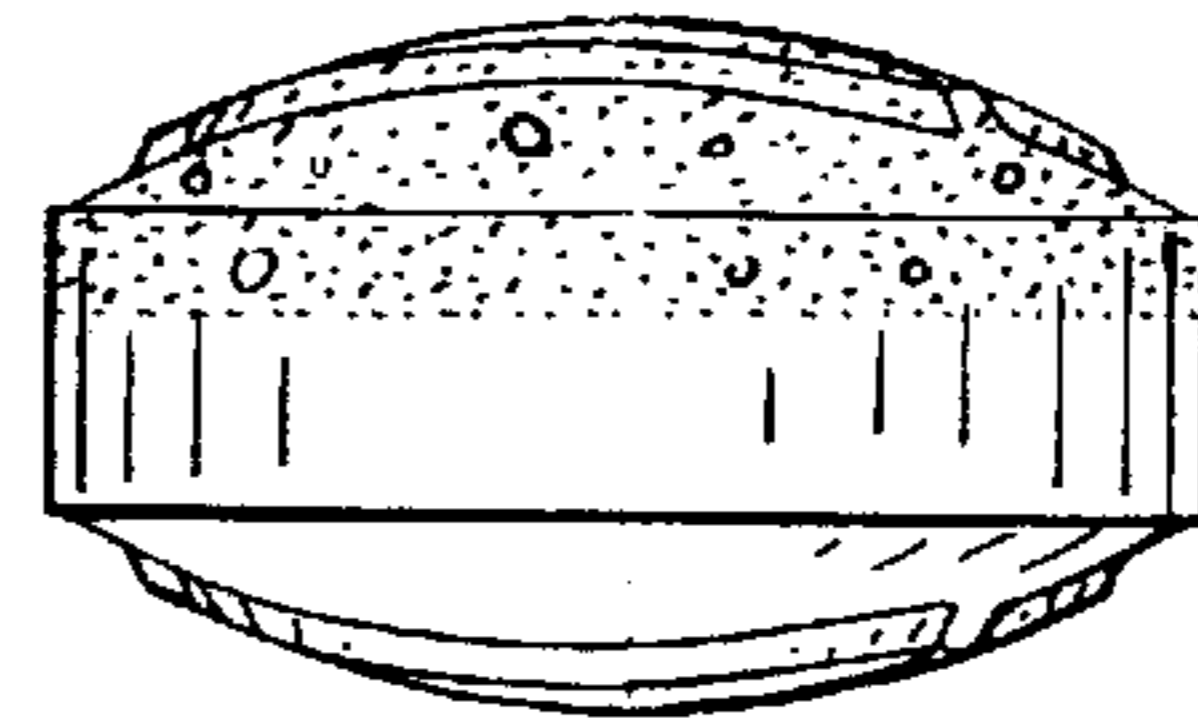

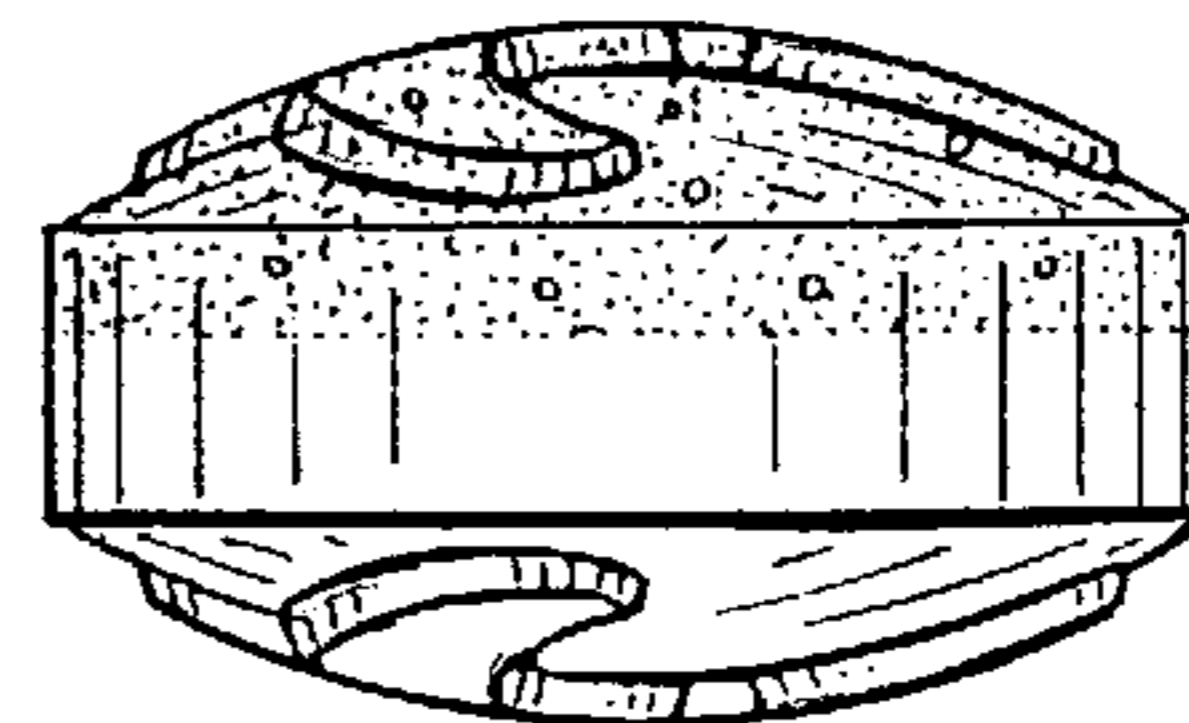
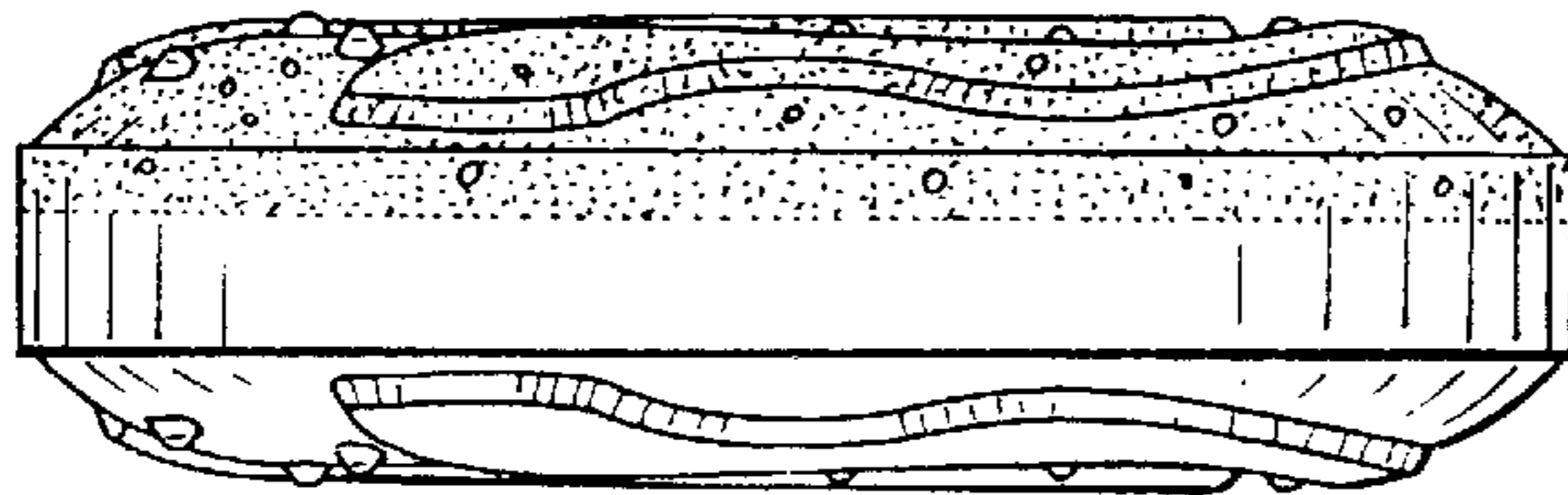

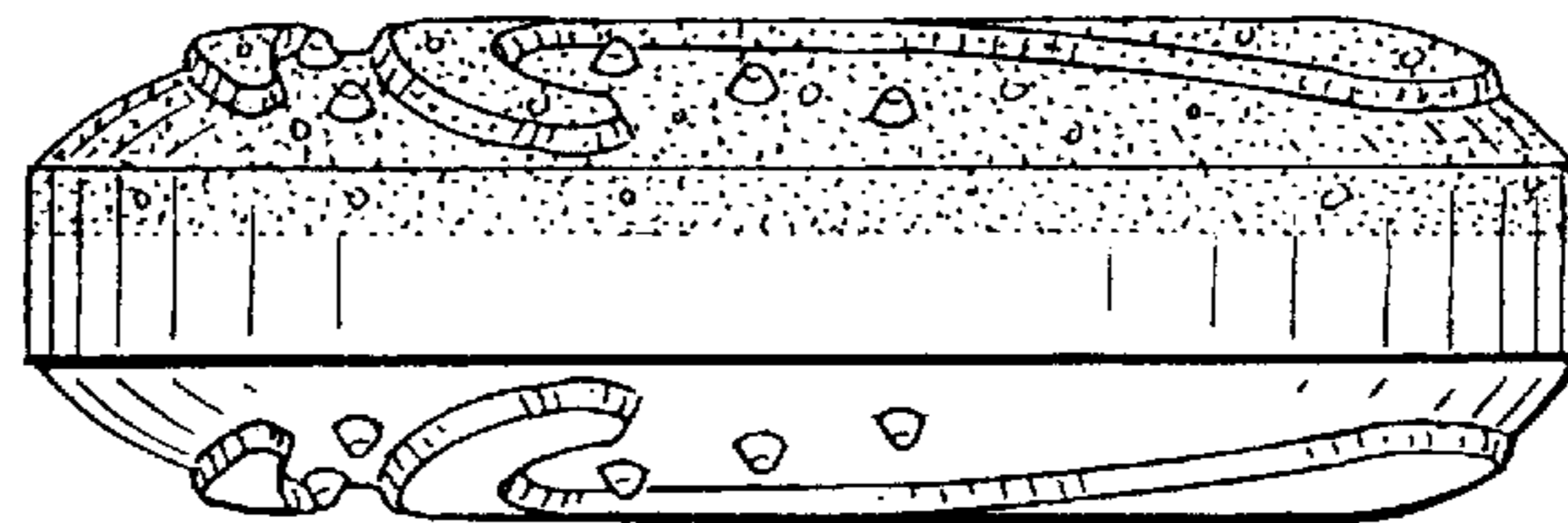

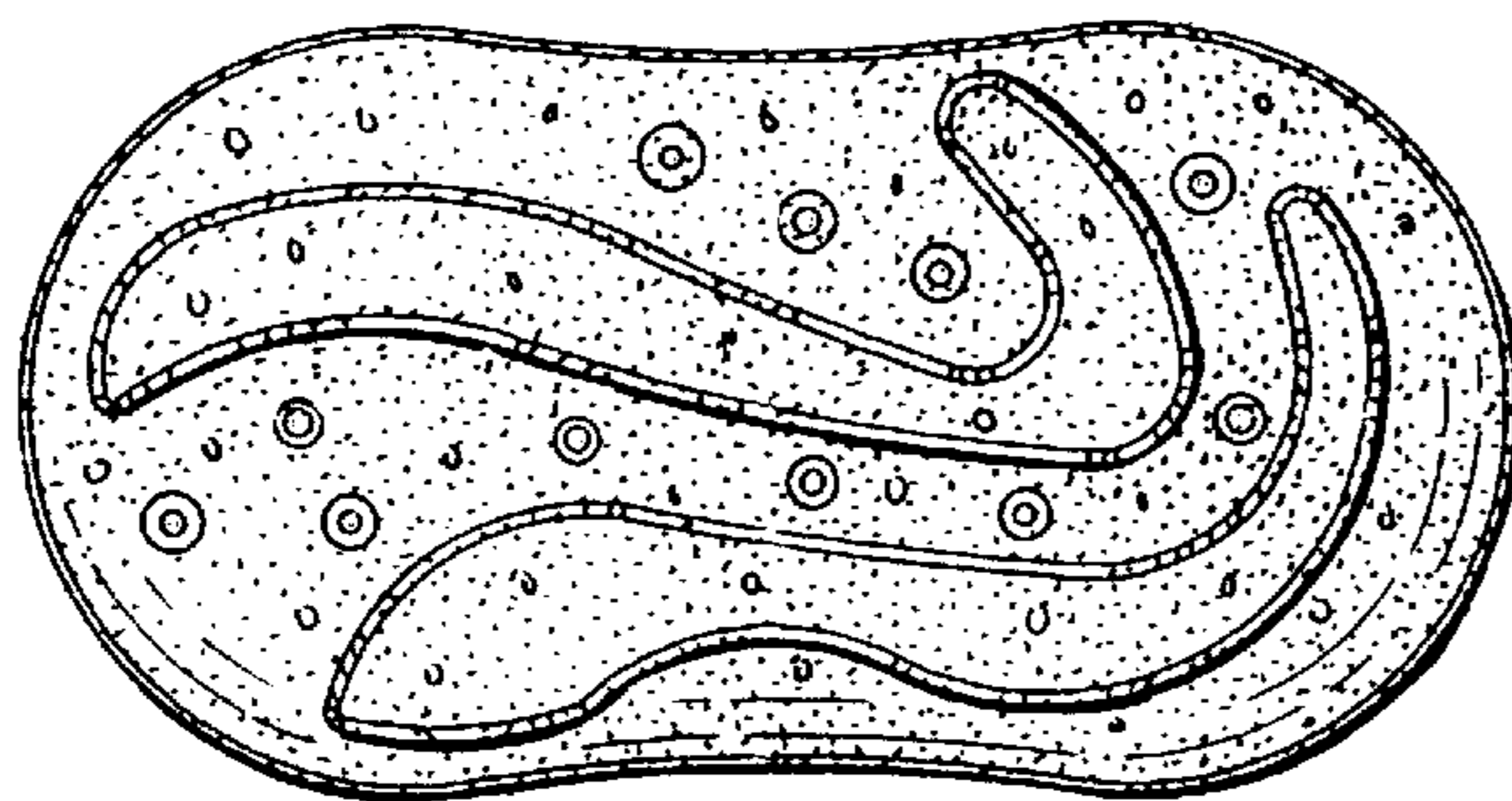

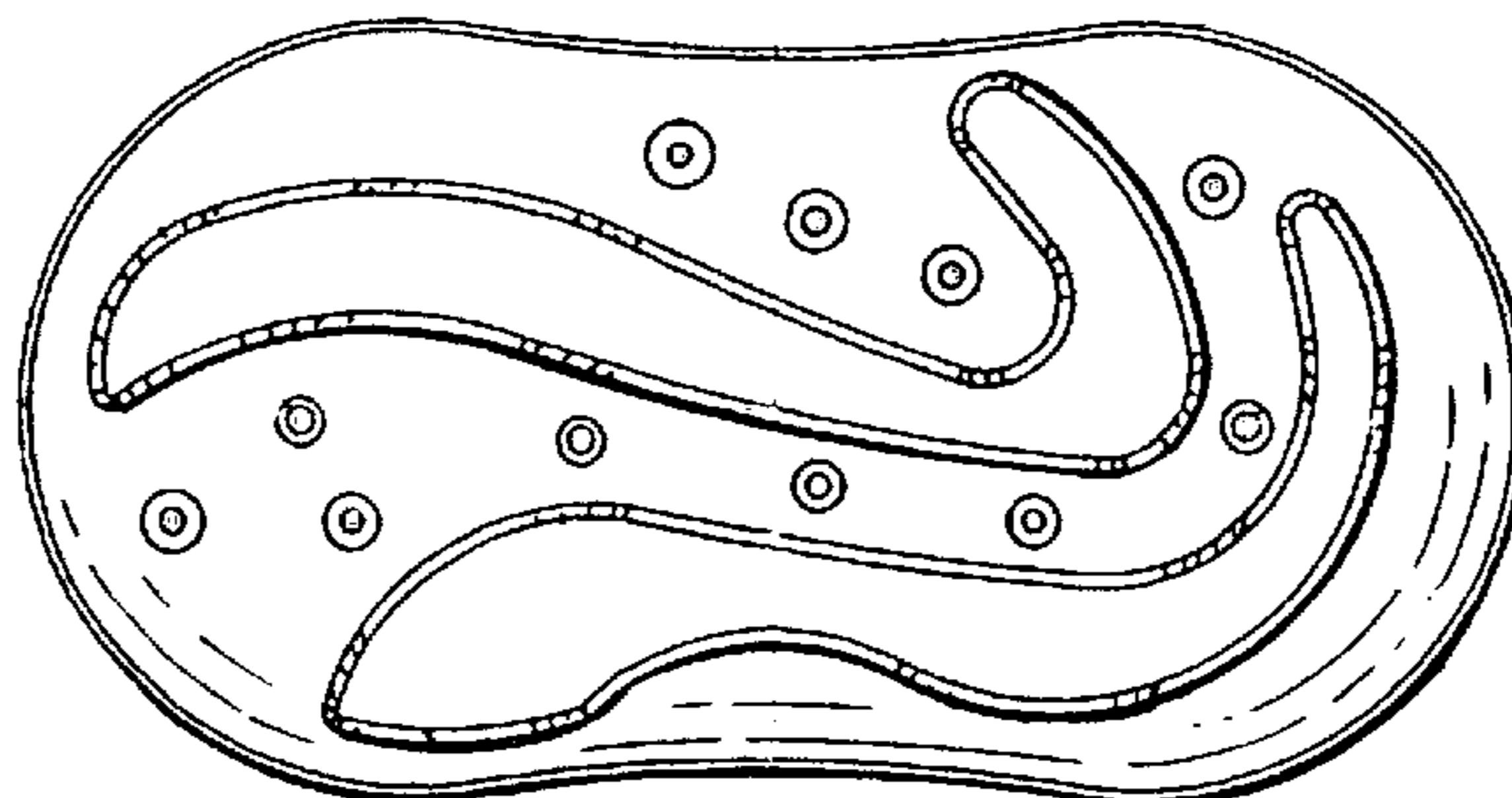
