(57) **CLAIM**

The ornamental design for a patient positioning frame, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a patient positioning frame showing a first embodiment of my design;

FIG. 2 is a right side view of the frame of FIG. 1, the left side view being a mirror image thereof;

FIG. 3 is a top view of the frame of FIG. 1;

FIG. 4 is a bottom view of the frame of FIG. 1;

FIG. 5 is a back view of the frame of FIG. 1;

FIG. 6 is a front view of a second embodiment of the patient positioning frame showing my design;

FIG. 7 is a right side view of the frame of FIG. 6, the left side view being a mirror image thereof;

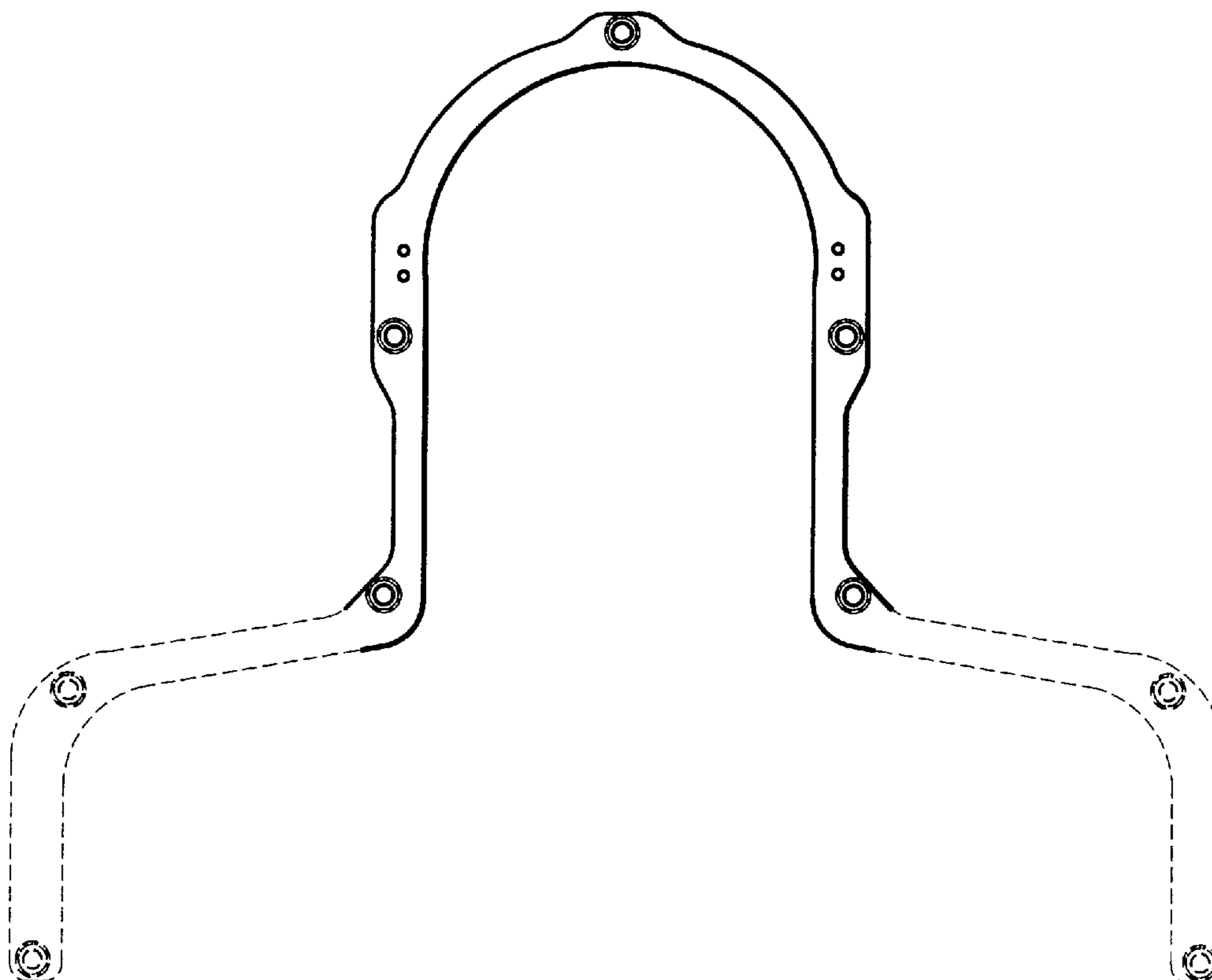
FIG. 8 is a top view of the frame of FIG. 6;

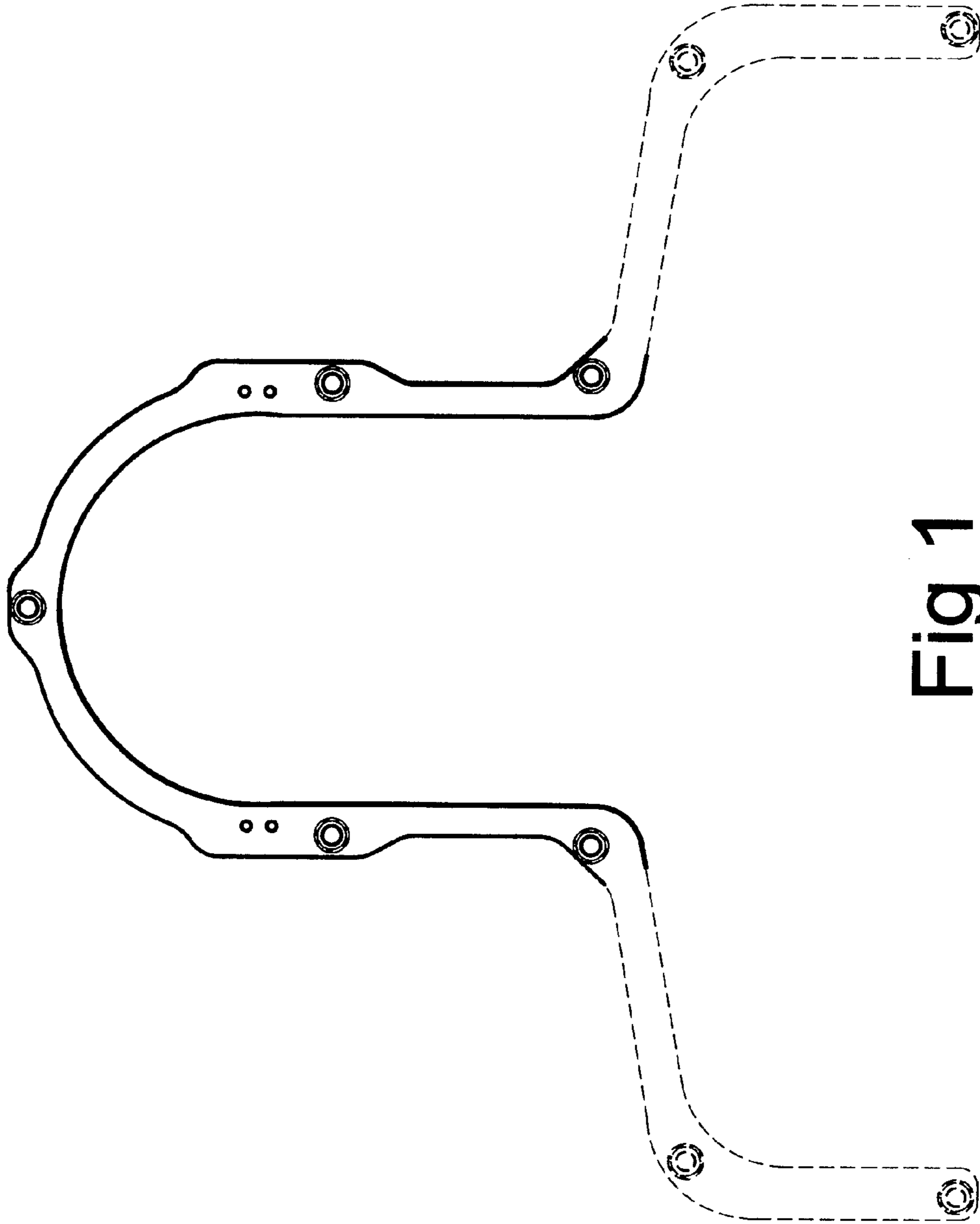

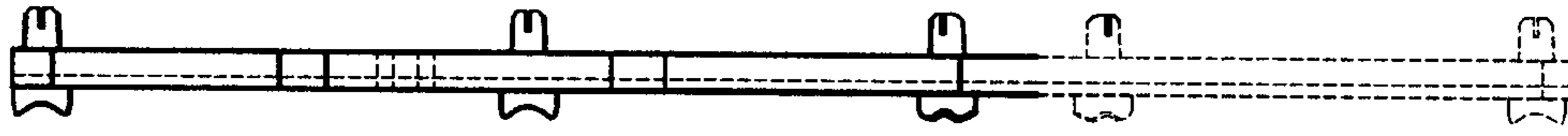

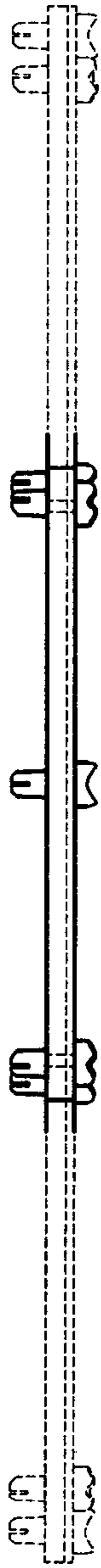

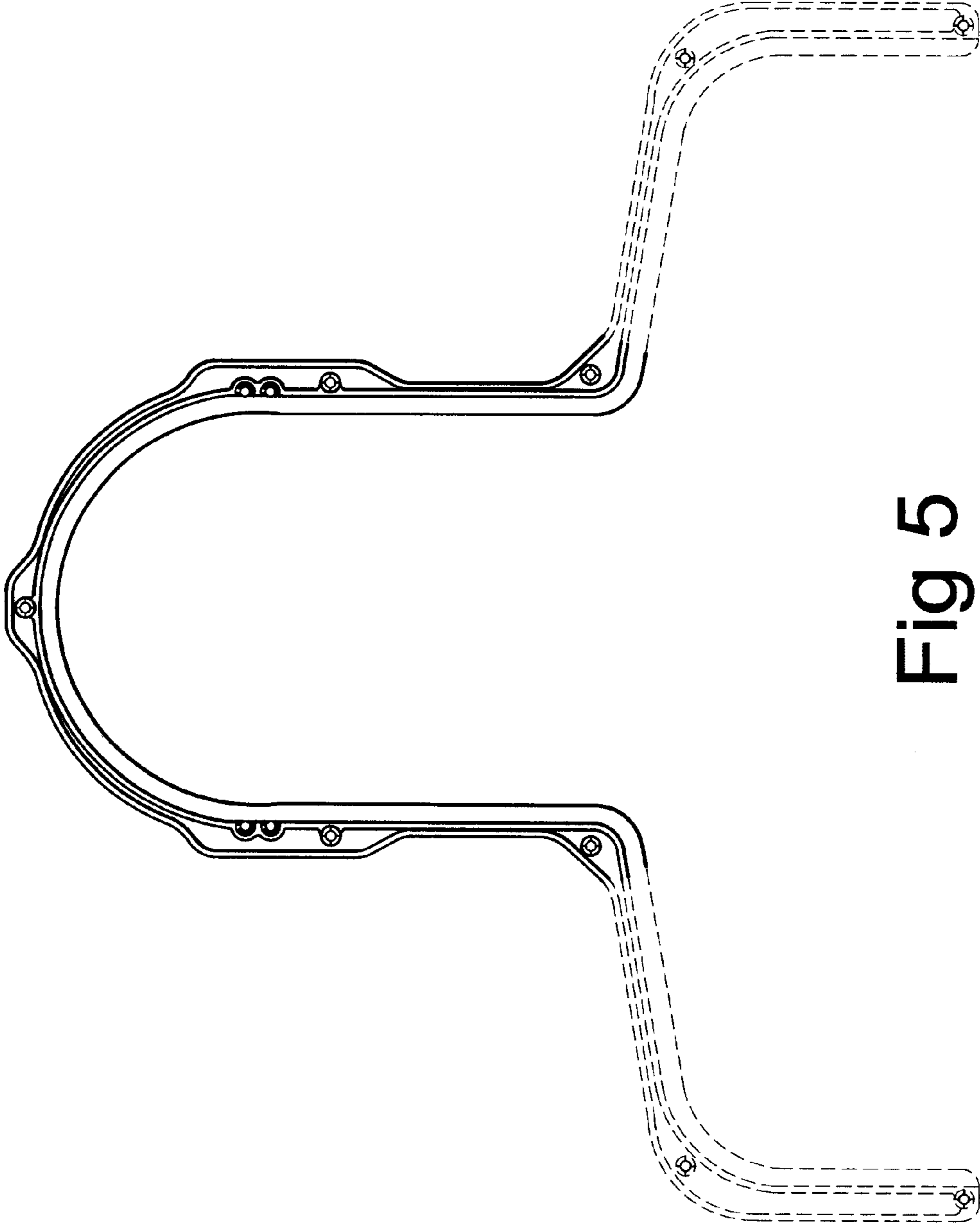

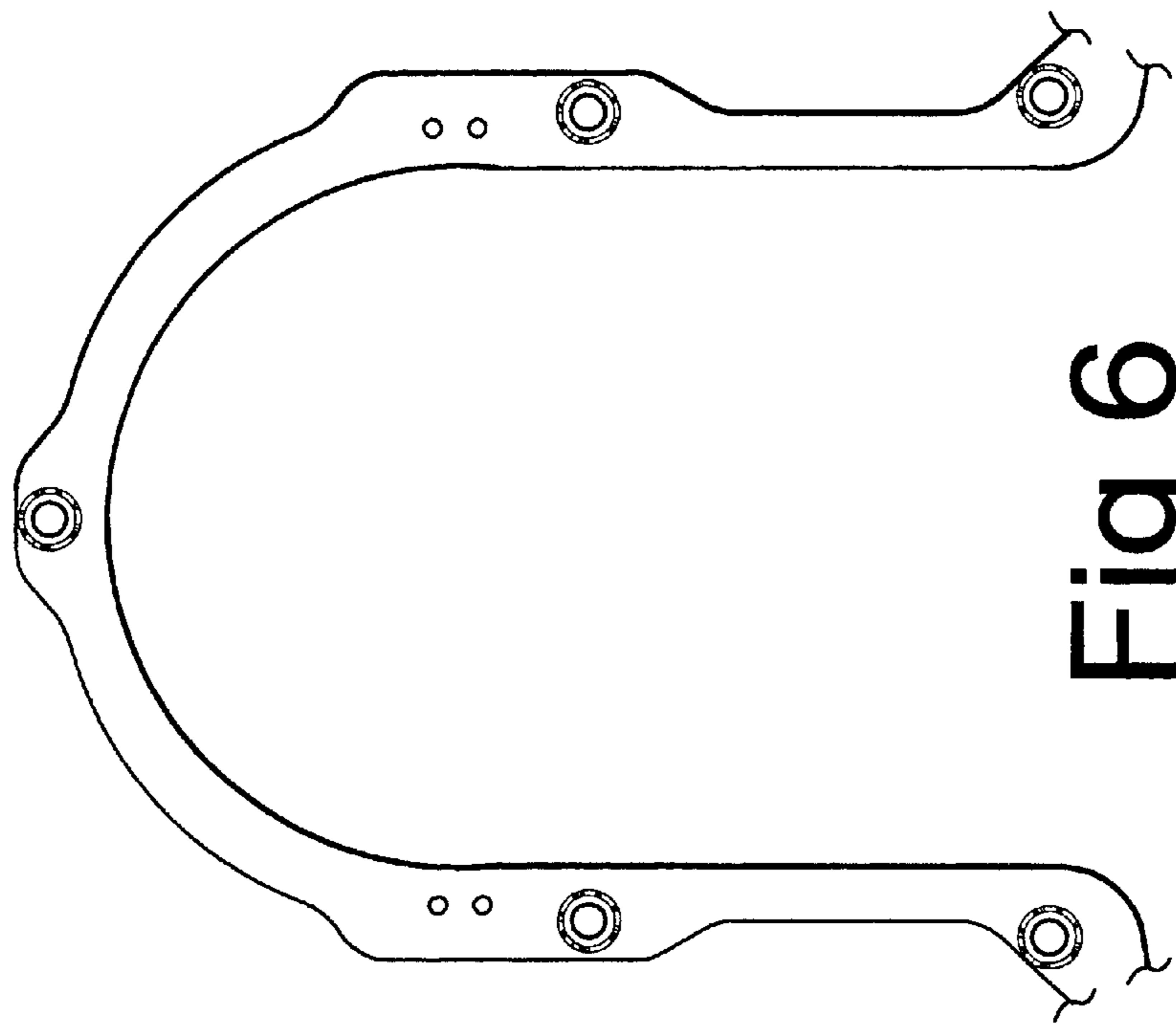

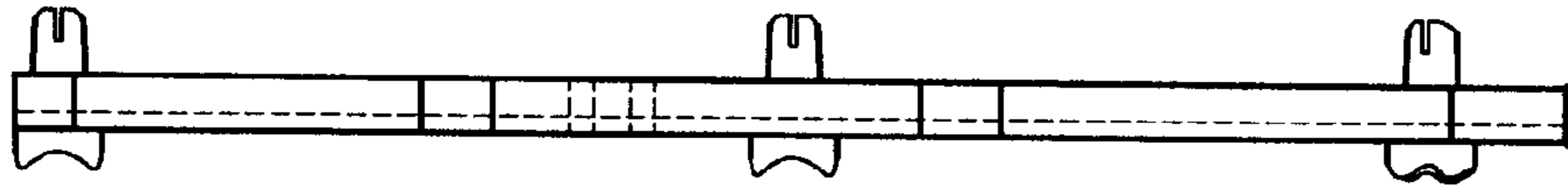

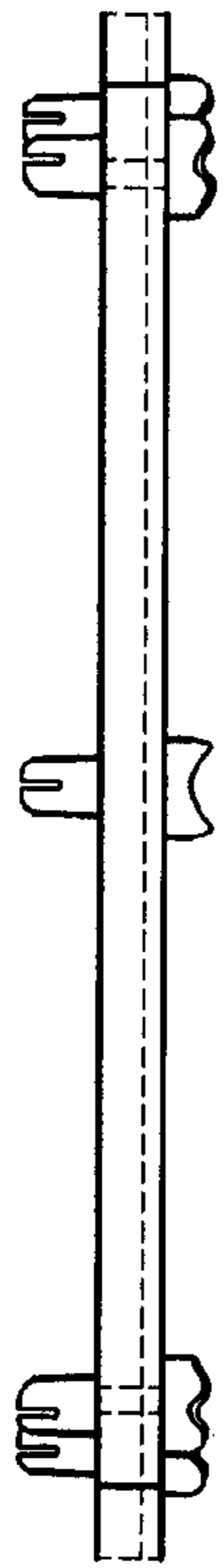

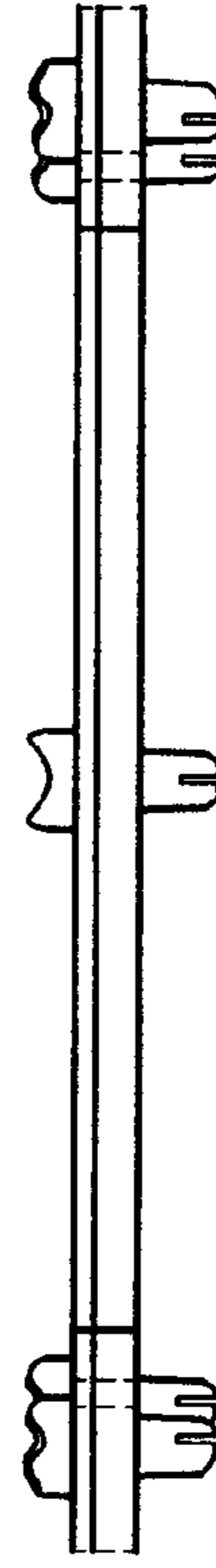

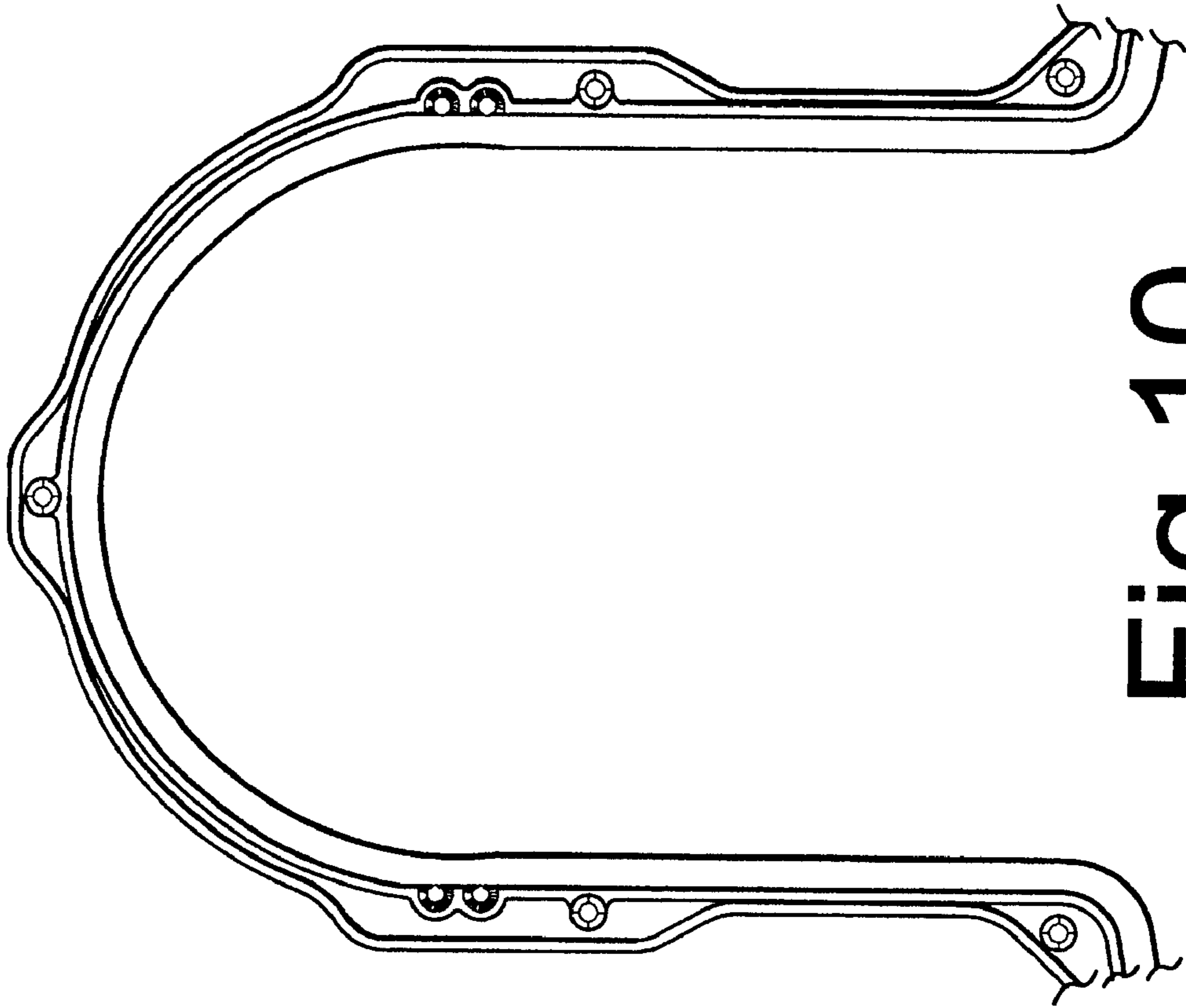
