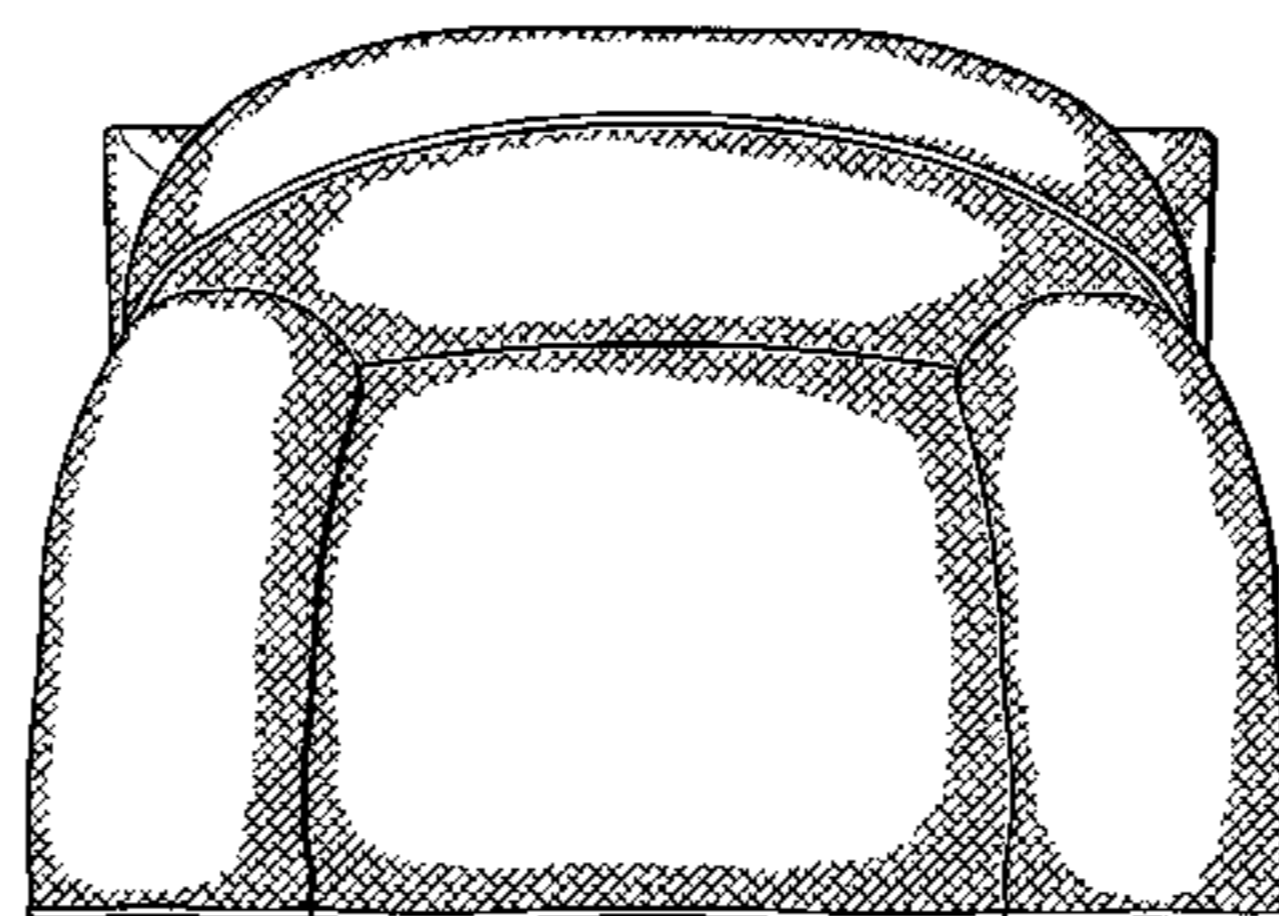
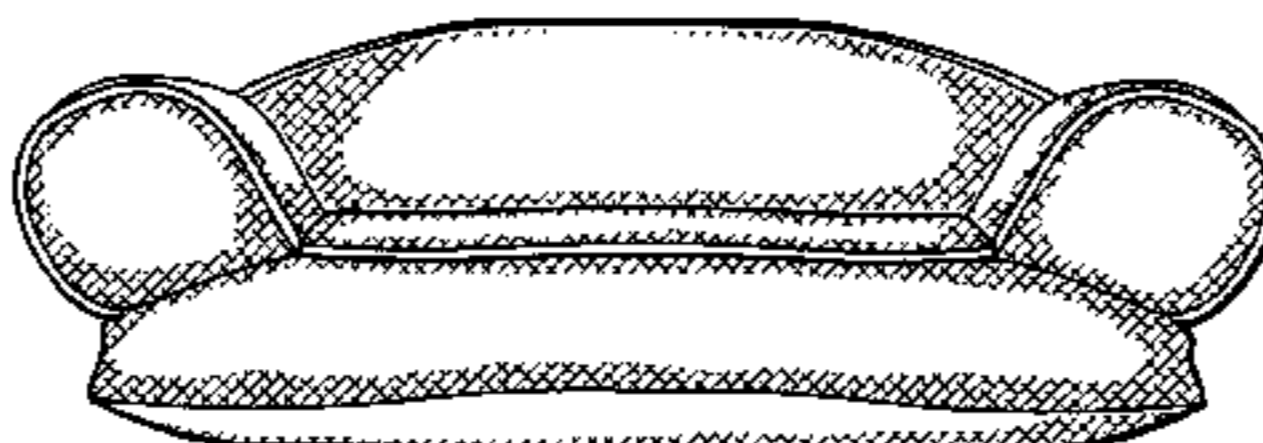
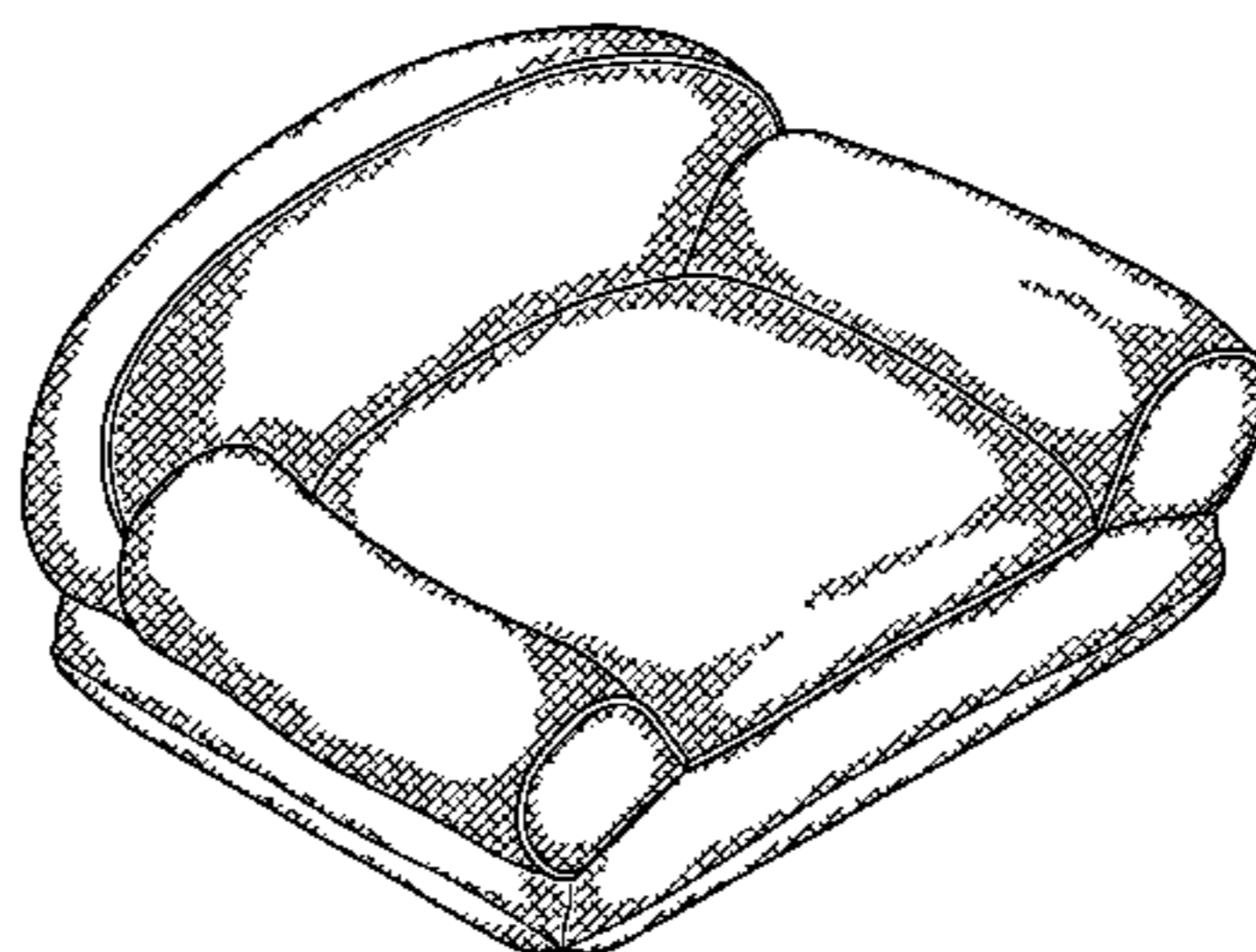

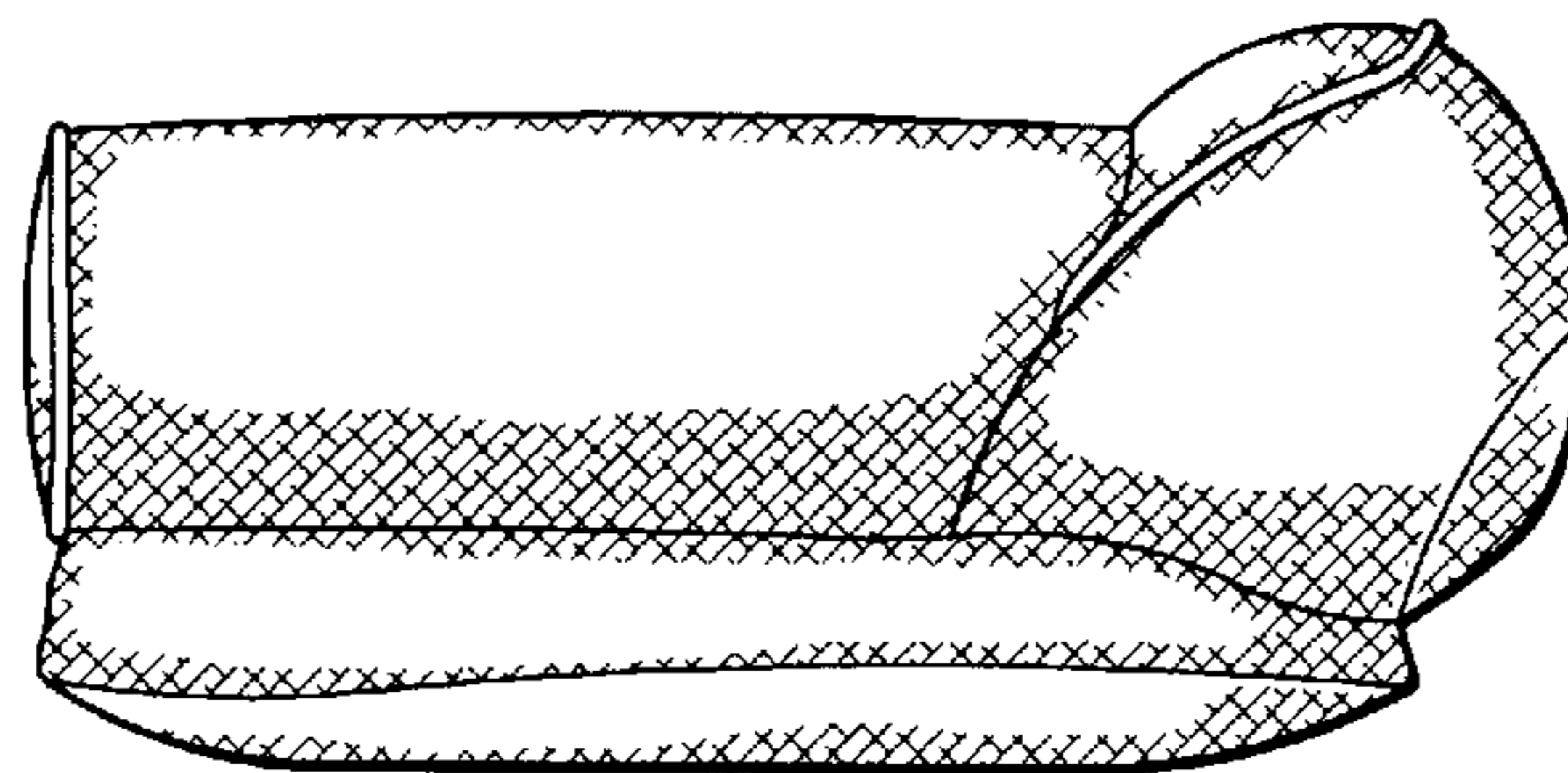
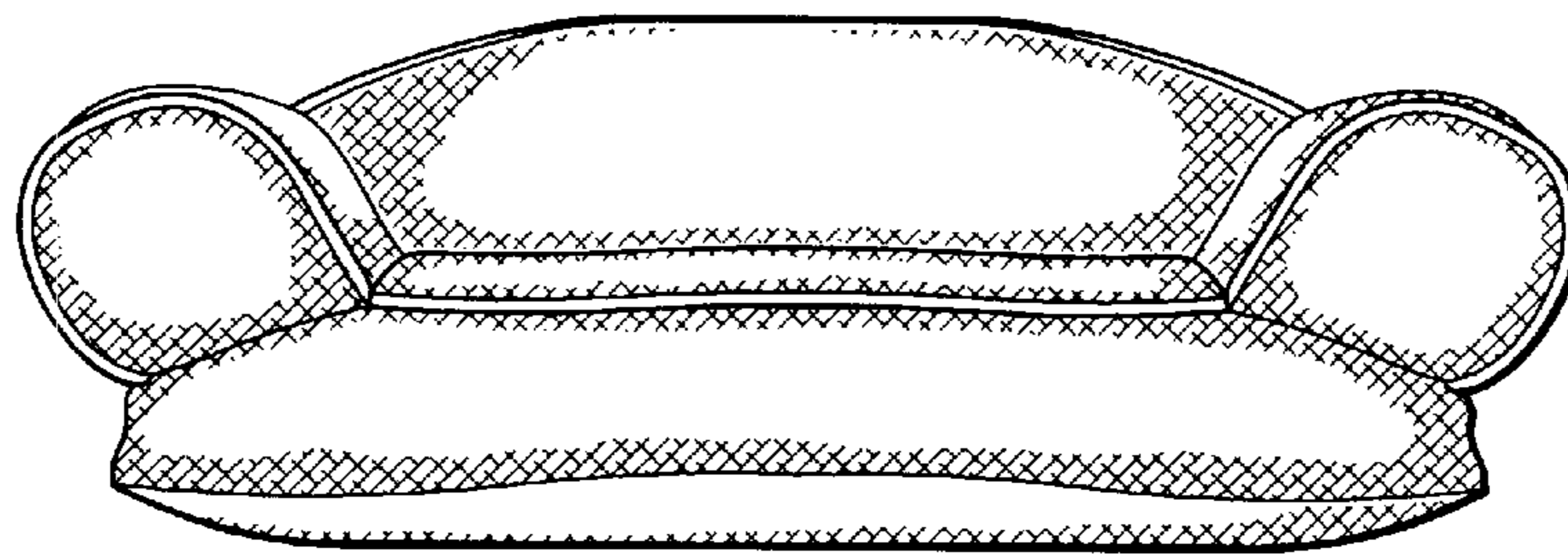
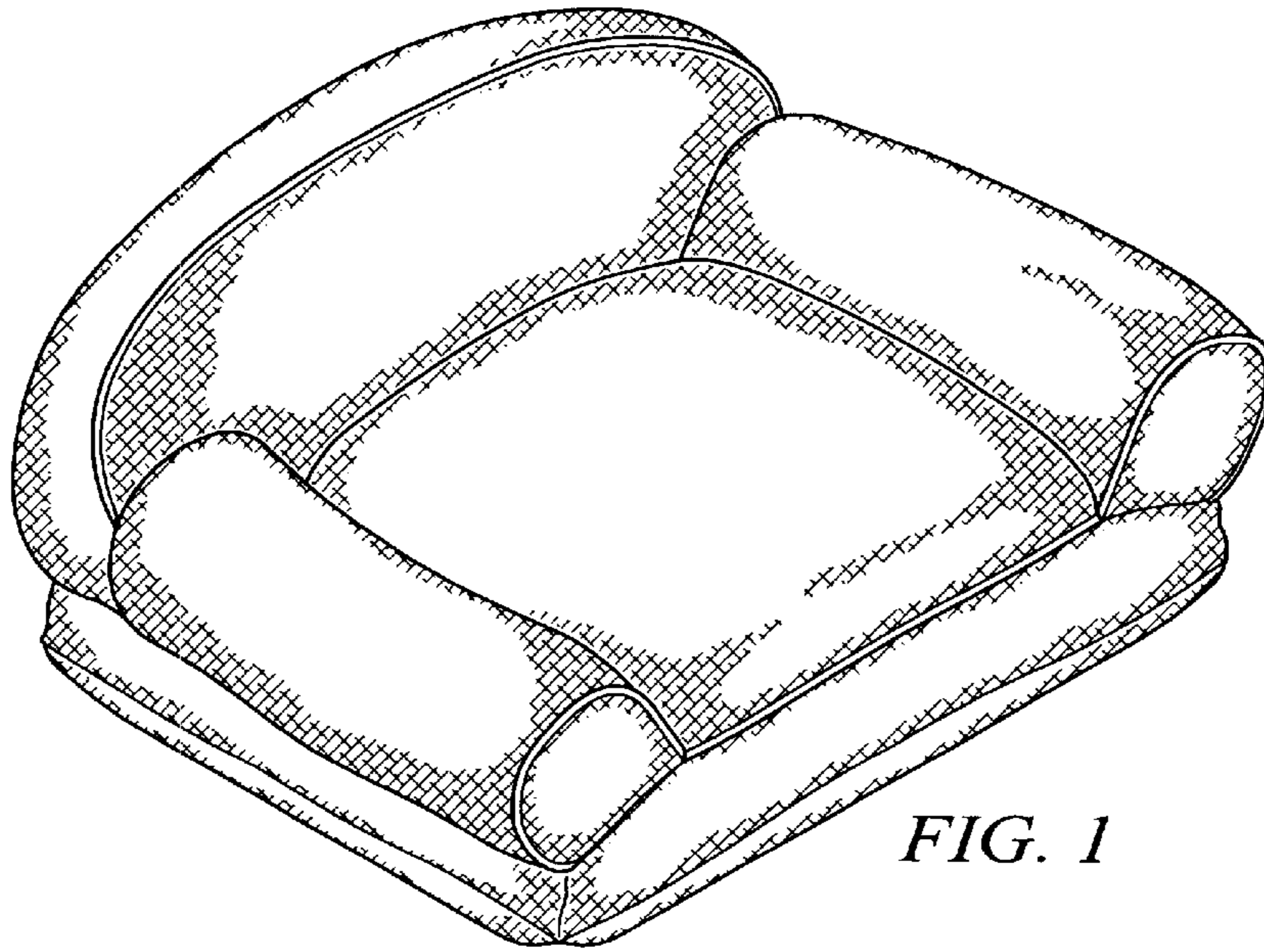
We claim the ornamental design for a sofa pet bed, as shown
and described.

DESCRIPTION

FIG. 1 is a perspective view of the sofa pet bed showing the
new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a right side elevational view thereof; the left side
elevational view being a mirror image of the right side
elevational view;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a top plan view thereof; and,

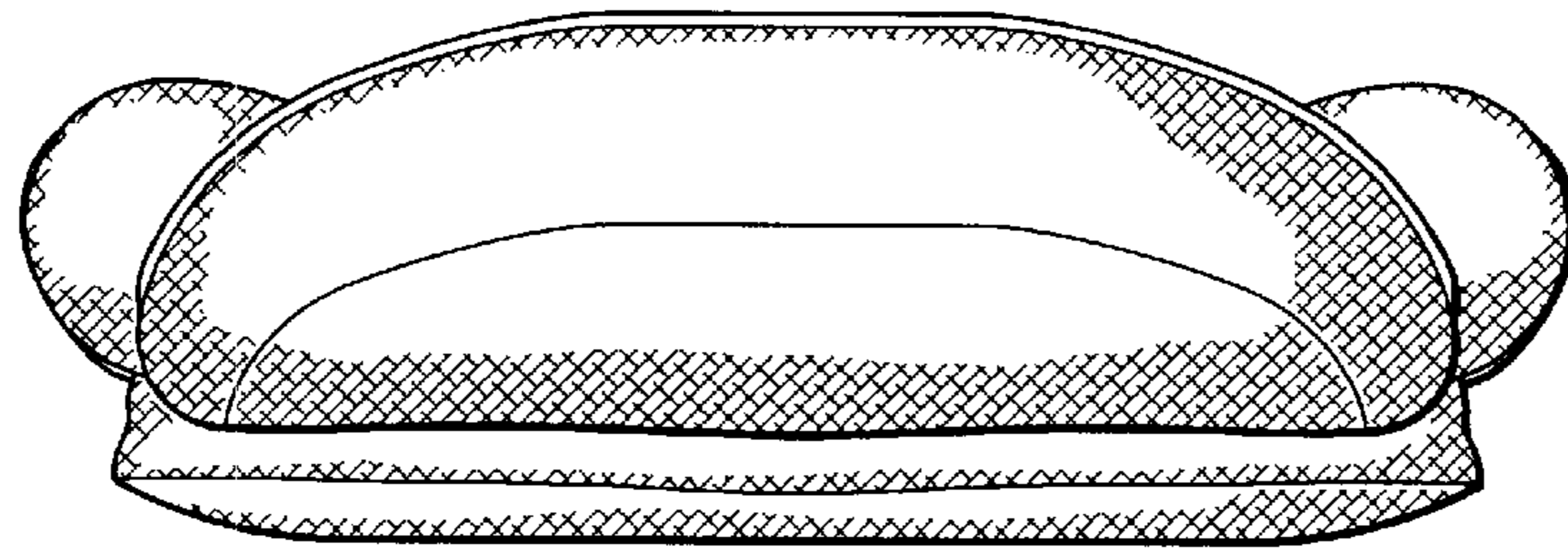

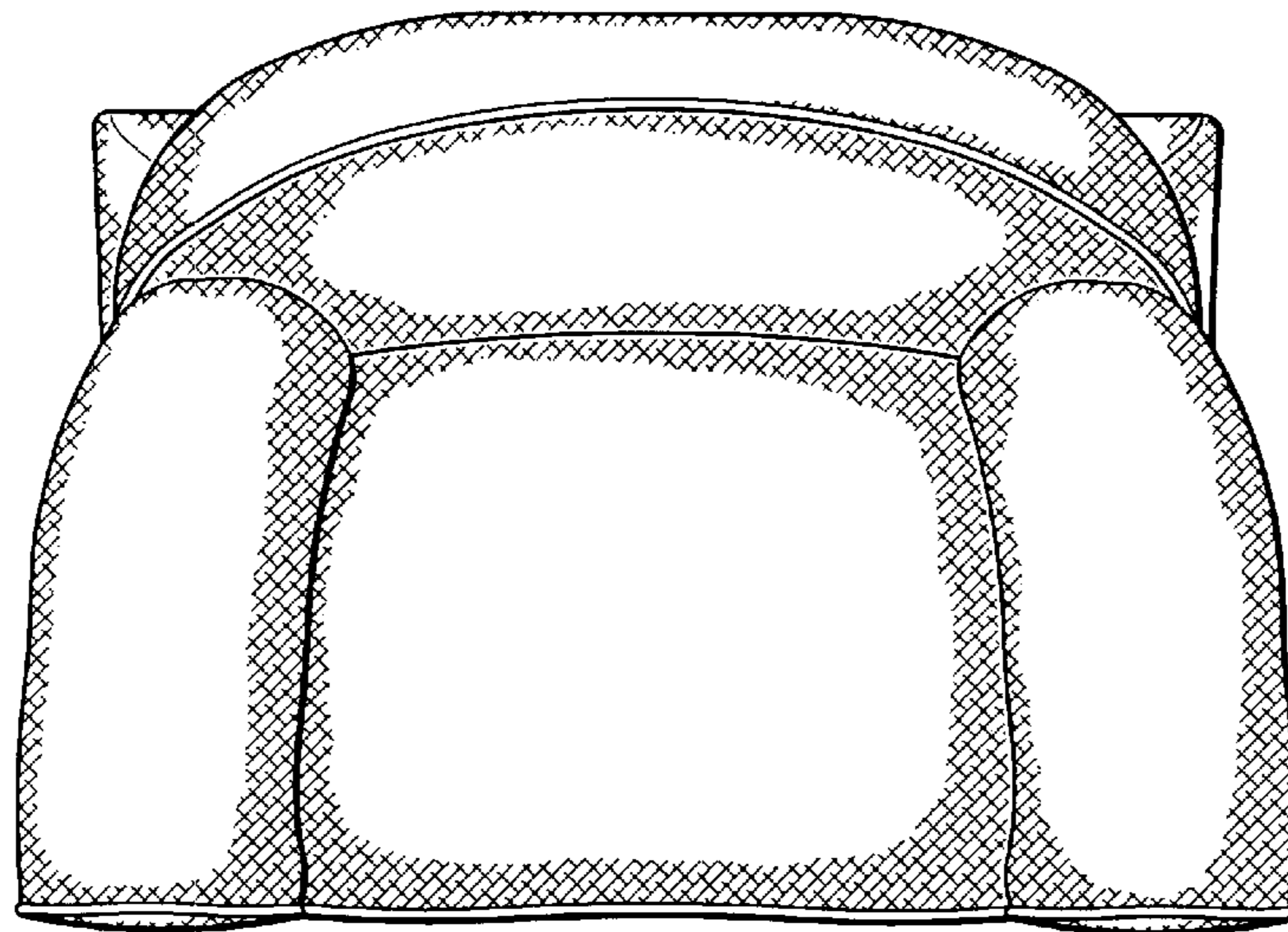

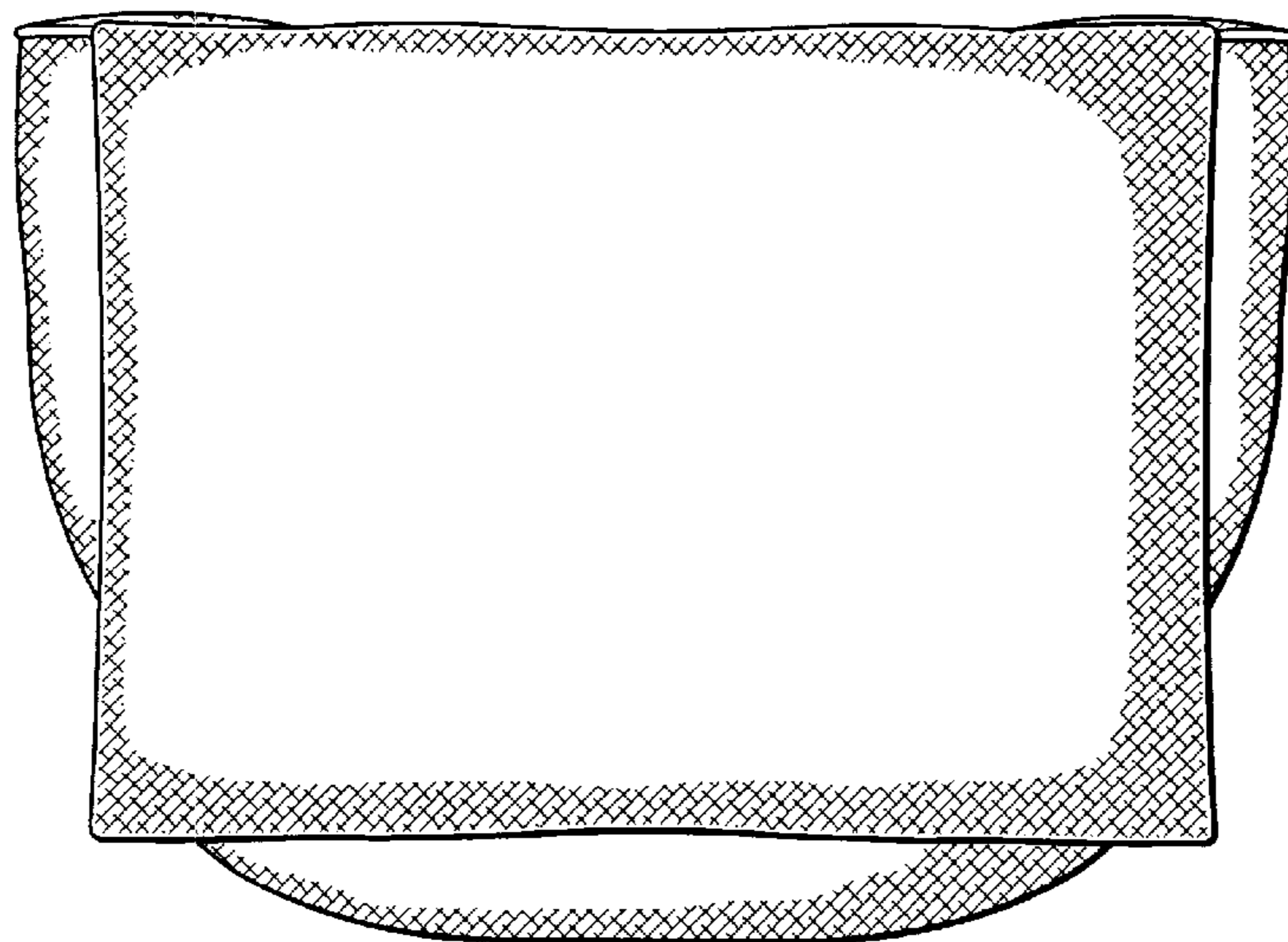
