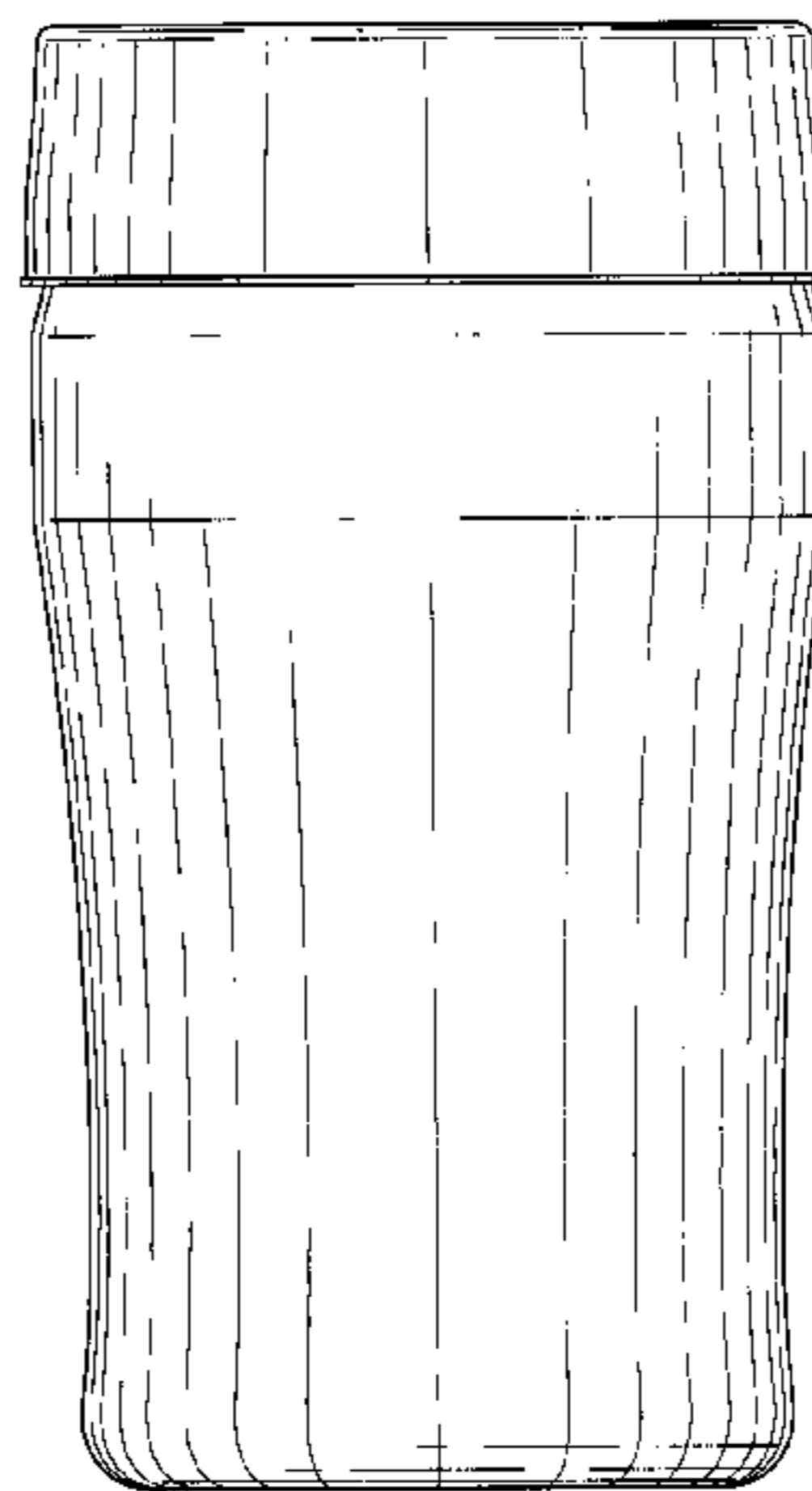
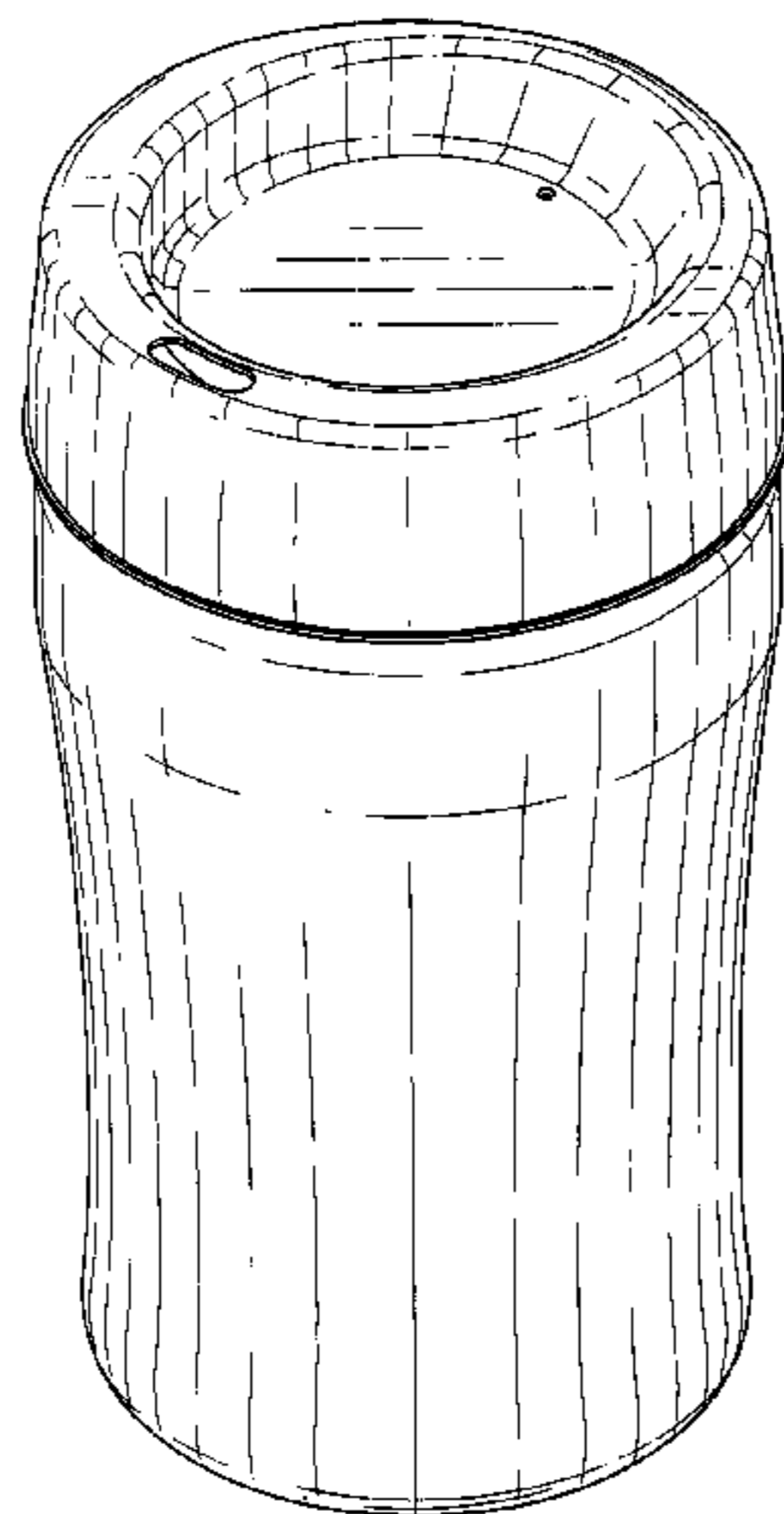
(57) **CLAIM**

The ornamental design for a beverage container, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the beverage container, embodying the new design;

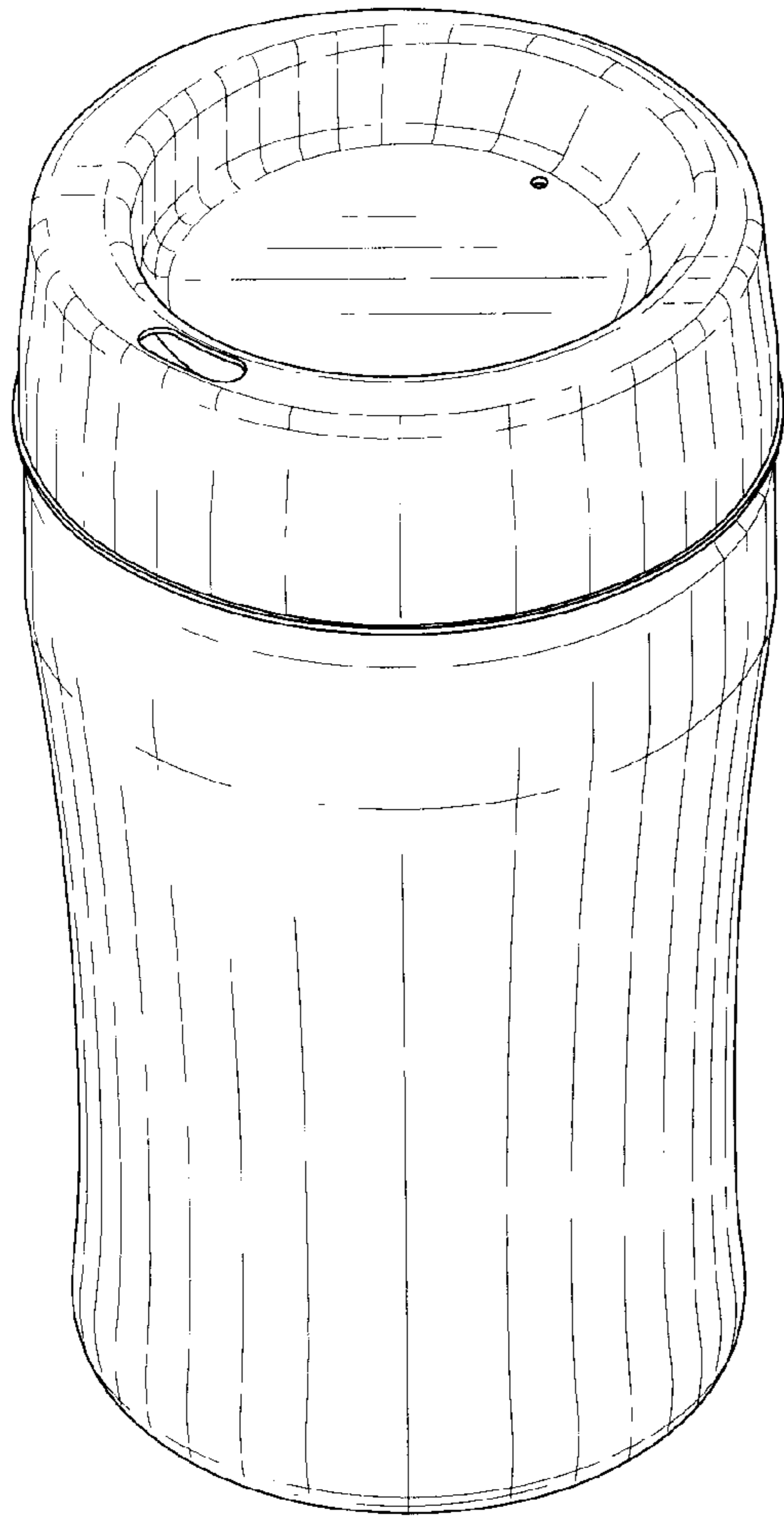

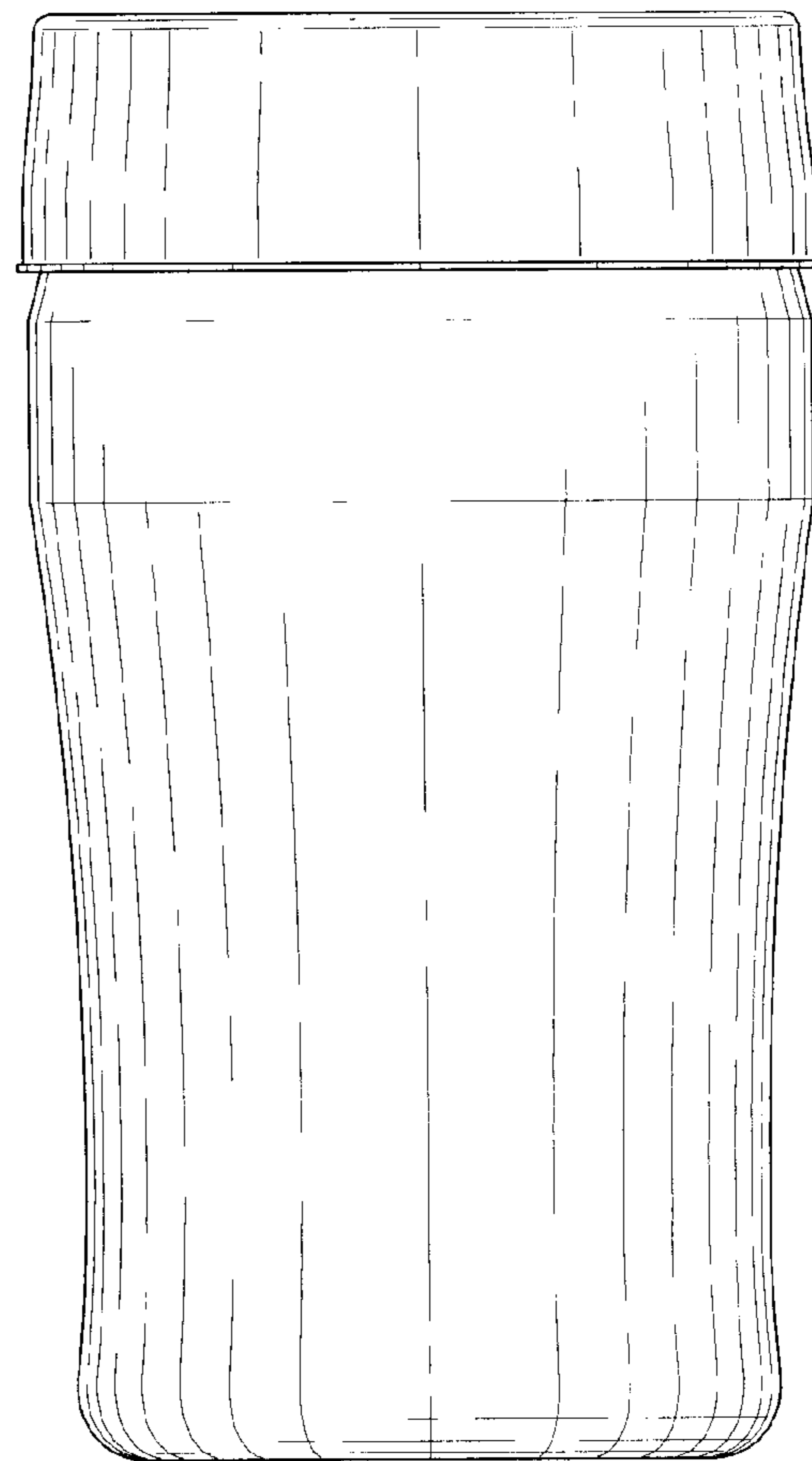

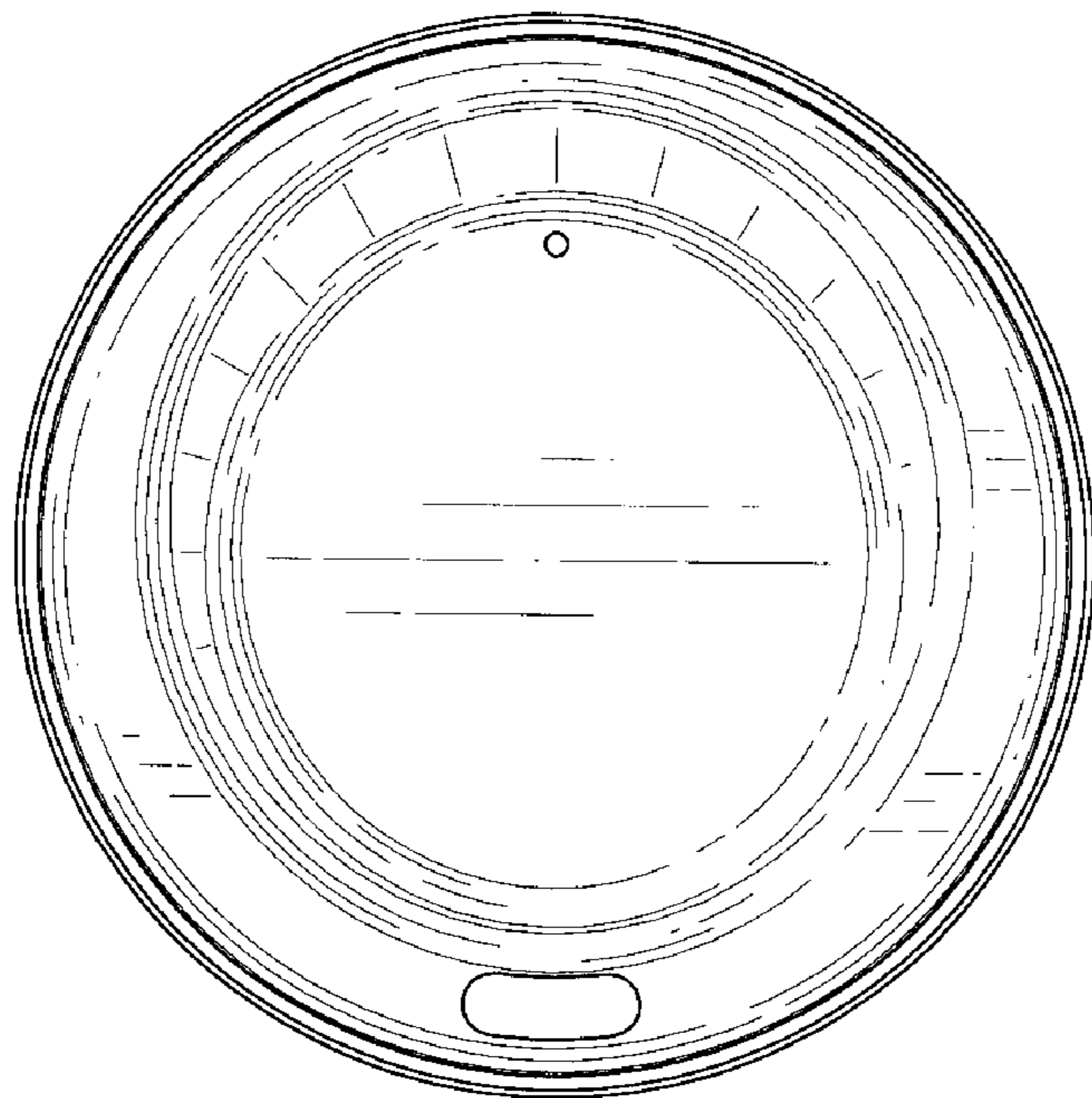

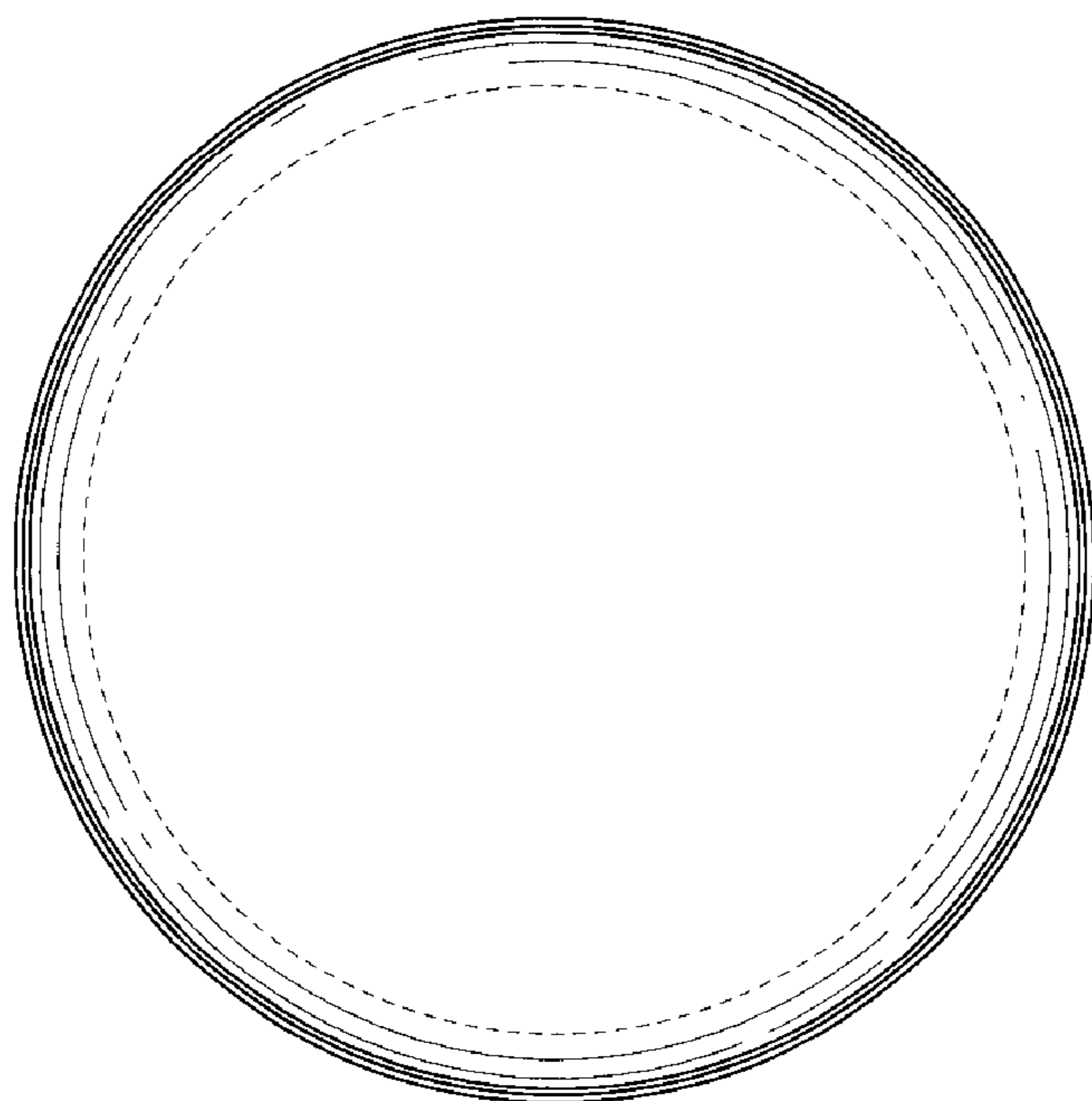
