8;

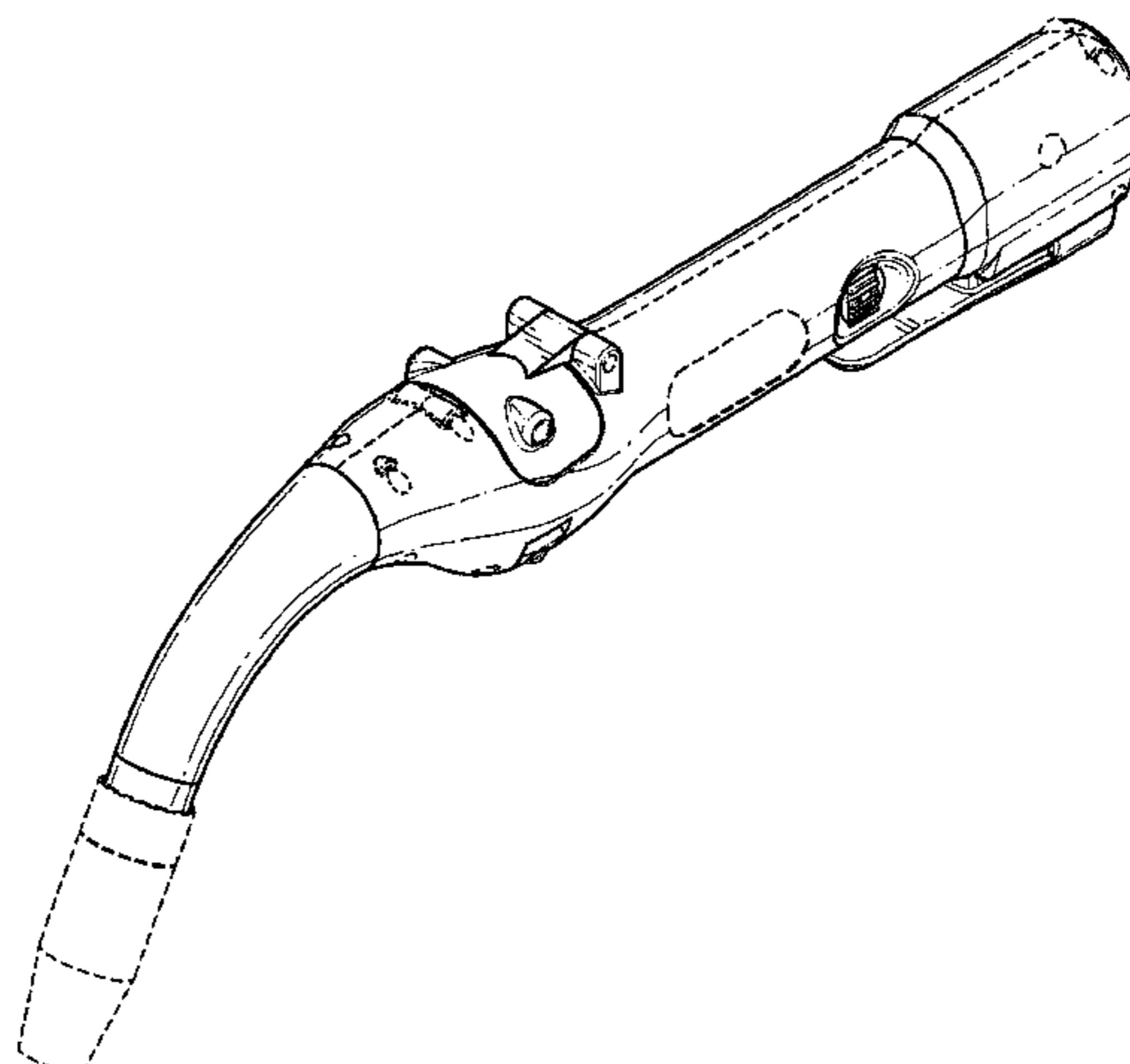
FIG. 12 is a bottom view of the welding gun as shown in

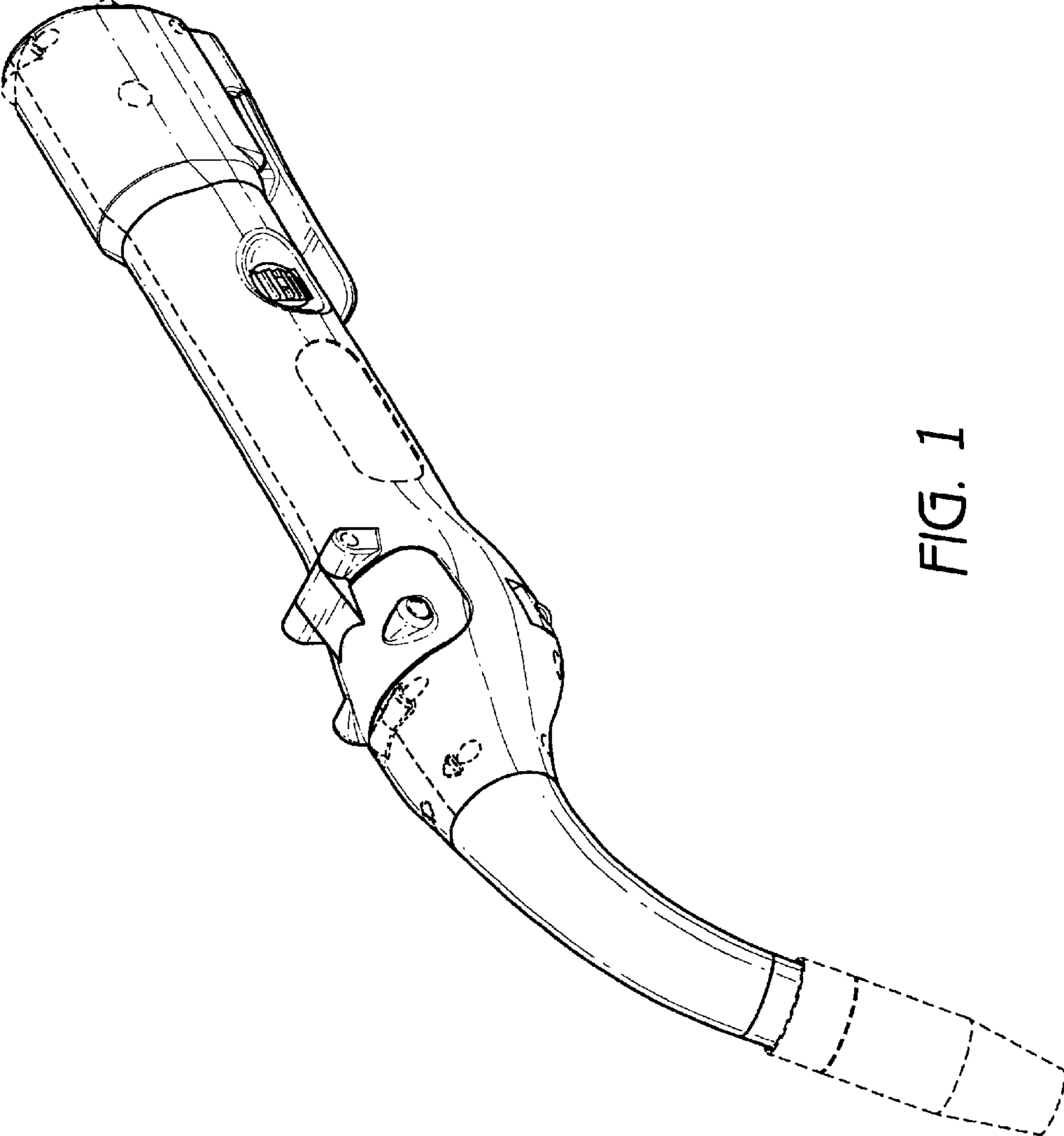

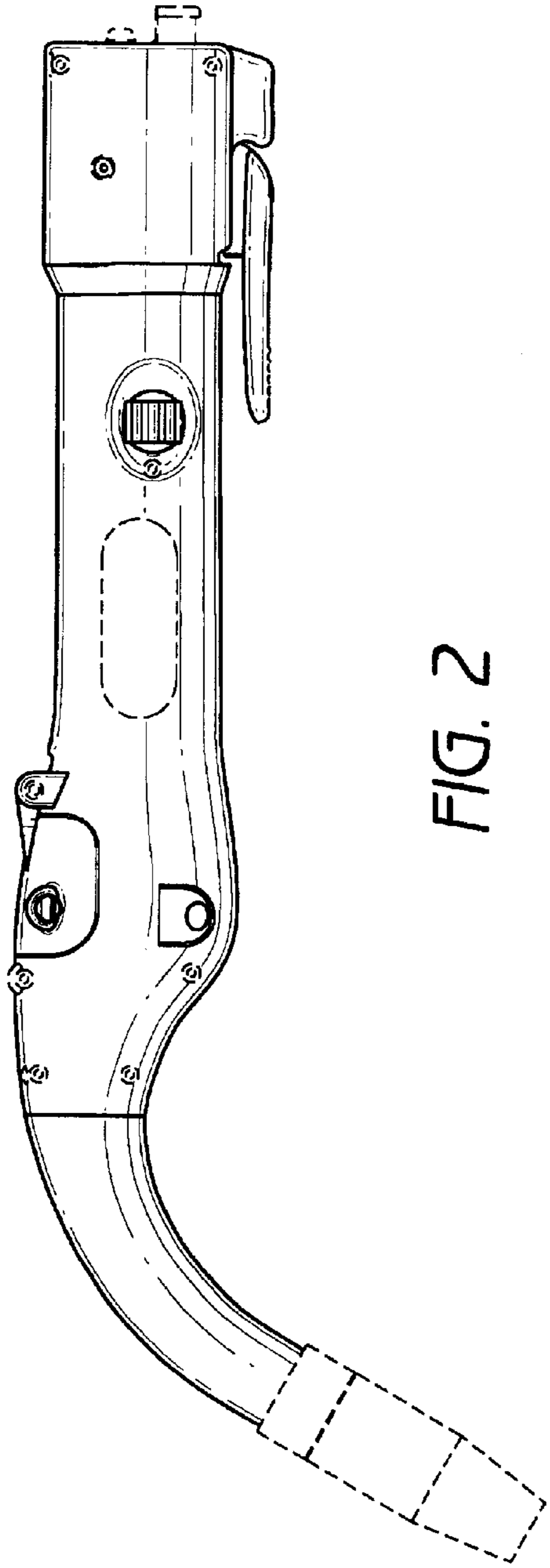

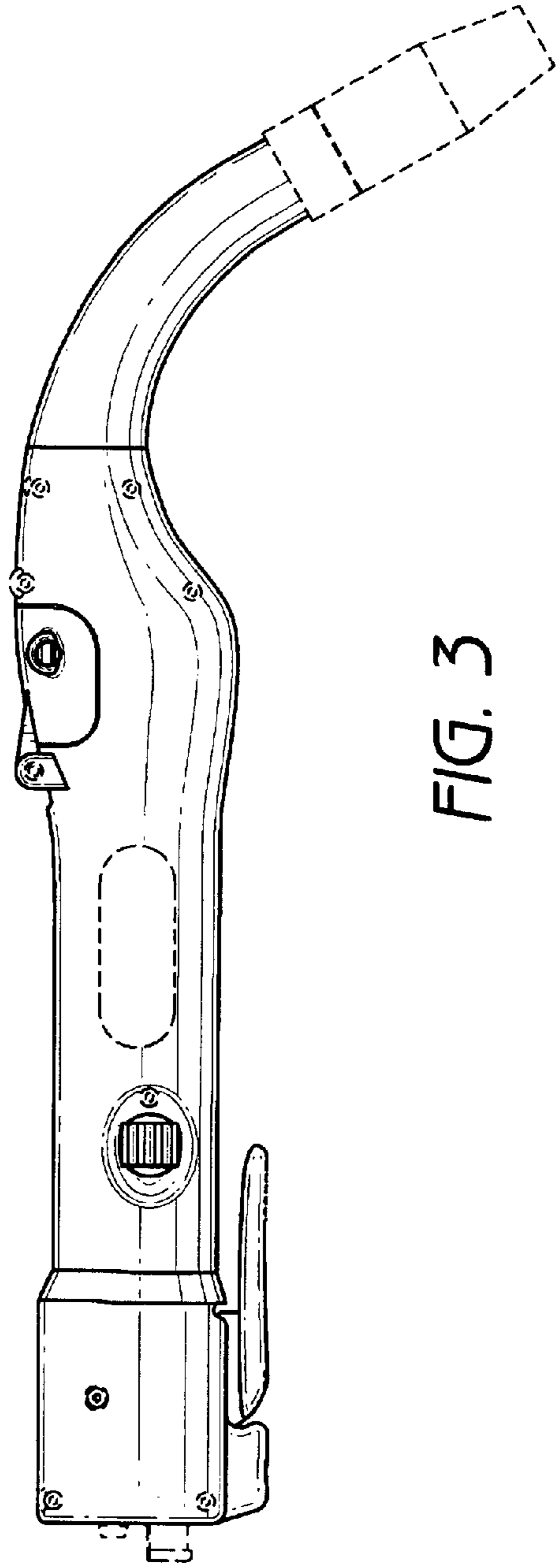

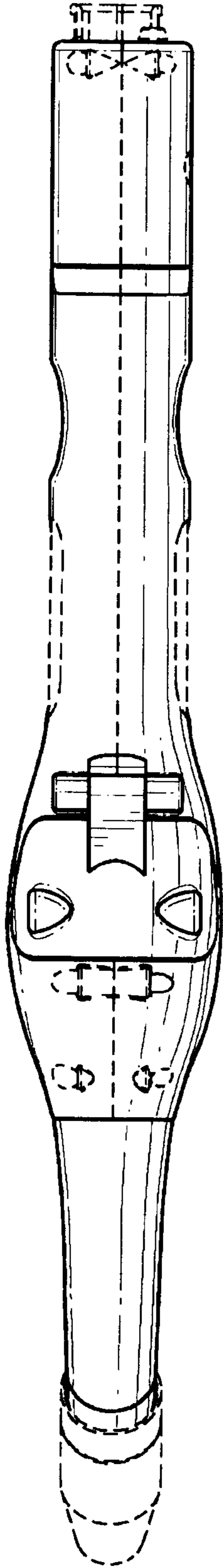

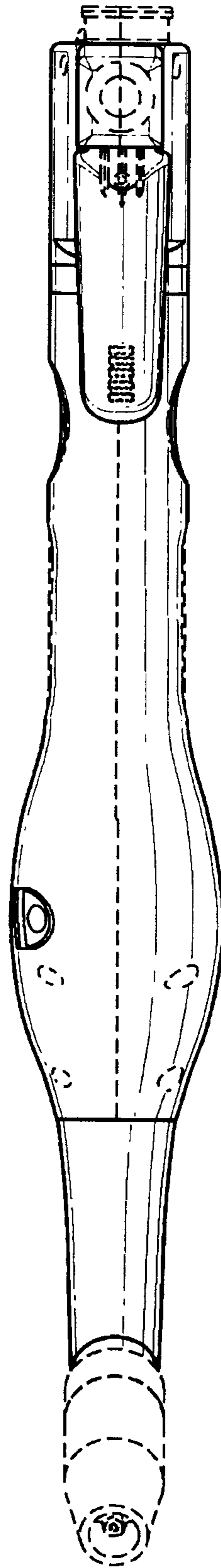

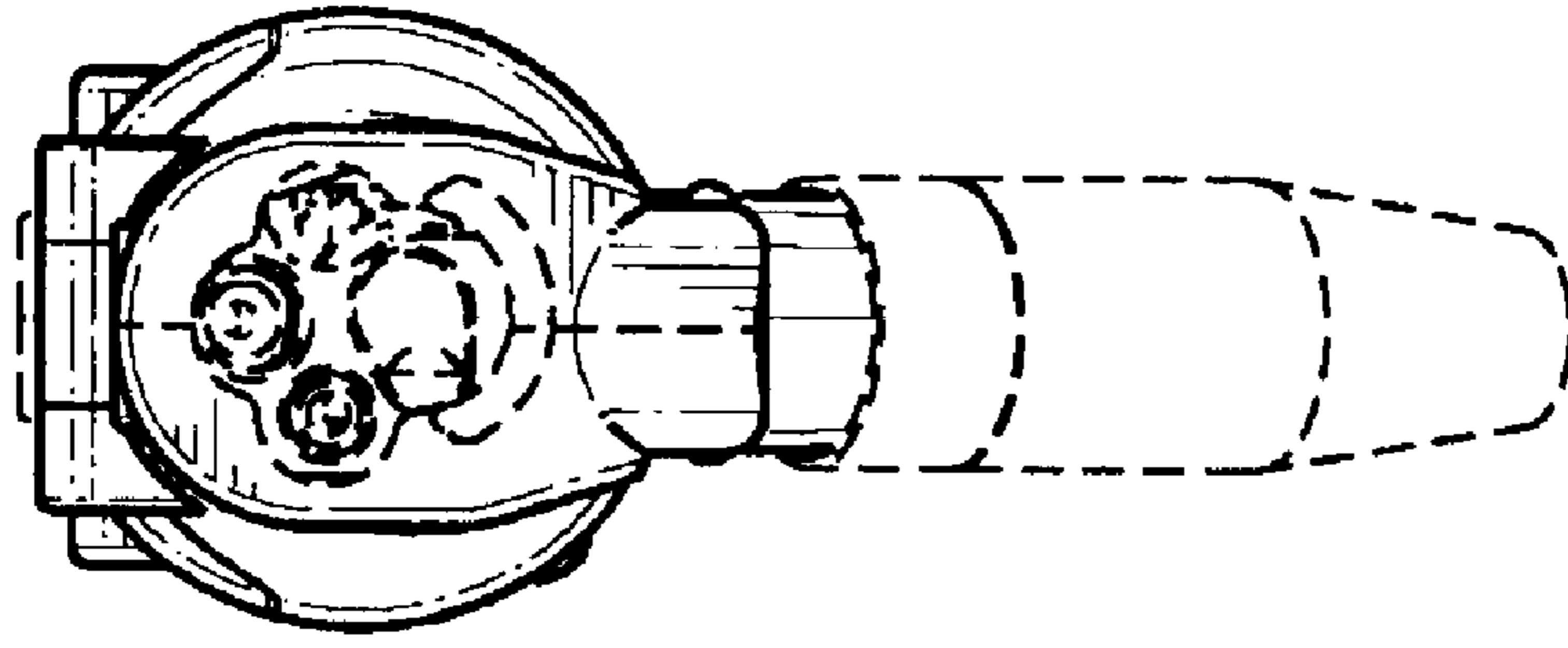

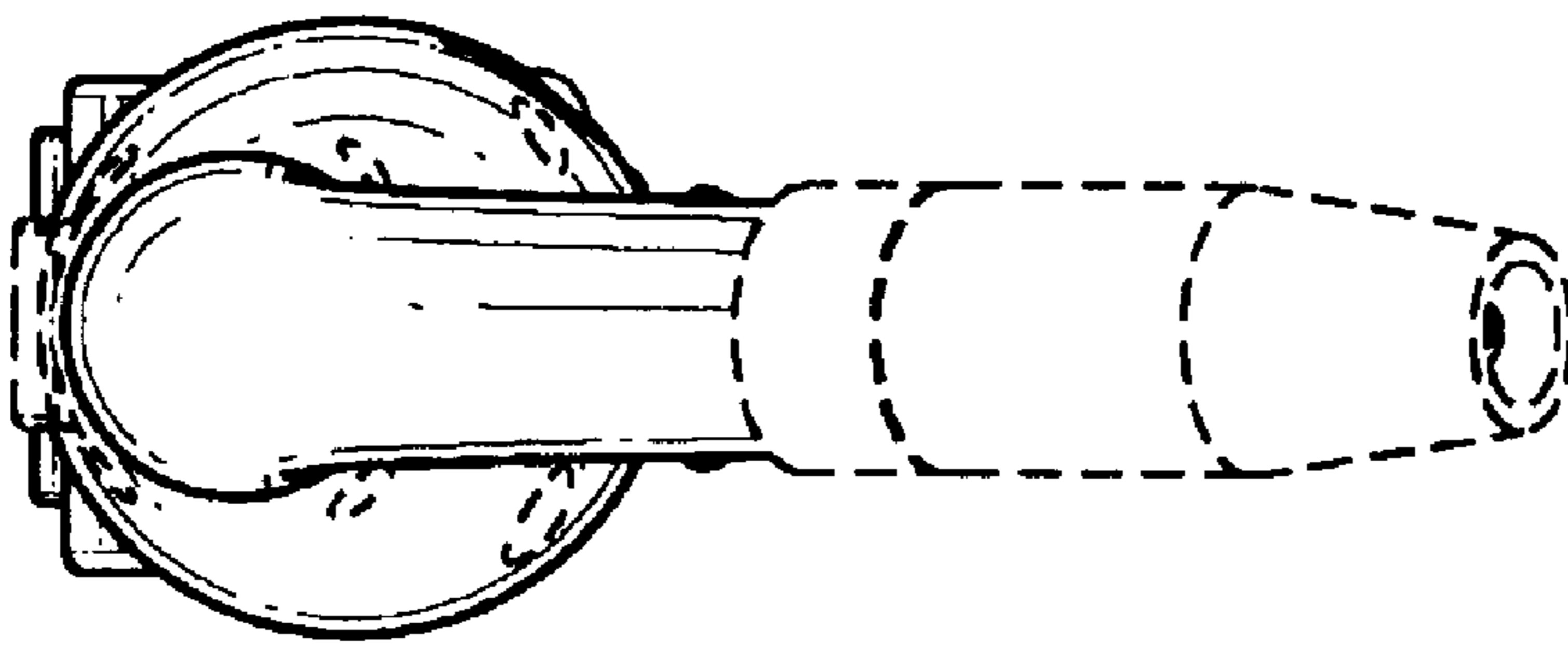

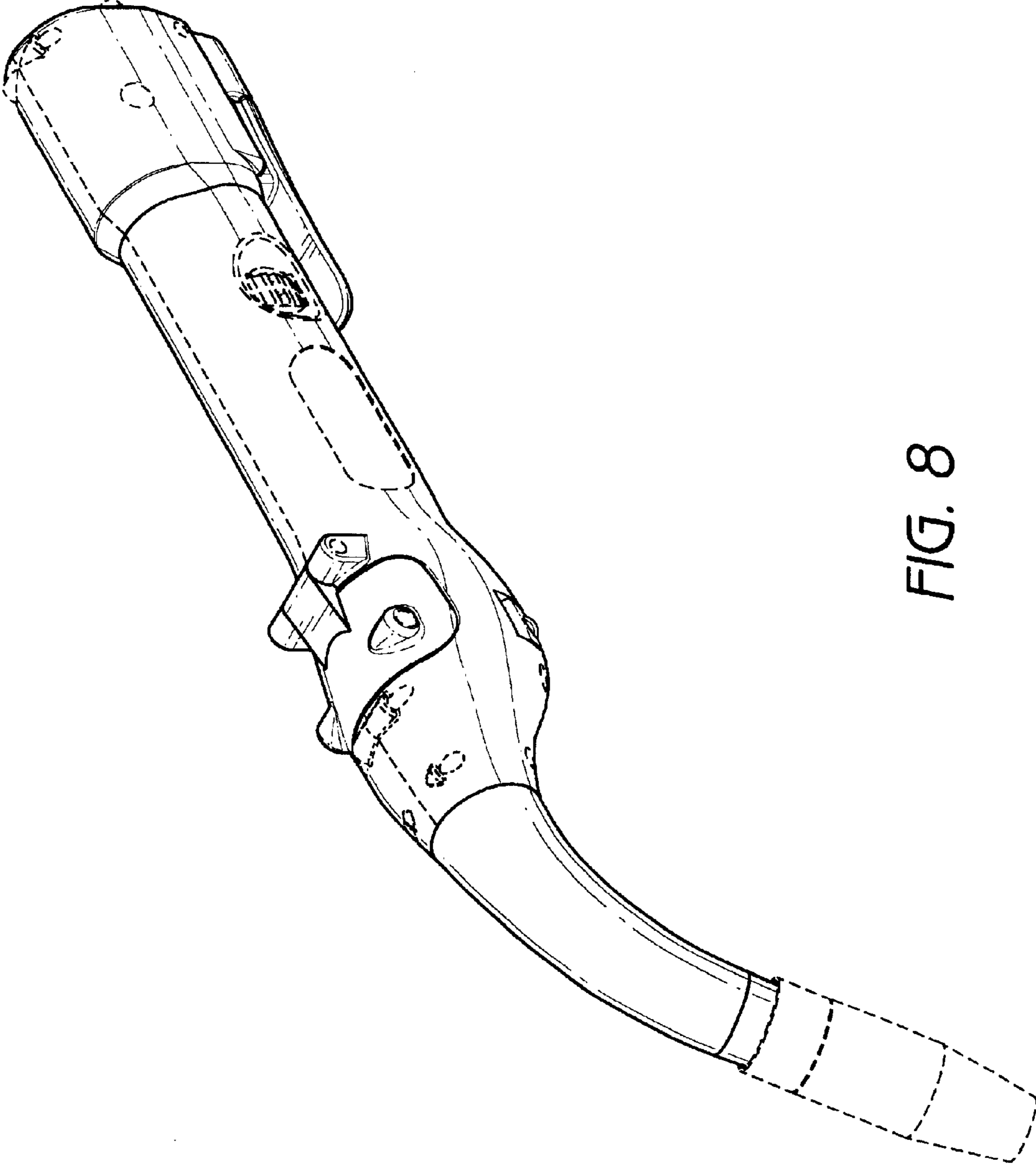
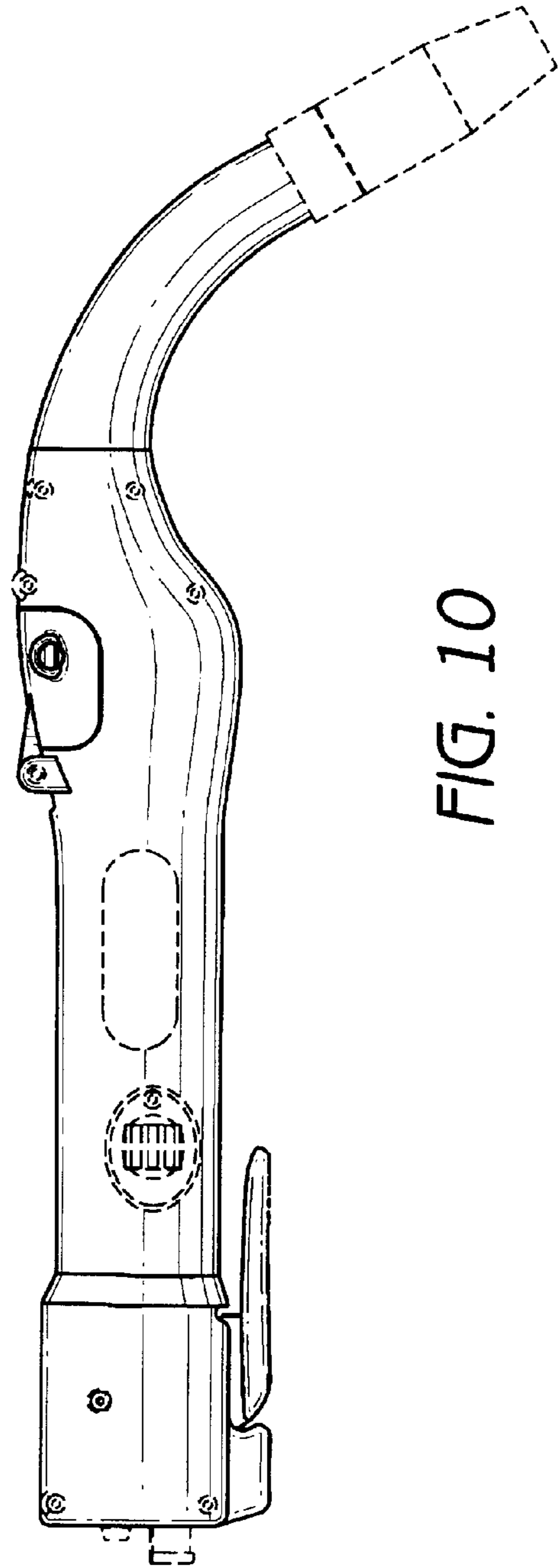
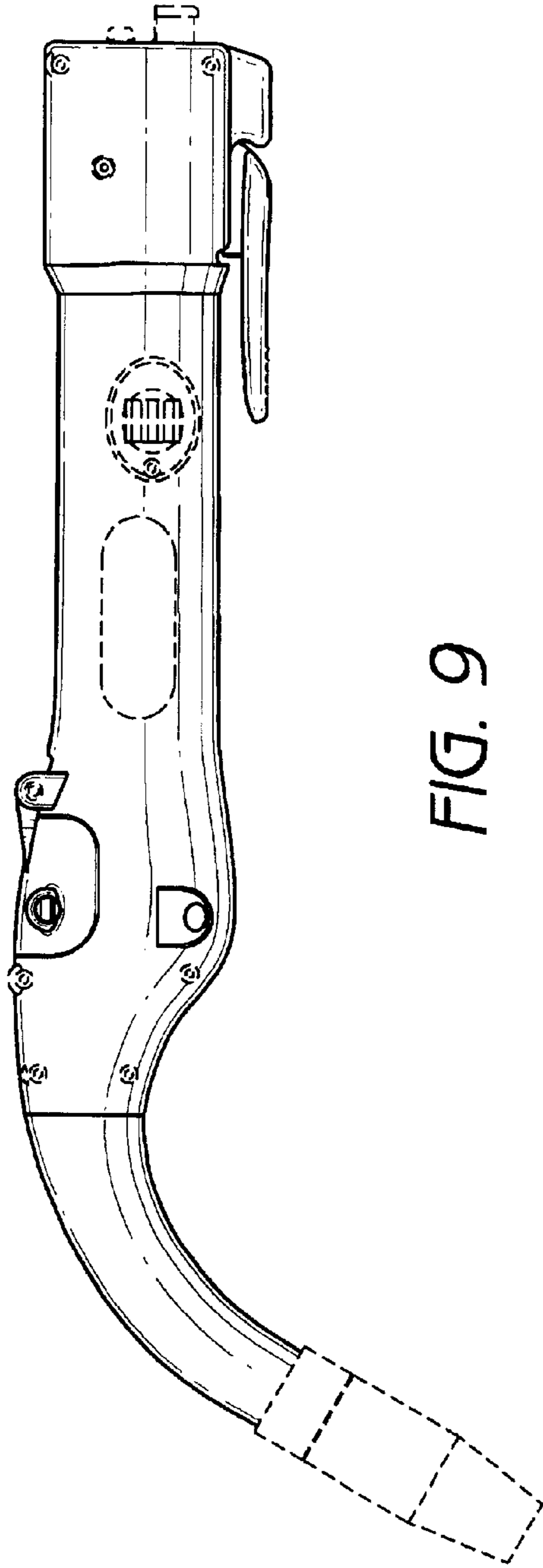

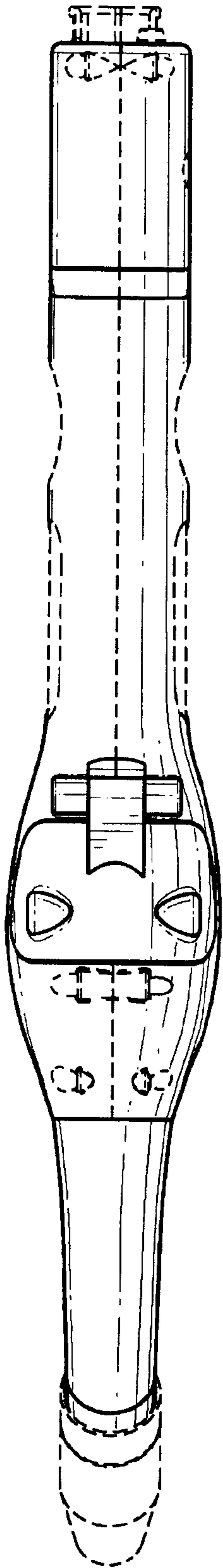

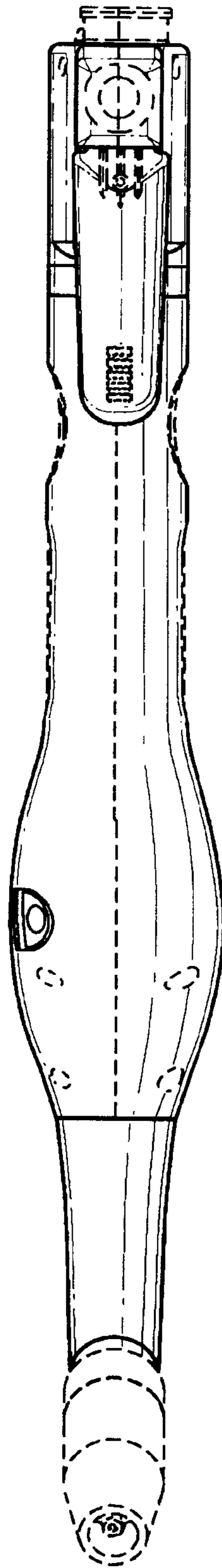

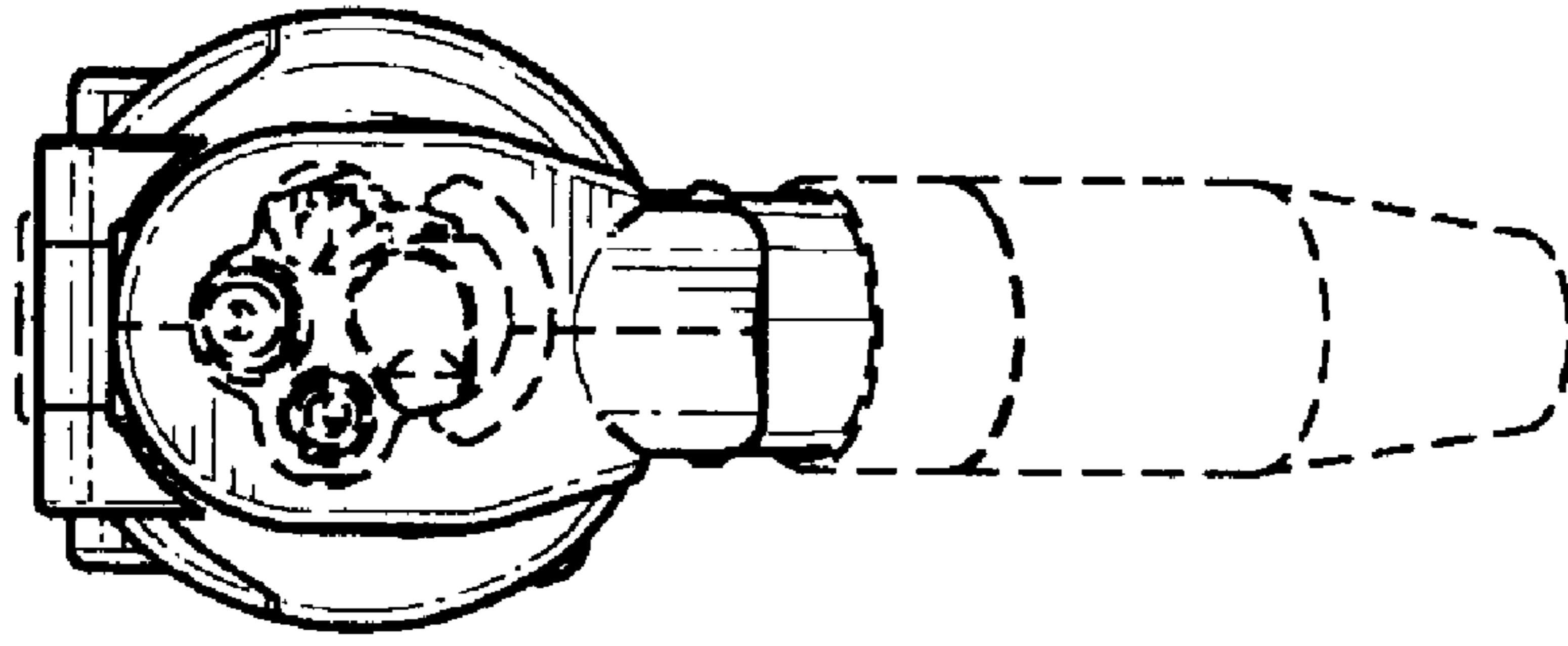

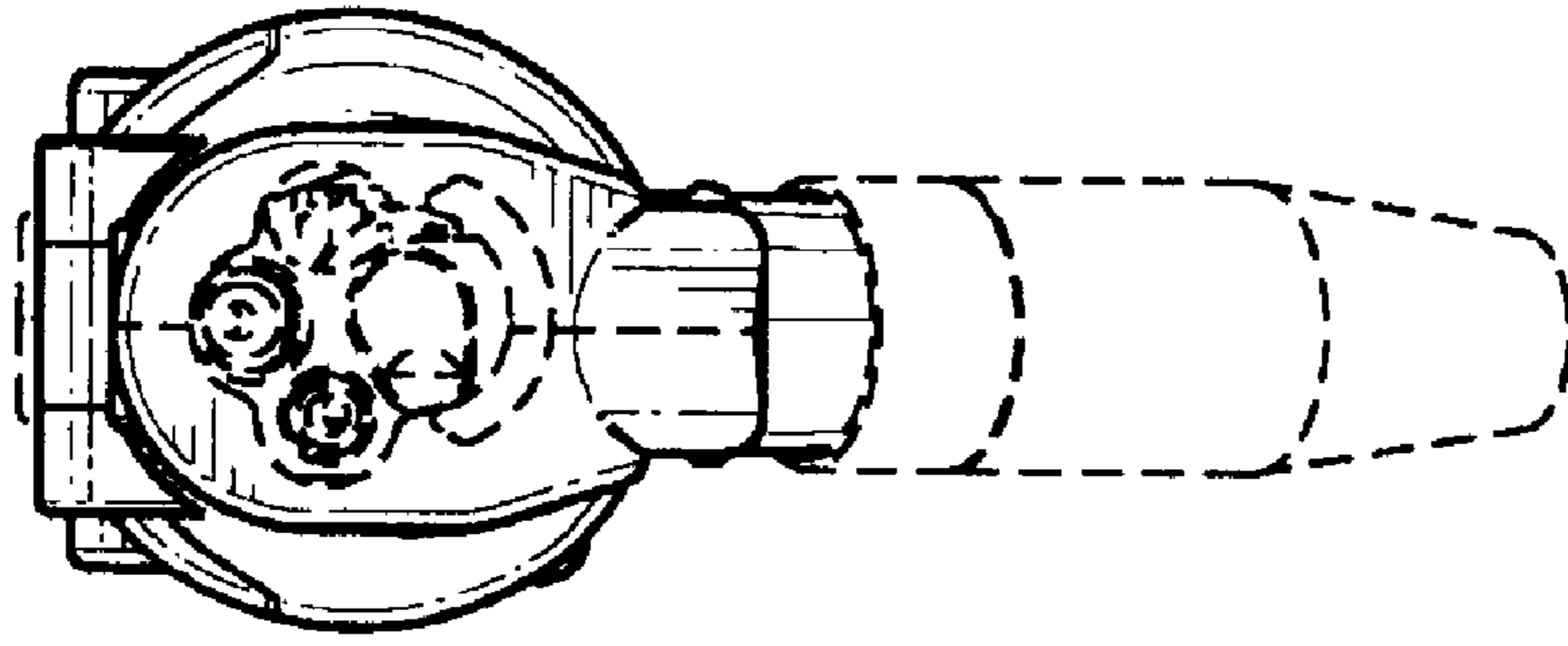
