We claim the ornamental design for a tool grip, as shown and described.

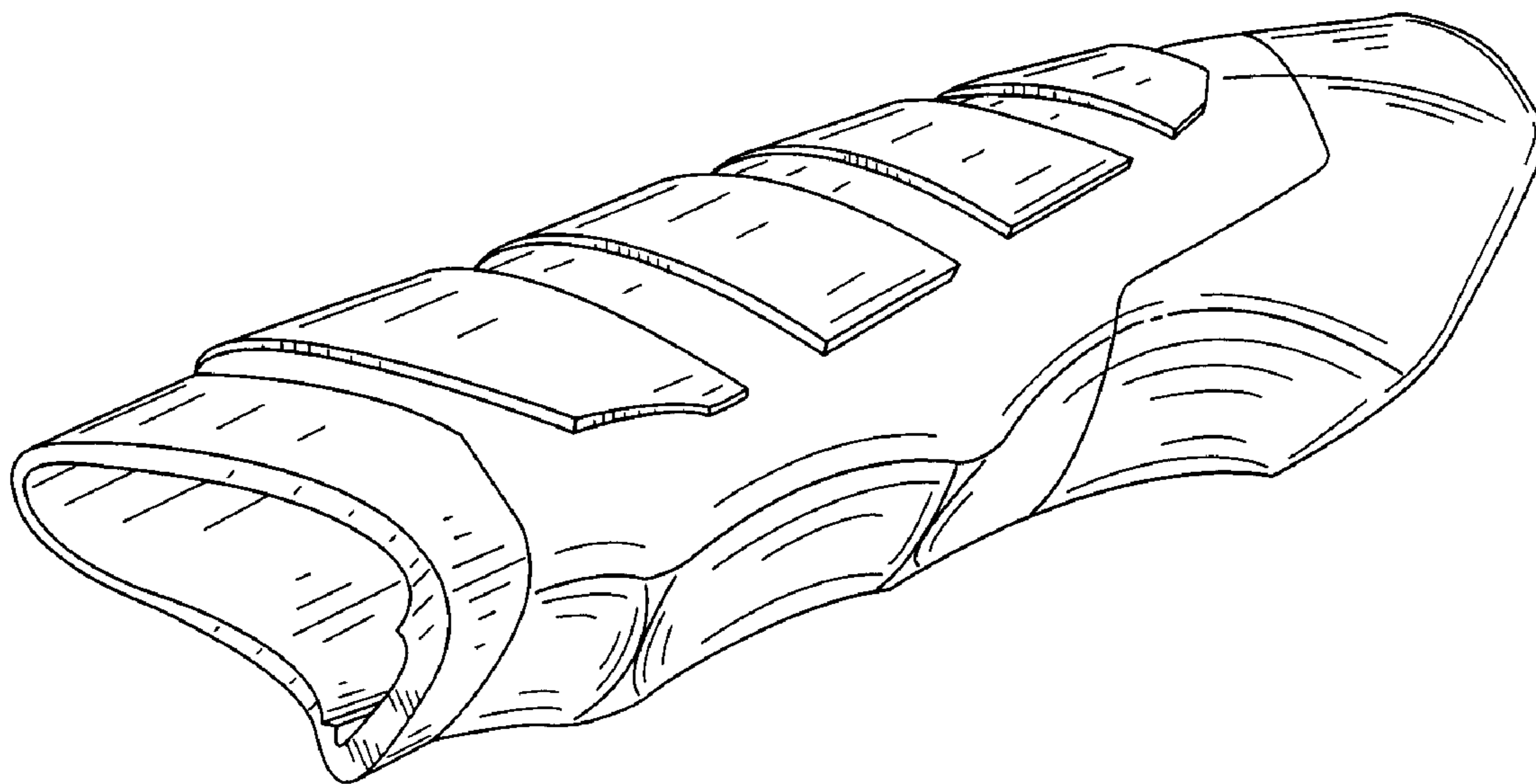
**DESCRIPTION**

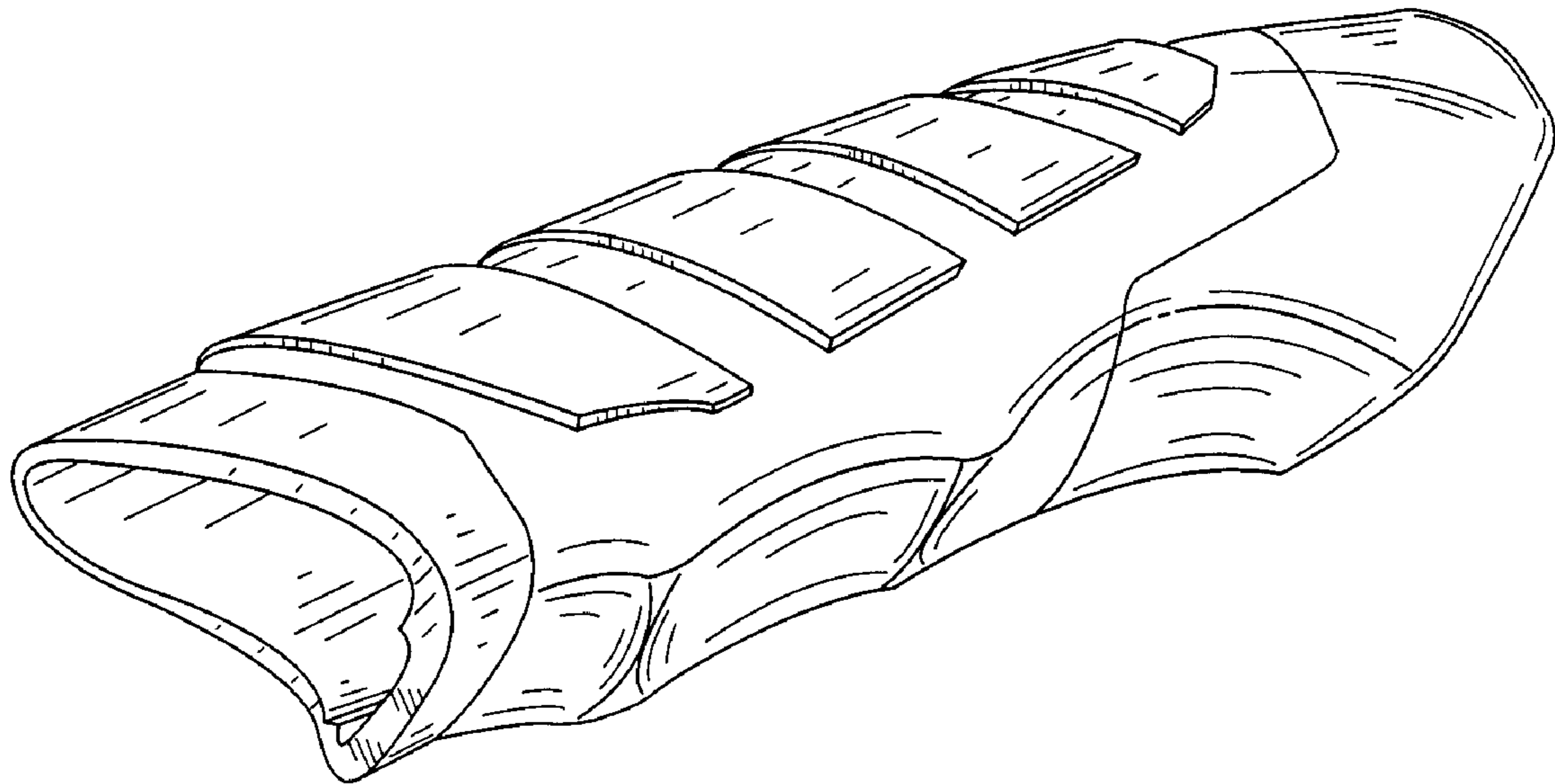
FIG. 1 is a perspective view showing our new design for a tool grip;

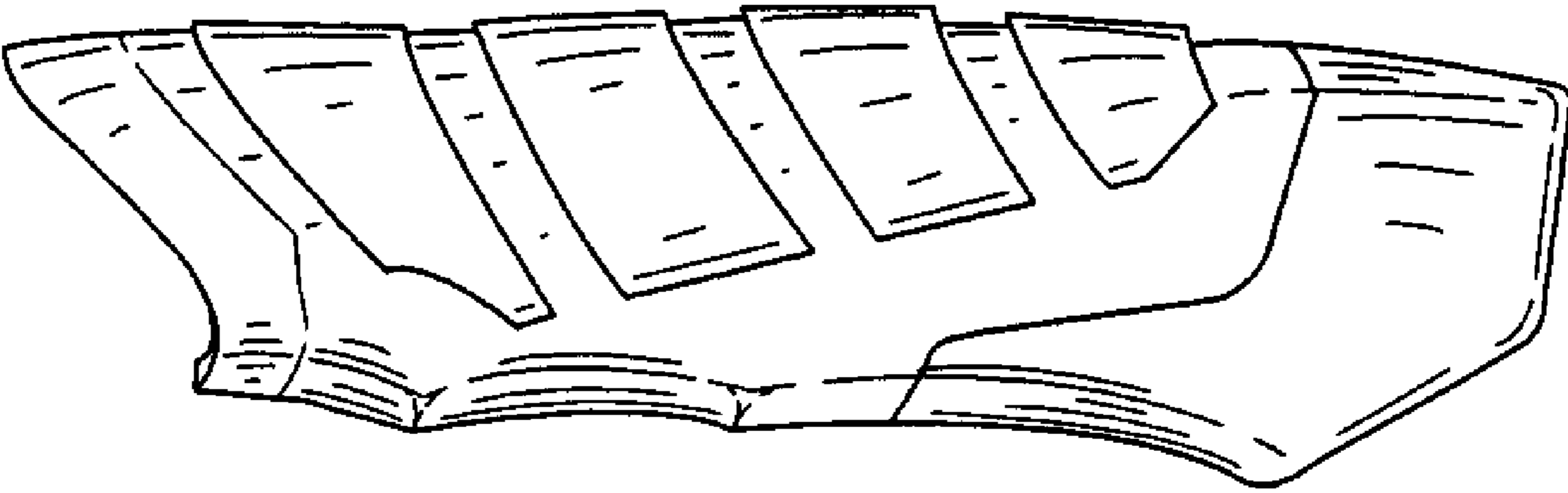

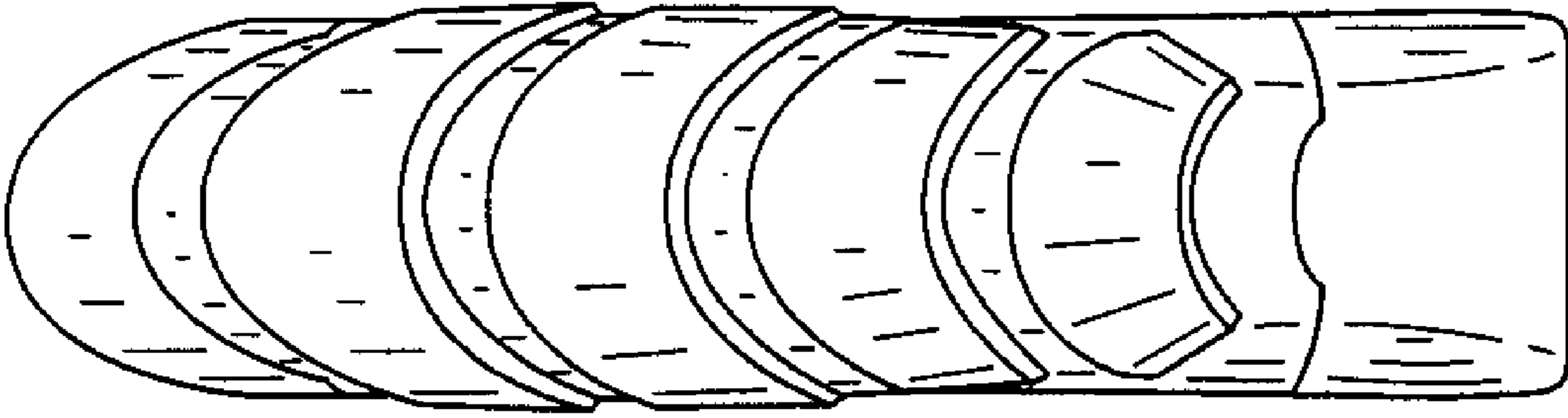




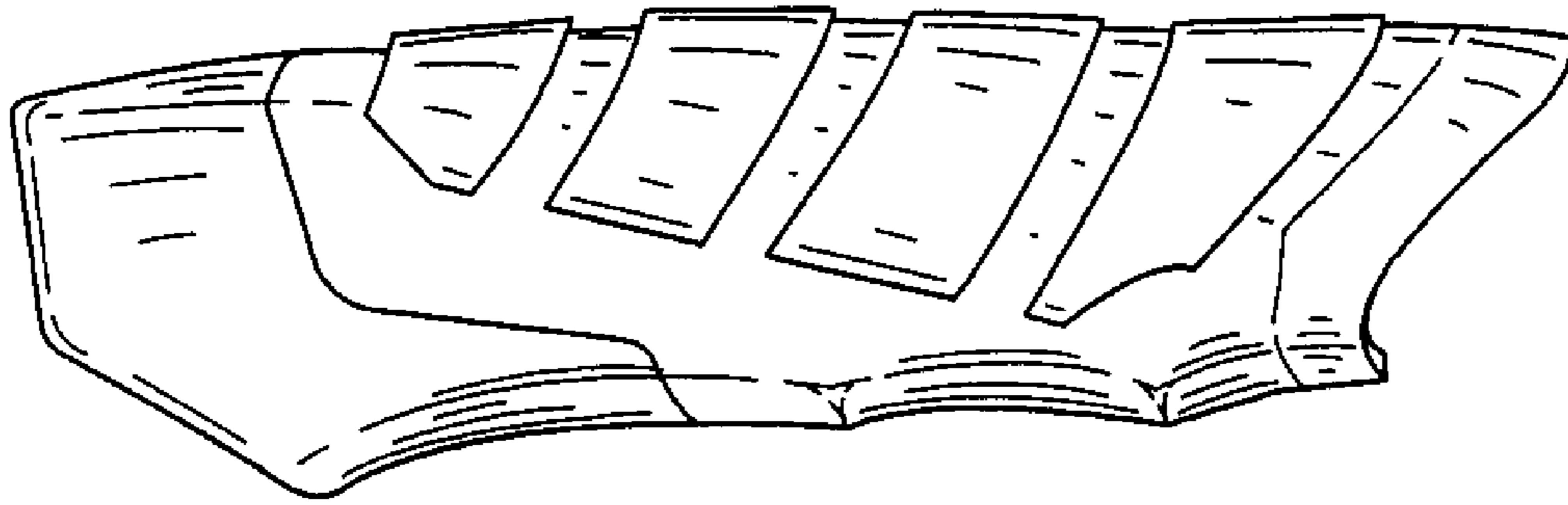

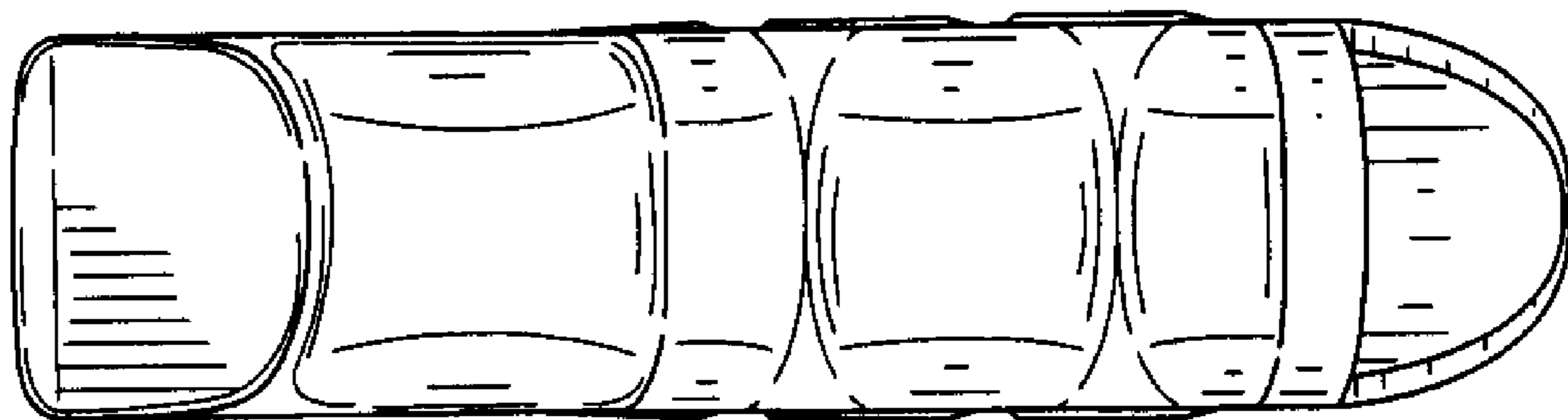

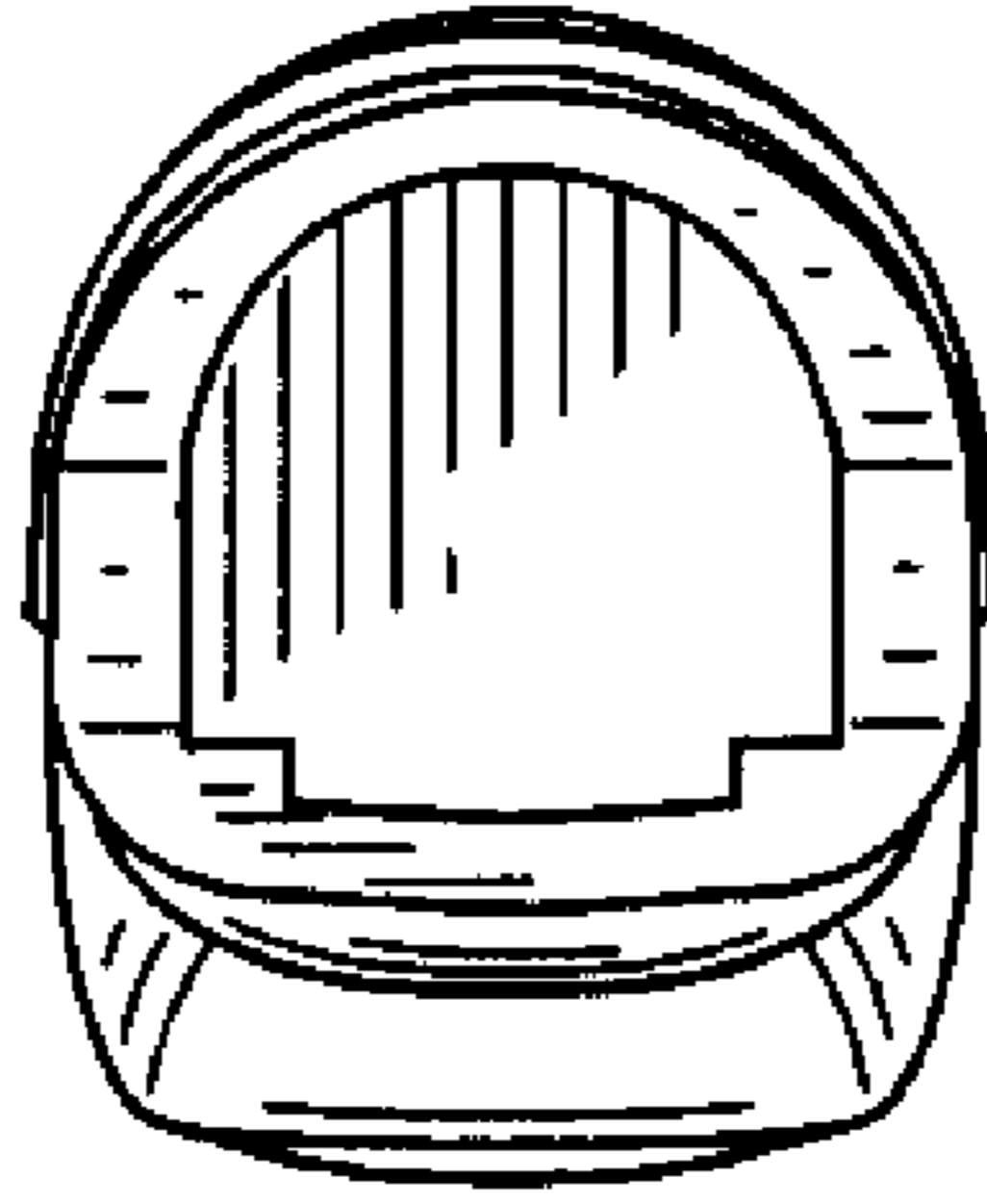

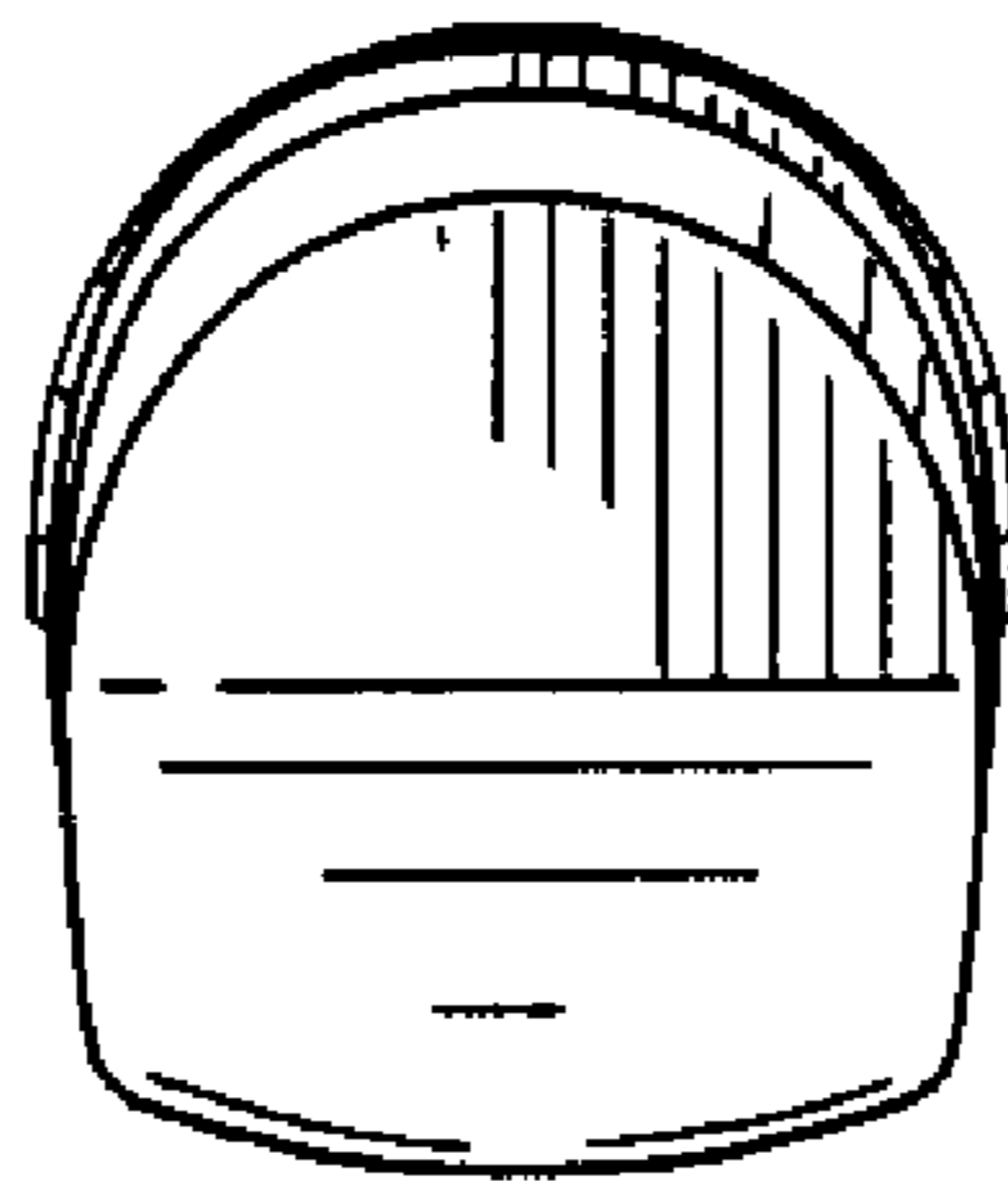
