(57) **CLAIM**

The ornamental design for a vehicle grille, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a vehicle grille attached to a vehicle, no part of the vehicle is claimed;

FIG. 2 is a perspective view of the vehicle grille;

FIG. 3 is a front elevational view of the vehicle grille;

FIG. 4 is a top plan view of the vehicle grille;

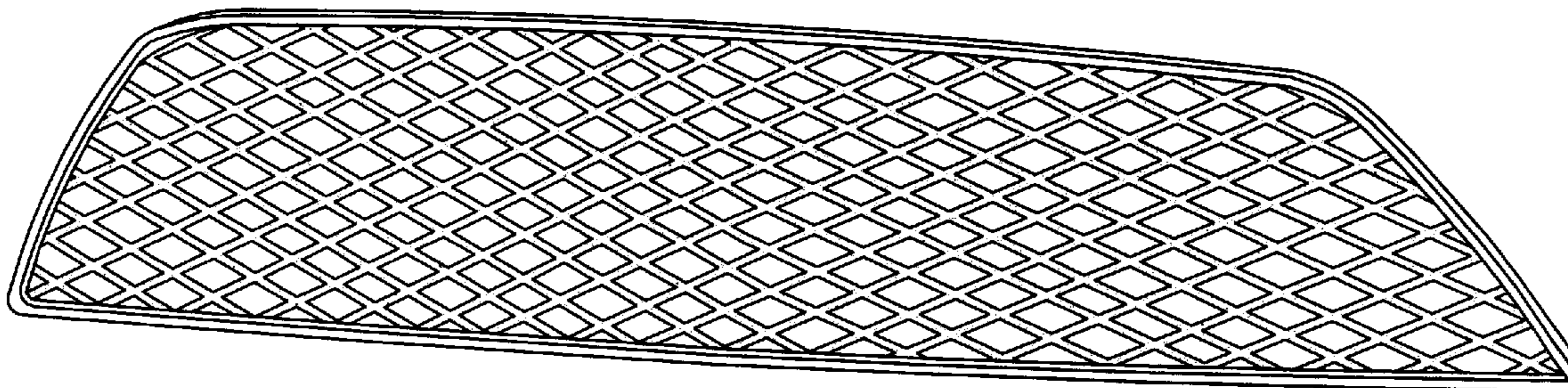
FIG. 5 is a right side elevational view of the vehicle grille; and

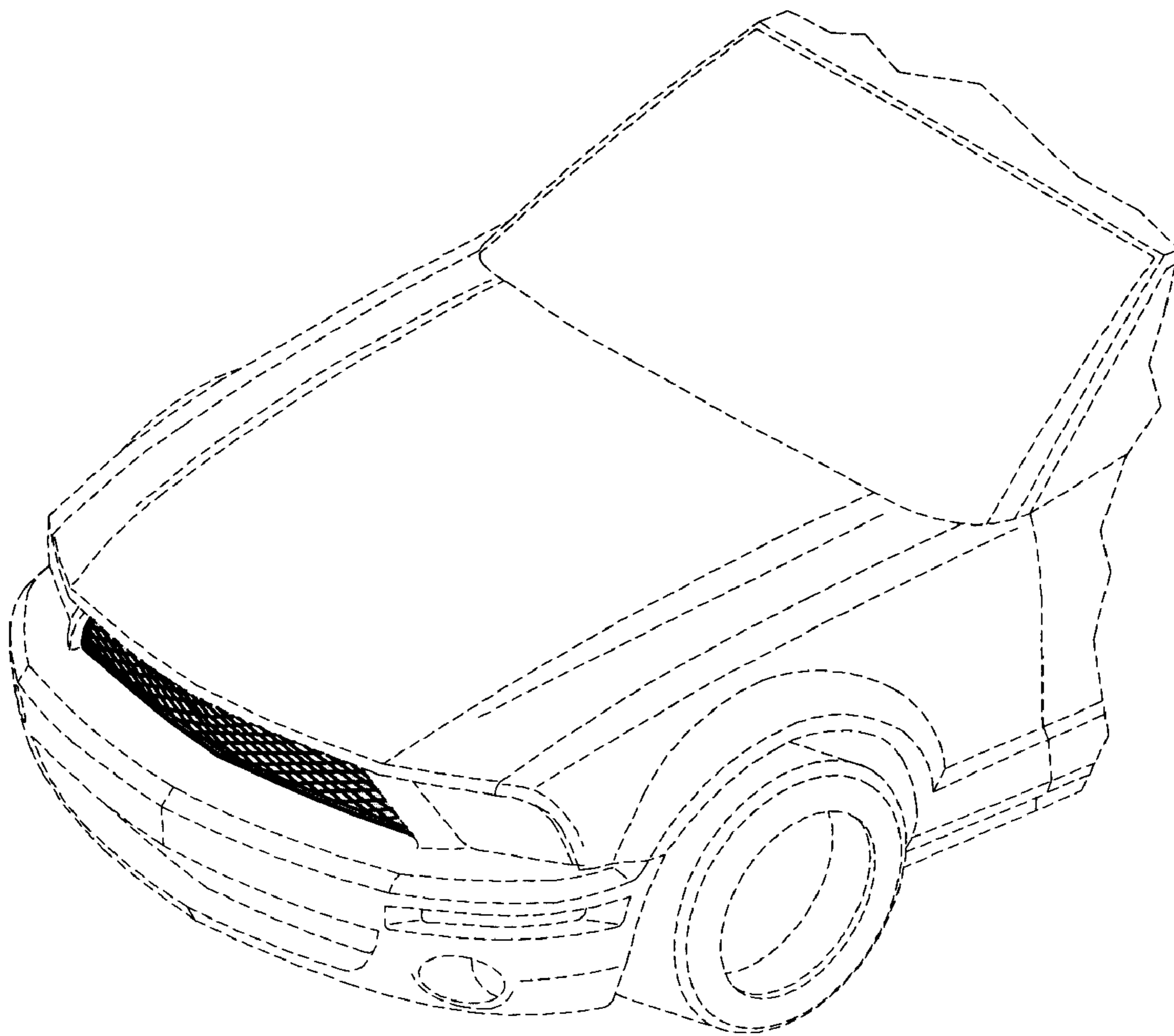

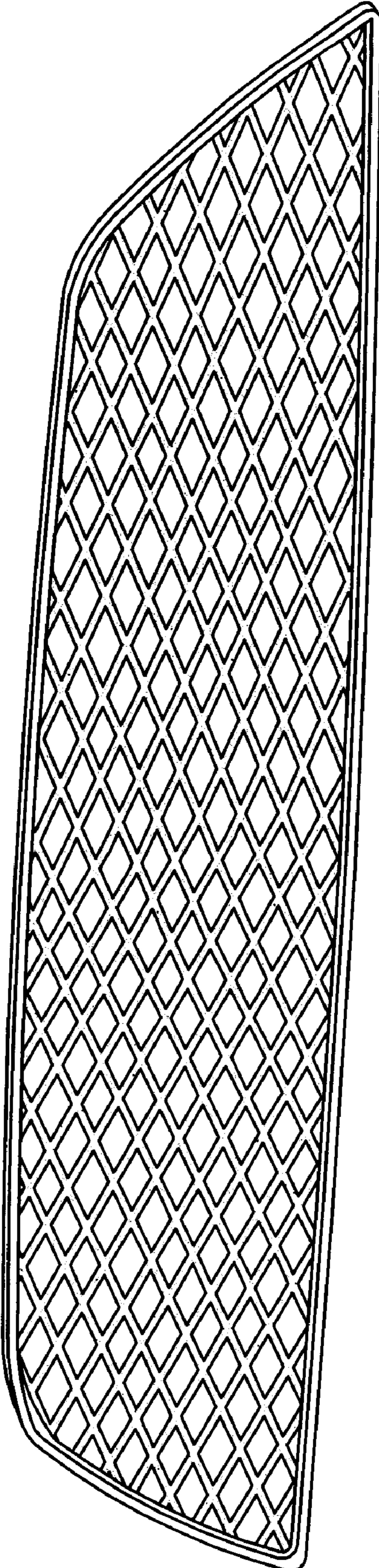

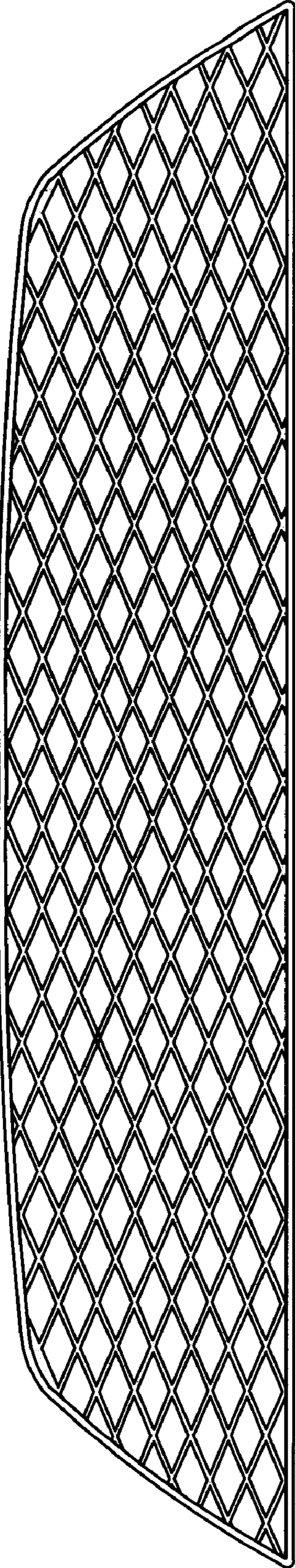

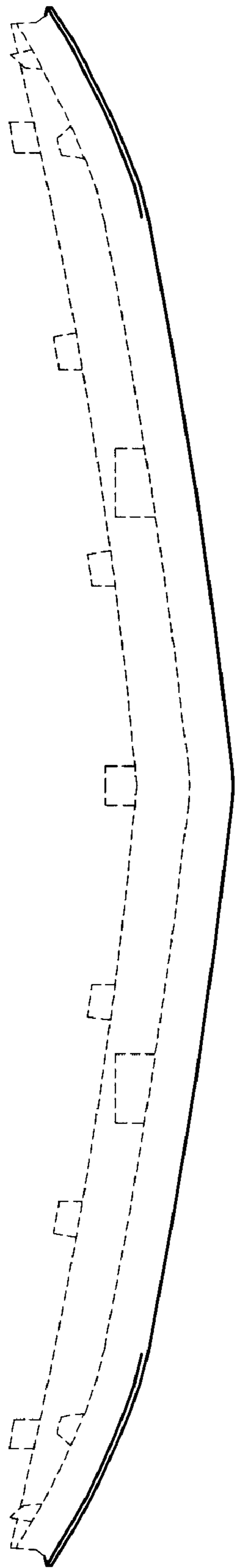

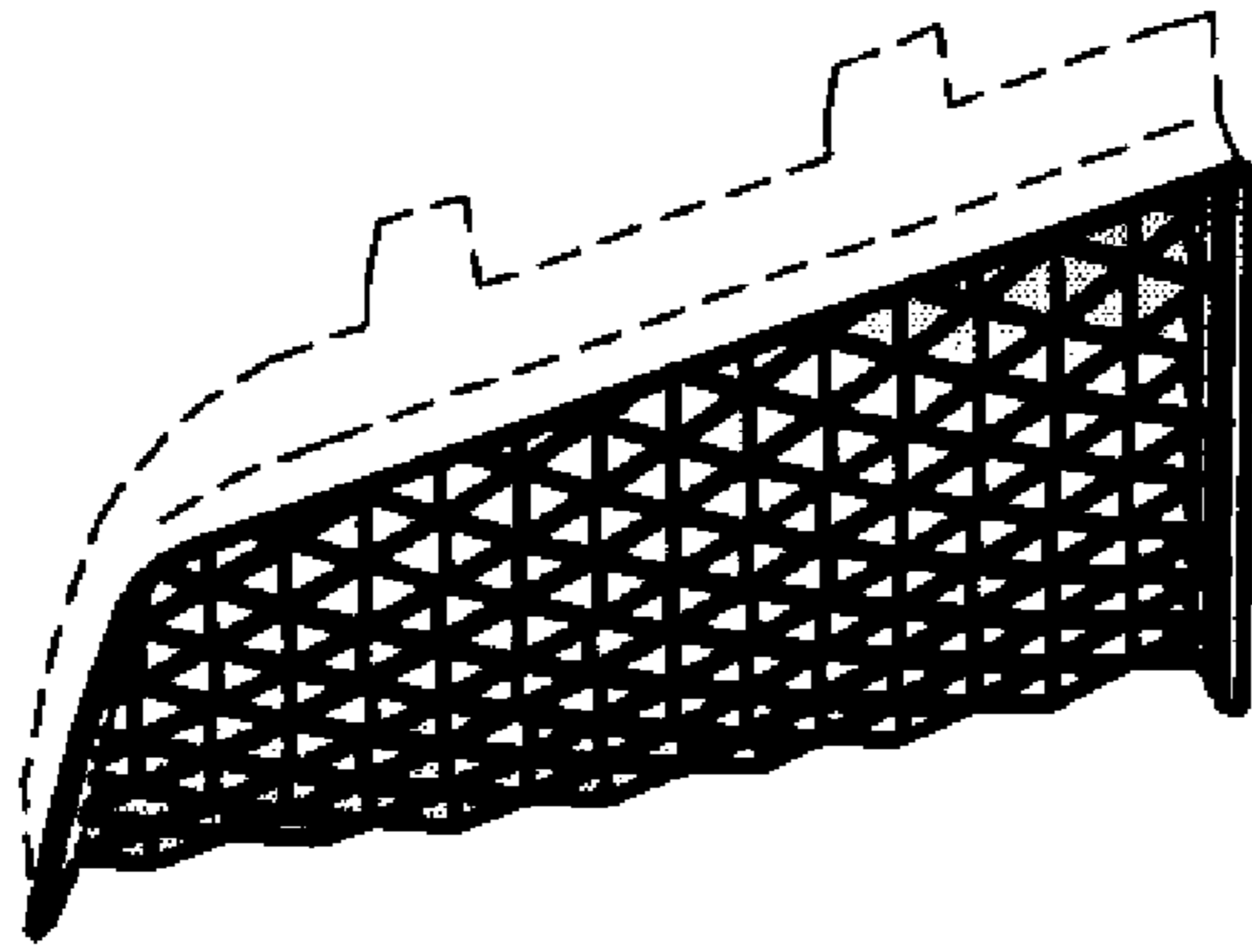

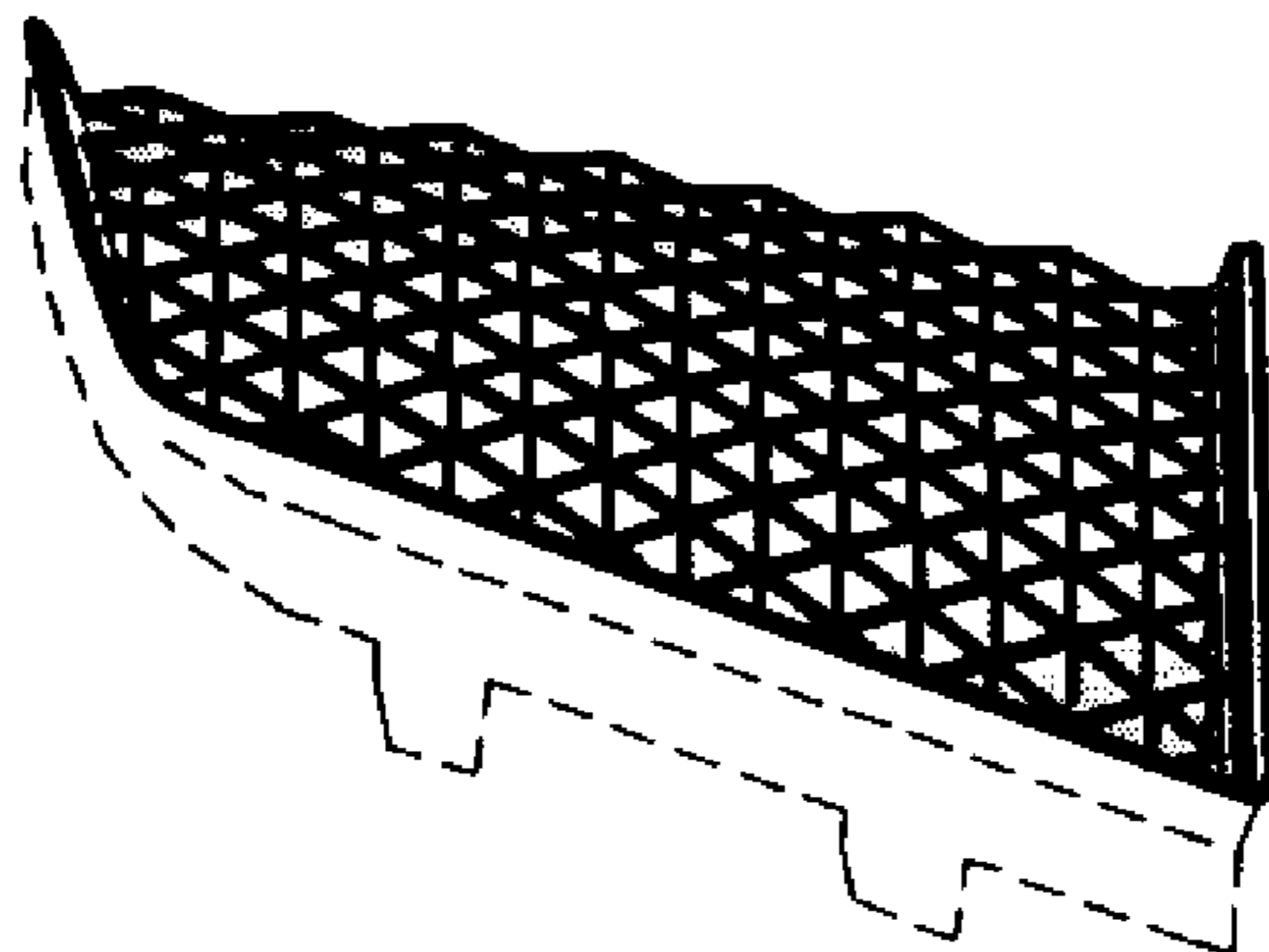

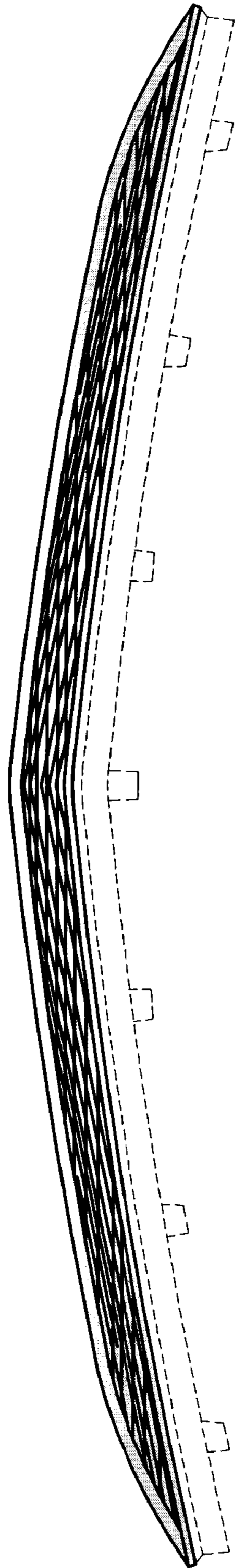
