**DESCRIPTION**

FIG. 1 is a perspective view of an MP3 player showing my new design;

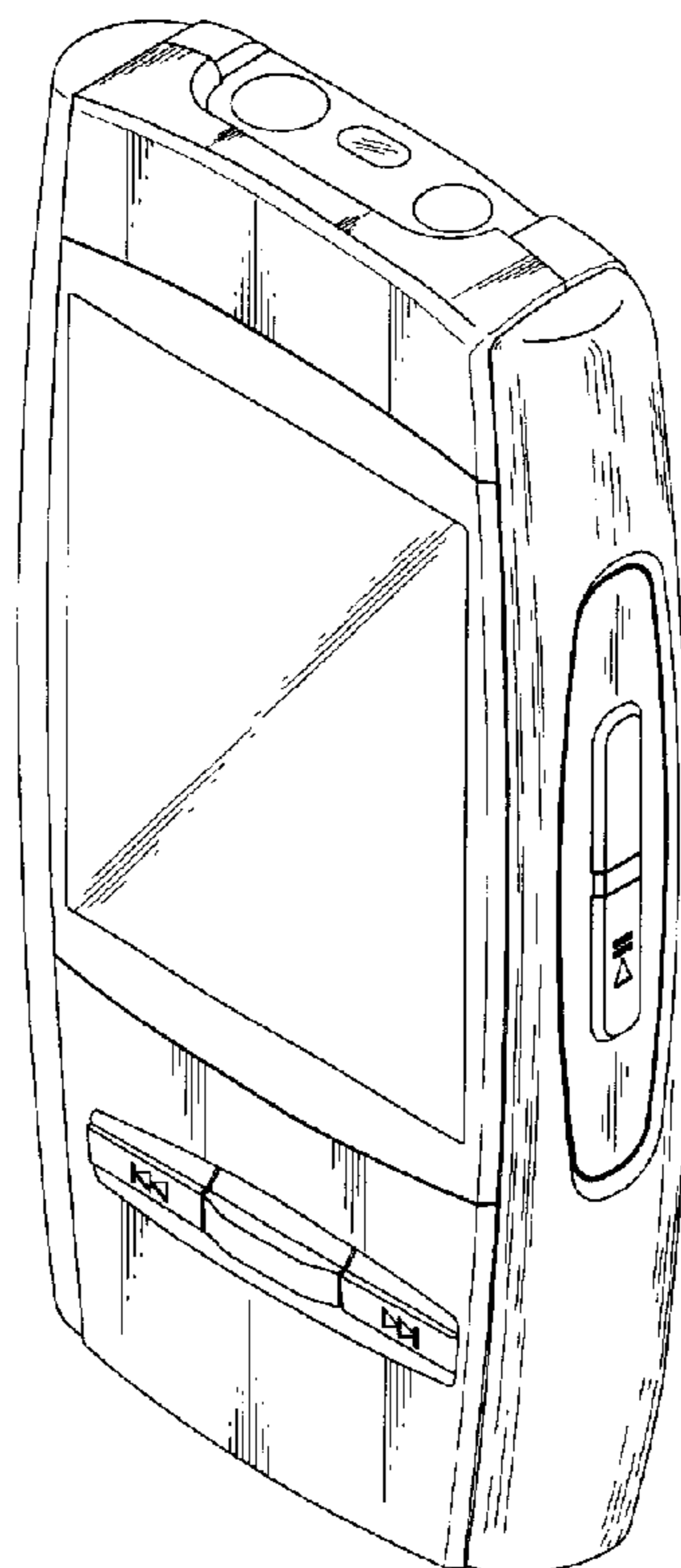

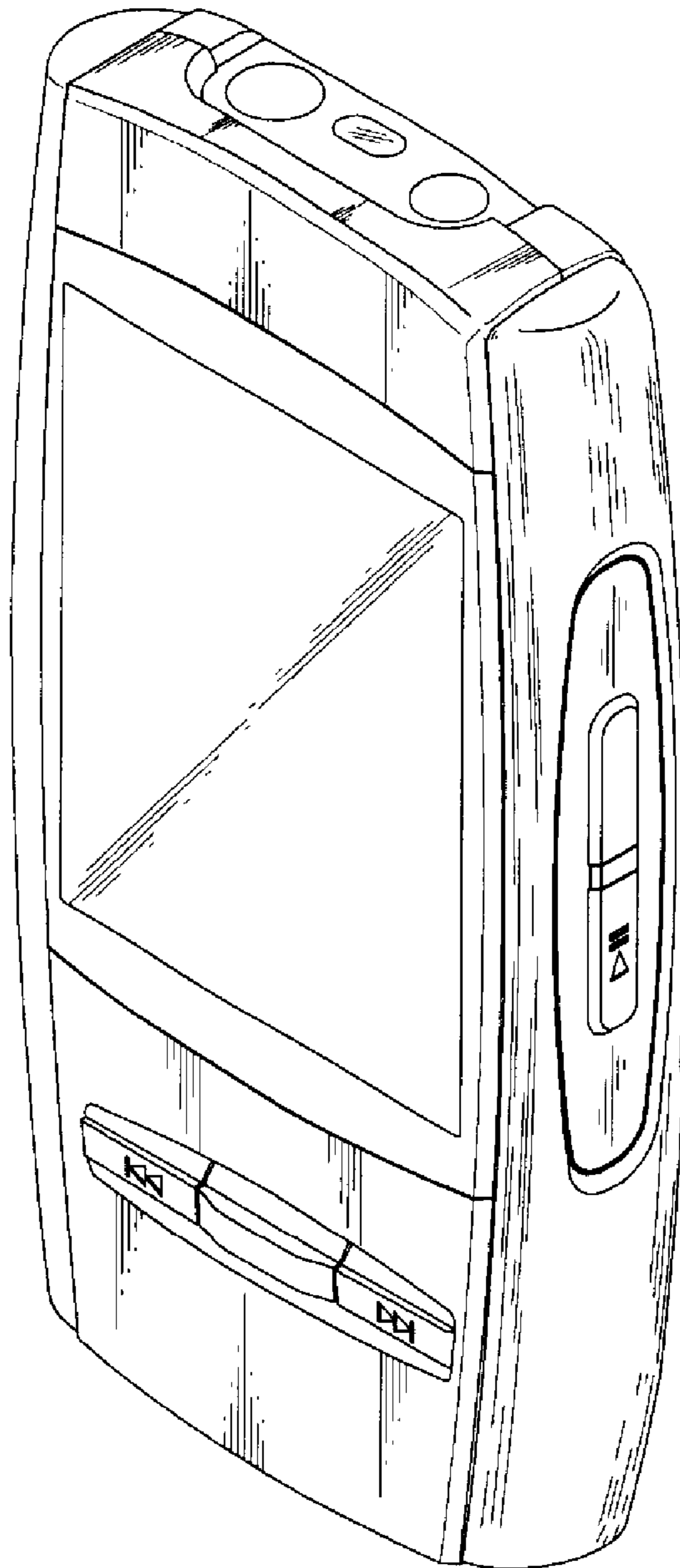

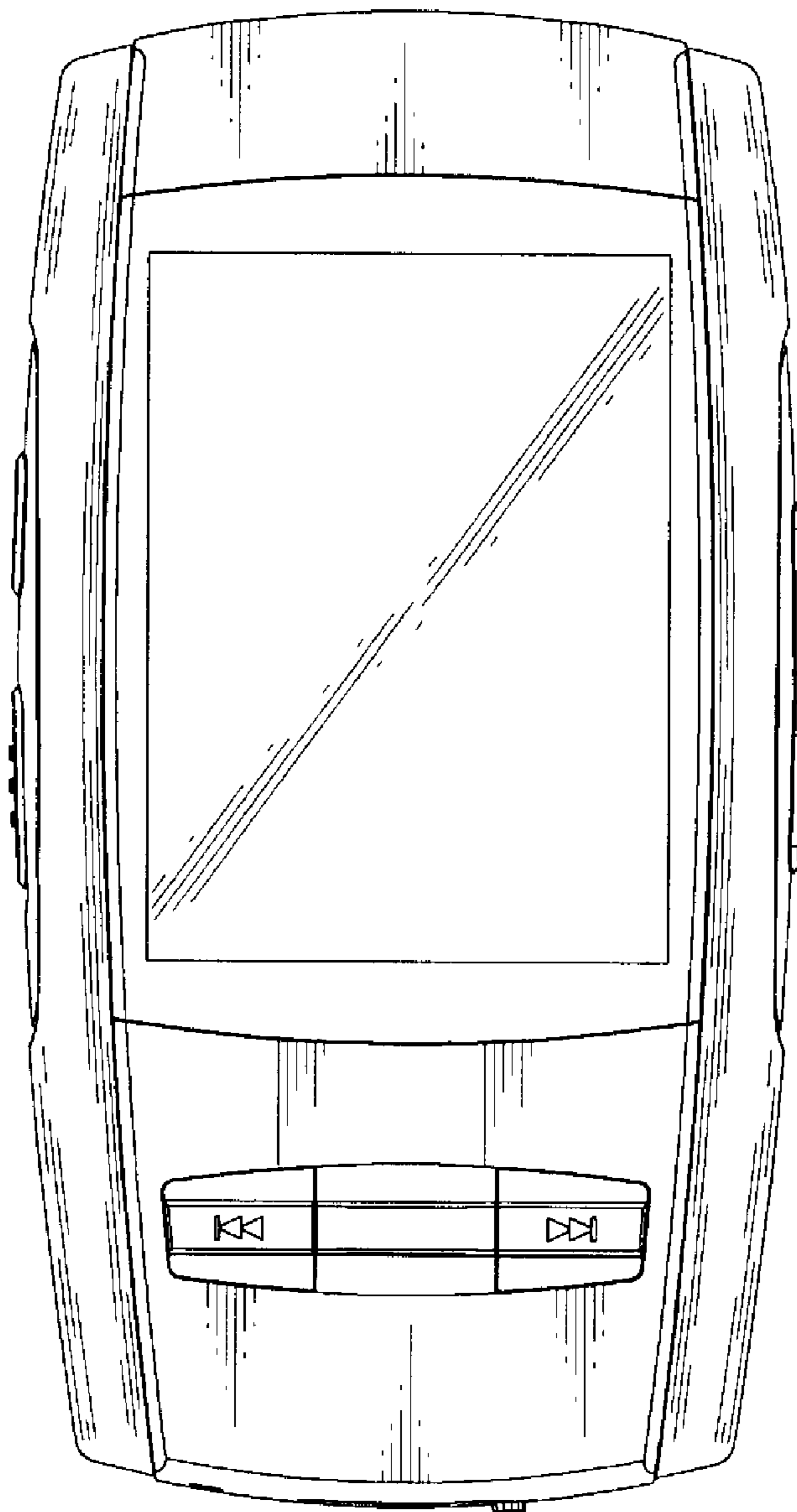

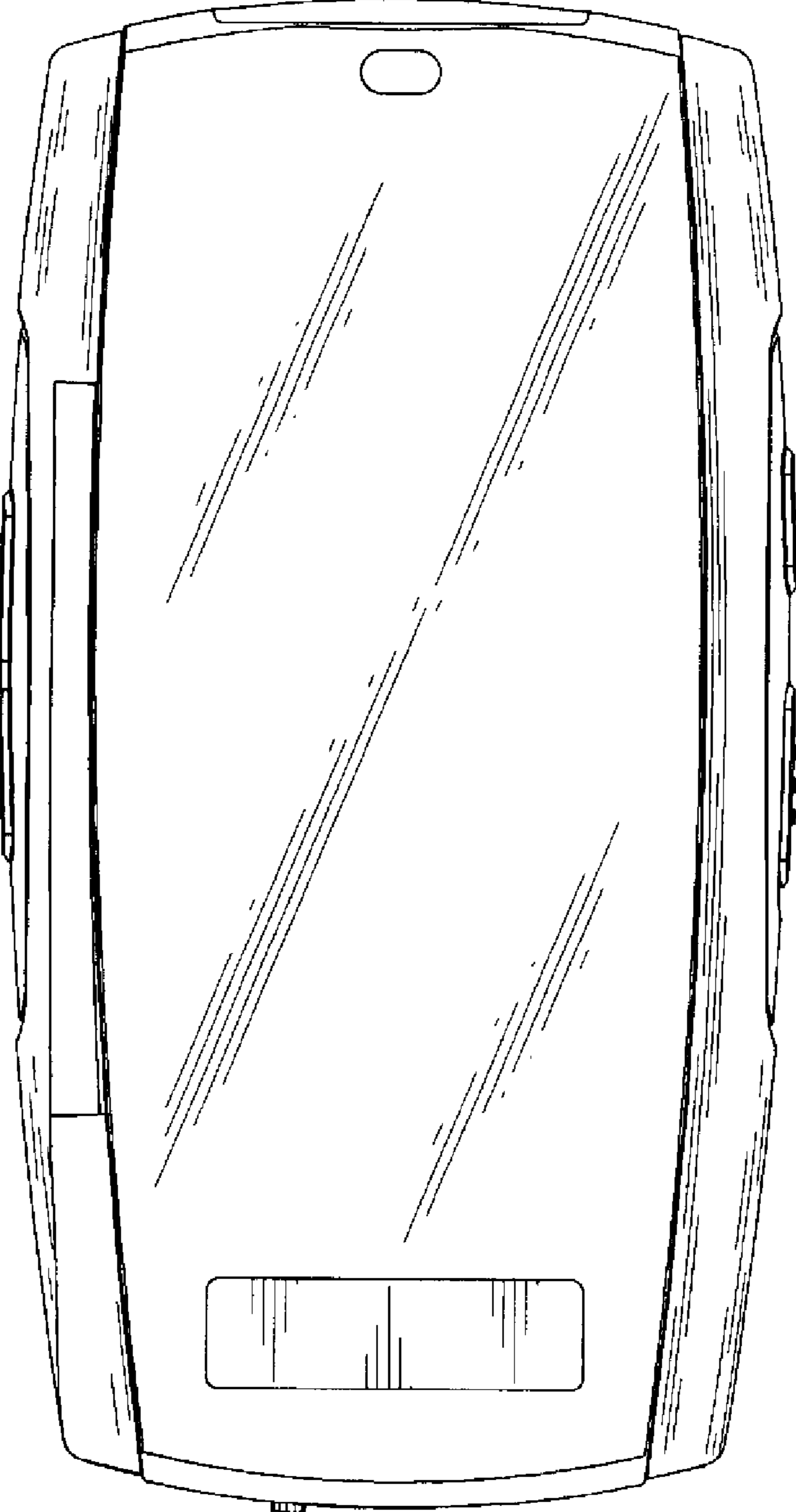

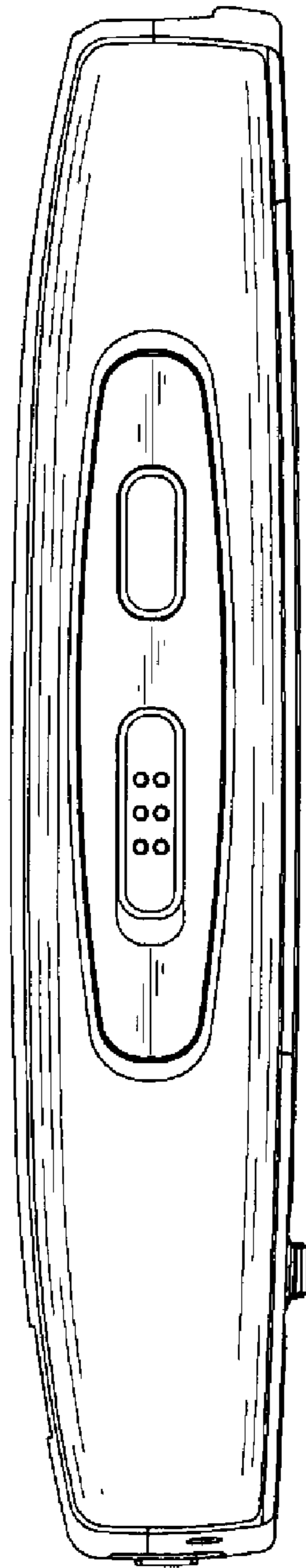

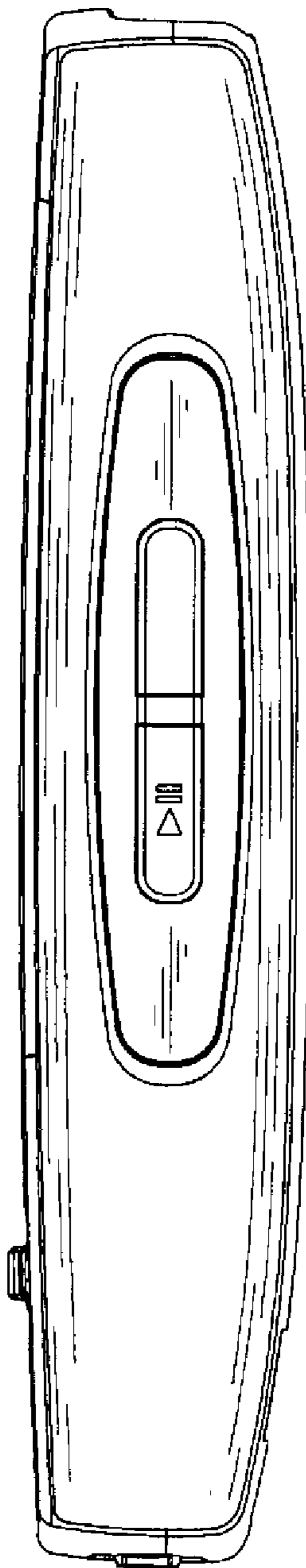

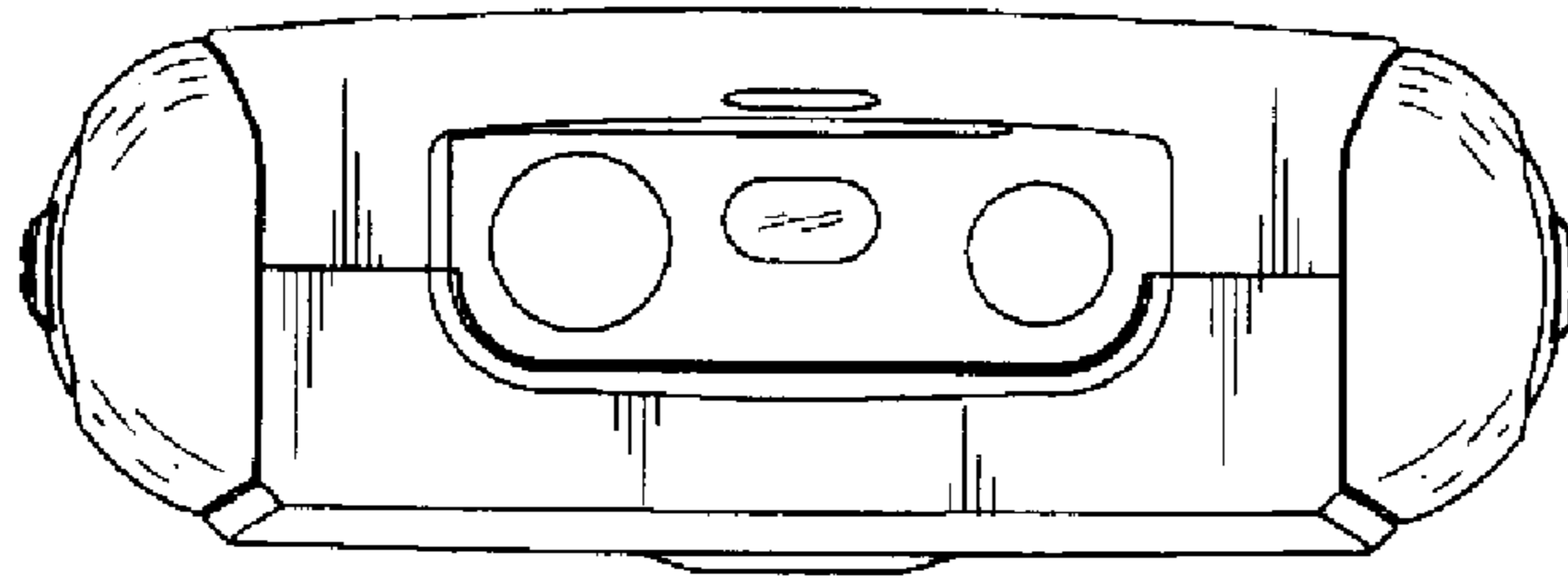
