DESCRIPTION

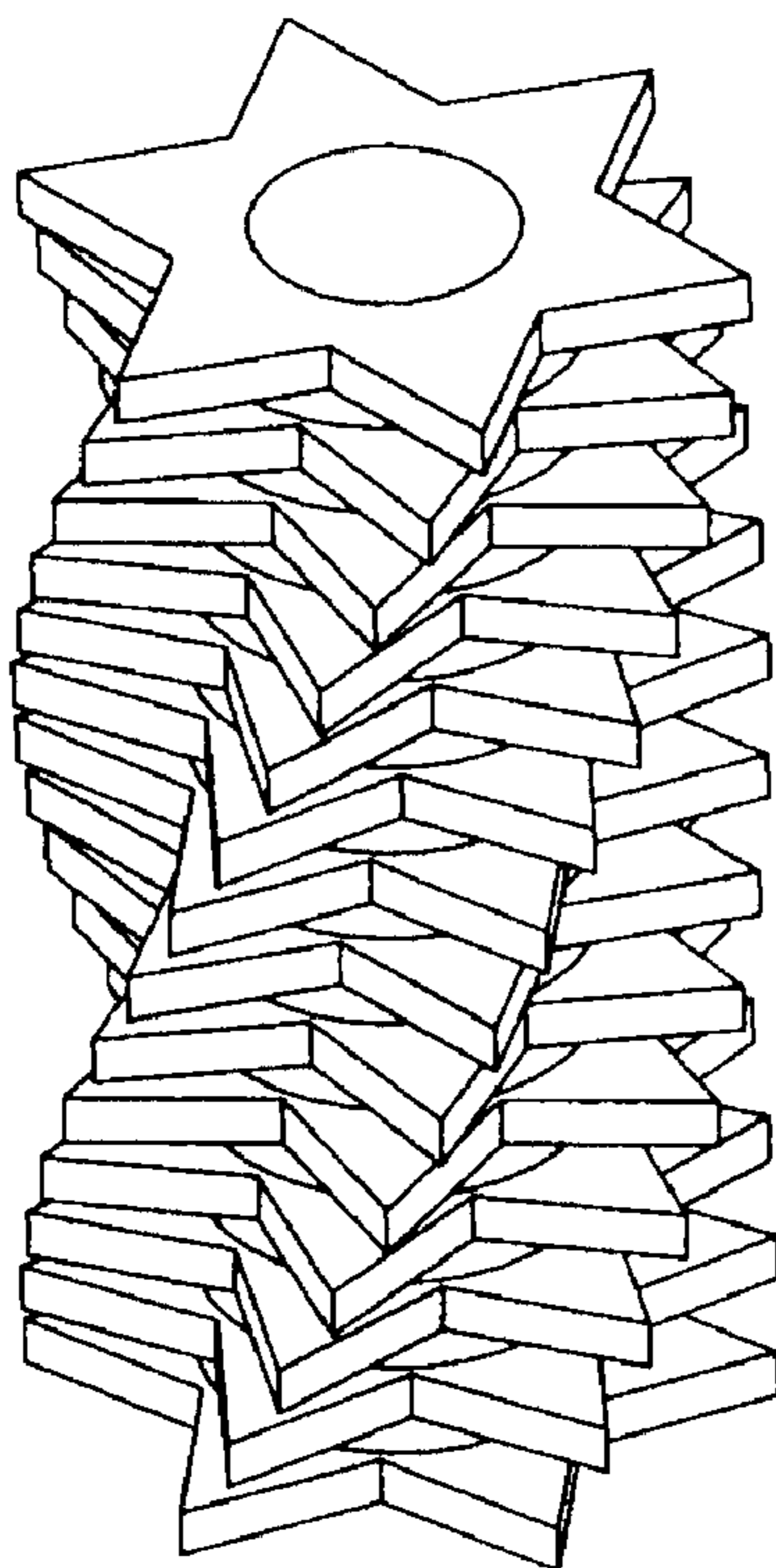
FIG. 1 is a top plan view of a grip for a writing instrument showing our new design;

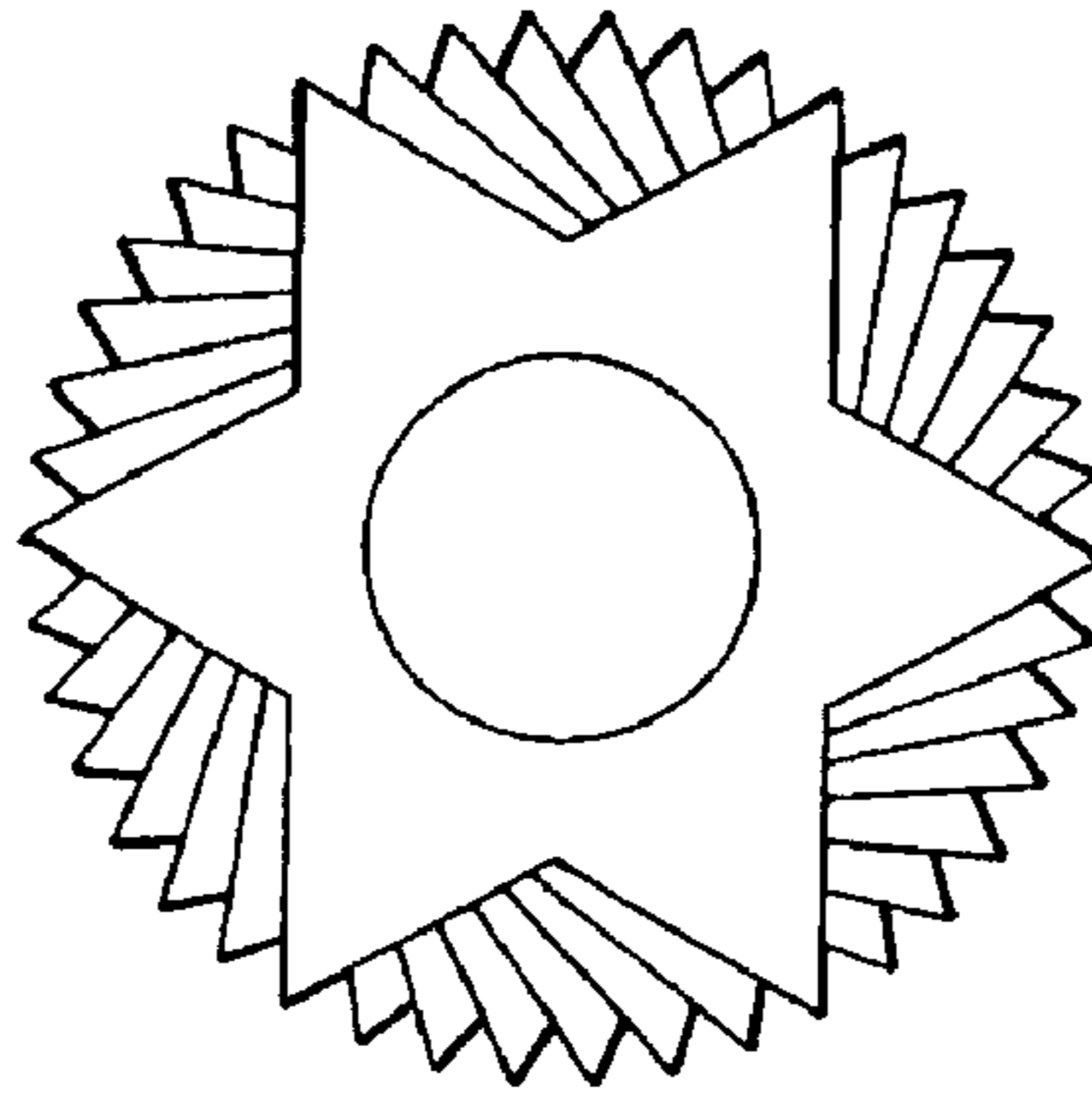

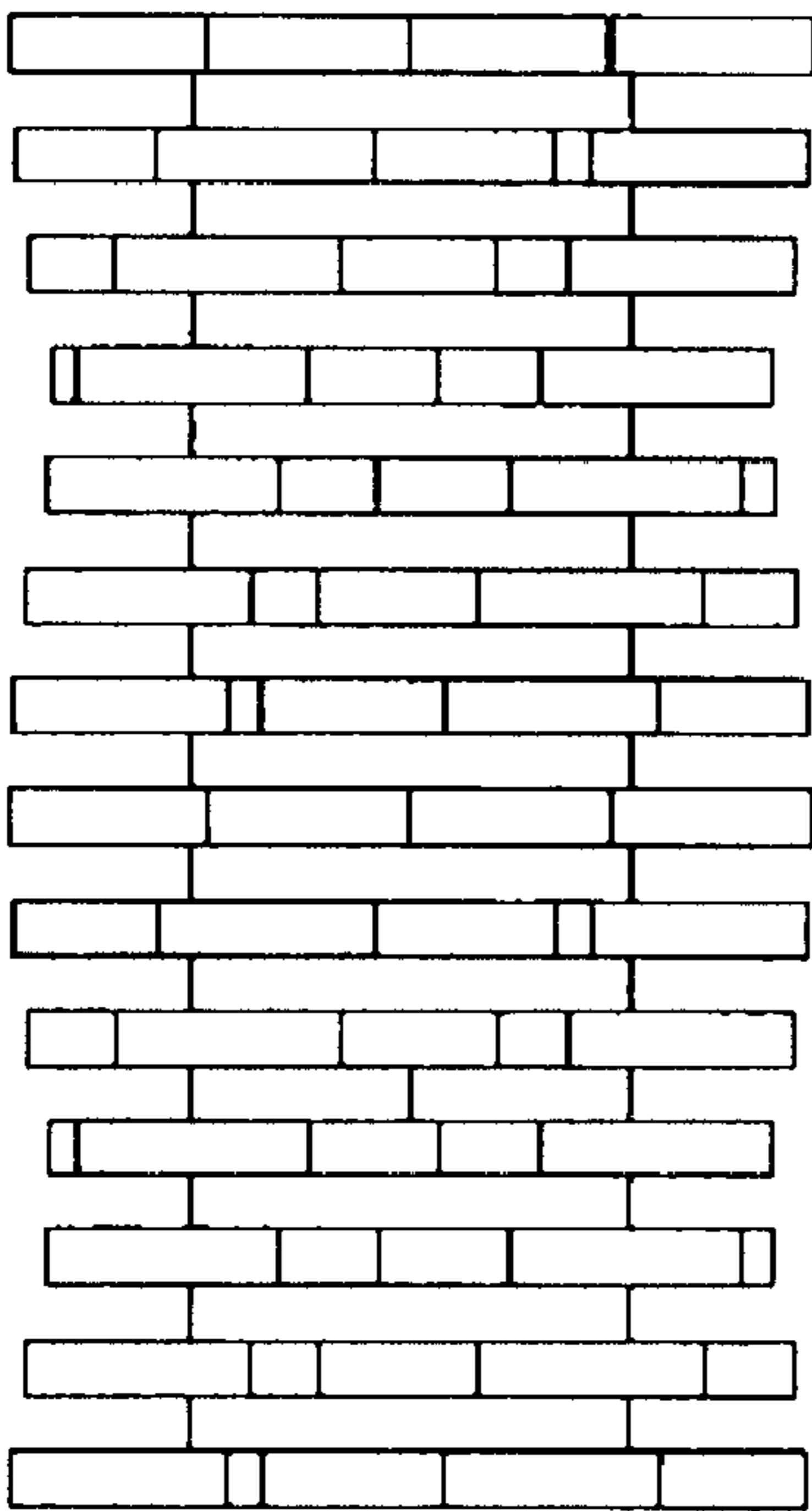

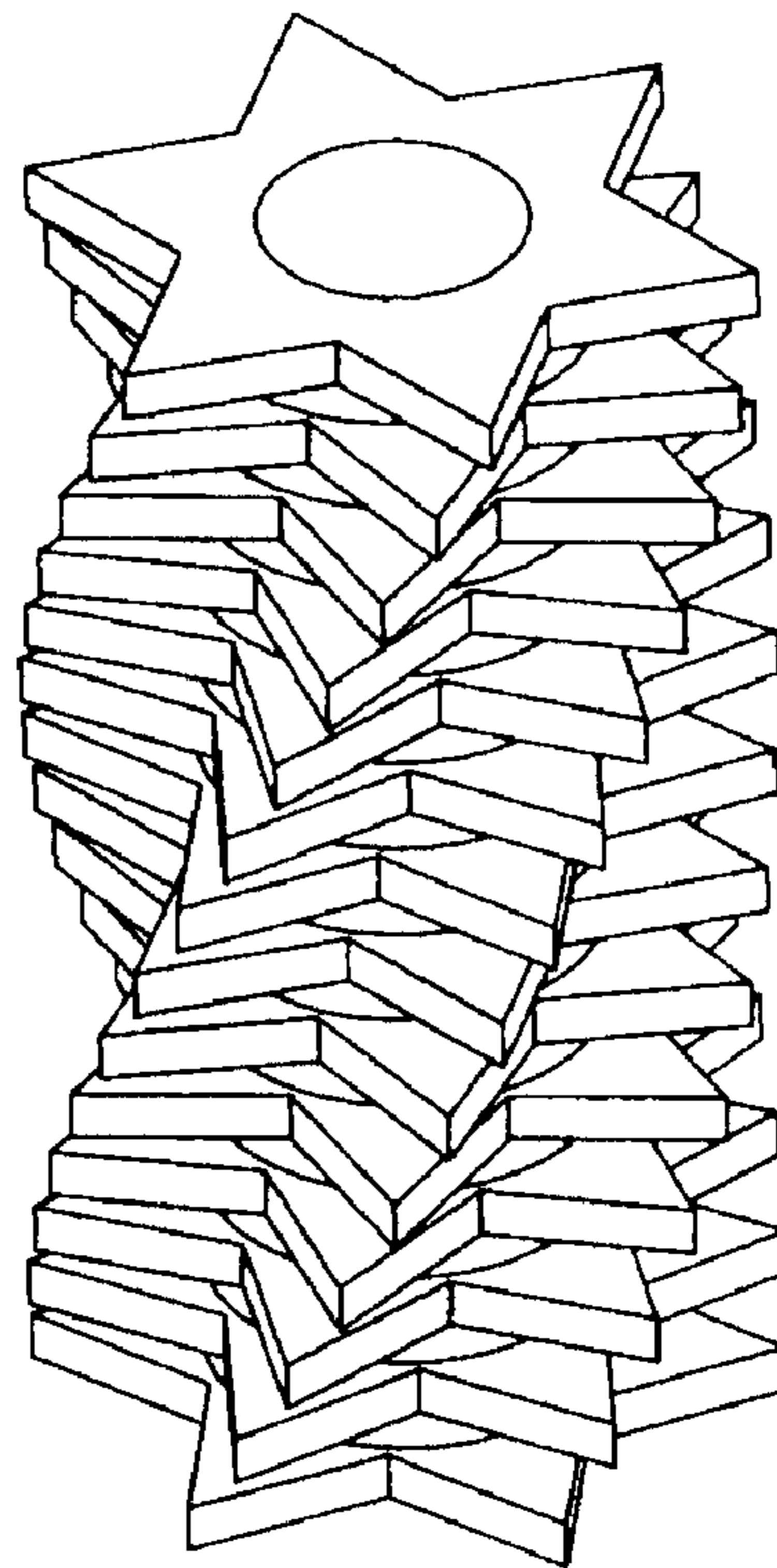
