The ornamental design for a light fixture, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view from above of a light fixture in accordance with our design;

FIG. 2 is a top plan view of the light fixture in accordance with our design;

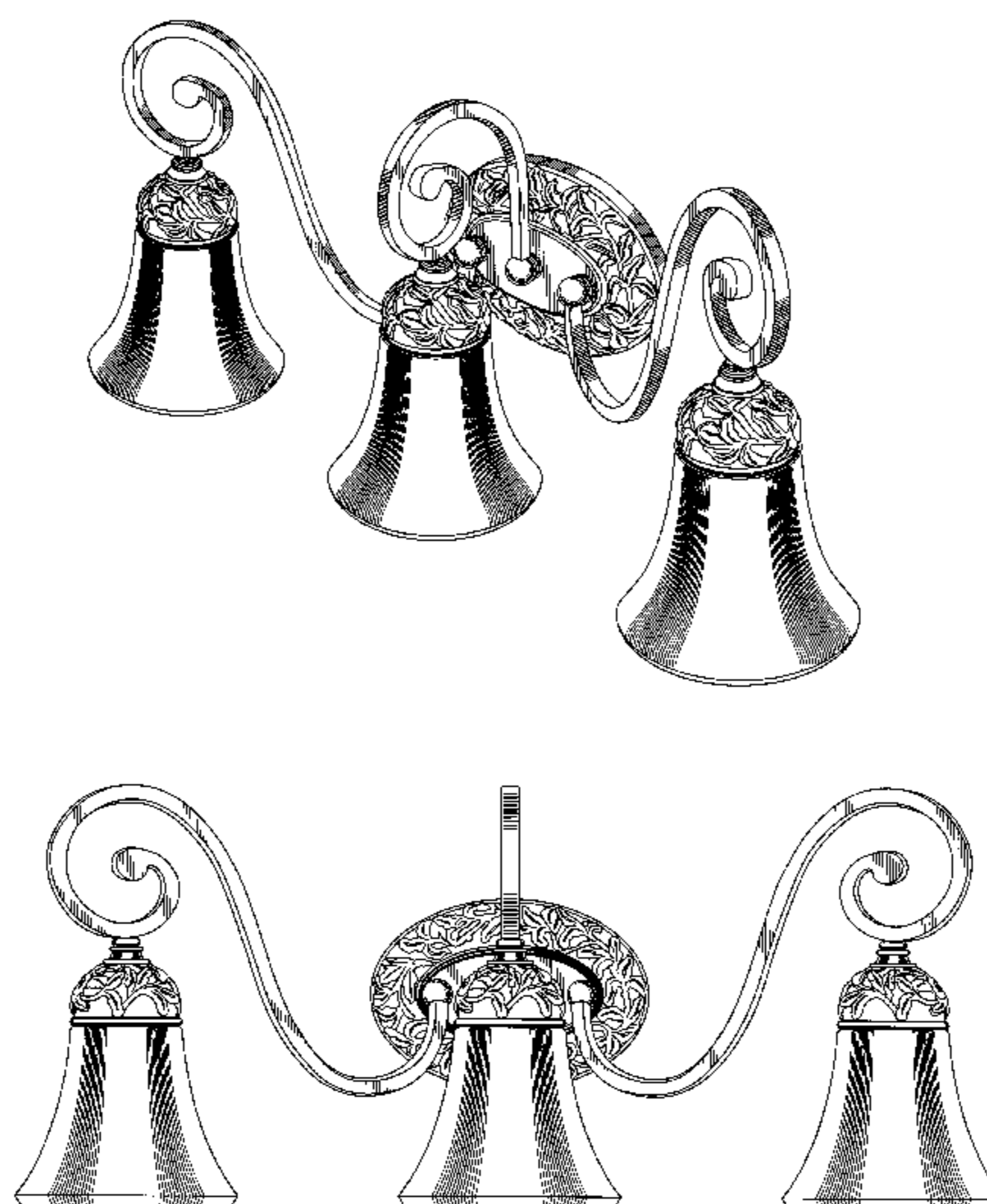
FIG. 3 is a bottom plan view of the light fixture in accordance with our design;

FIG. 4 is a front plan view of the light fixture in accordance with our design; and,

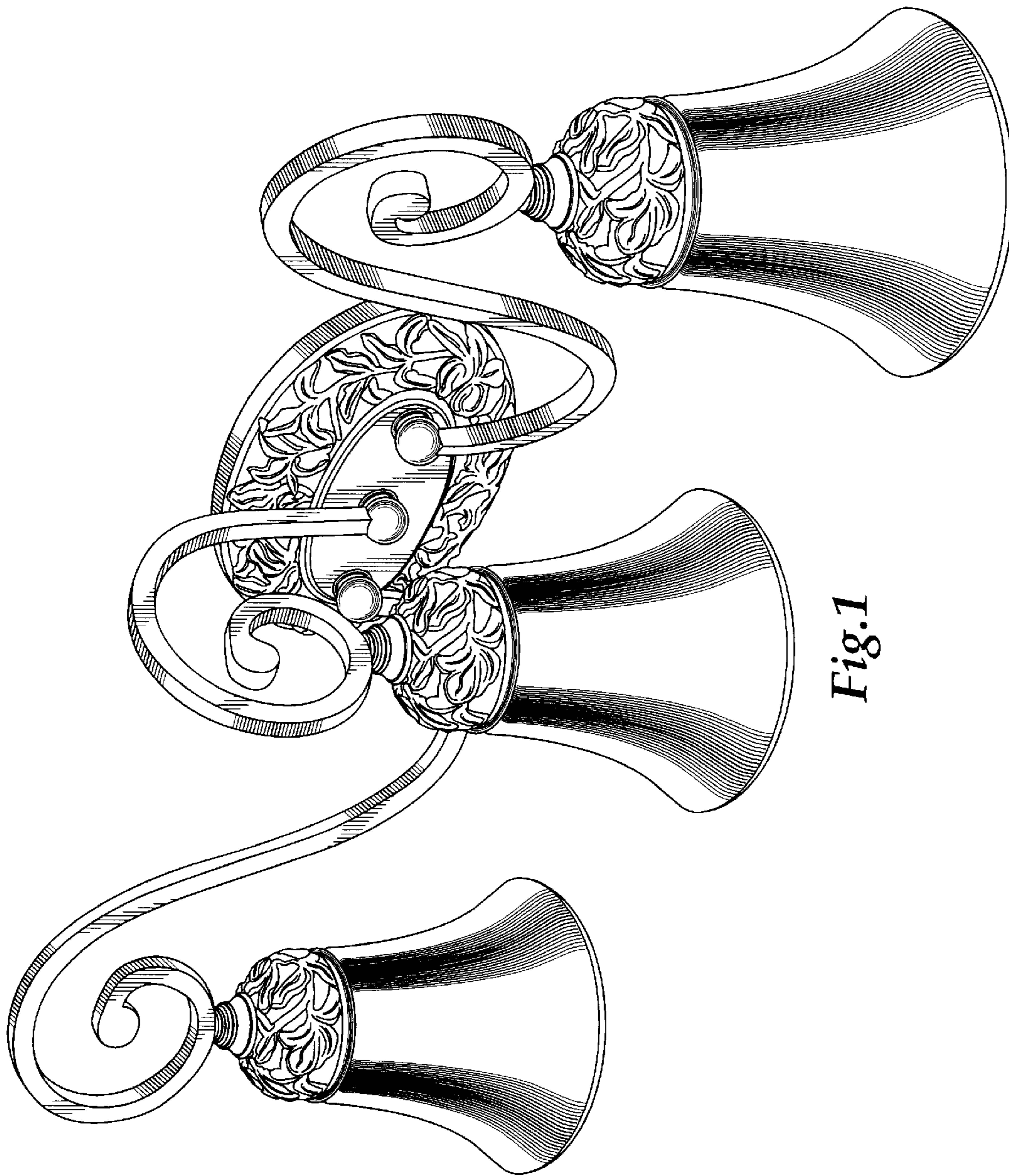

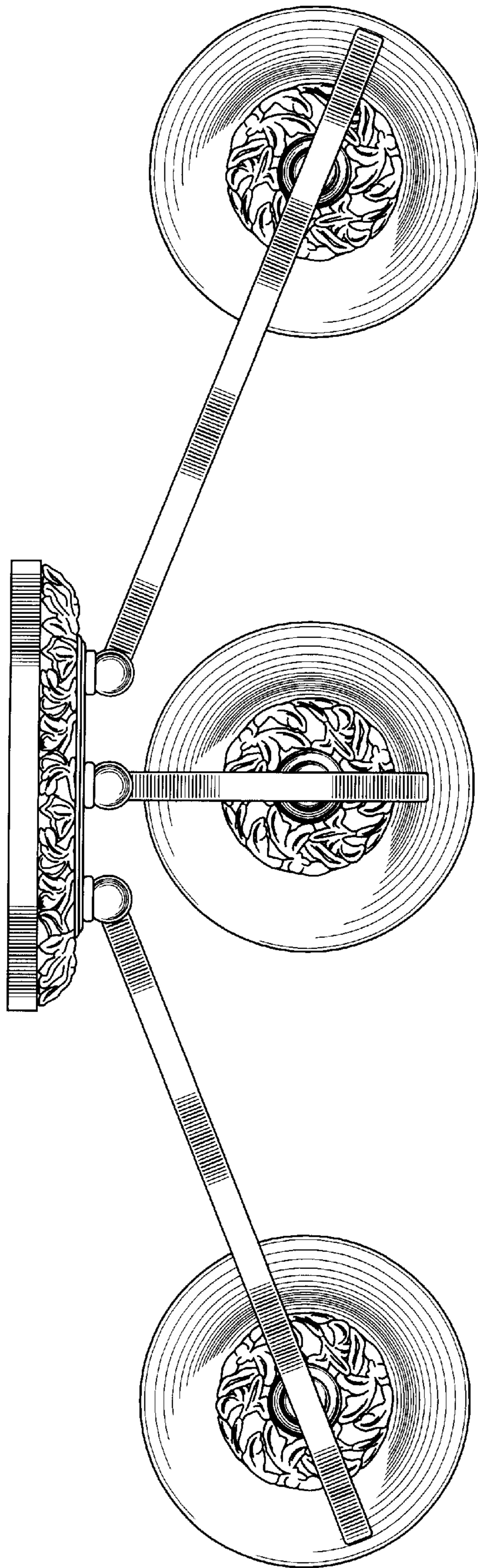

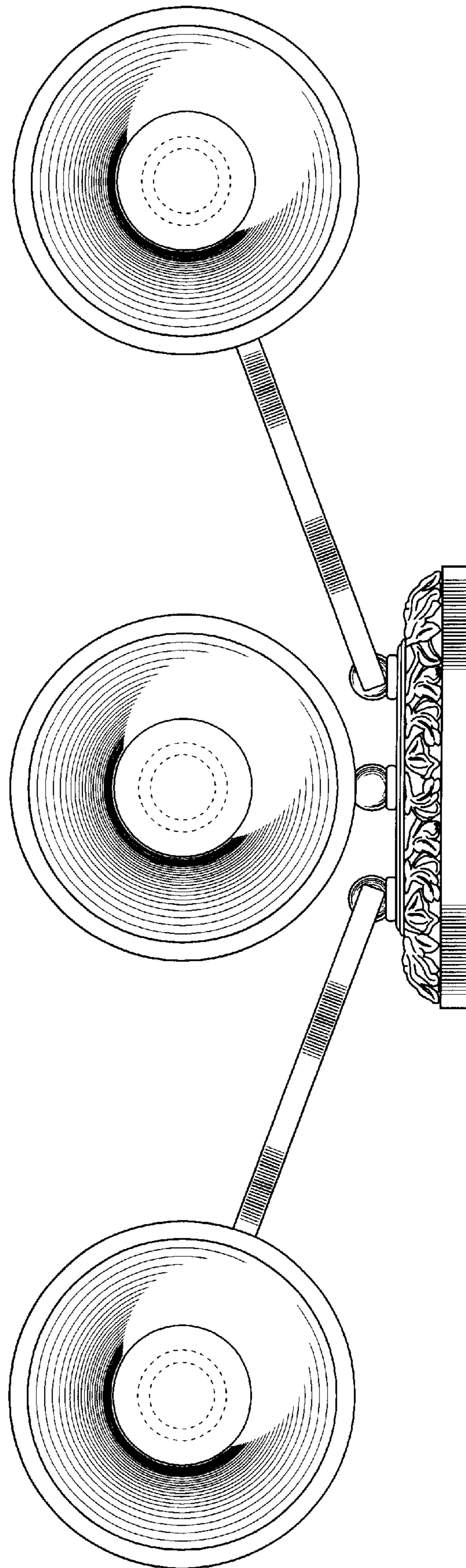

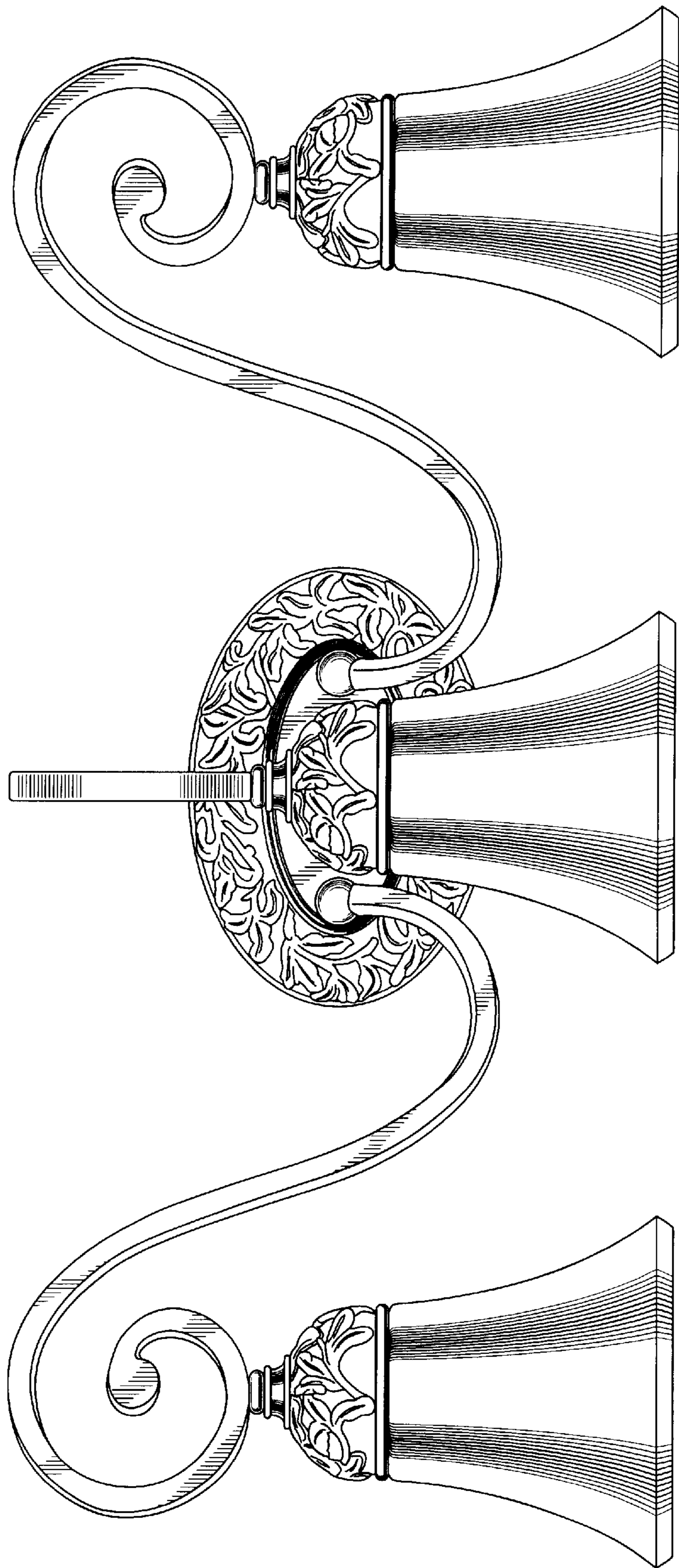
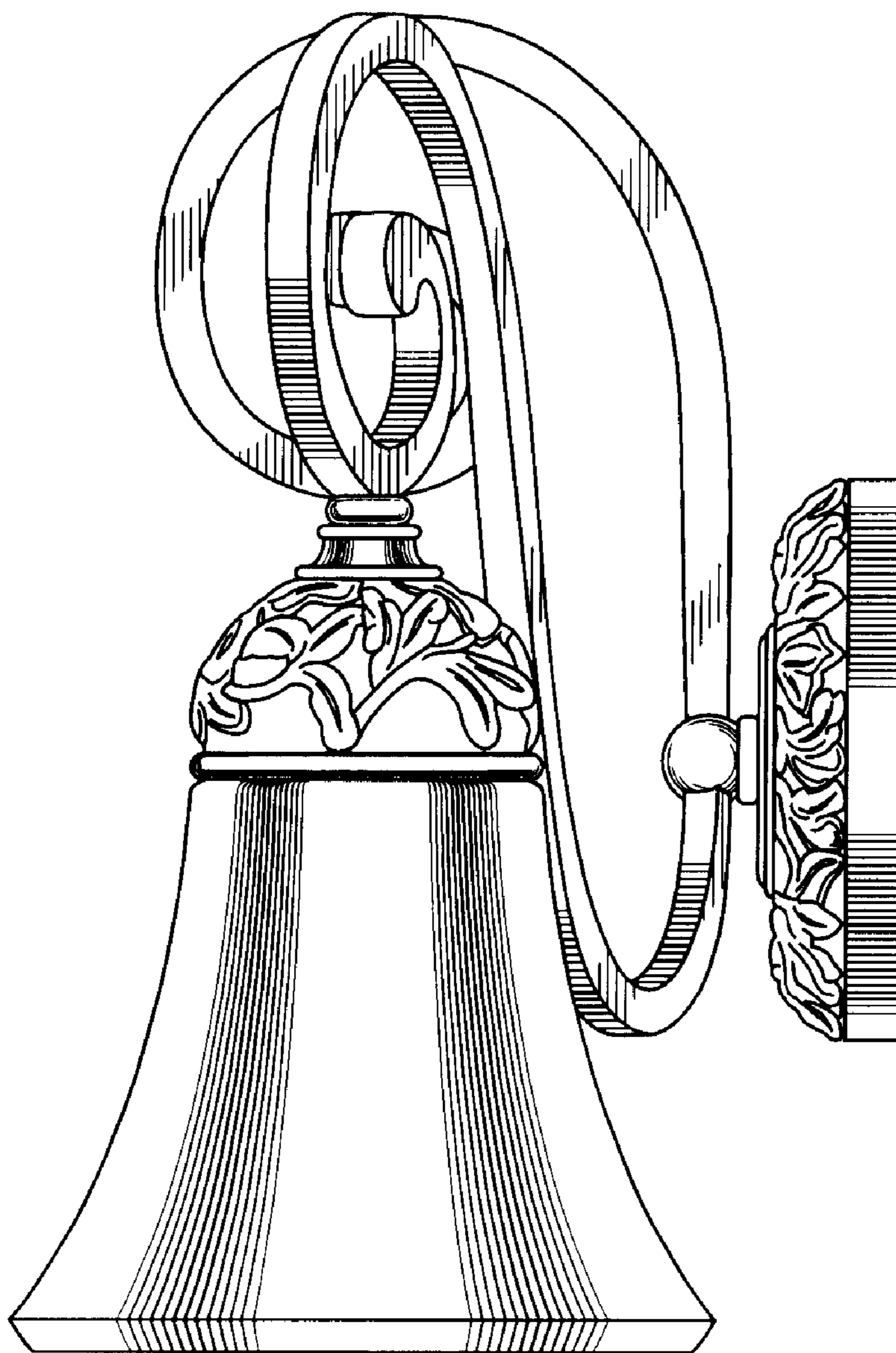
