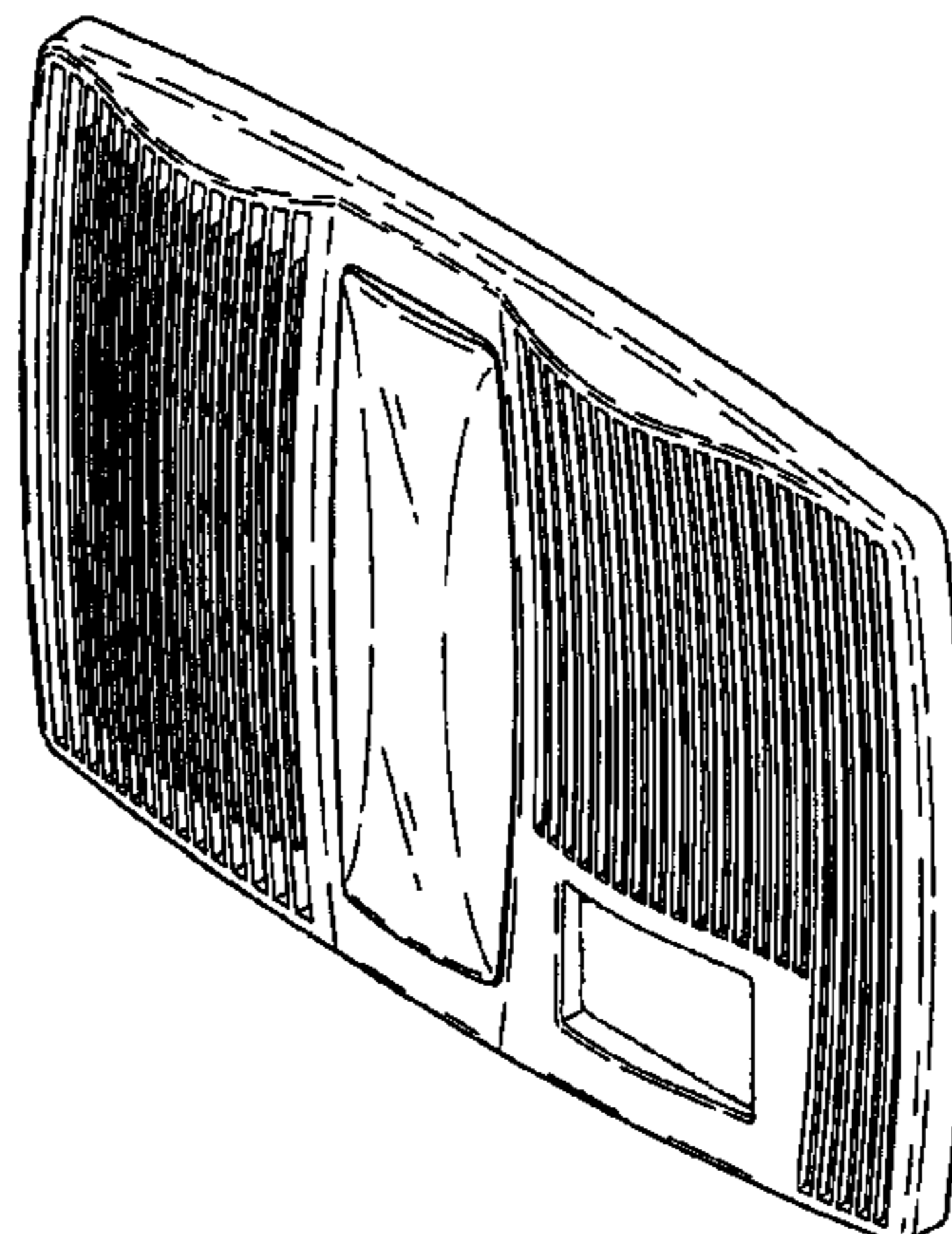
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of a ventilating and lighting assembly constructed in accordance with an embodiment of the present invention;  
FIG. 2 is a top view of the ventilating and lighting assembly shown in FIG. 1;  
FIG. 3 is a front view of the ventilating and lighting assembly shown in FIGS. 1 and 2; and,  
FIG. 4 is a side view of the ventilating and lighting assembly shown in FIGS. 1-3.

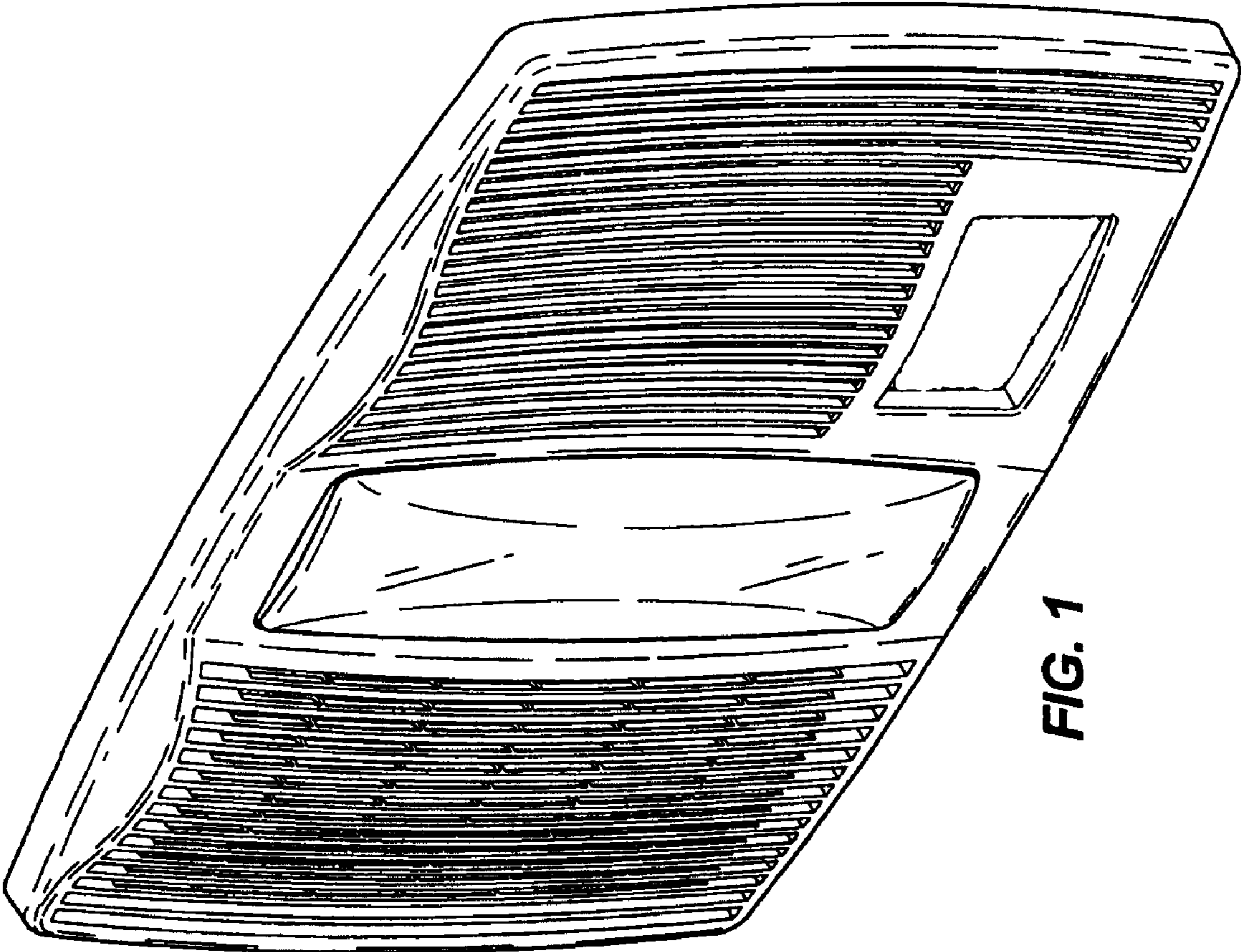

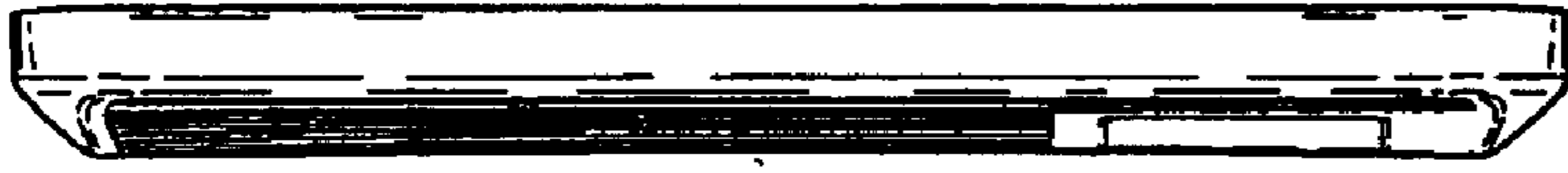

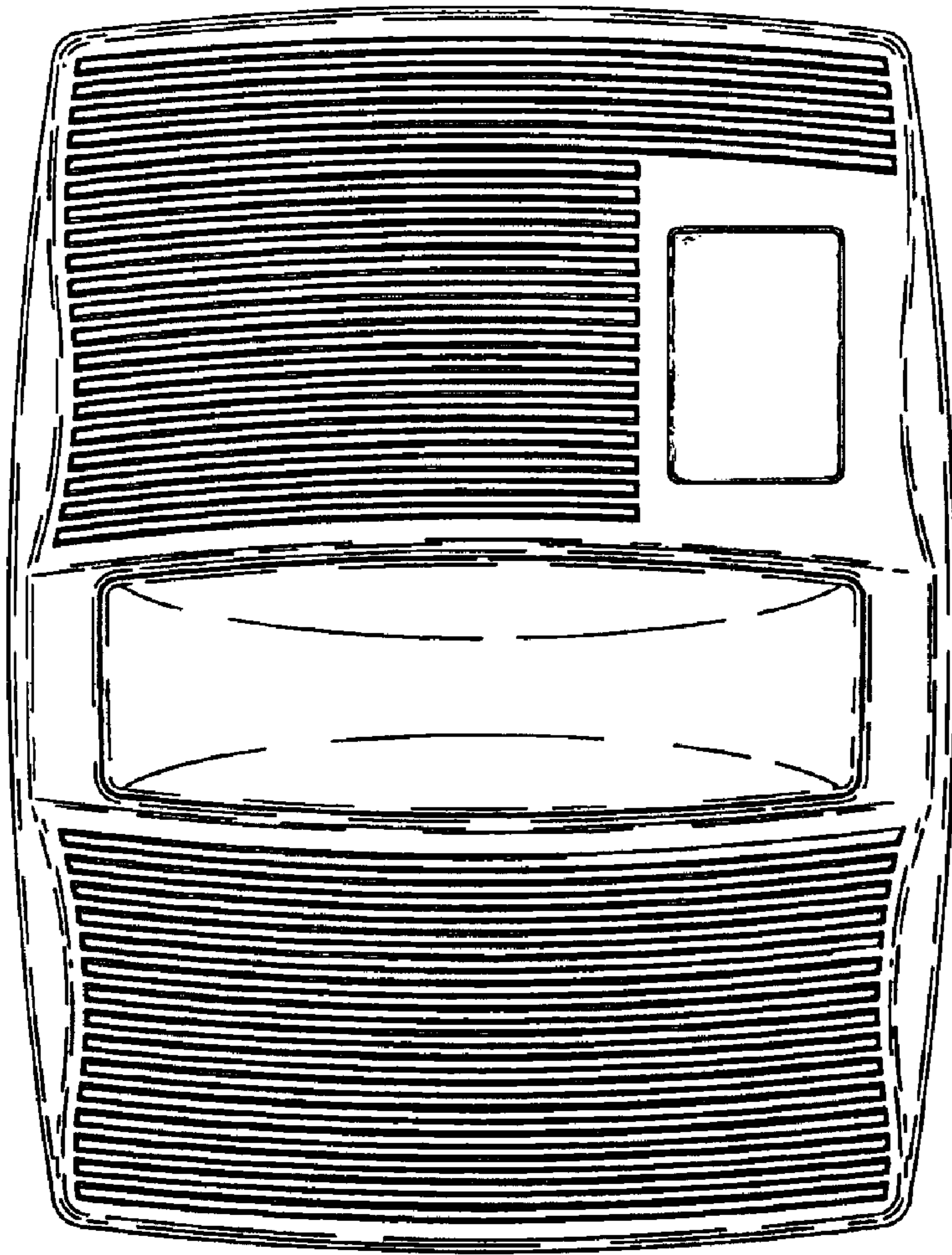
