(57) **CLAIM**

I claim the ornamental design for a poodle bath puff, as shown.

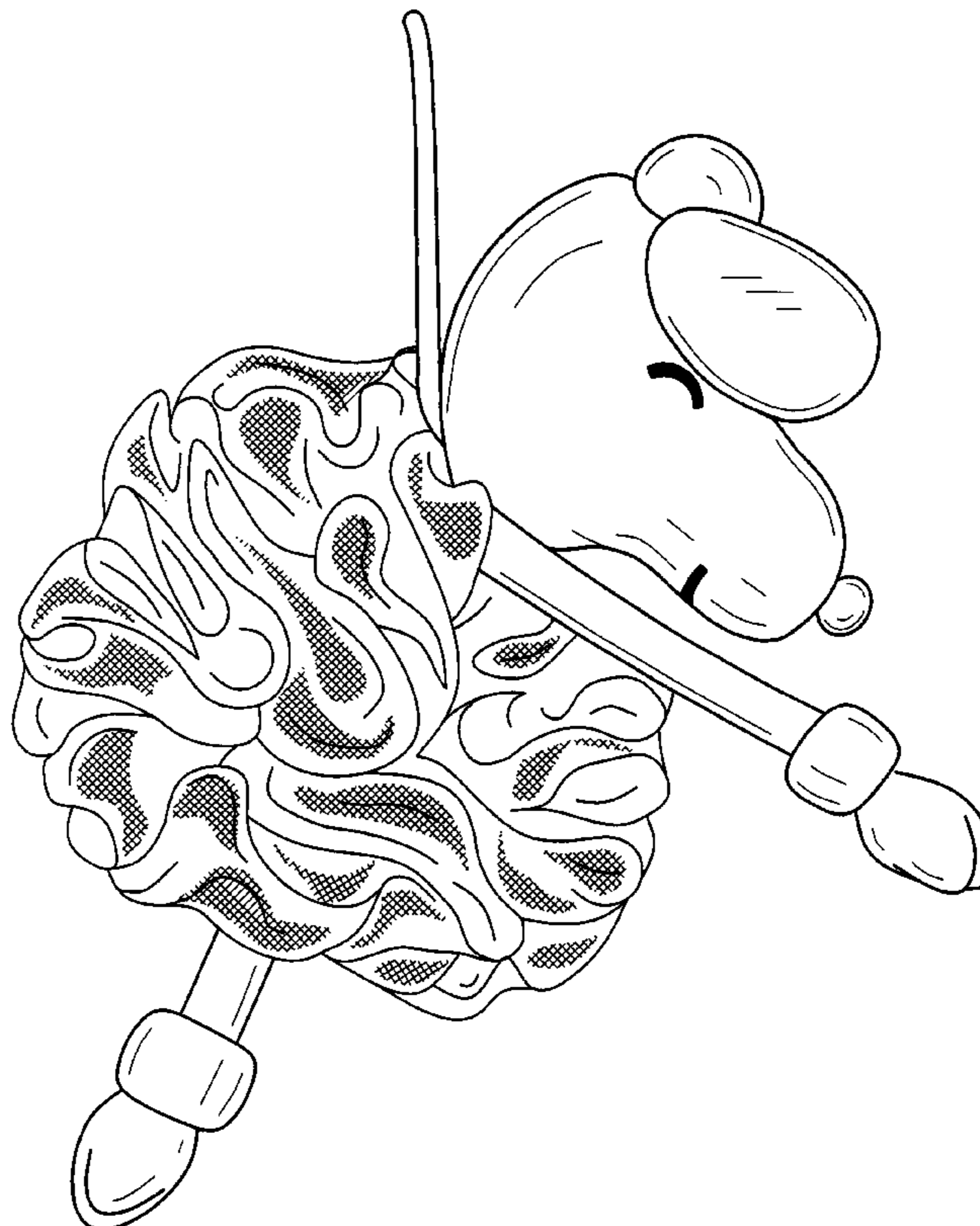
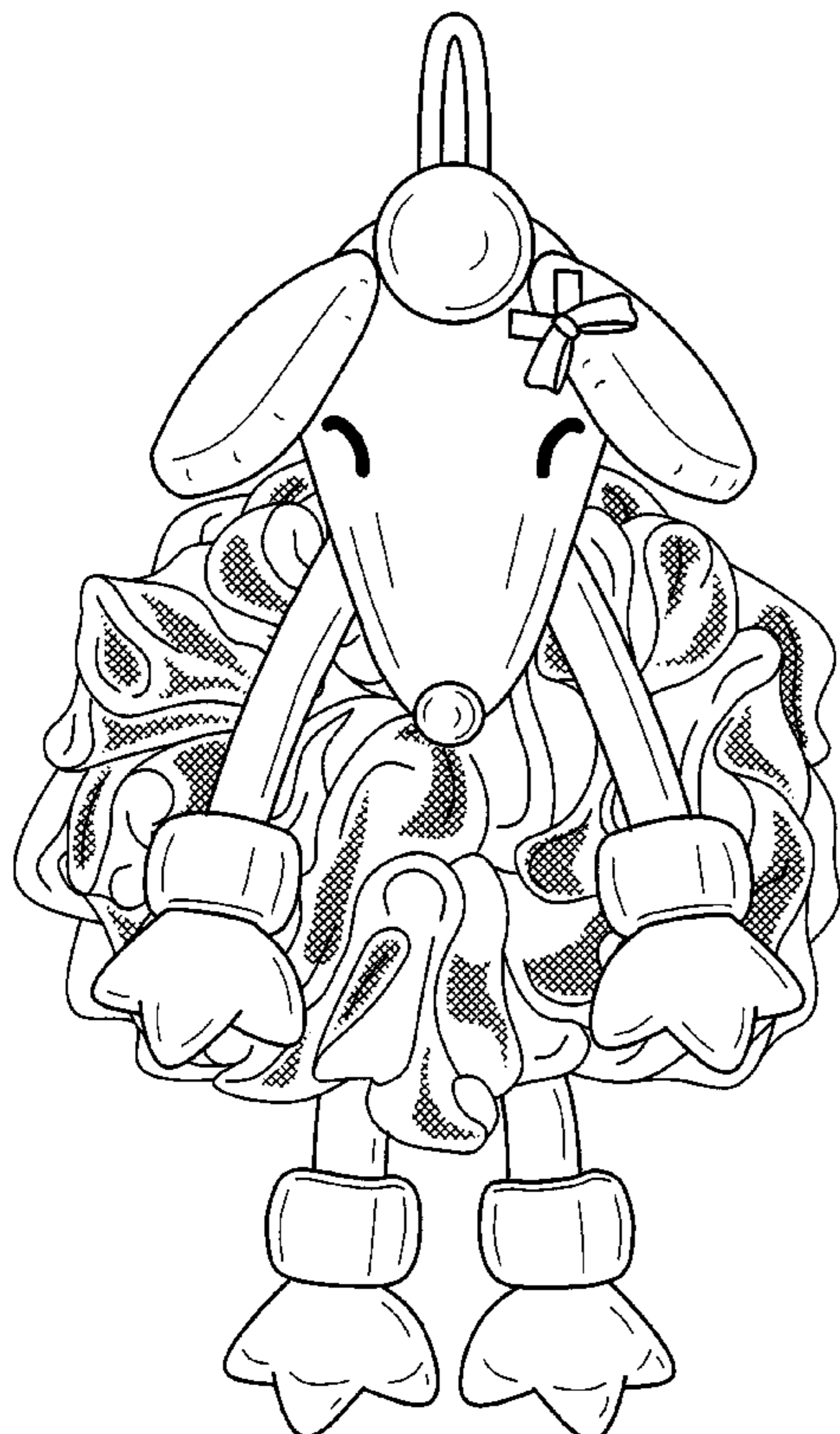

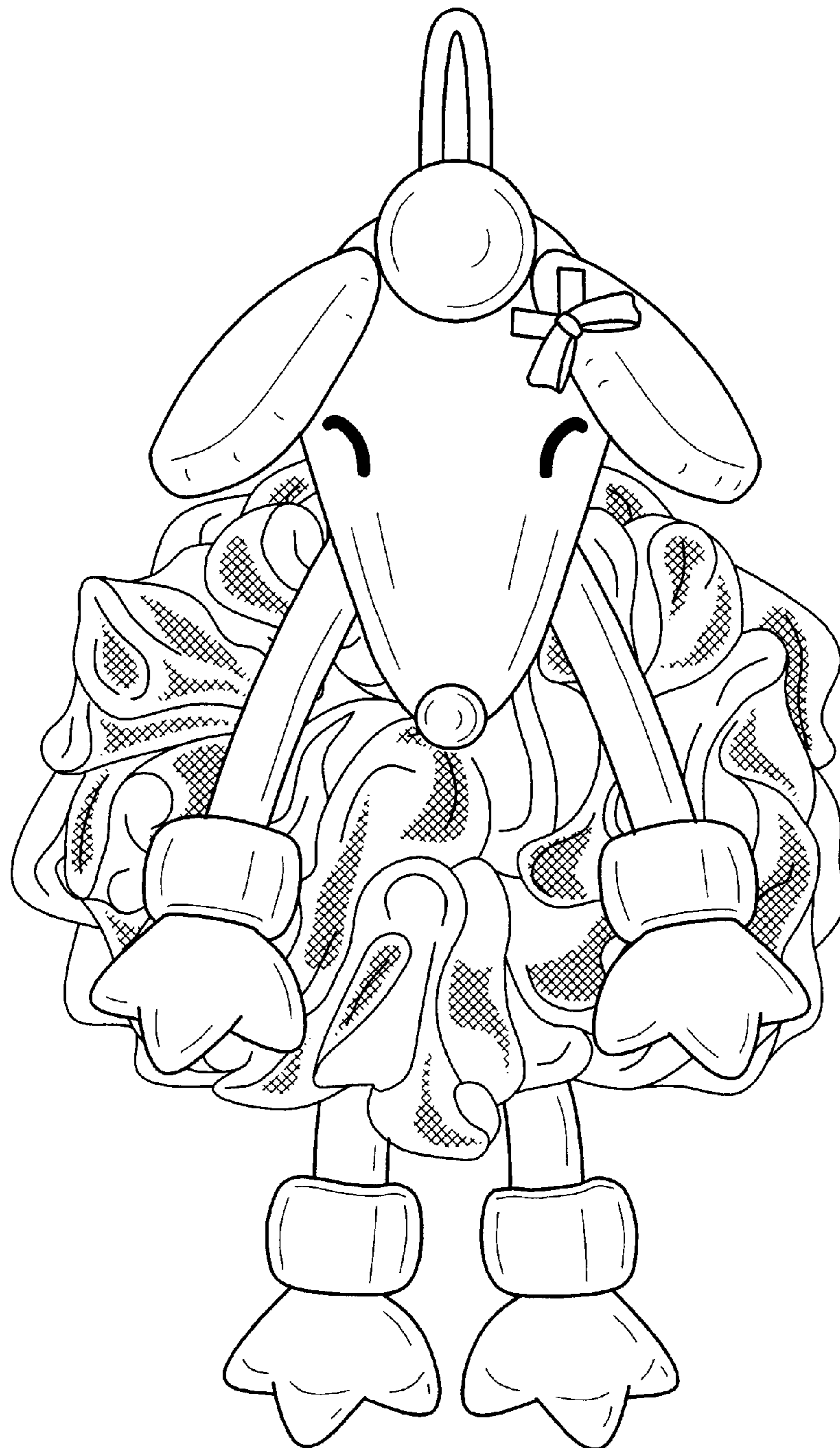

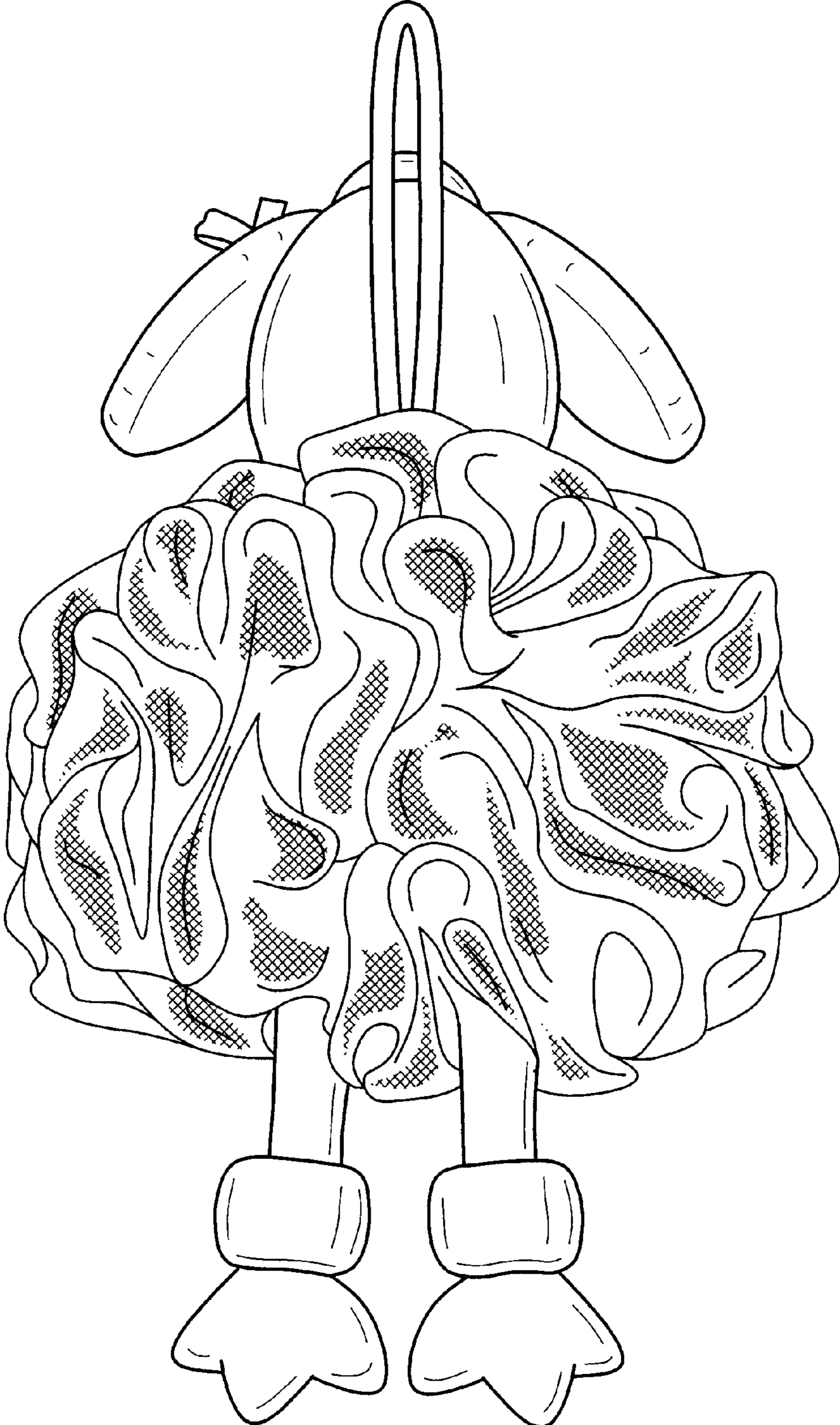

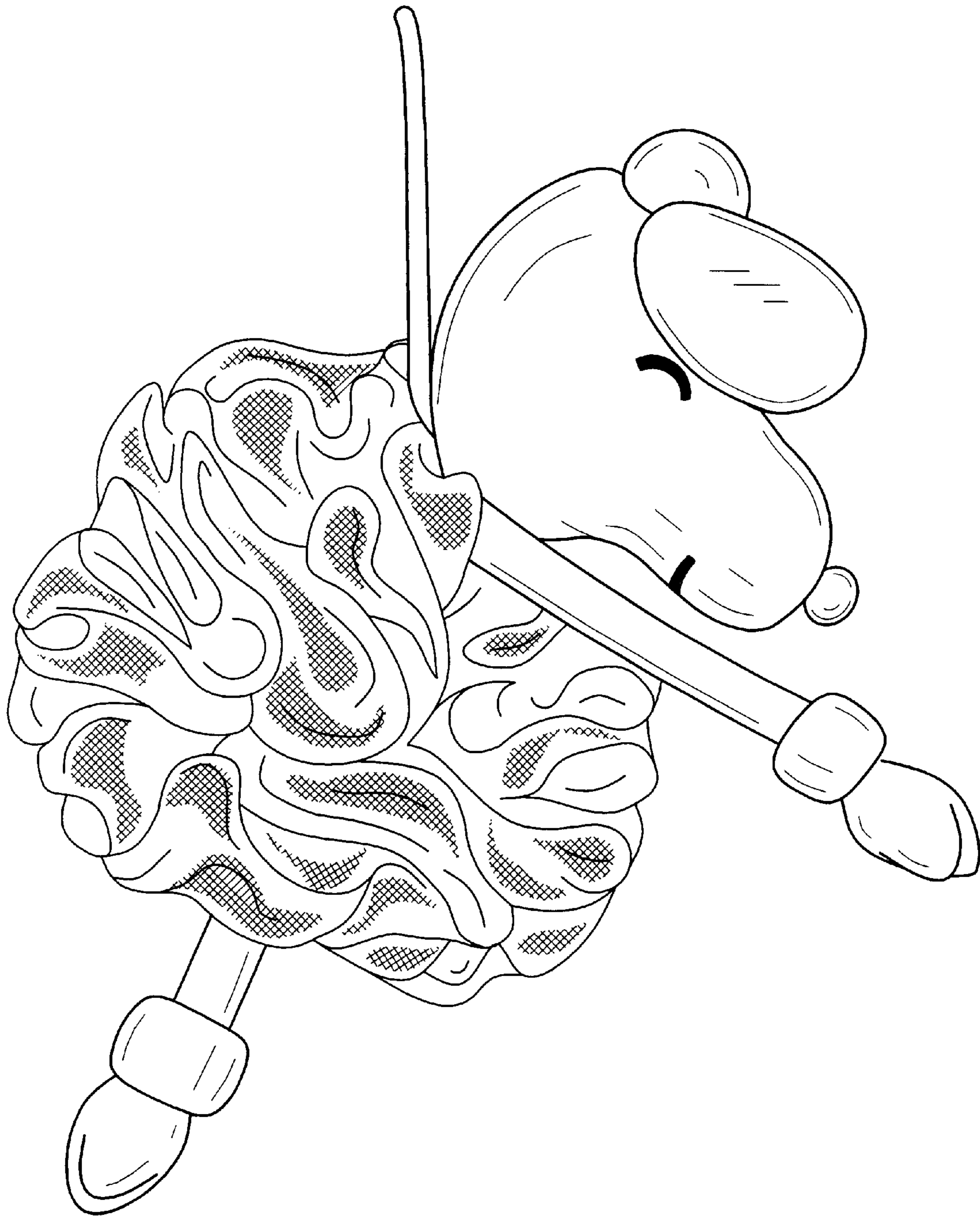

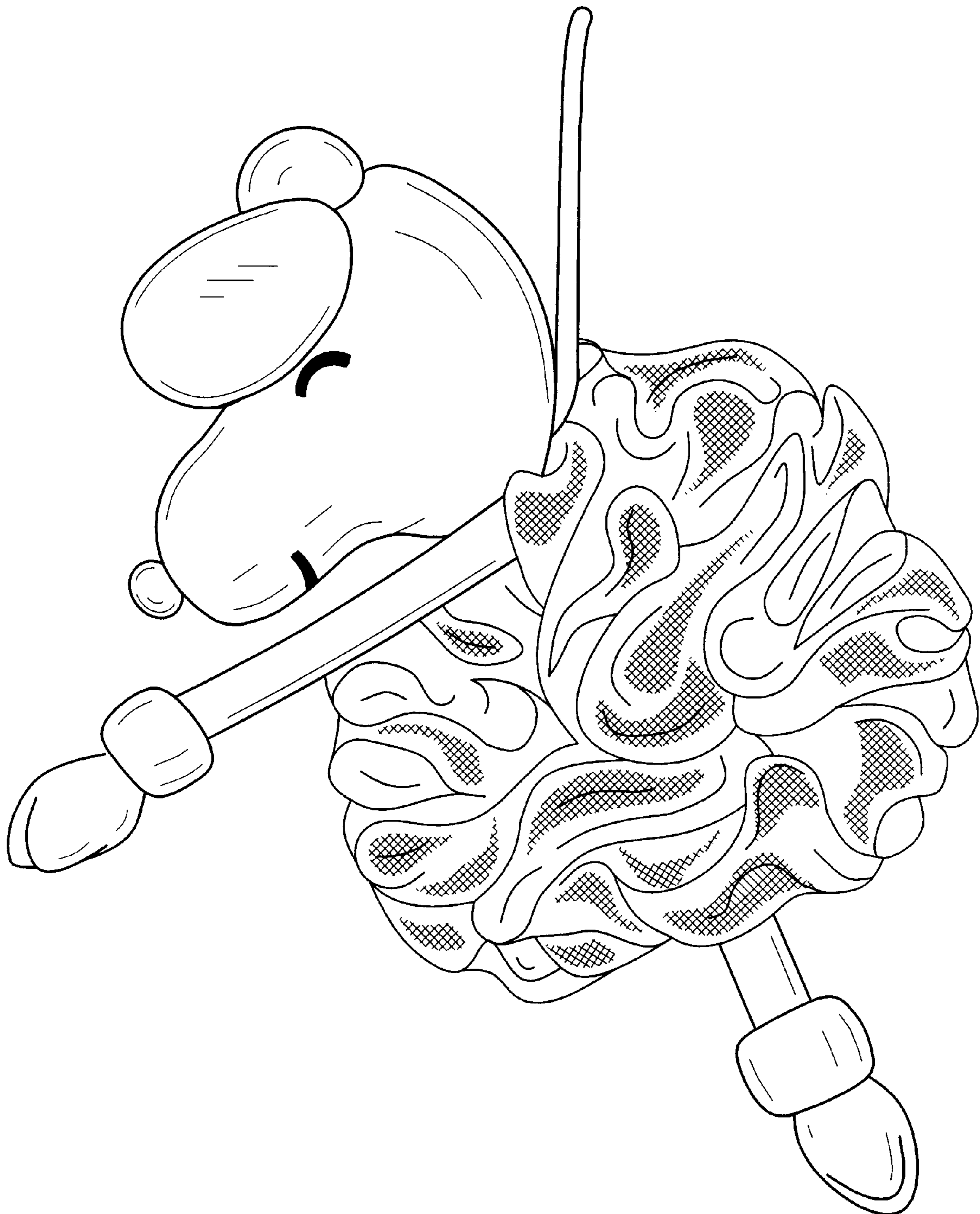

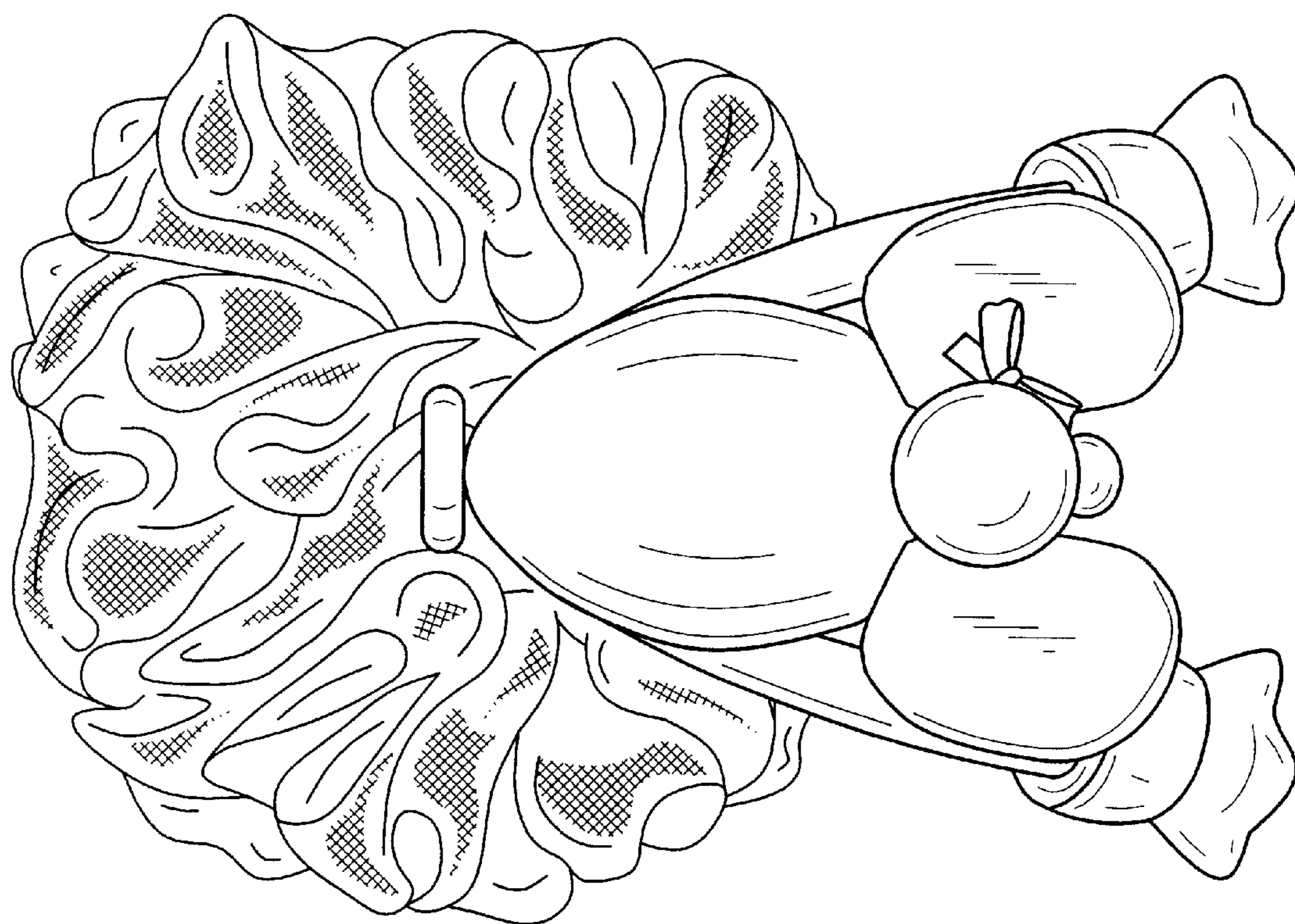
