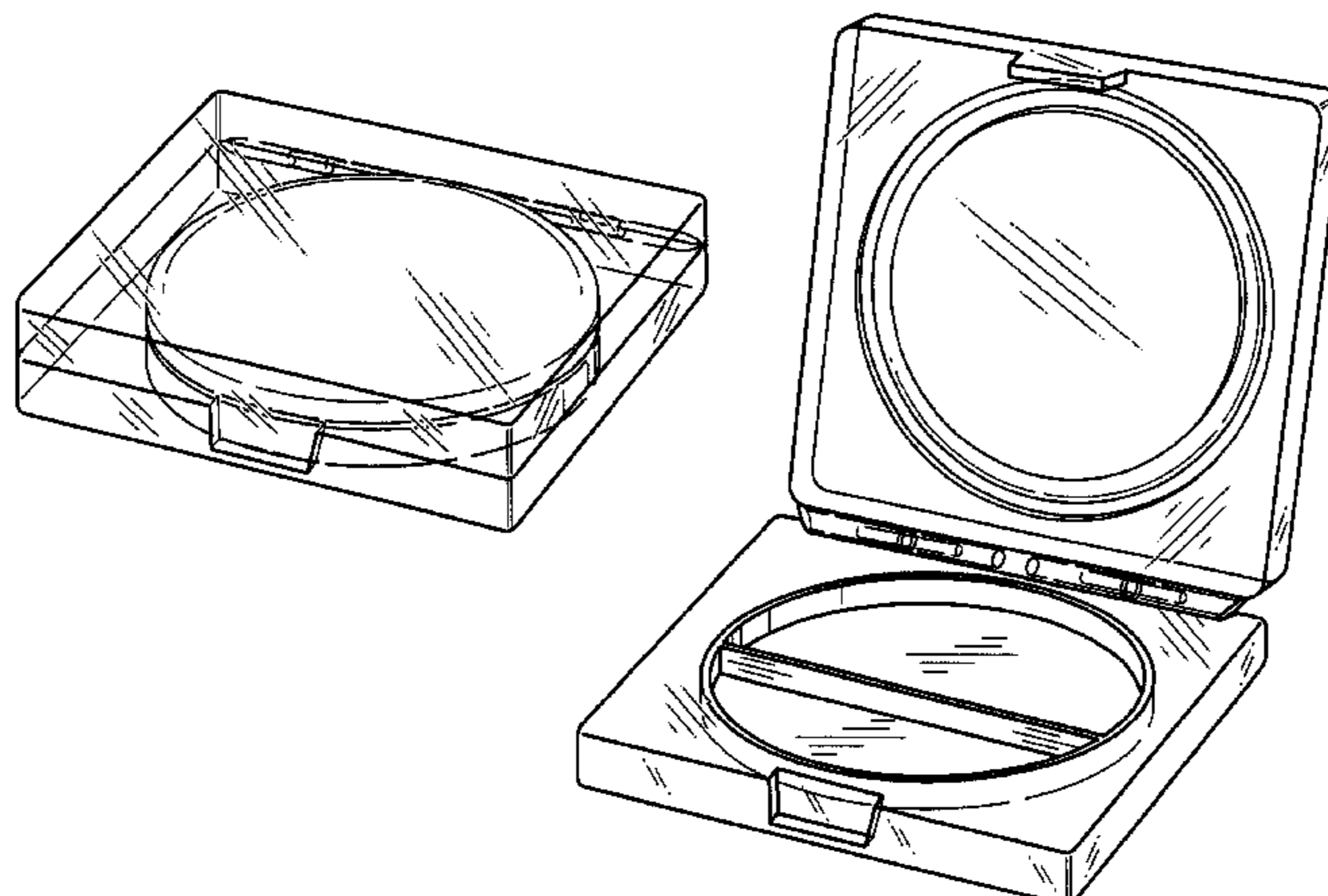
(57) **CLAIM**

What is claimed is the ornamental design for a cosmetic compact, substantially as shown and described.

DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a new design for a cosmetic compact shown in the closed position; FIG. 2 is a top, front and right side perspective view of the cosmetic compact shown in the open position; FIG. 3 is a top plan view of the cosmetic compact shown in FIG. 1; FIG. 4 is a bottom plan view of the cosmetic compact shown in FIG. 1; FIG. 5 is a top plan view of the cosmetic compact shown in FIG. 2; FIG. 6 is a front elevation view of the cosmetic compact shown in FIG. 1; FIG. 7 is a right side elevation view of the cosmetic compact shown in FIG. 1, a left side elevation view being a mirror image thereof; and, FIG. 8 is a rear elevation view of the cosmetic compact shown in FIG. 1.
 The broken lines shown in the figures are for illustrative purposes only and form no part of the claimed design.

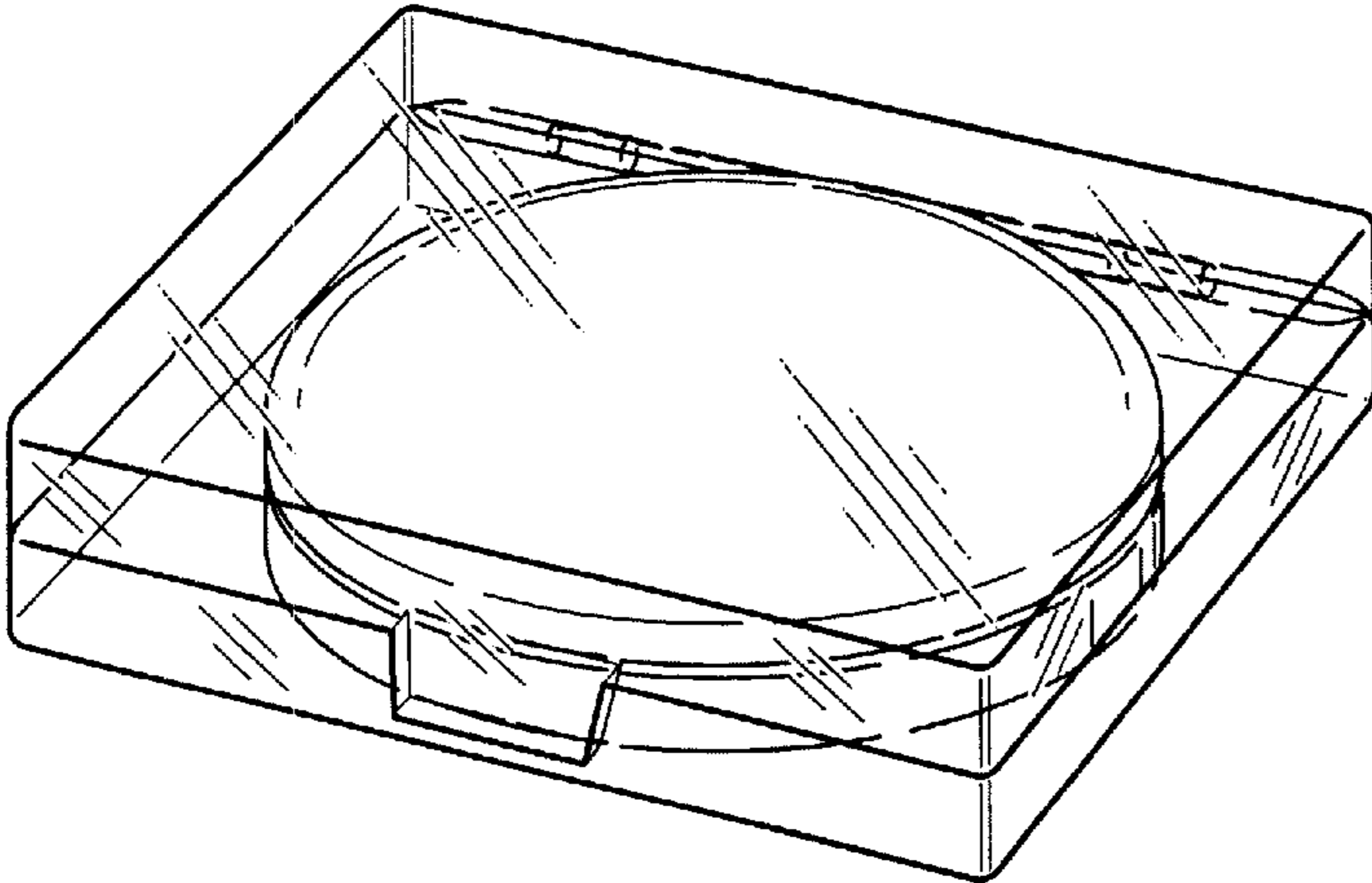

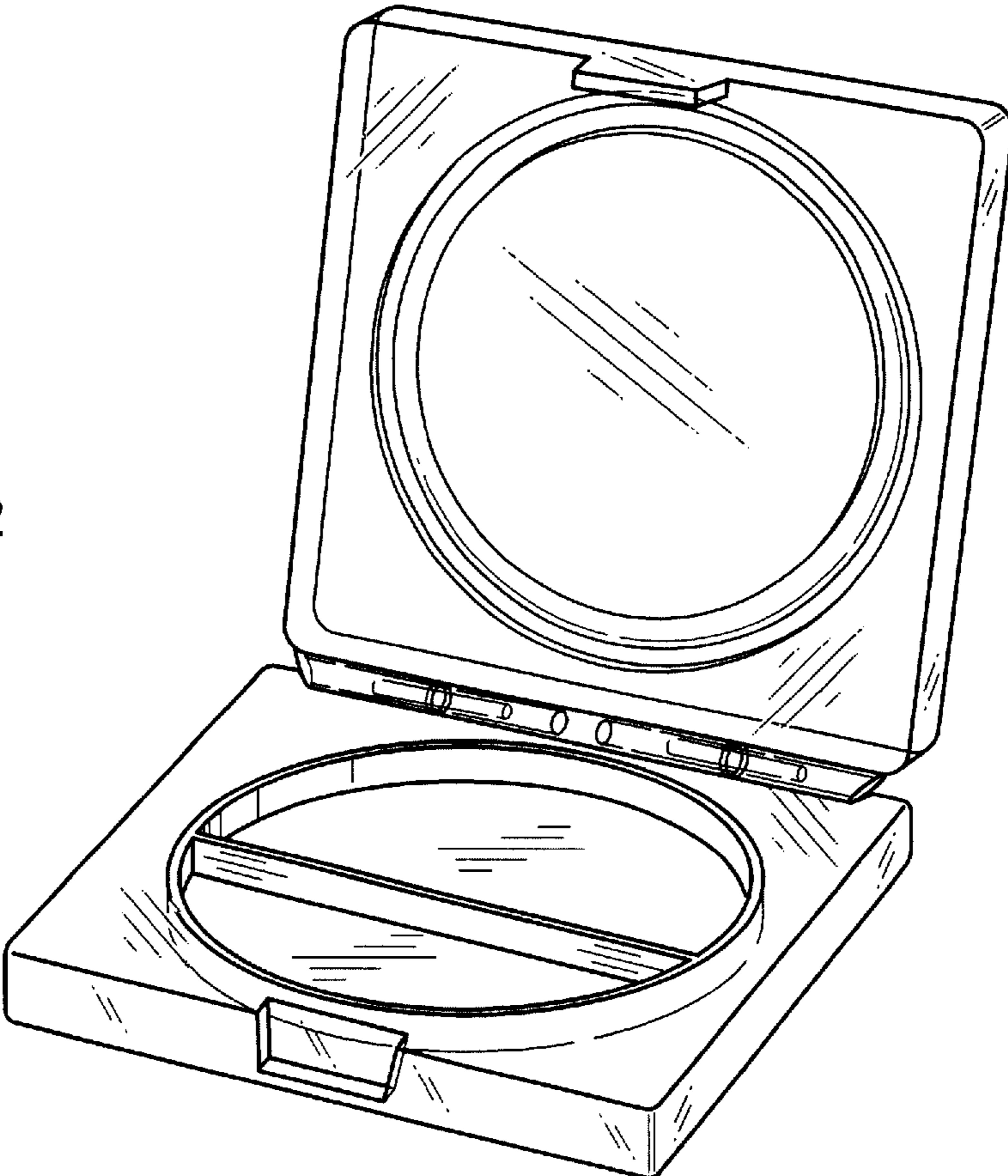

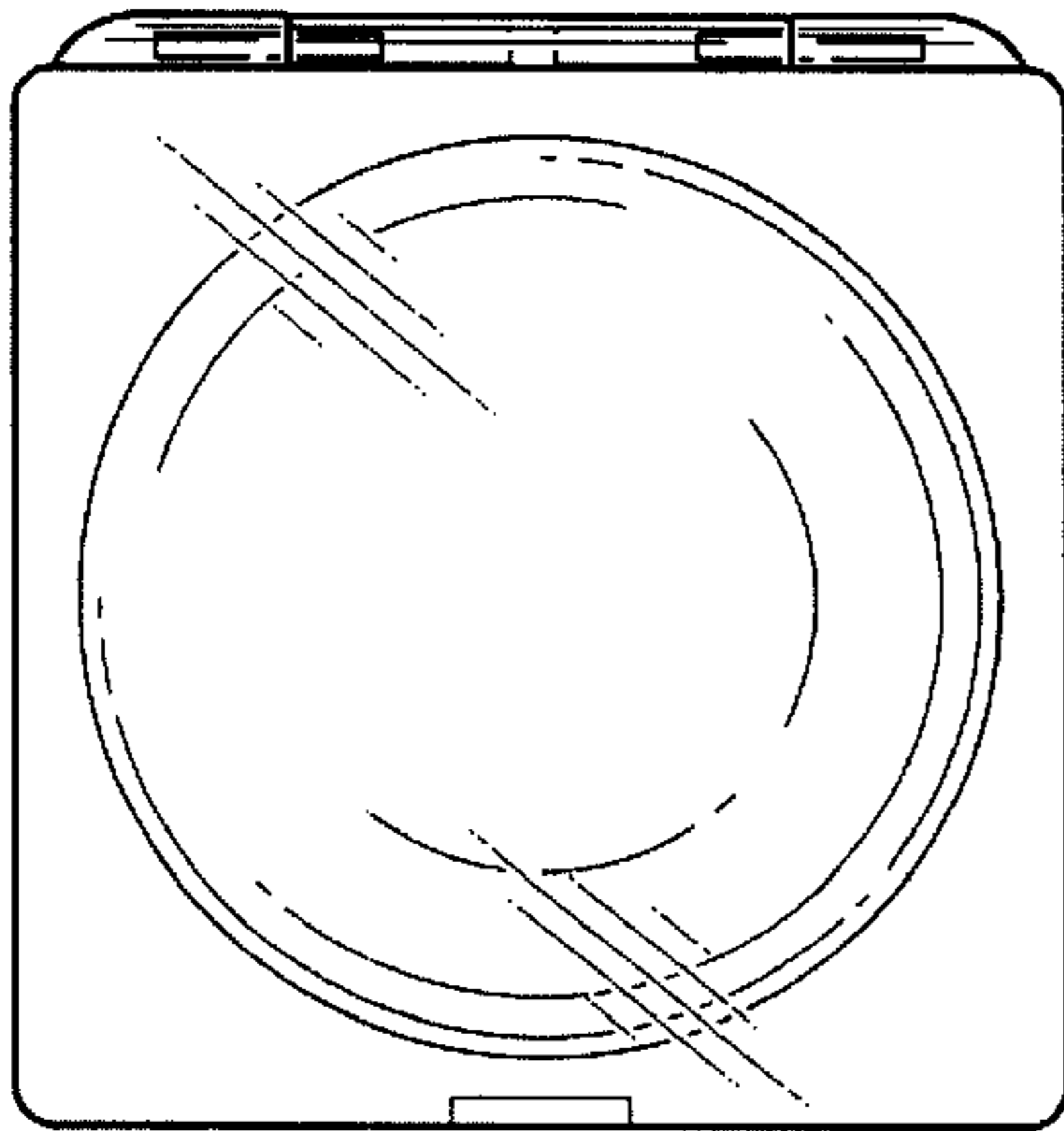

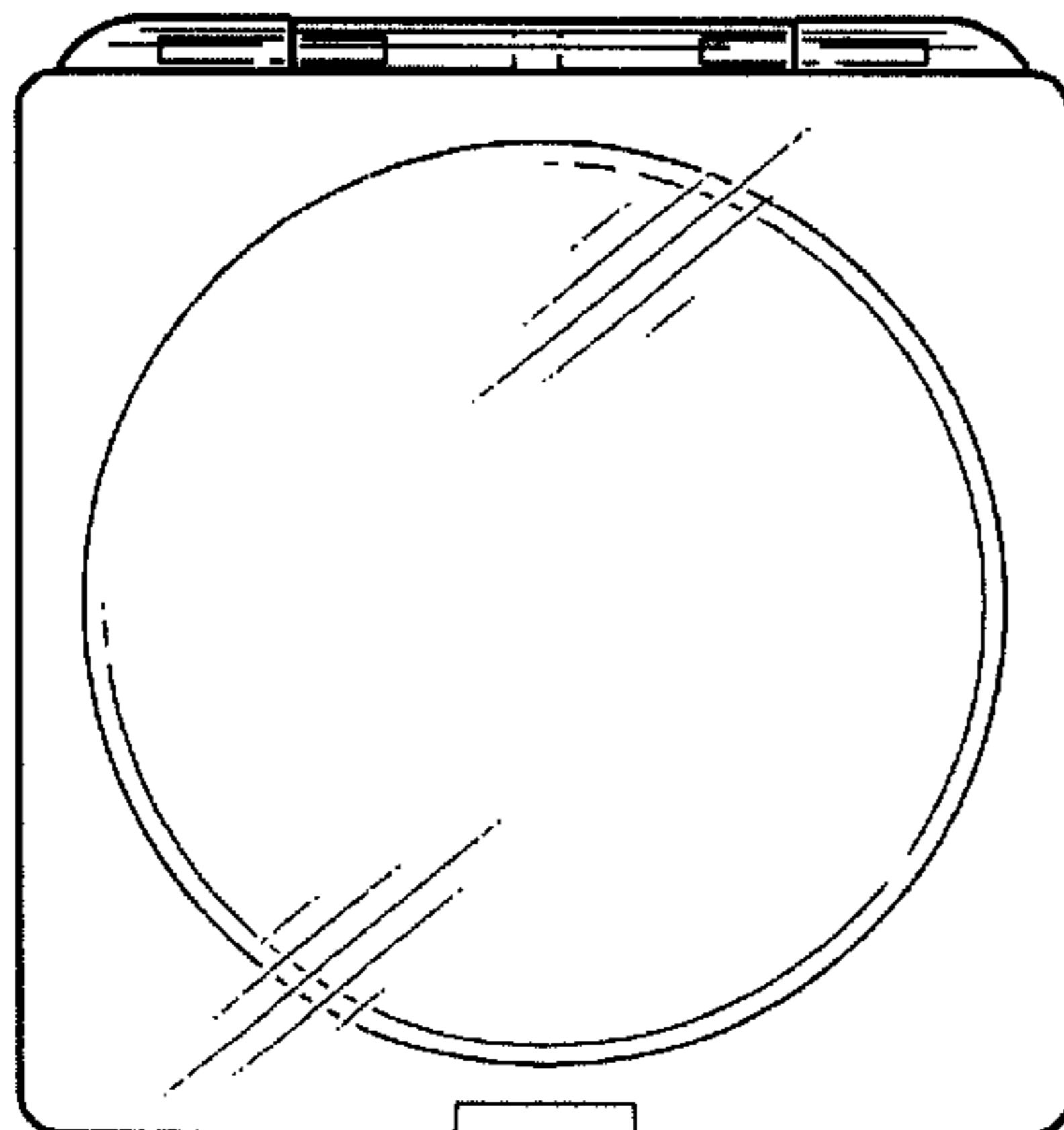

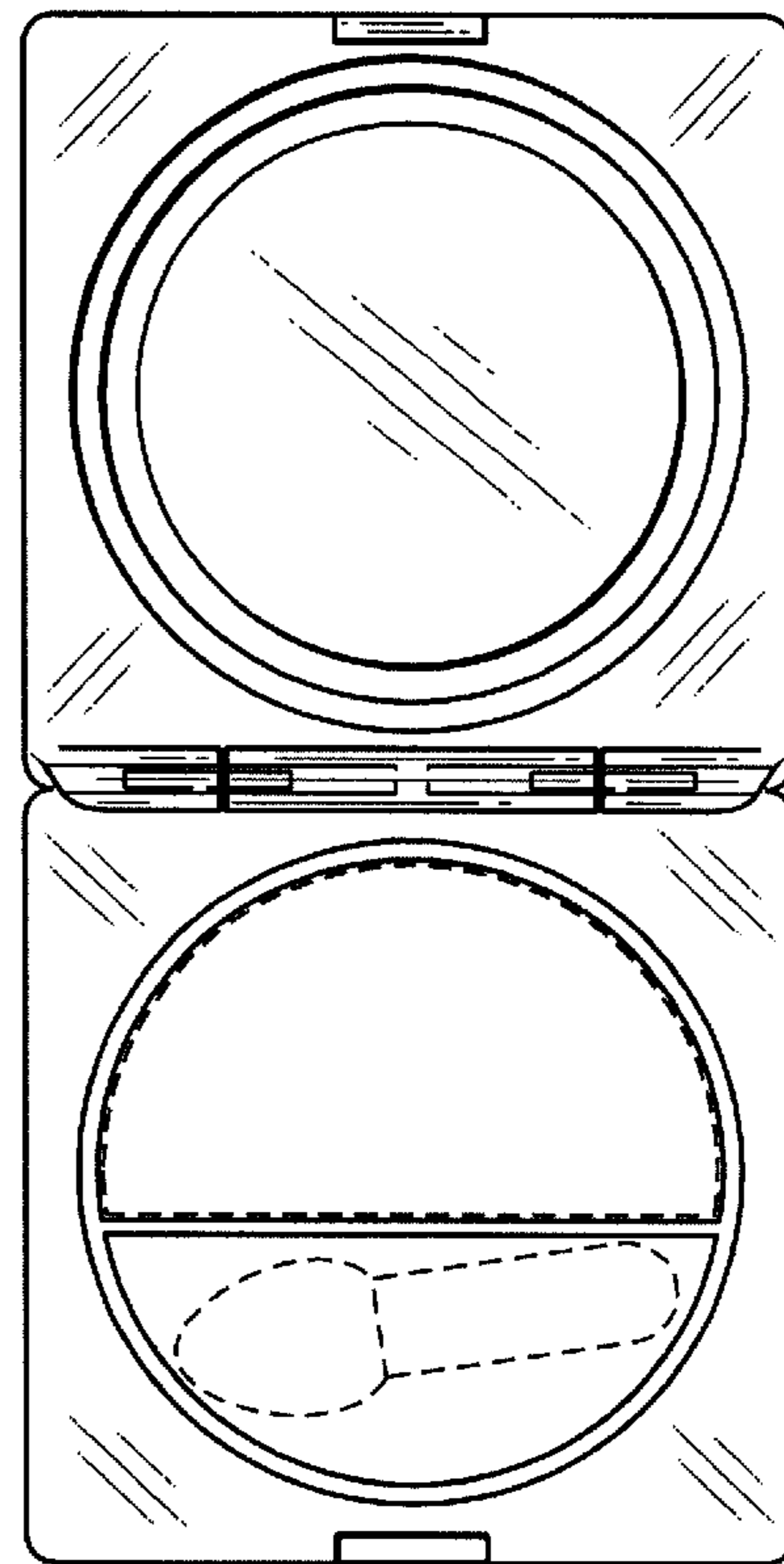

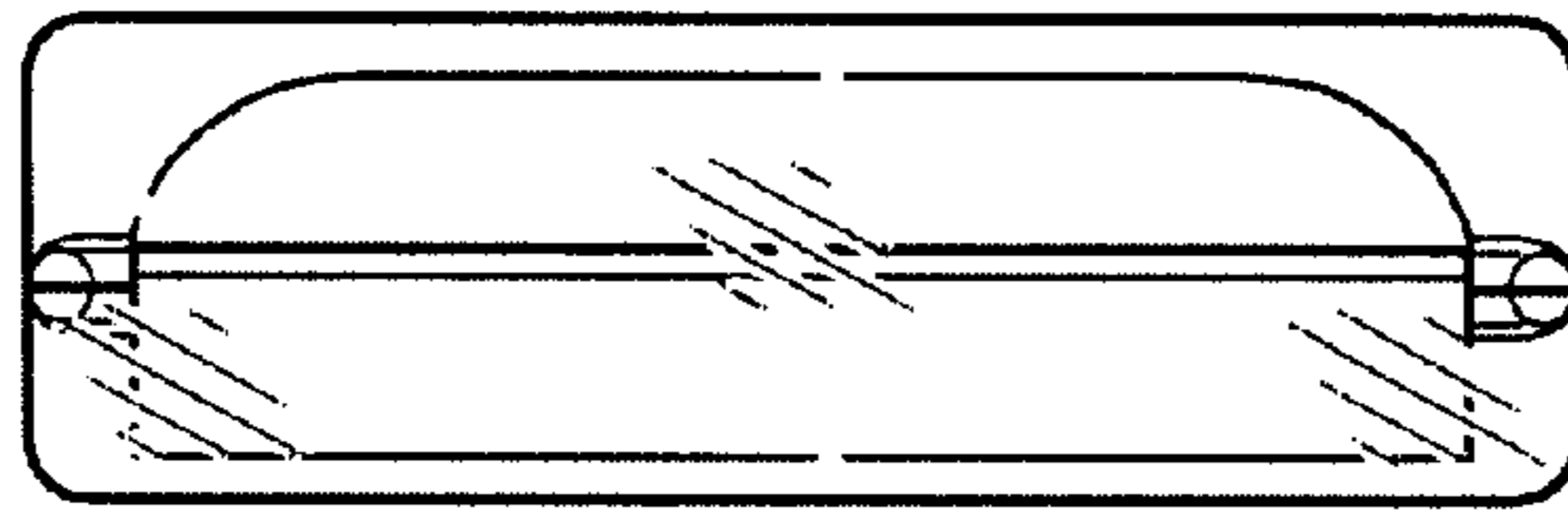

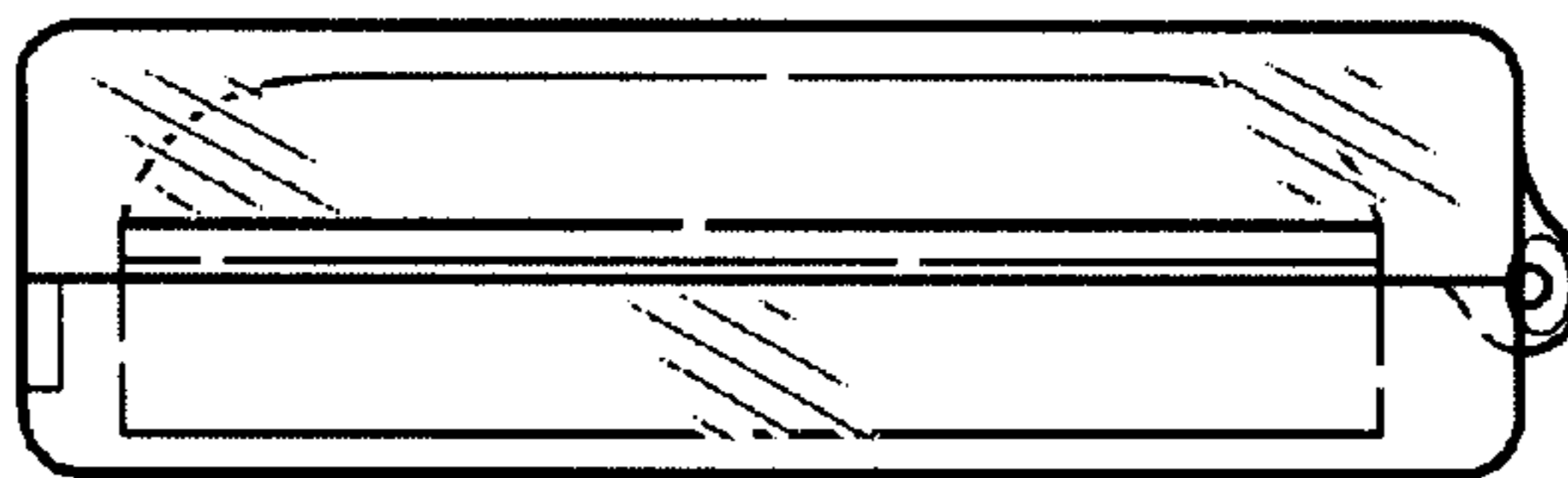

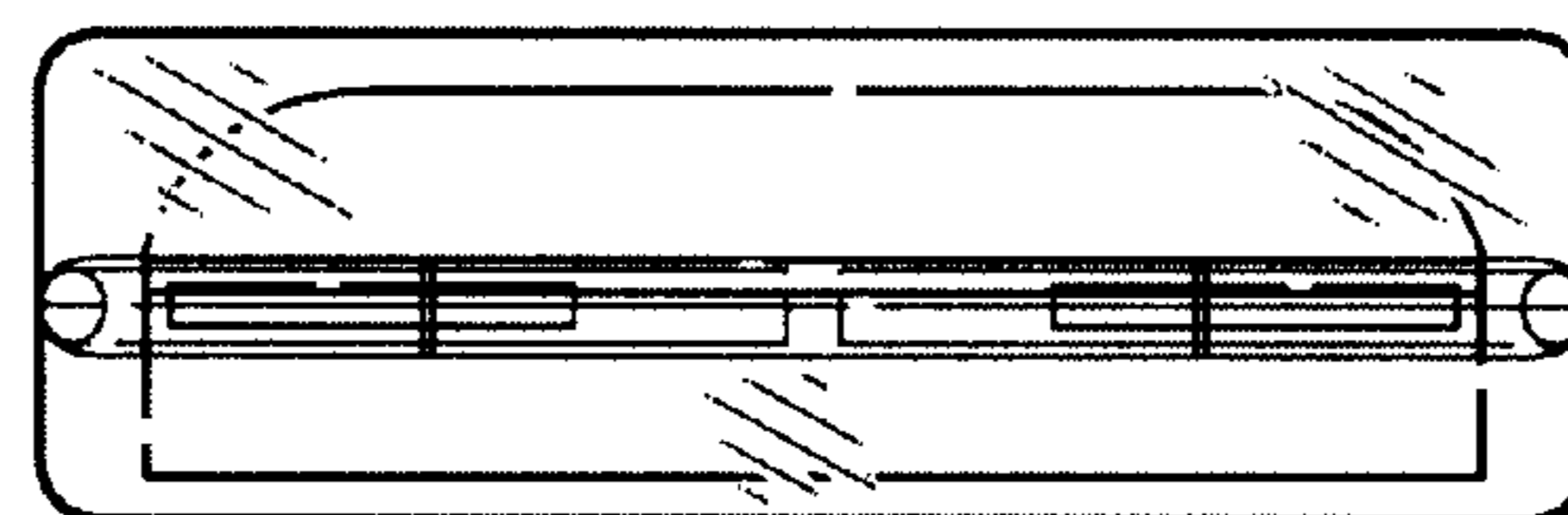
