The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe showing my new design;

FIG. 5 is a bottom view of the shoe shown in FIG. 1;

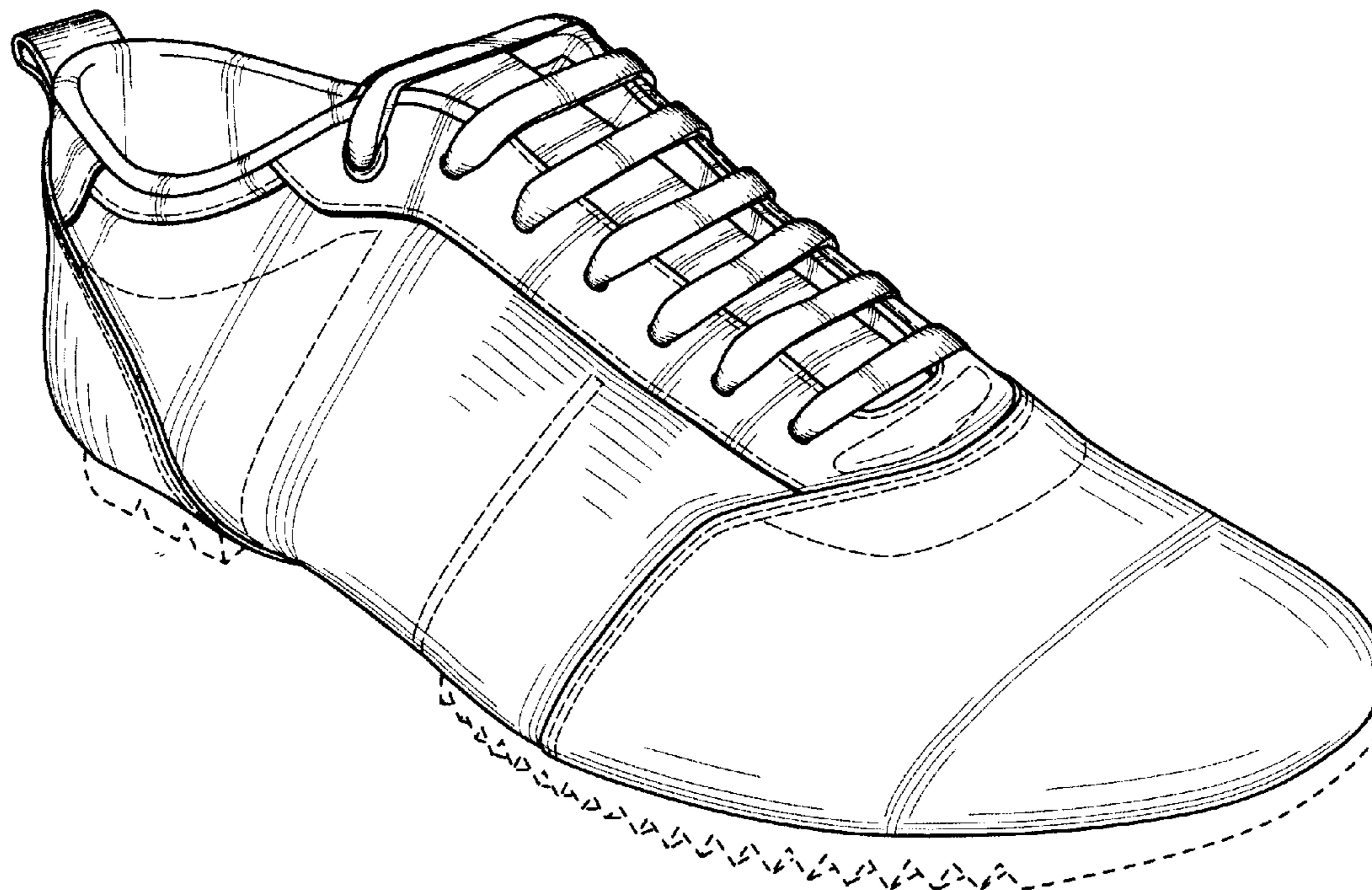
FIG. 6 is a front view of the shoe shown in FIG. 1; and,

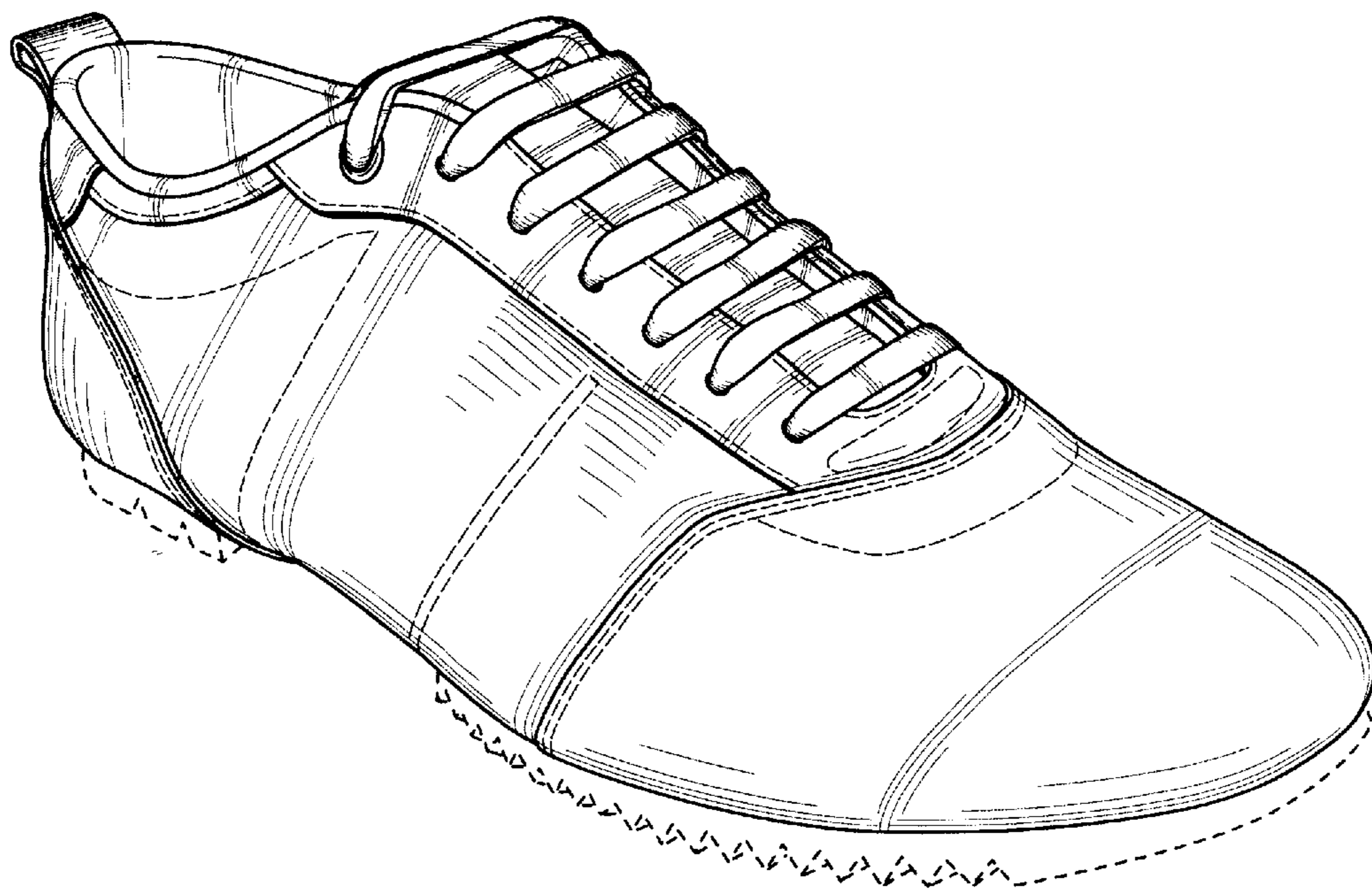

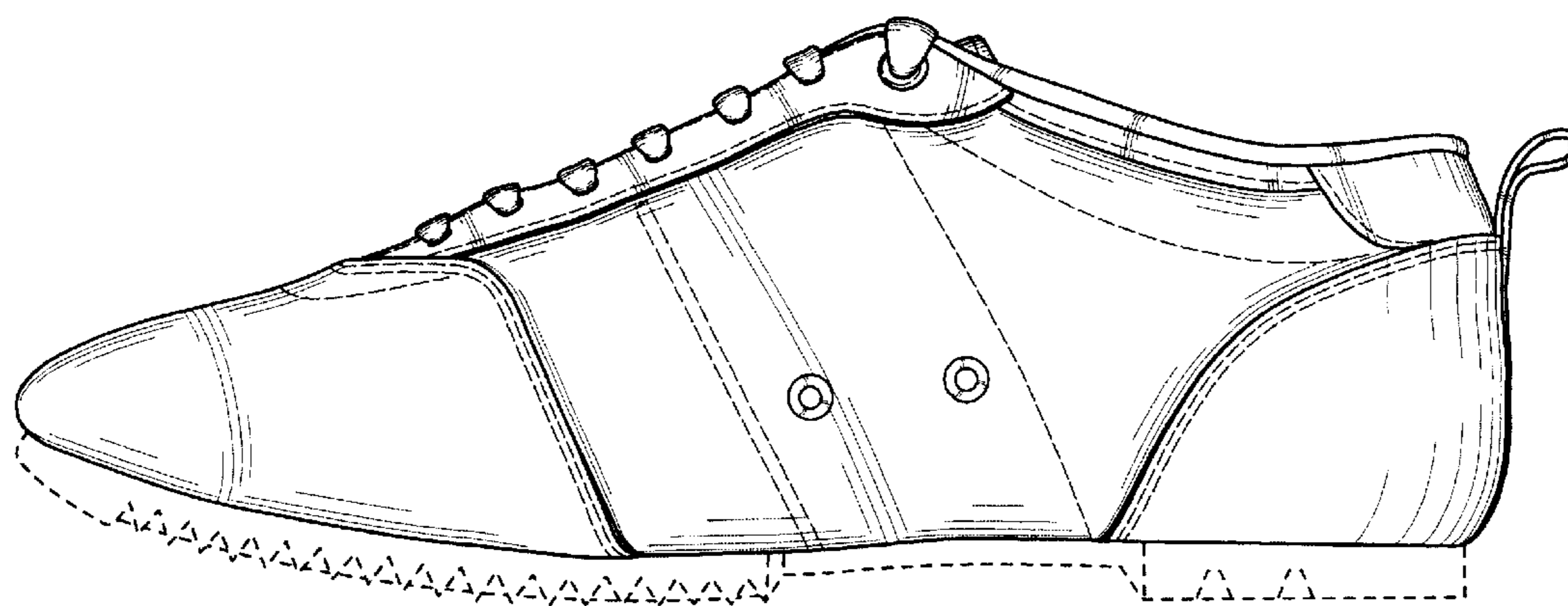

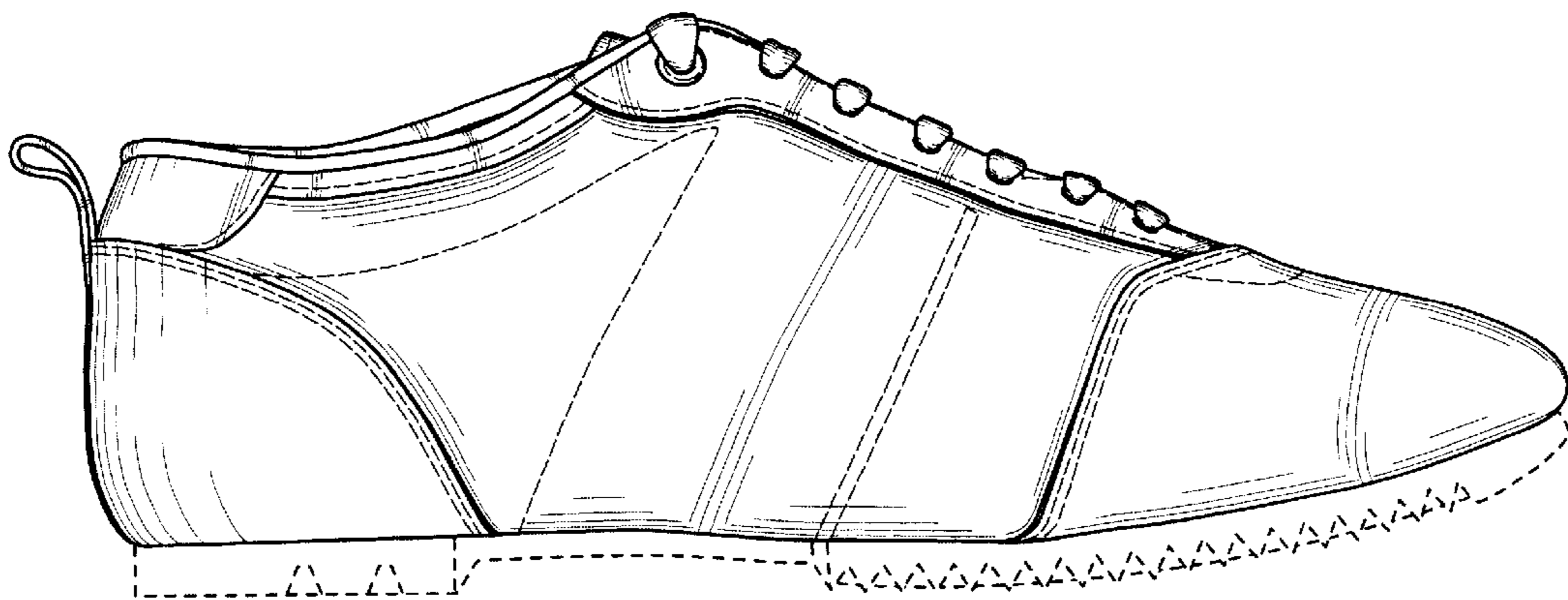

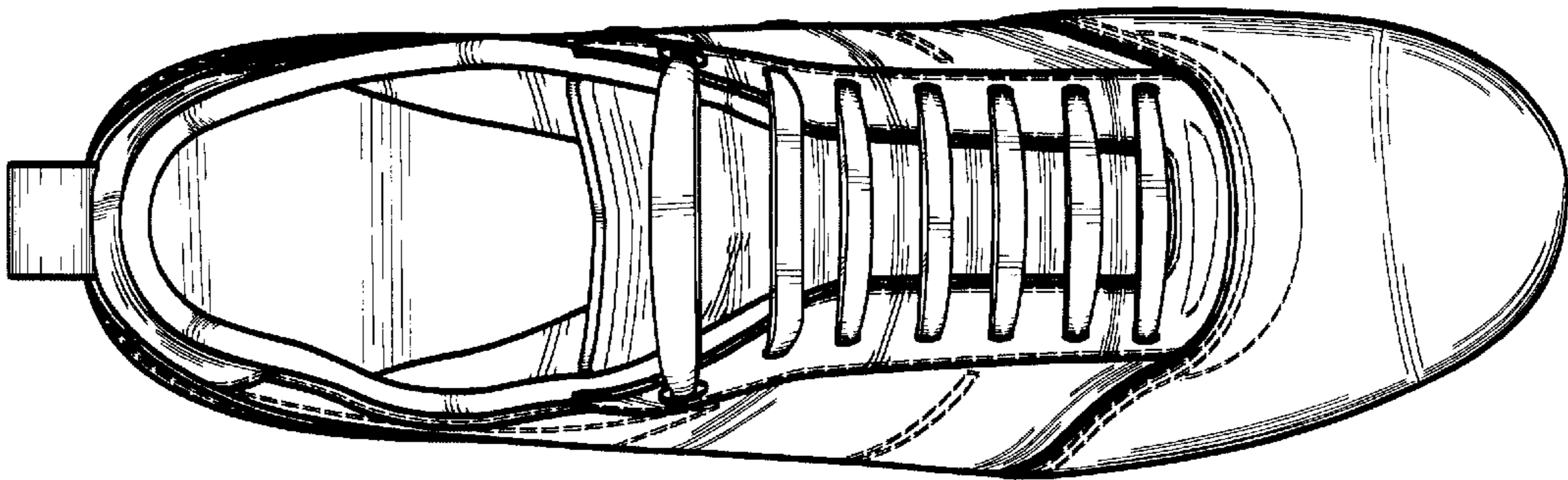

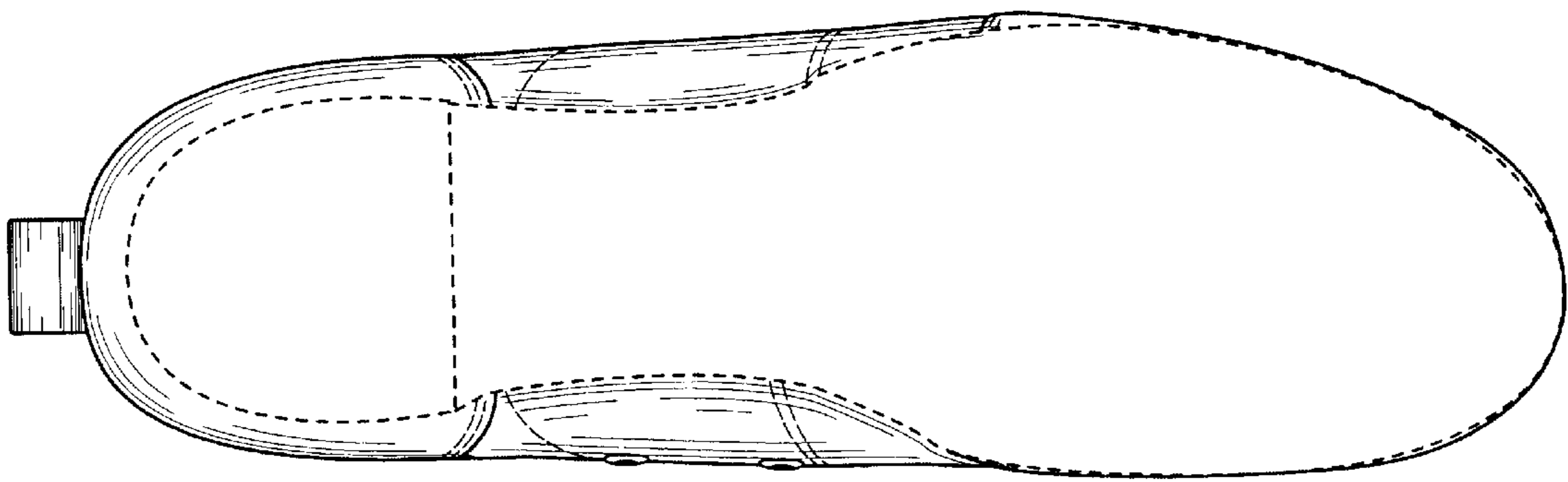

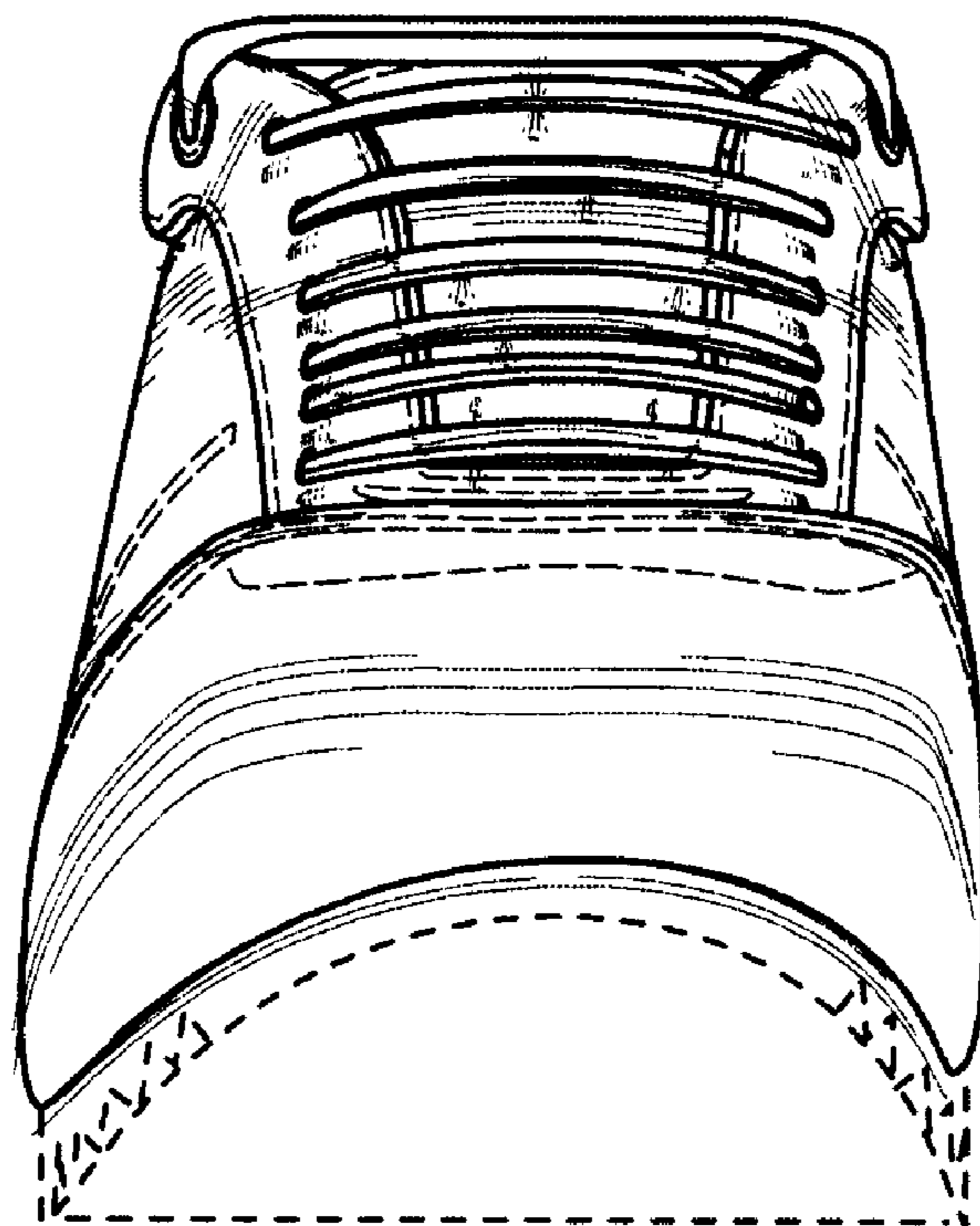

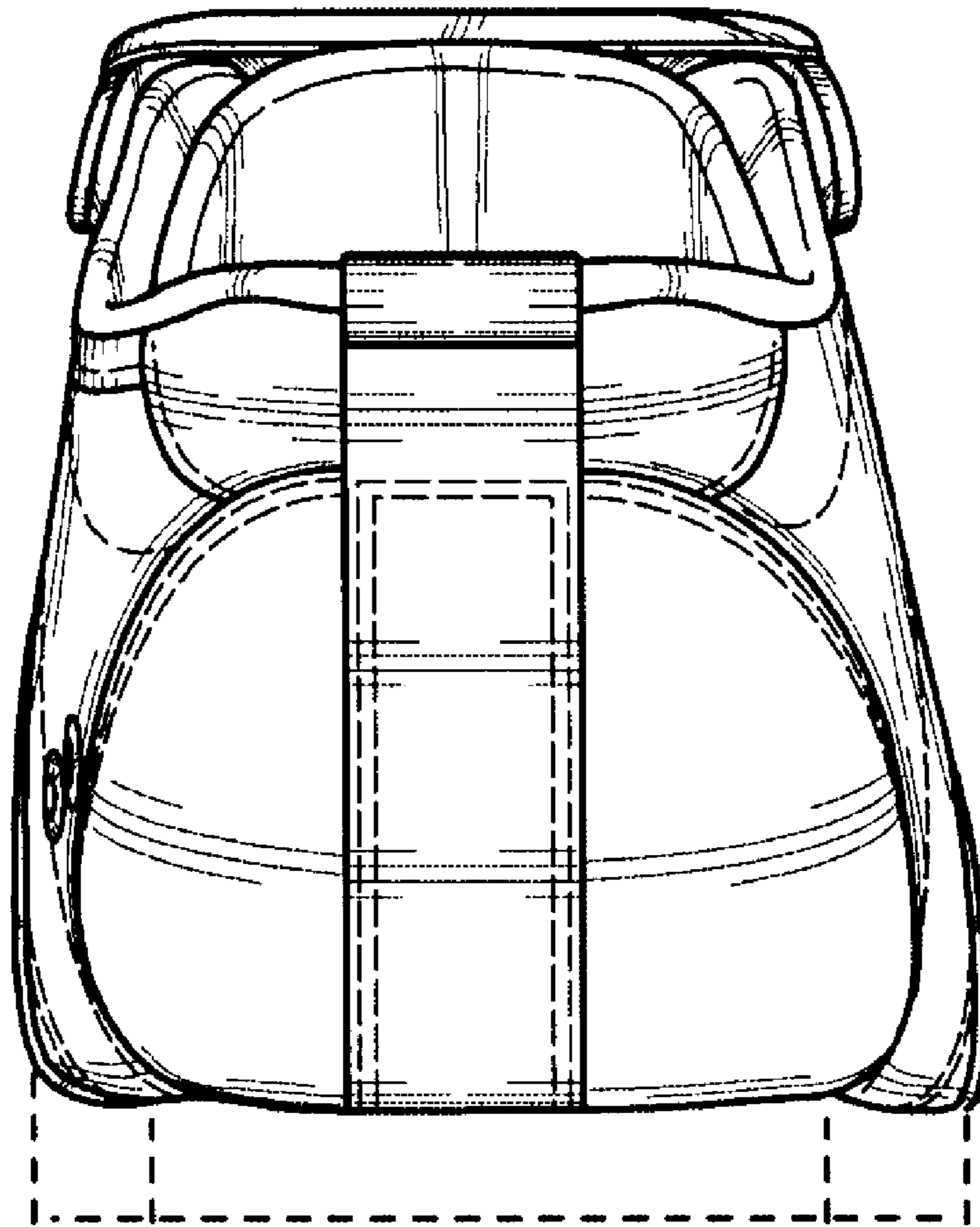
