DESCRIPTION

FIG. 1 is a front elevational view of an end table according to an embodiment of the invention.

FIG. 2 is a side elevational view of an end table according to an embodiment of the invention.

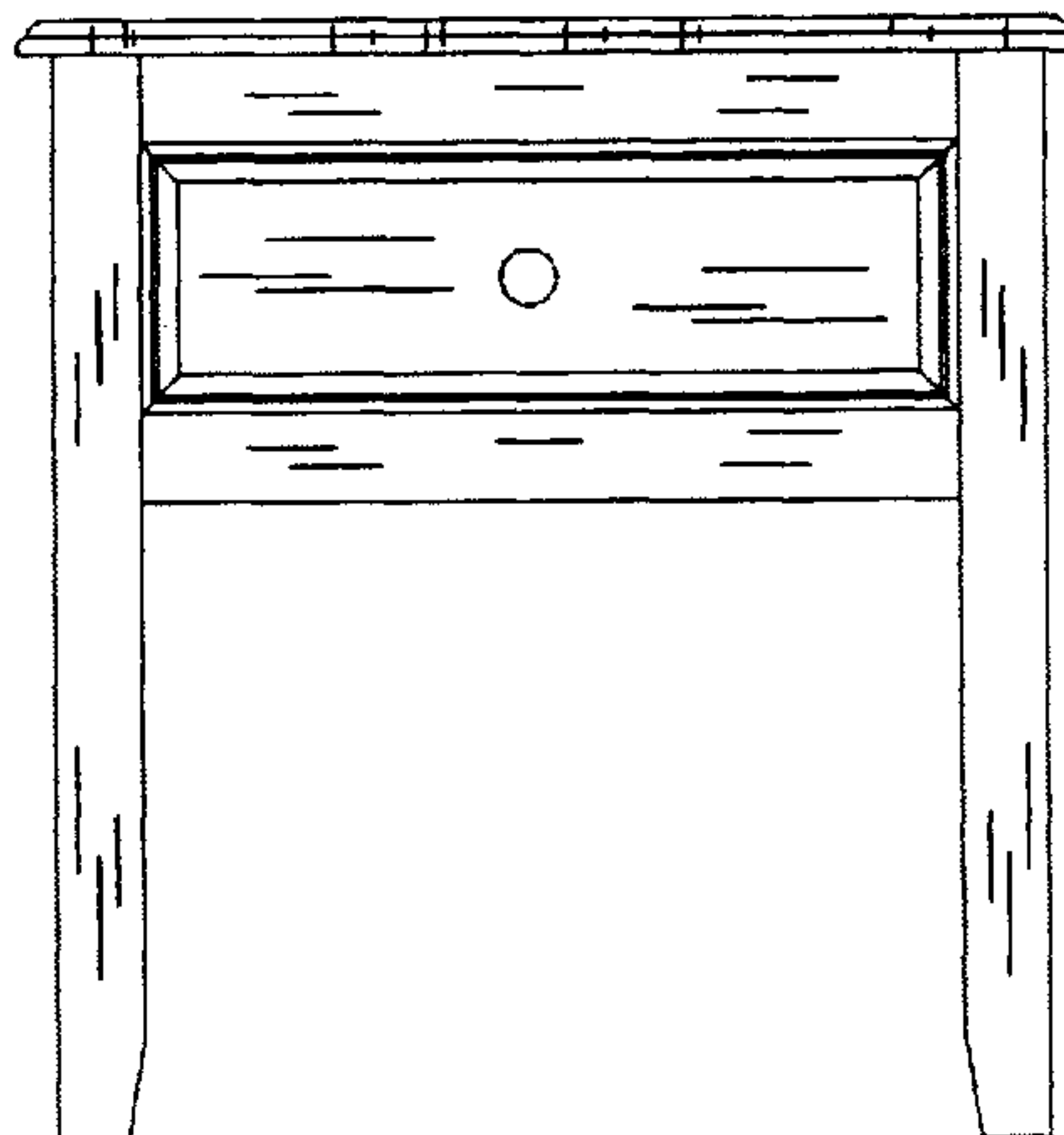
FIG. 3 is a back elevational view of an end table according to an embodiment of the invention.

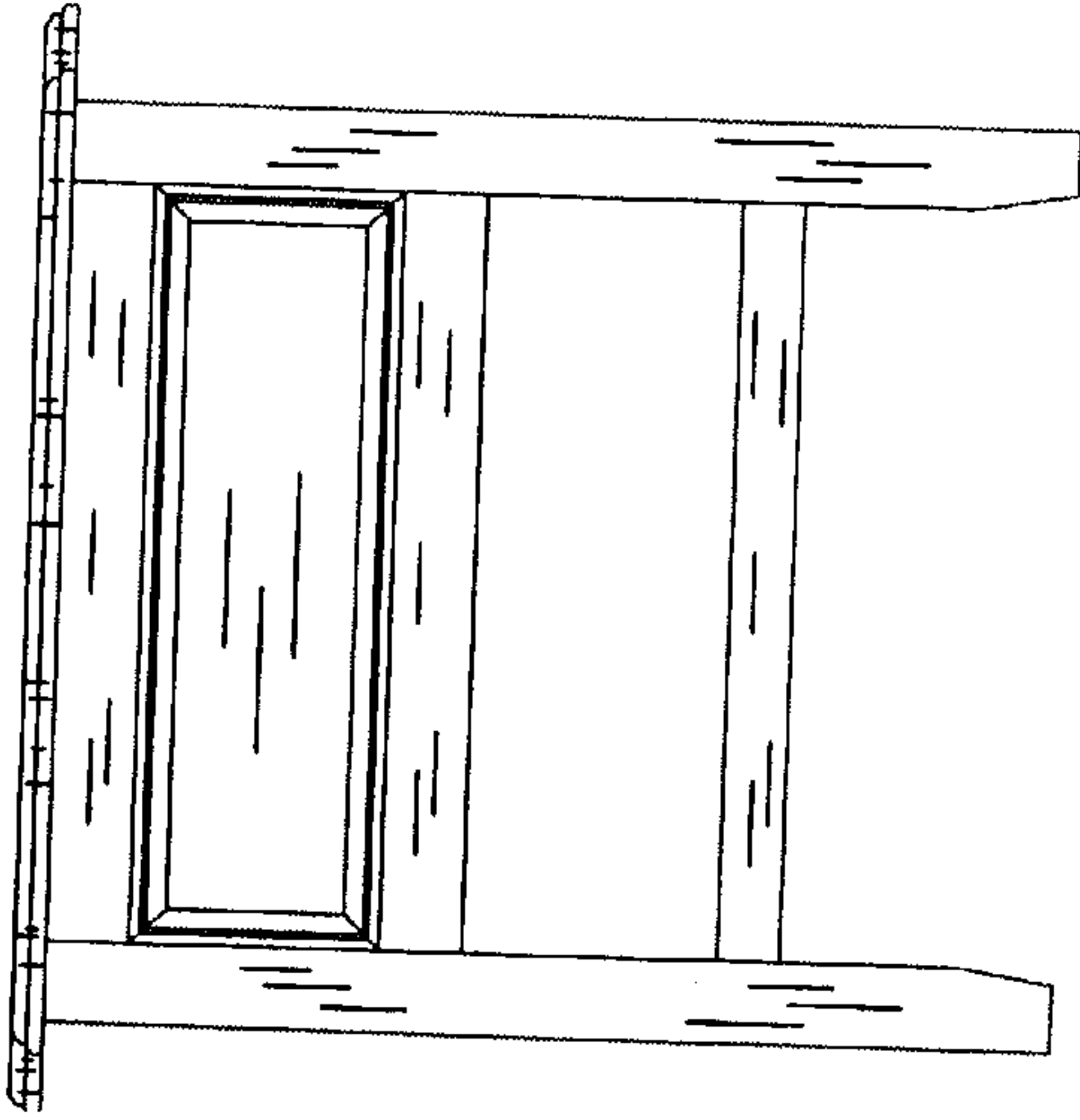

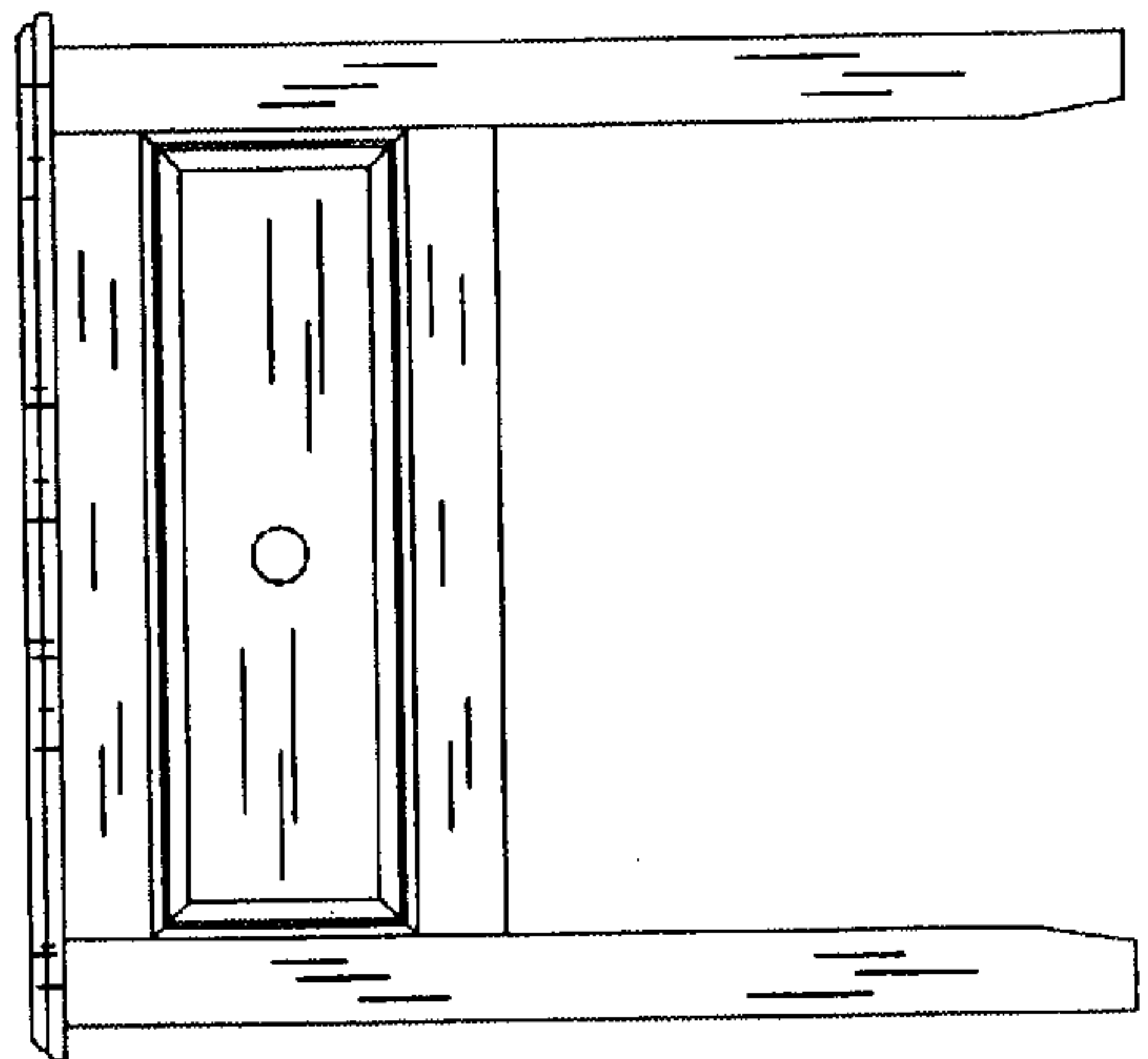

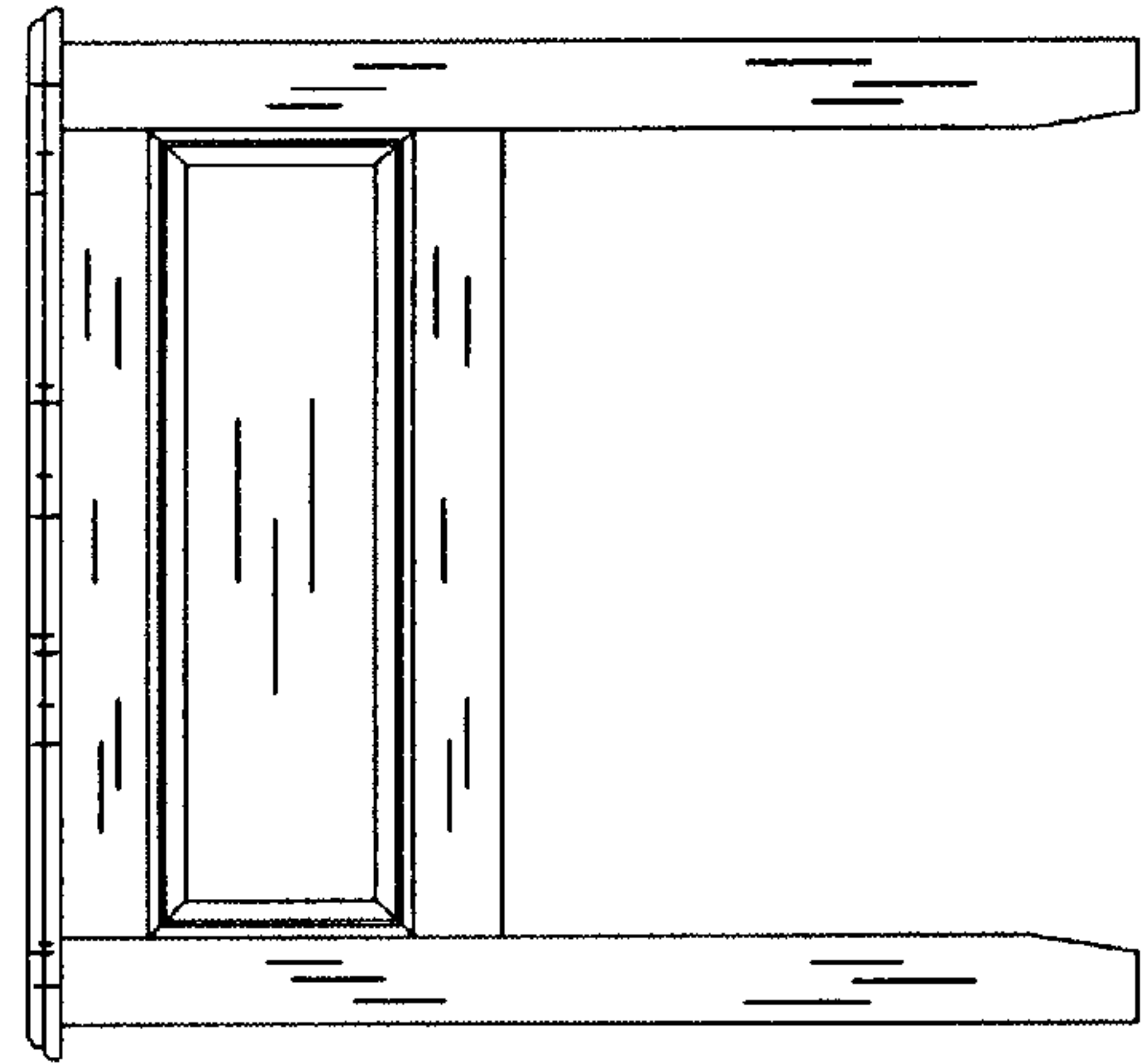

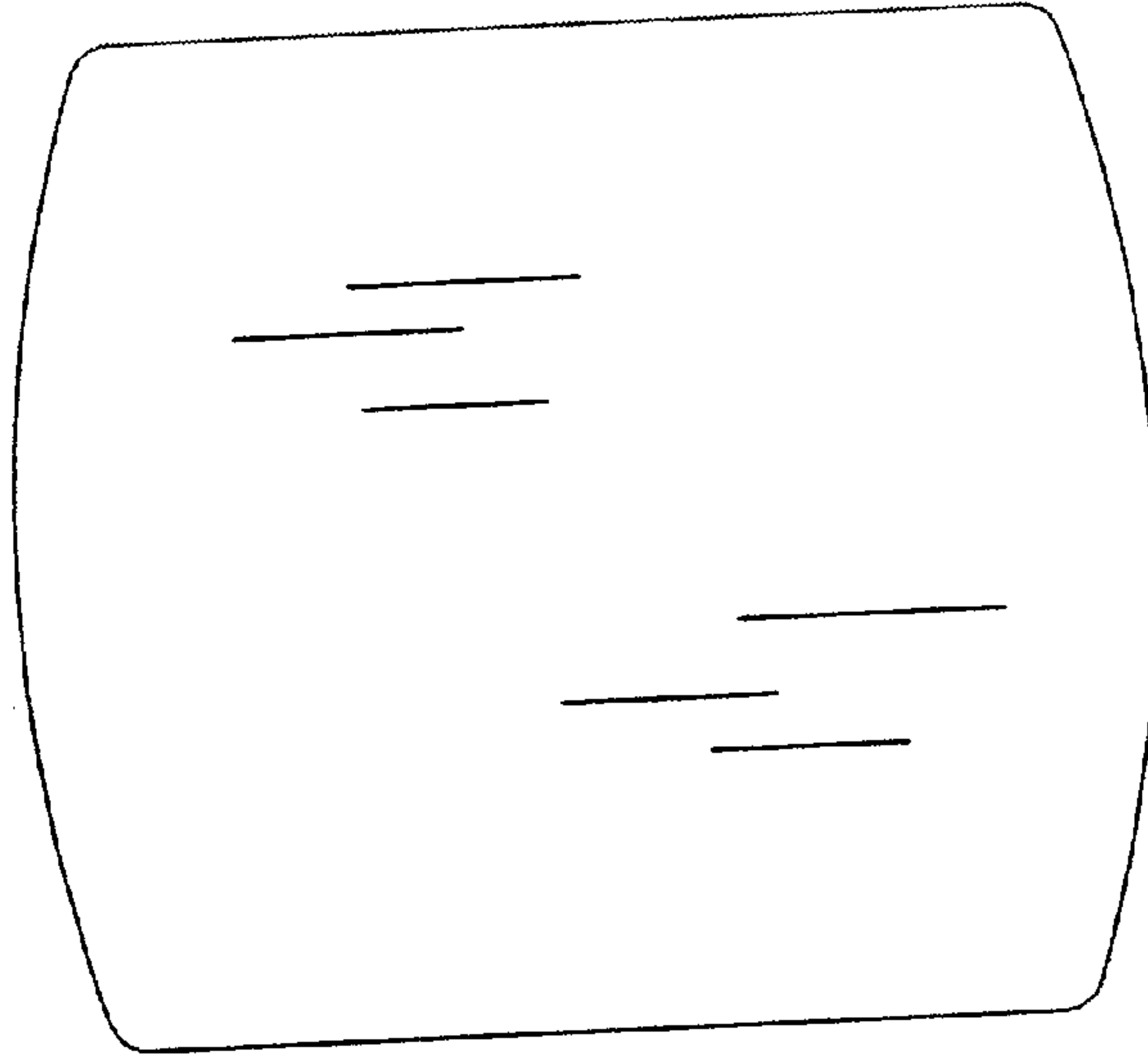
