(57) **CLAIM**

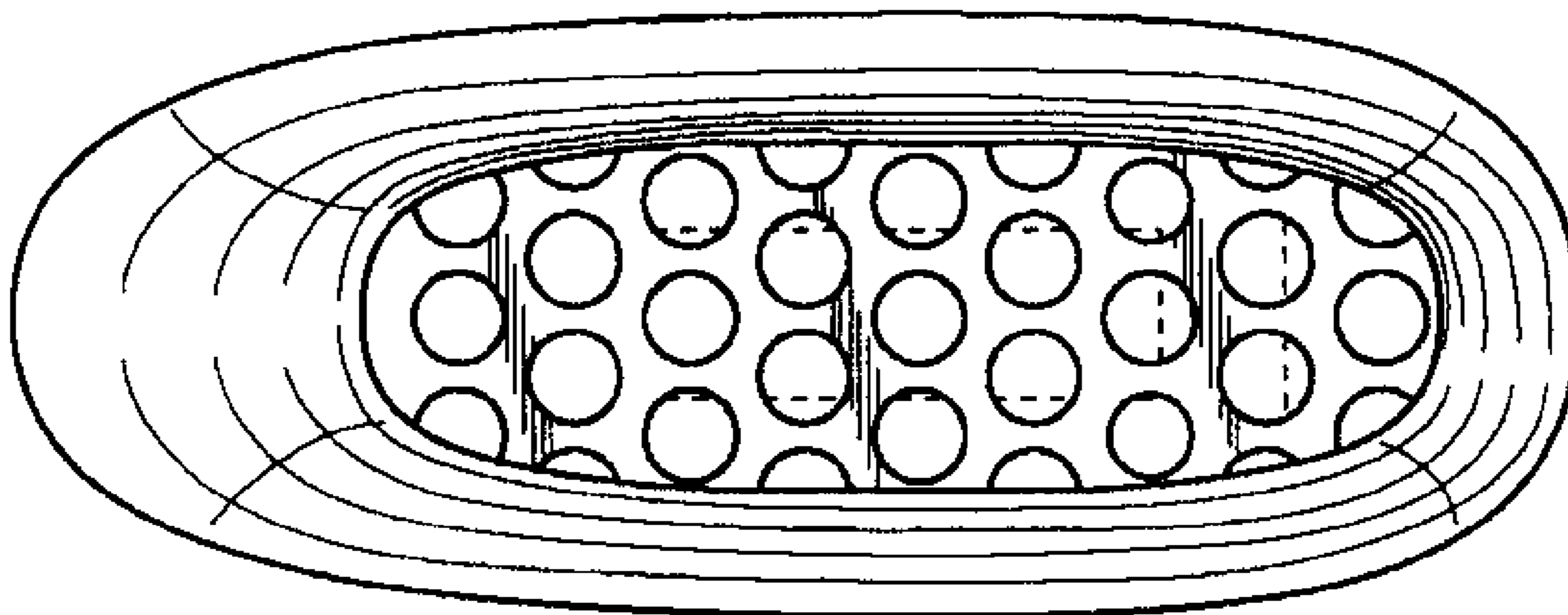
The ornamental design for a portion of a child car seat, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a portion of a child car seat embodying the new design; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a top view thereof; FIG. 5 is a bottom view thereof; FIG. 6 is a right side view thereof; FIG. 7 is a left side view thereof; and, FIG. 8 is an enlarged view of the portion denoted *a— $a'$*  and *b— $b'$*  in FIG. 2.

The portions of the drawings shown in broken lines are environmental structures or boundaries only, and form no part of the claimed design.

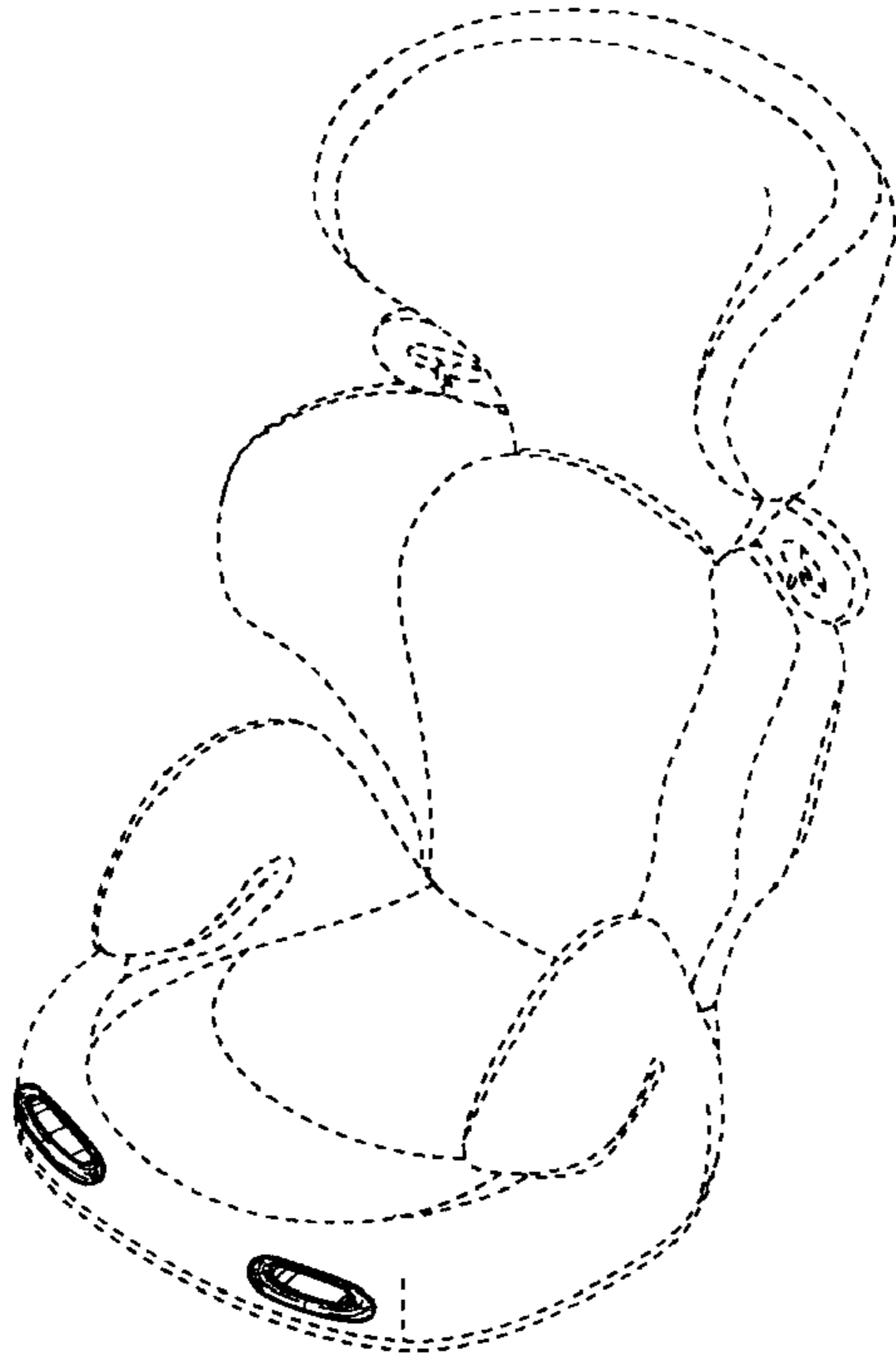

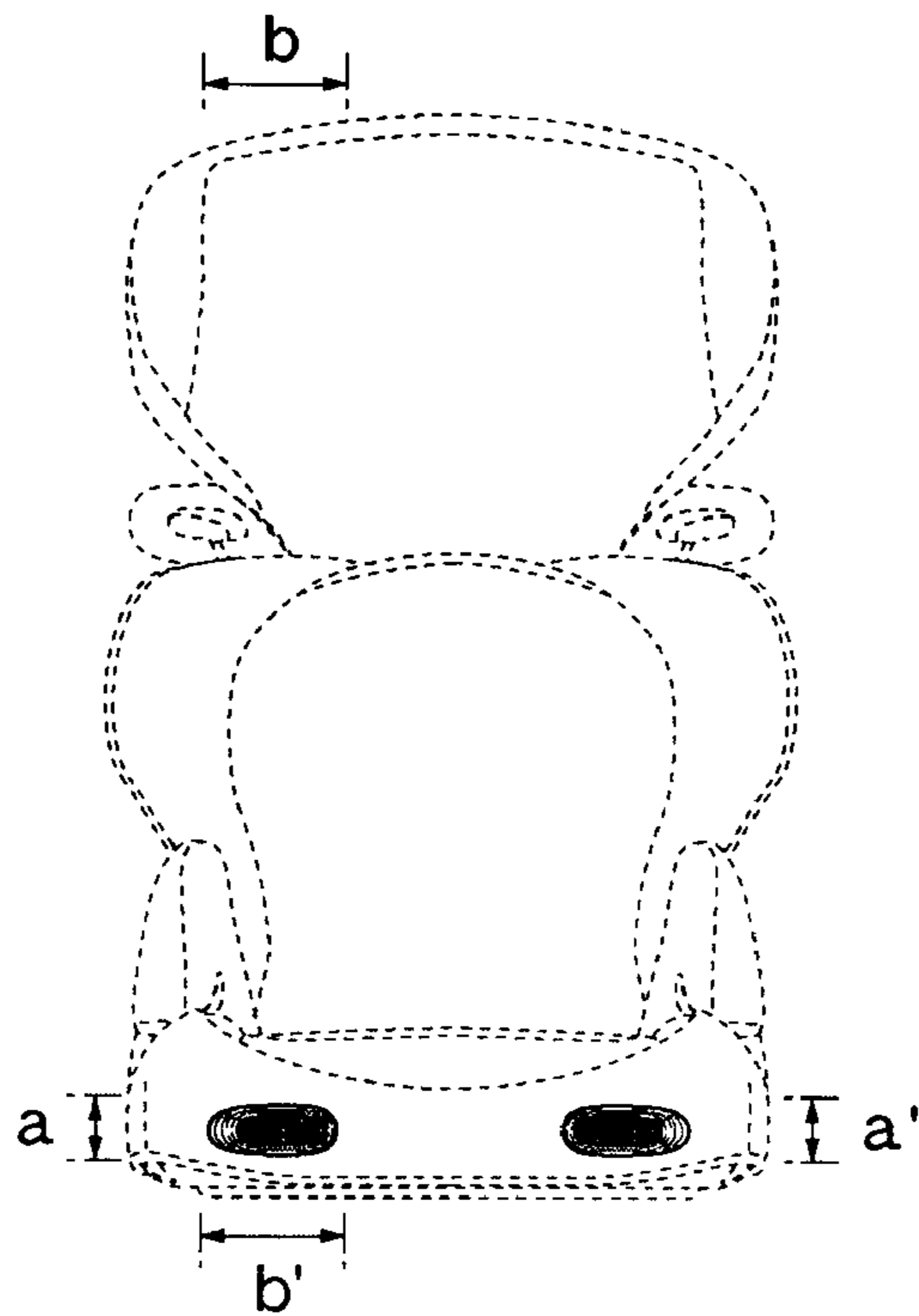

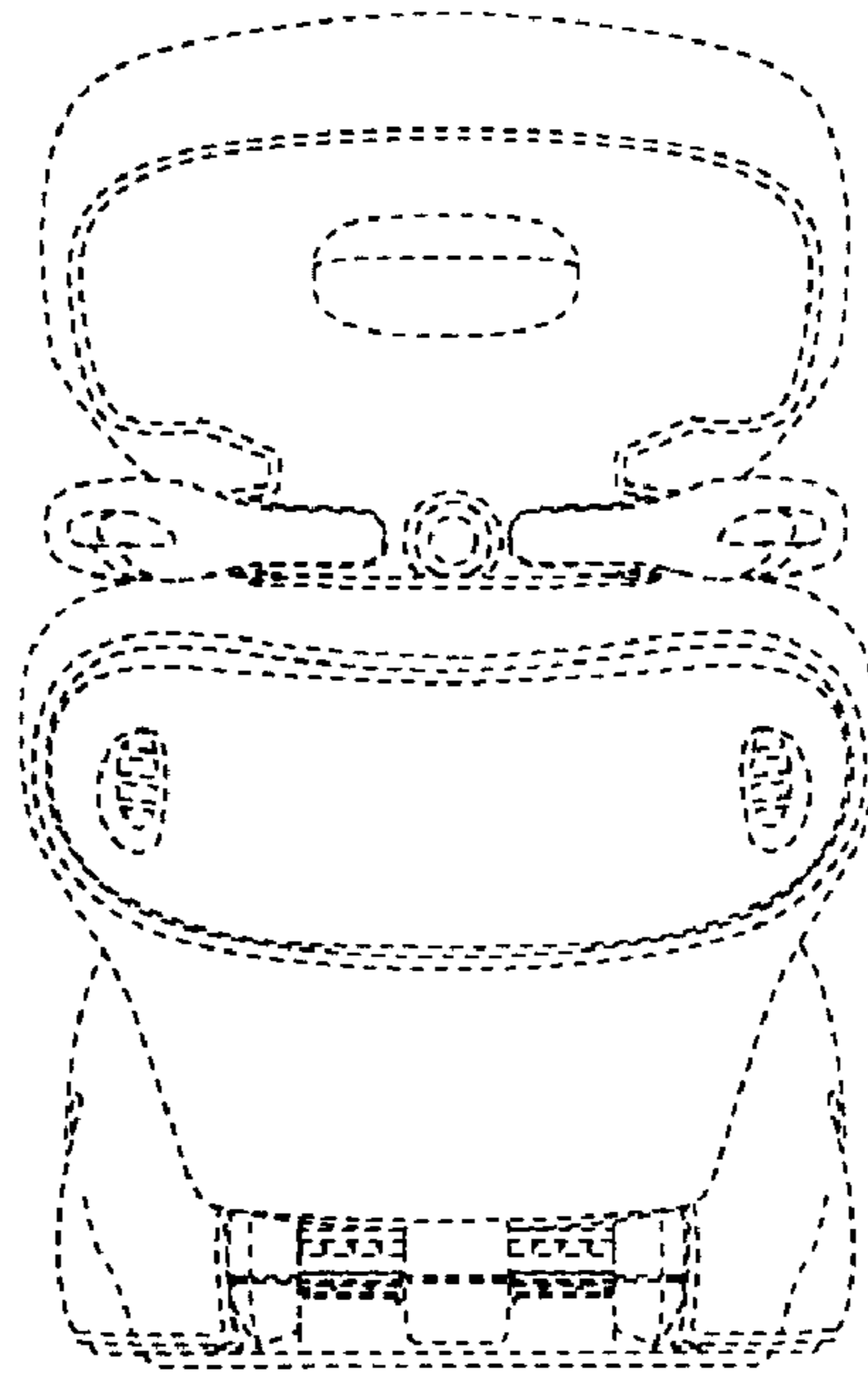

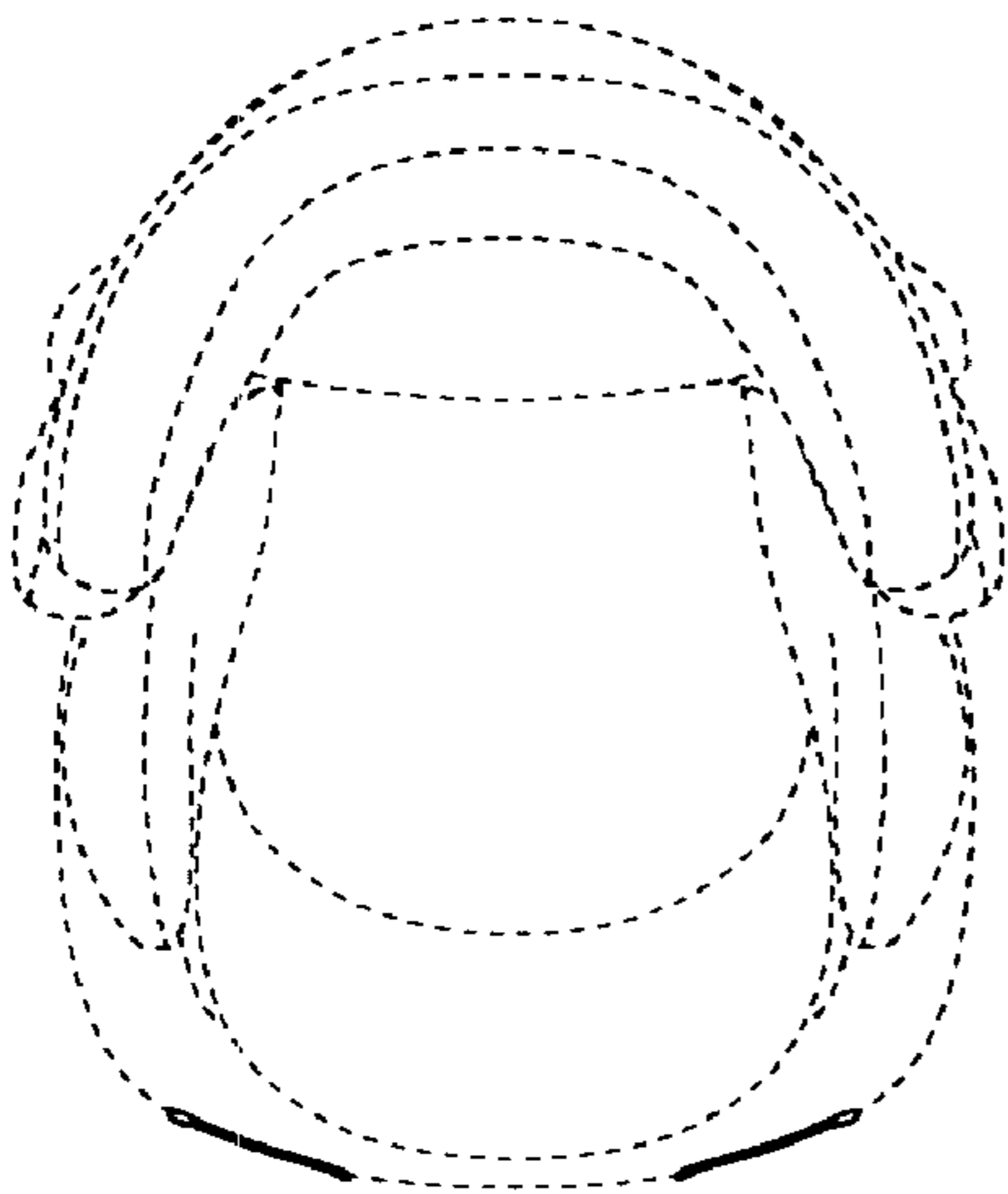

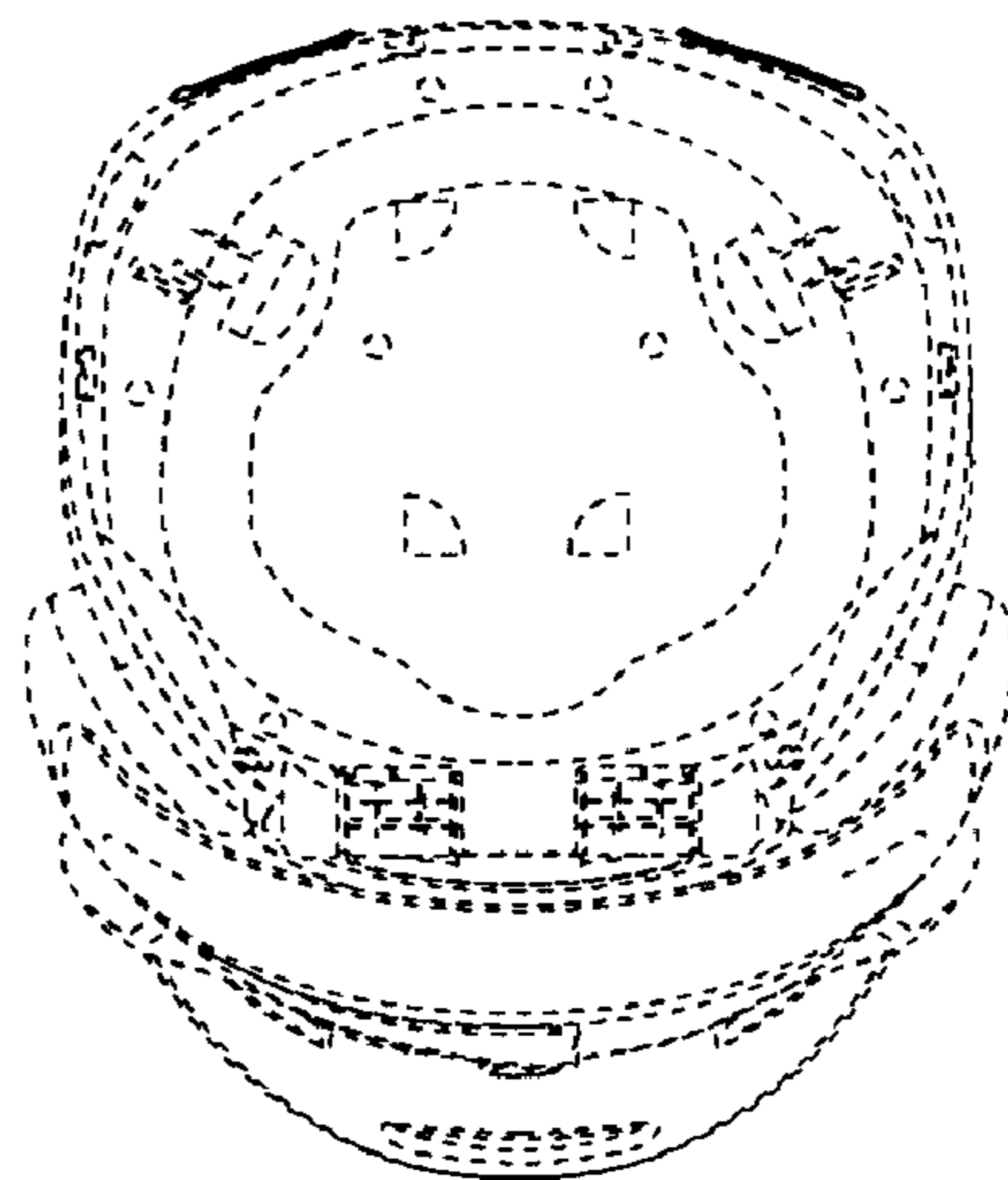

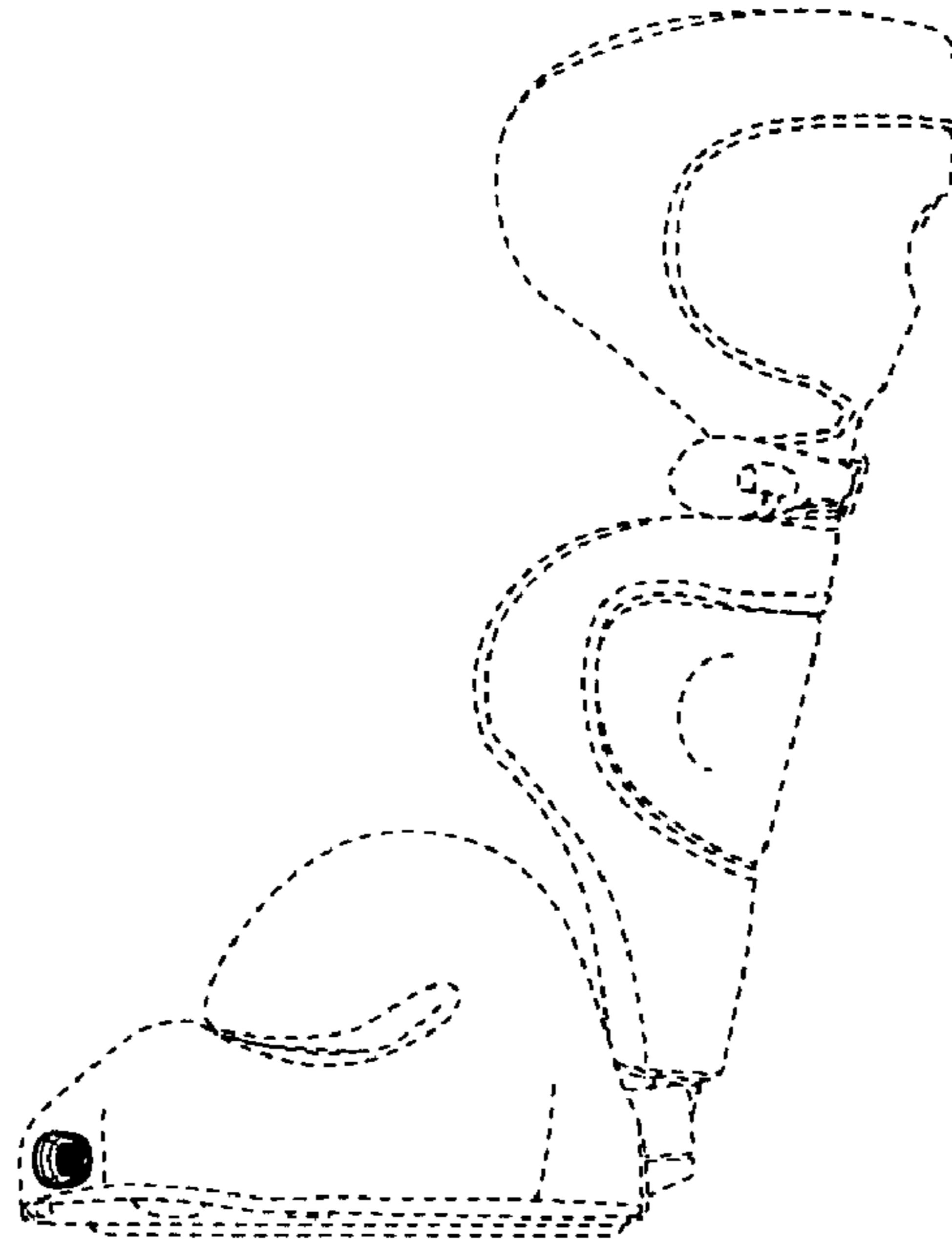

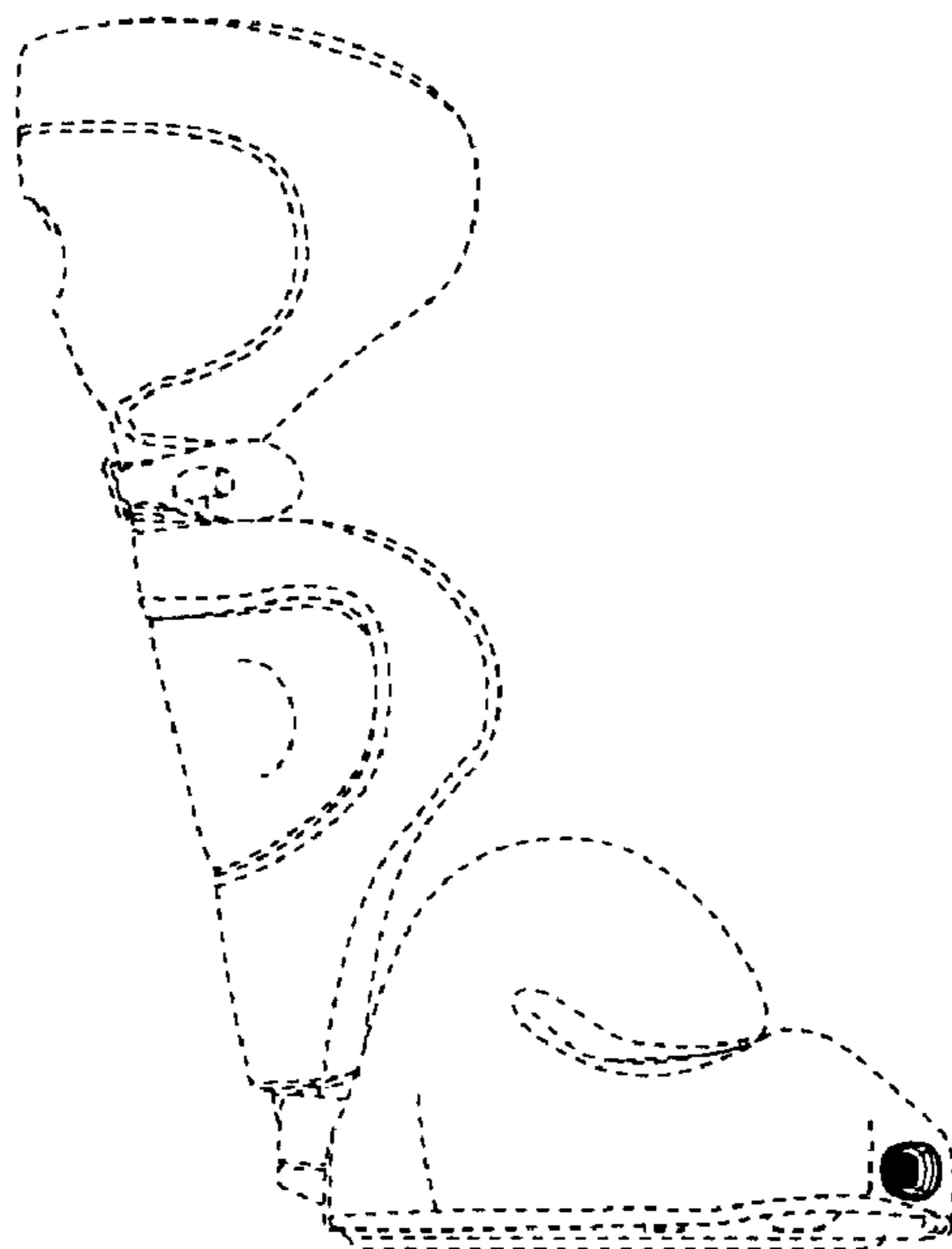
