FIG. 3 is a rear elevational view of the ornamental design of the present invention;

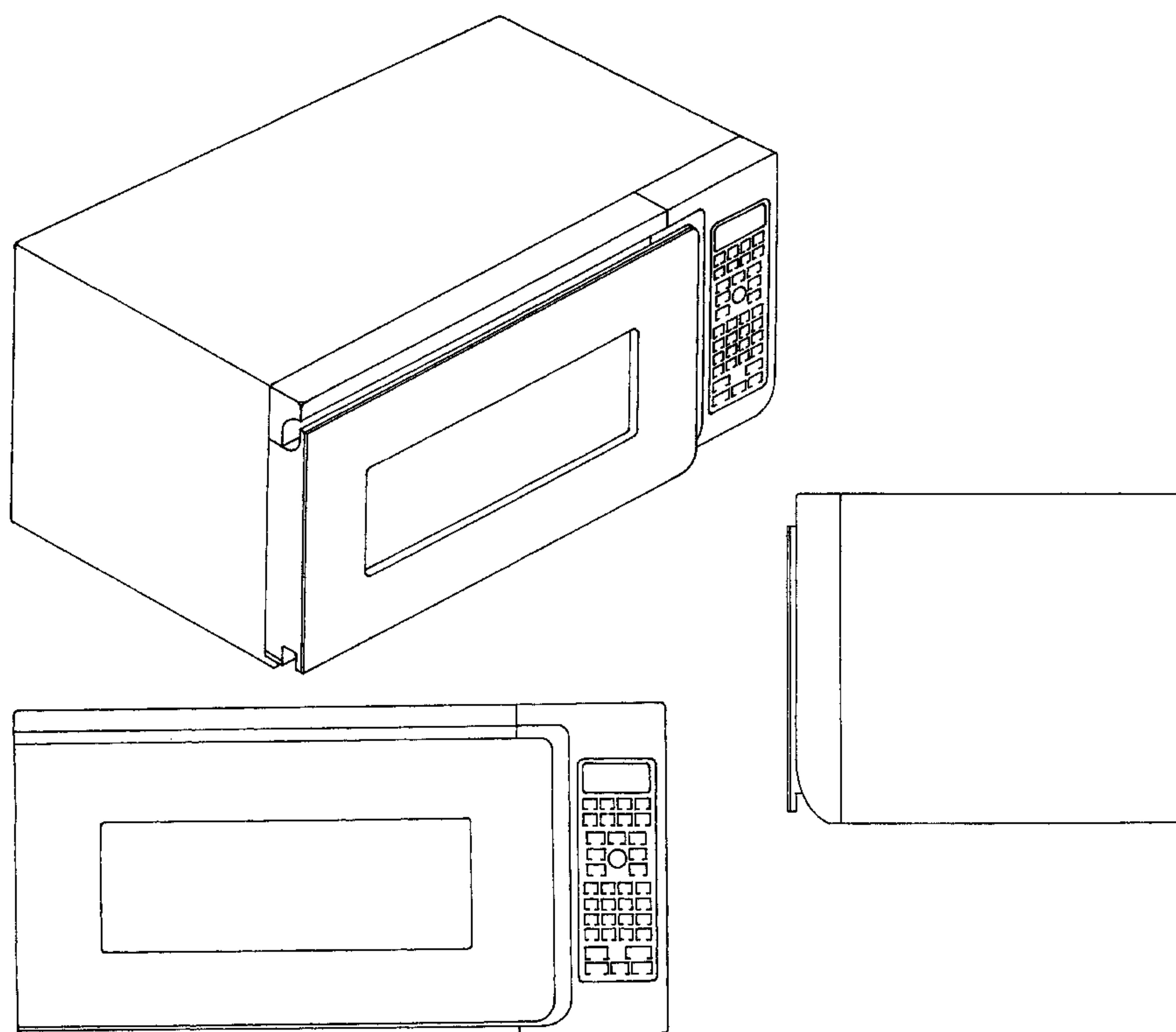
FIG. 4 is a left side elevational view of the ornamental design of the present invention;

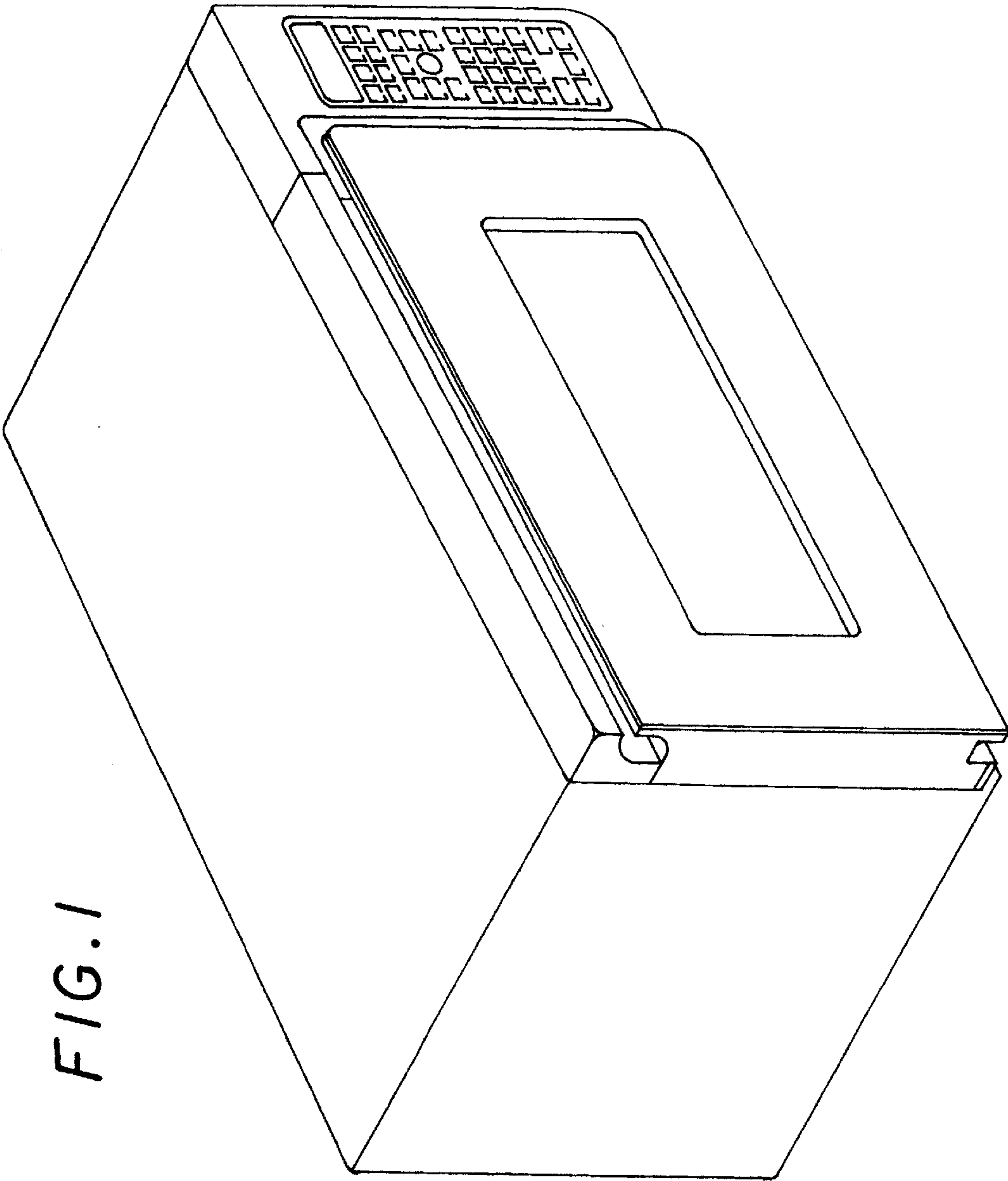

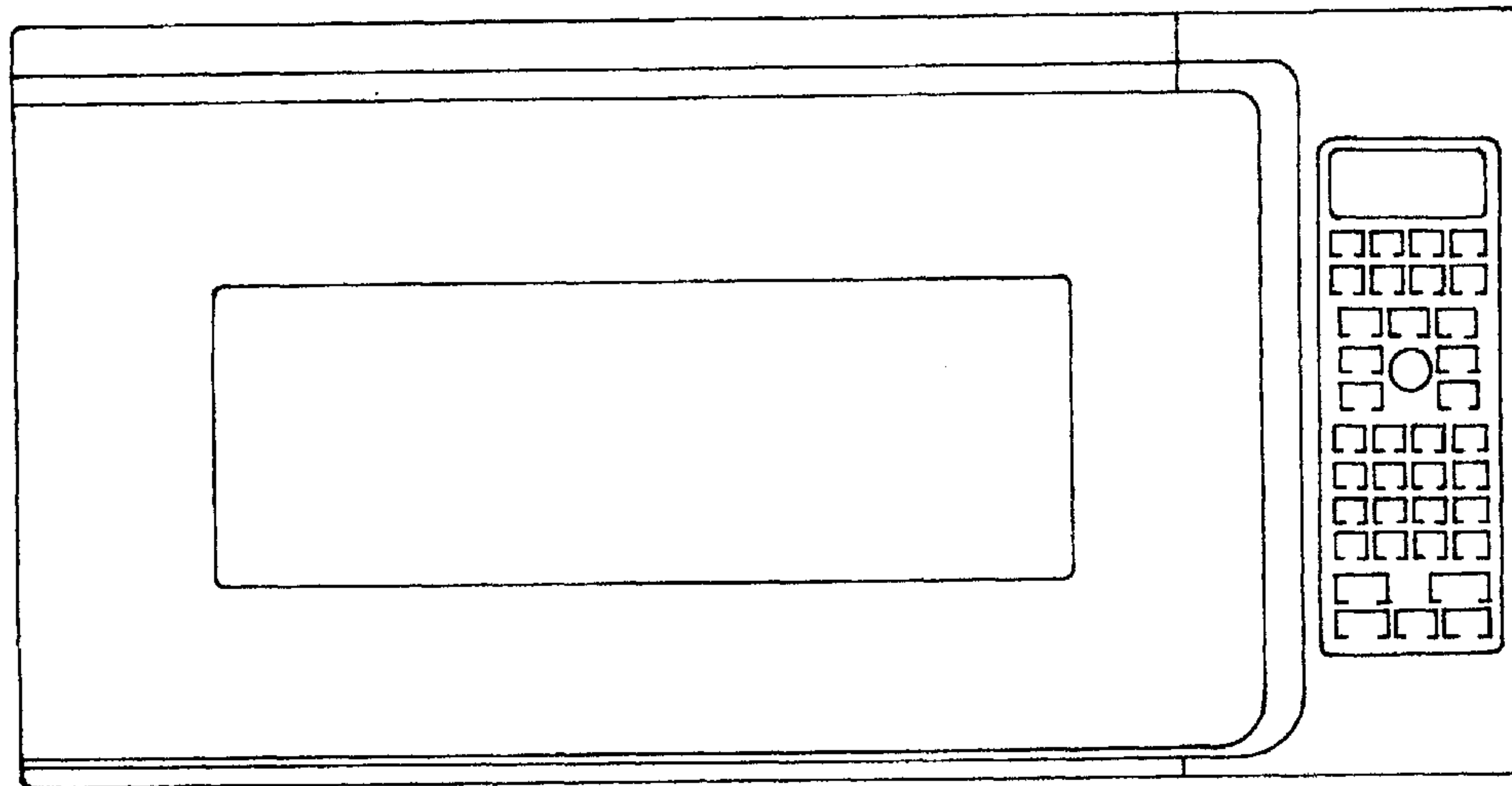

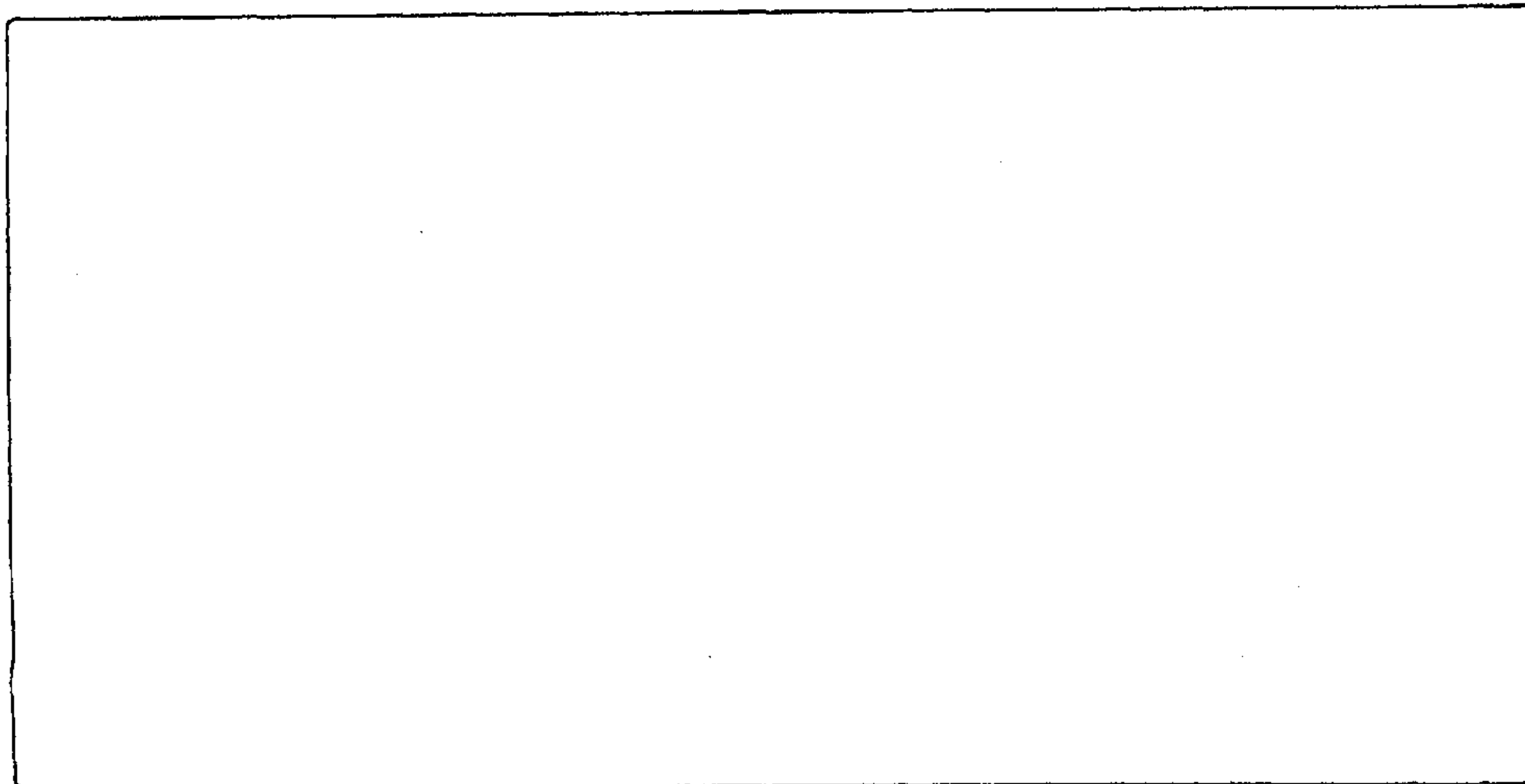

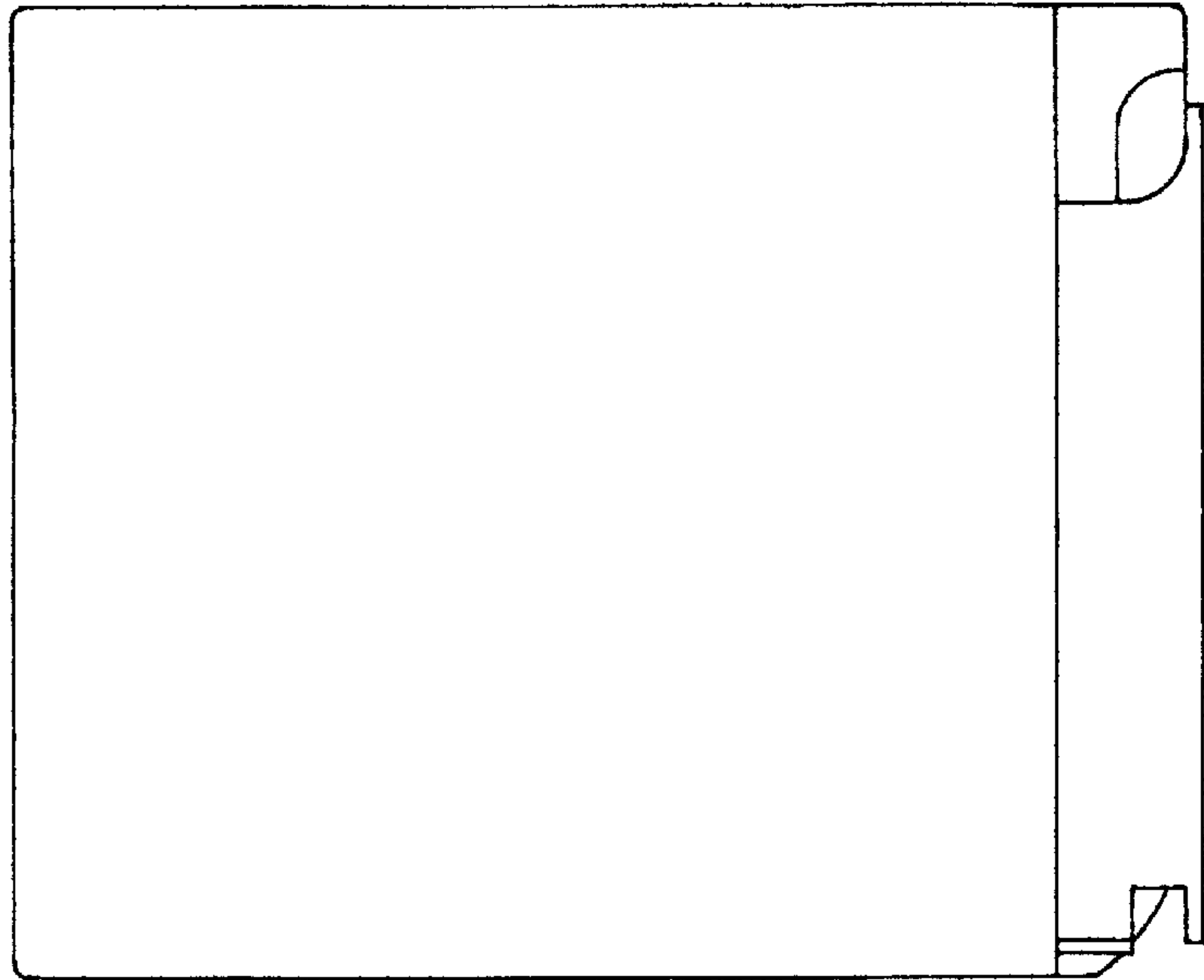

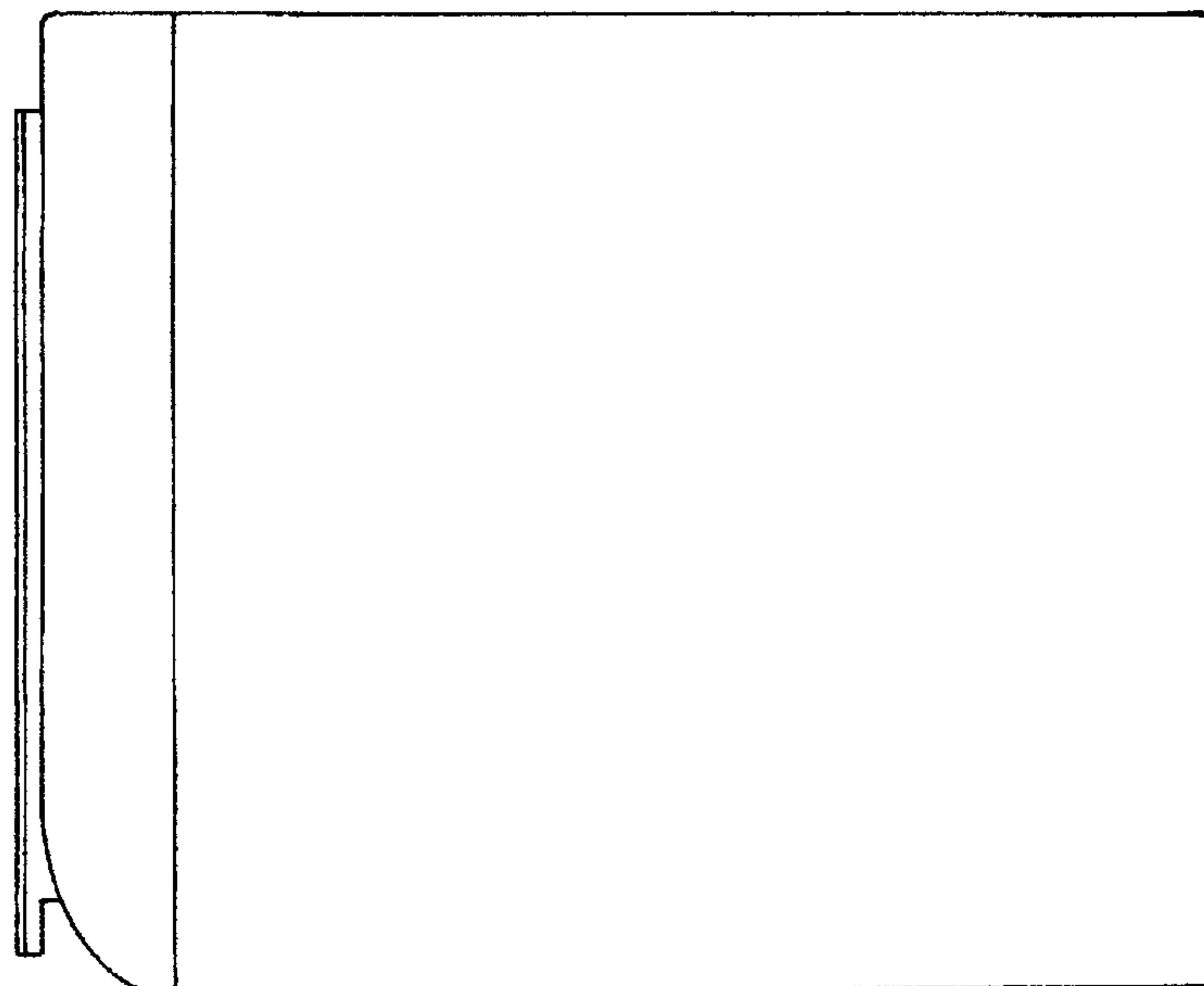

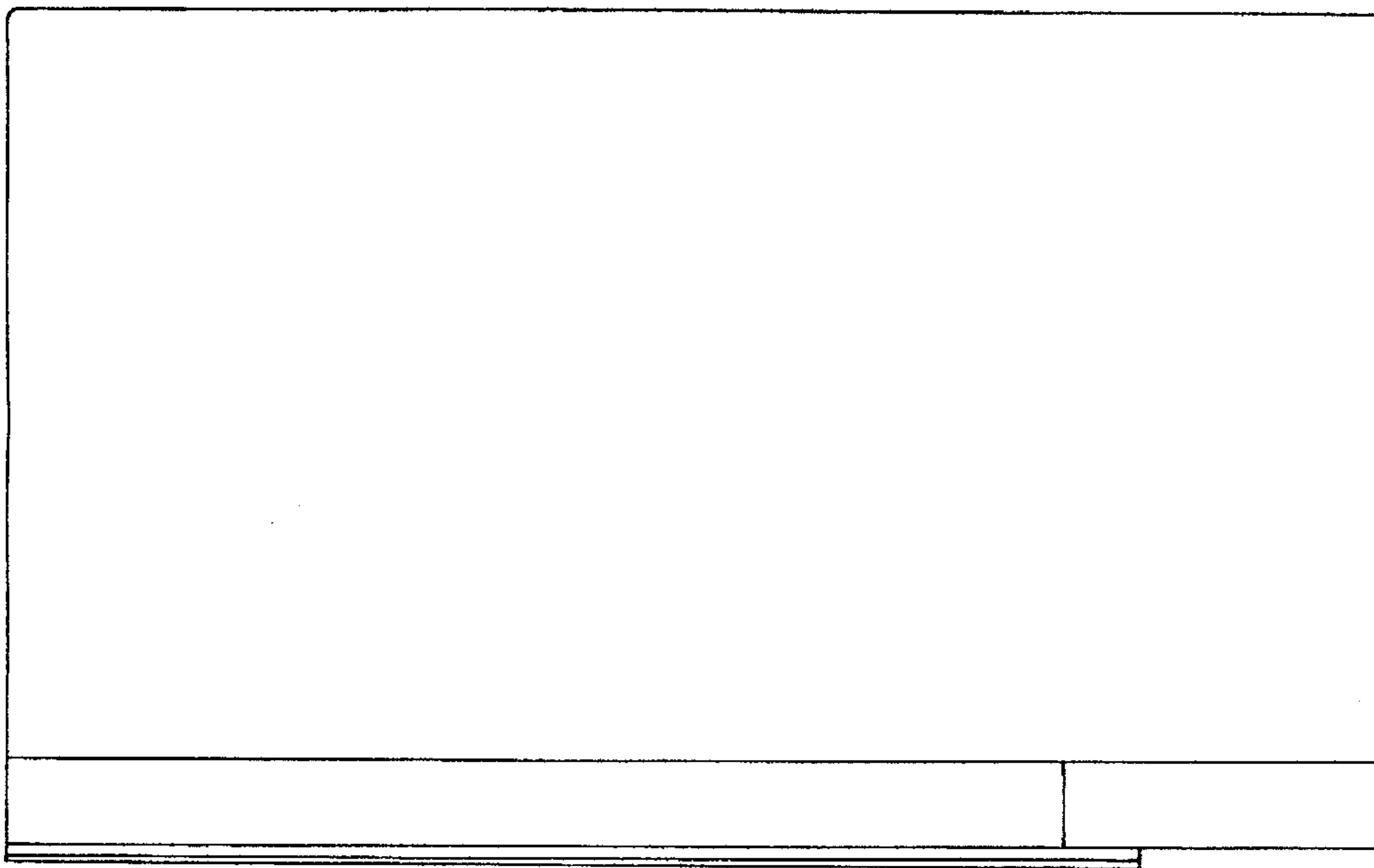
