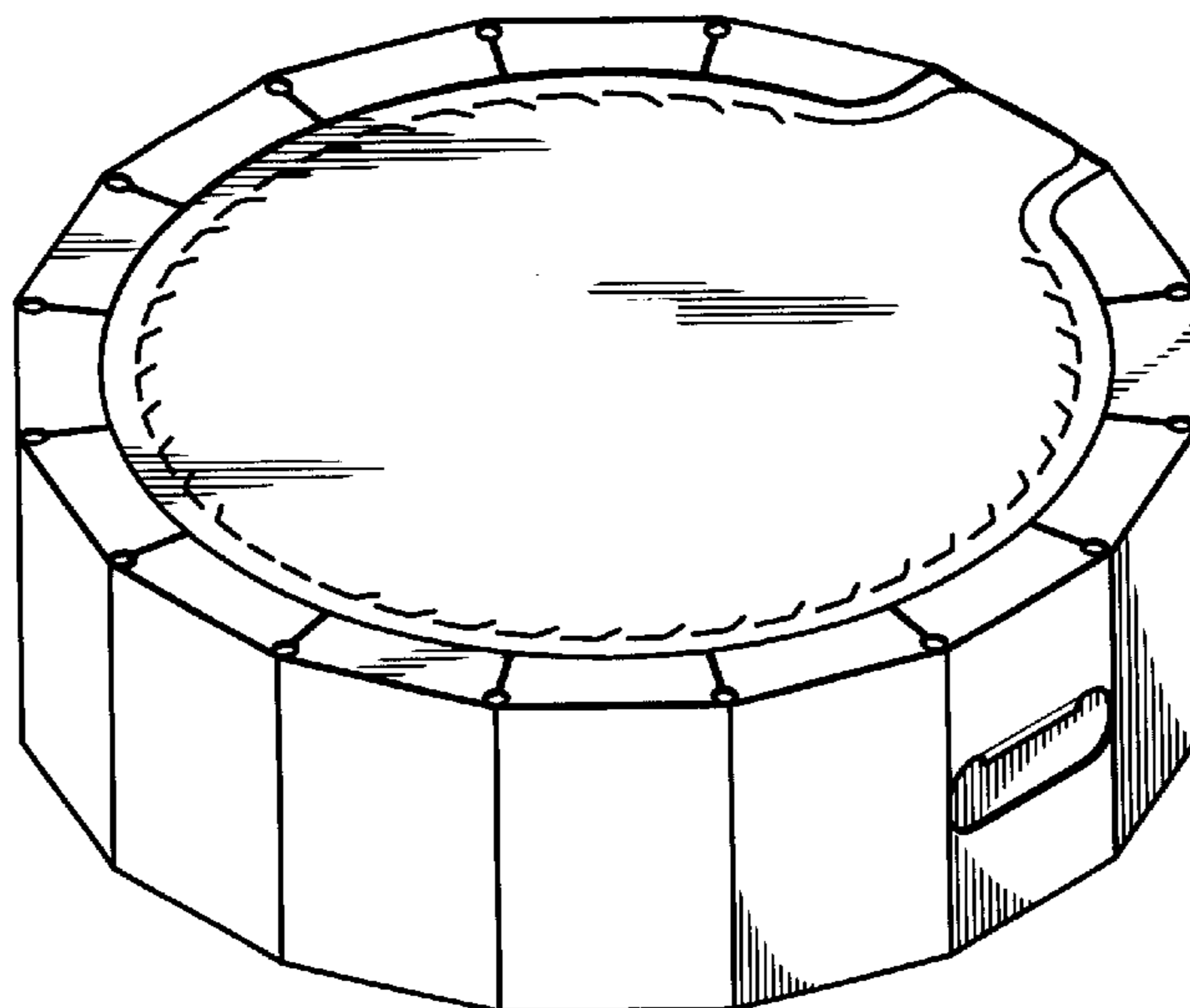

FIG. 1 is a perspective view of a circular carton showing our new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a front elevational view thereof, with the rear view being a mirror image;
FIG. 5 is a right side elevational view thereof, with the left side being a mirror image;
FIG. 6 is a perspective view thereof, in accordance with a second embodiment;
FIG. 7 is a top plan view thereof;
FIG. 8 is a bottom plan view thereof;
FIG. 9 is a front elevational view thereof, with the rear view being a mirror image; and,
FIG. 10 is a right side elevational view thereof, with the left side being a mirror image.

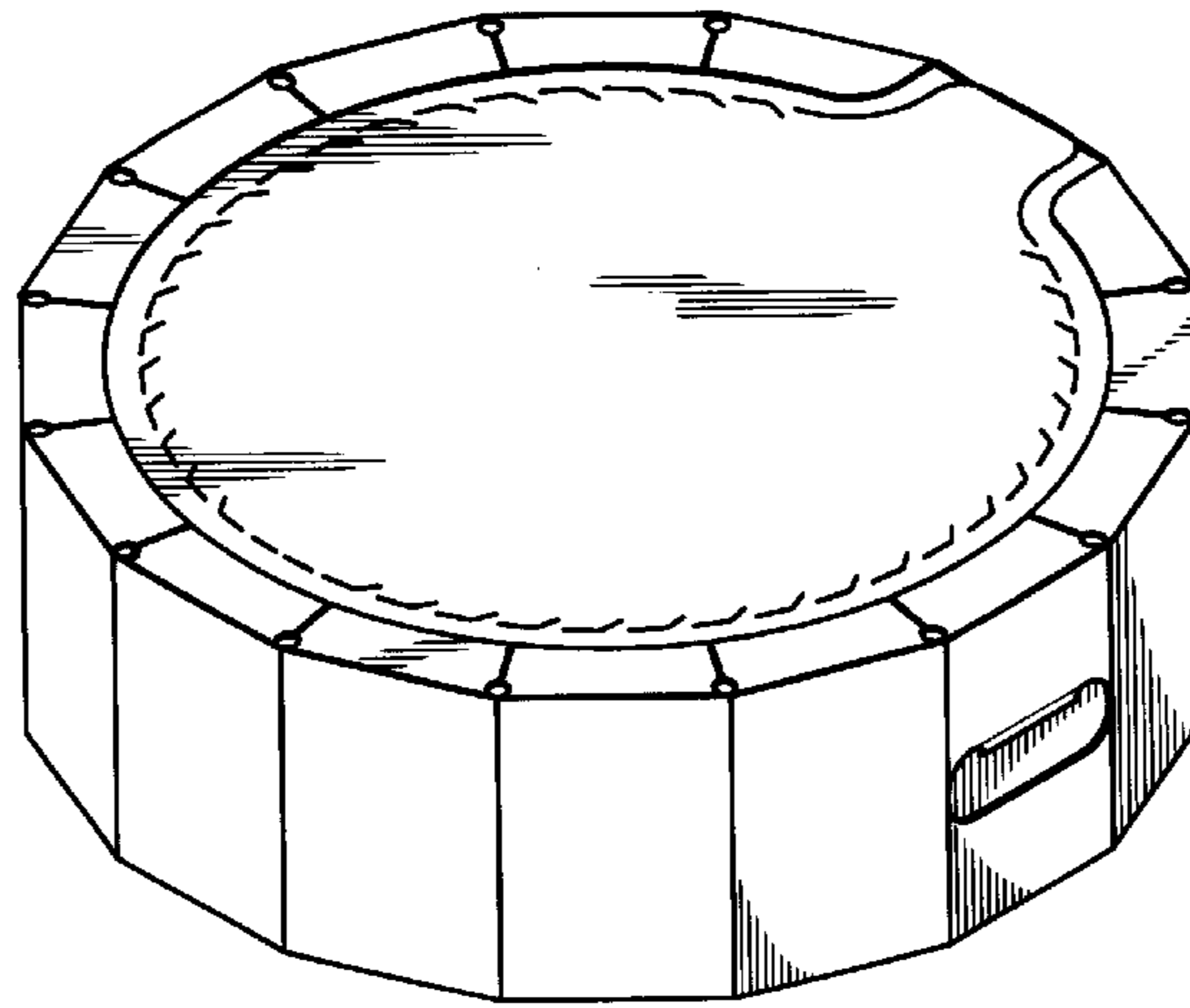

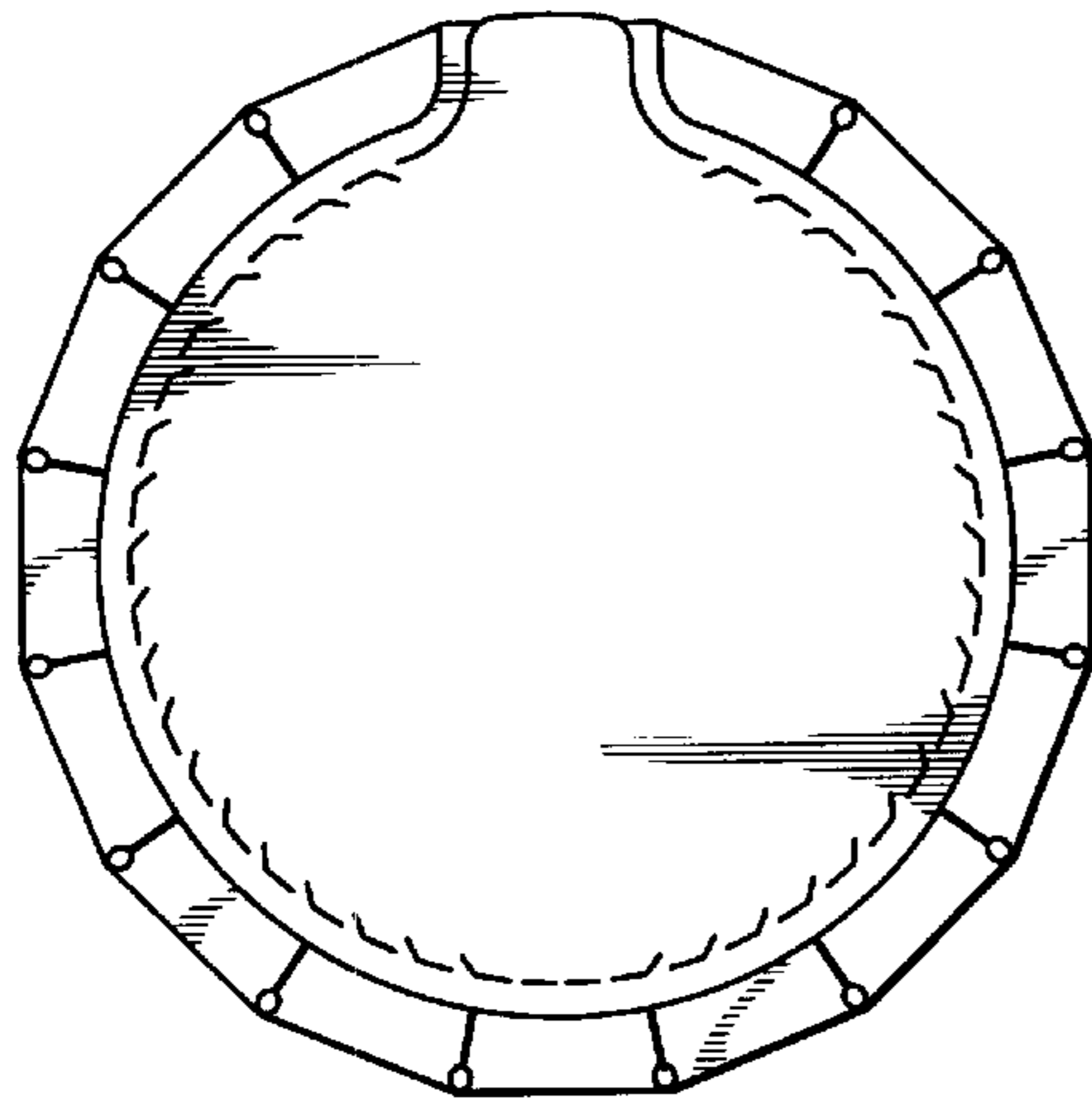

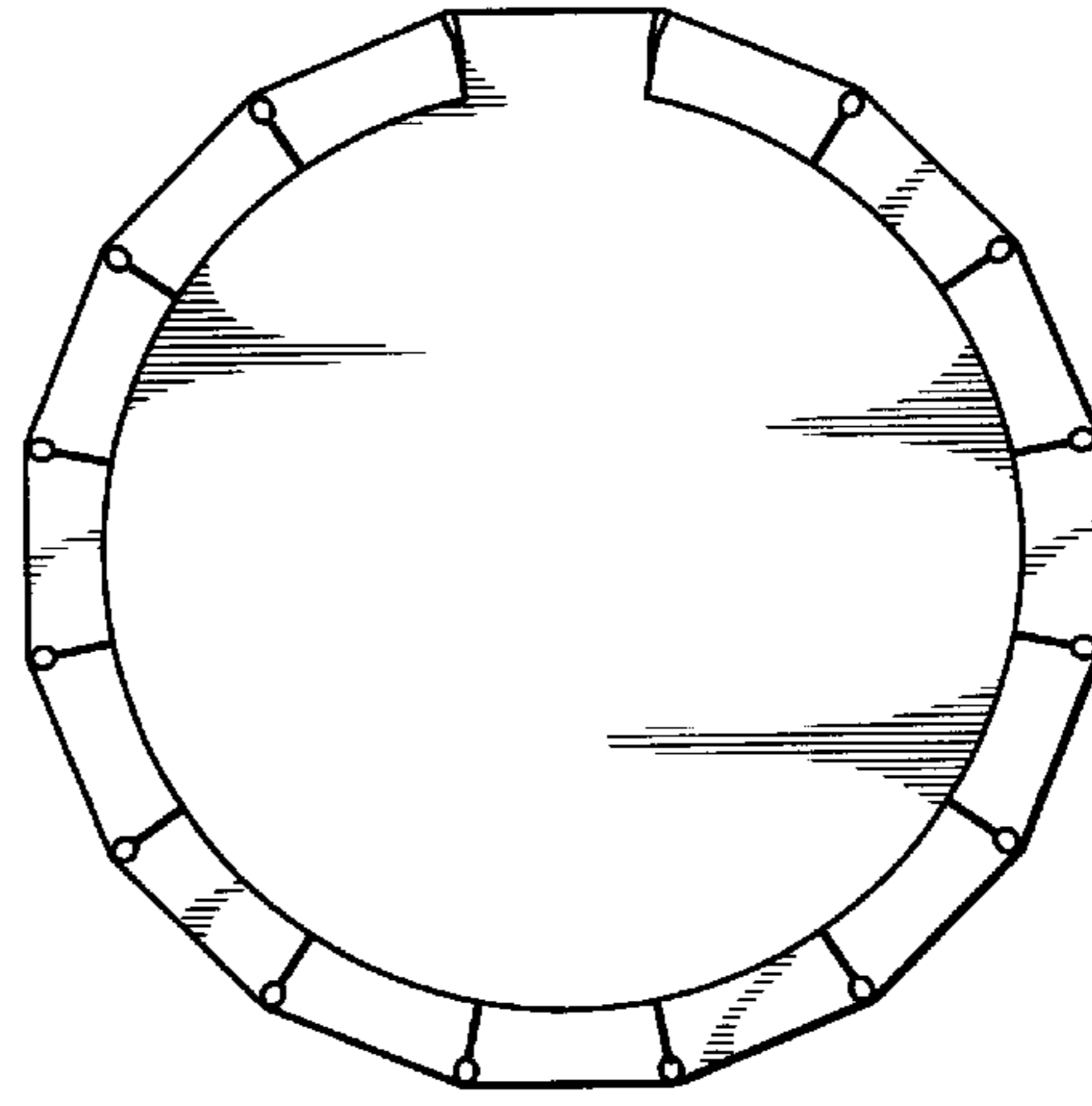

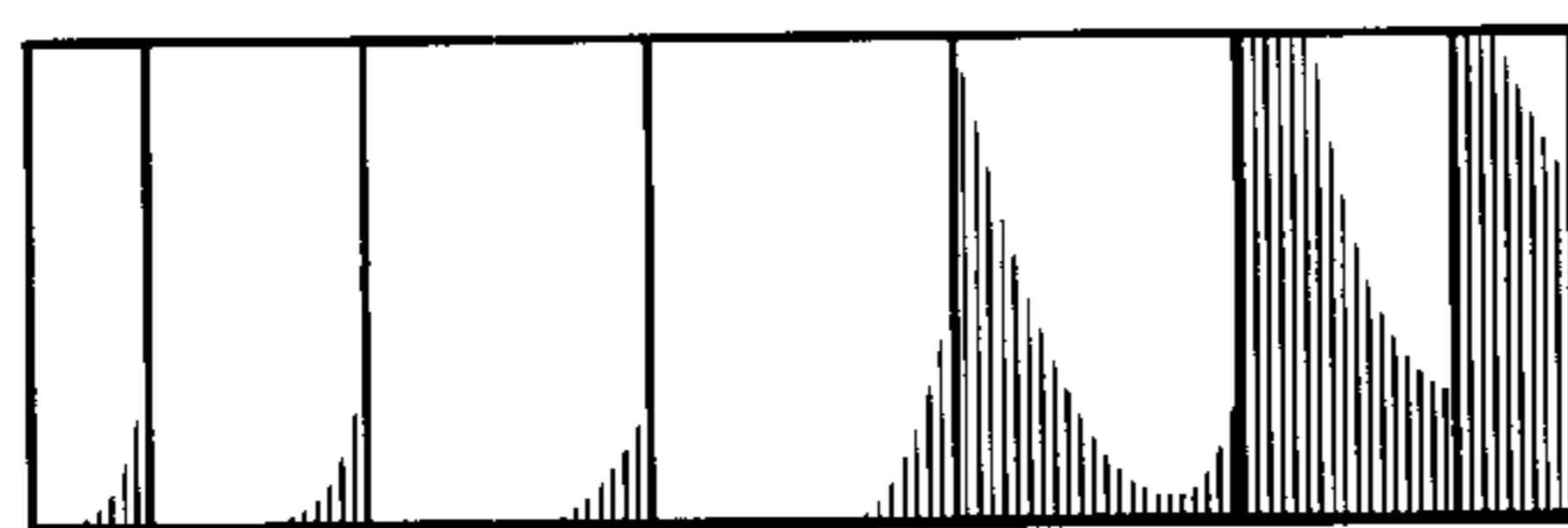

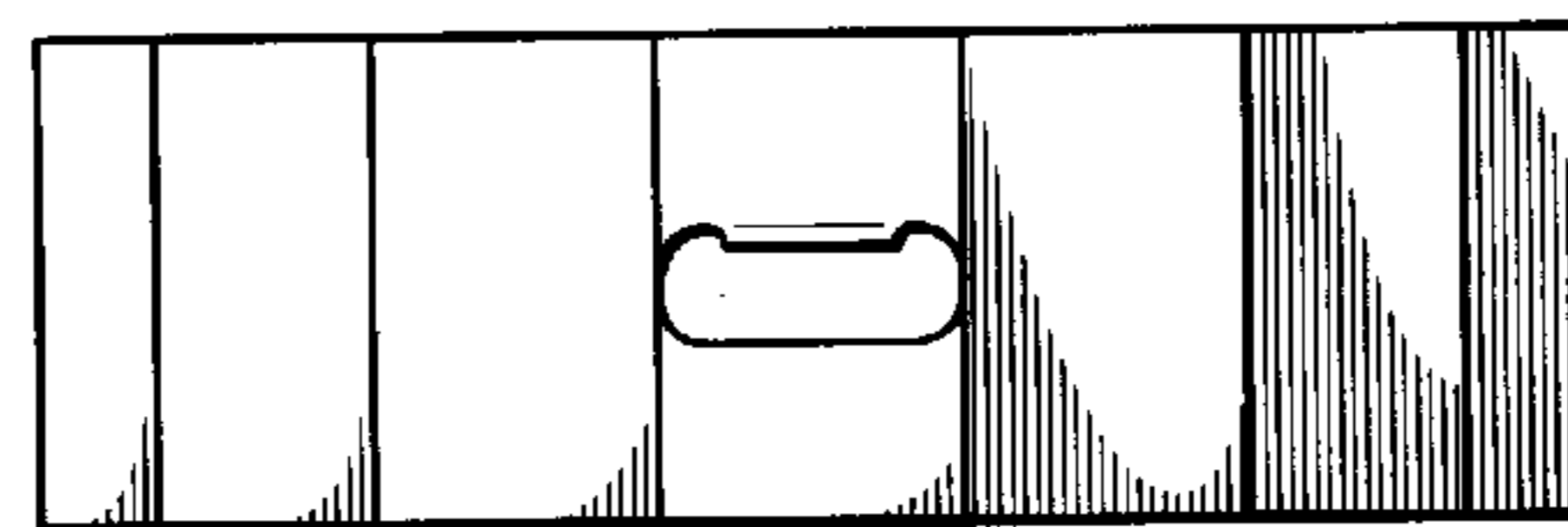

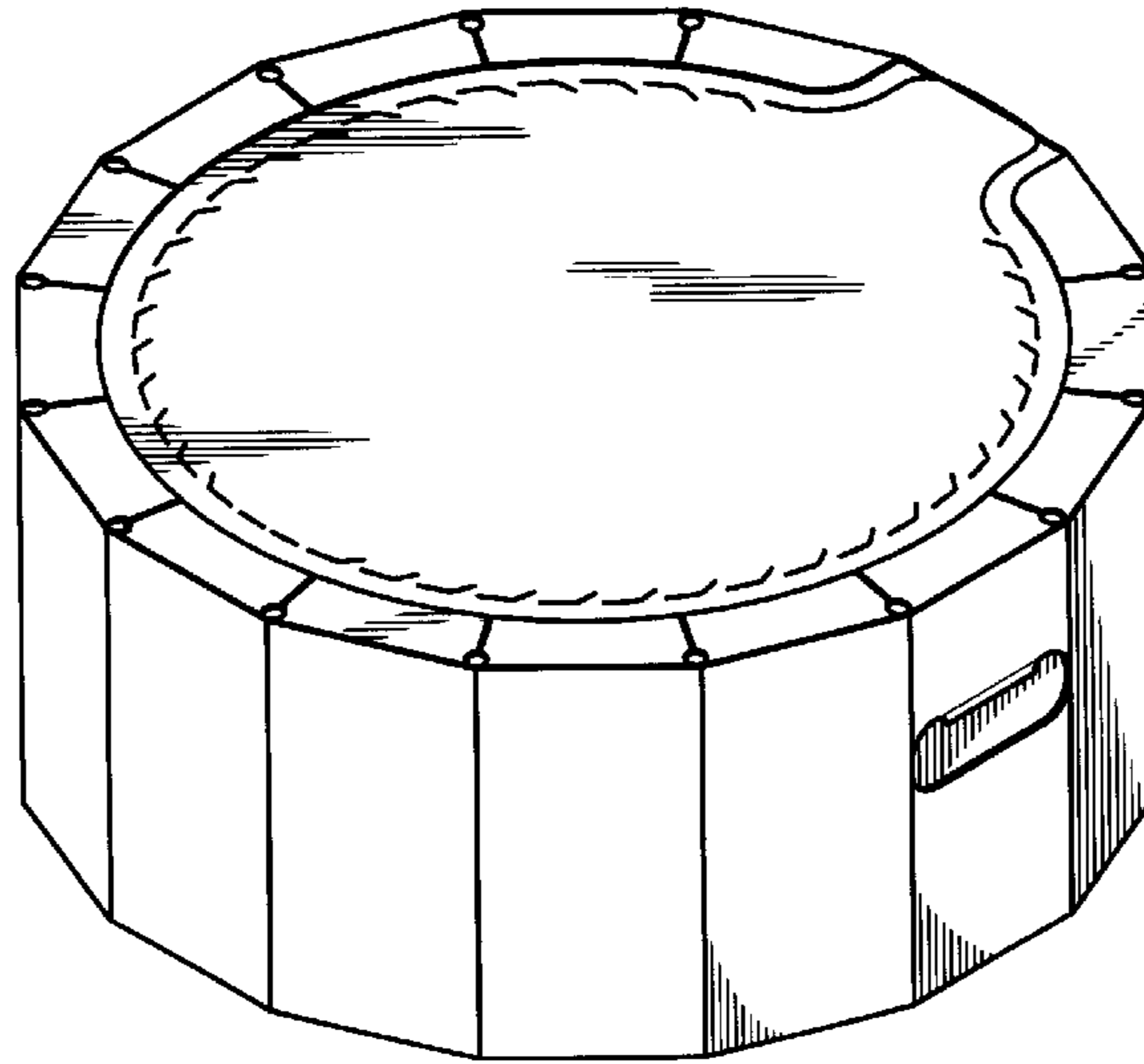

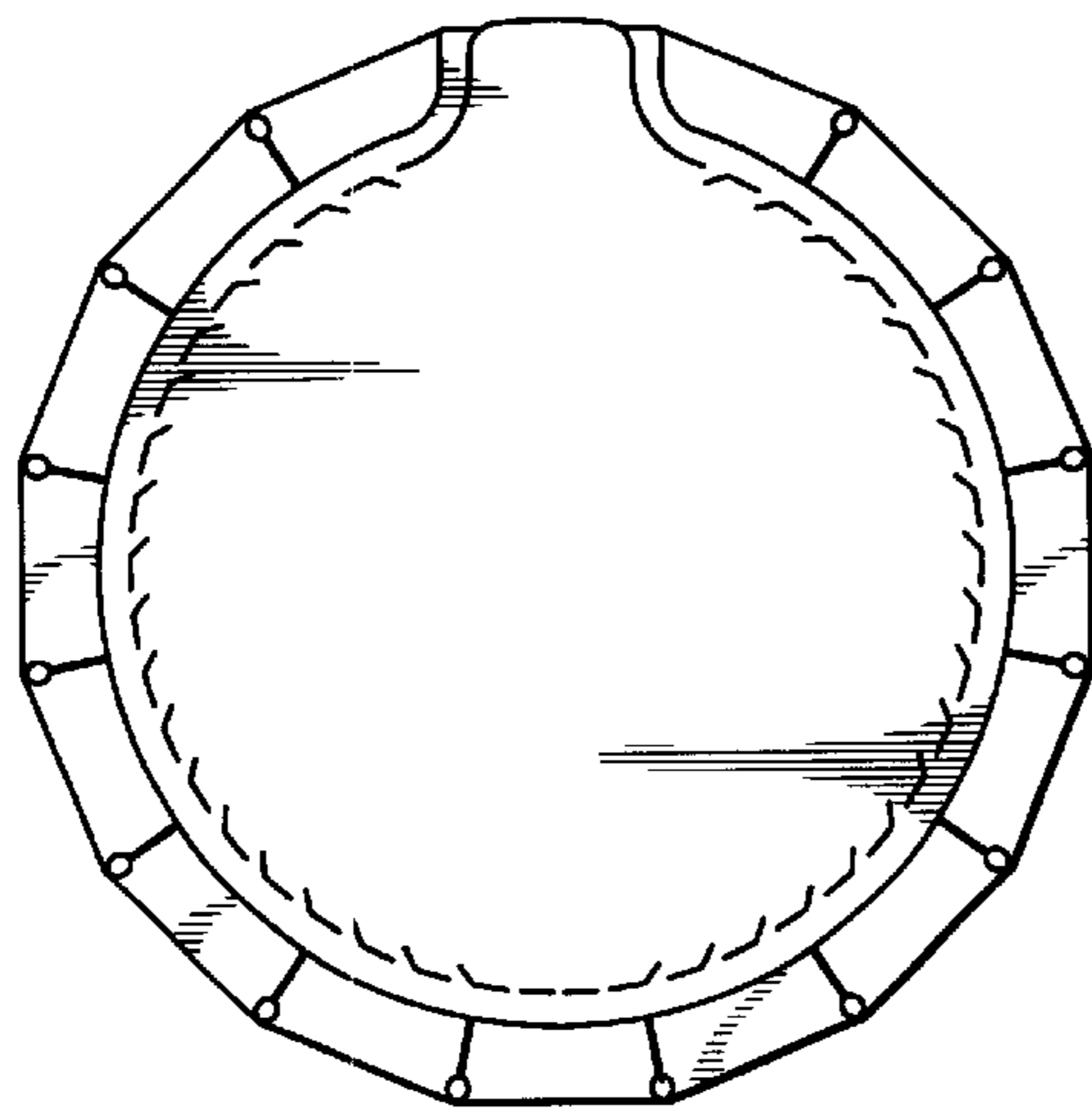

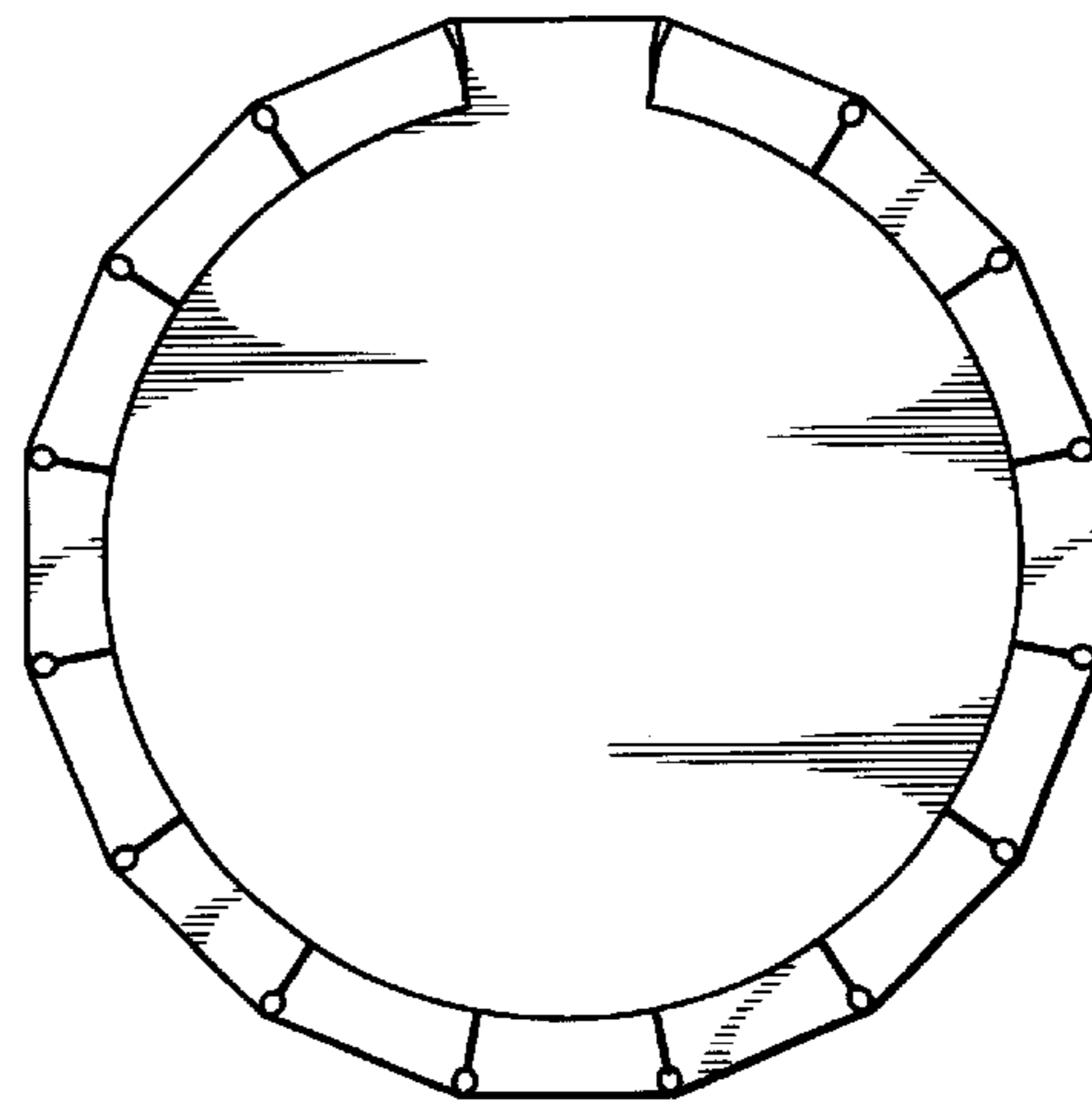

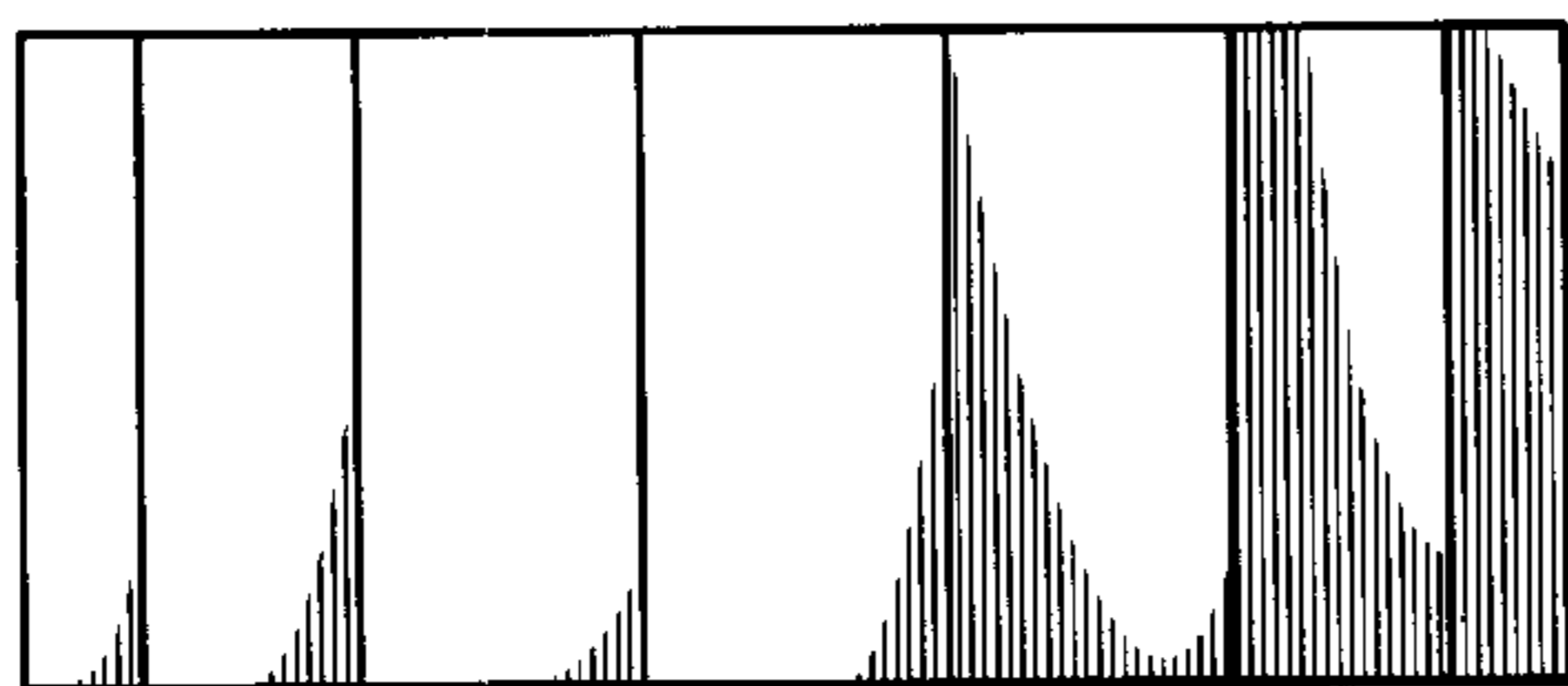

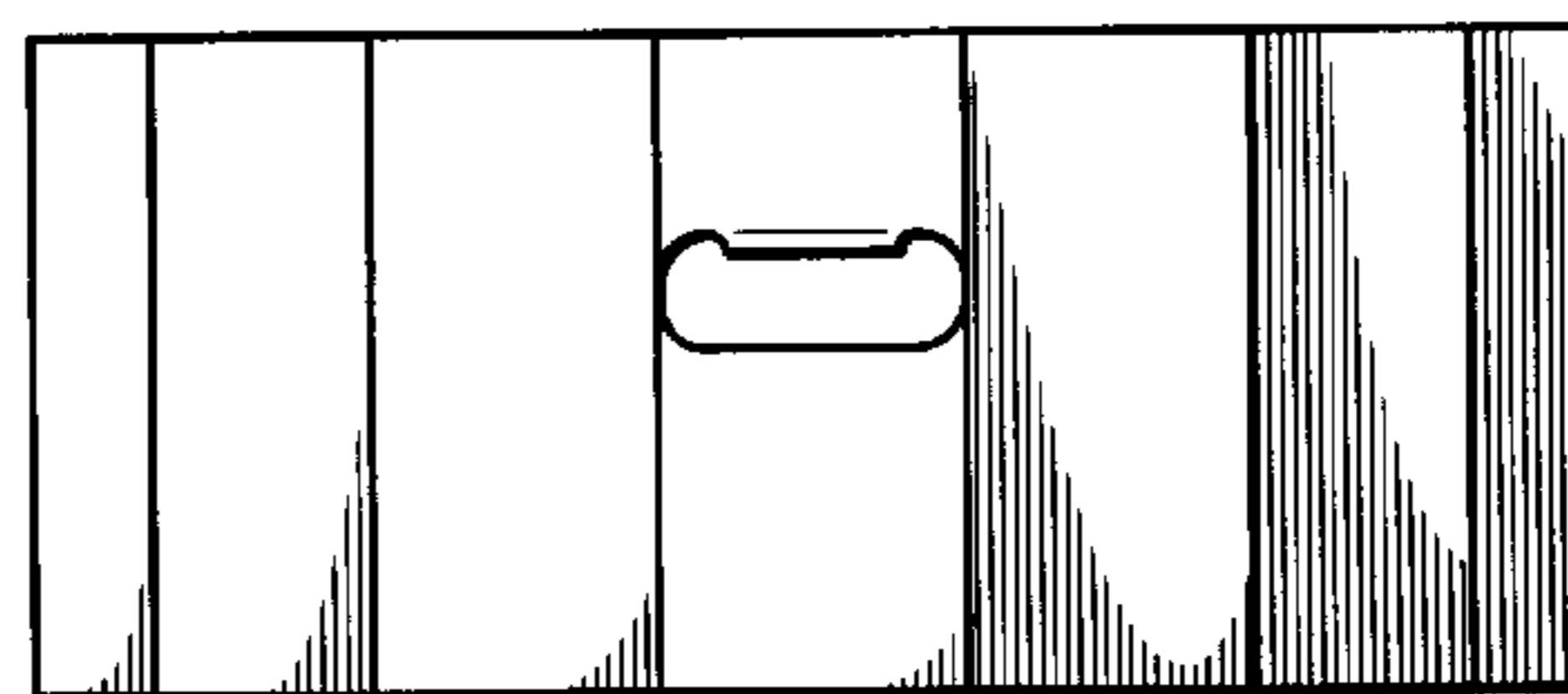
