(57) **CLAIM**

I claim the ornamental design for a cigarette carton, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a cigarette carton showing my new design, the bottom plan view being a mirror image thereof;

FIG. 2 is a front elevational view thereof, the rear elevational view being a mirror image thereof;

FIG. 3 is a left side elevational view thereof;

FIG. 4 is a right side elevational view thereof; and,

FIG. 5 is a blank thereof.

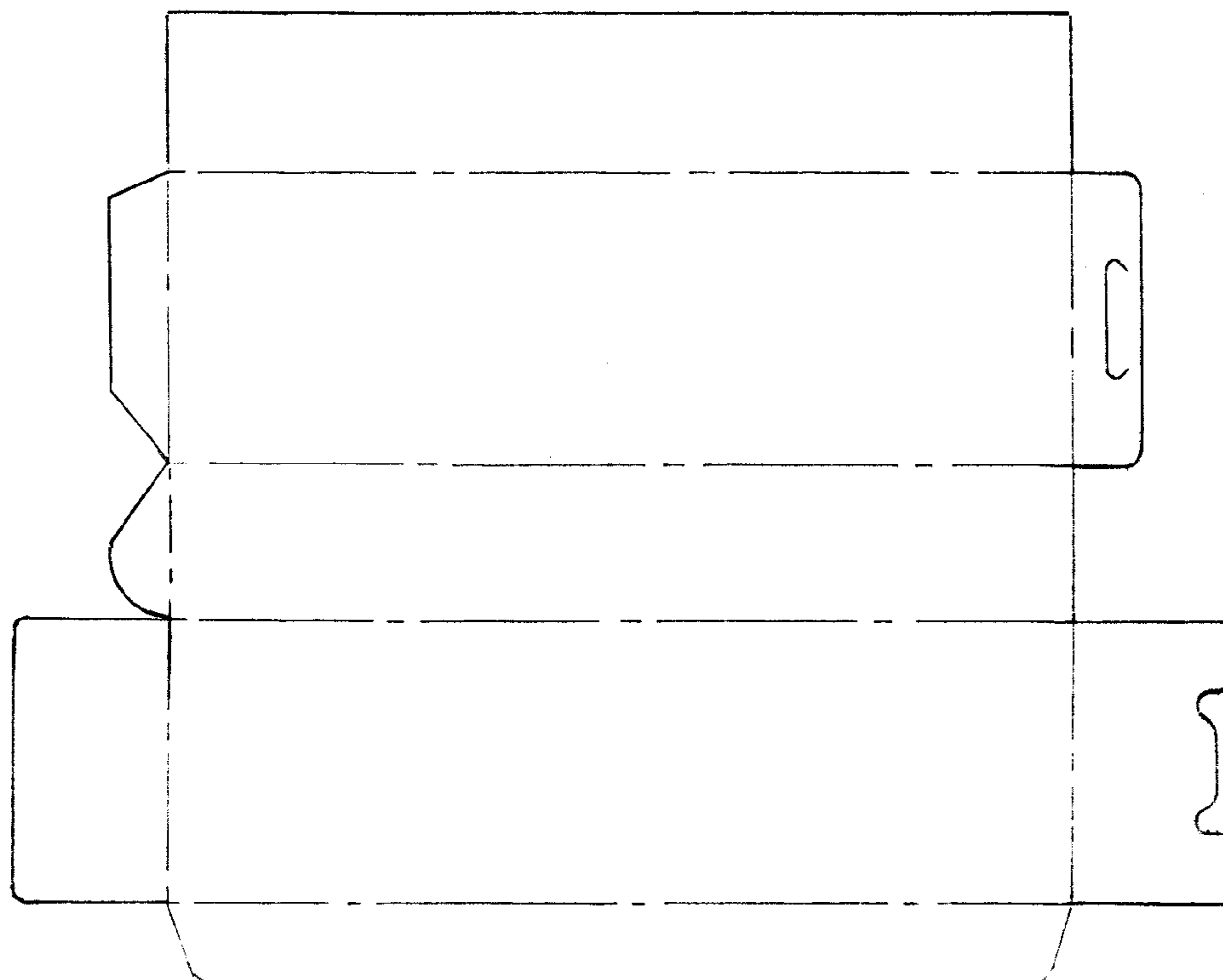

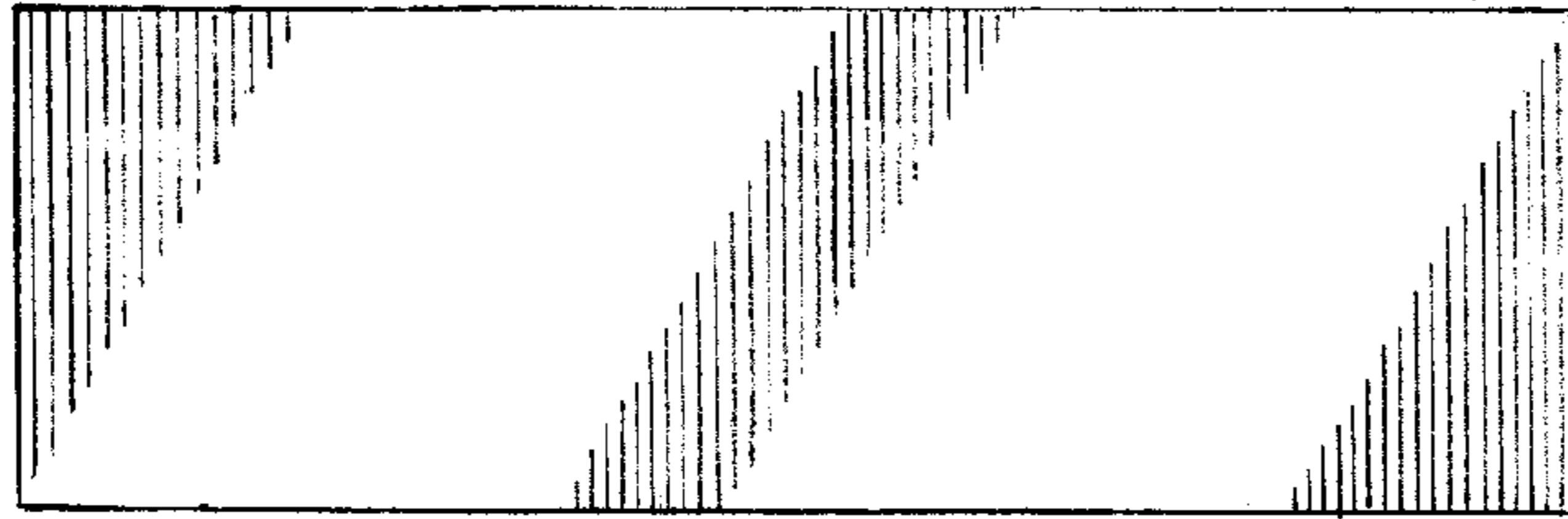

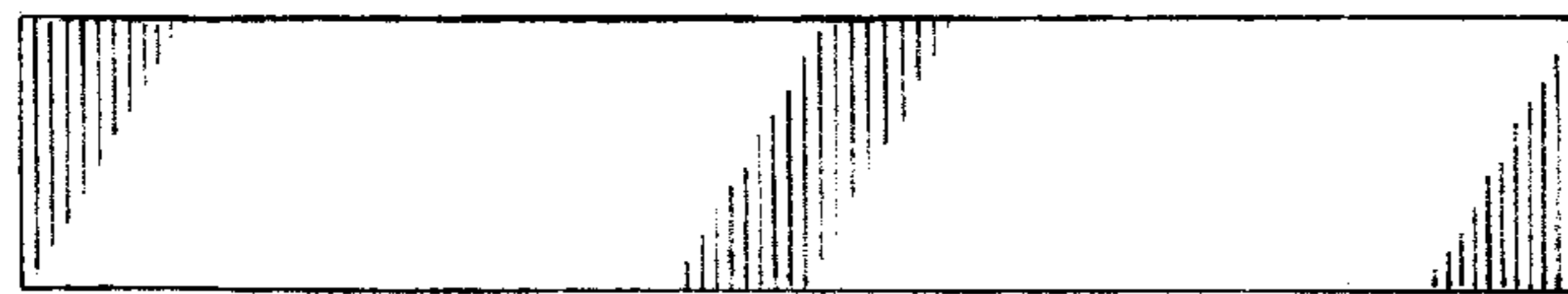

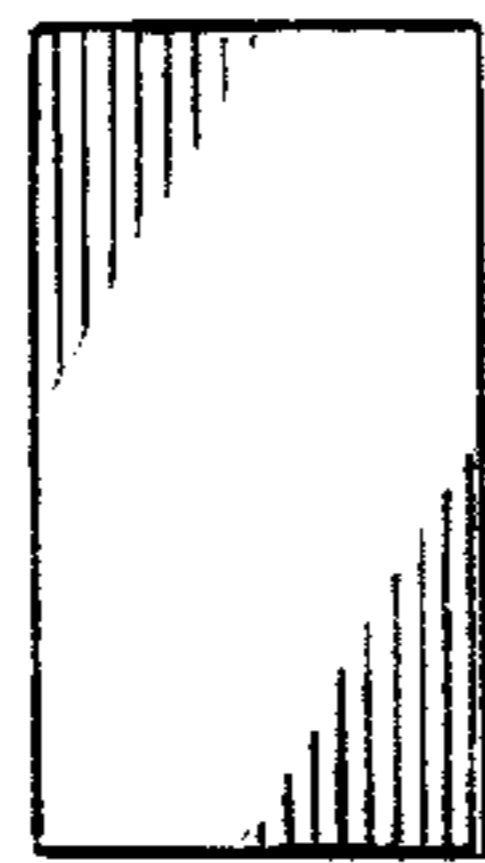
