(57) **CLAIM**

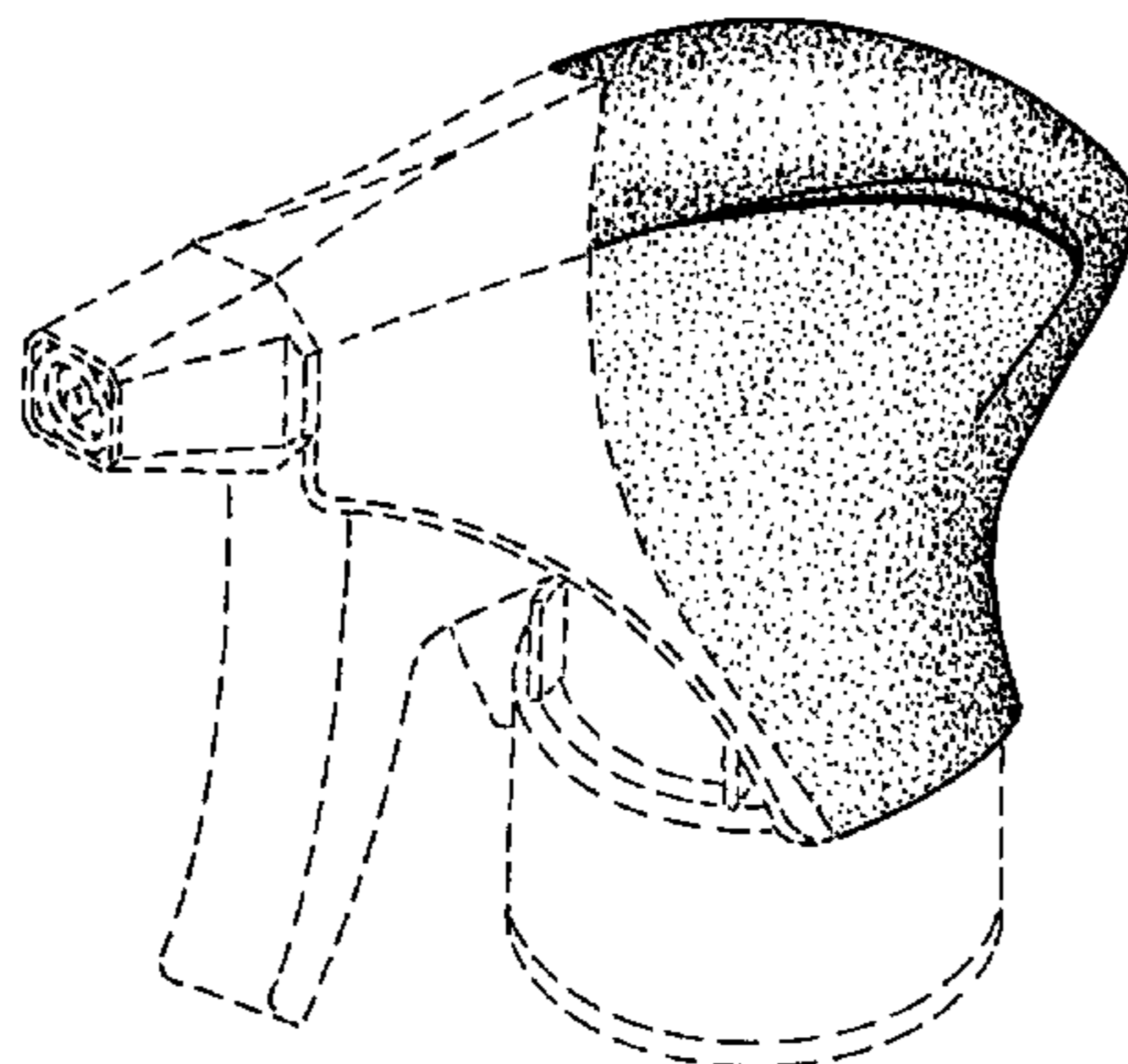
The ornamental design for a rear element of a sprayer shroud, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a rear element of a sprayer shroud in accordance with the present invention;  
 FIG. 2 is a side elevational view of the rear element of the sprayer shroud of FIG. 1;  
 FIG. 3 is a top view of the rear element of the sprayer shroud of FIG. 1;  
 FIG. 4 is a front view of the rear element of the sprayer shroud of FIG. 1;  
 FIG. 5 is a rear view of the rear element of the sprayer shroud of FIG. 1;  
 FIG. 6 is a perspective view of another embodiment of a rear element of a sprayer shroud in accordance with the present invention;  
 FIG. 7 is a side elevational view of the rear element of the sprayer shroud of FIG. 6;  
 FIG. 8 is a top view of the rear element of the sprayer shroud of FIG. 6; and,  
 FIG. 9 is a rear view of the rear element of the sprayer shroud of FIG. 6.

The front view of the alternate embodiment of FIGS. 6-8 is omitted as being identical to FIG. 4 of the embodiment of FIGS. 1-5. The shaded area(s) represent(s) the bounds of the claimed design. All broken lines represent the remaining portion of the sprayer shroud, which is provided for illustrative purposes only and form no part of the claimed design.

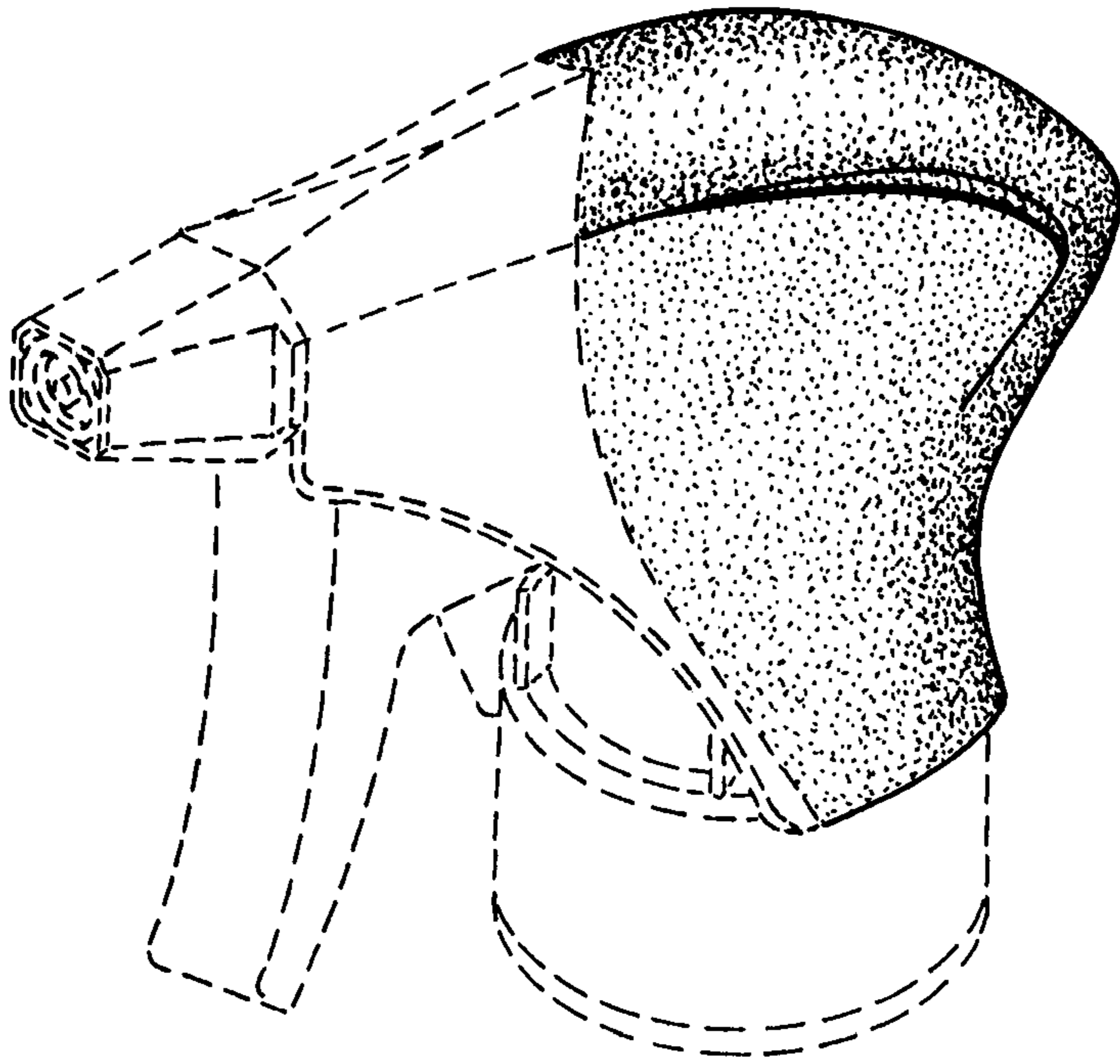

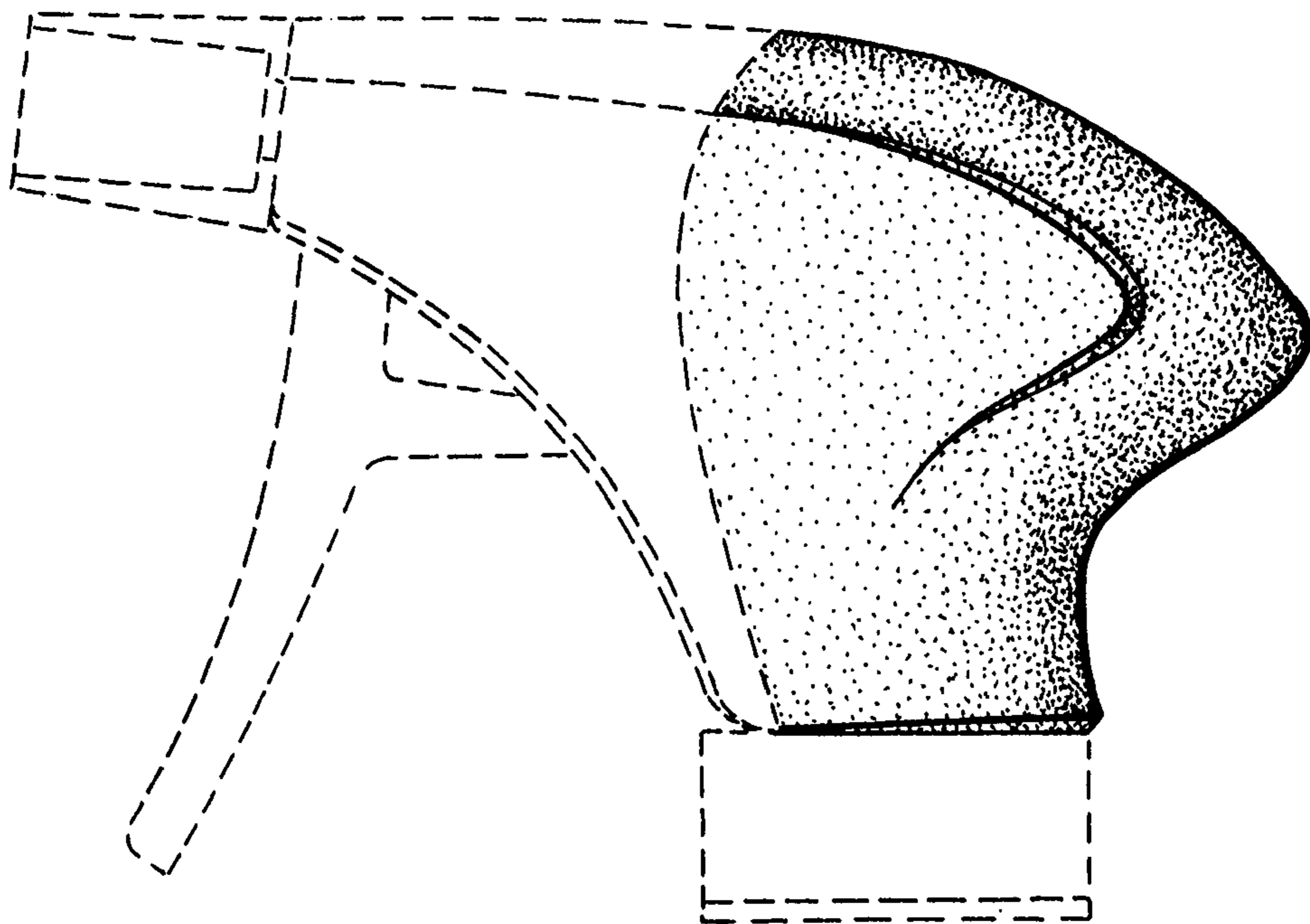

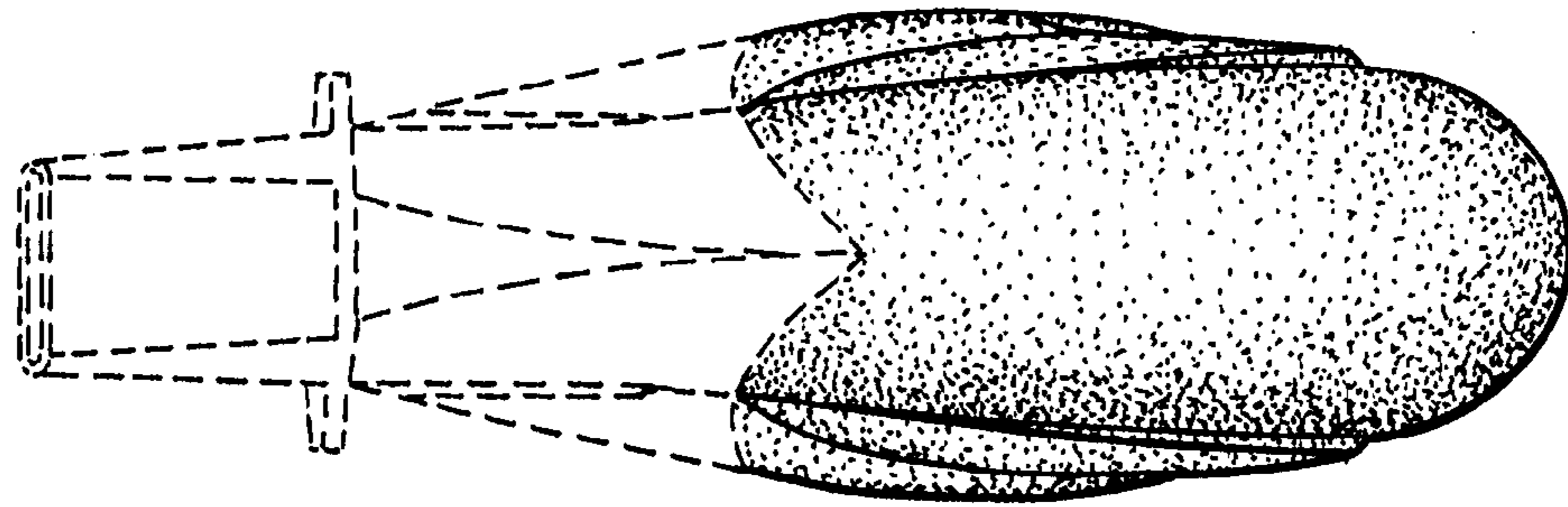

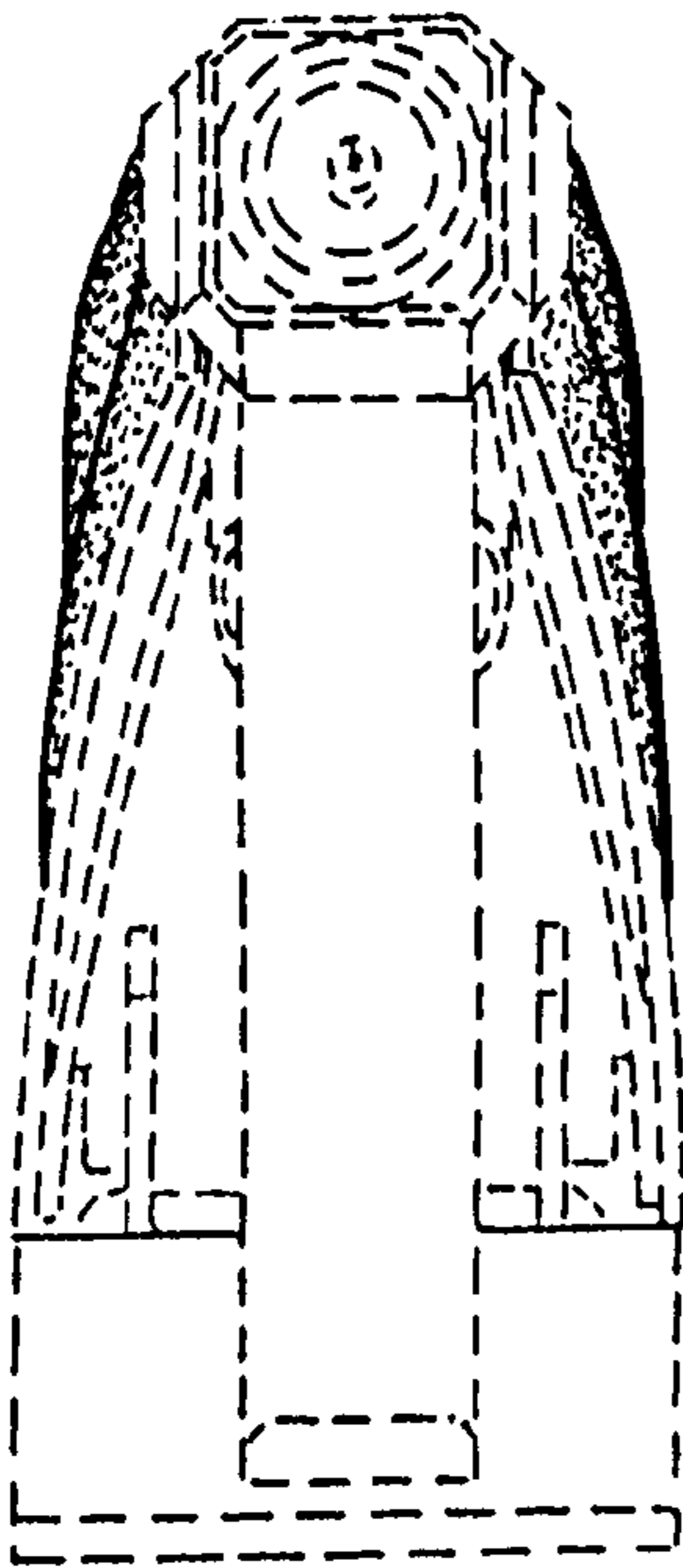
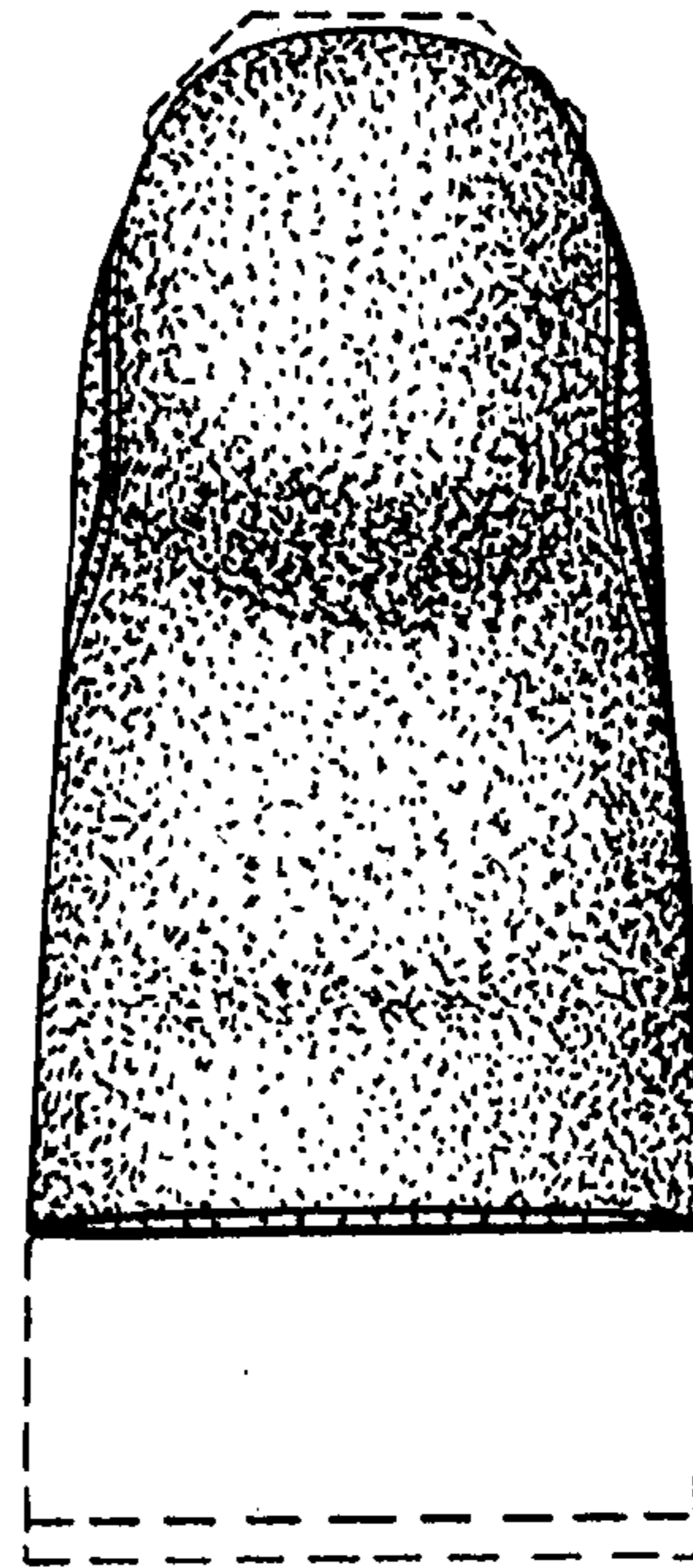

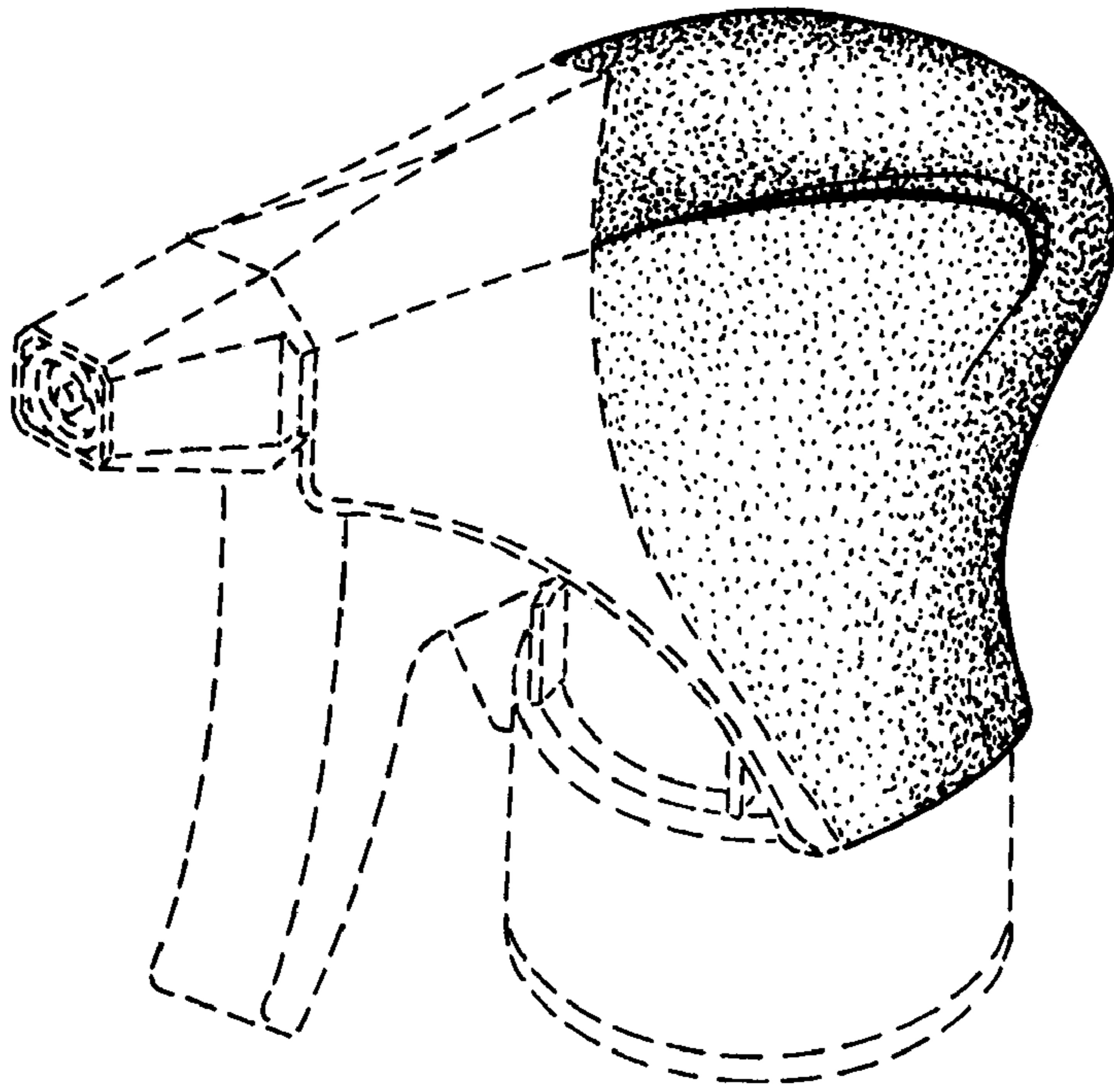

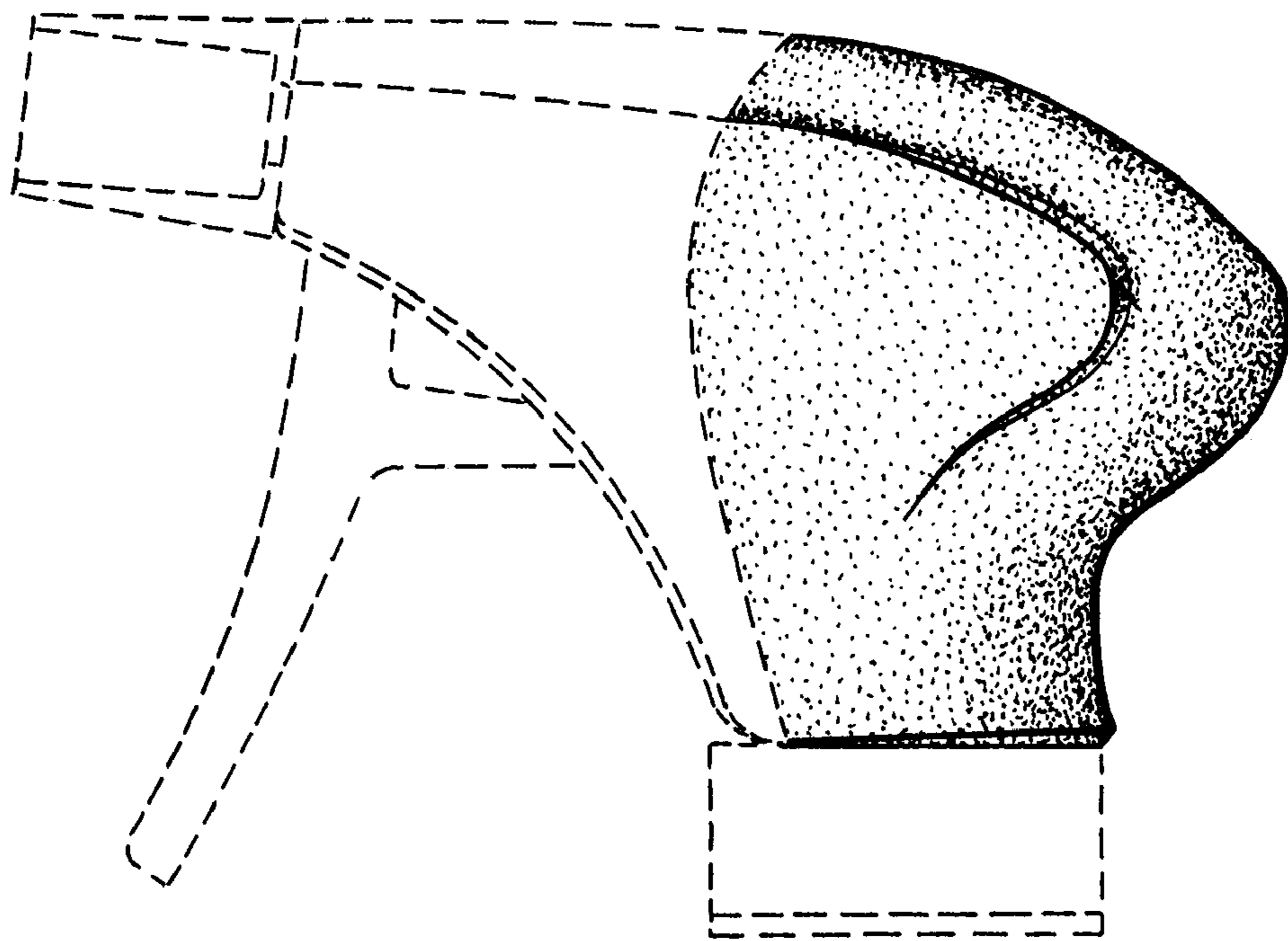

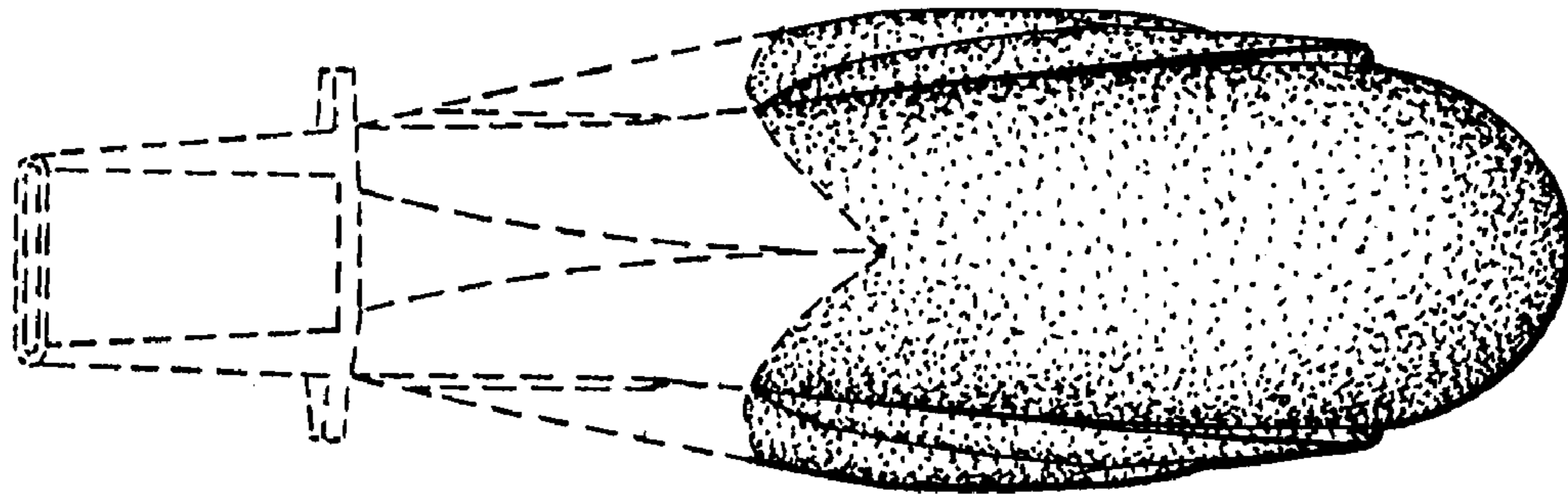
