(57) **CLAIM**

The ornamental design for an combined armrest and vehicle entertainment center, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an combined armrest and vehicle entertainment center showing my new design. FIG. 2 is a rear perspective view of the combined armrest and vehicle entertainment center. FIG. 3 is a top plan view of the combined armrest and vehicle entertainment center. FIG. 4 is a side plan view of the combined armrest and vehicle entertainment center. 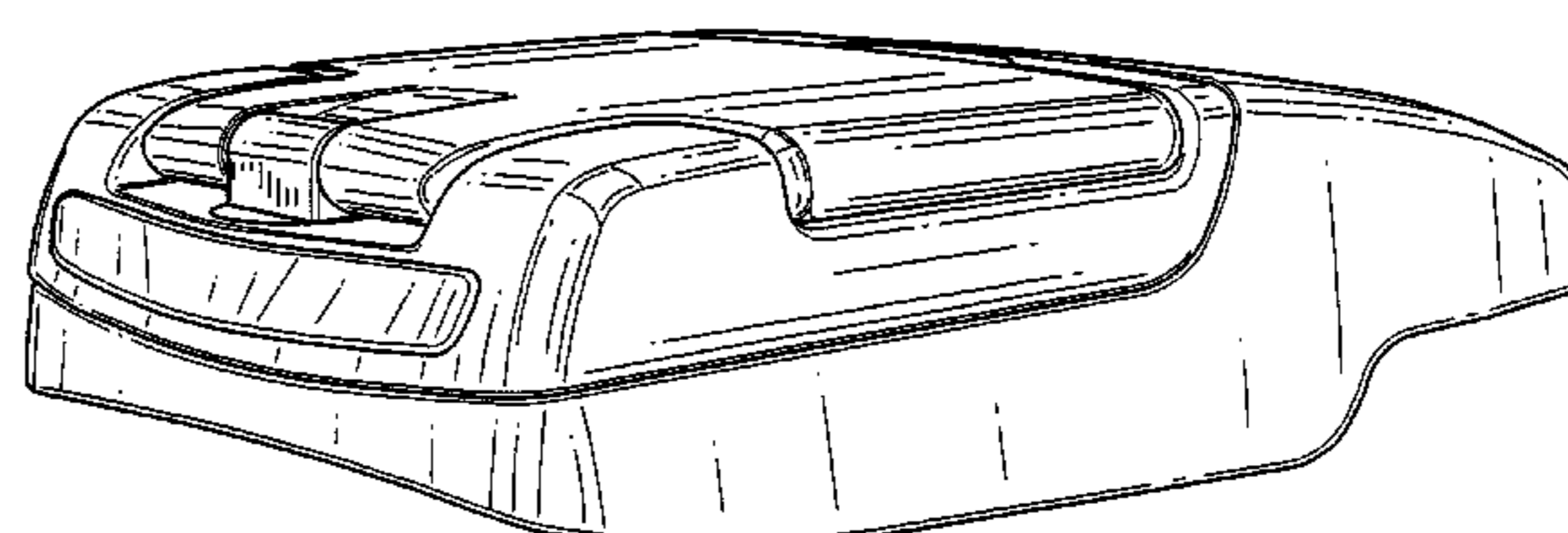
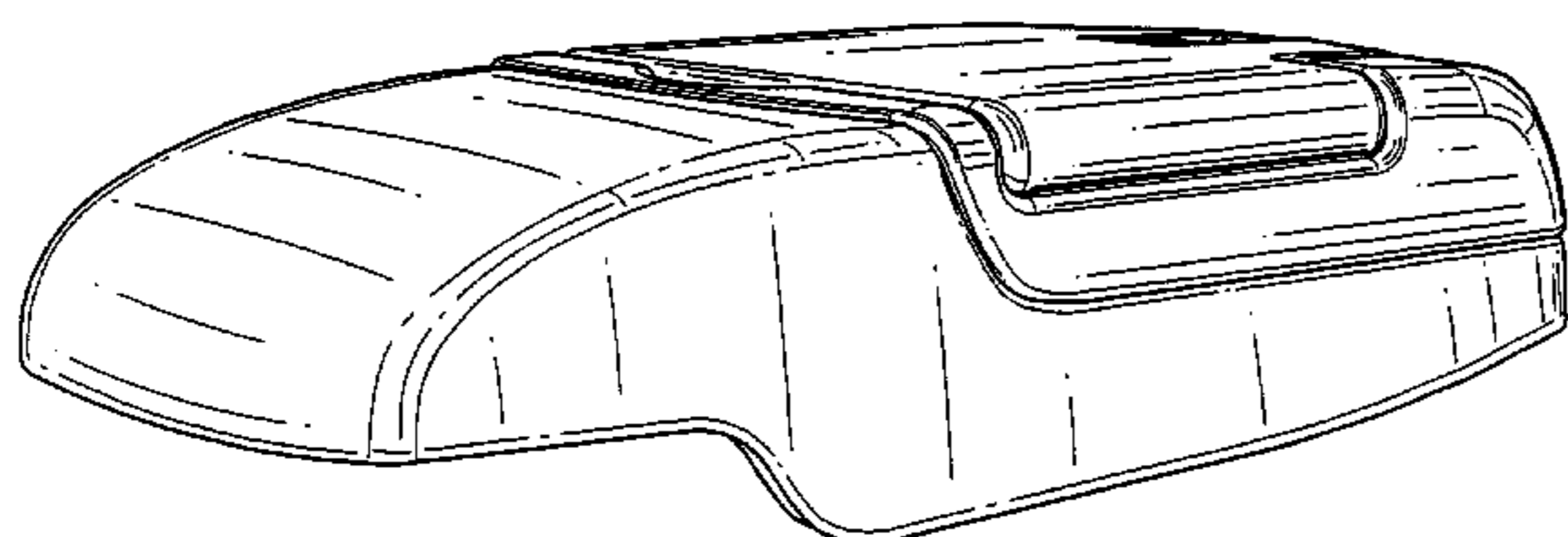

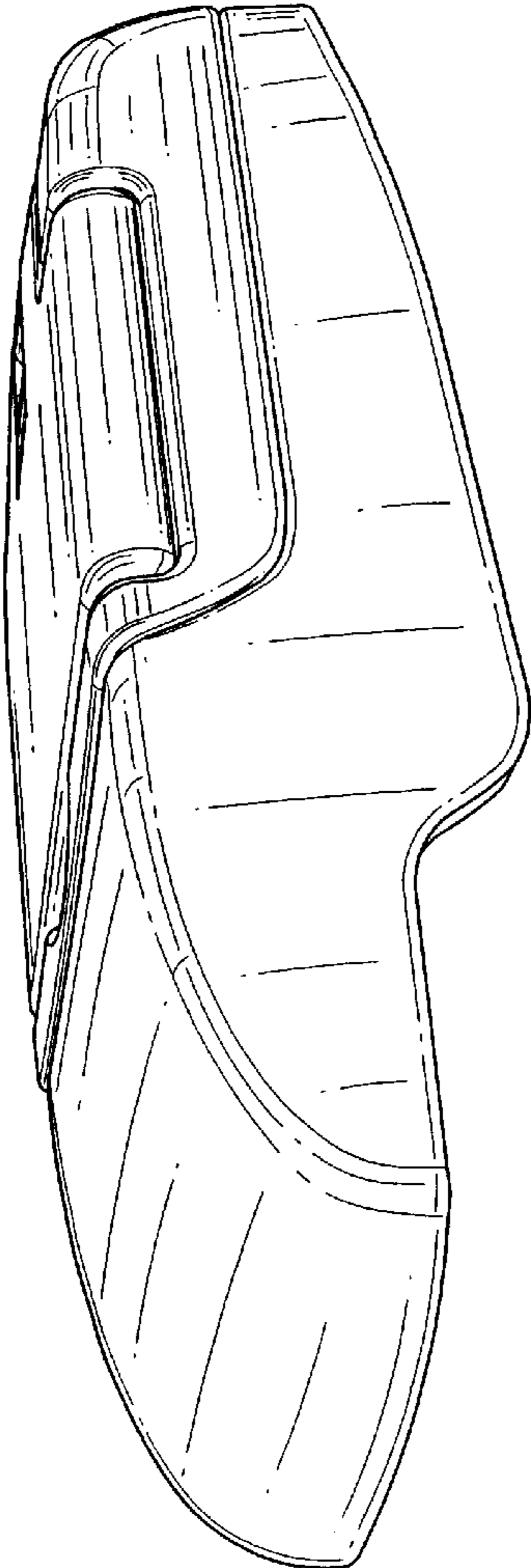
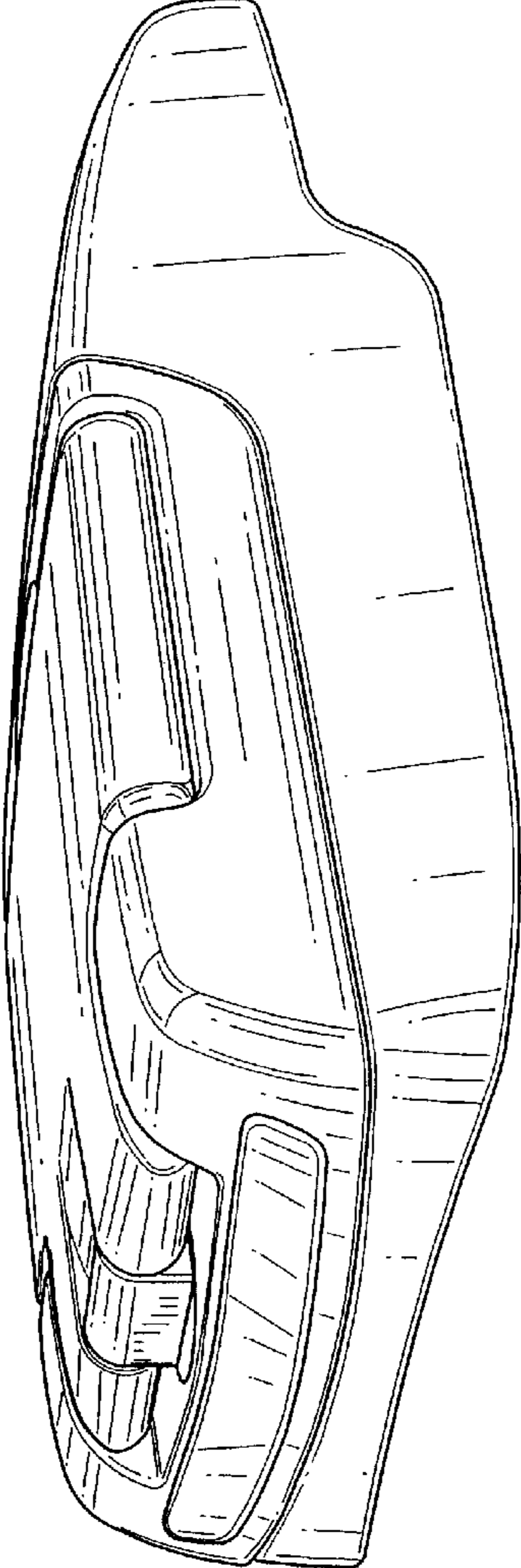

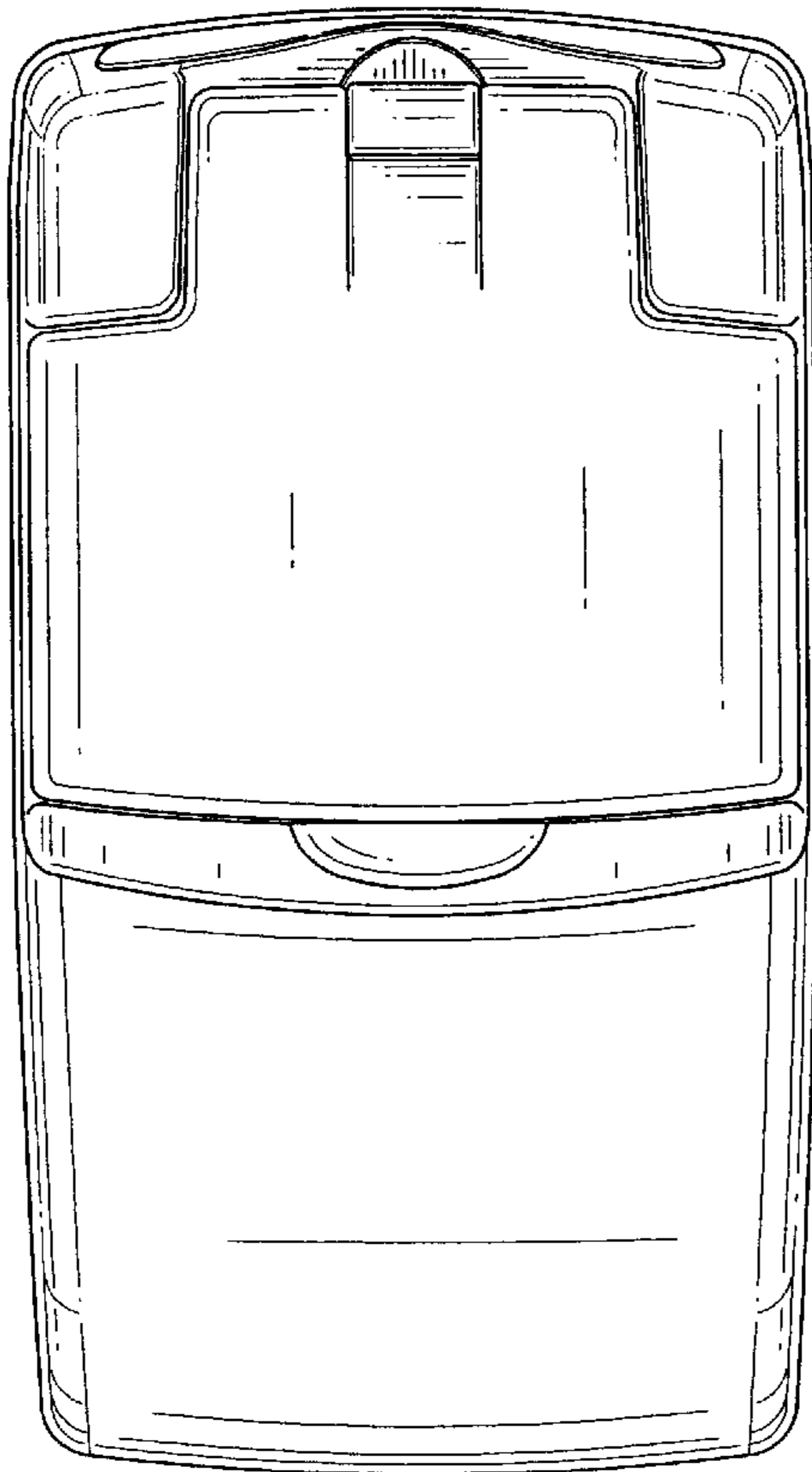

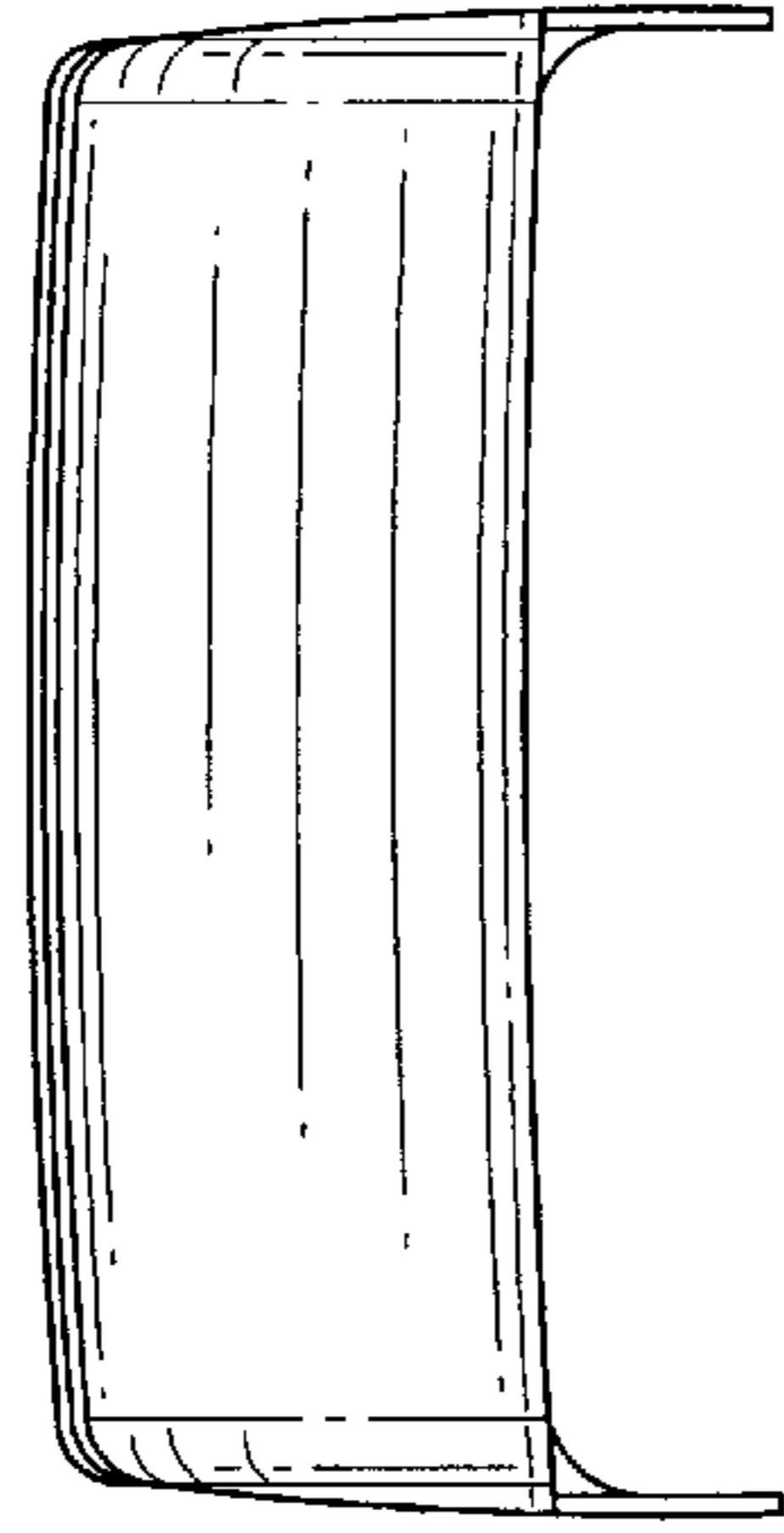

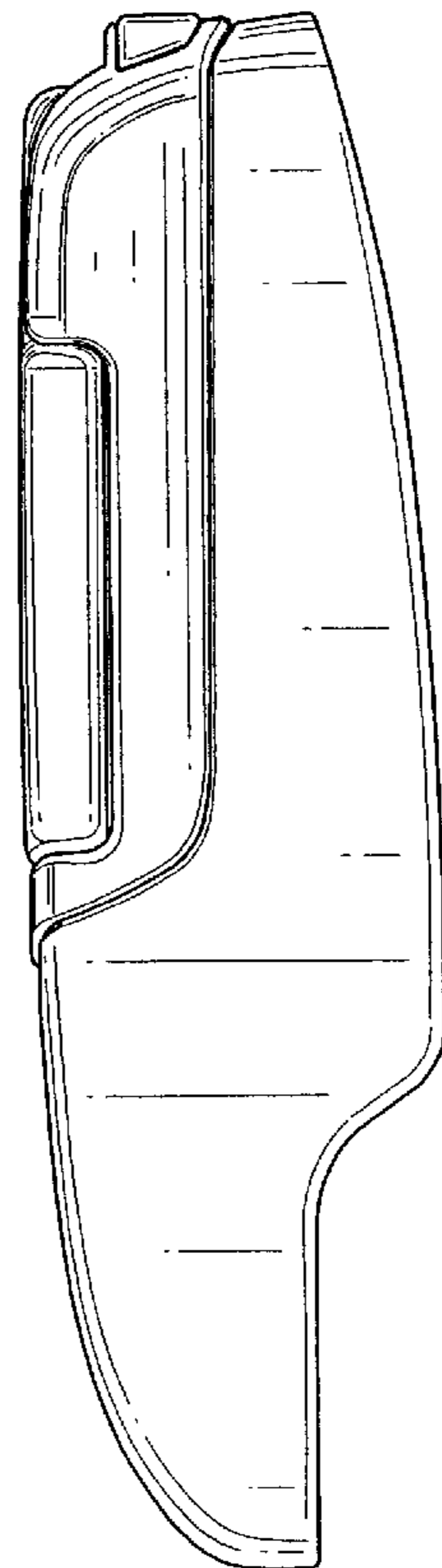
