FIG. 4 is a back side elevation view thereof;

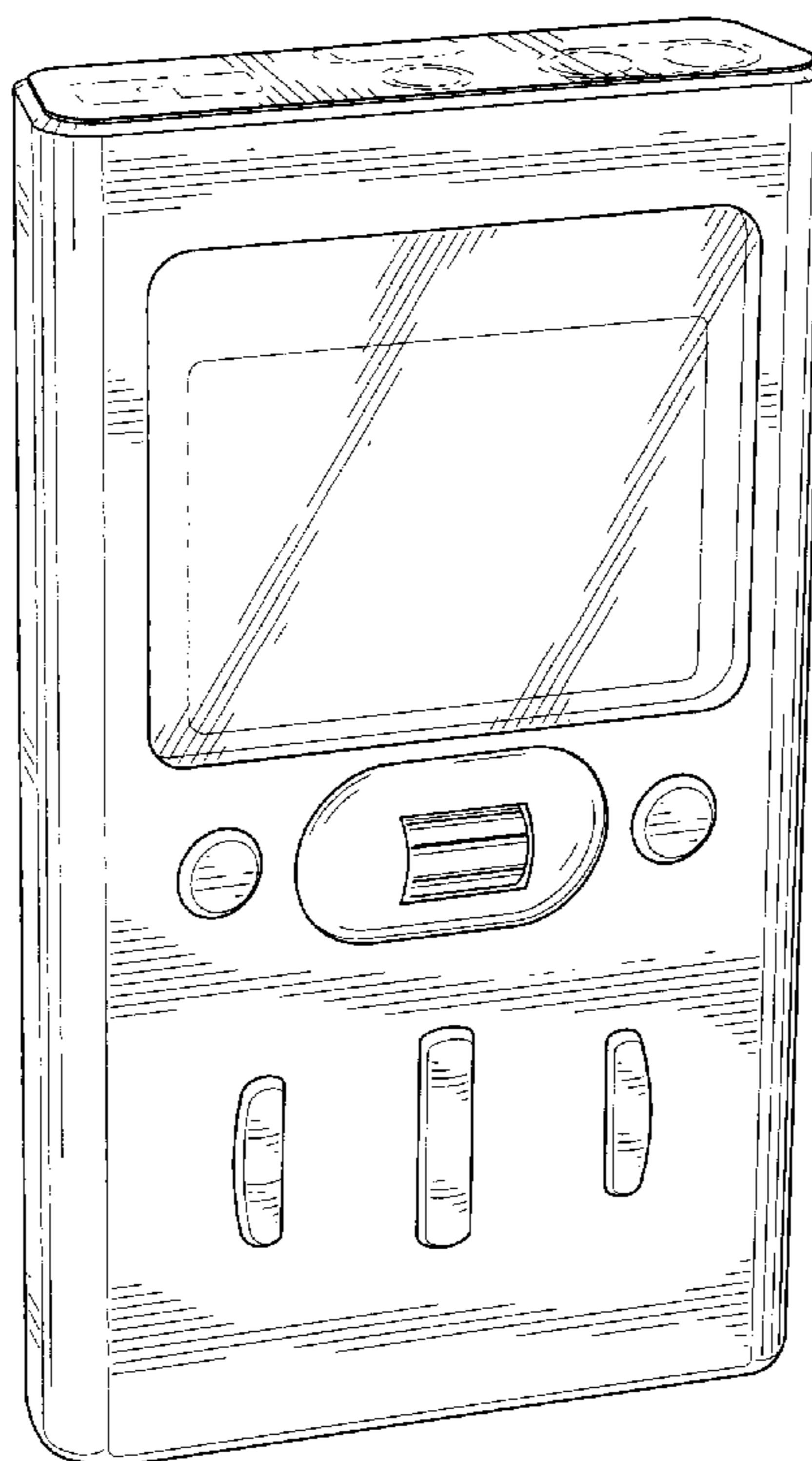
FIG. 5 is a top plan view thereof;

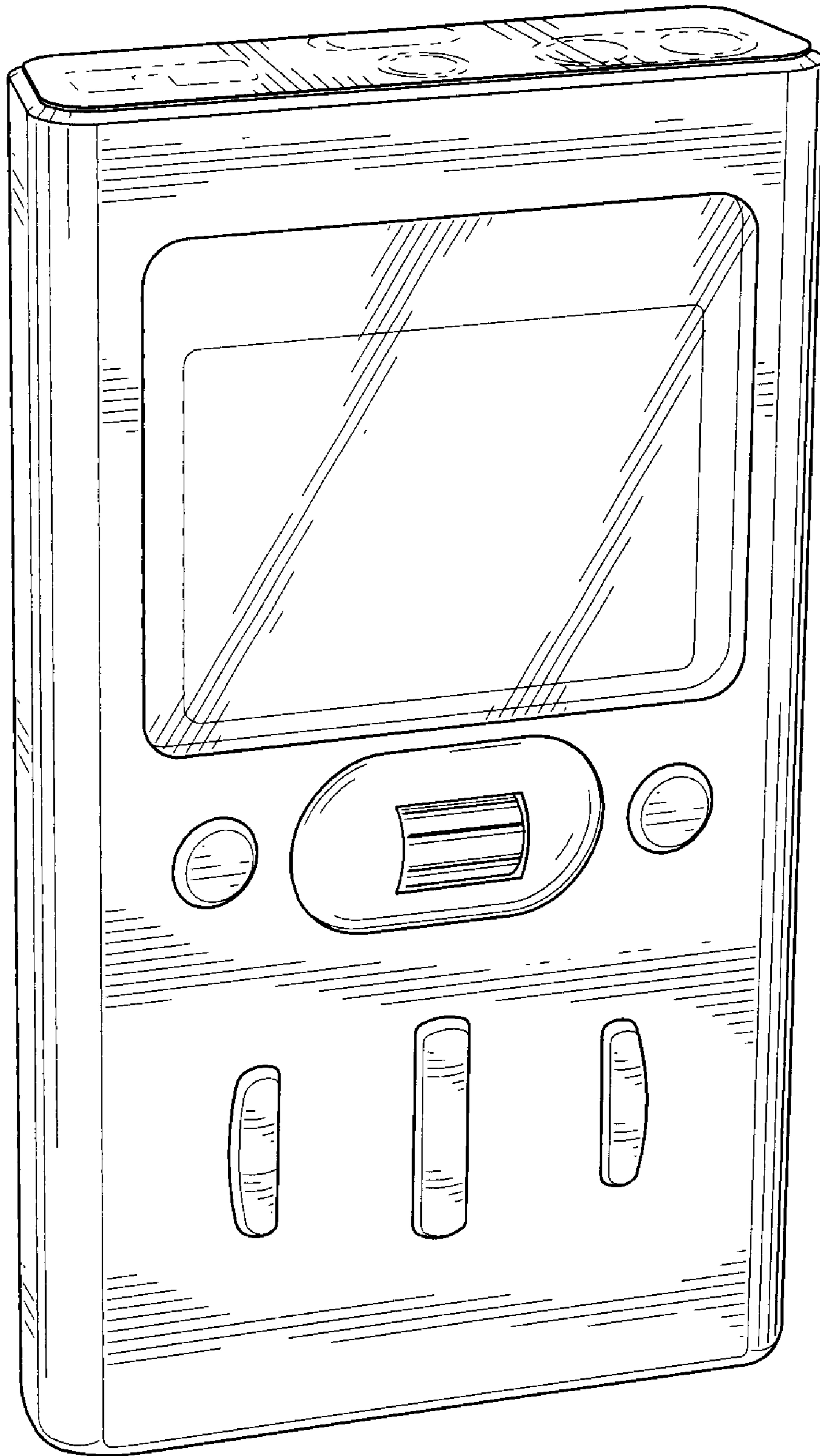
FIG. 6 is a bottom plan view thereof; and,

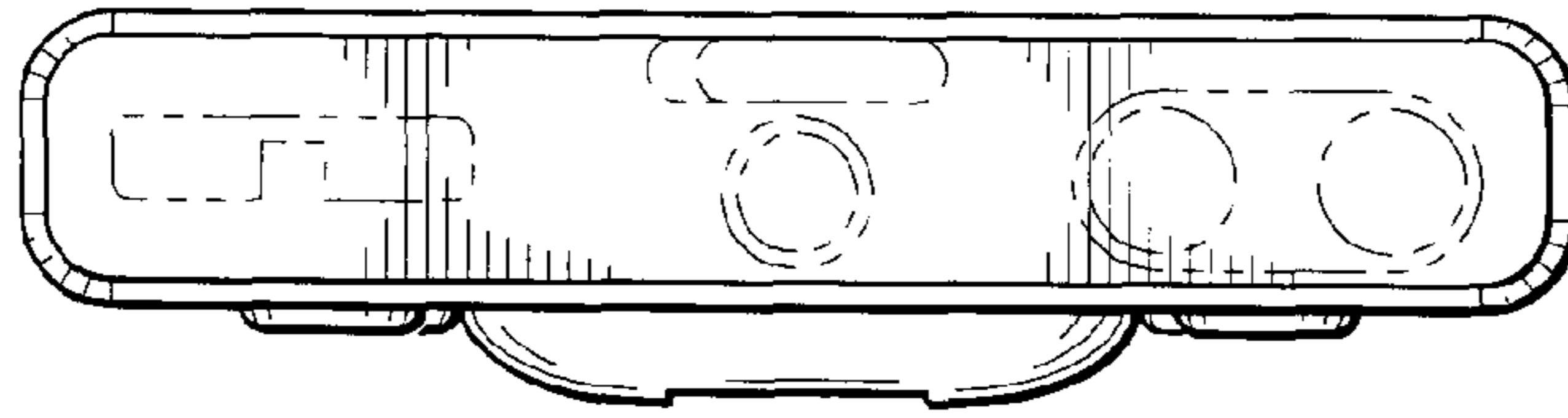

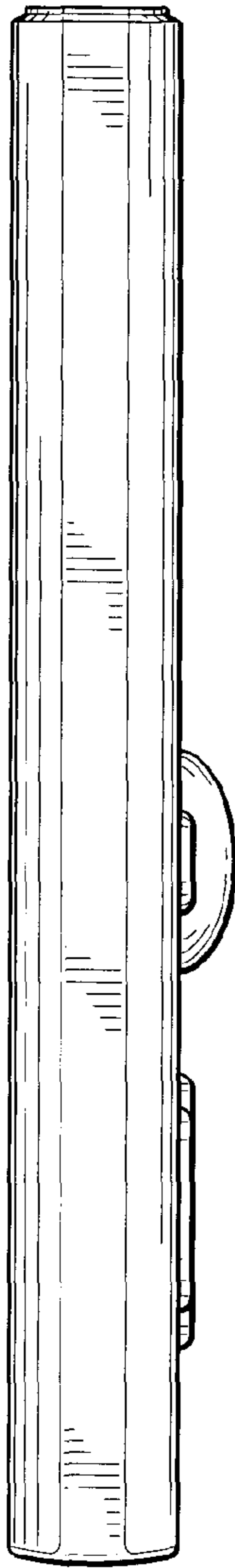

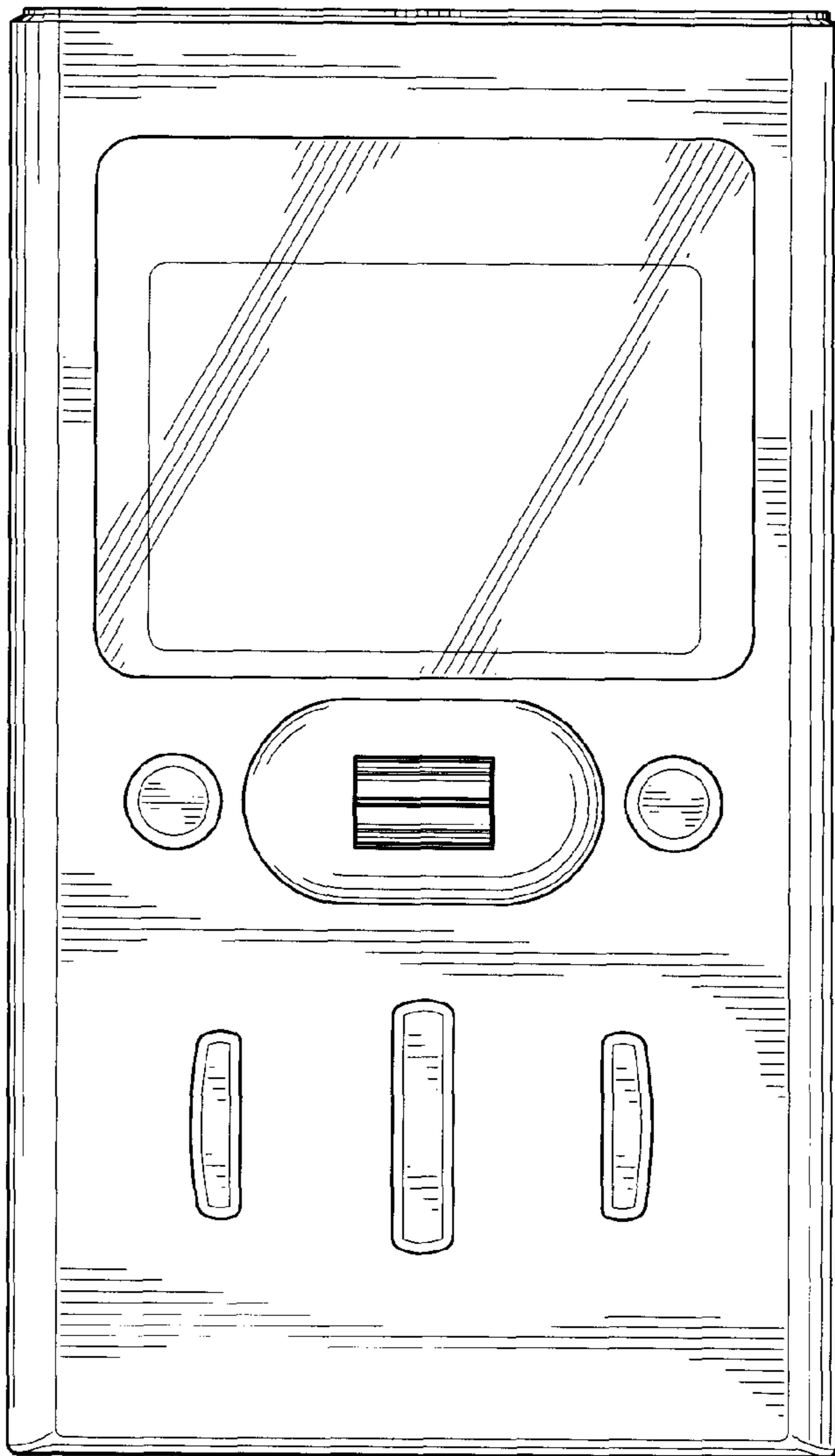

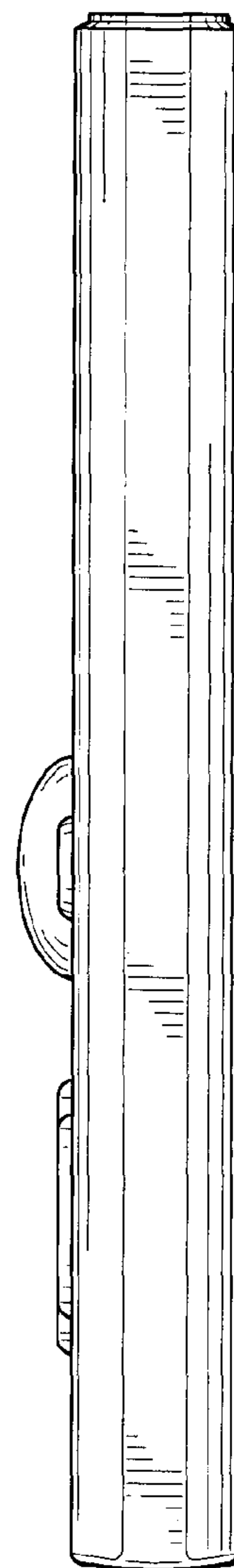
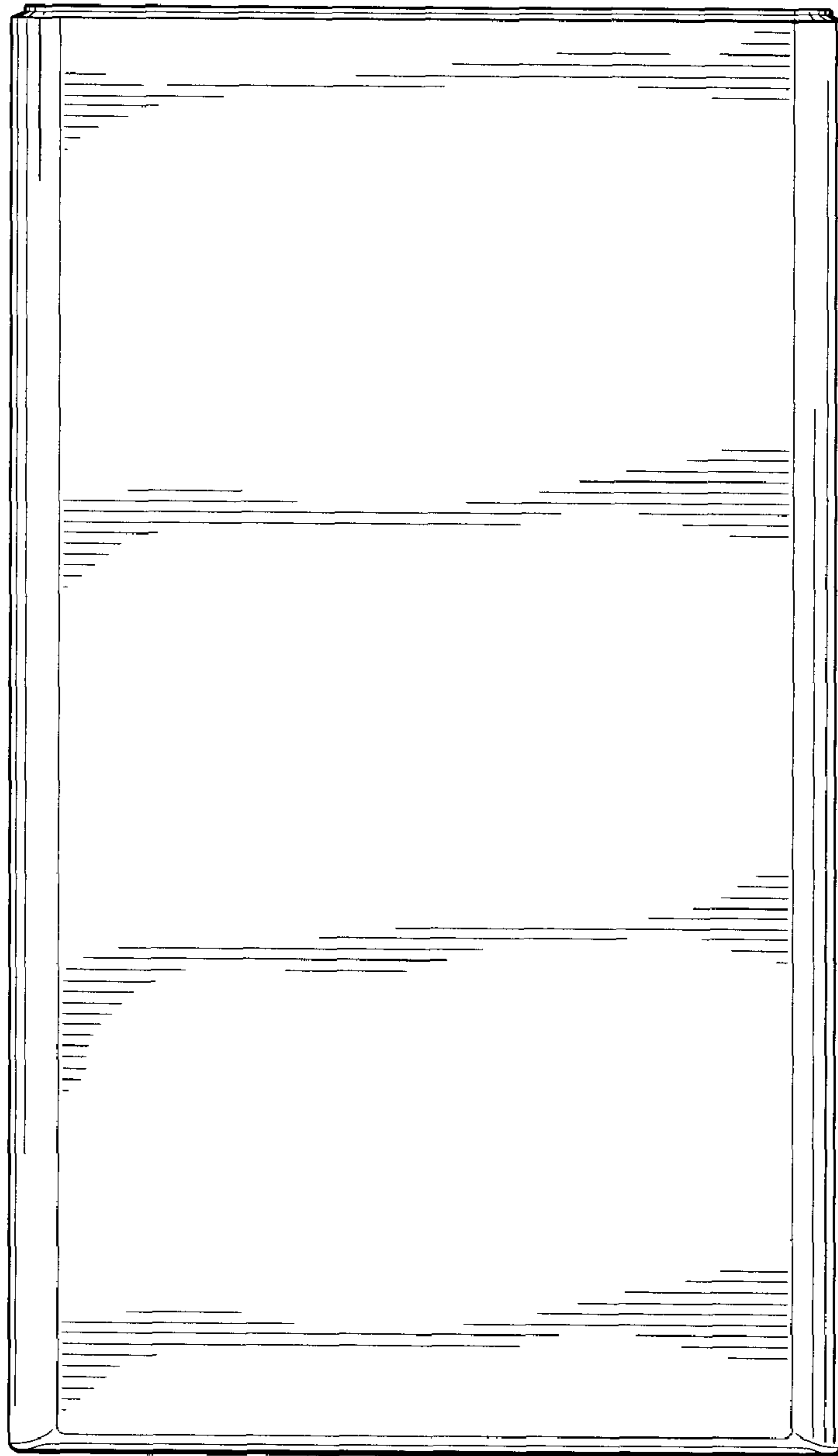
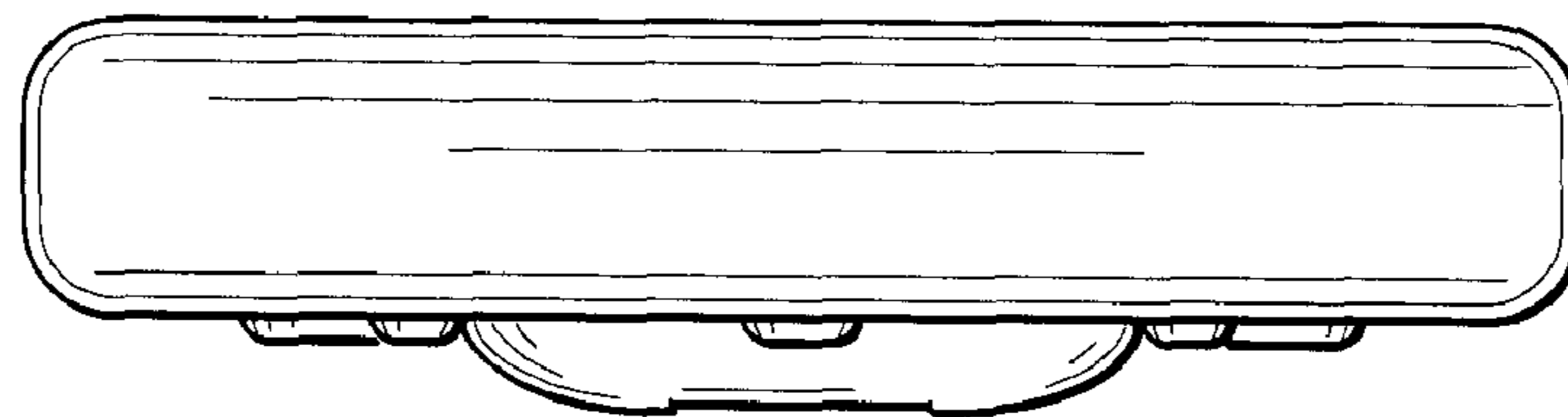
