DESCRIPTION

FIG. 4 is a back view of the left component of the rounded earphones of FIG. 1;

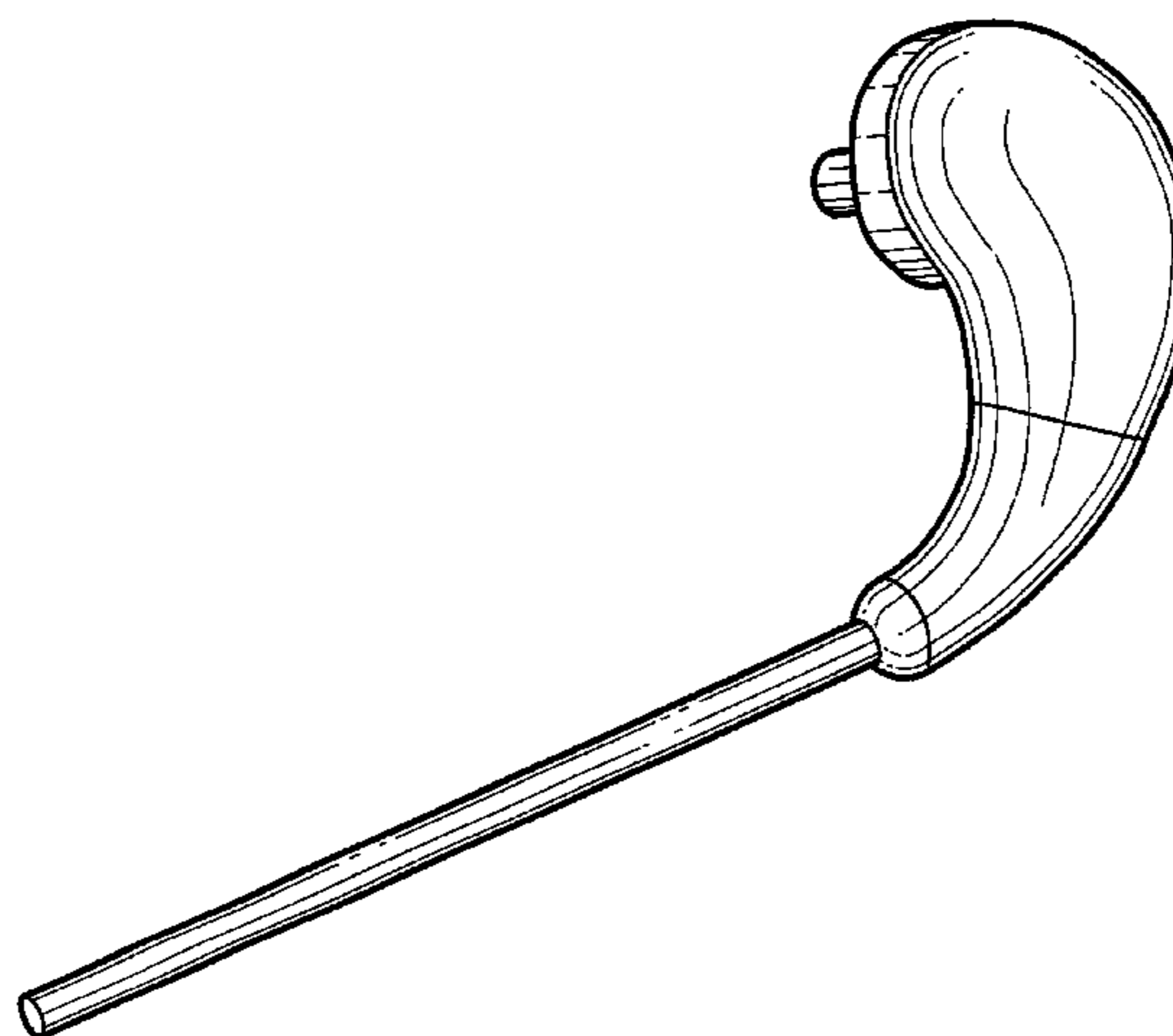
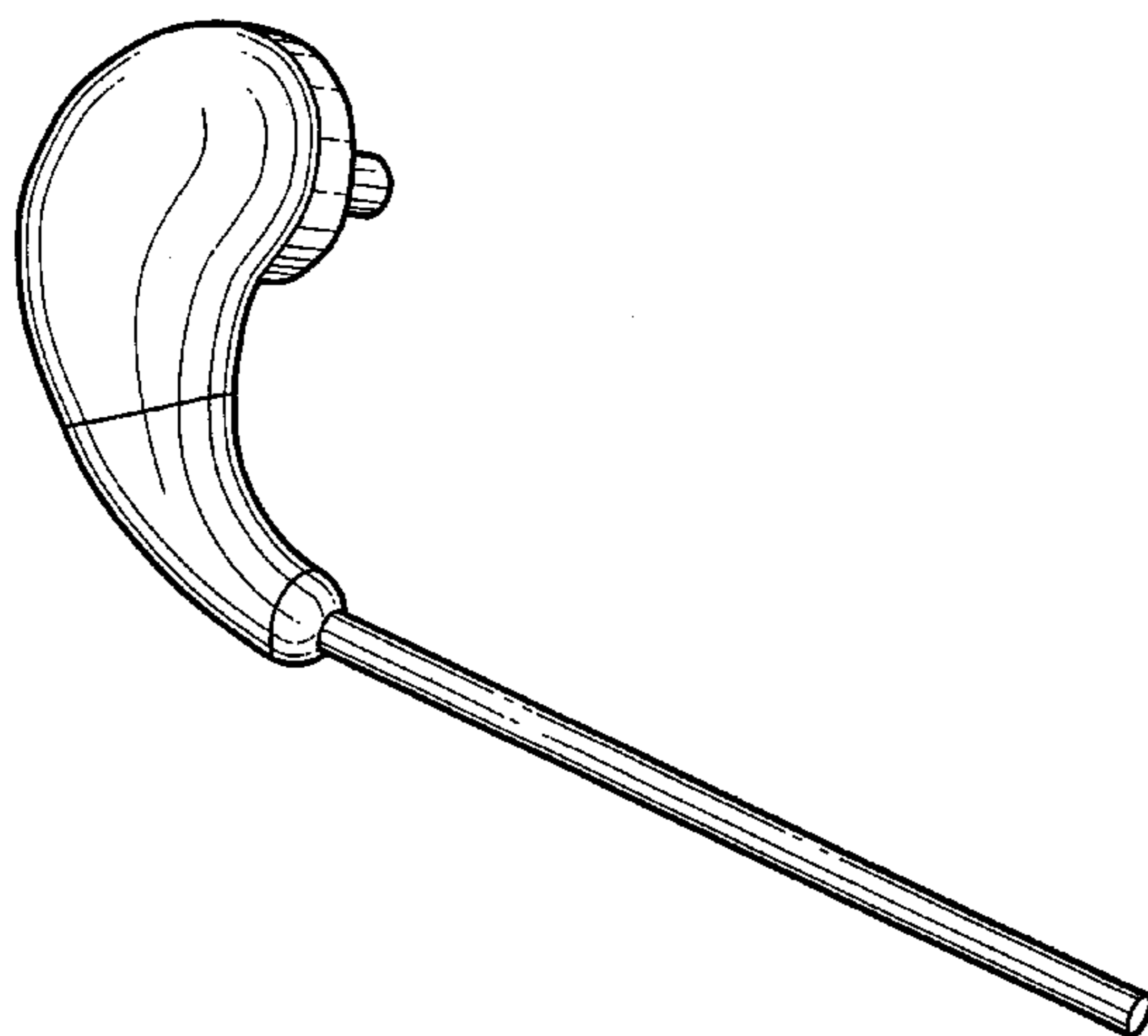
FIG. 5 is a rear perspective view of a right component of the rounded earphones illustrating my new design;

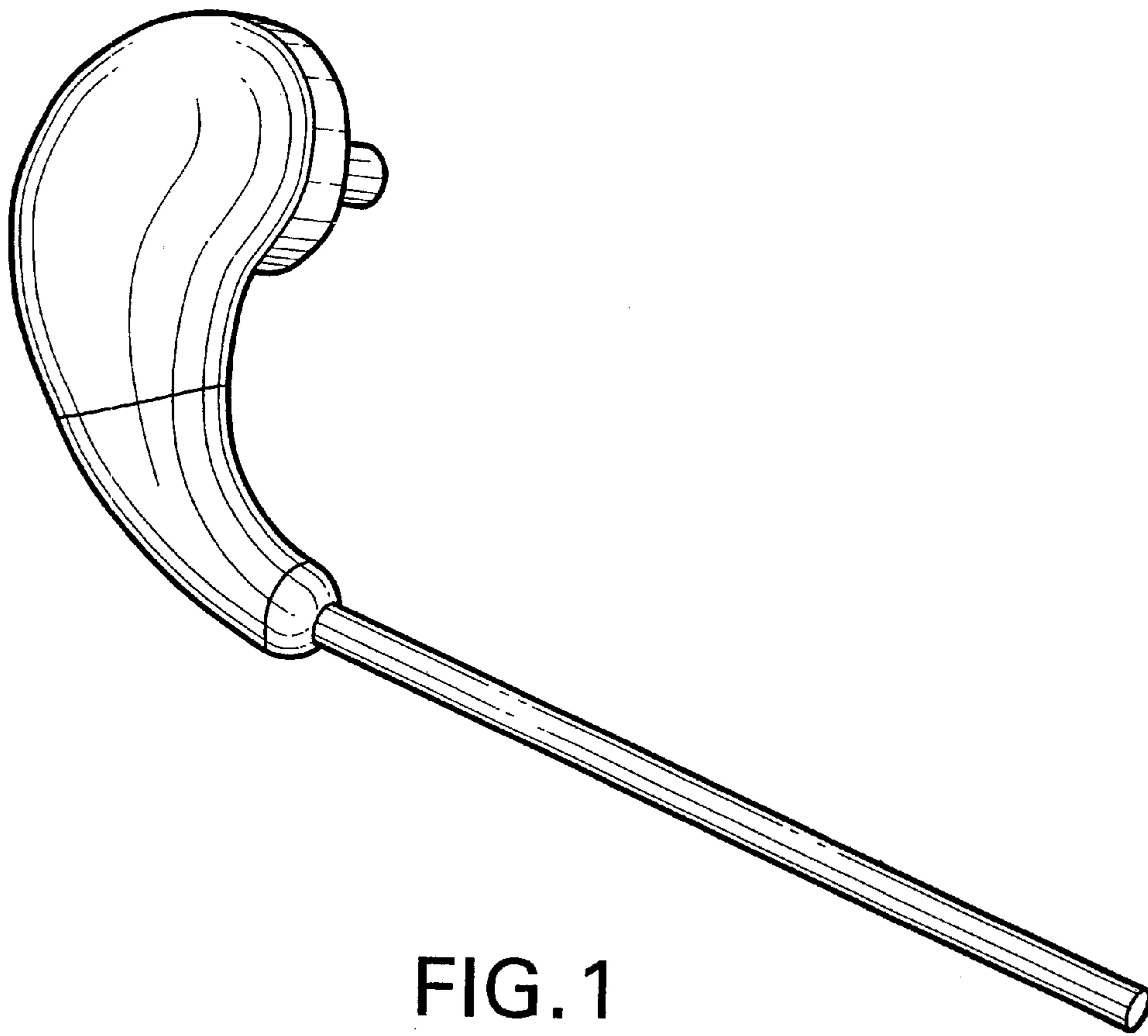

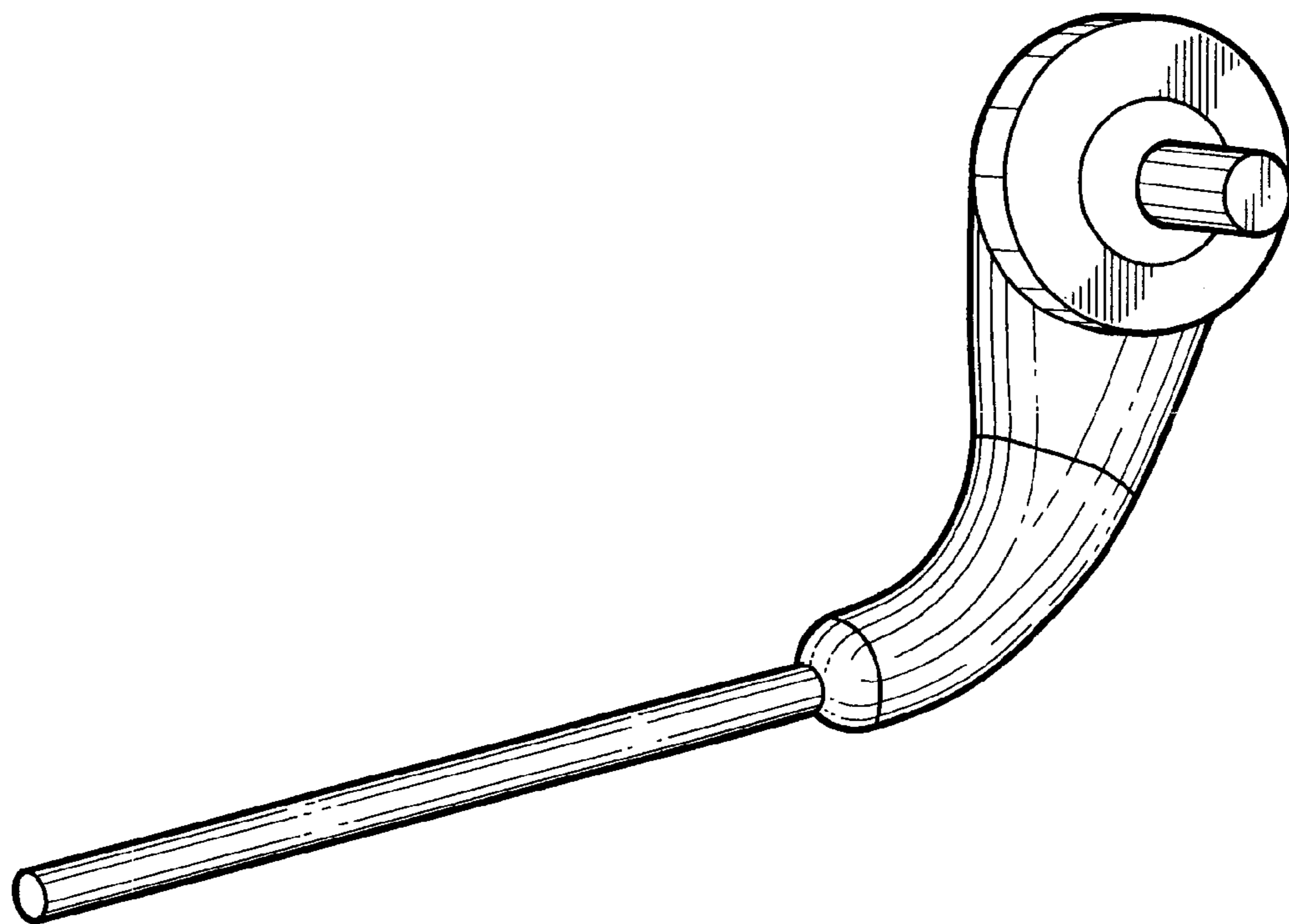

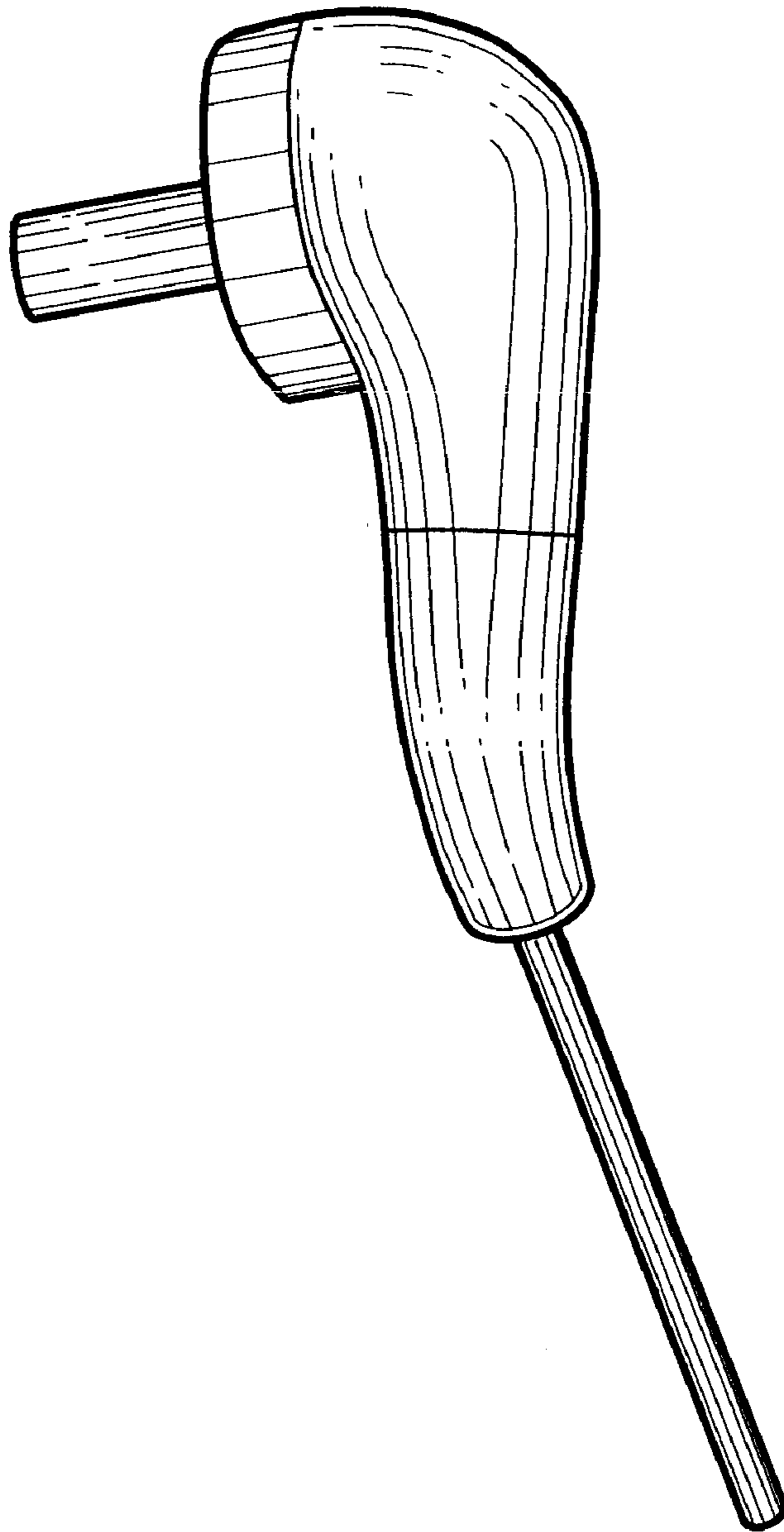

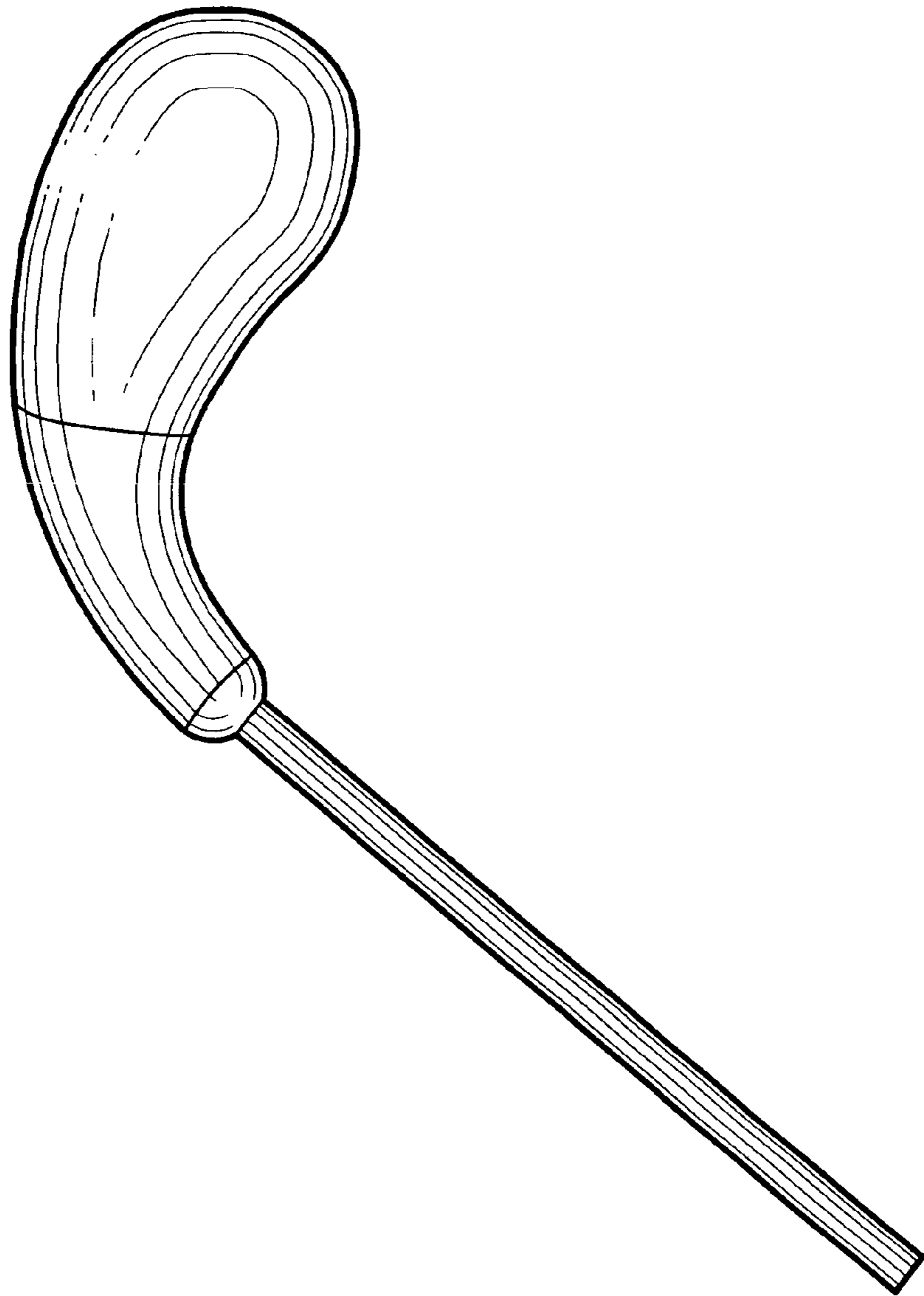

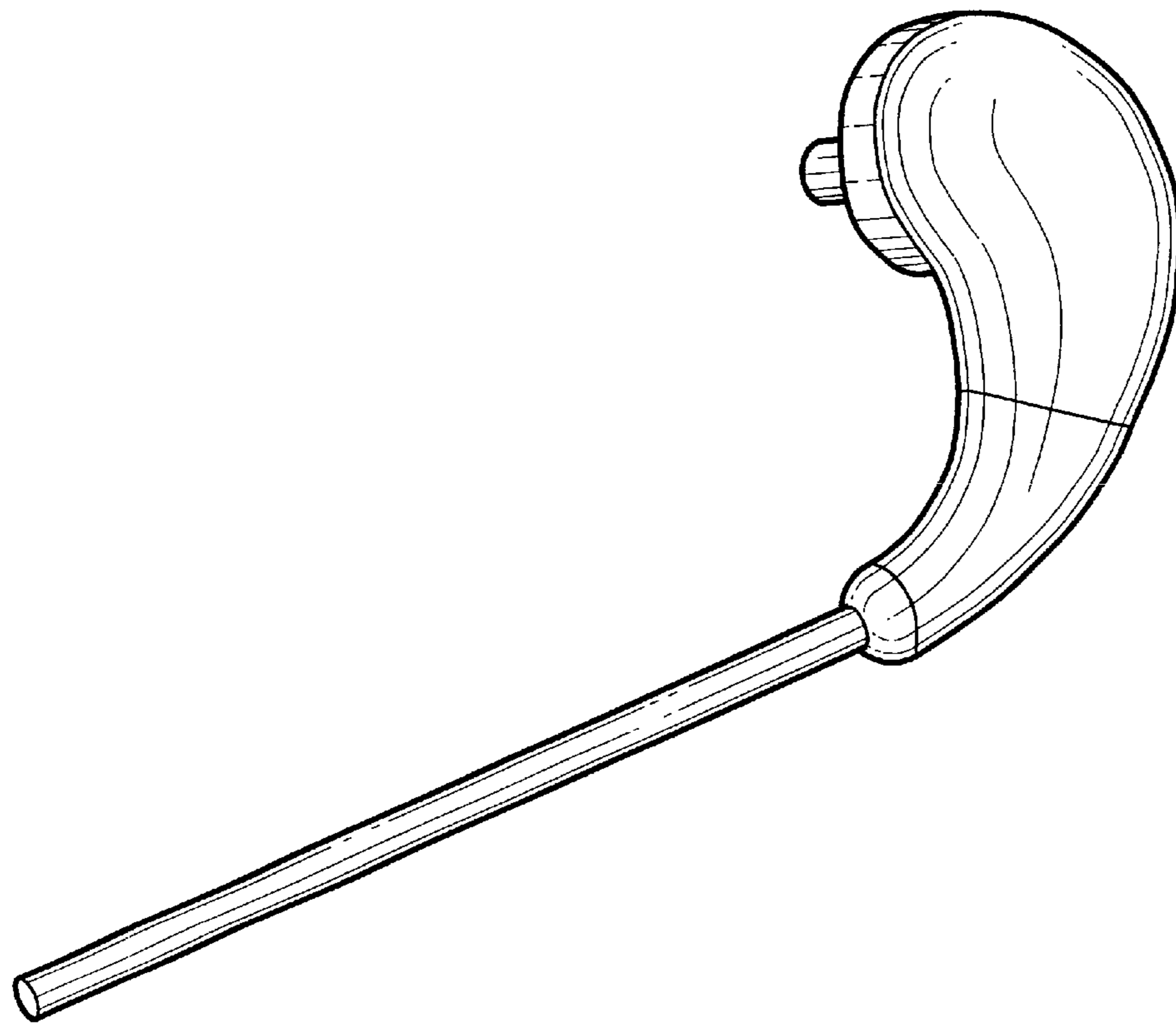

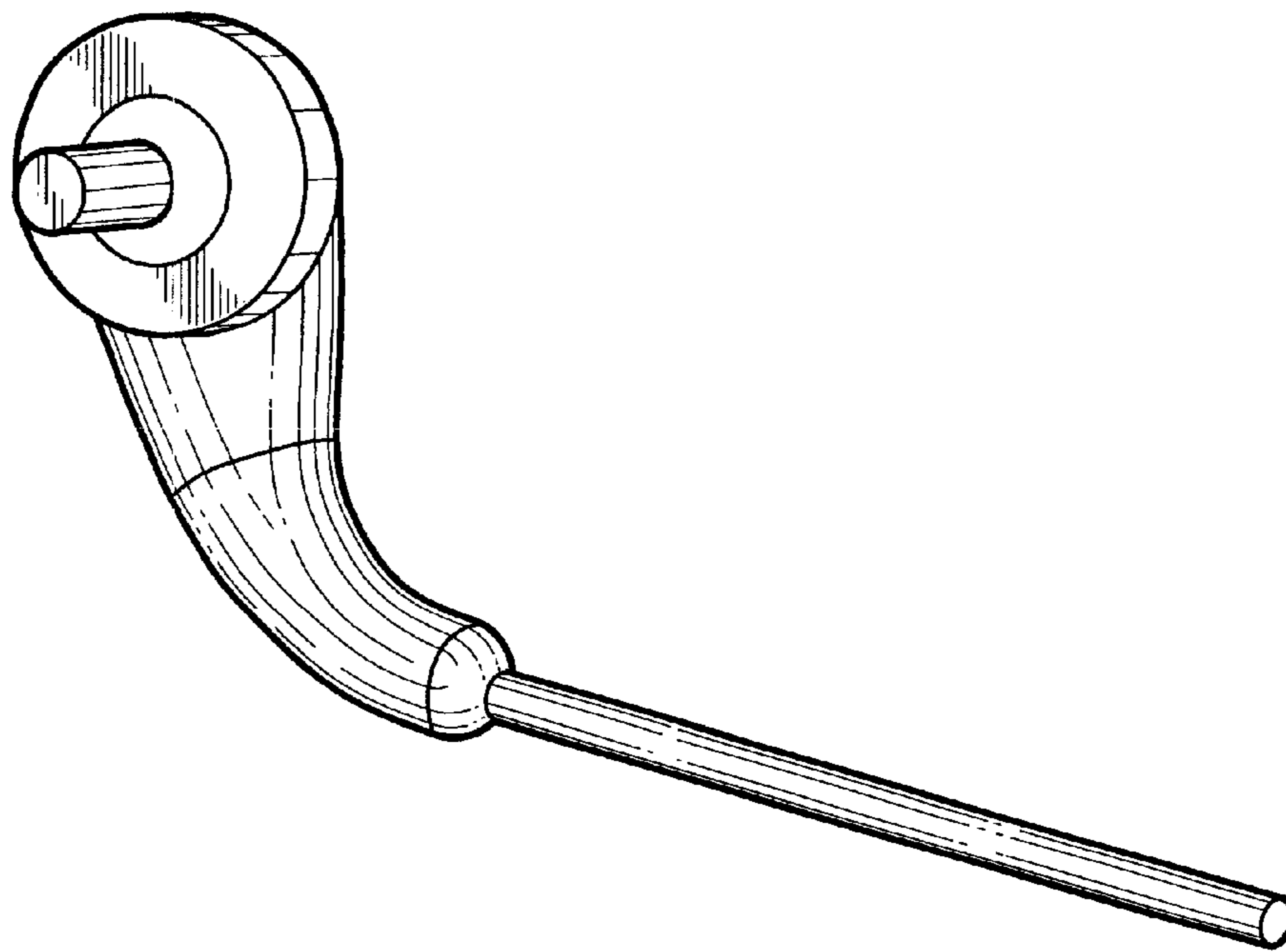

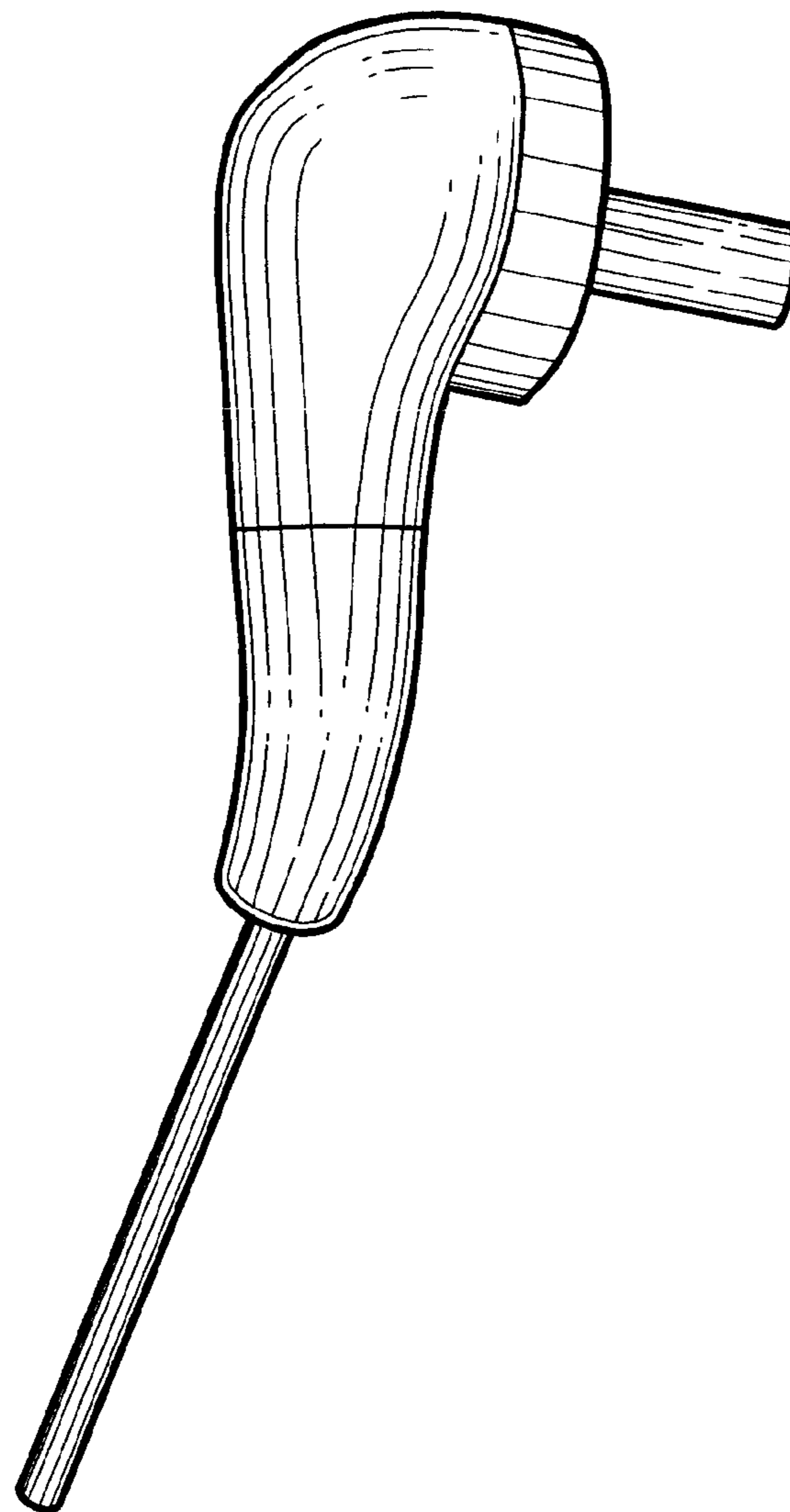

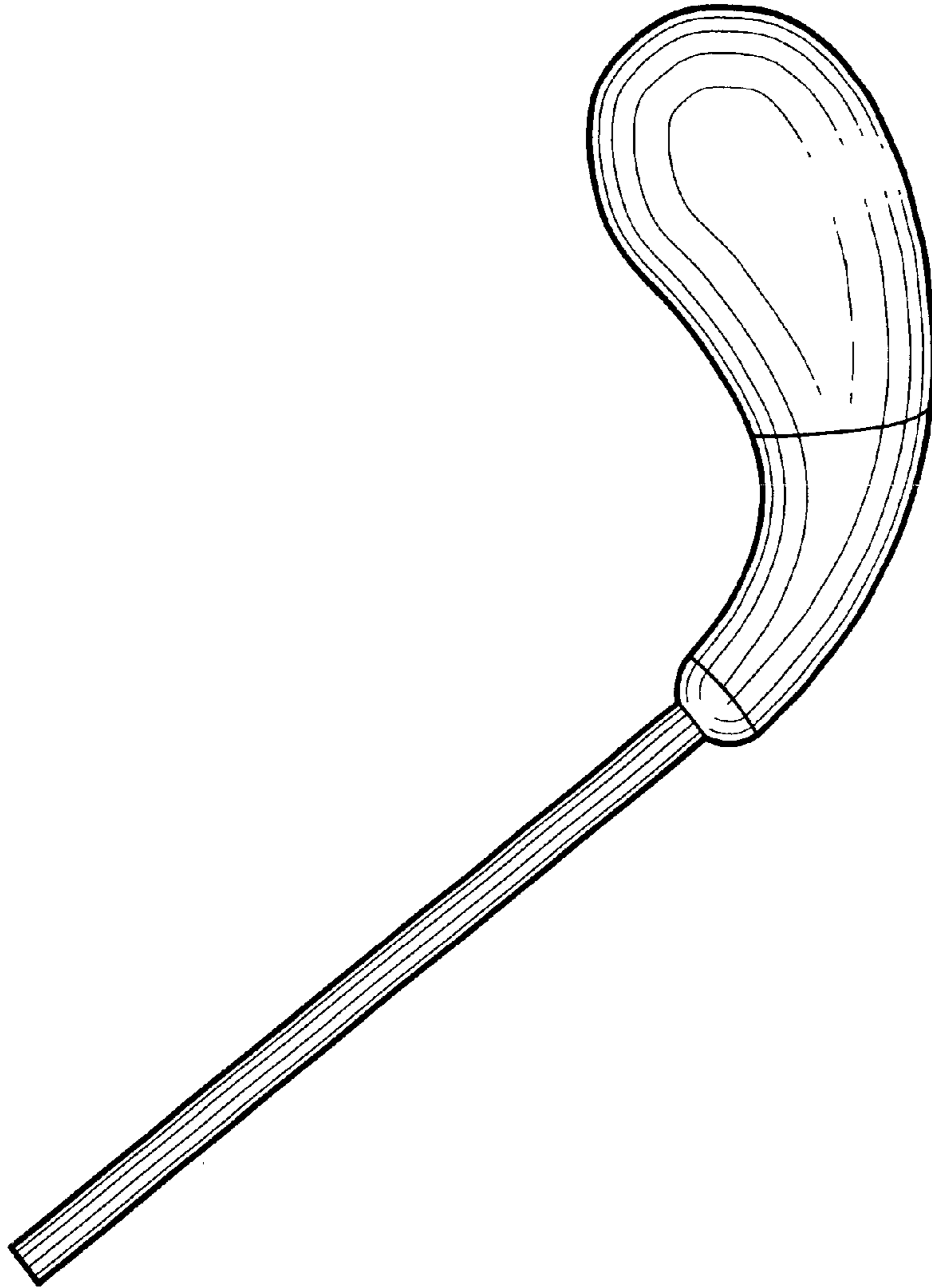
