(57) **CLAIM**

The ornamental design for the eyeglasses frame, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the eyeglasses frame showing my design;

FIG. 2 is a right elevational view thereof, the left elevational view being a mirror image thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a rear elevational view thereof;

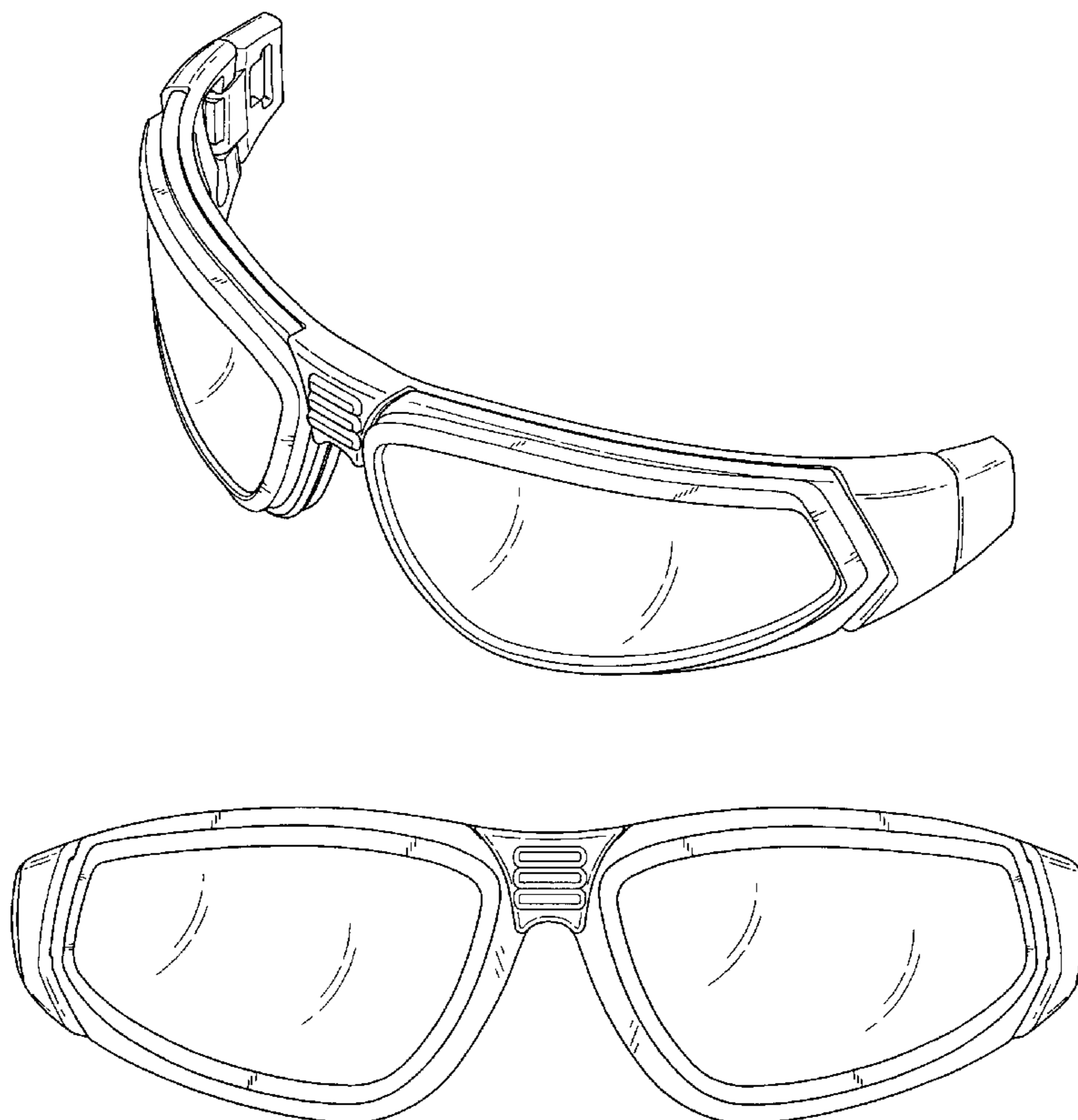
FIG. 5 is a top plan view thereof;

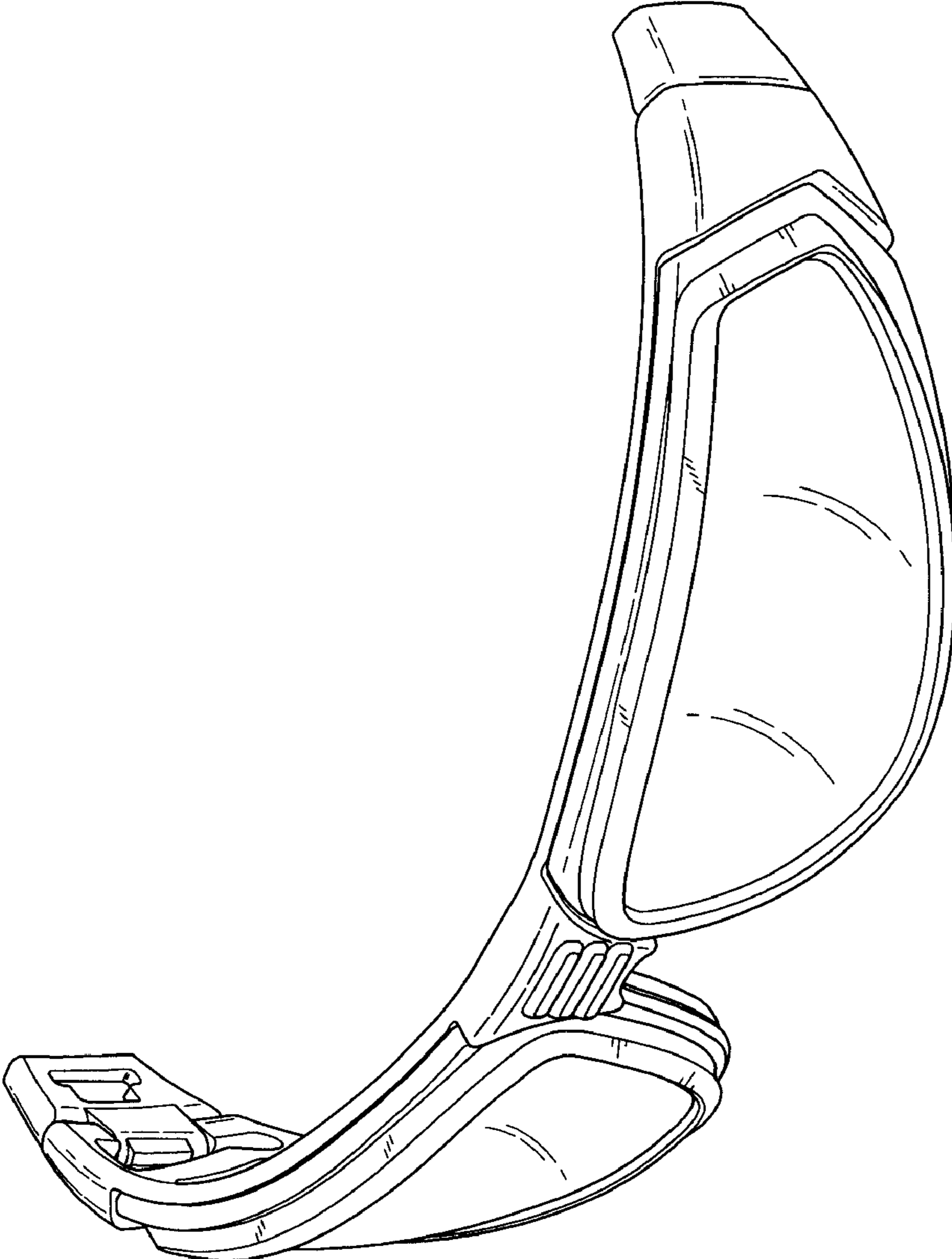

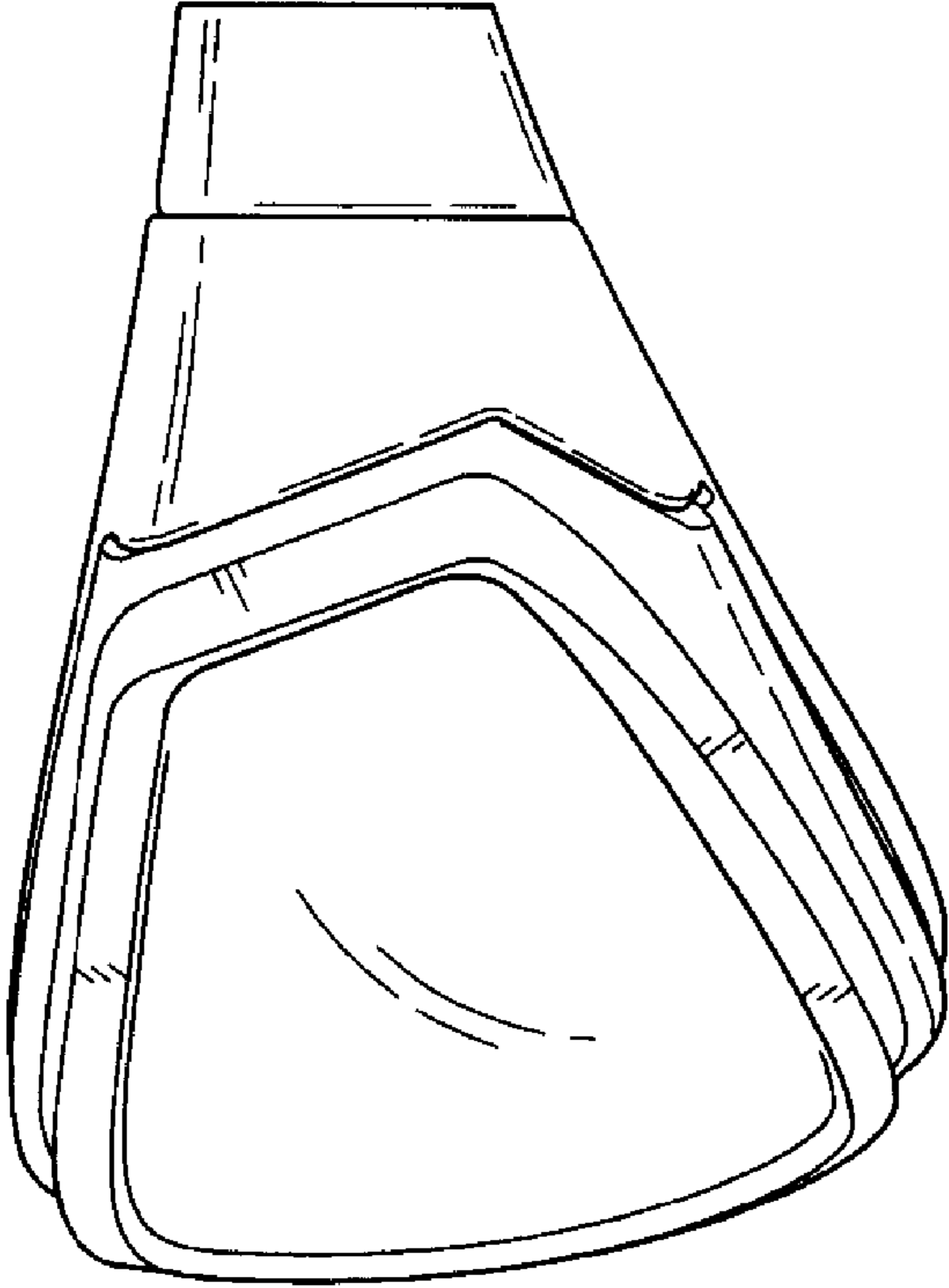

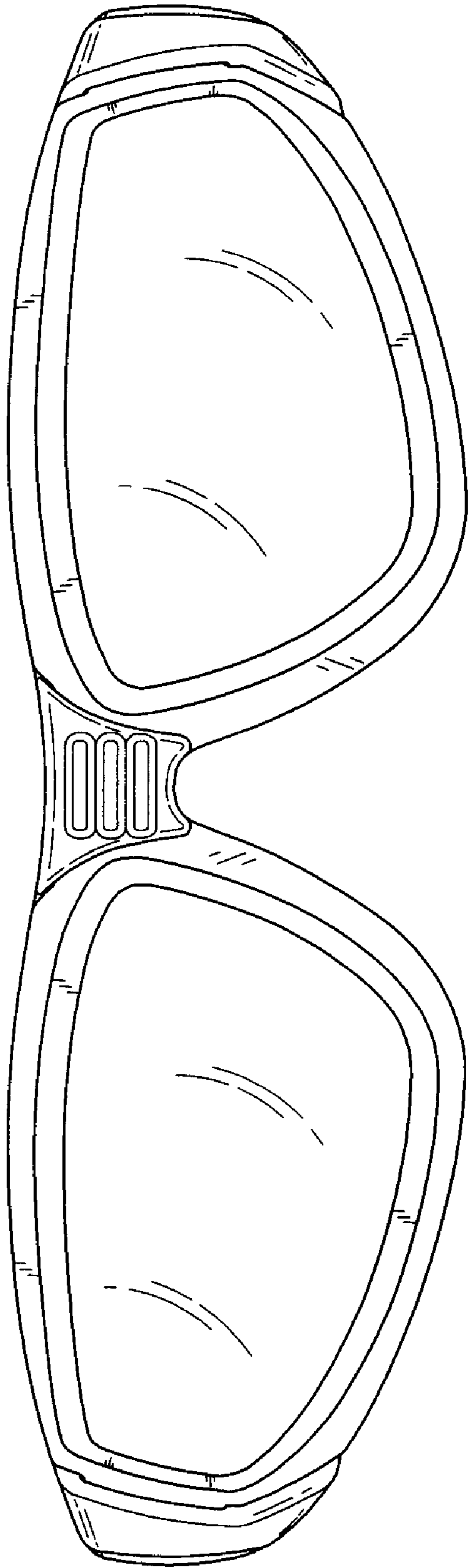

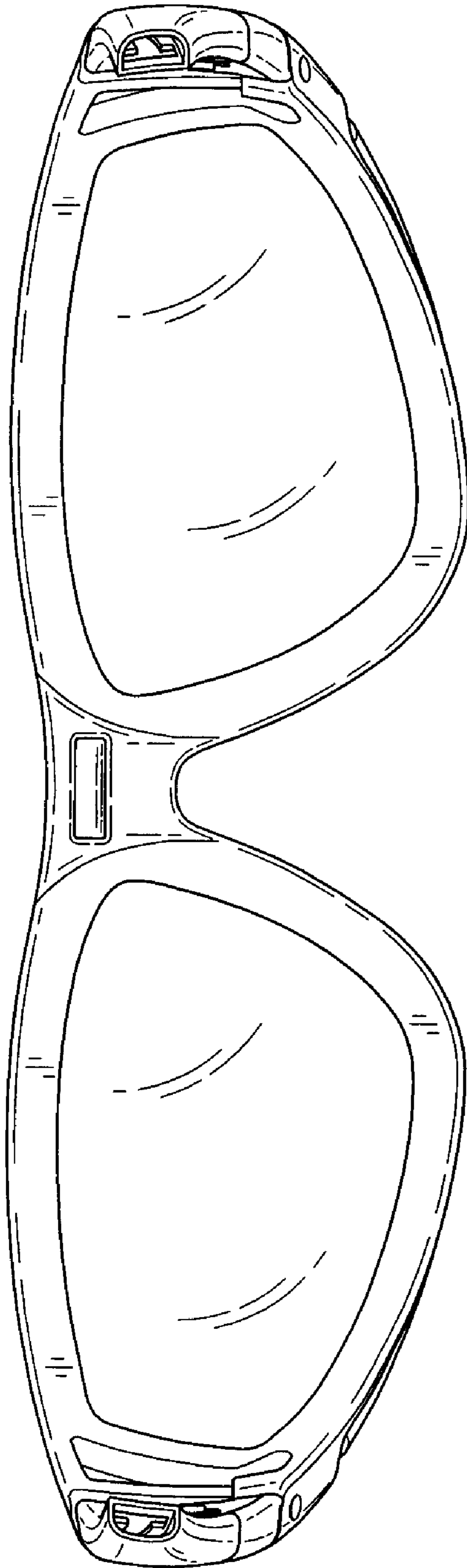

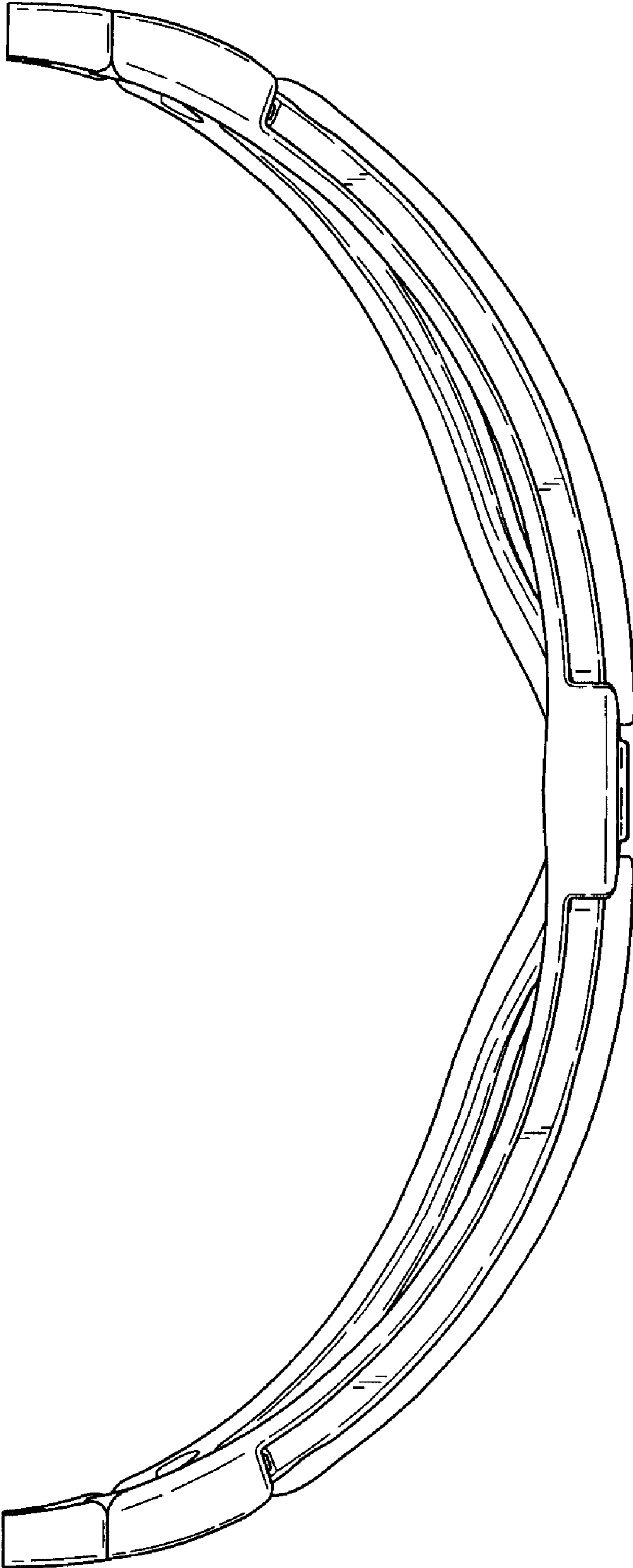

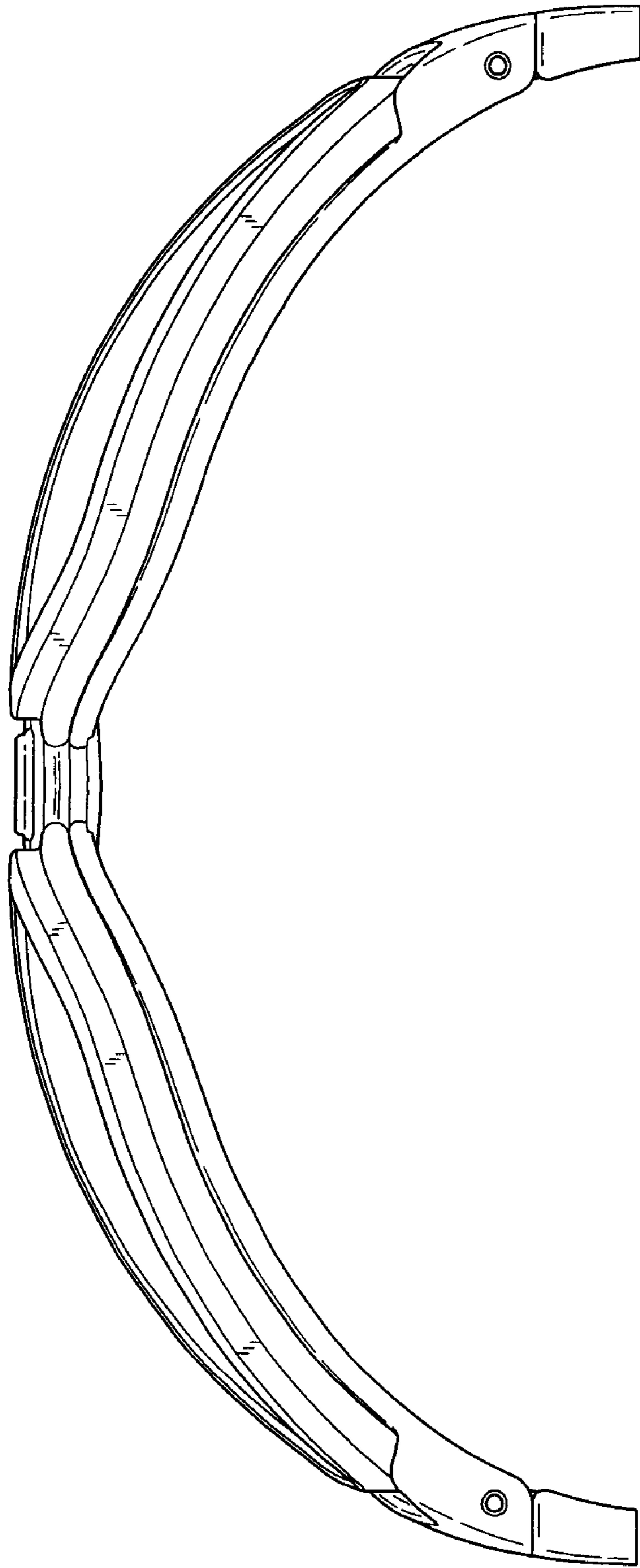

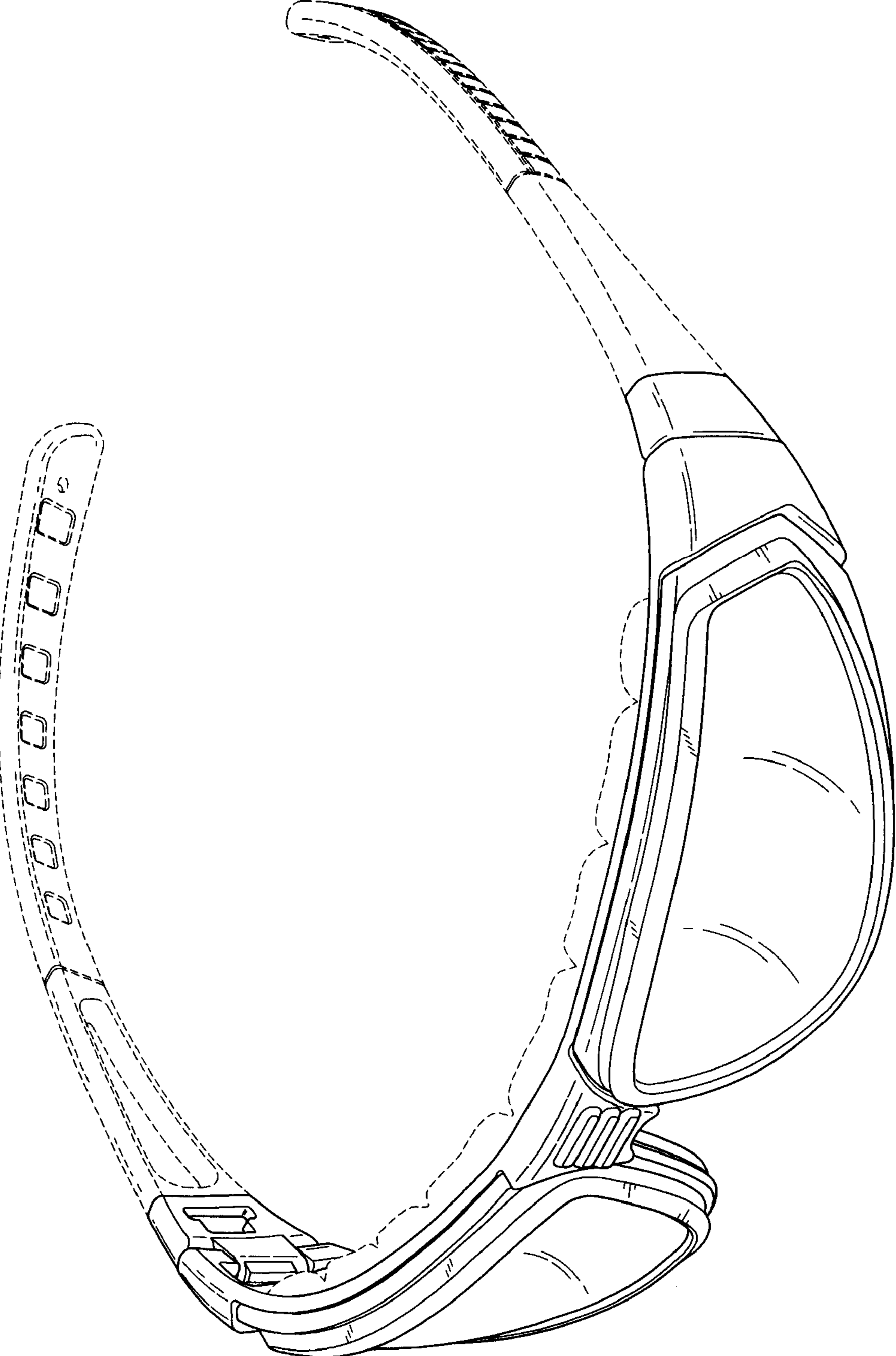

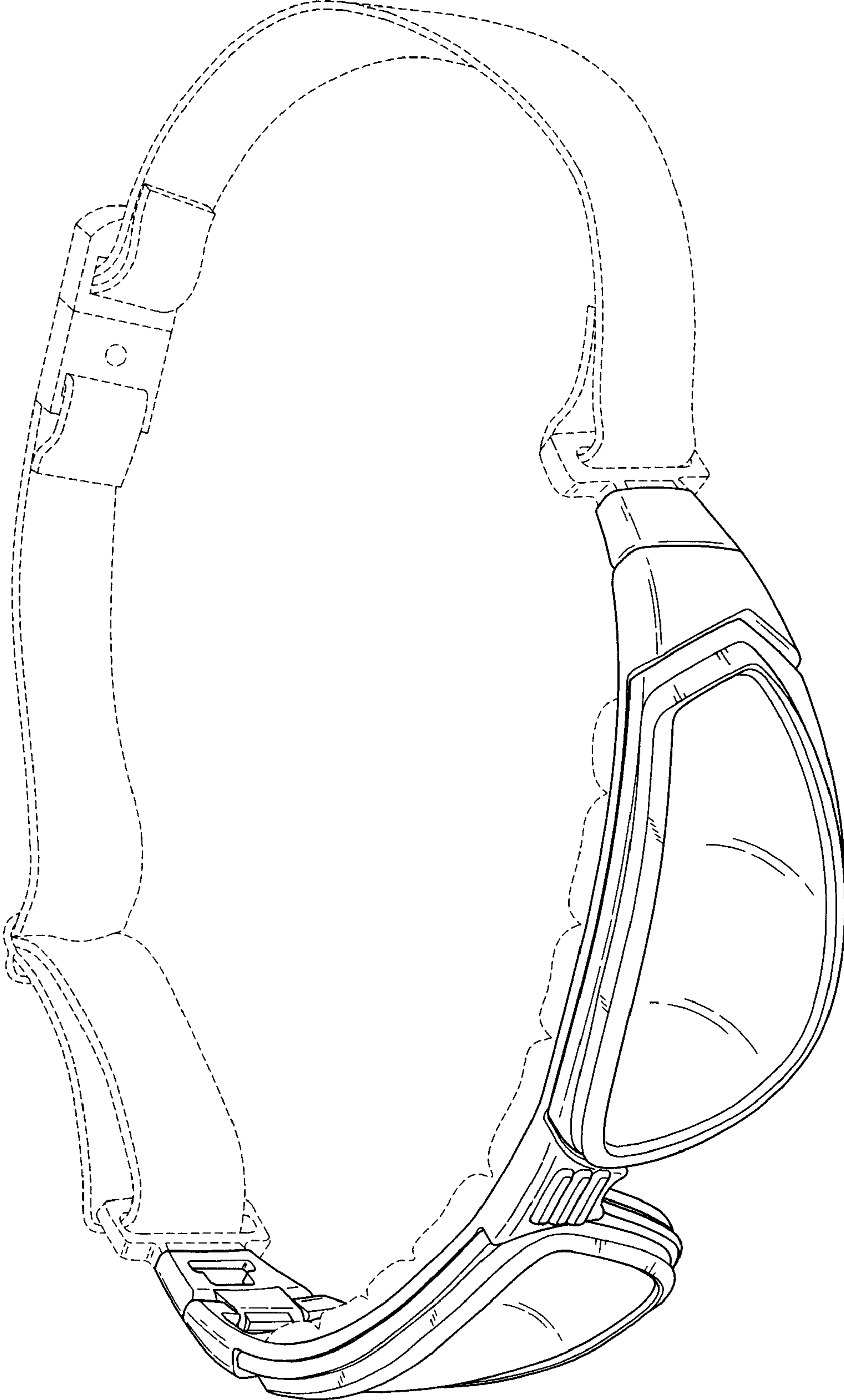
