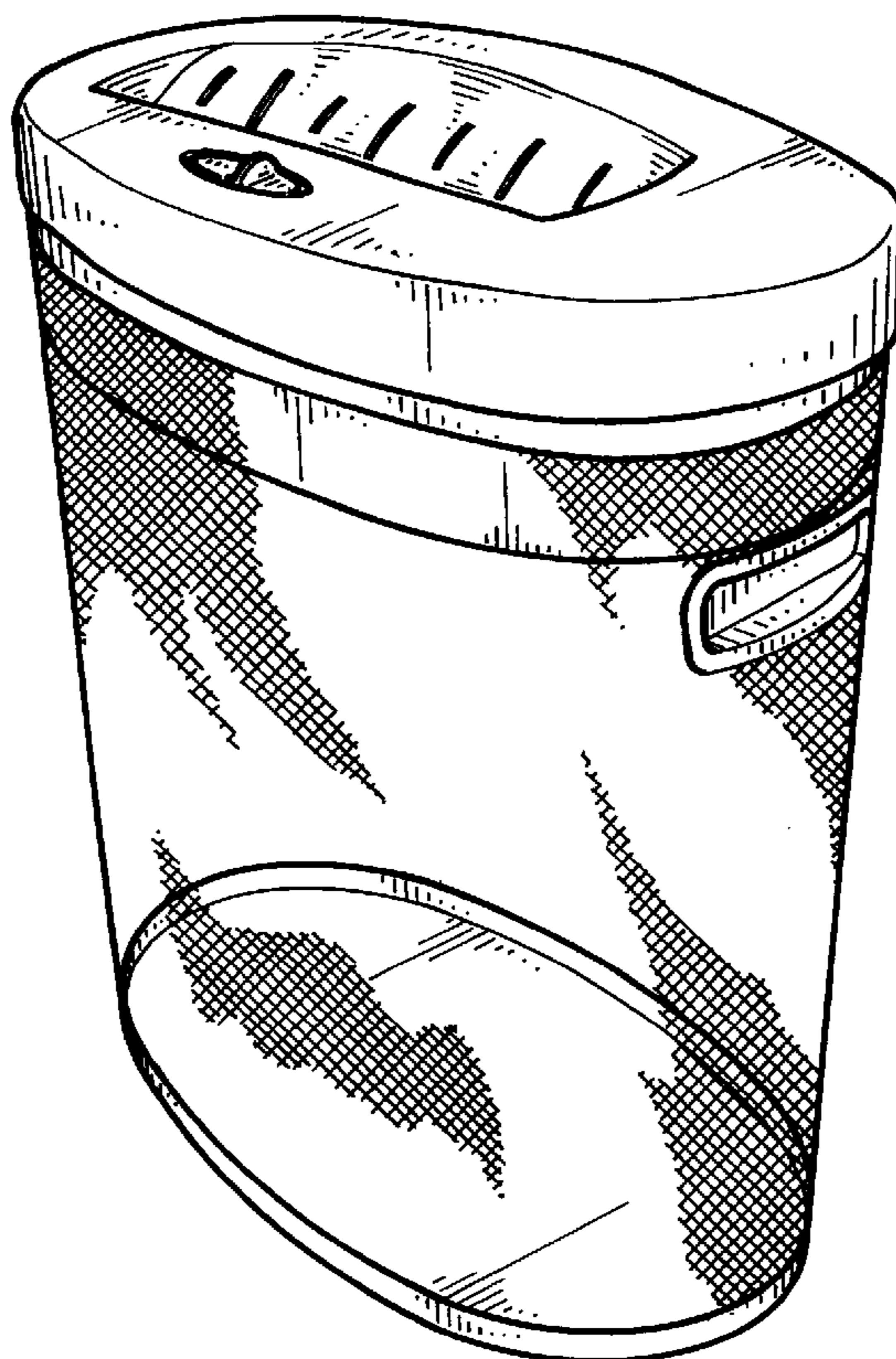
(57) **CLAIM**

The ornamental design for paper shredder, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of paper shredder showing my new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a top plan view thereof;  
FIG. 5 is a bottom plan view thereof;  
FIG. 6 is a left side elevational view thereof; and,  
FIG. 7 is a right side elevational view thereof.  
The texture shown in fragment on the collection container member in FIGS. 1, 2, 3, 6 and 7 represents an overall pattern within the indicated area.

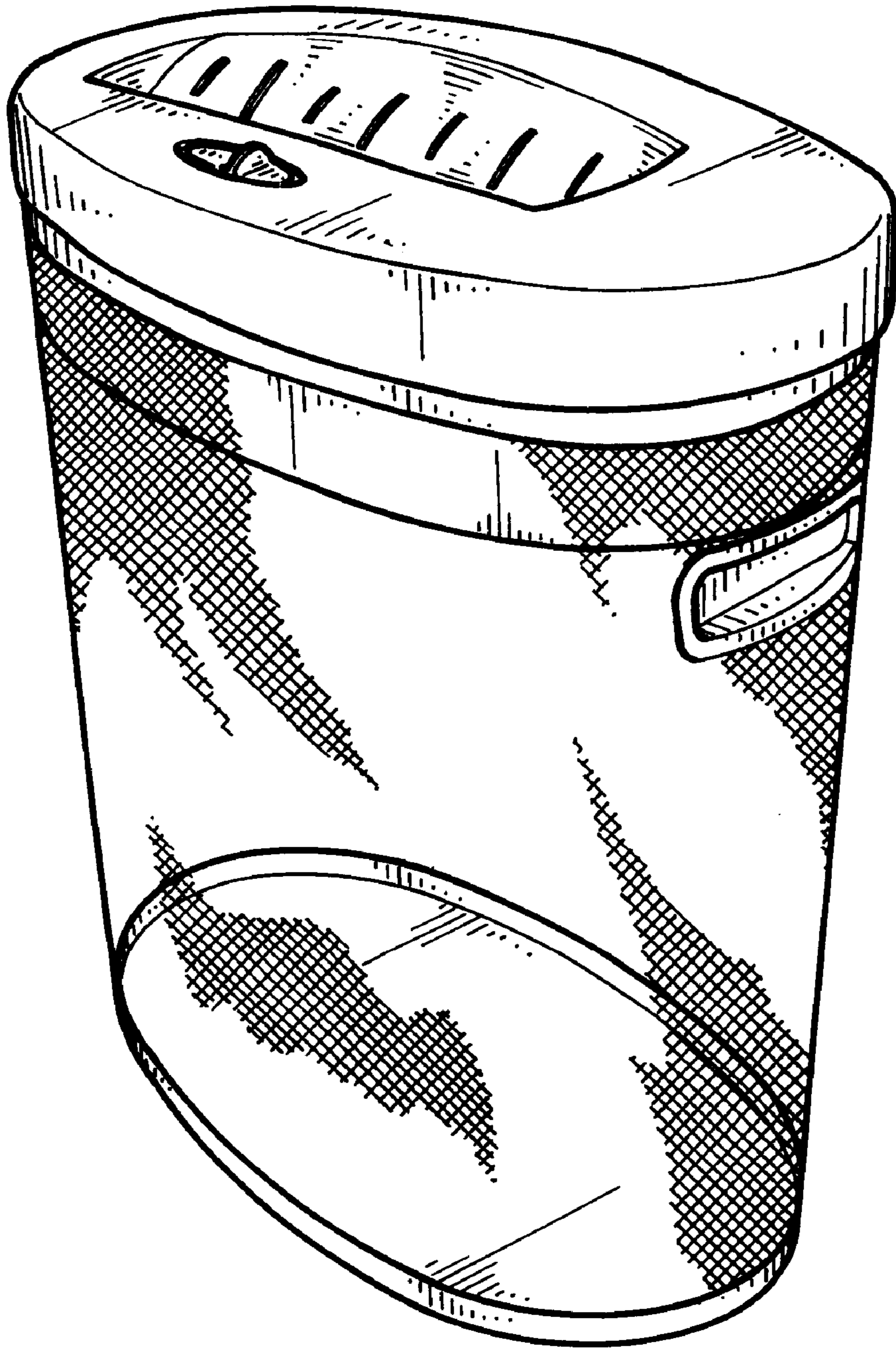

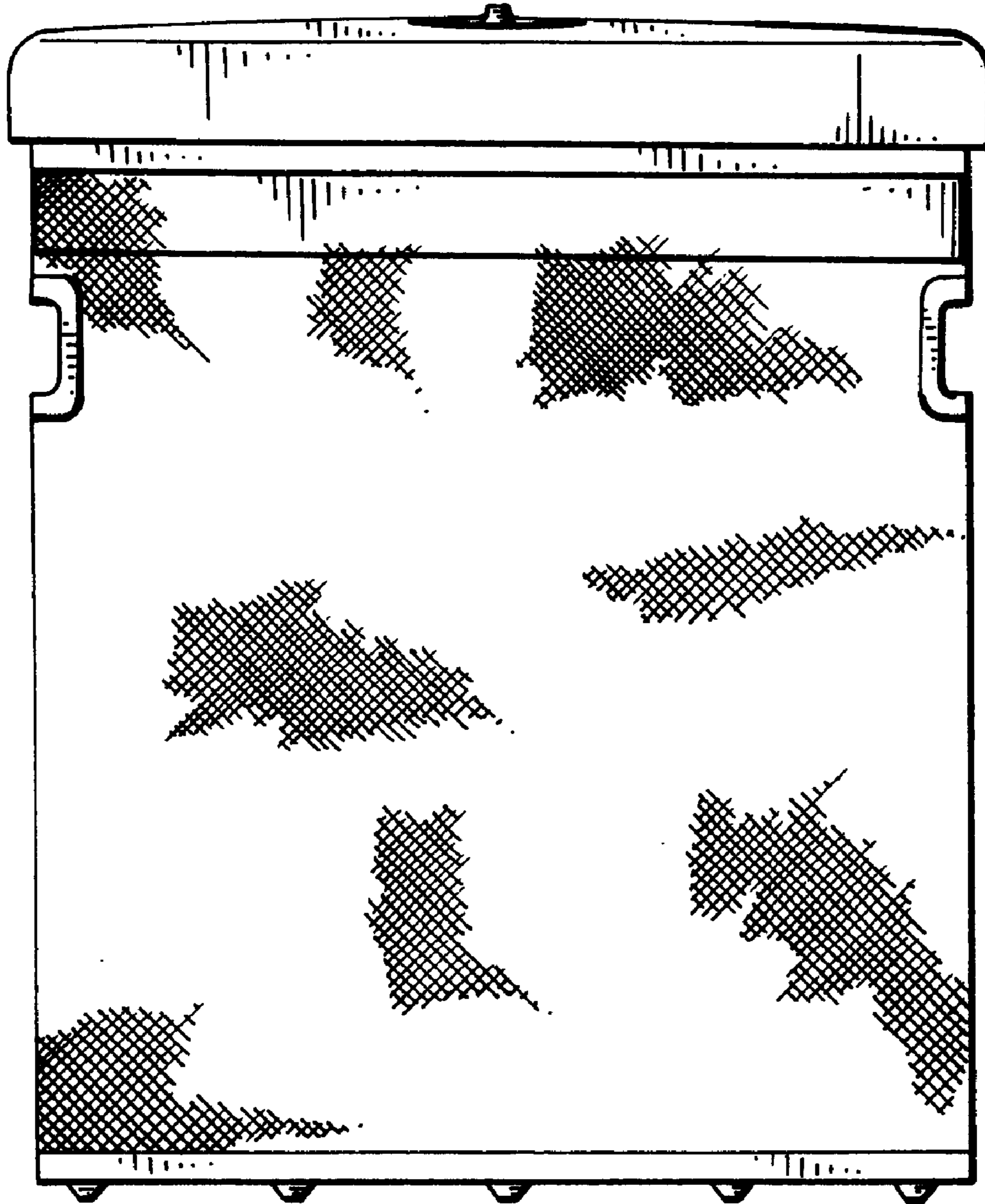

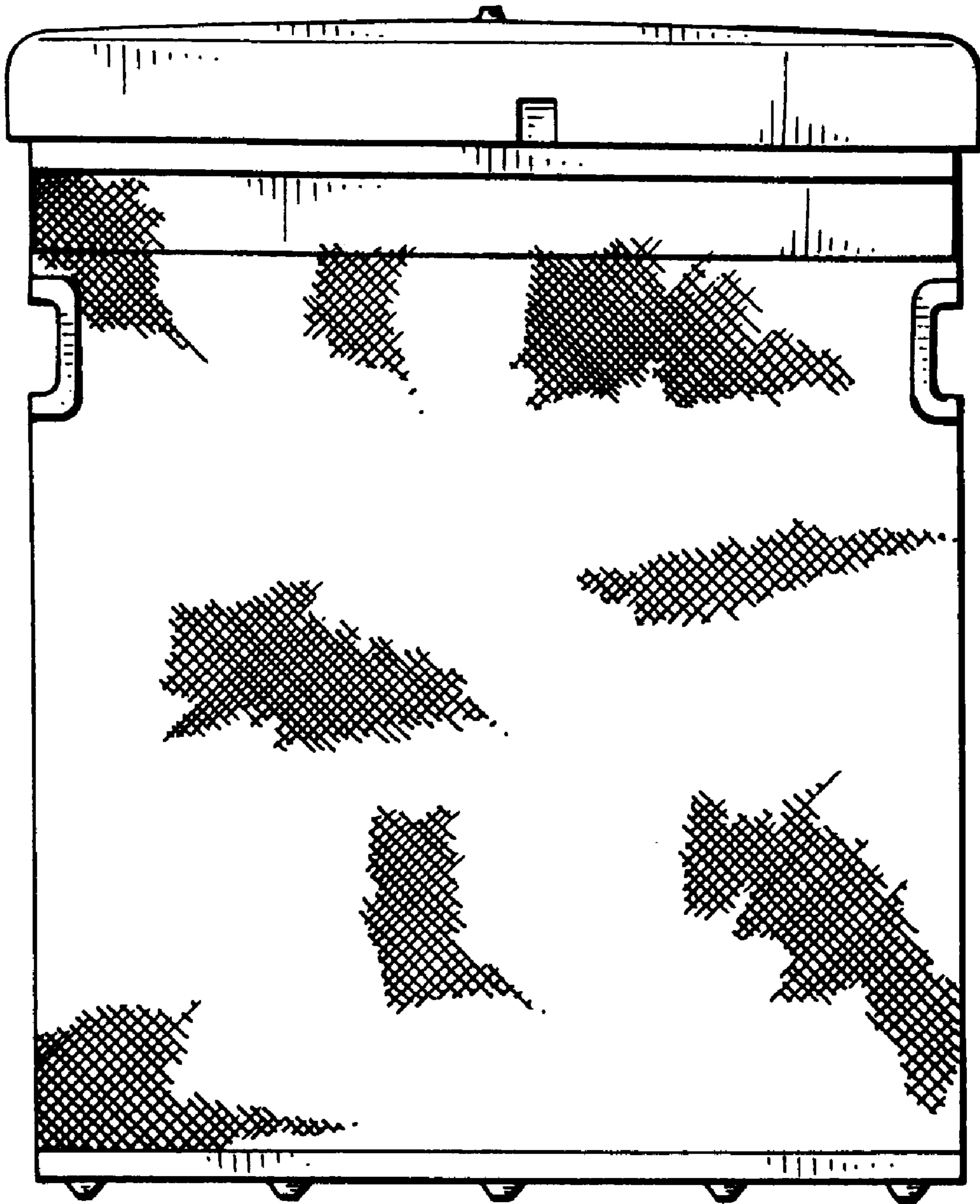

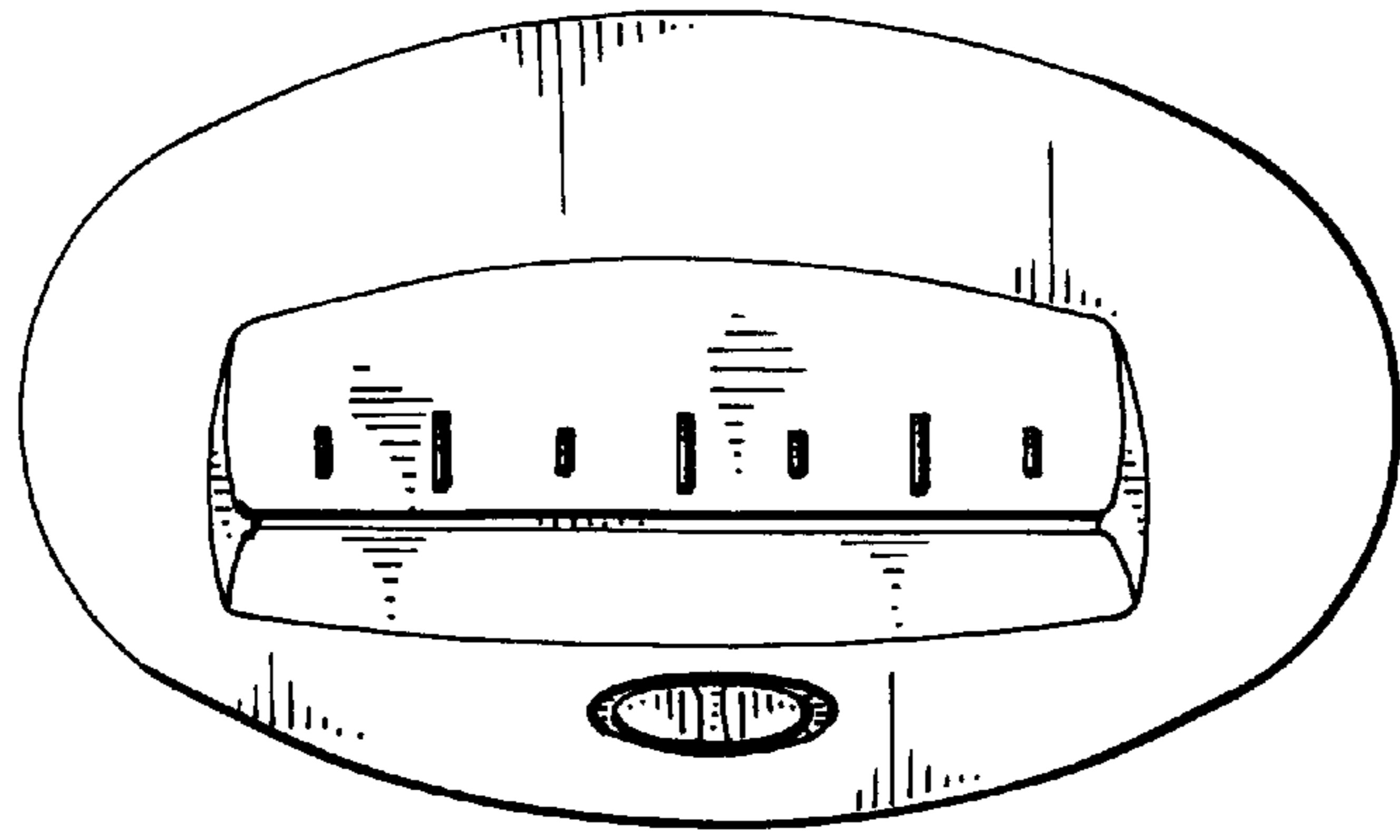

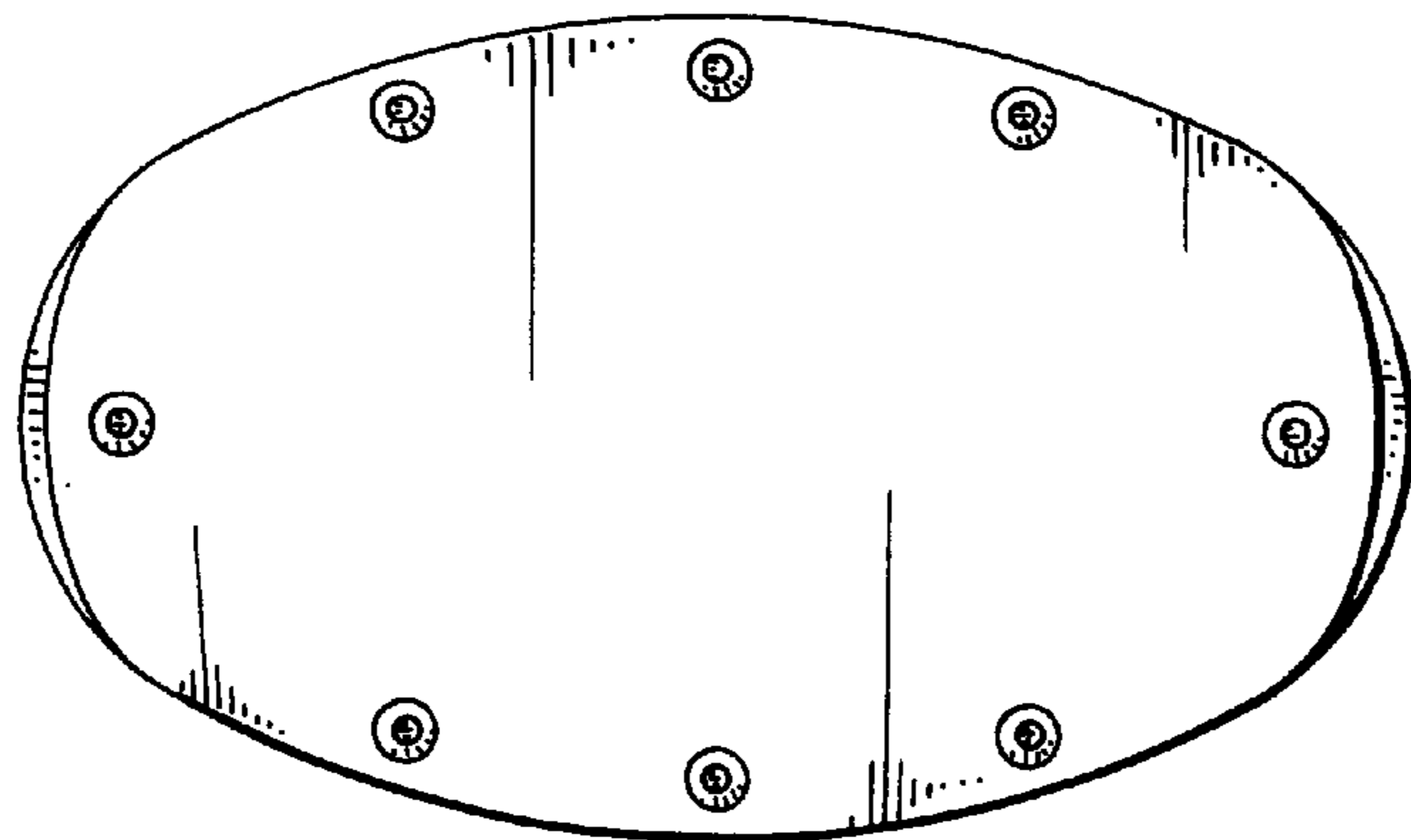

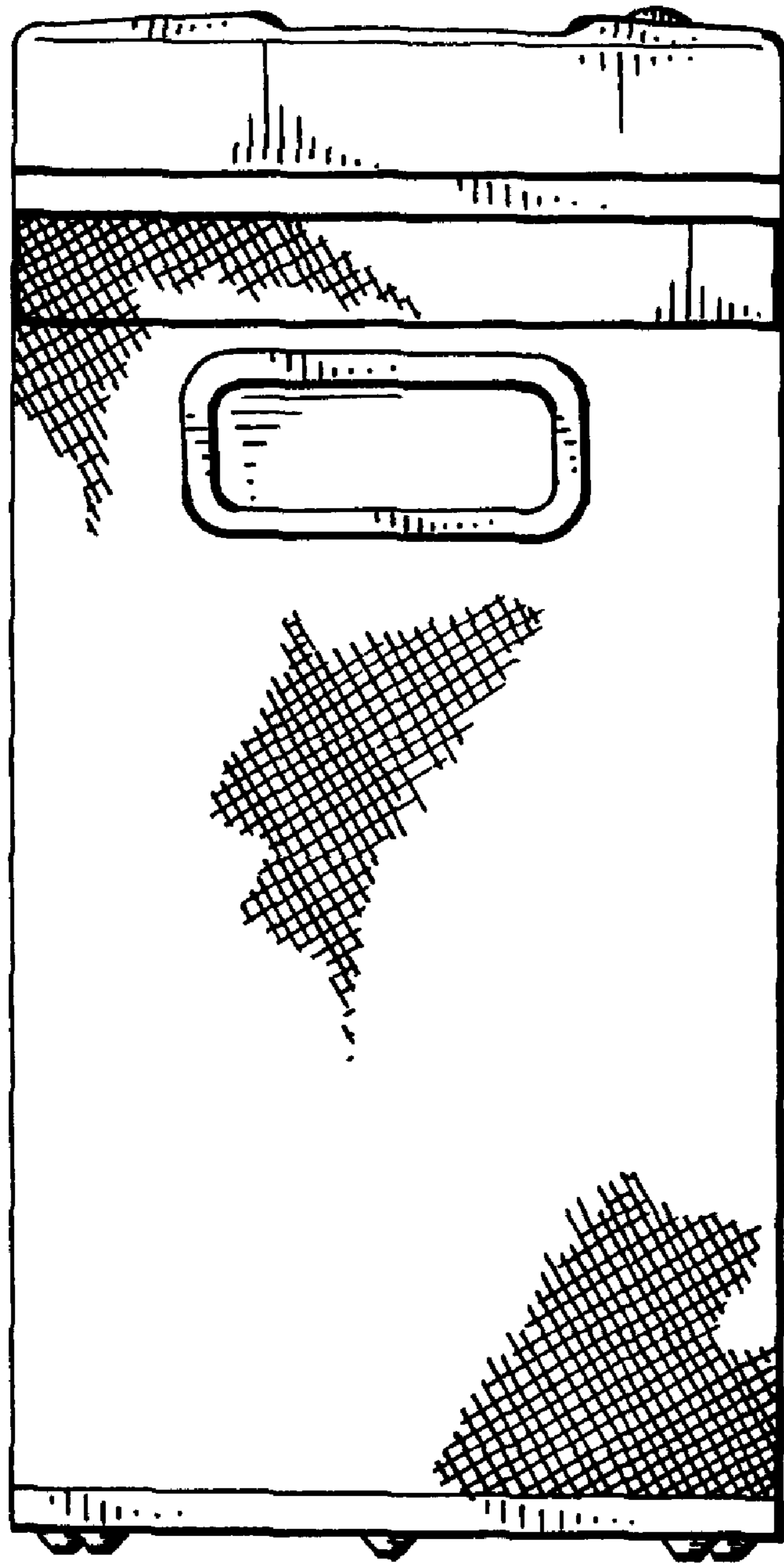

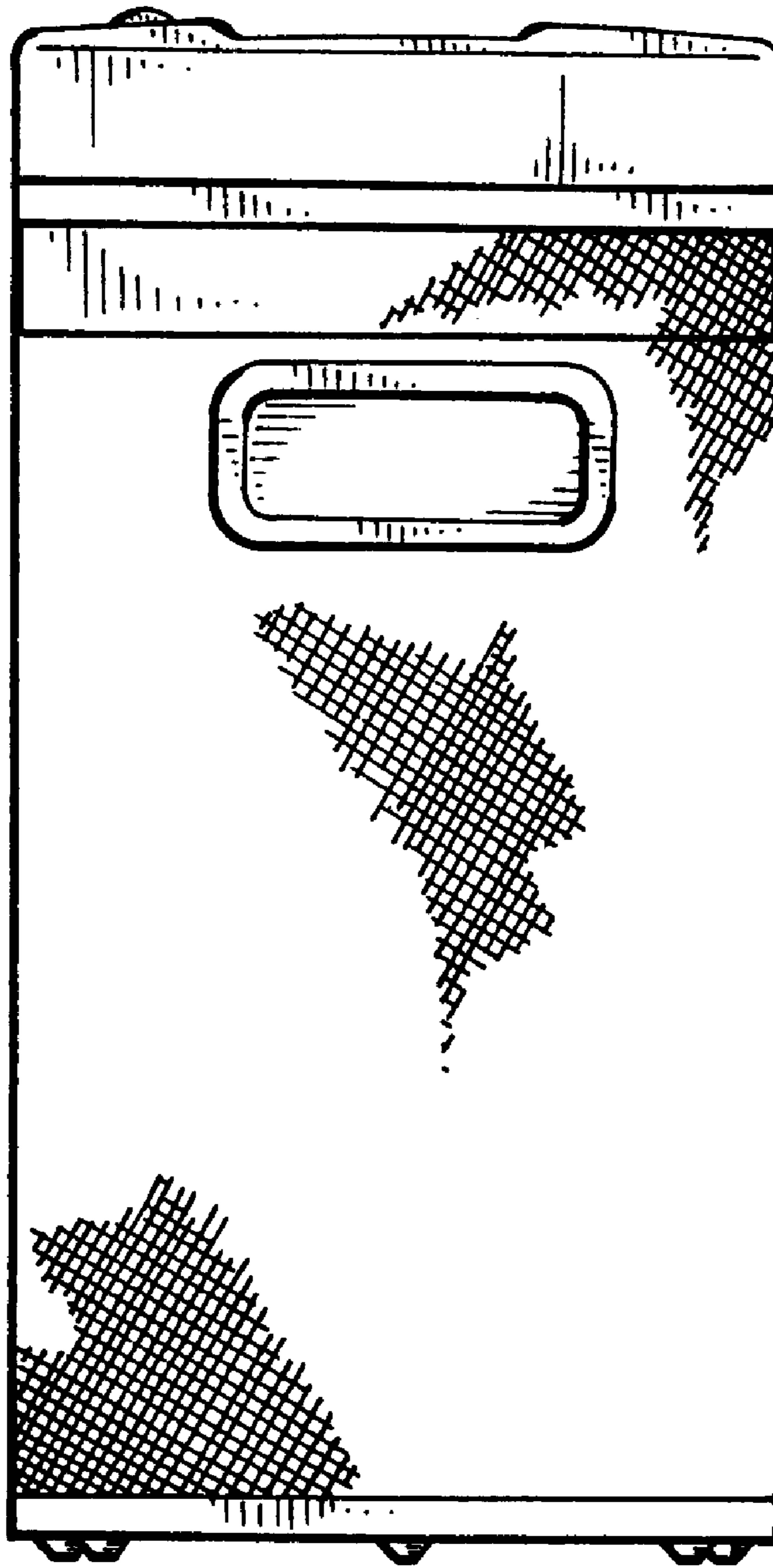
