FIG. 8 is an enlarged bottom plan view thereof.

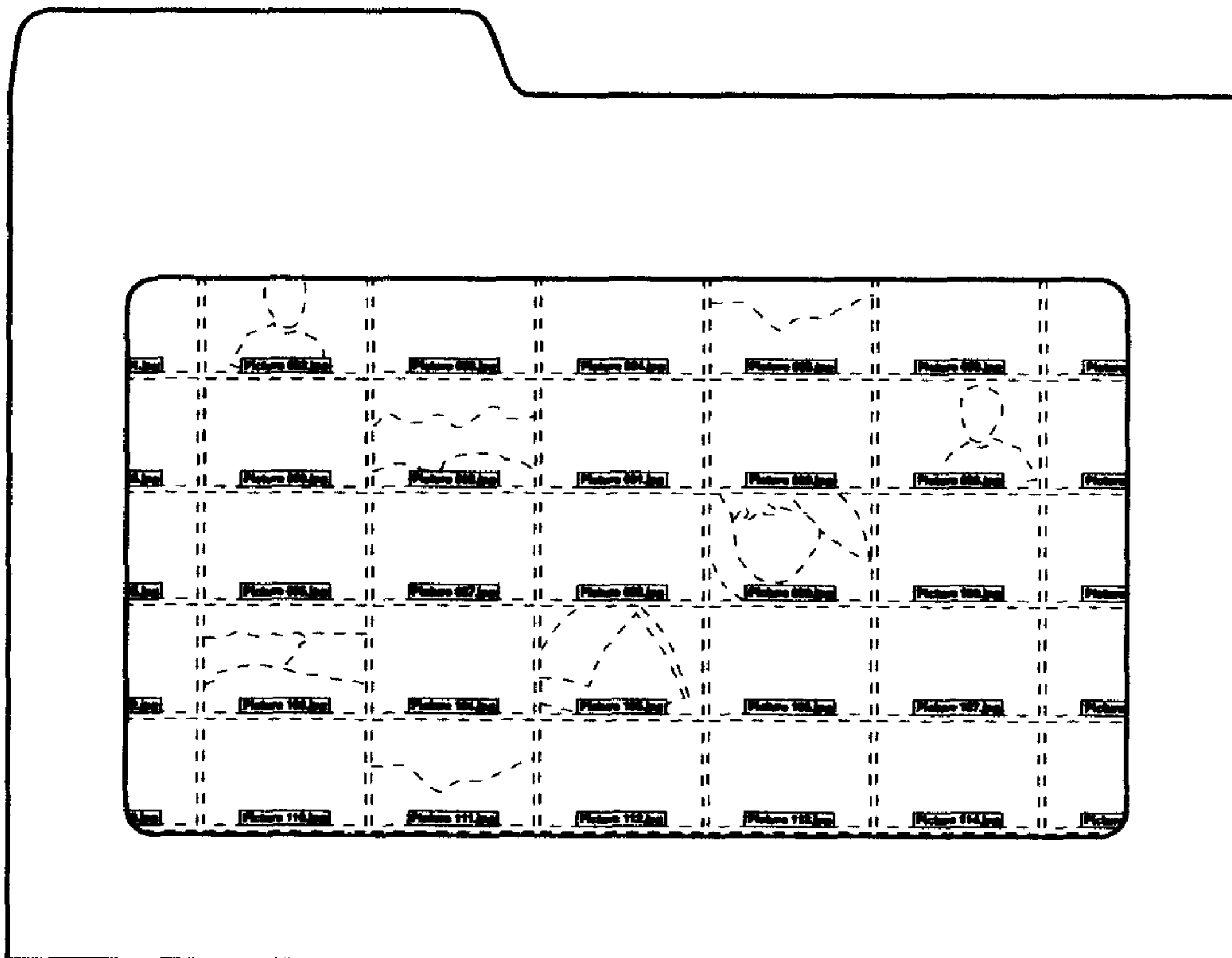

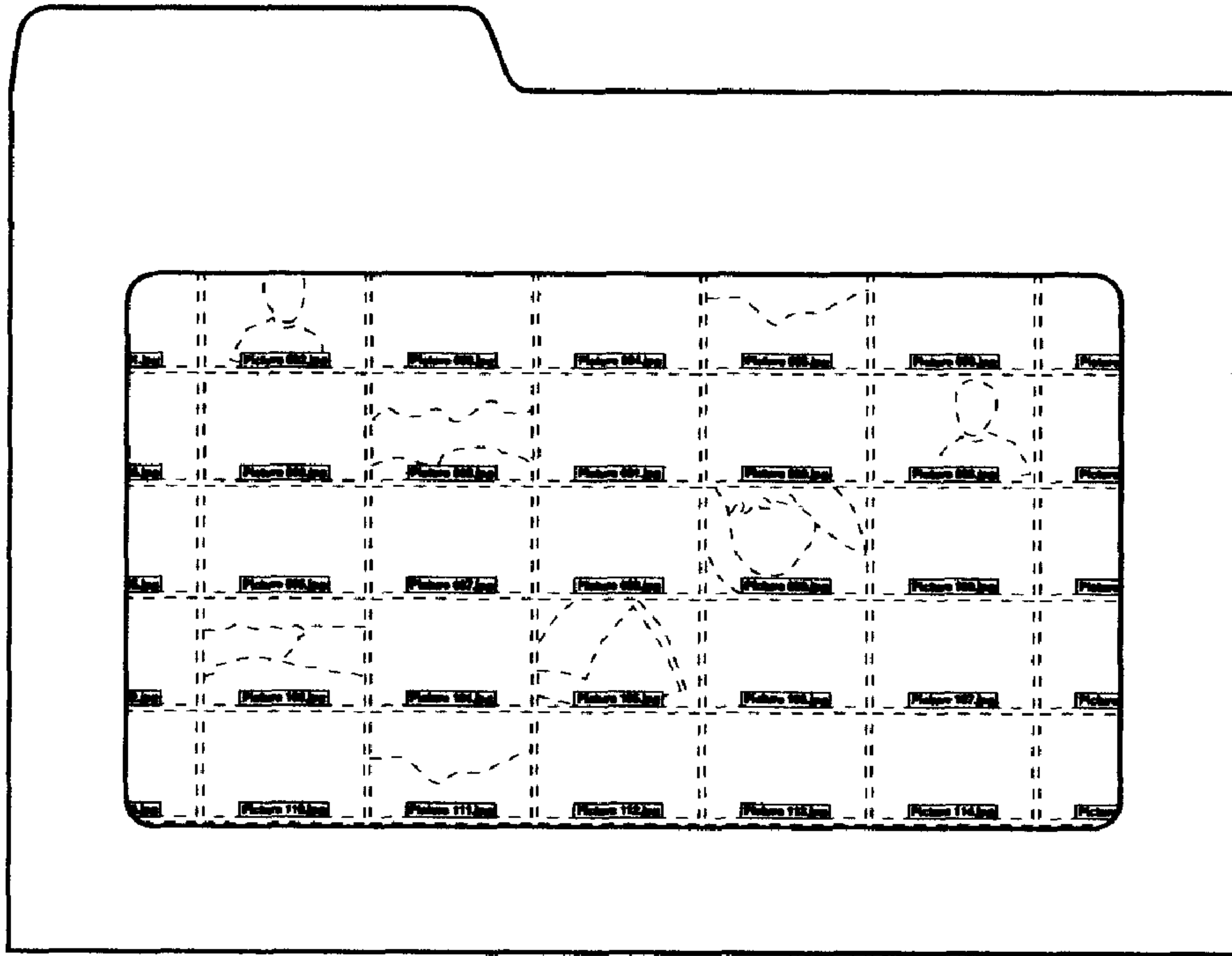

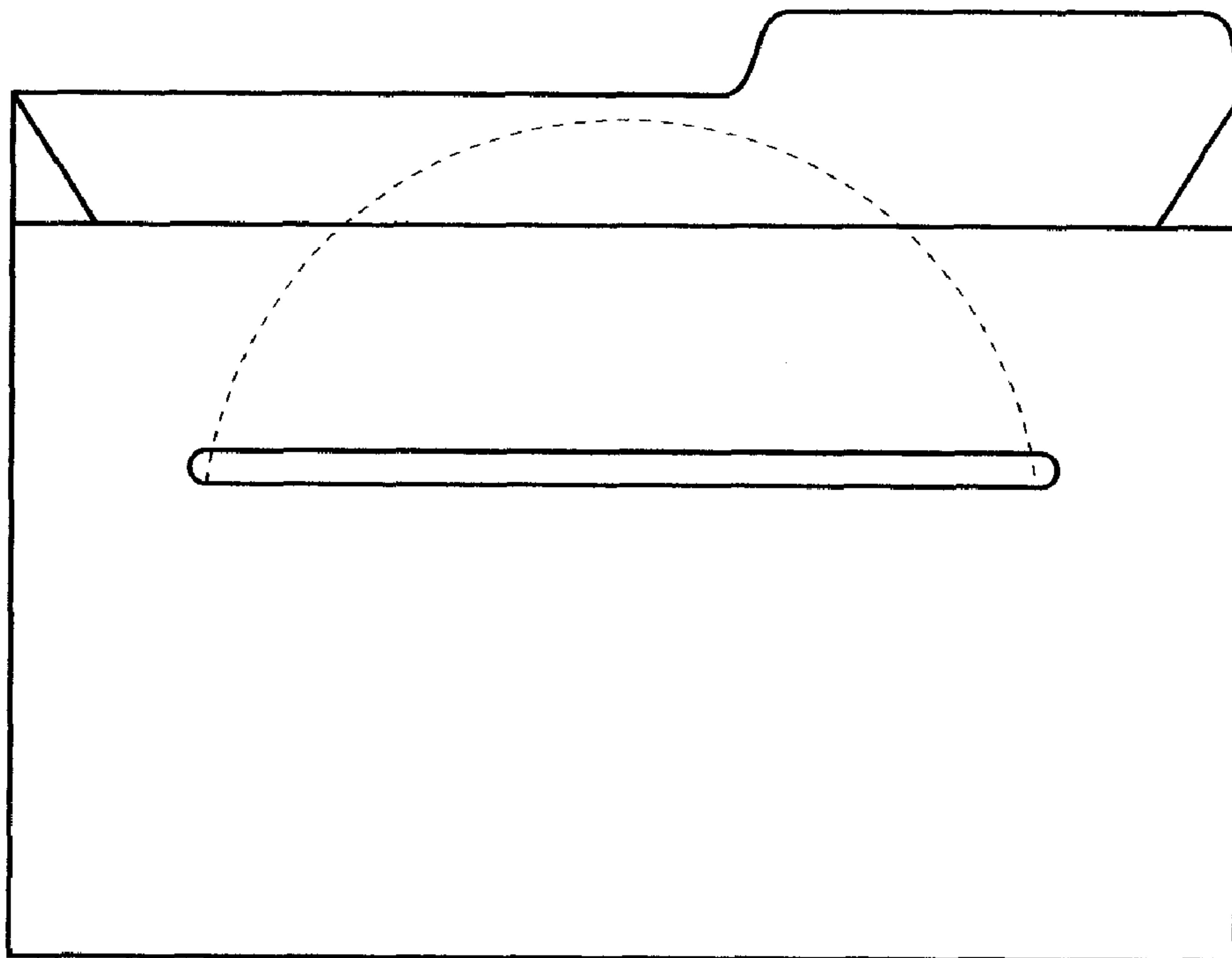

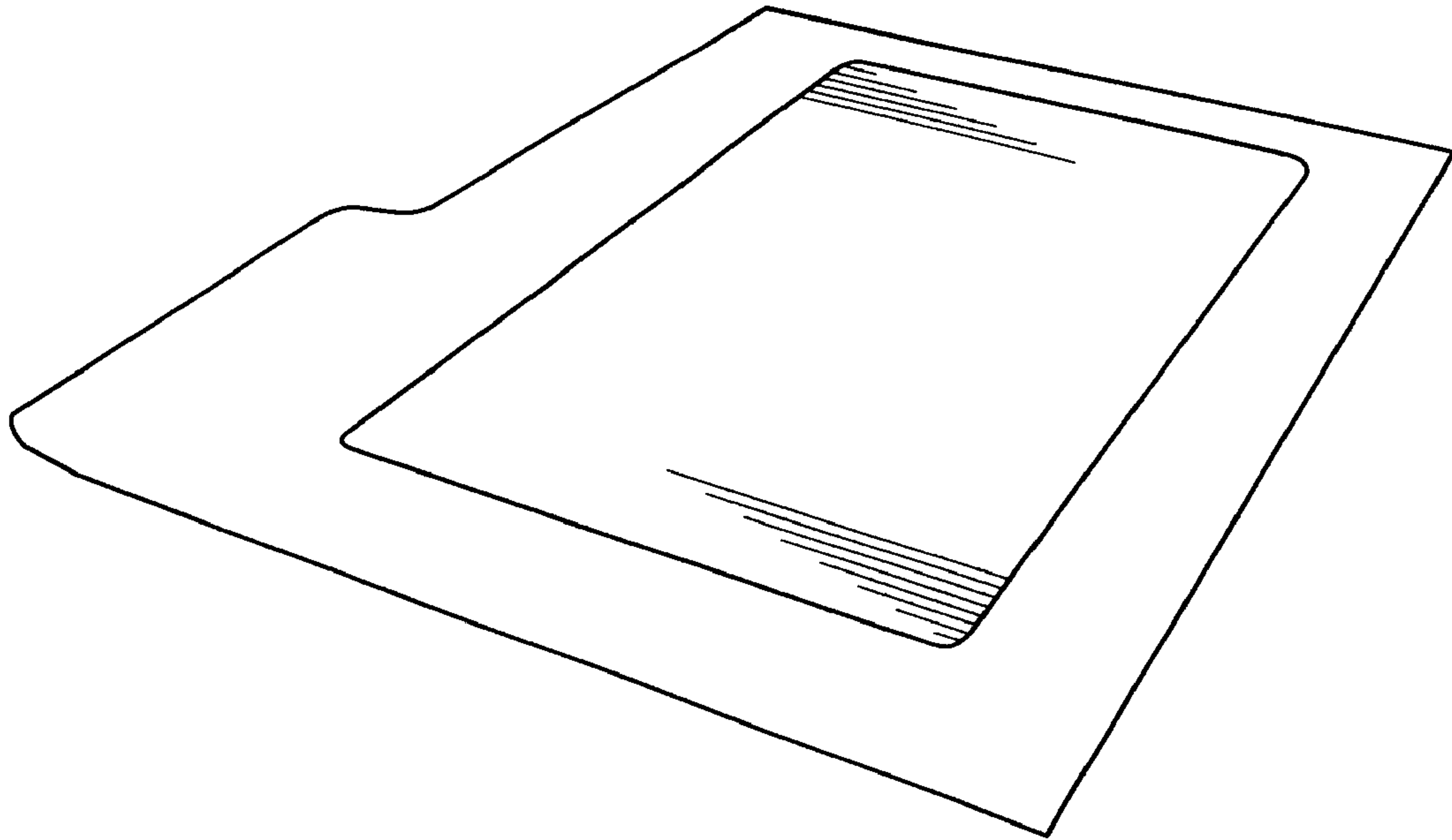

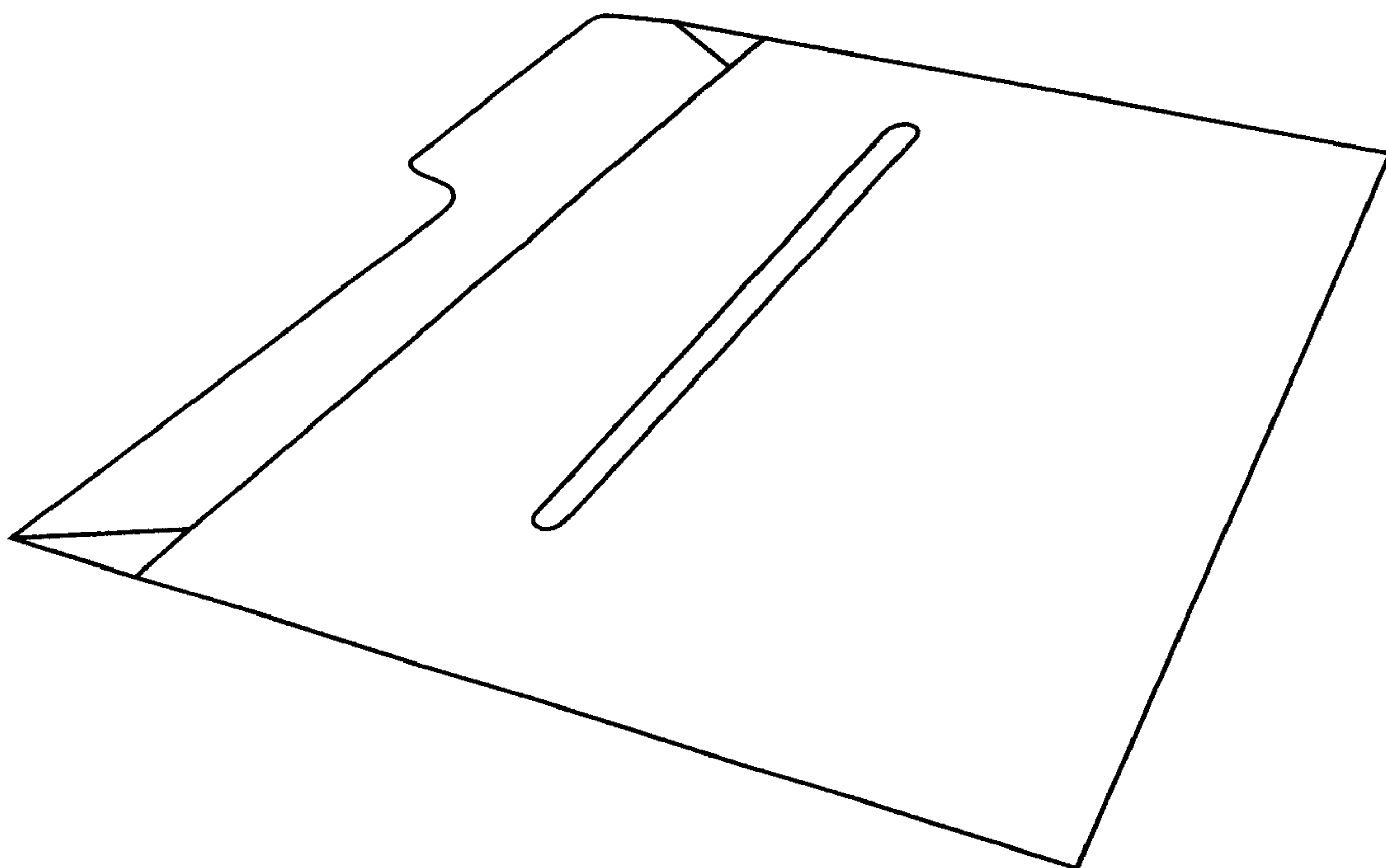

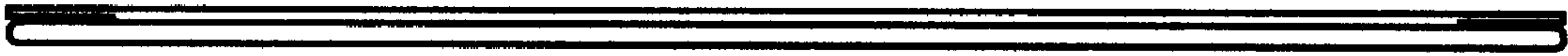
