FIG. 1 is a front view of a retail shelving label showing my new design.
 FIG. 2 is a top view of FIG. 1.
 FIG. 3 is a bottom view of FIG. 1.
 FIG. 4 is a right side view of FIG. 1, the left side view being the same thereof.
 FIG. 5 is a front view of a retail shelving label in an alternative embodiment.

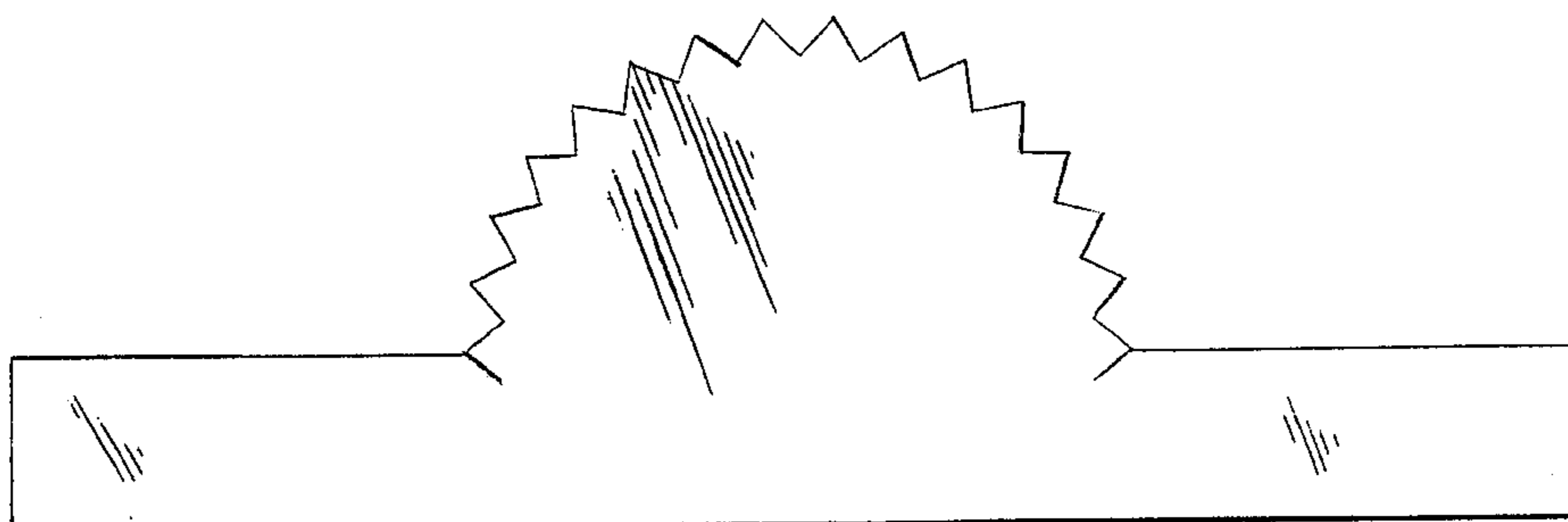
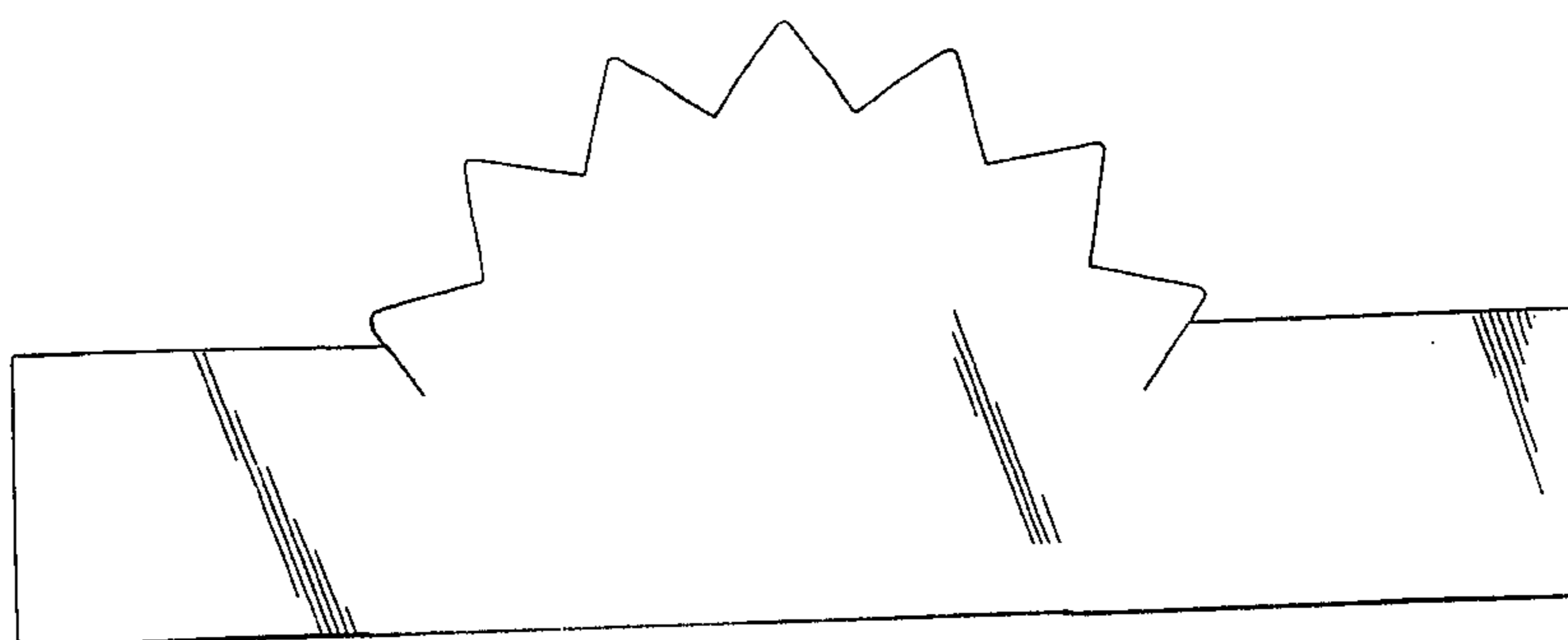

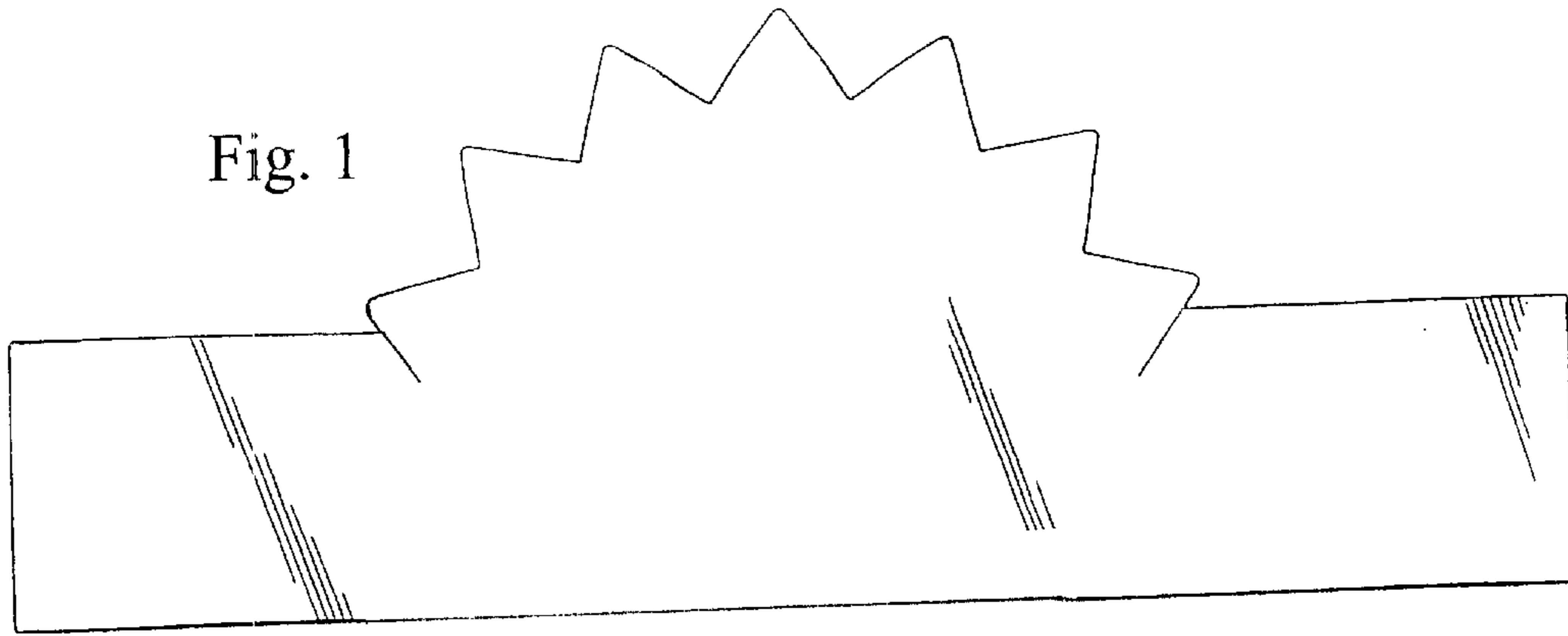

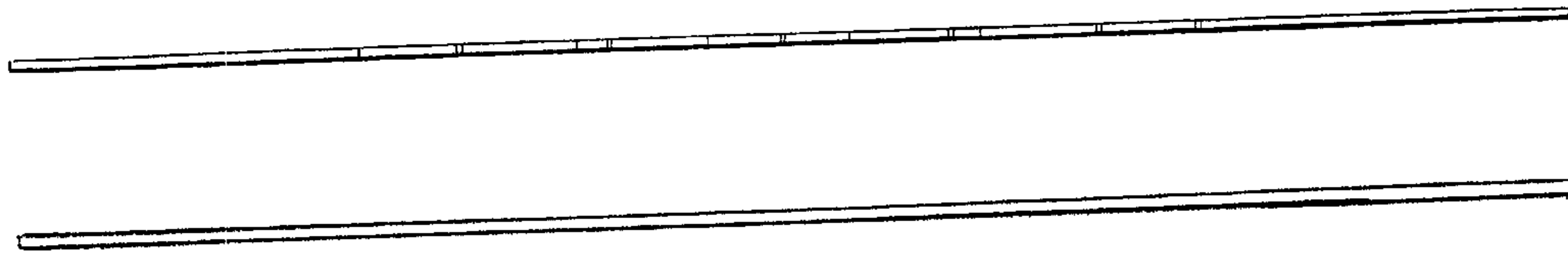
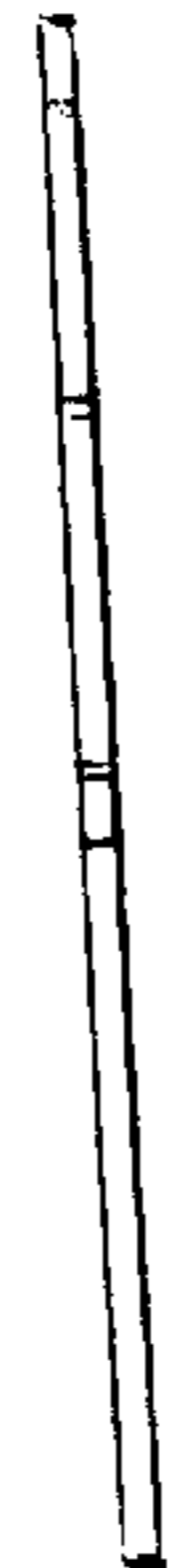

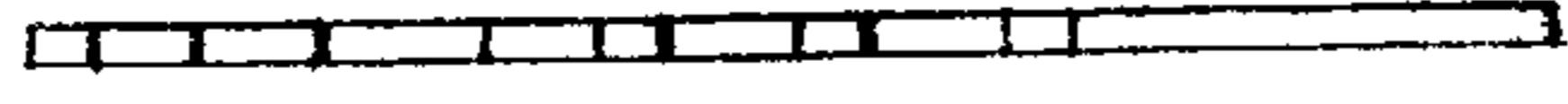

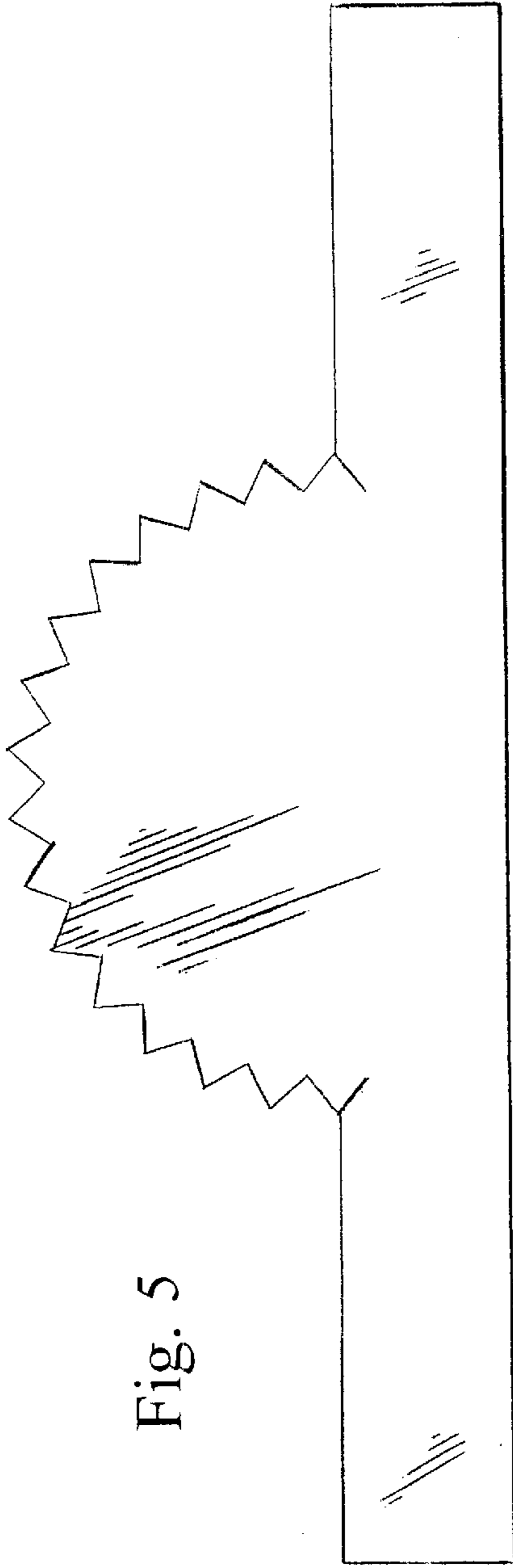
