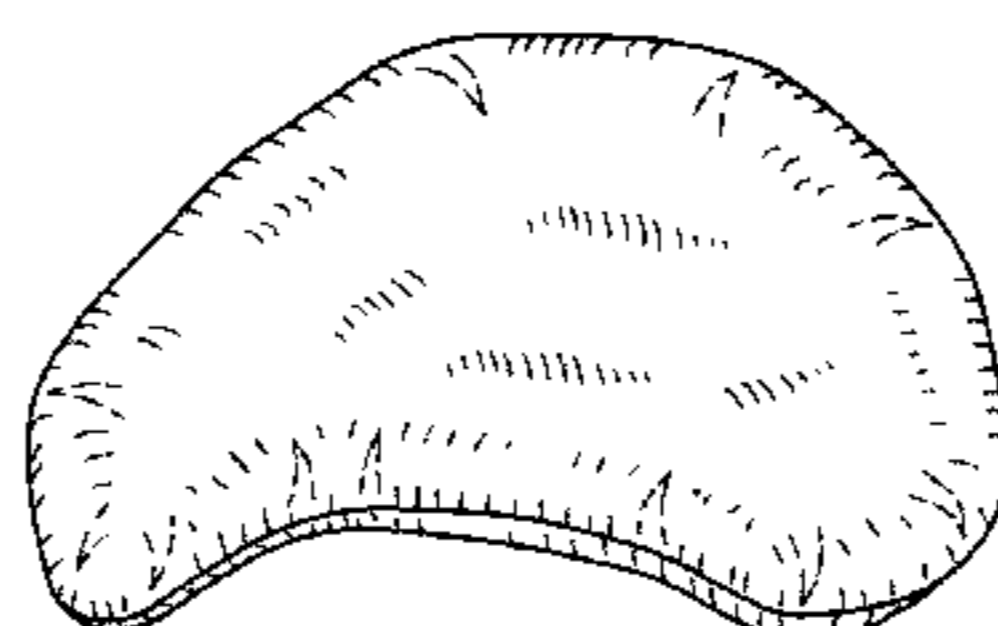
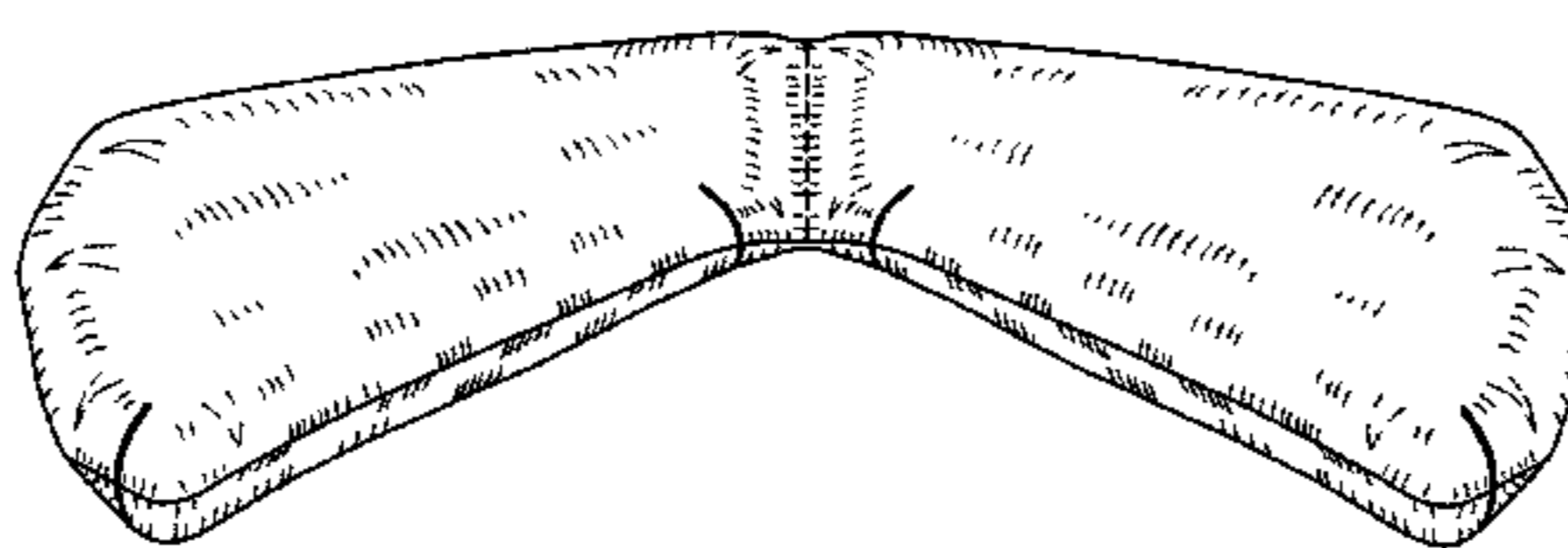
(57) **CLAIM**

The ornamental design for a set of two facial free weights, as shown and described.

DESCRIPTION

FIG. 1 is a perspective of a set of two facial free weights consisting of a large facial free weight and a small facial free weight;
FIG. 2 is the top plan view of the large facial free weight of FIG. 1;
FIG. 3 is the front plan view of the large facial free weight of FIG. 1;
FIG. 4 is the bottom plan view of the large facial free weight of FIG. 1;
FIG. 5 is the rear plan view of the large facial free weight of FIG. 1;
FIG. 6 is the right side view of the large facial free weight of FIG. 1;
FIG. 7 is the left side view of the large facial free weight of FIG. 1;
FIG. 8 is the top plan view of the small facial free weight of FIG. 1;
FIG. 9 is the front plan view of the small facial free weight of FIG. 1;
FIG. 10 is the bottom plan view of the small facial free weight of FIG. 1;
FIG. 11 is the rear plan view of the small facial free weight of FIG. 1;
FIG. 12 is the right side view of the small facial free weight of FIG. 1; and,
FIG. 13 is the left side view of the small facial free weight of FIG. 1.

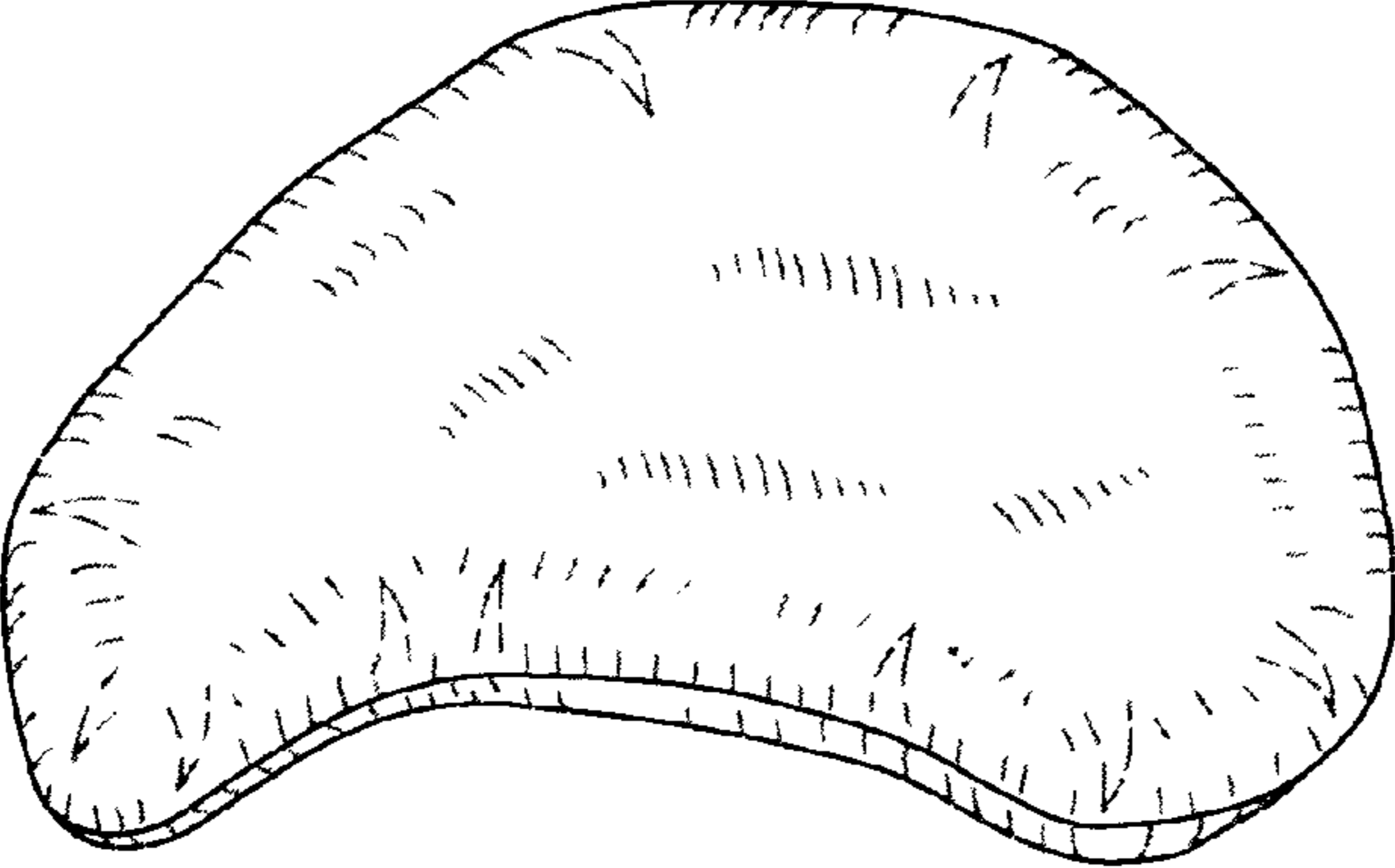
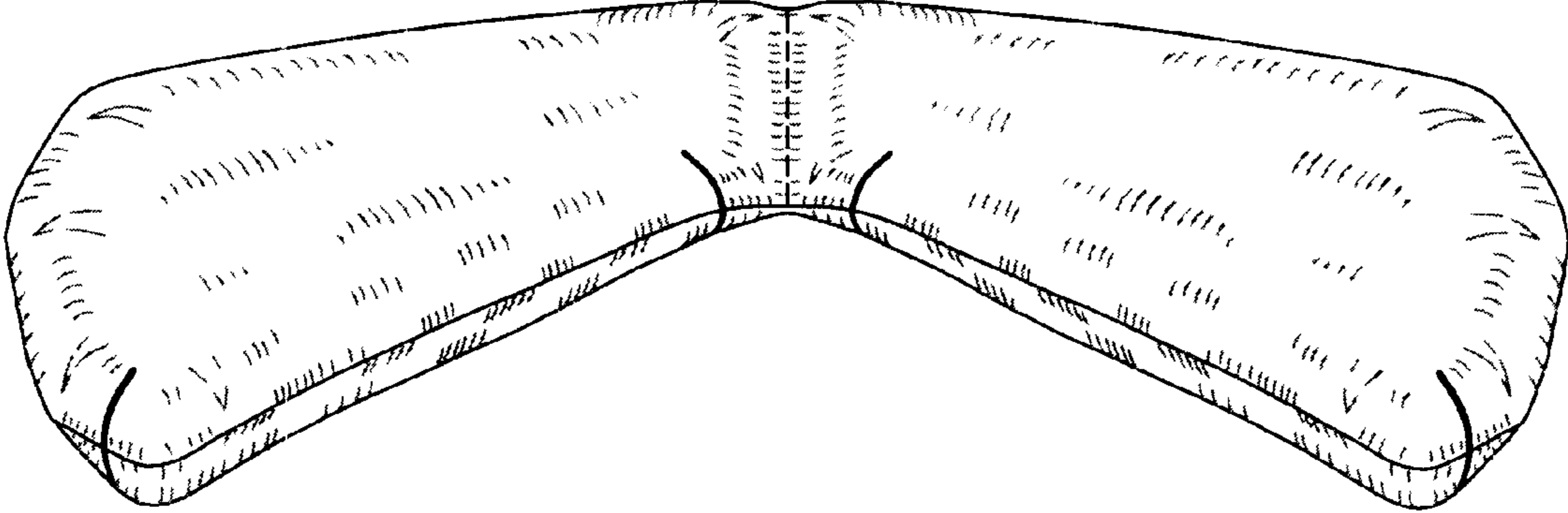

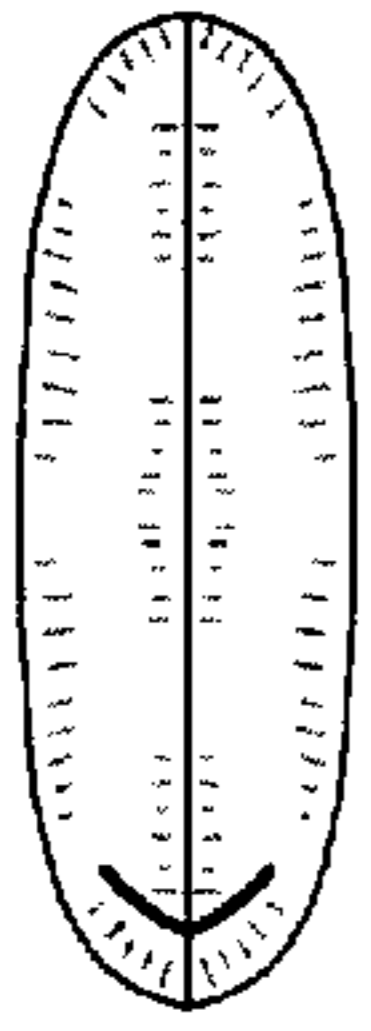

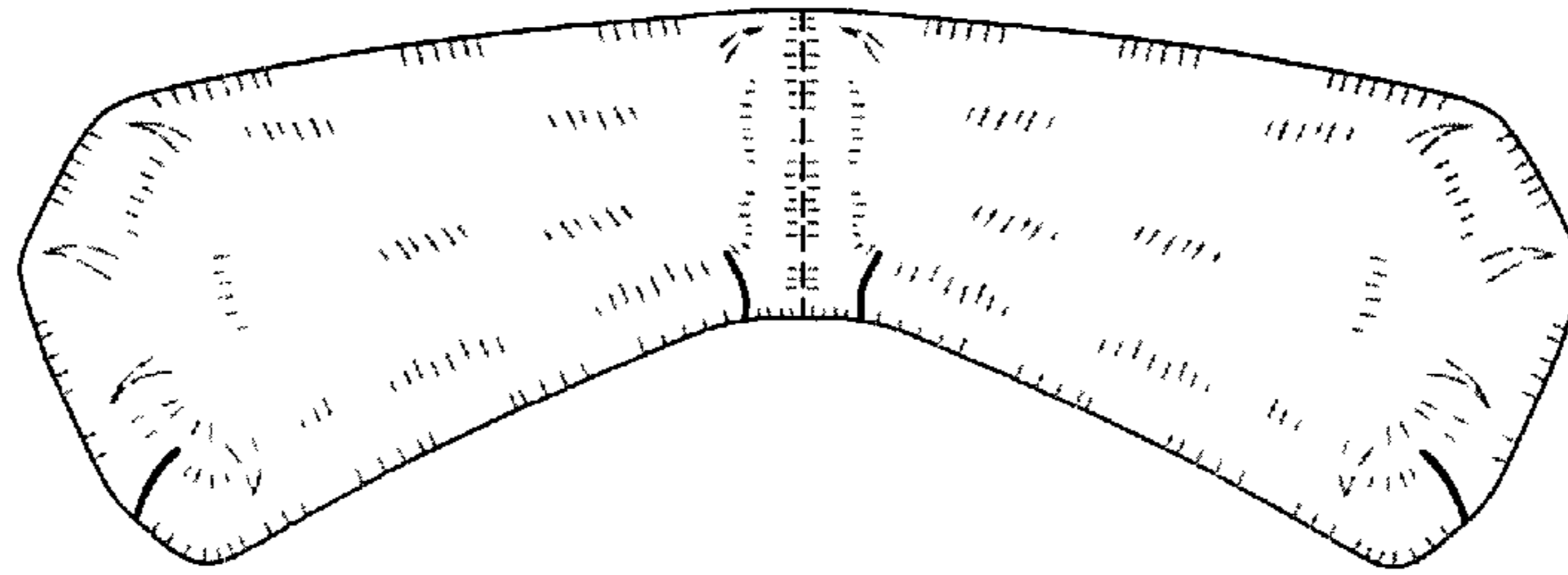

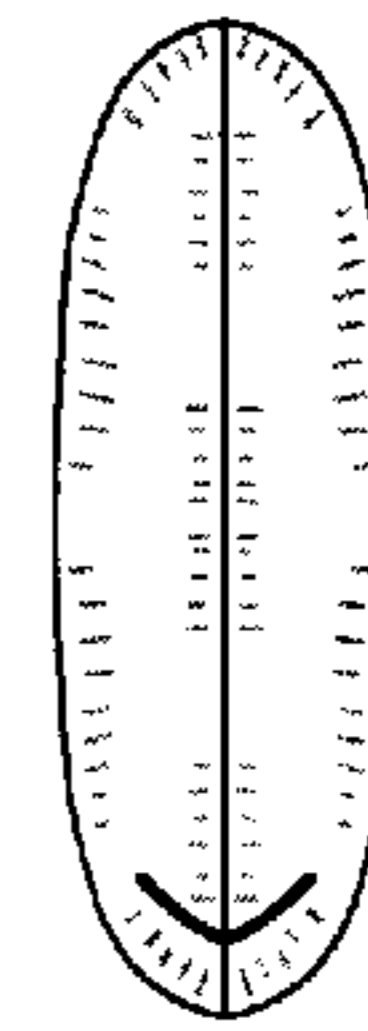

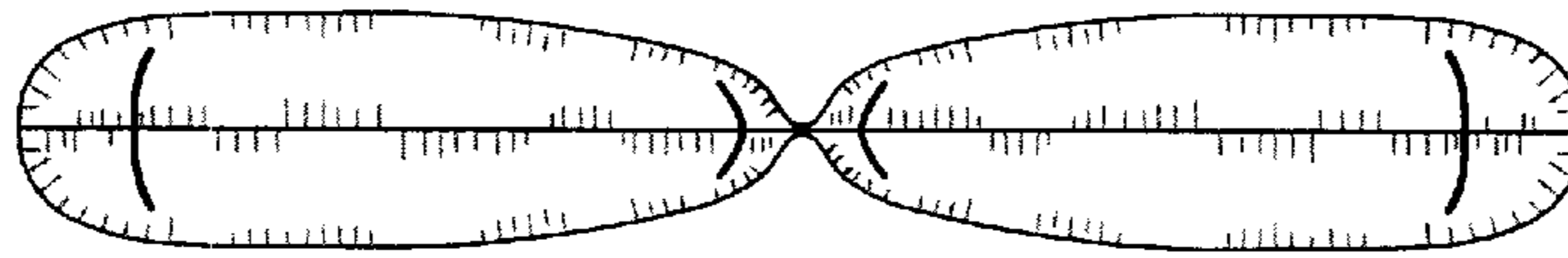

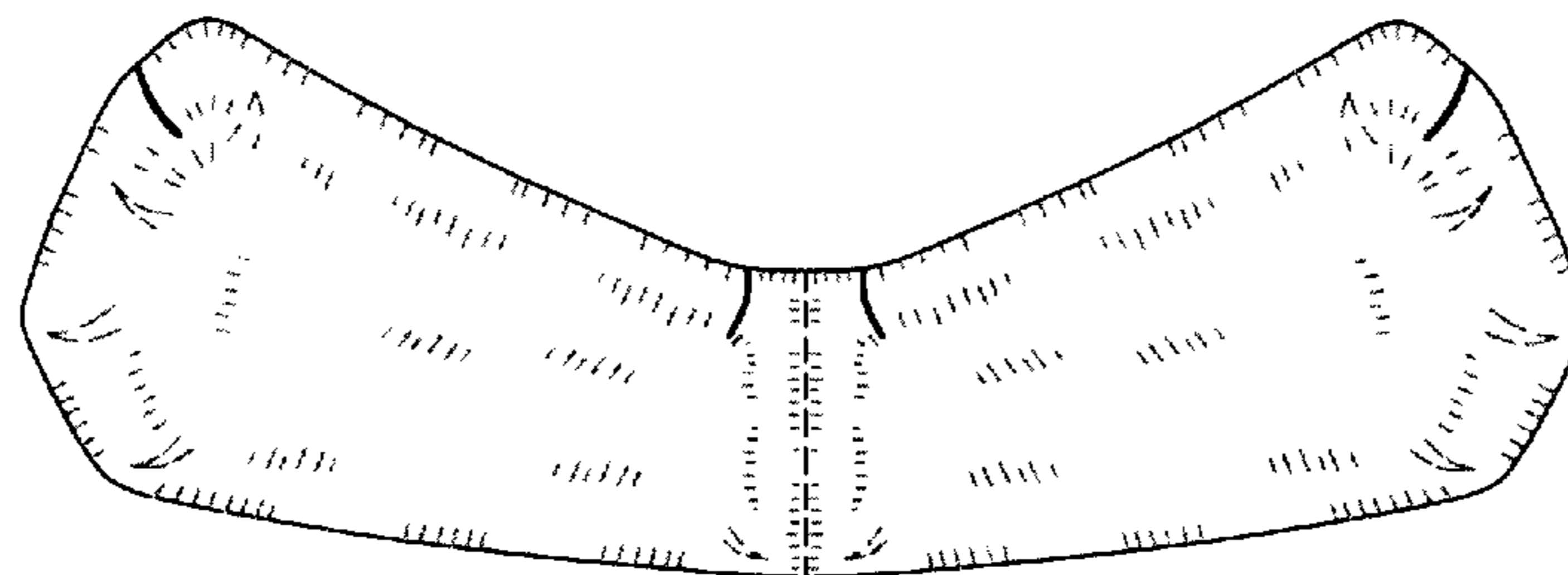

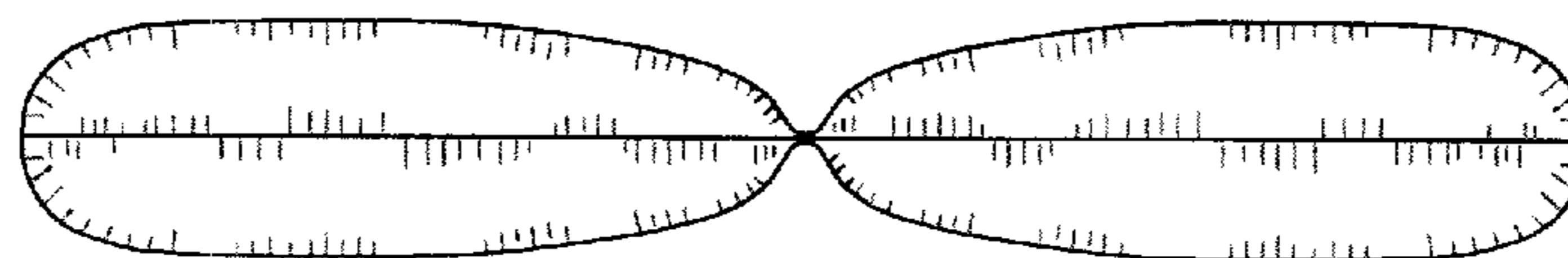

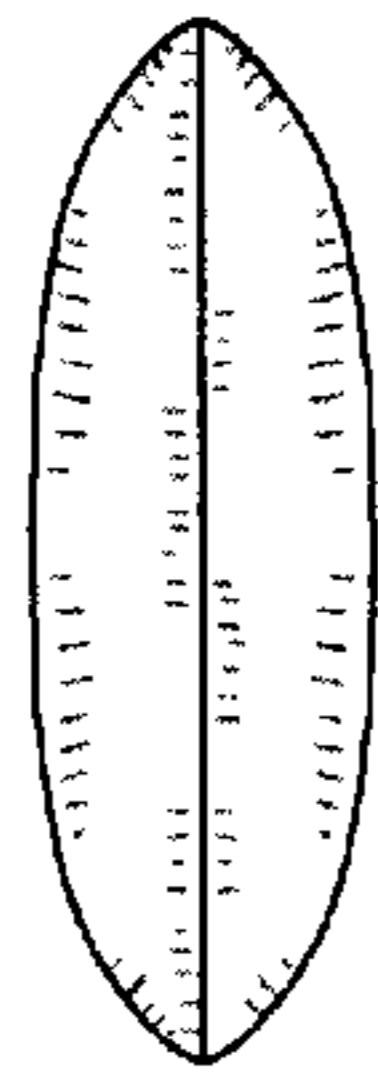

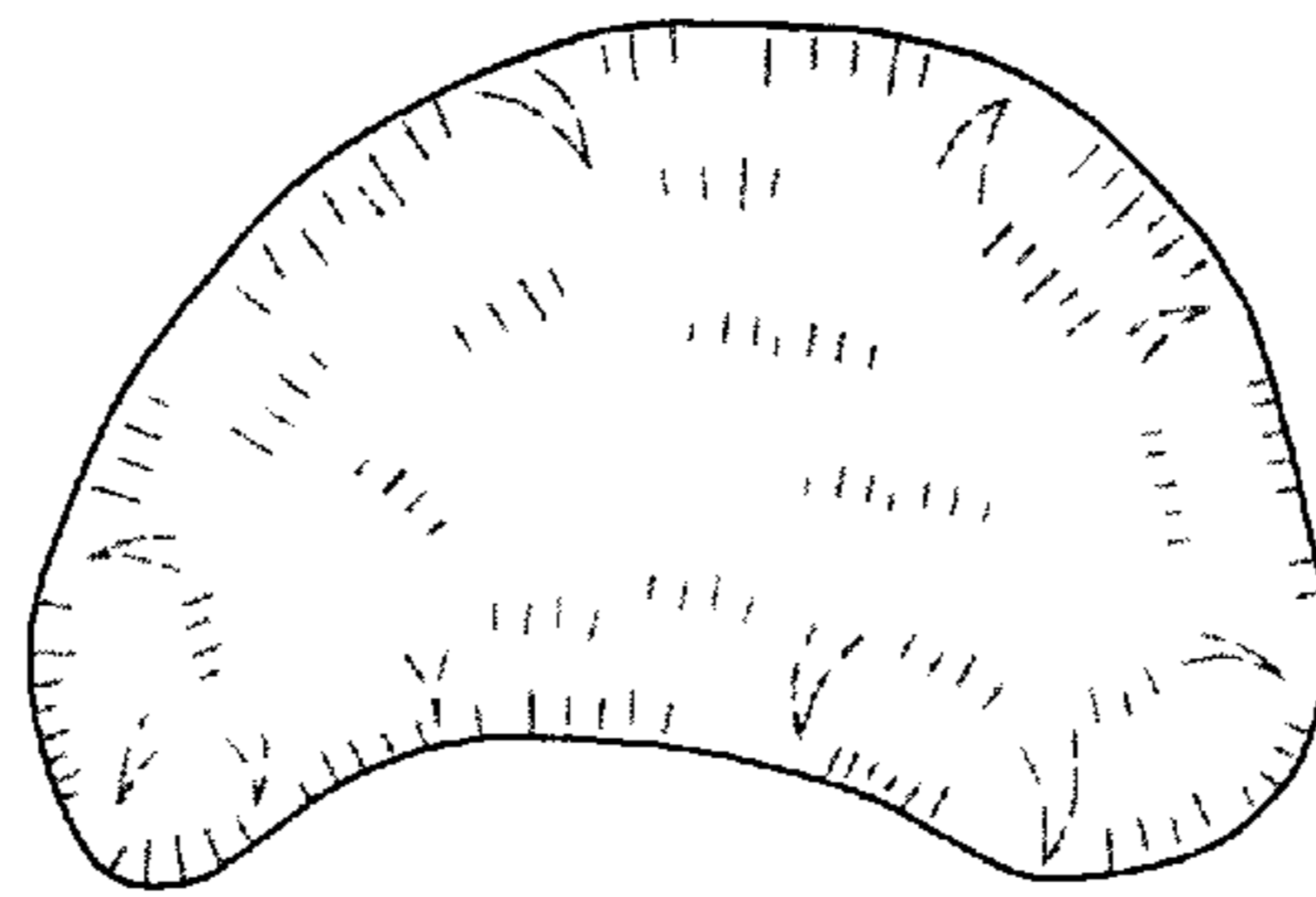

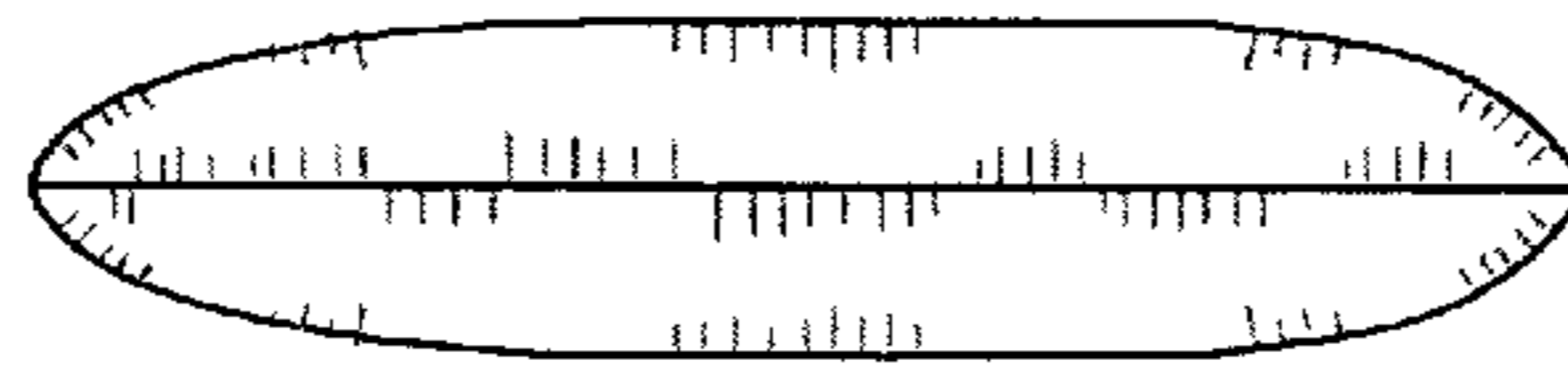

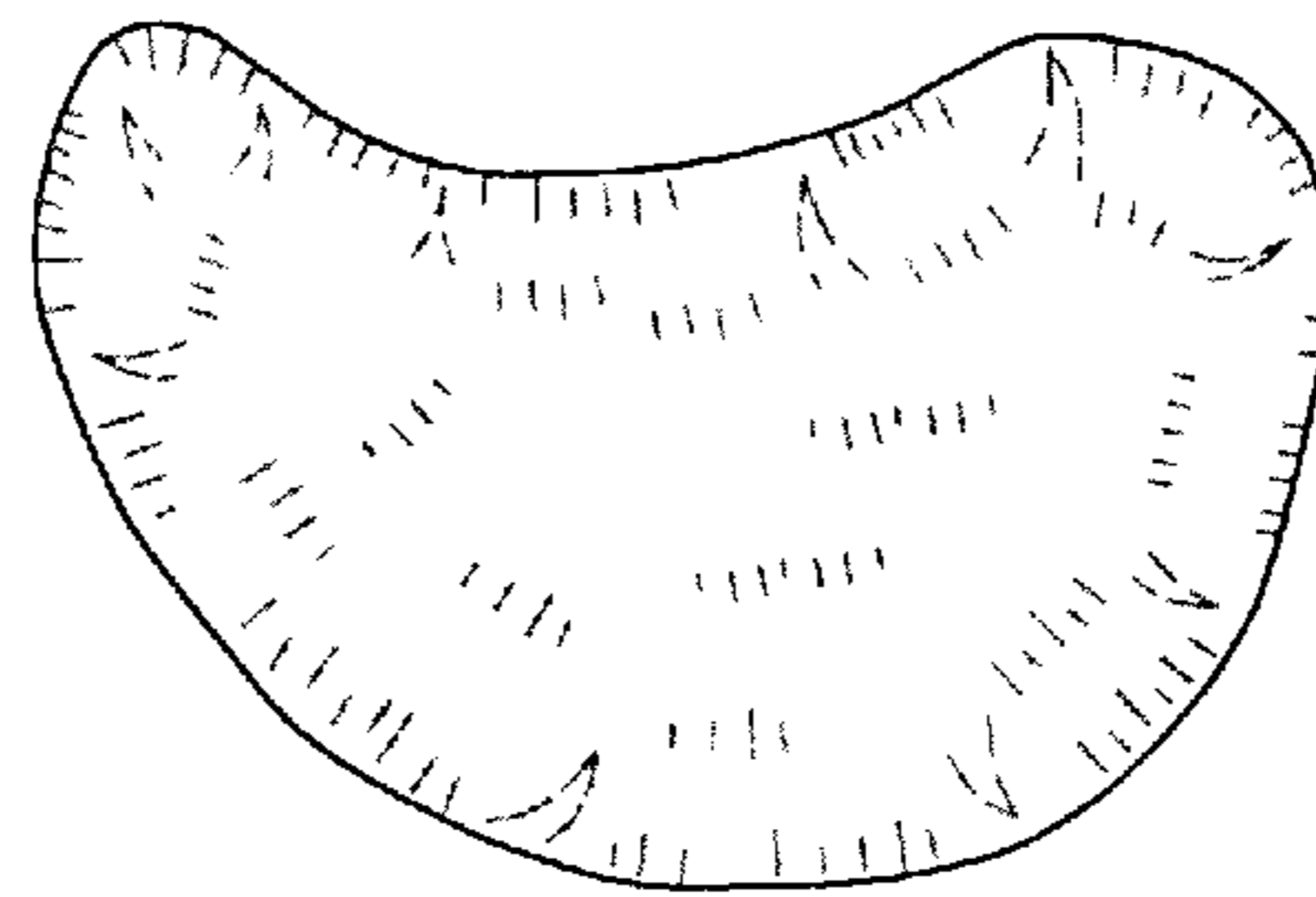

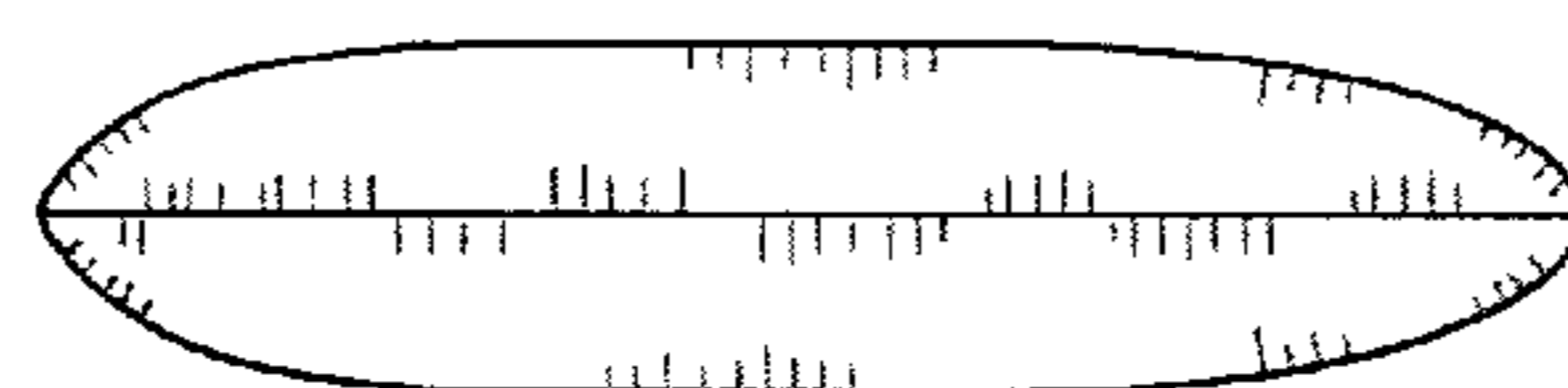
